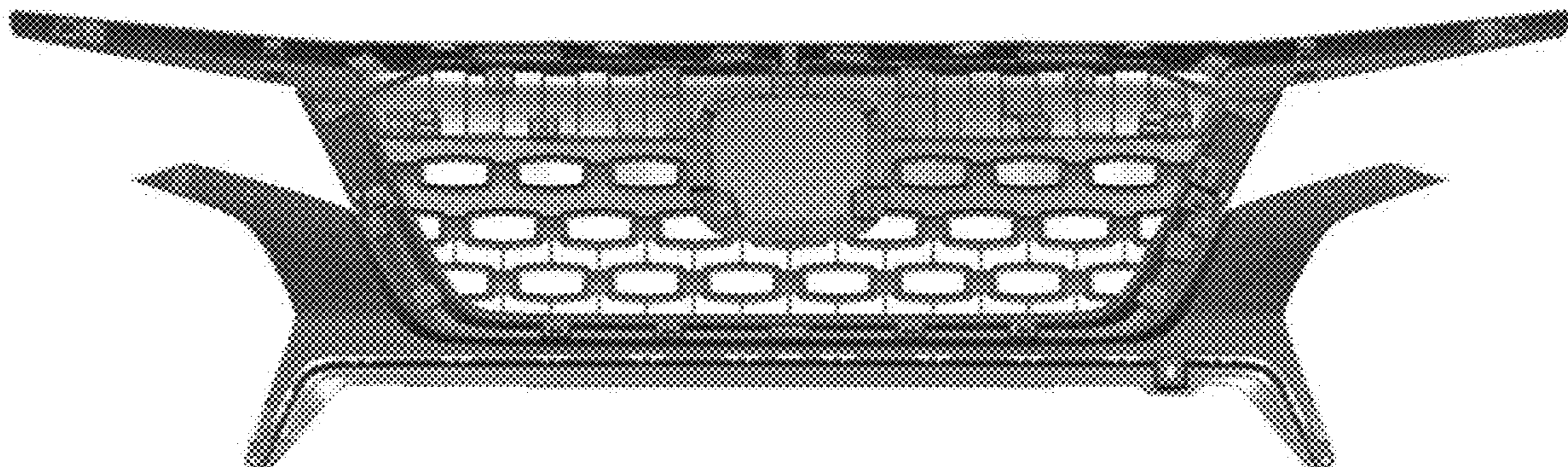

DESCRIPTION

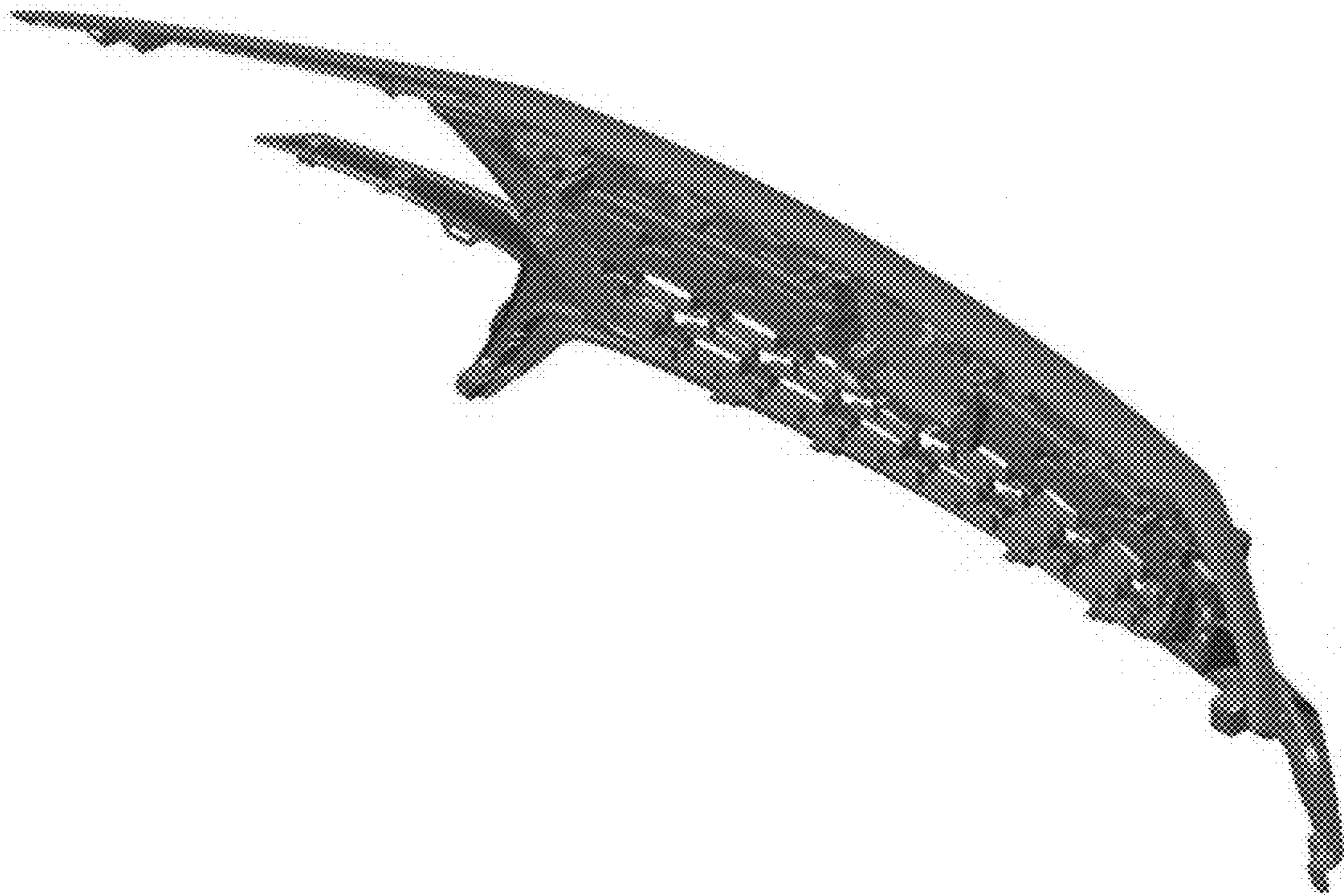

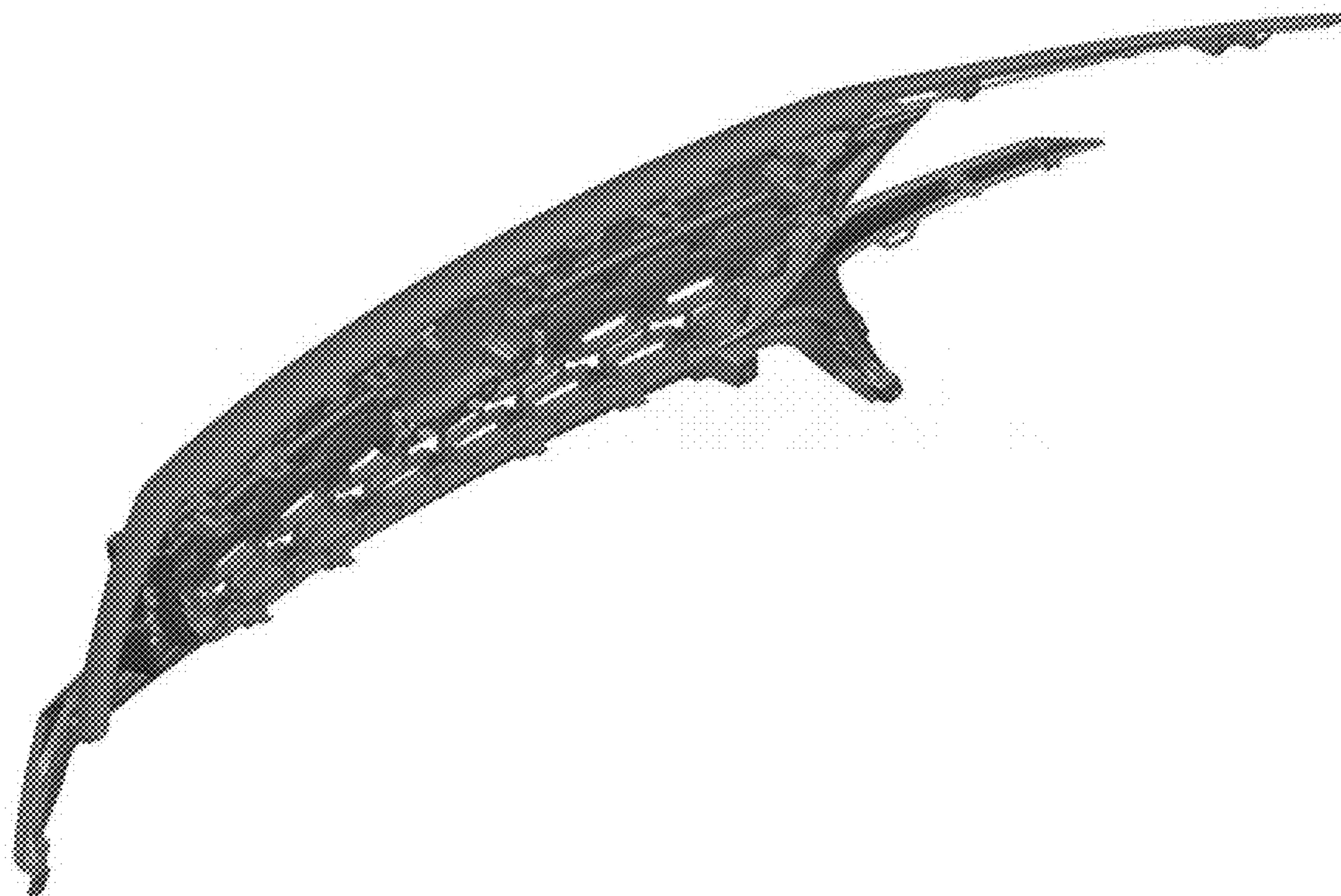

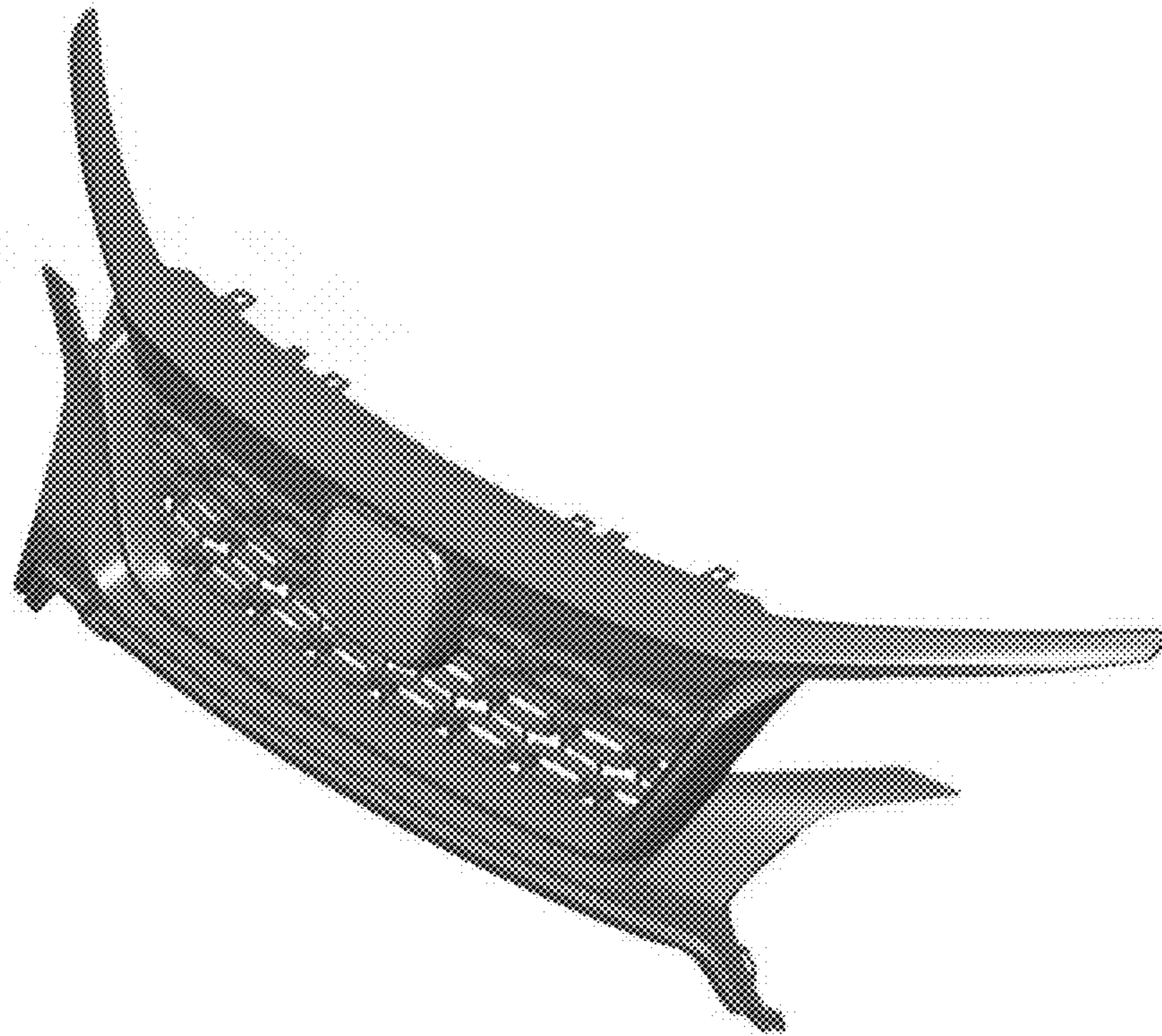

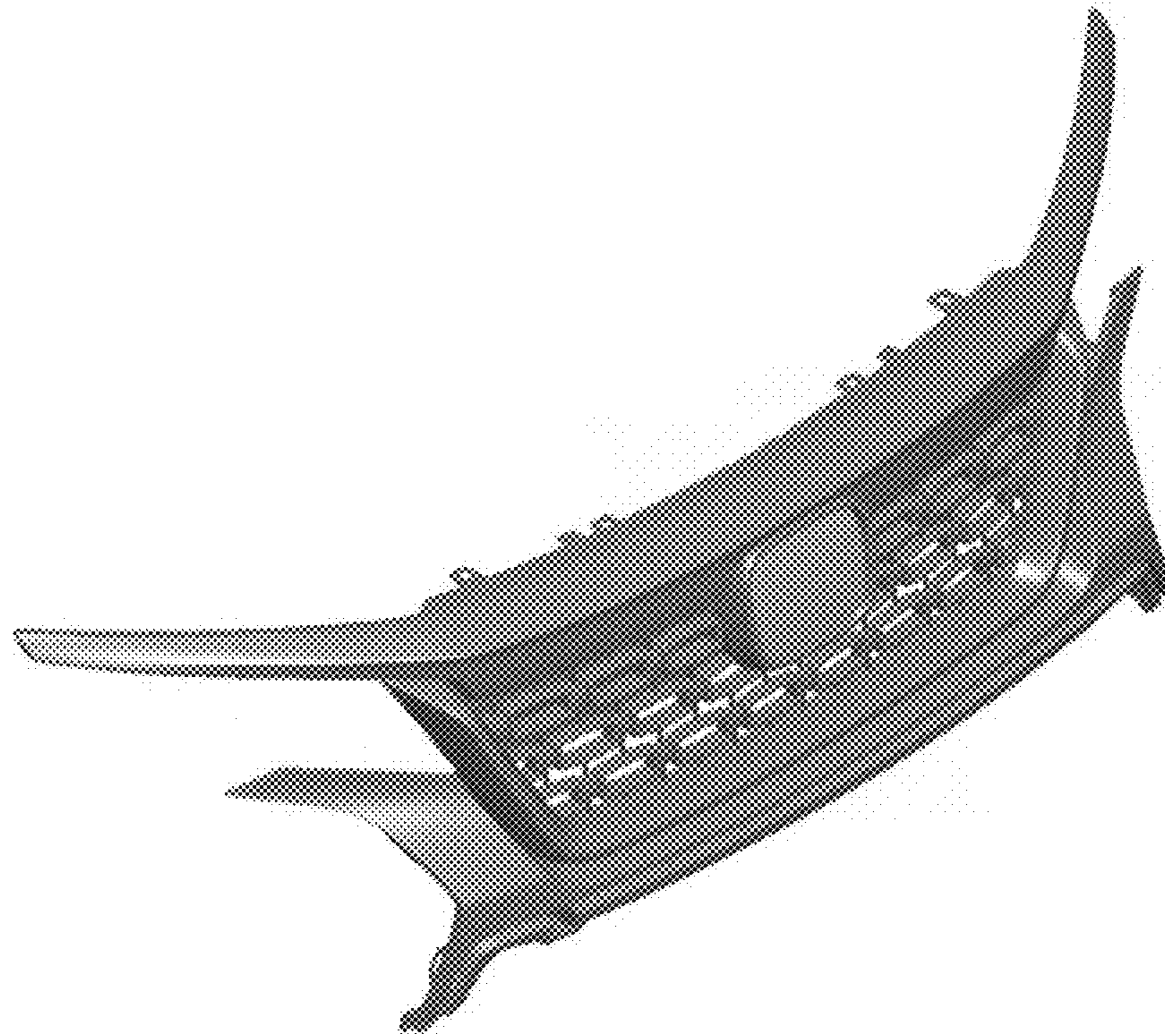

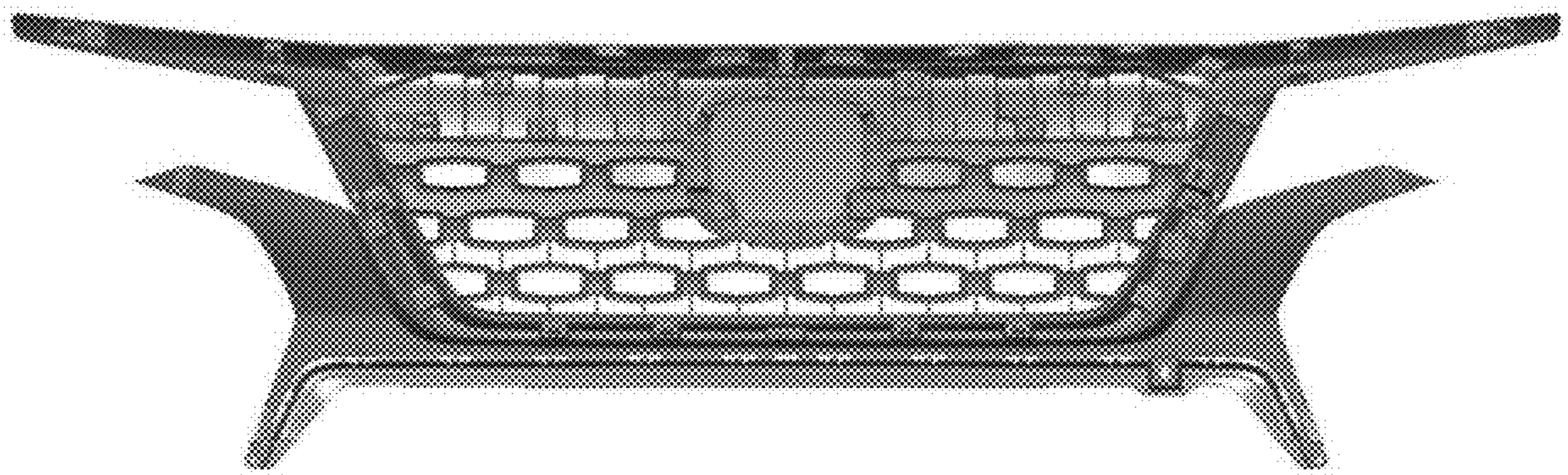

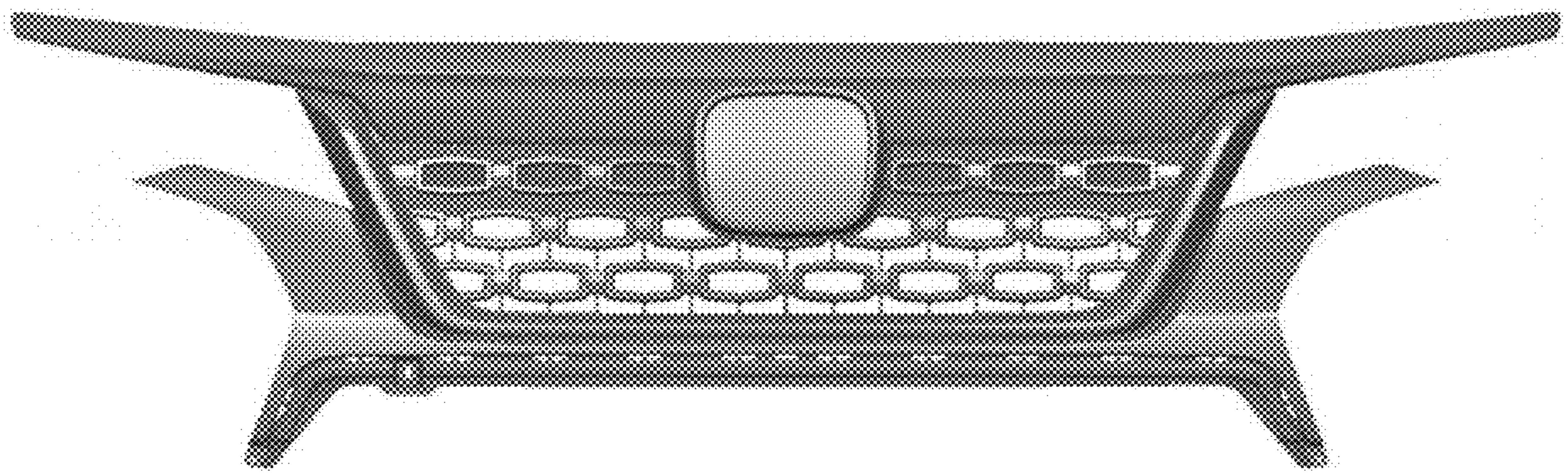

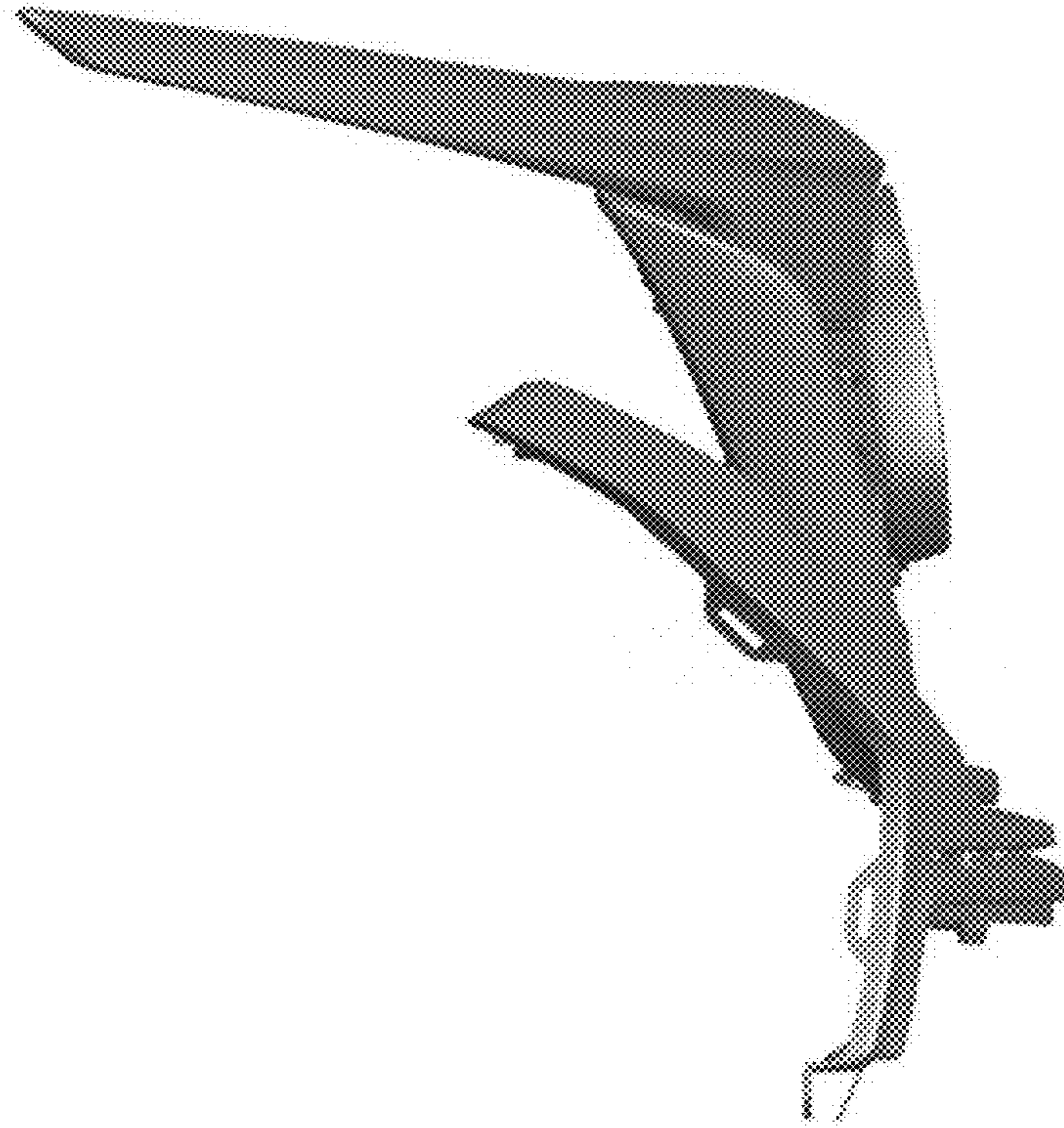

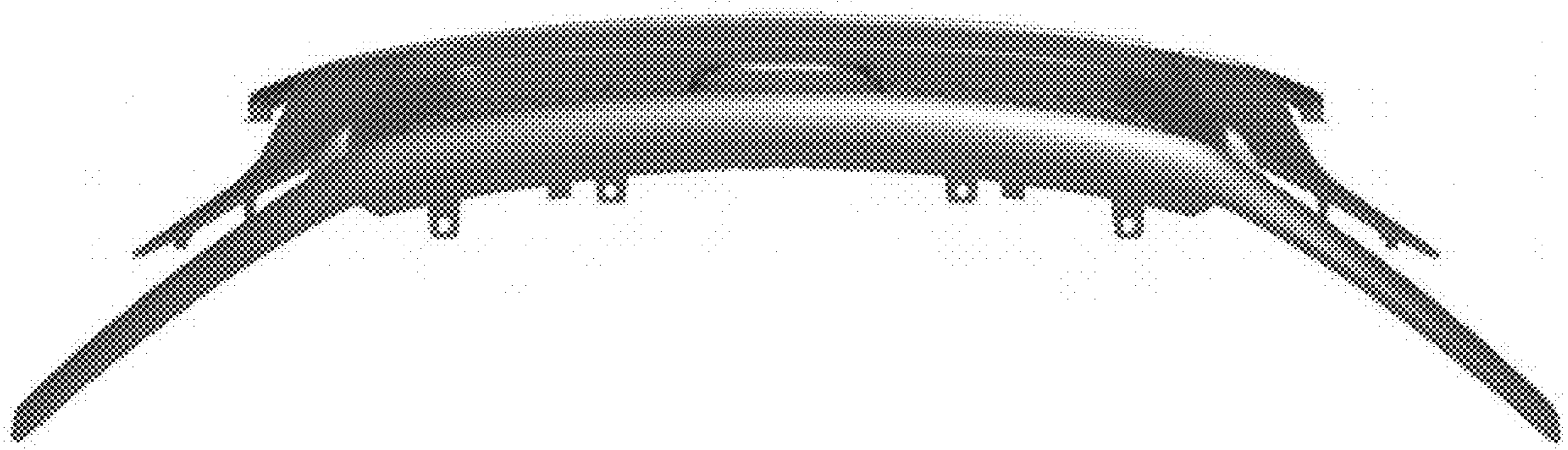

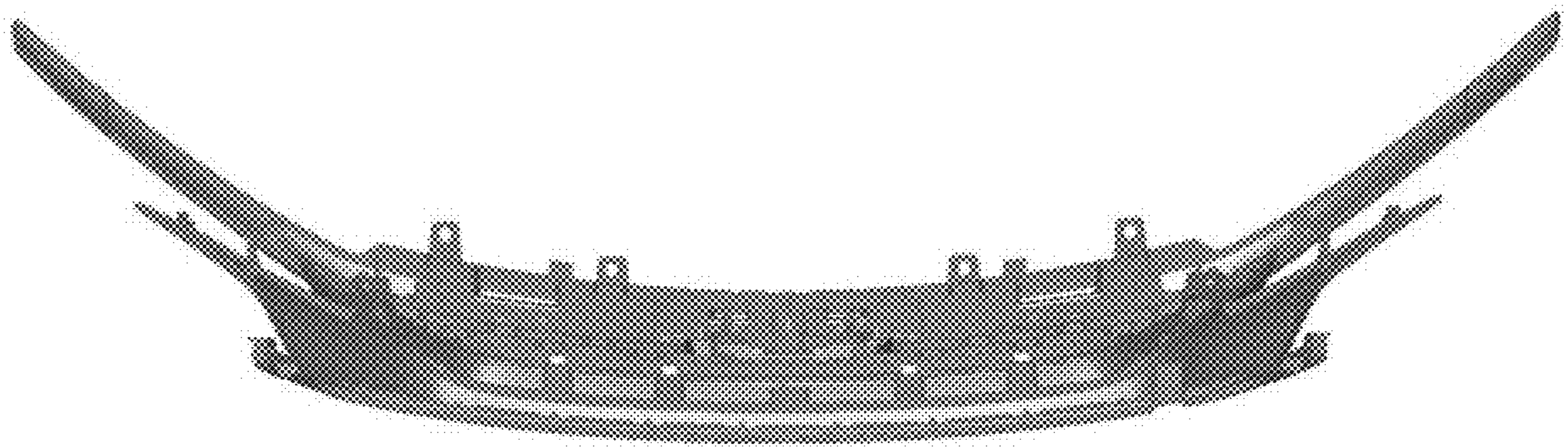
