FIG. 7 is a bottom plan view thereof.

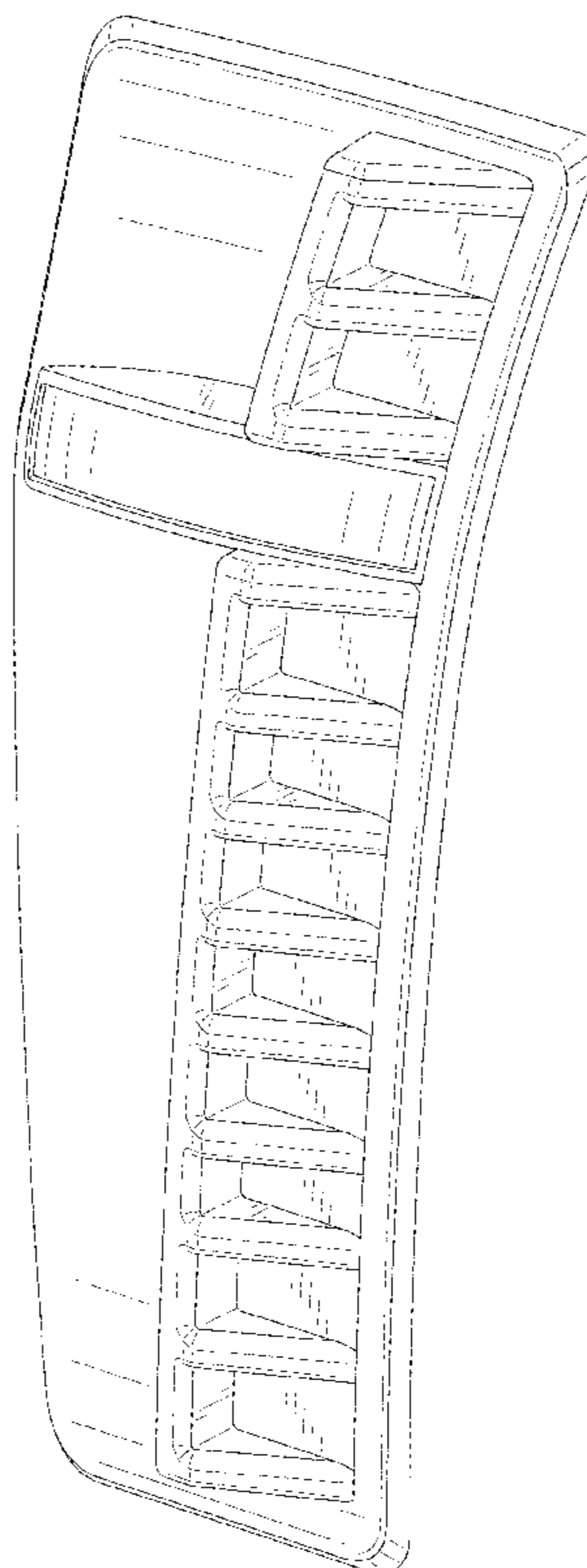
The broken lines shown in the drawings depict portions of the side vent for a motor vehicle that form no part of the claimed design.

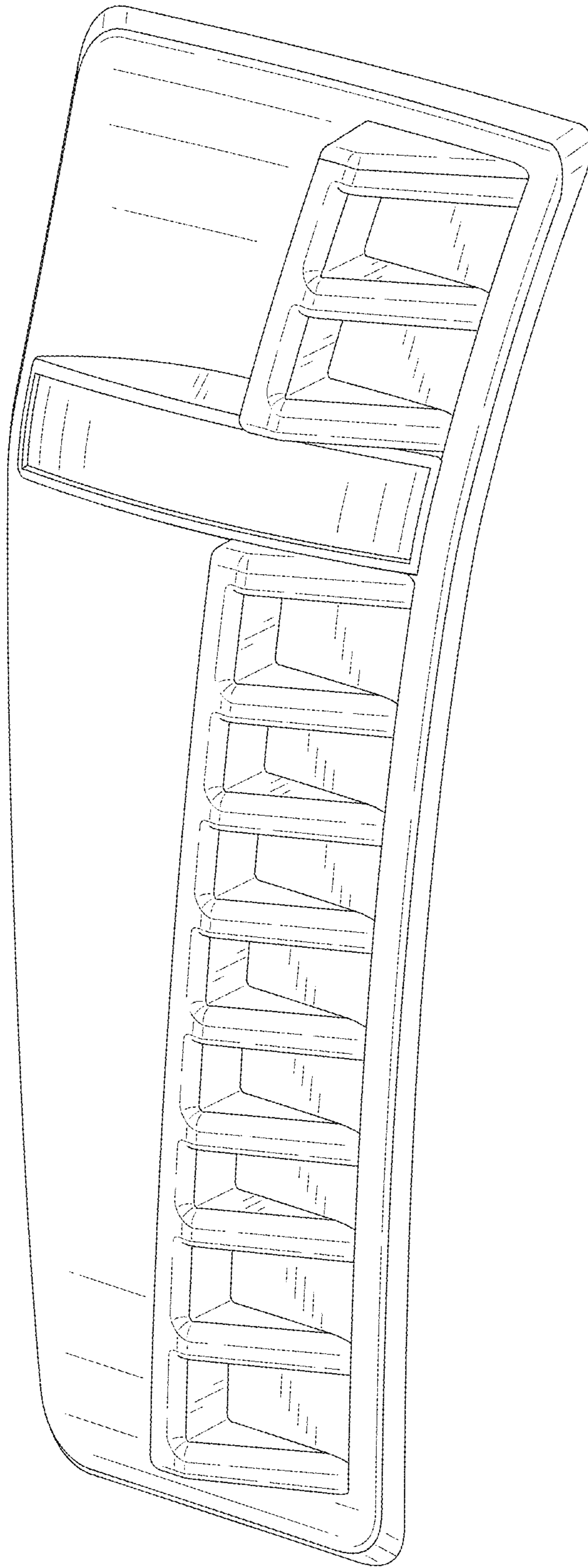

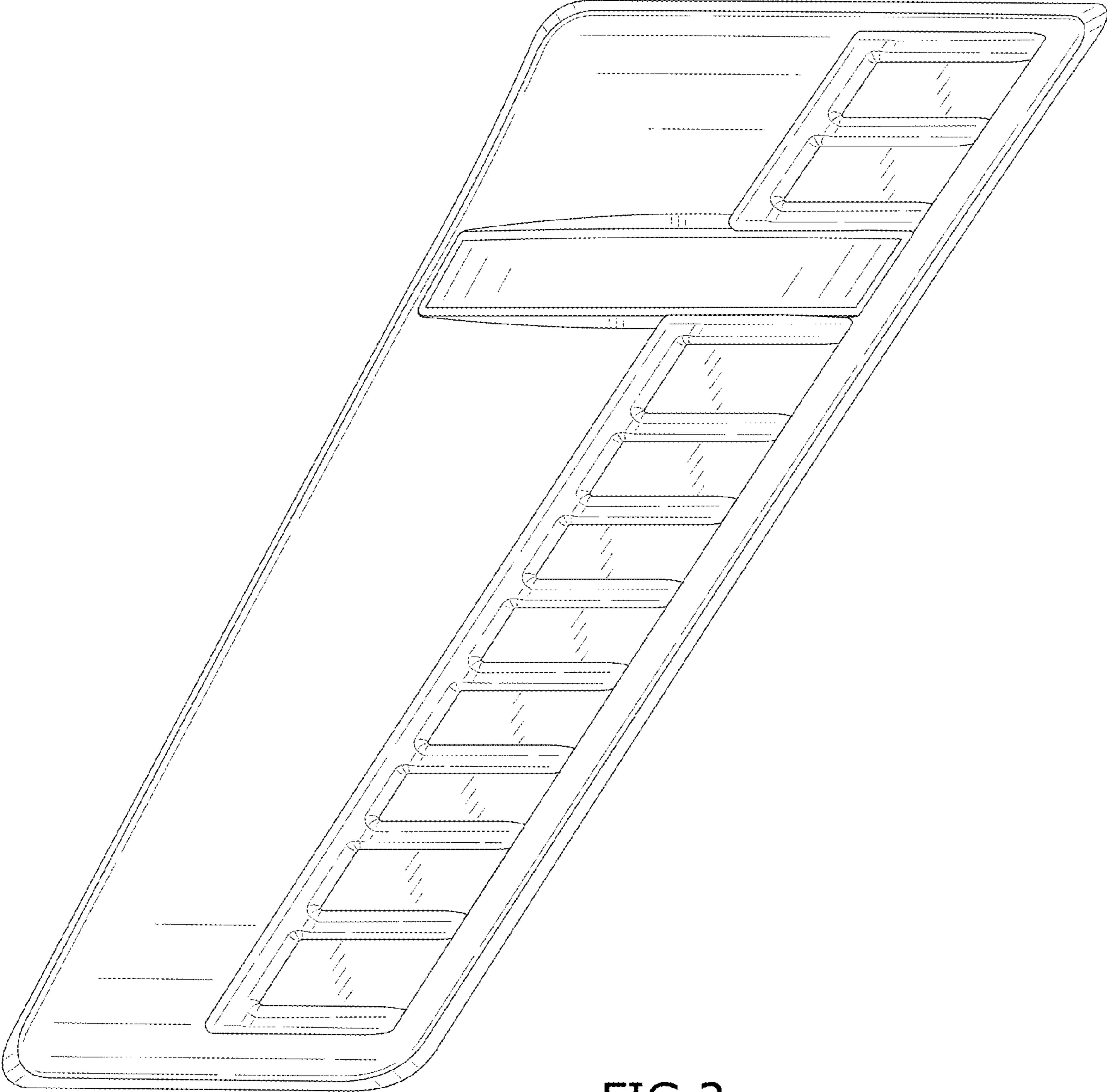

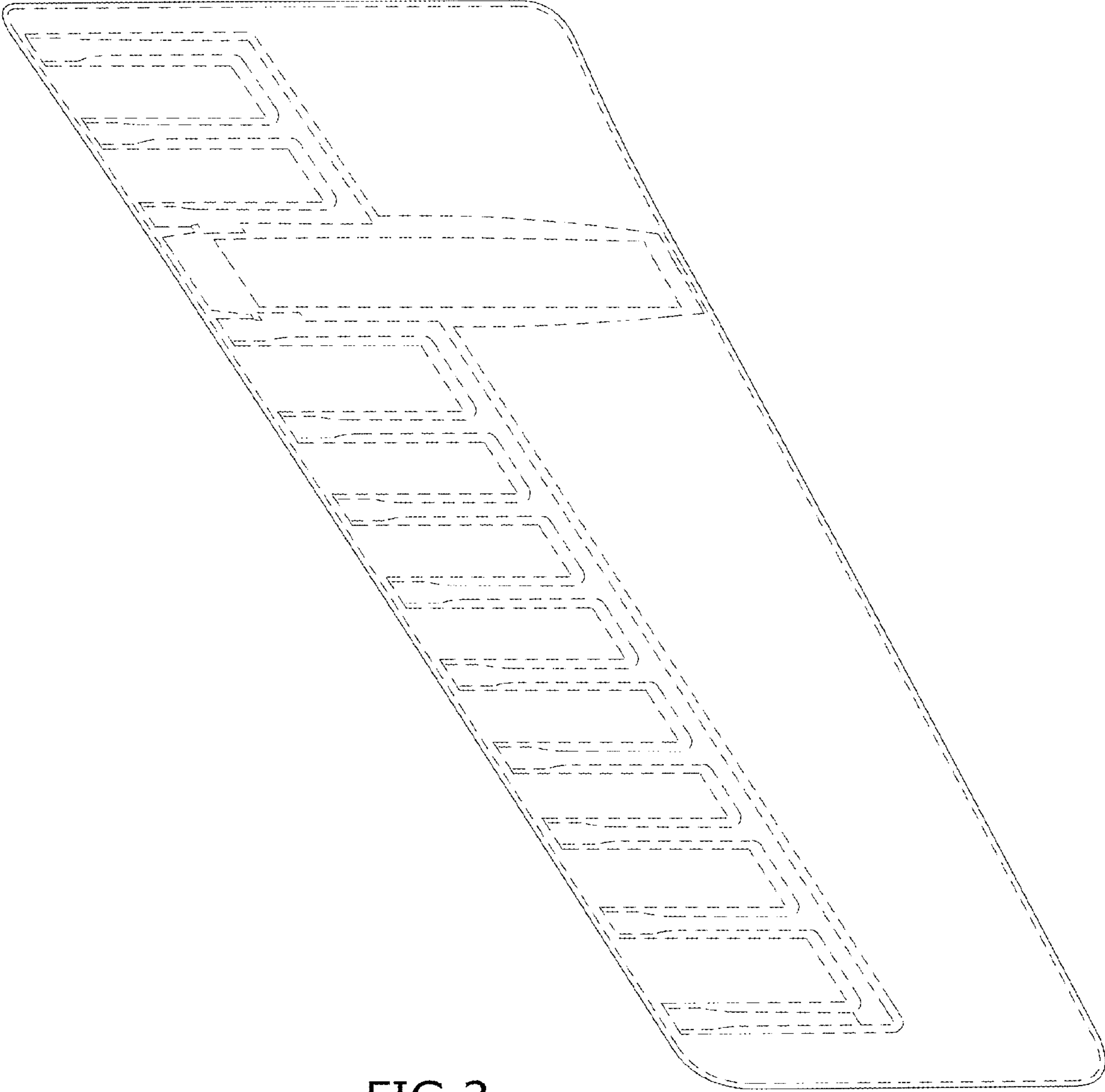

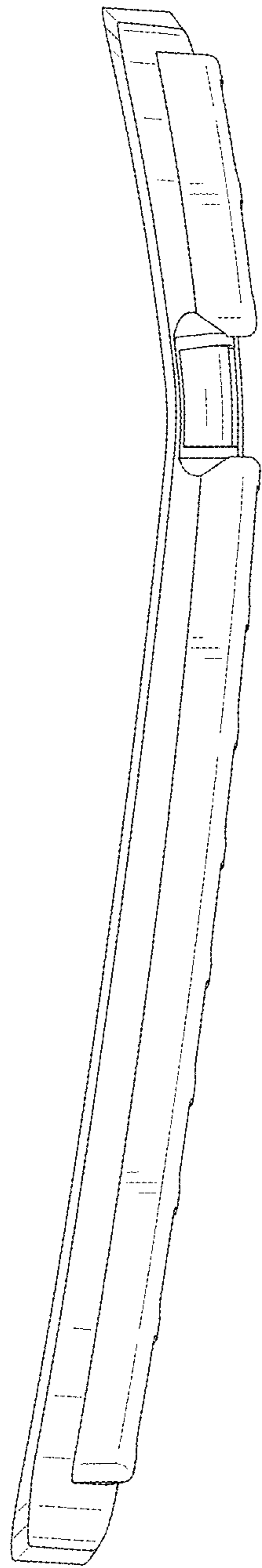

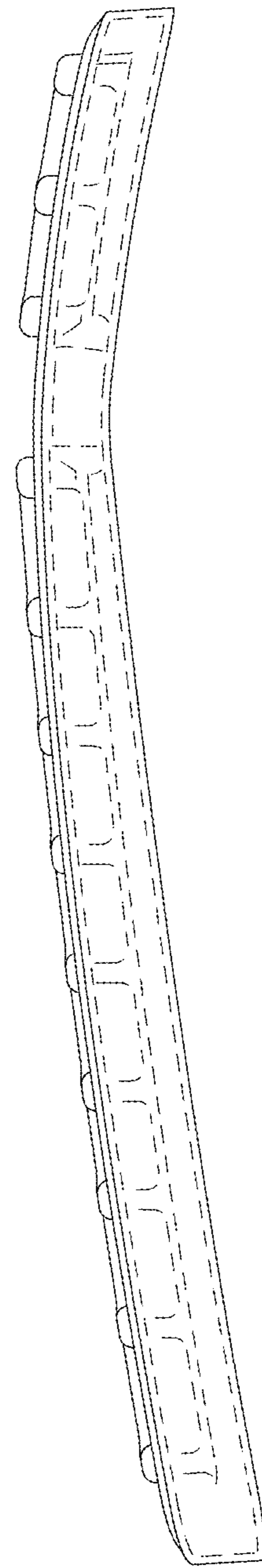

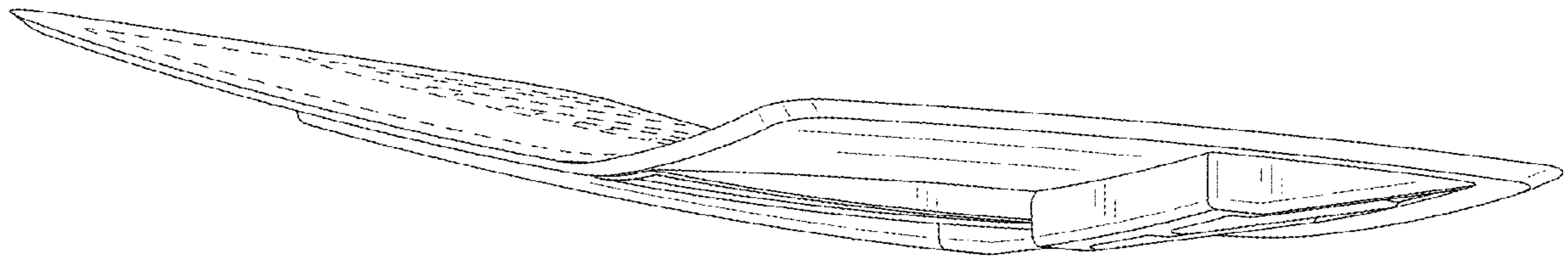

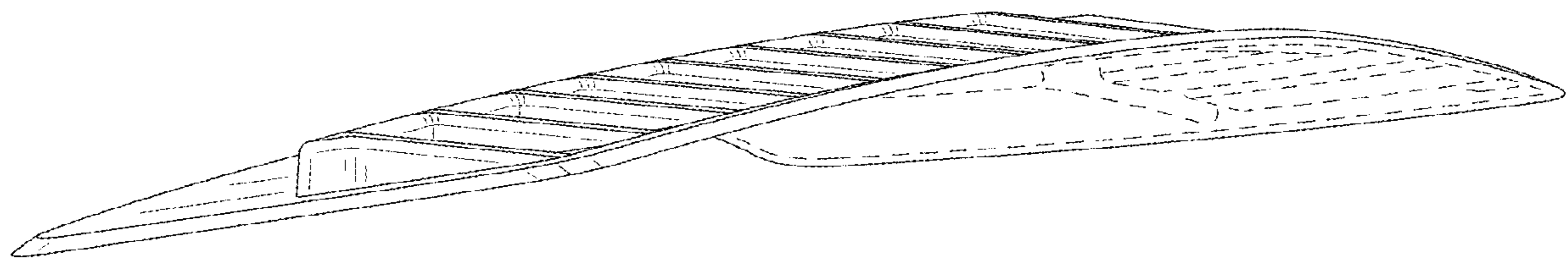
