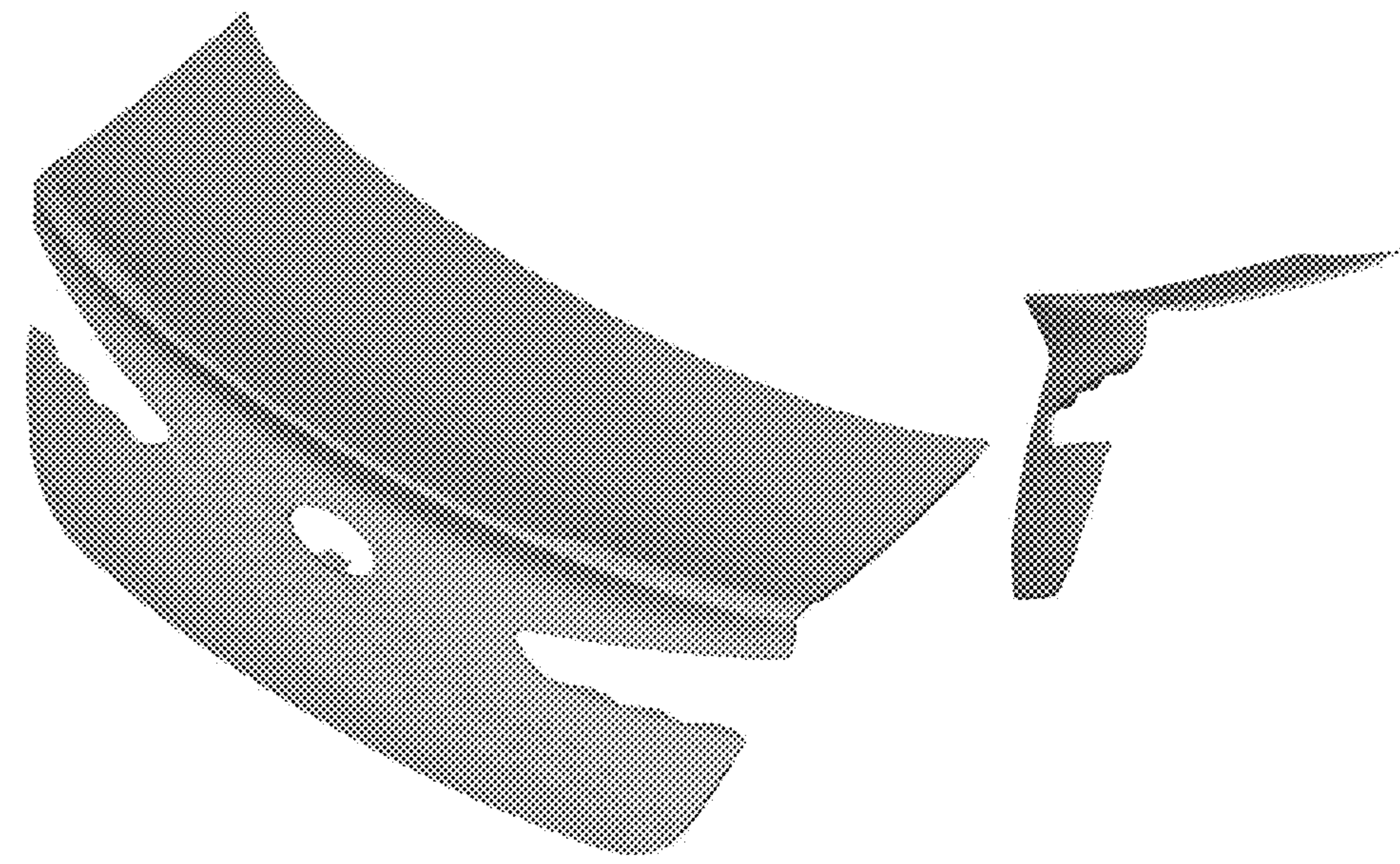

shown and described.

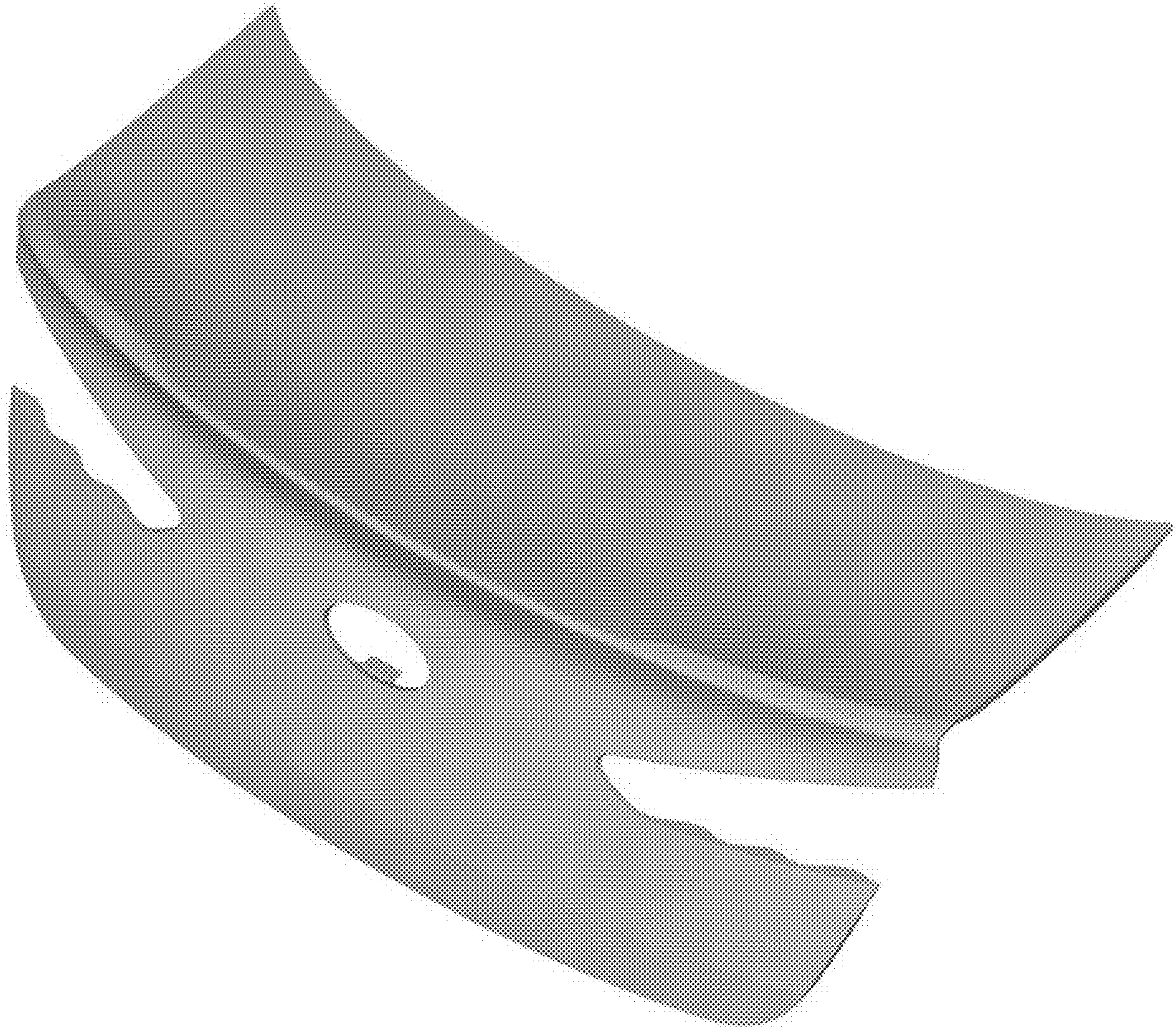
**DESCRIPTION**

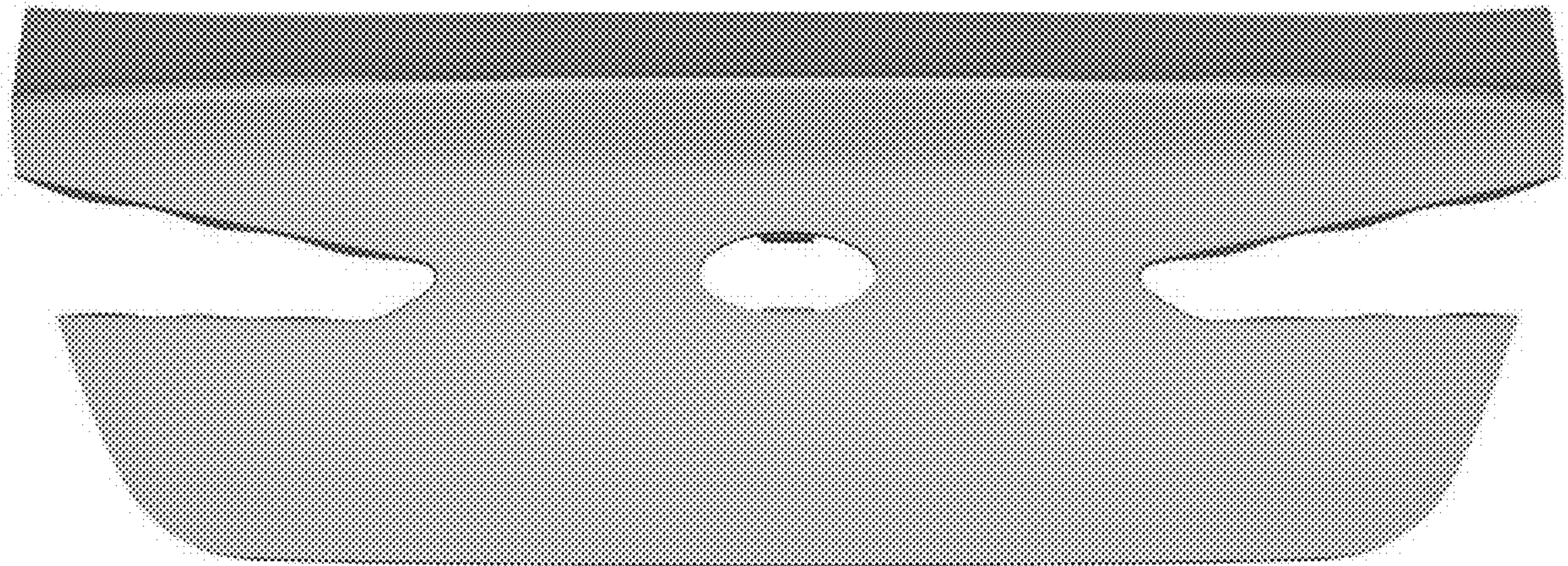

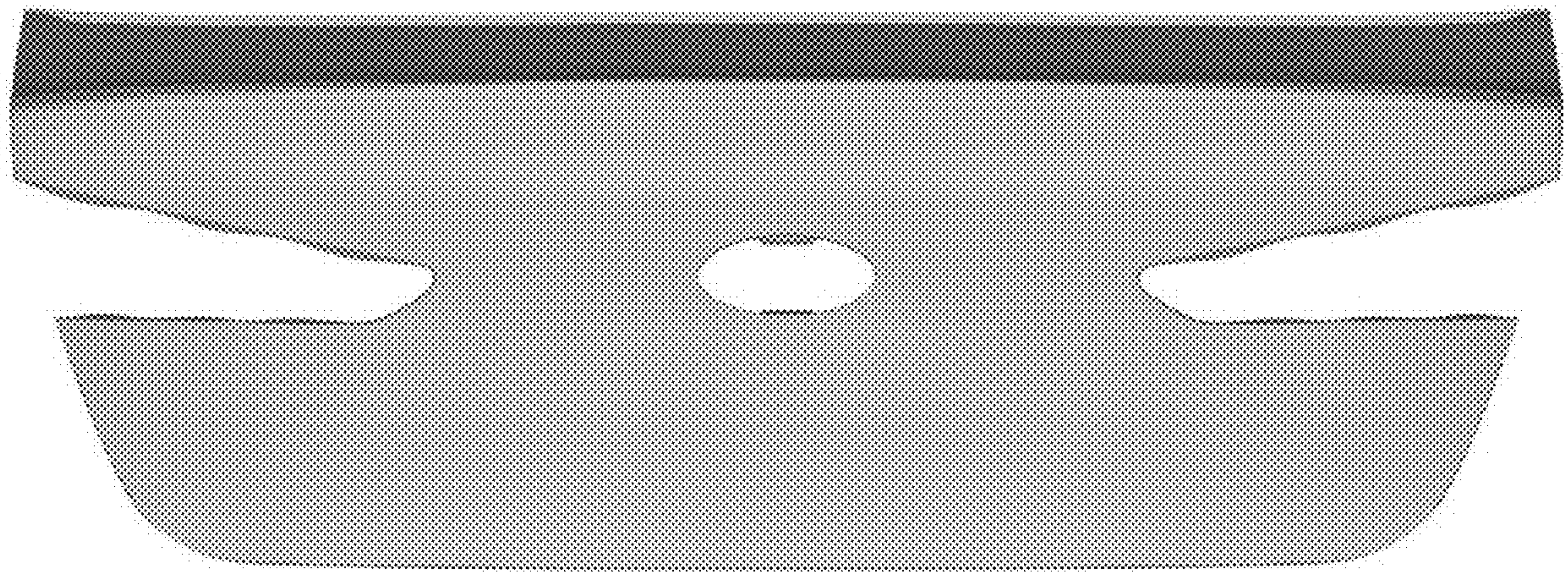

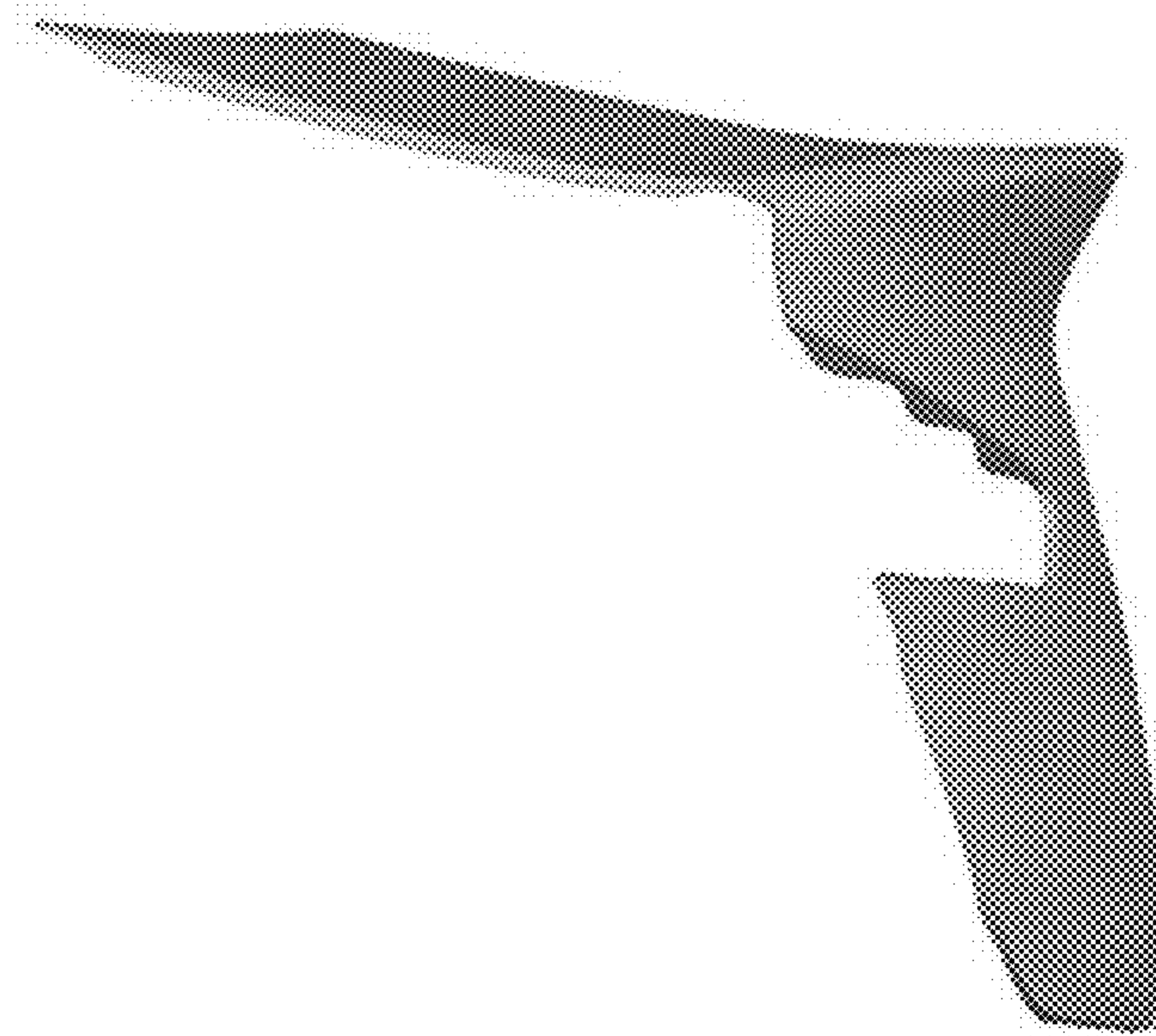




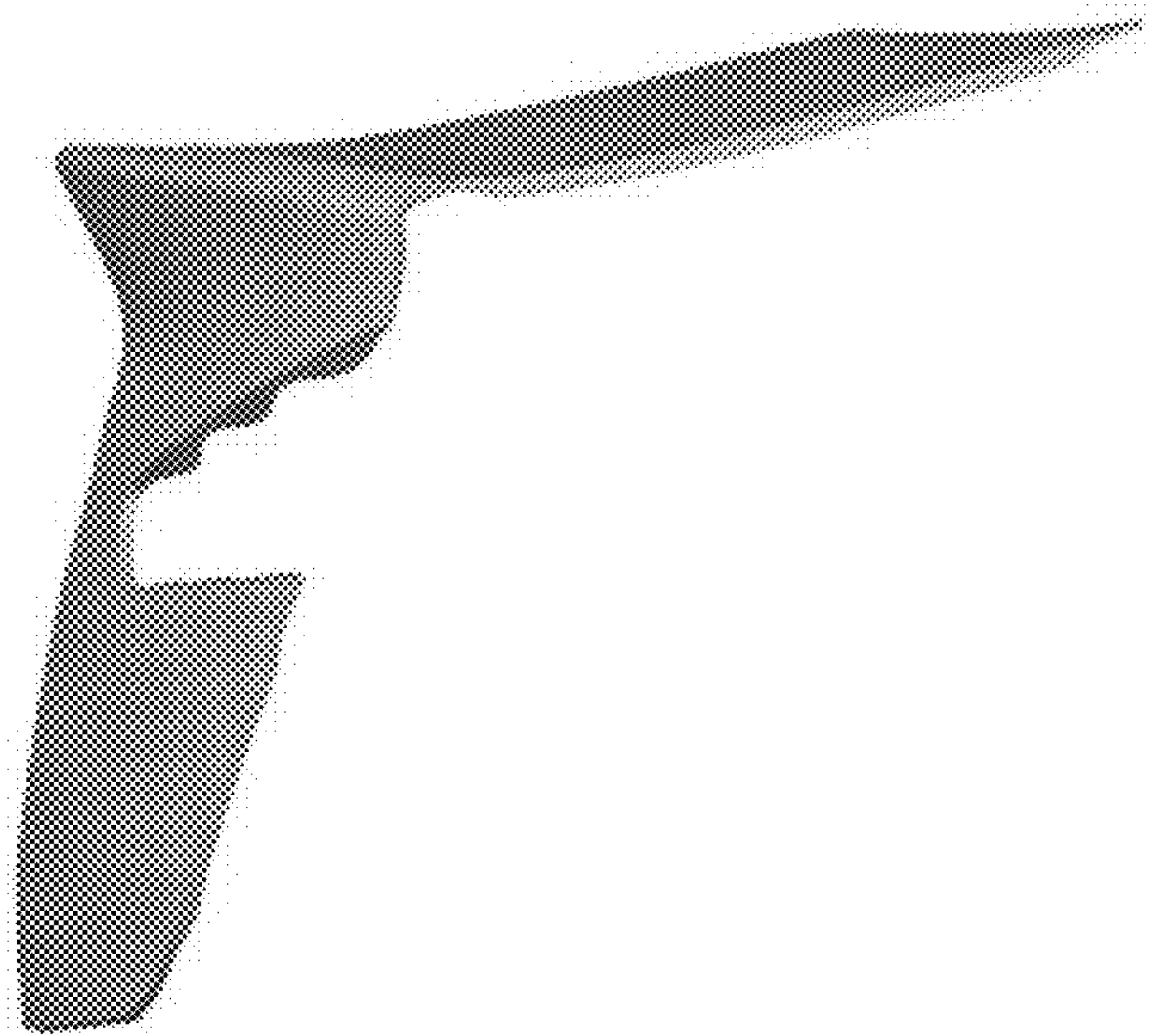

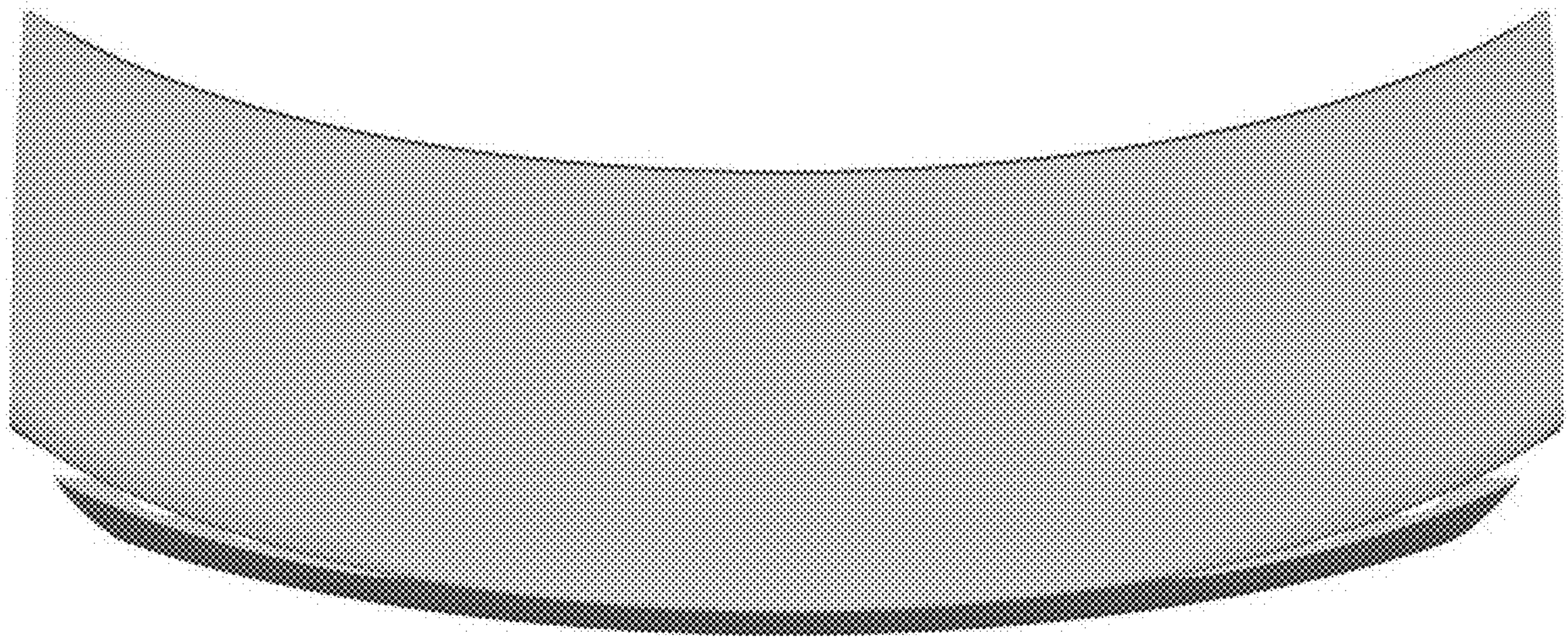
