(57) **CLAIM**

The ornamental design for a display screen with computer-generated graphical user interface, as shown and described.

DESCRIPTION

FIG. 6 is a sixth image thereof; and,

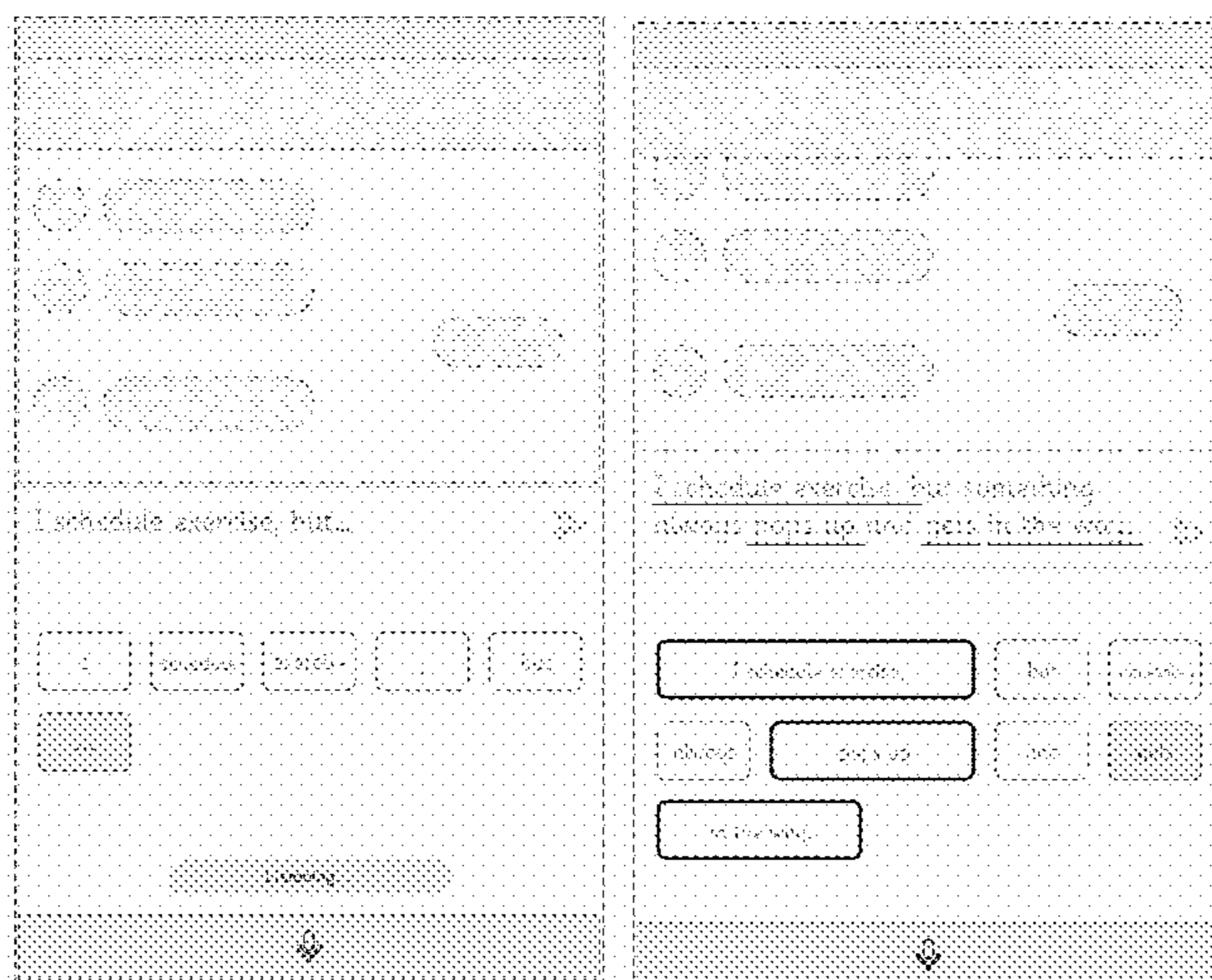
FIG. 7 is a seventh image thereof.

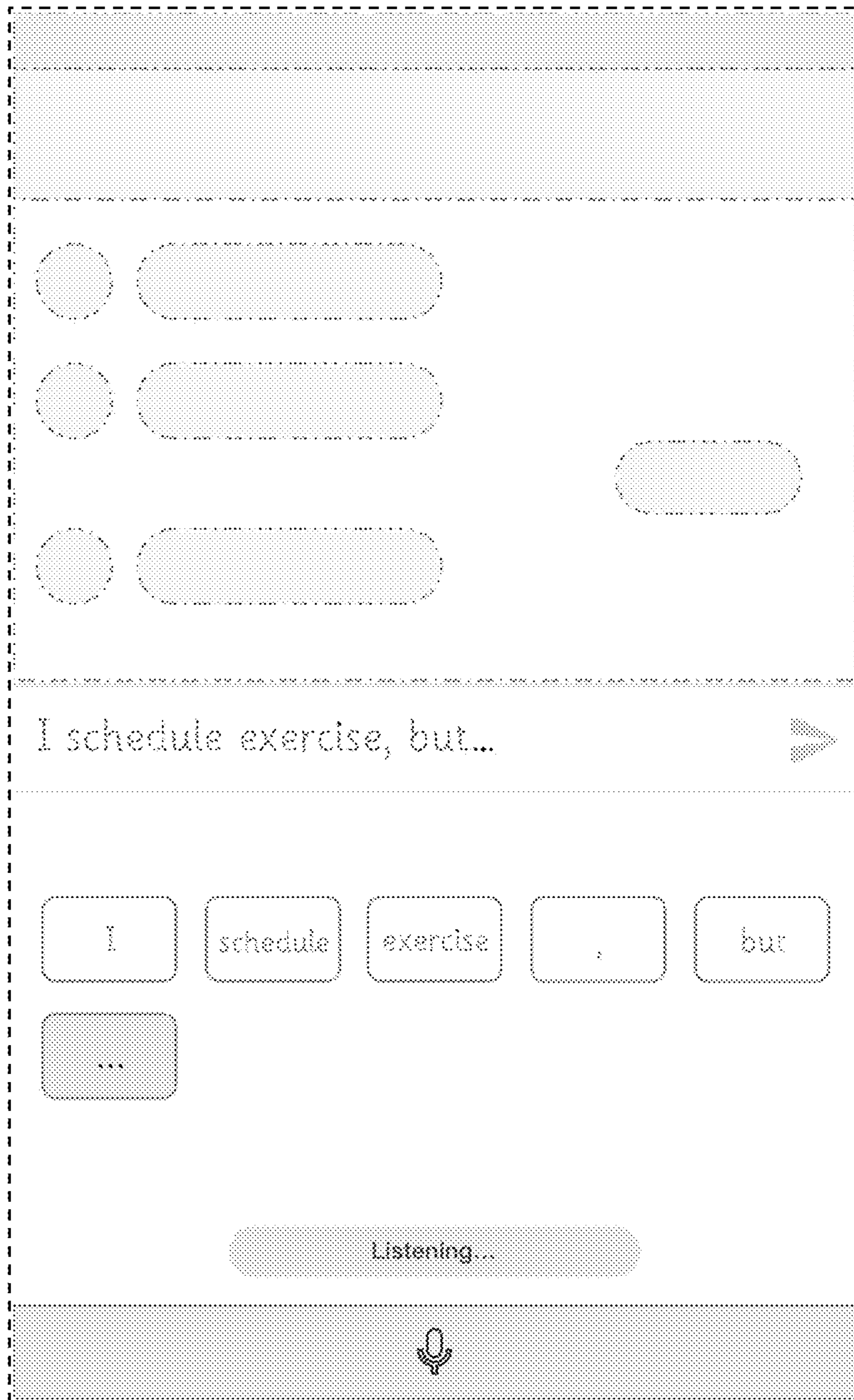

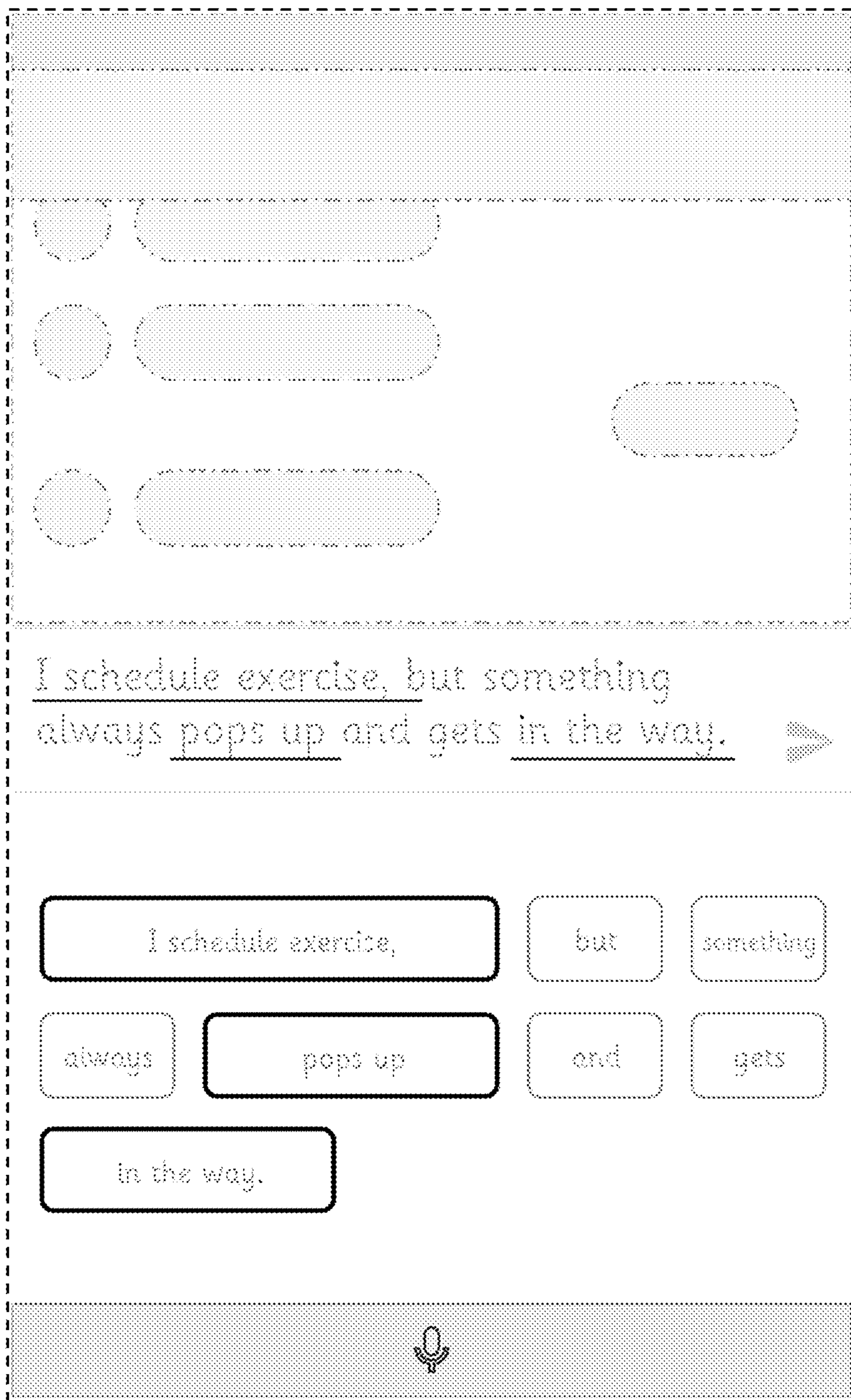

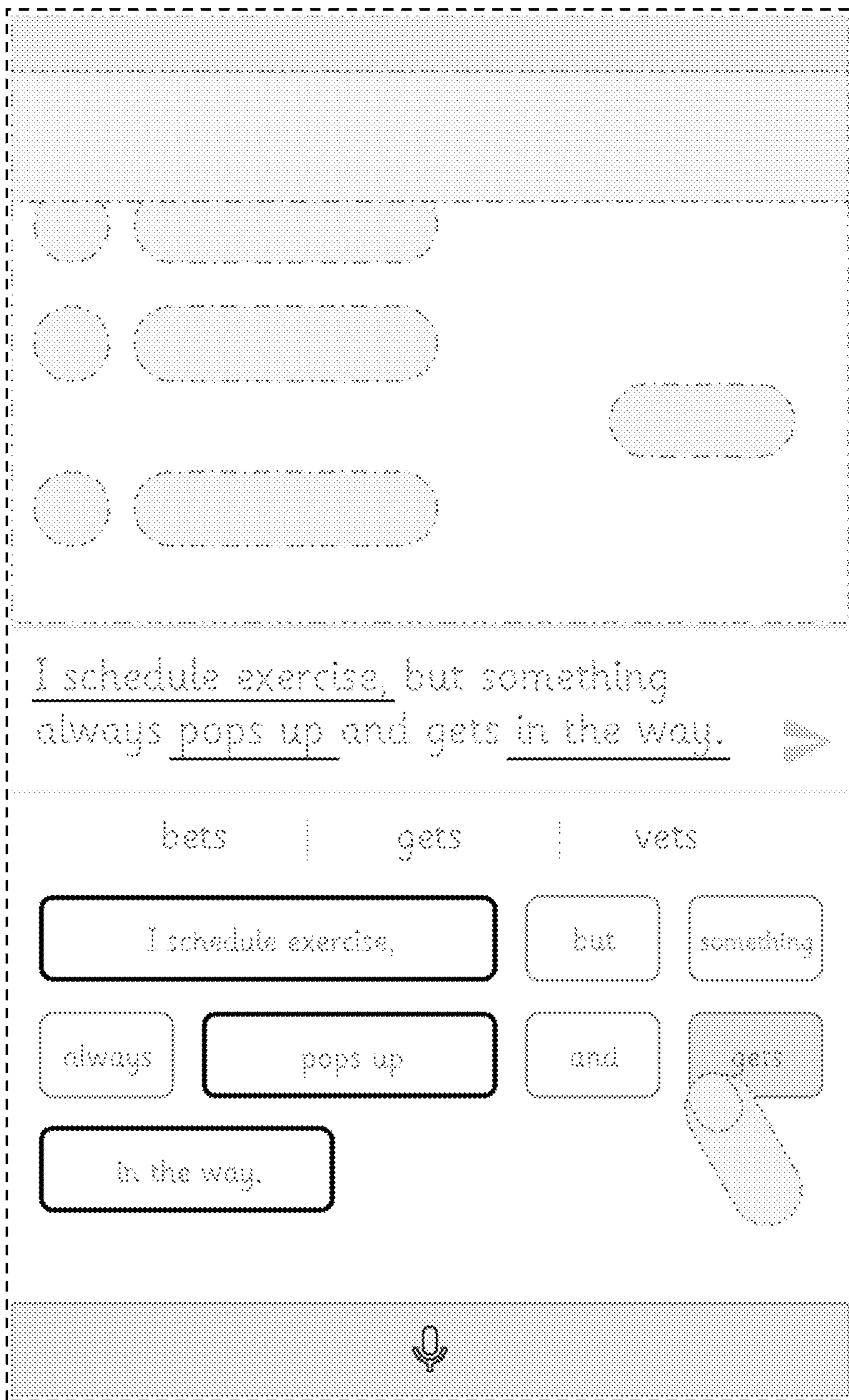

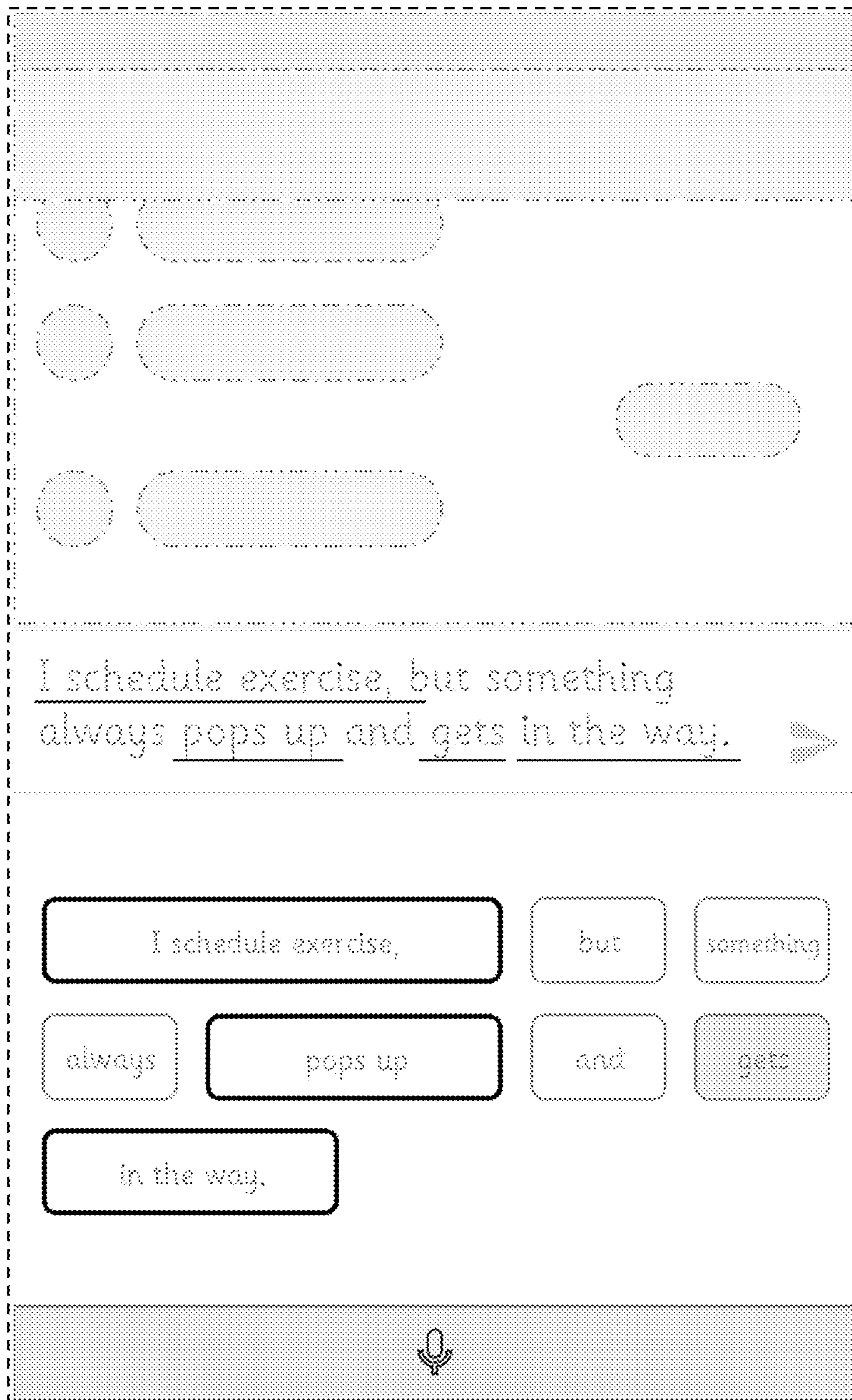

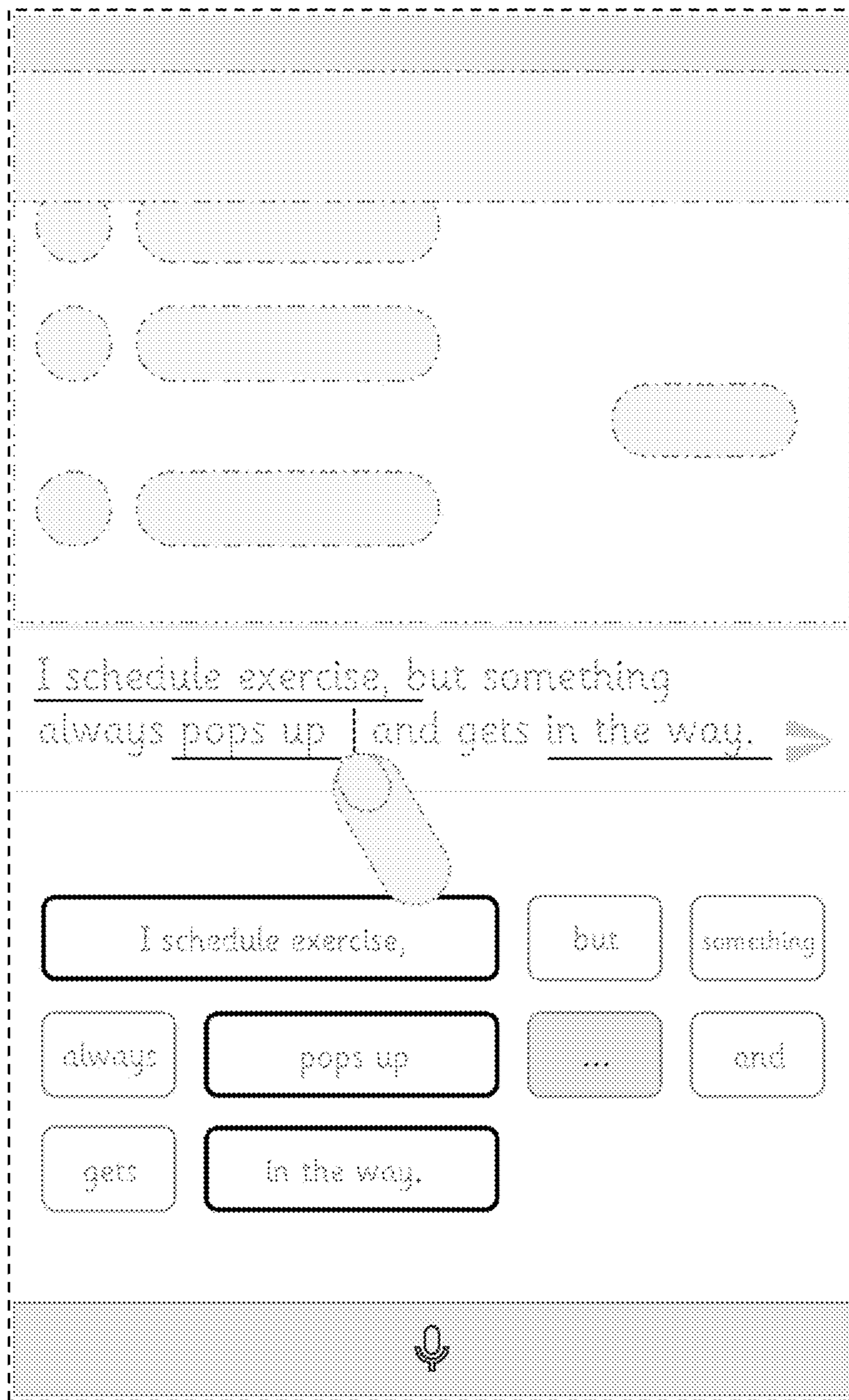

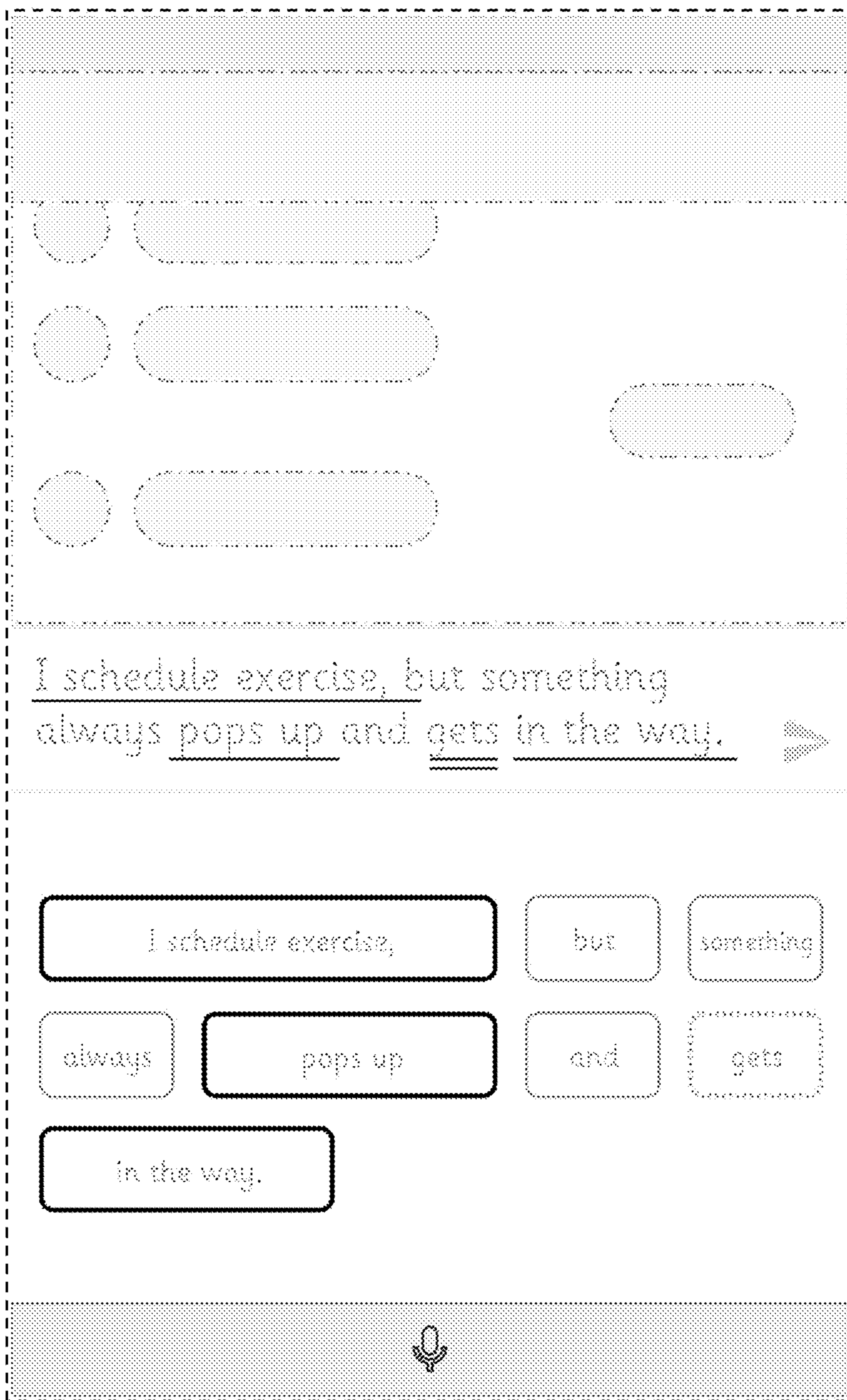

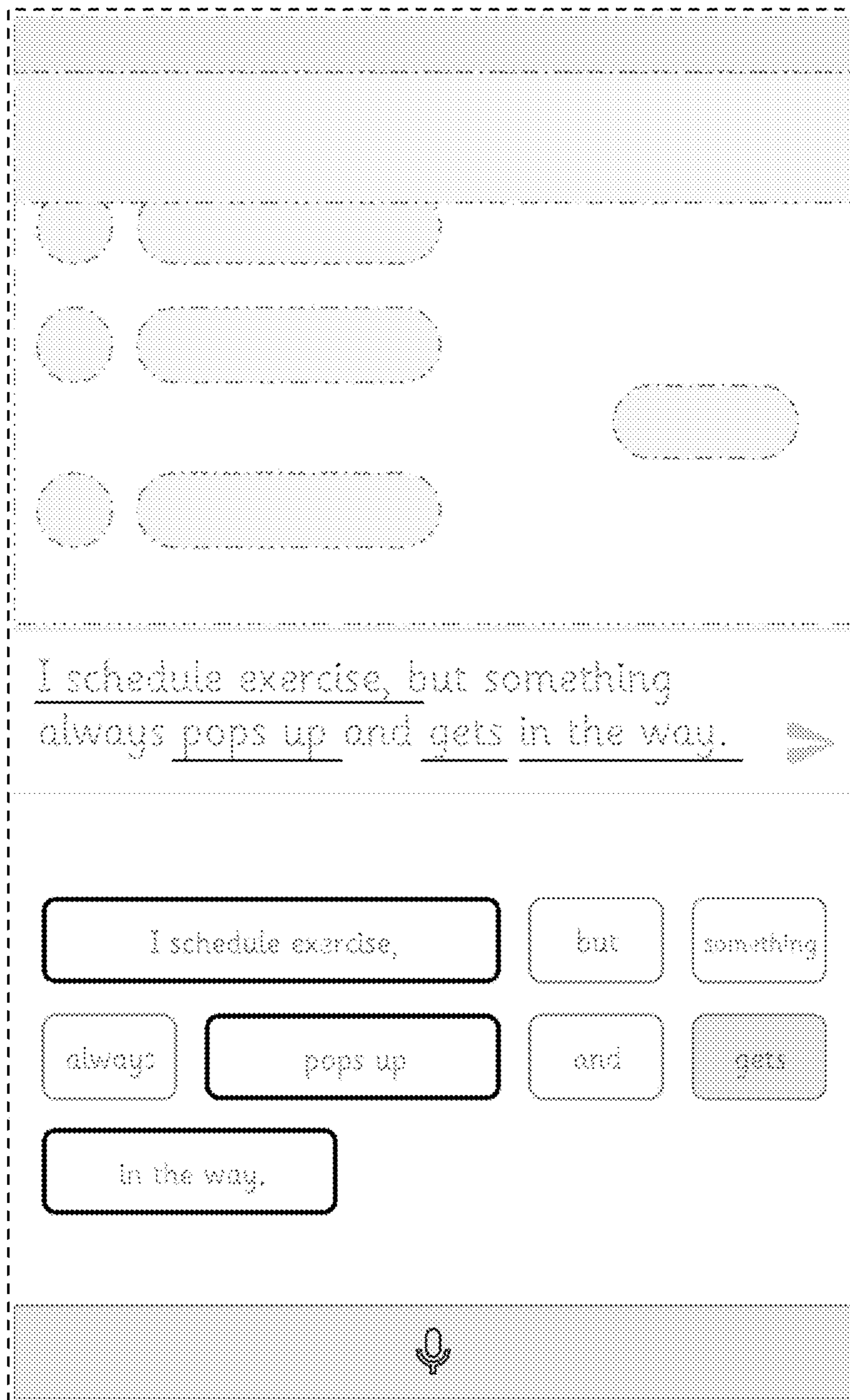
