(57) **CLAIM**

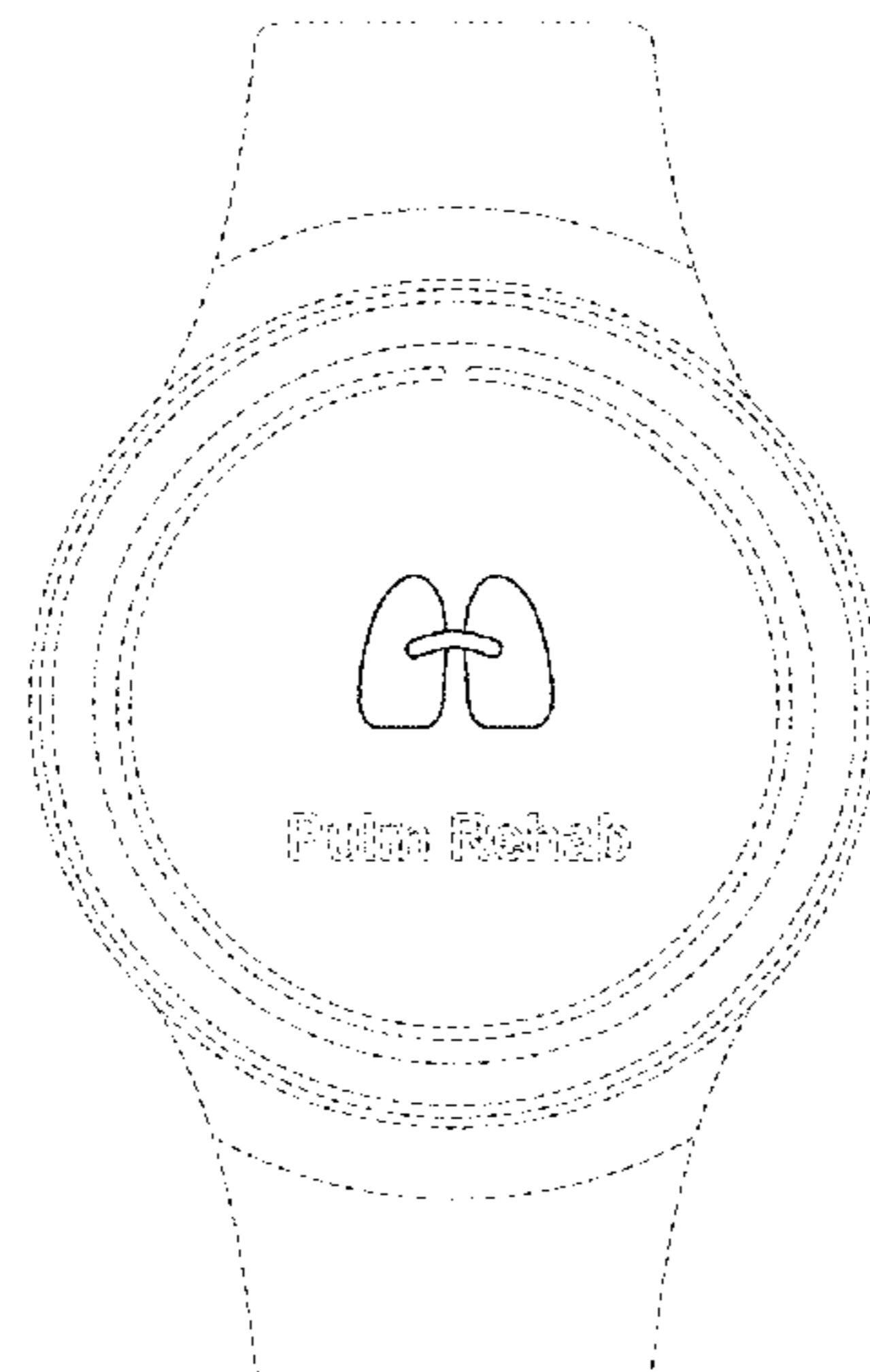
The ornamental design for display screen or portion thereof with icon, as shown and described.
