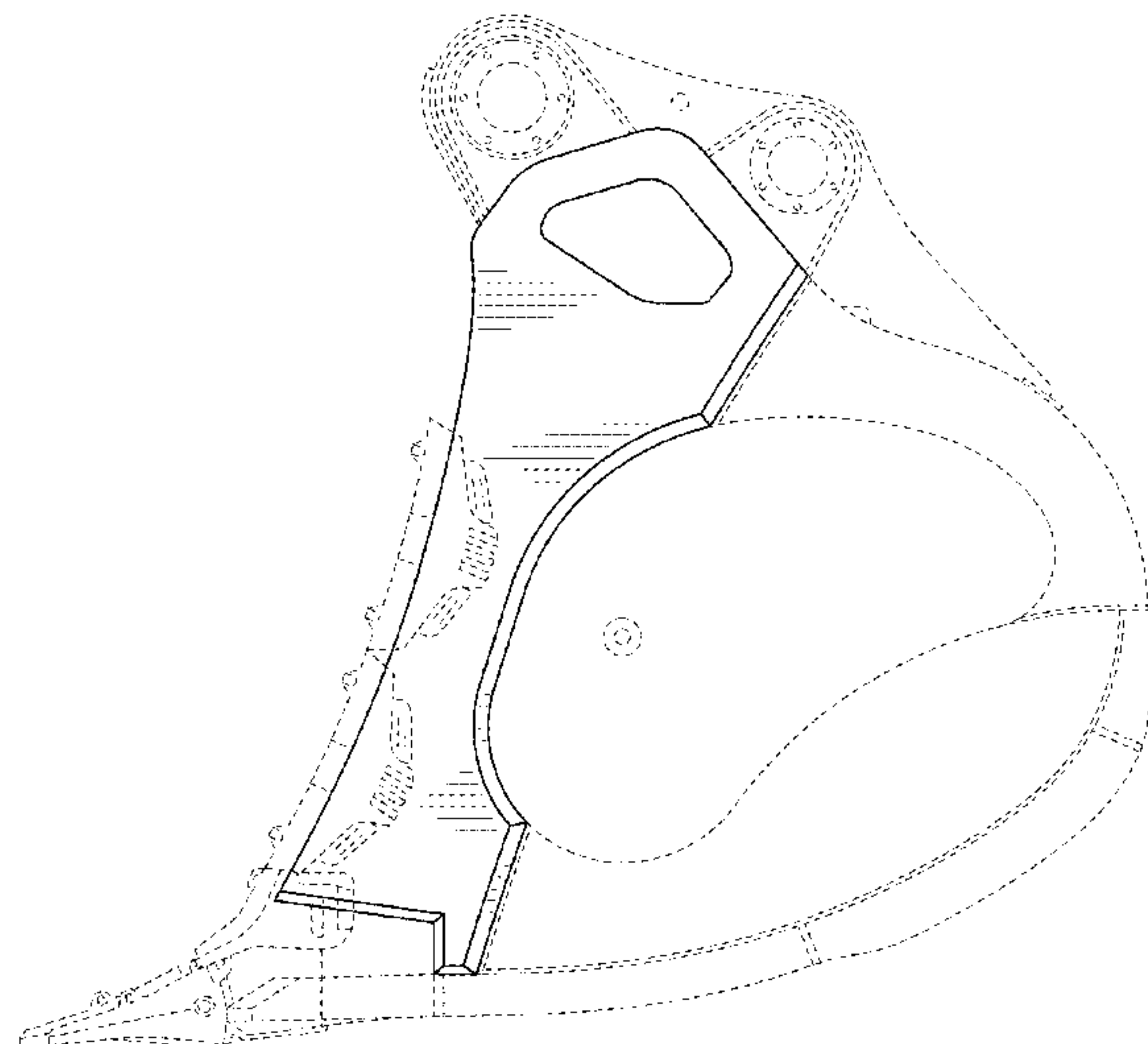
(57) **CLAIM**

The ornamental design for a light weight bucket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a light weight bucket according to our design;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

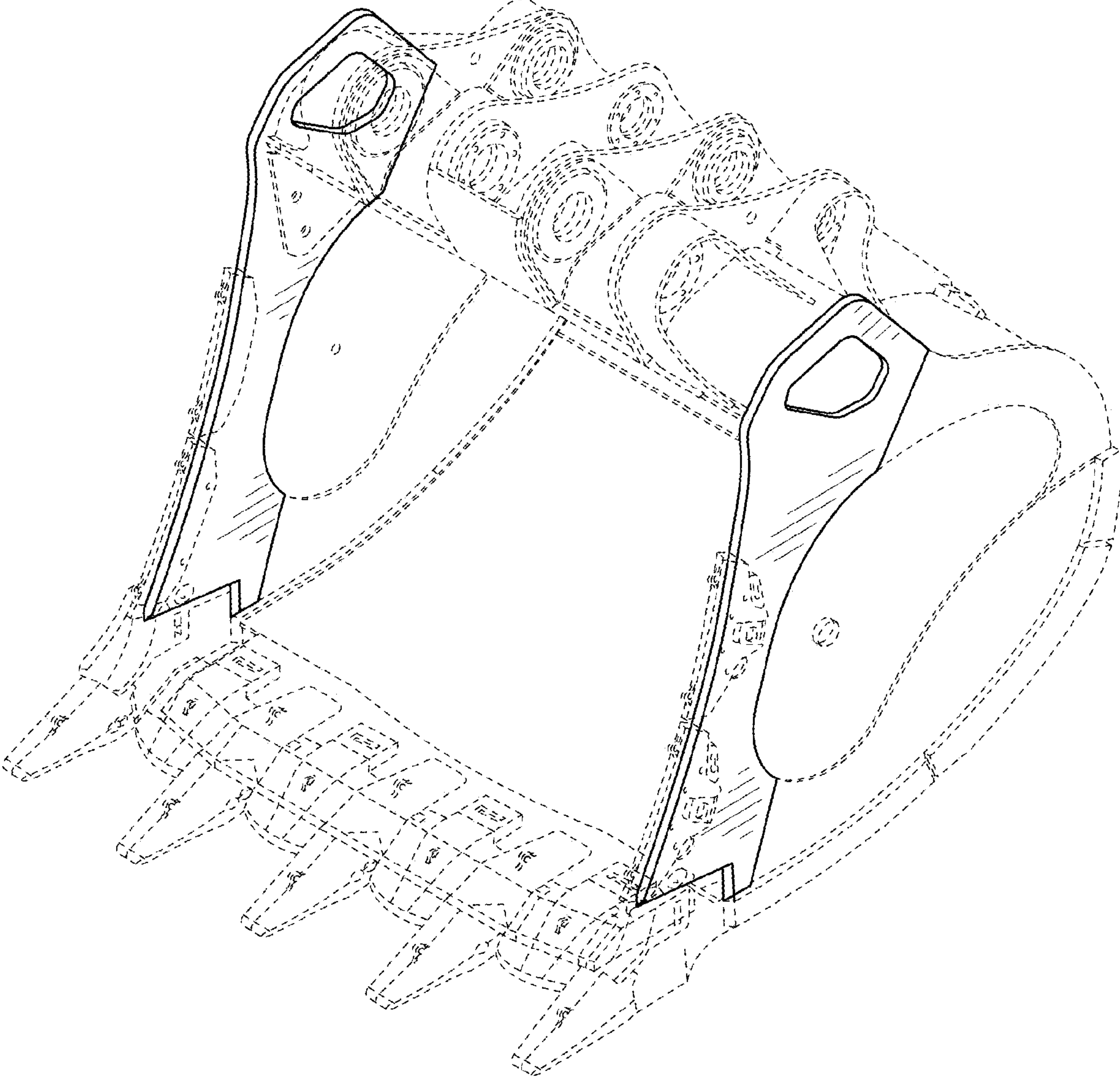

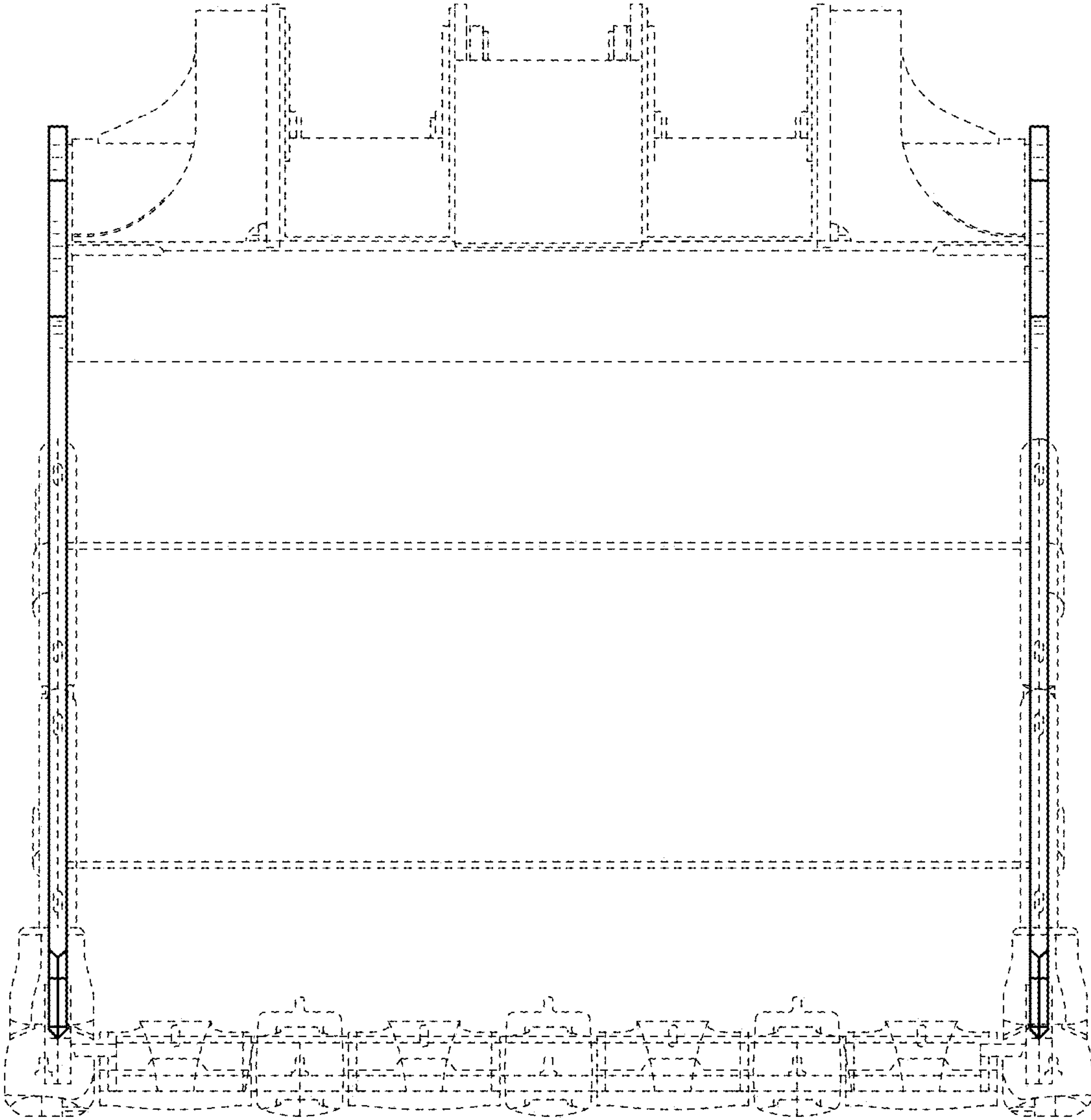

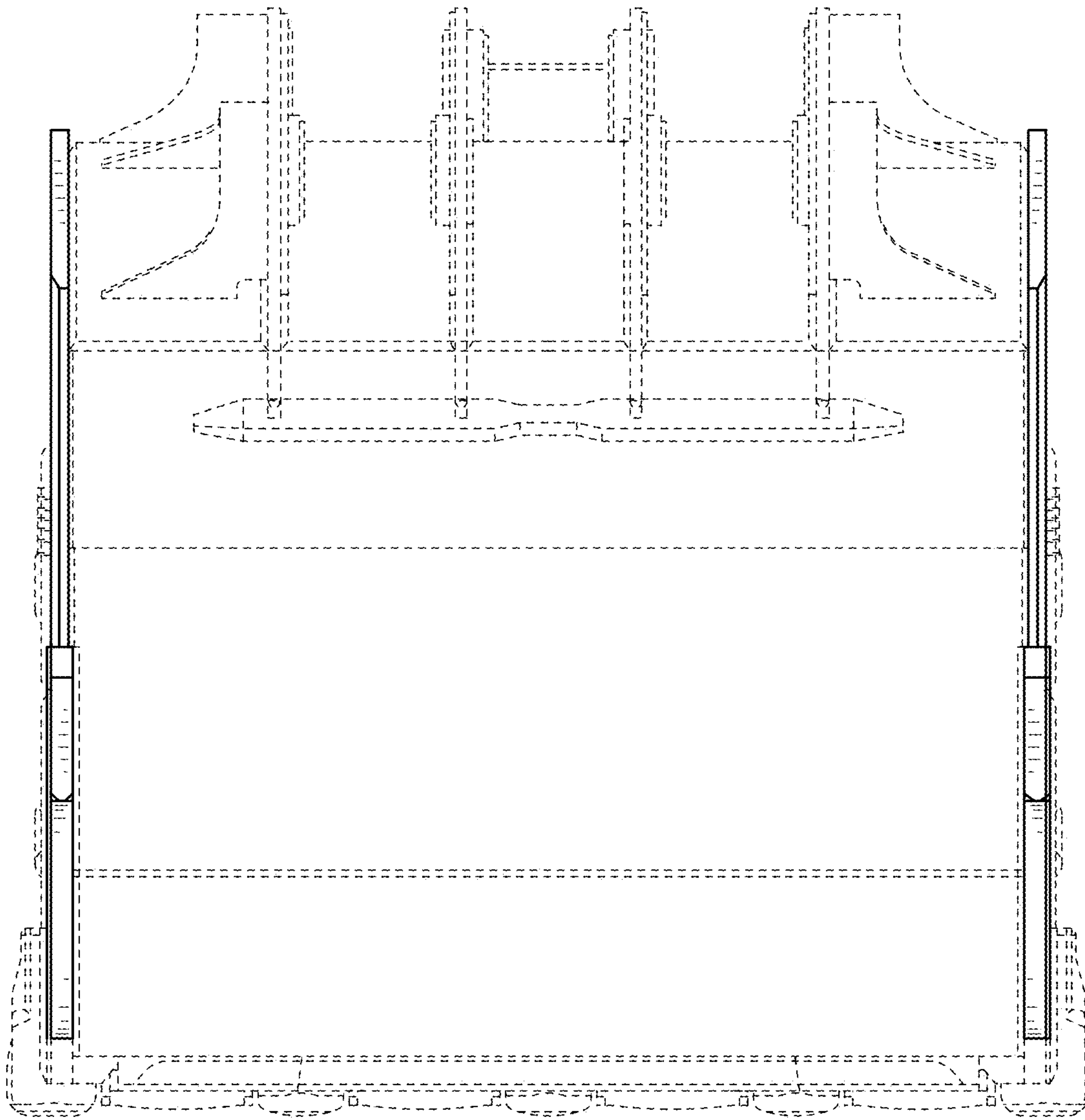

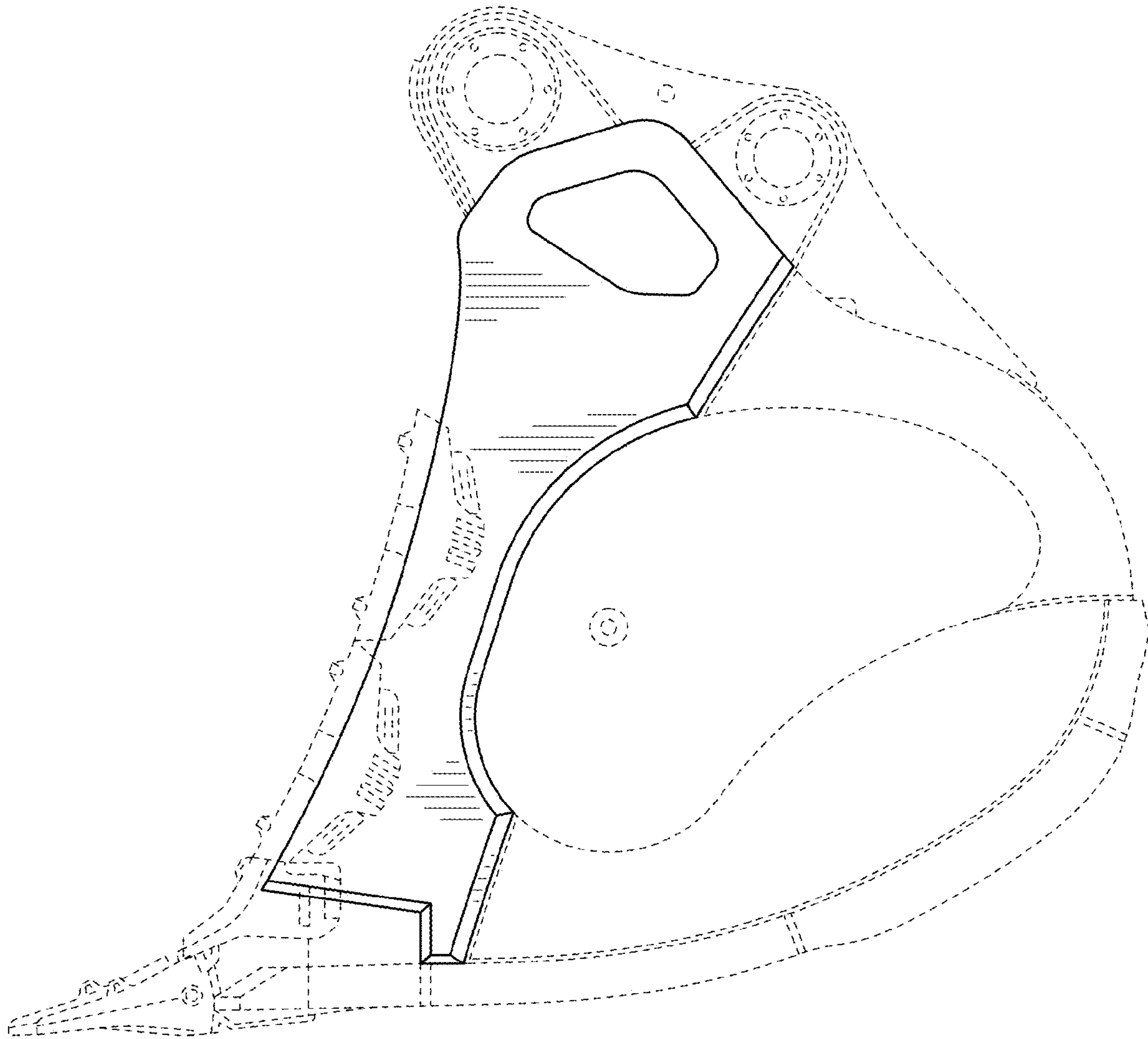

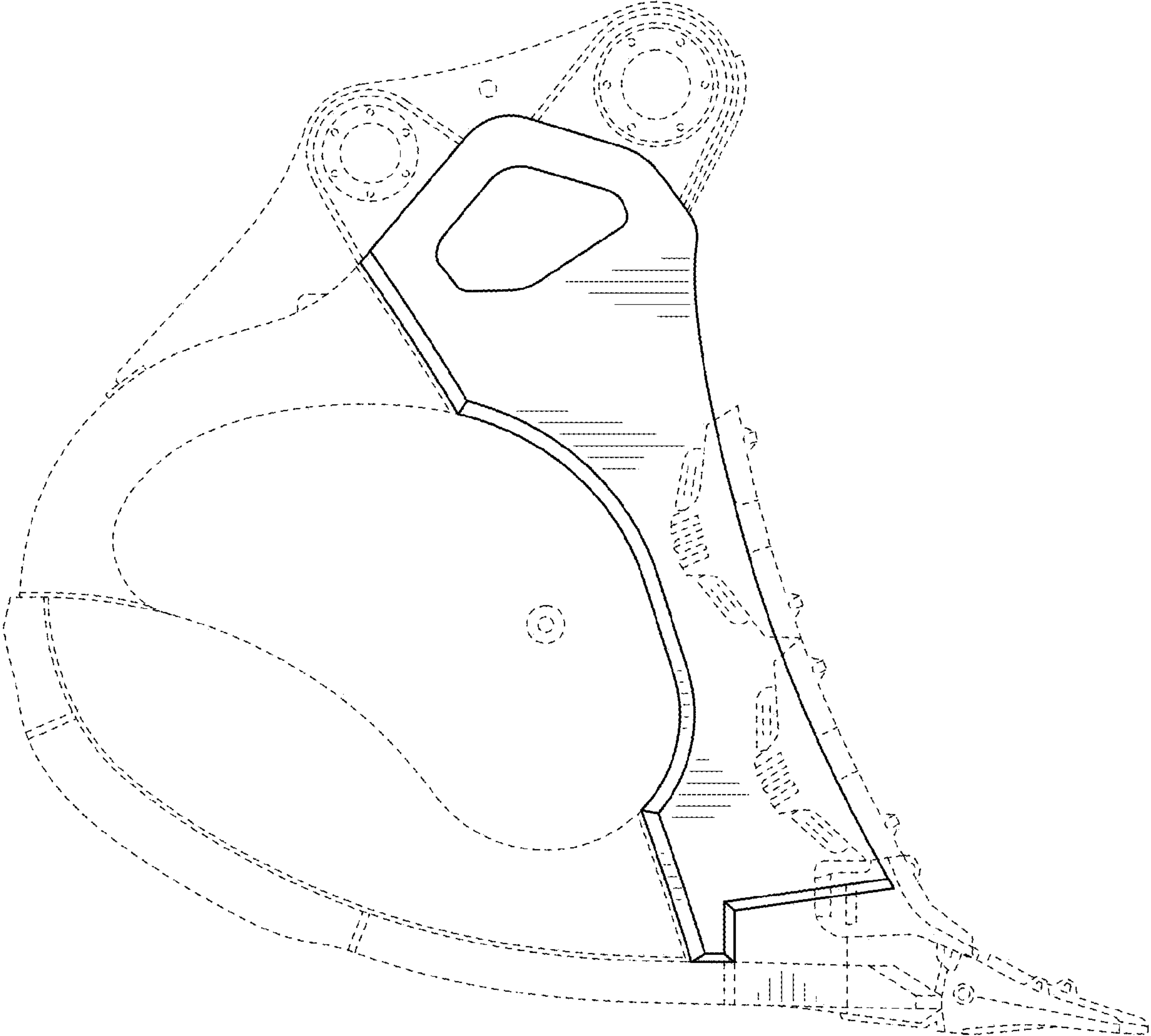

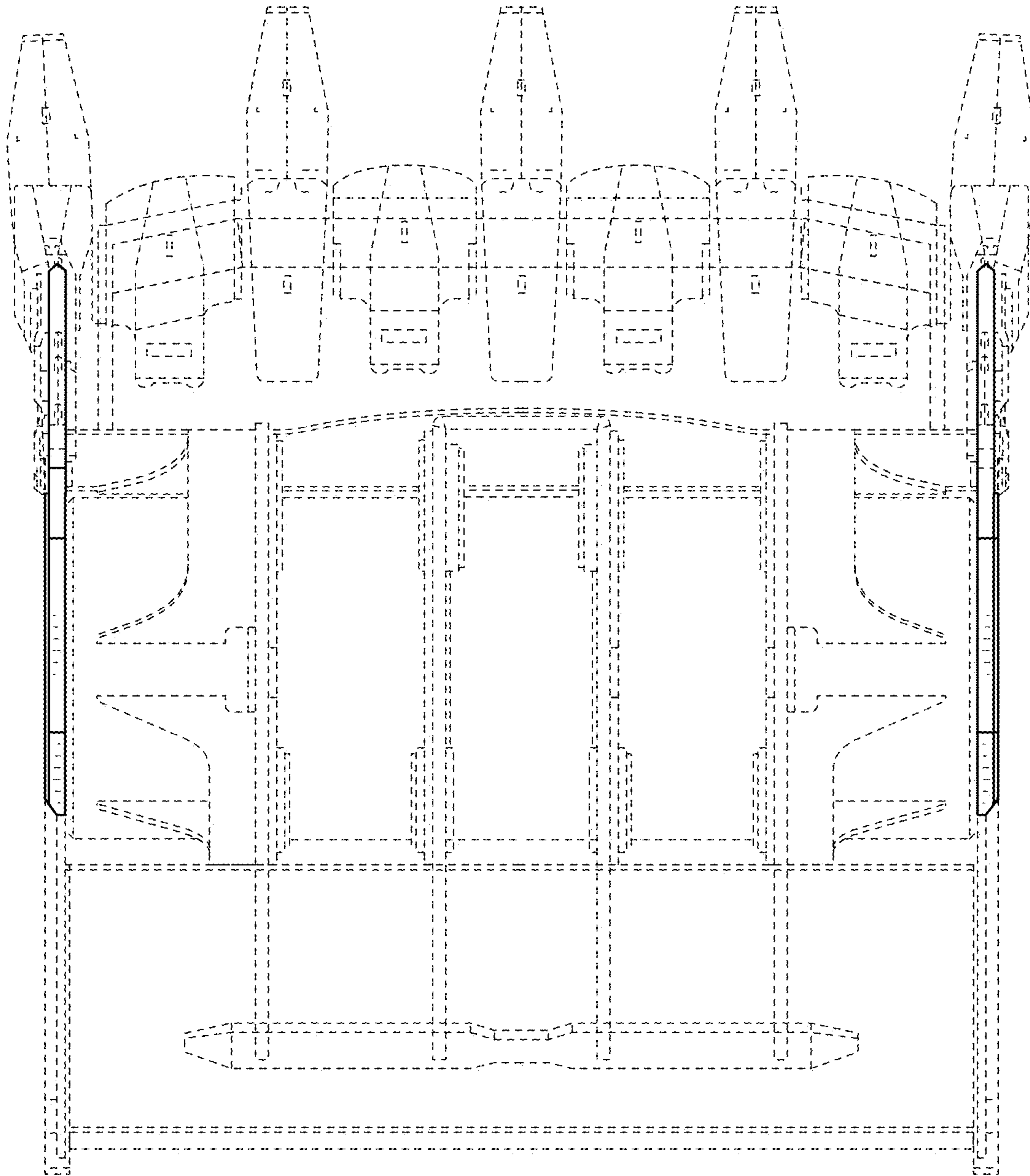

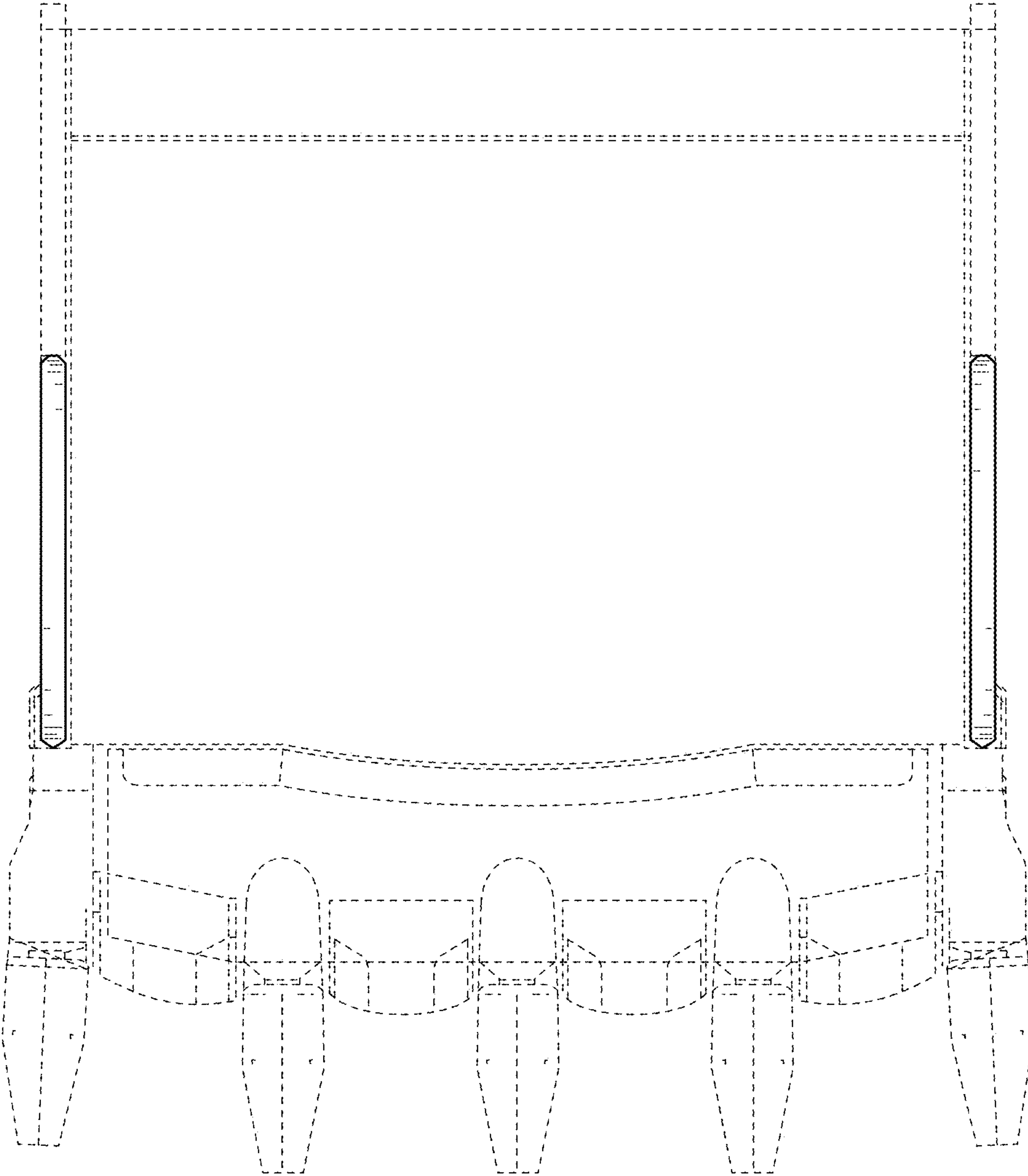
