(57) **CLAIM**

The ornamental design for a dunnage conversion machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front, top, and left side of a dunnage conversion machine provided by the invention; FIG. 2 is a perspective view of a rear, top, and right side of the dunnage conversion machine of FIG. 1;

FIG. 3 is a front side view of the dunnage conversion machine of FIG. 1;

FIG. 4 is a rear side view of the dunnage conversion machine of FIG. 1;

FIG. 5 is a right side view of the dunnage conversion machine of FIG. 1;

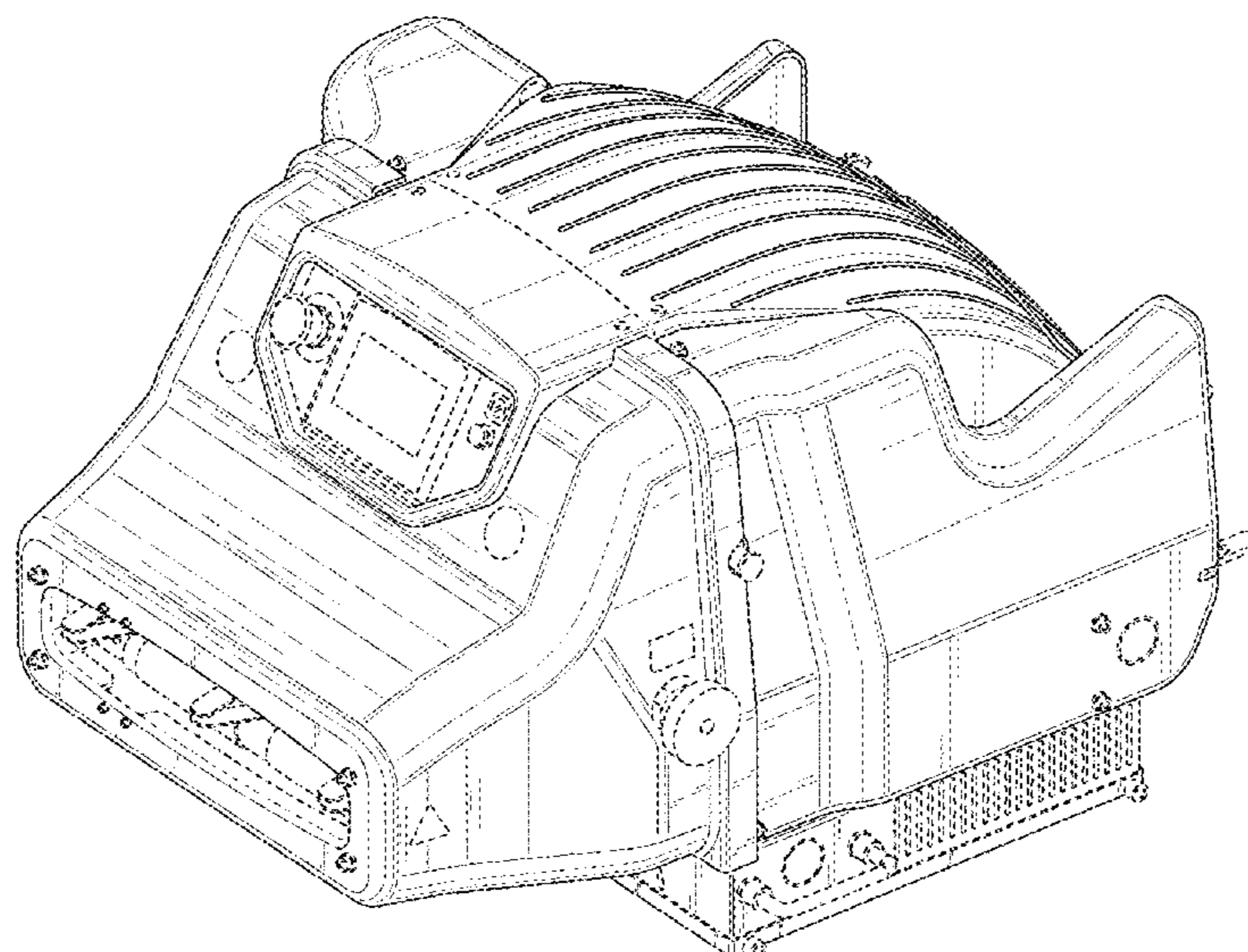
FIG. 6 is a left side view of the dunnage conversion machine of FIG. 1;

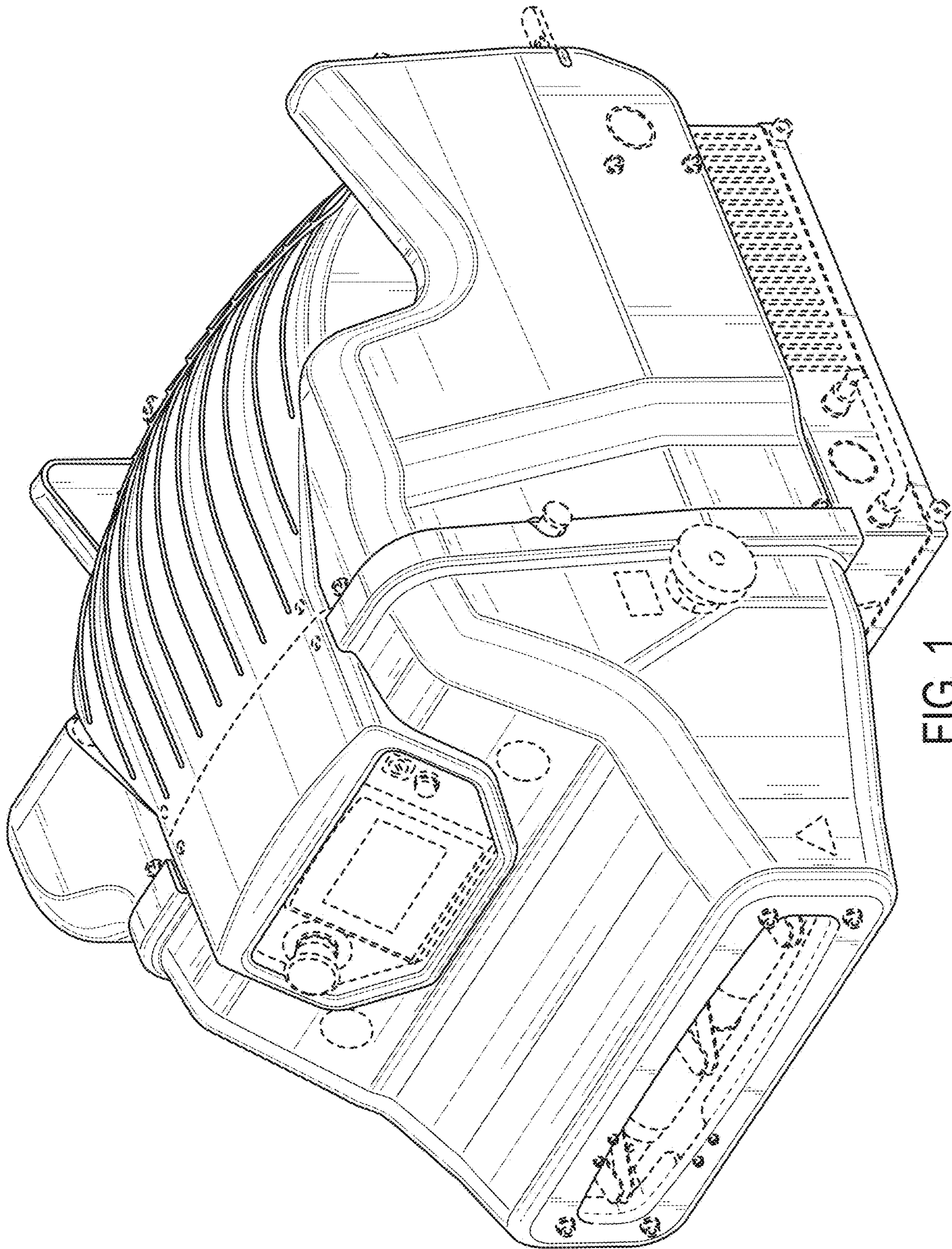

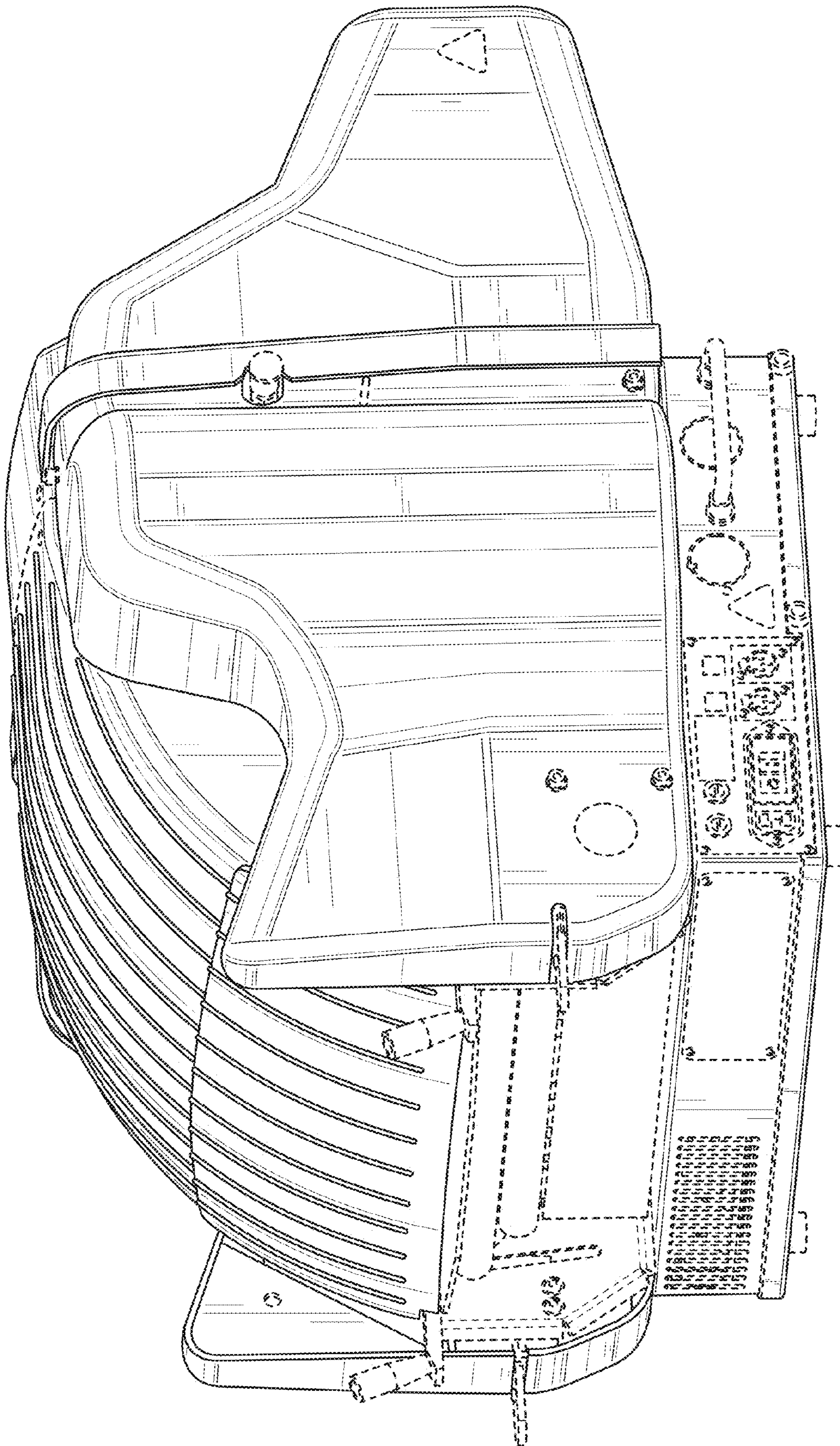

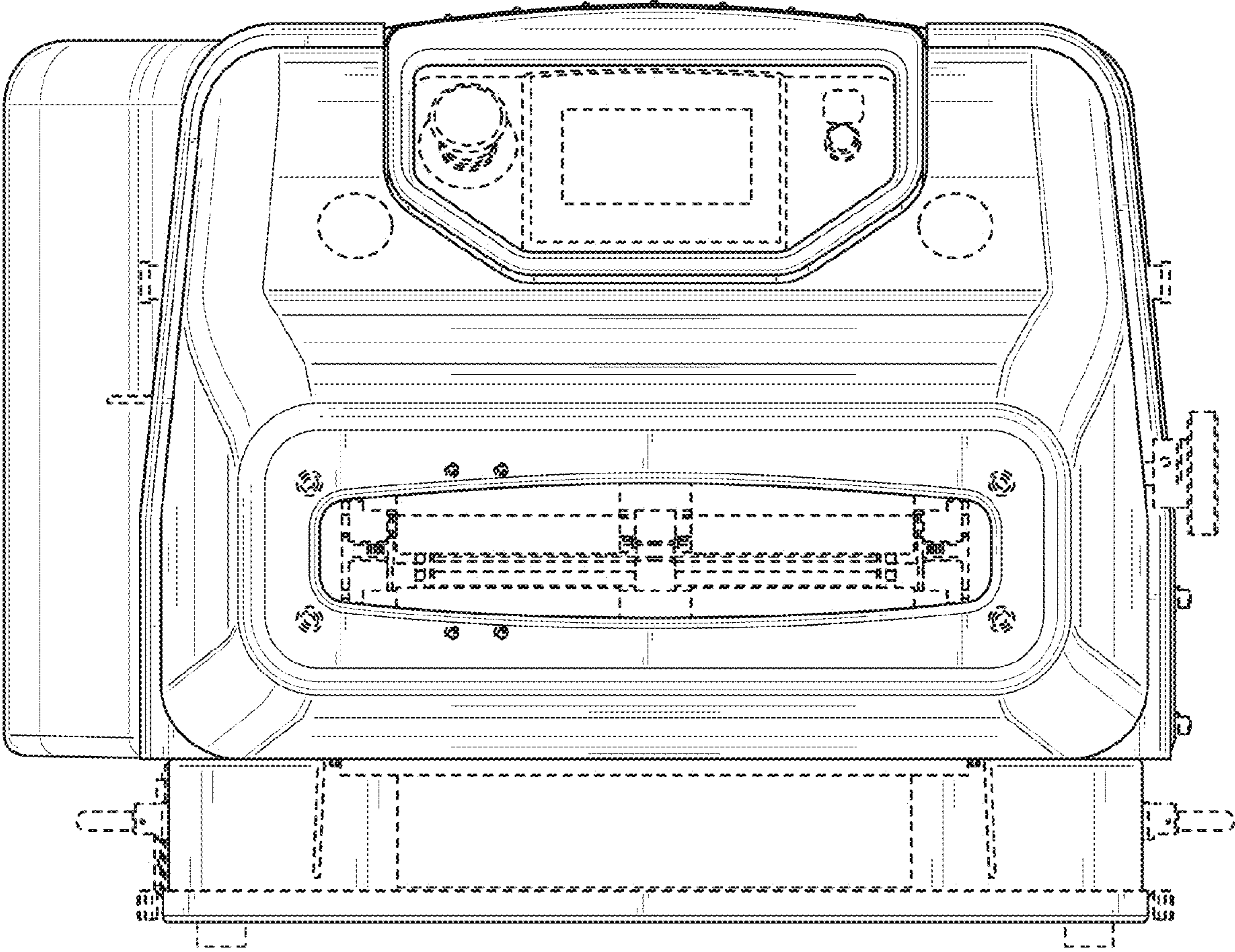

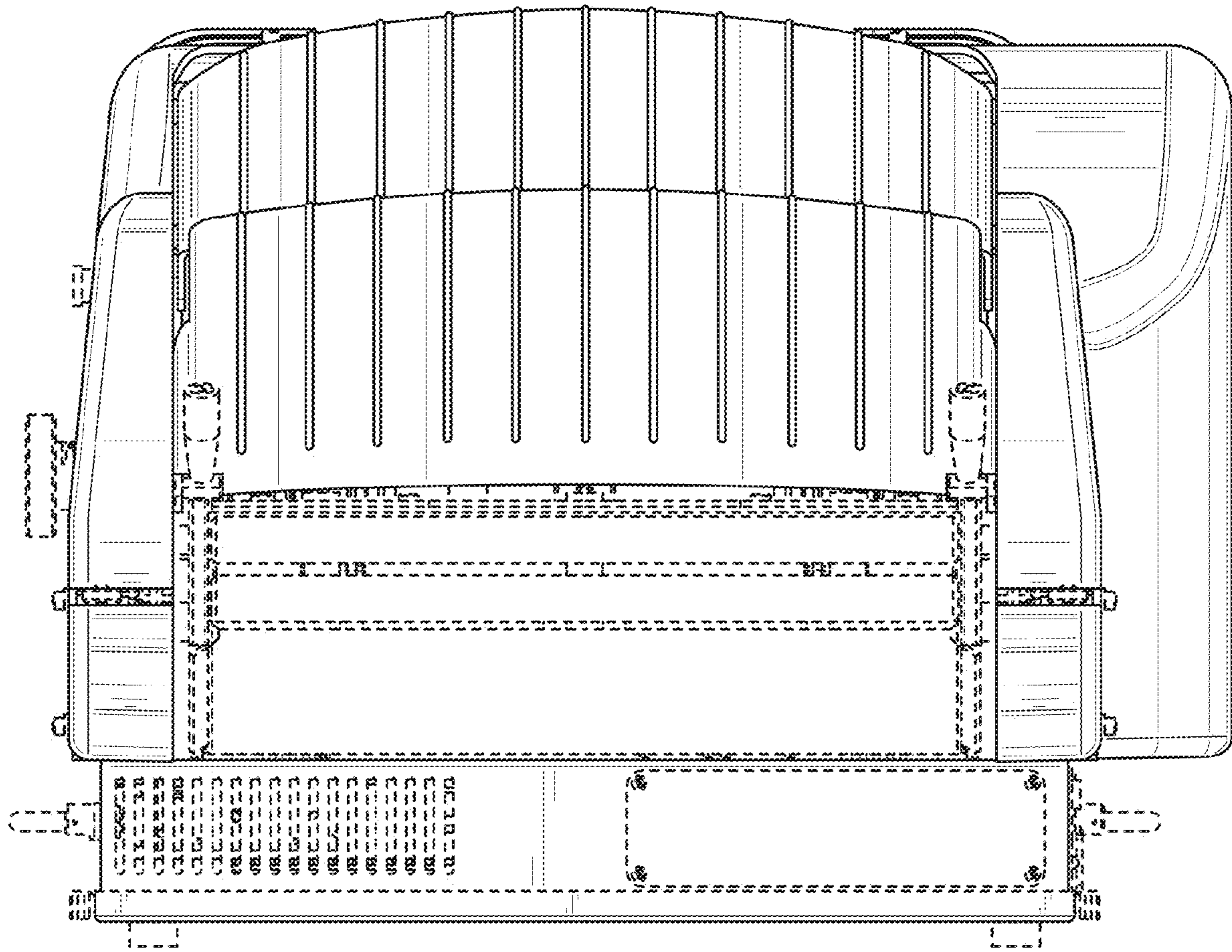

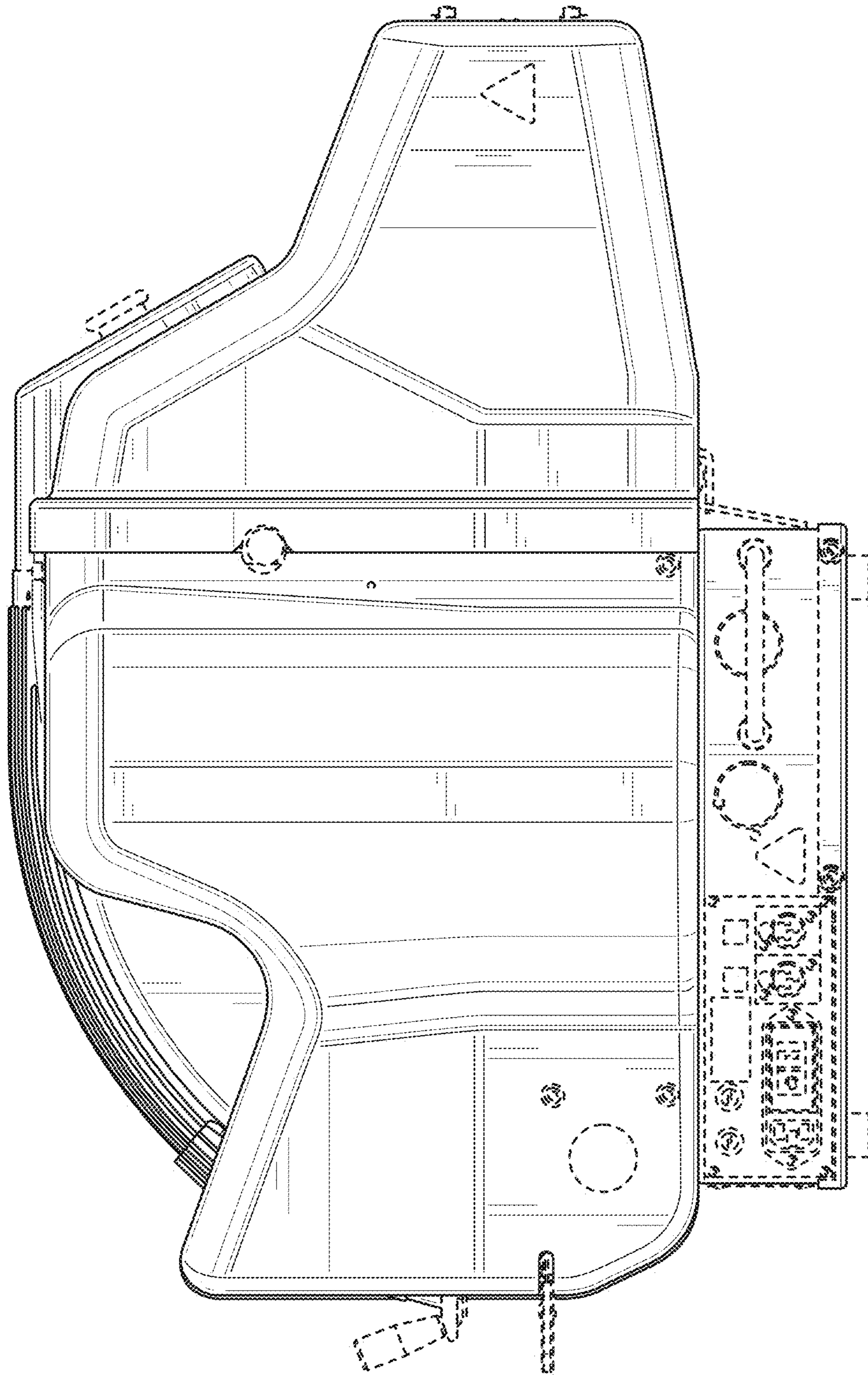

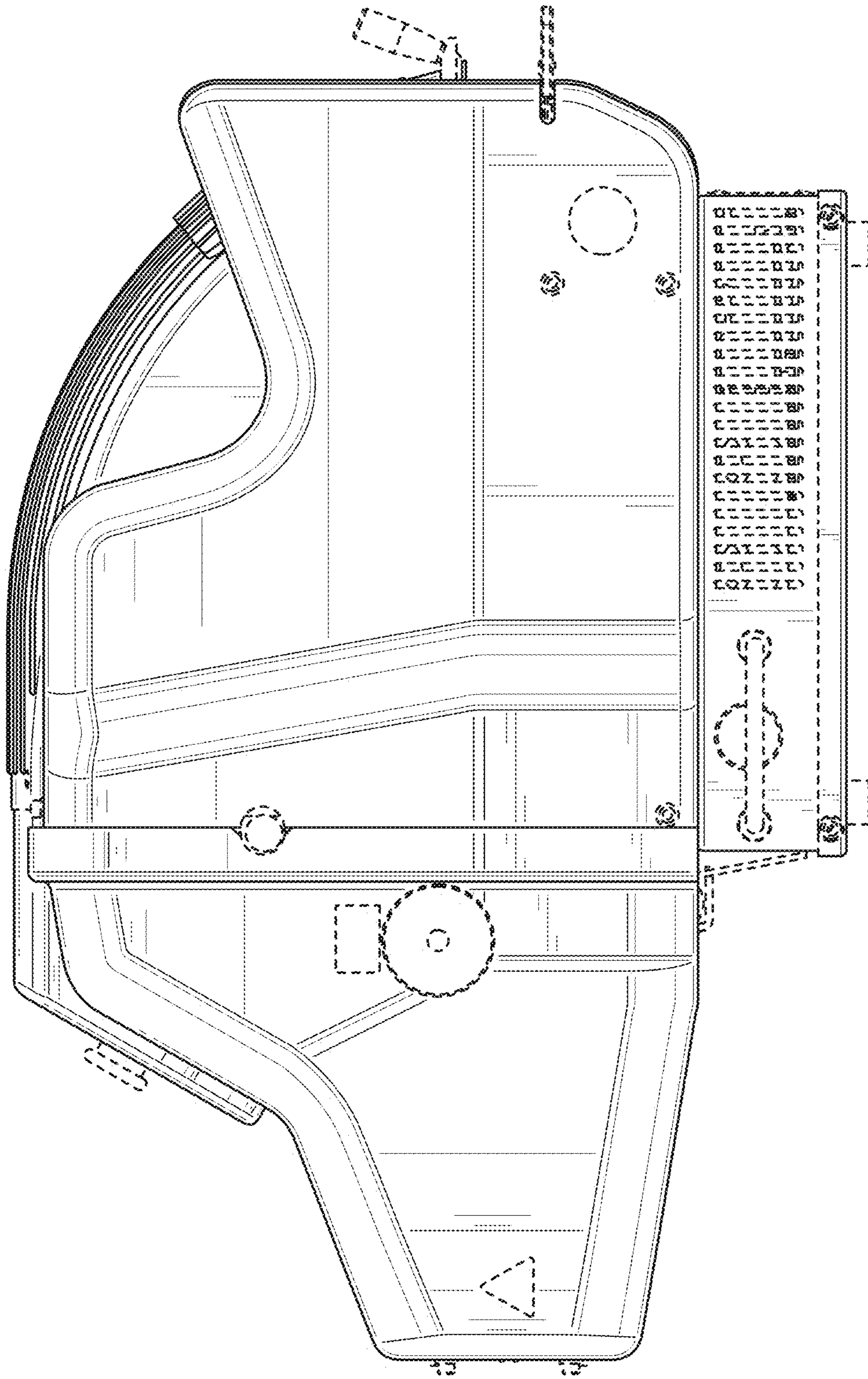

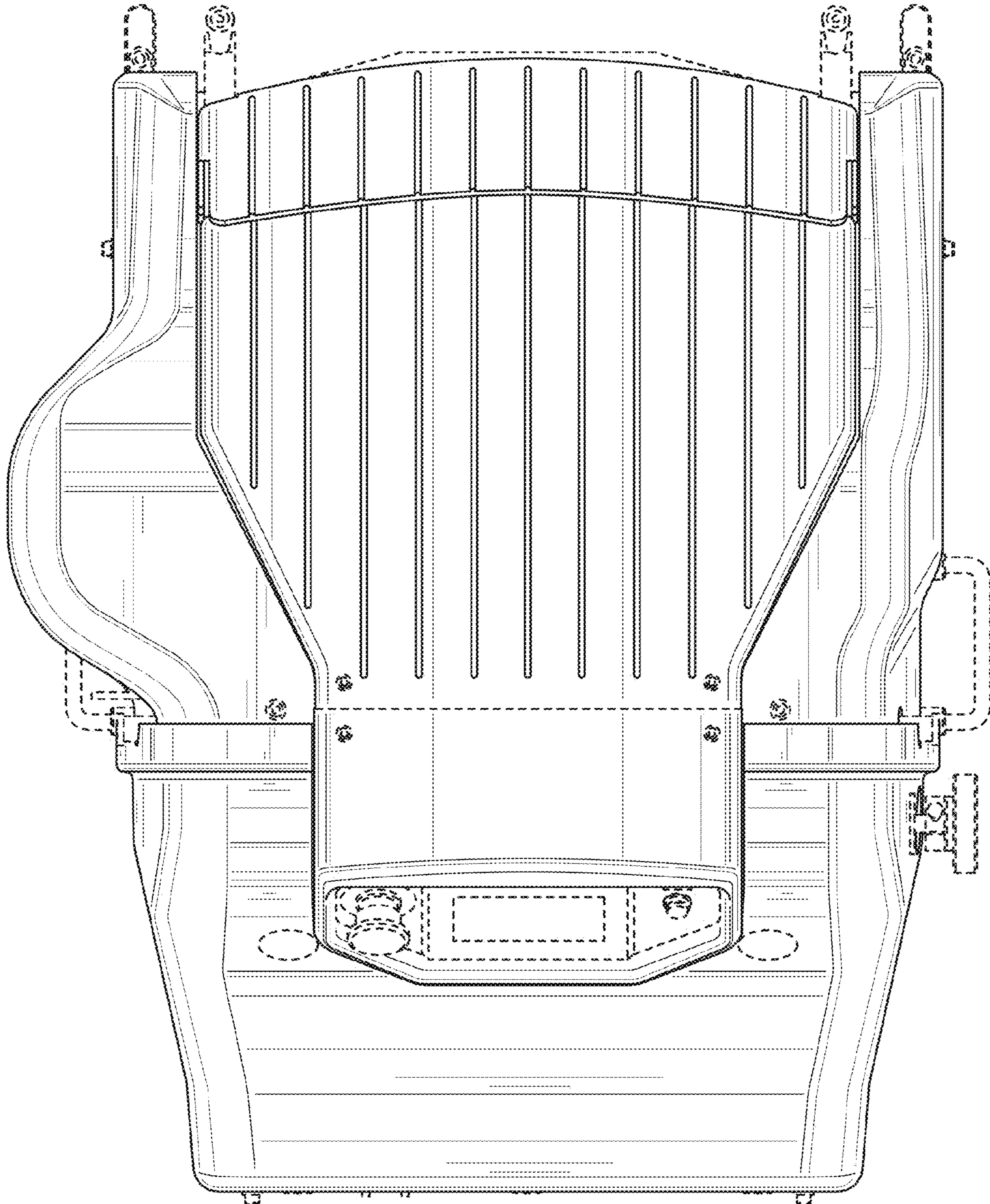

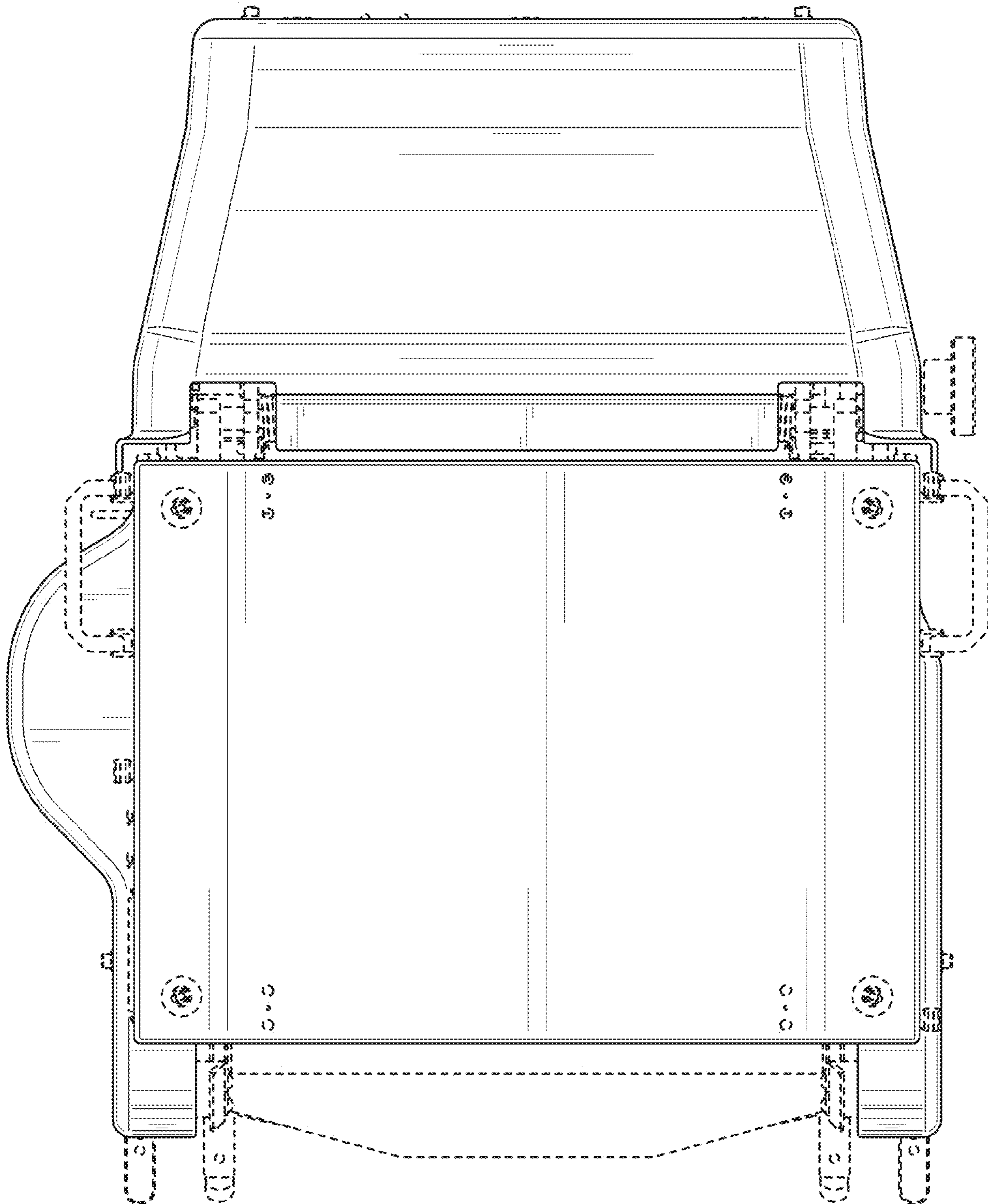
