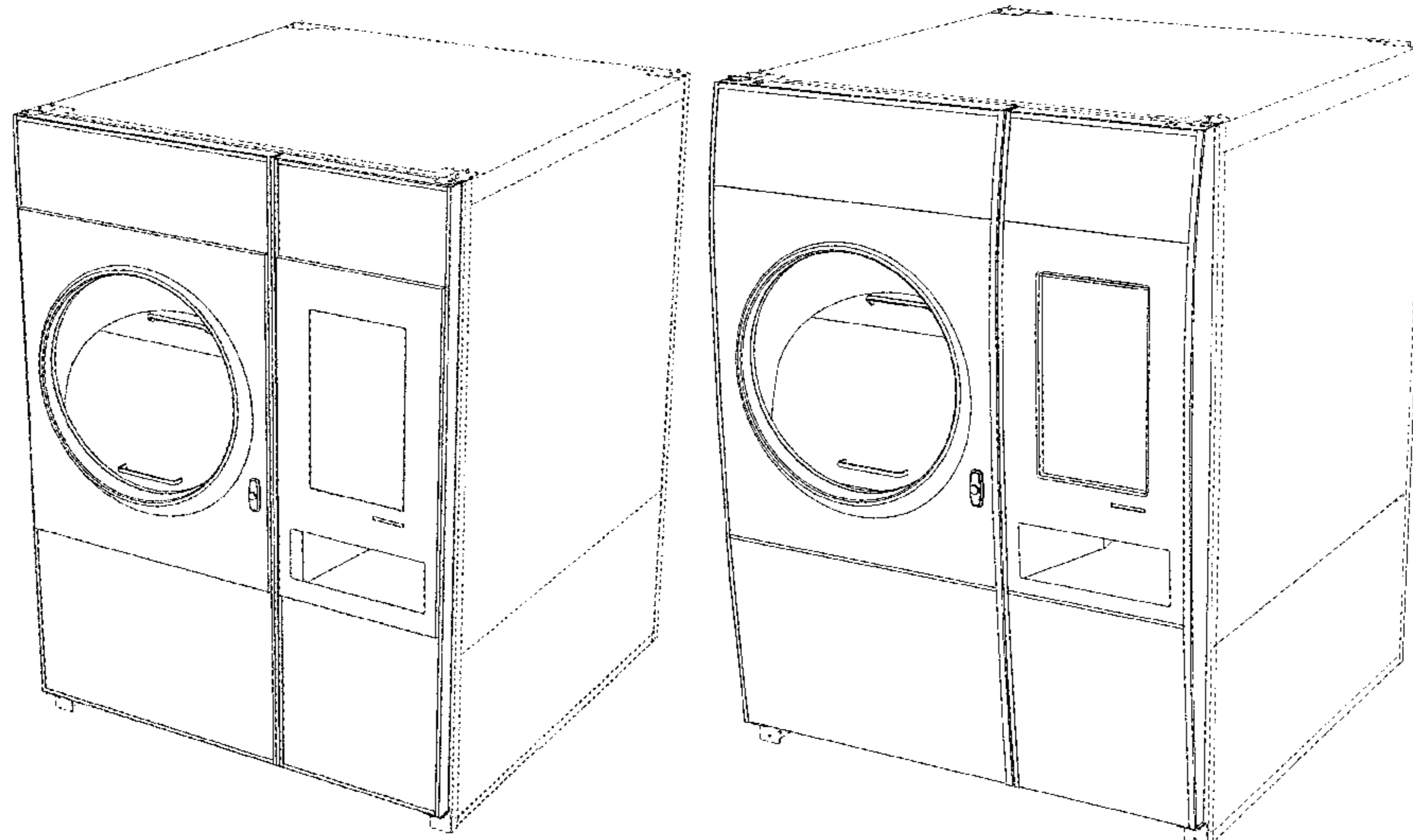

The ornamental design for reverse vending machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a reverse vending machine showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of a second embodiment of a reverse vending machine, showing my new design; FIG. 9 is a front plan view thereof; FIG. 10 is a right side view thereof; FIG. 11 is a left side view thereof; FIG. 12 is a top plan view thereof; FIG. 13 is a rear plan view thereof; and, FIG. 14 is a bottom plan view thereof. The broken lines shown in the drawings depict portions of the reverse vending machine that form no part of the claimed design.

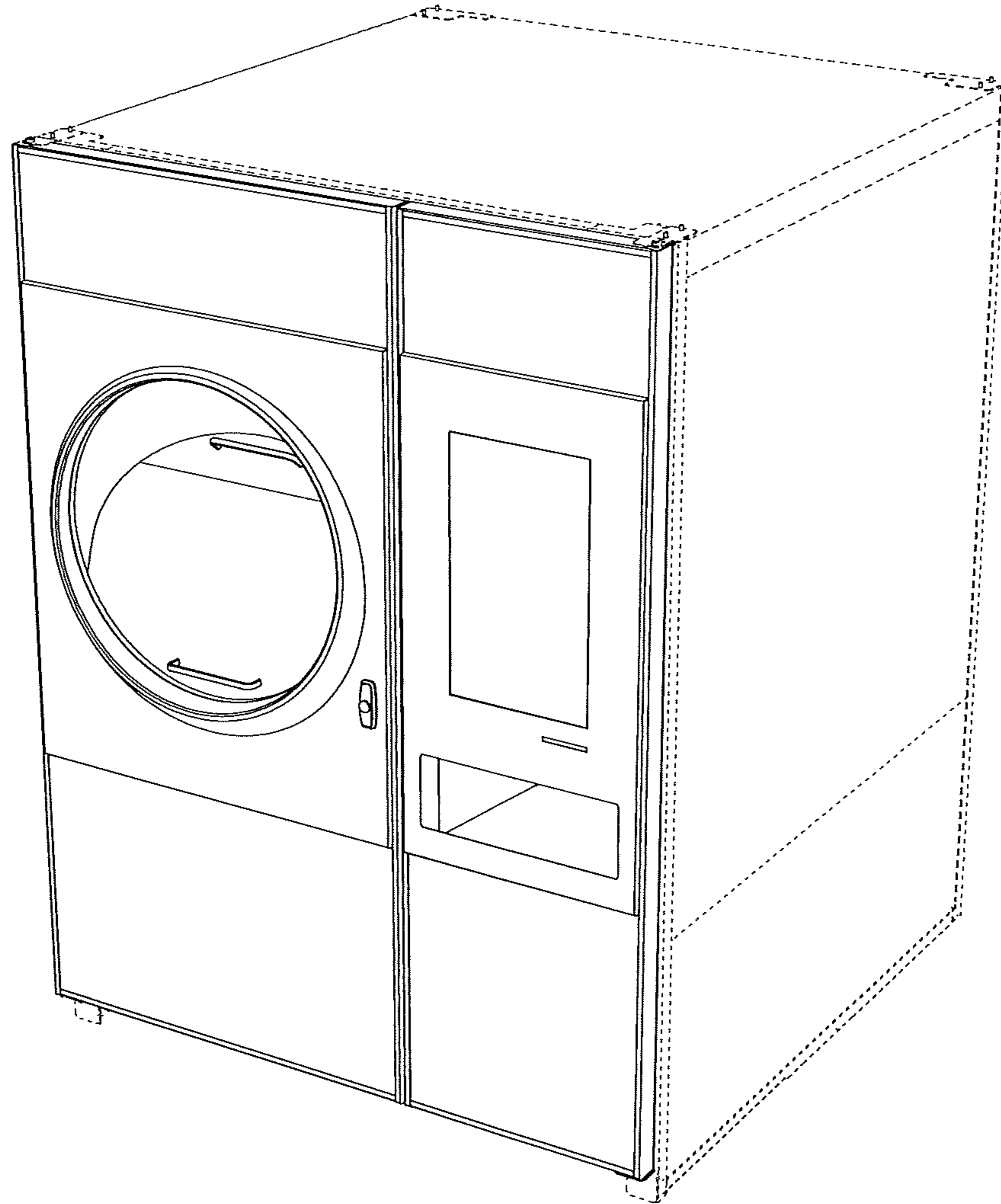

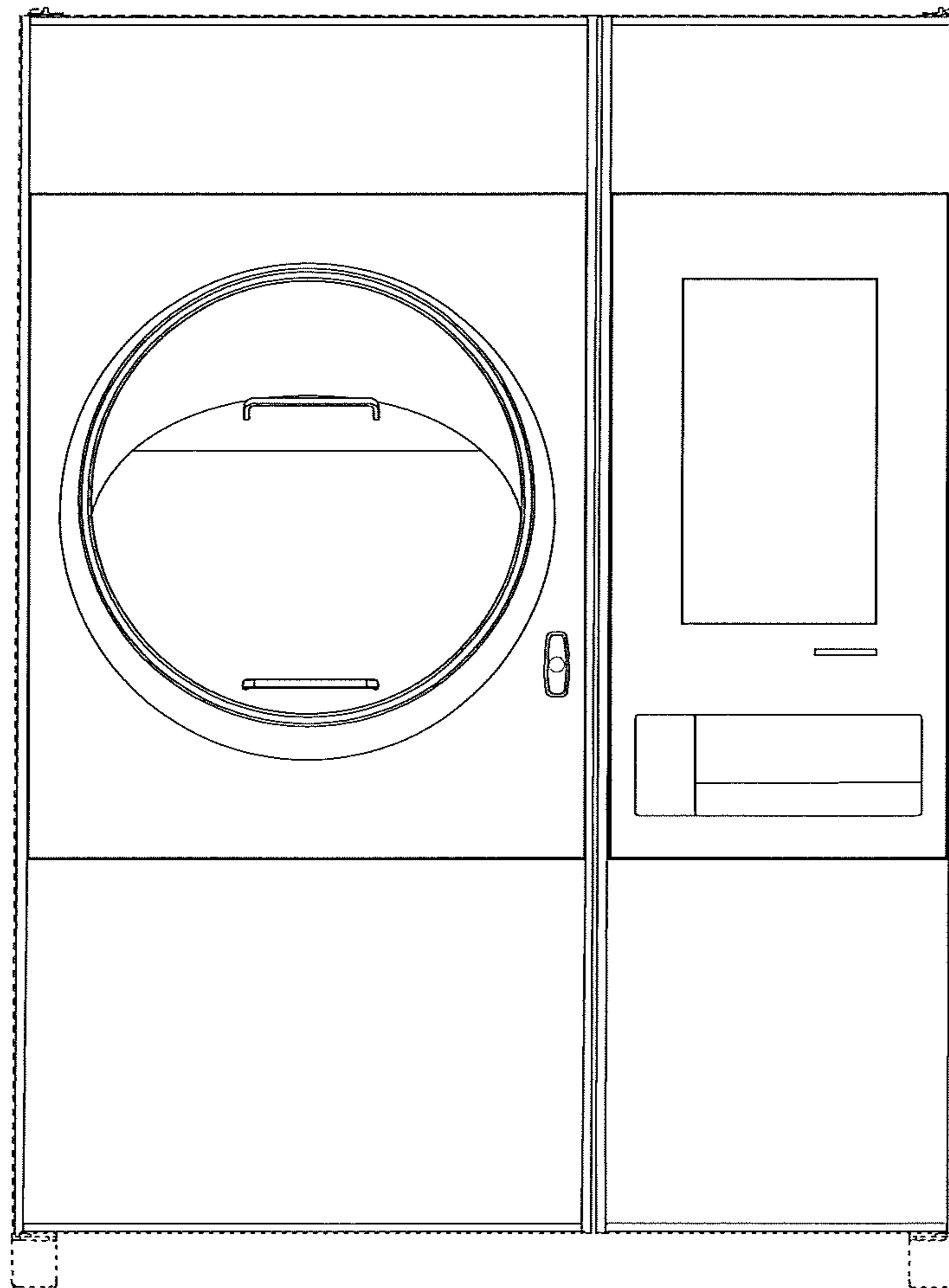

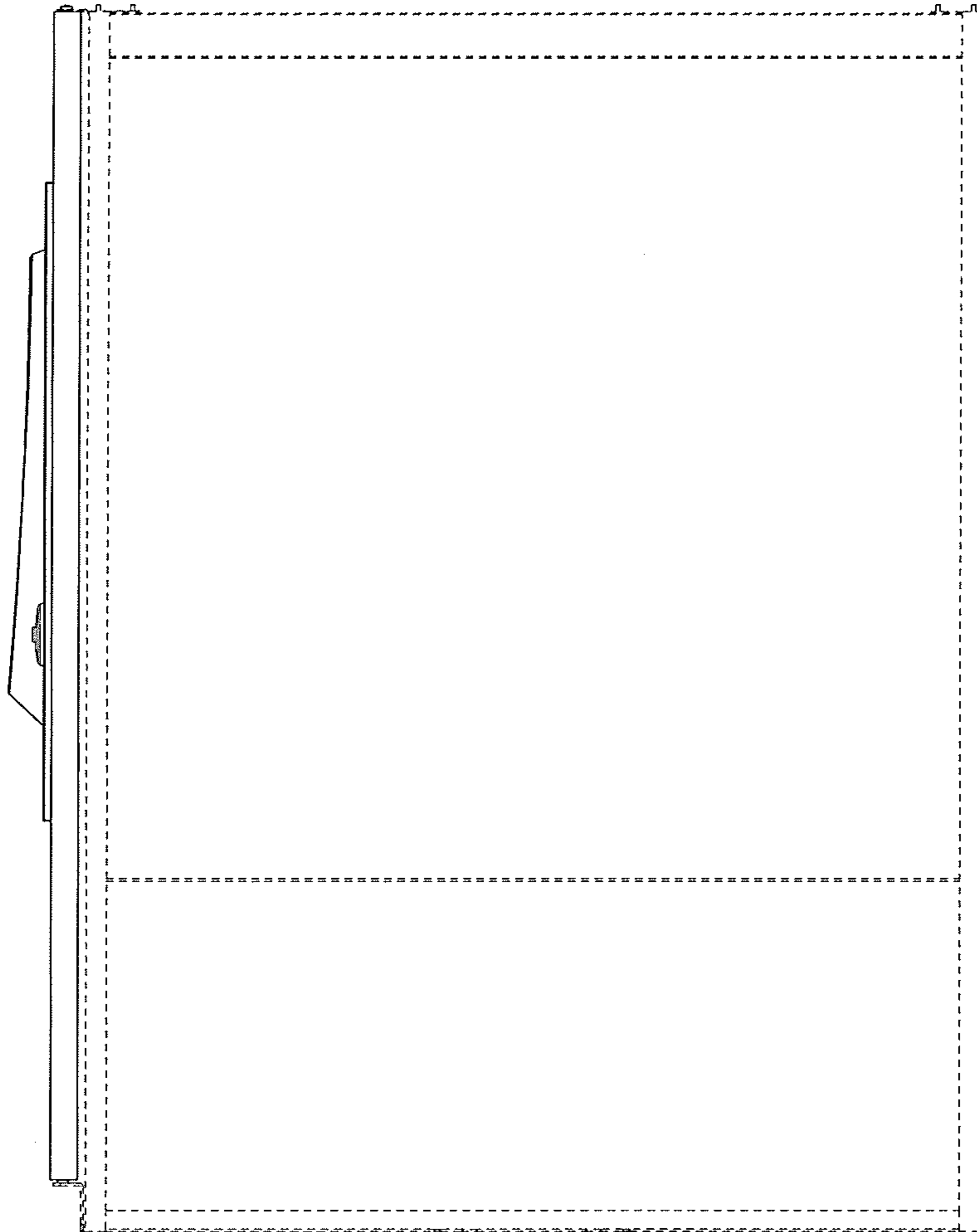

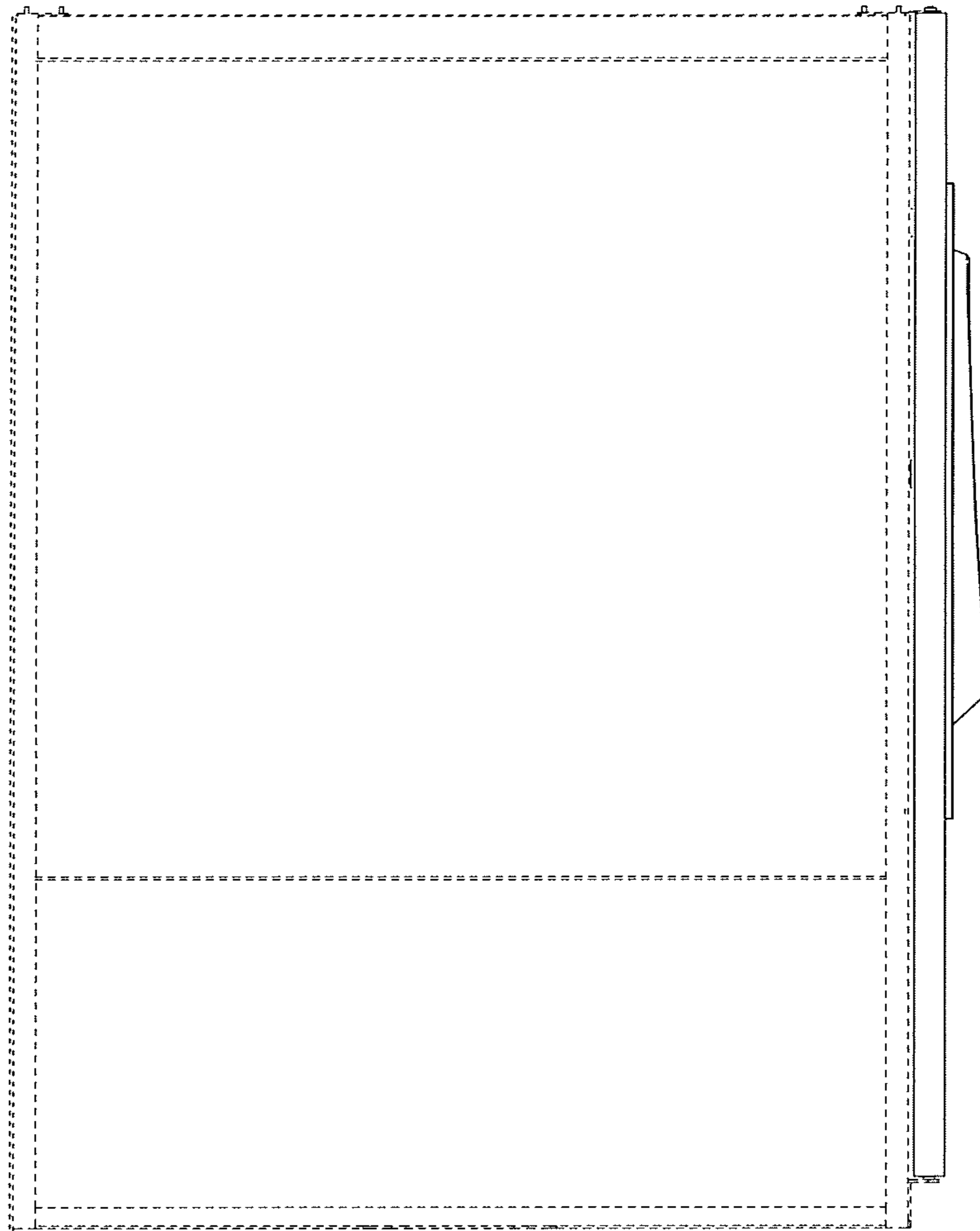

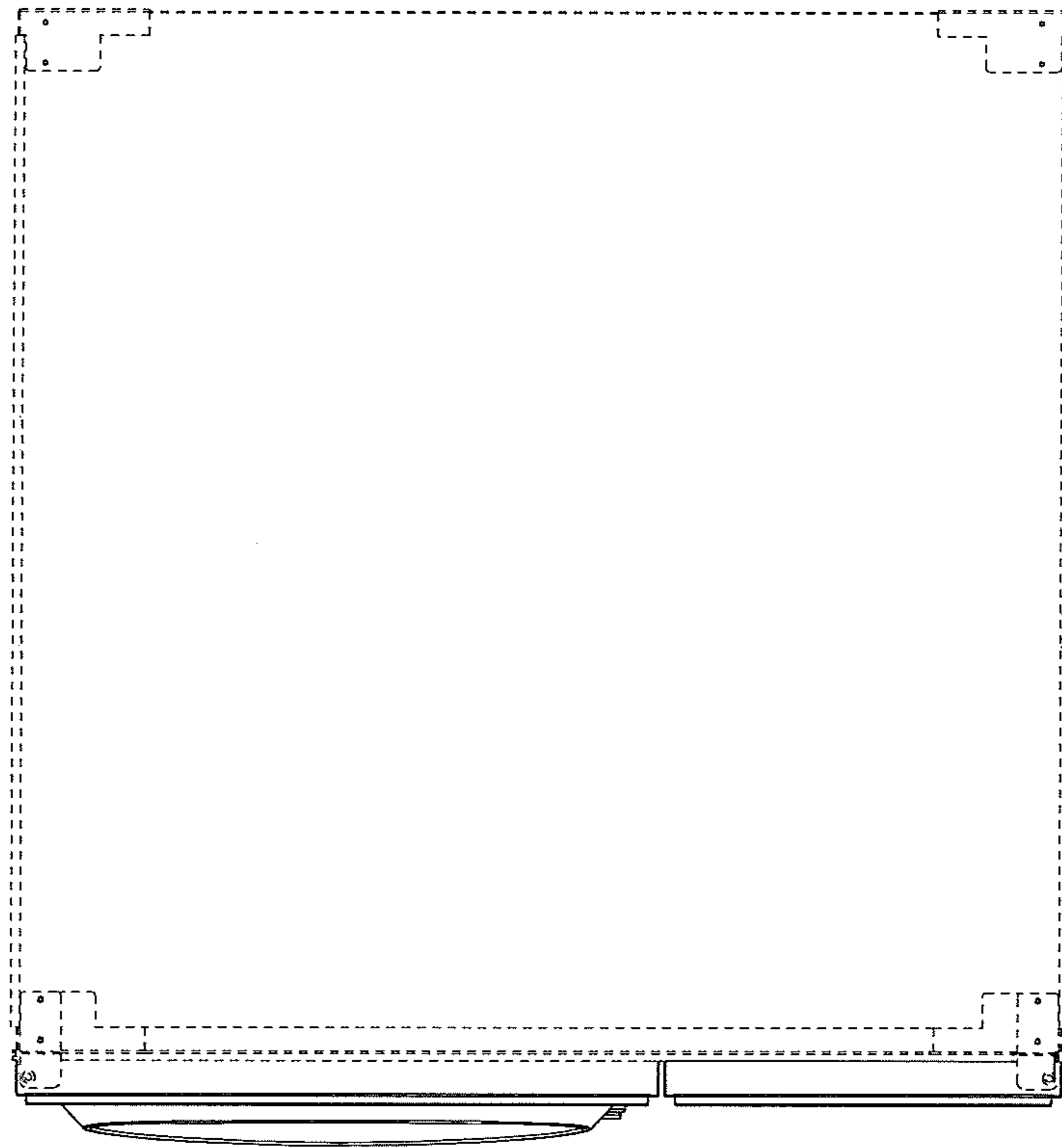

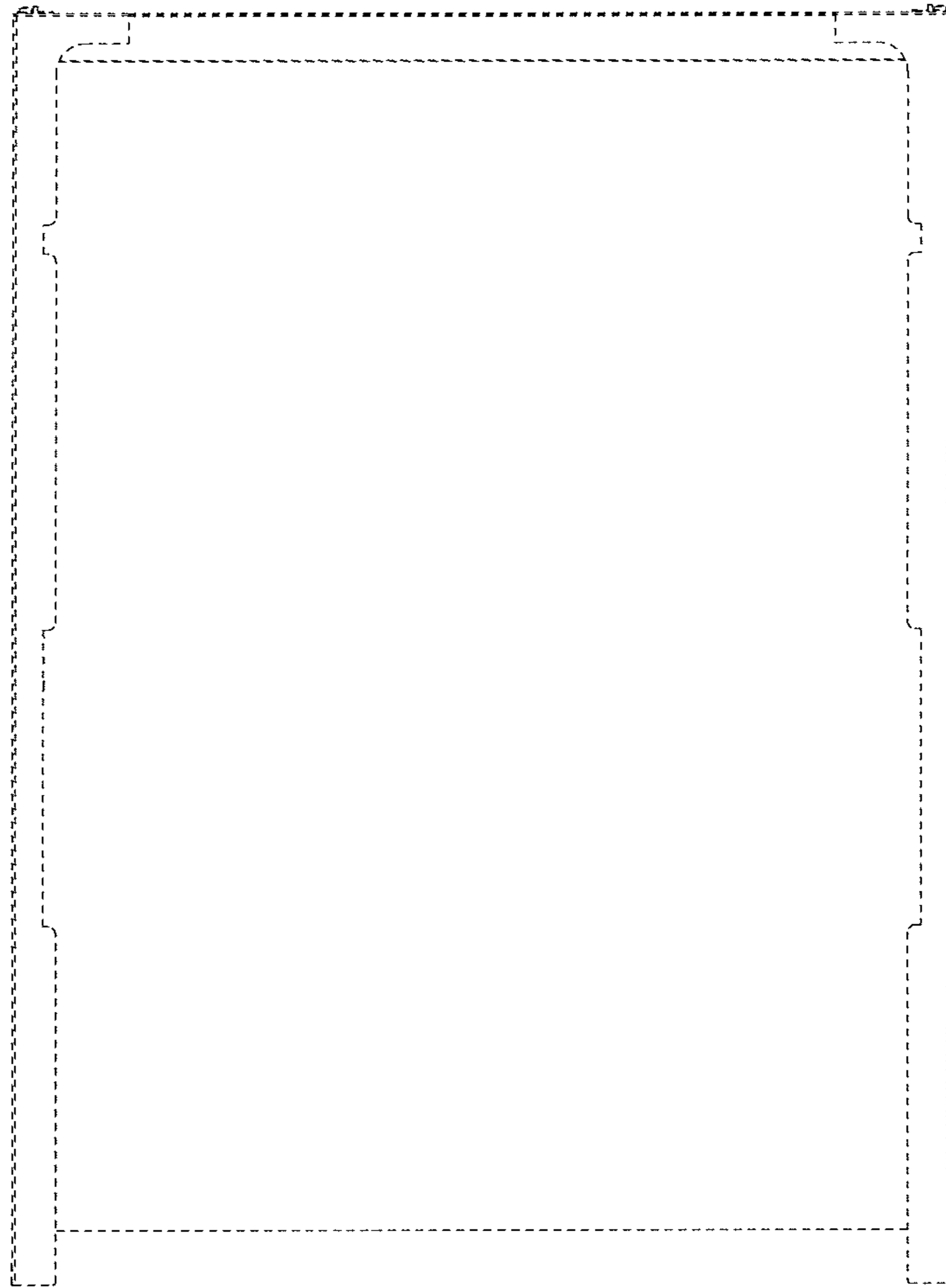

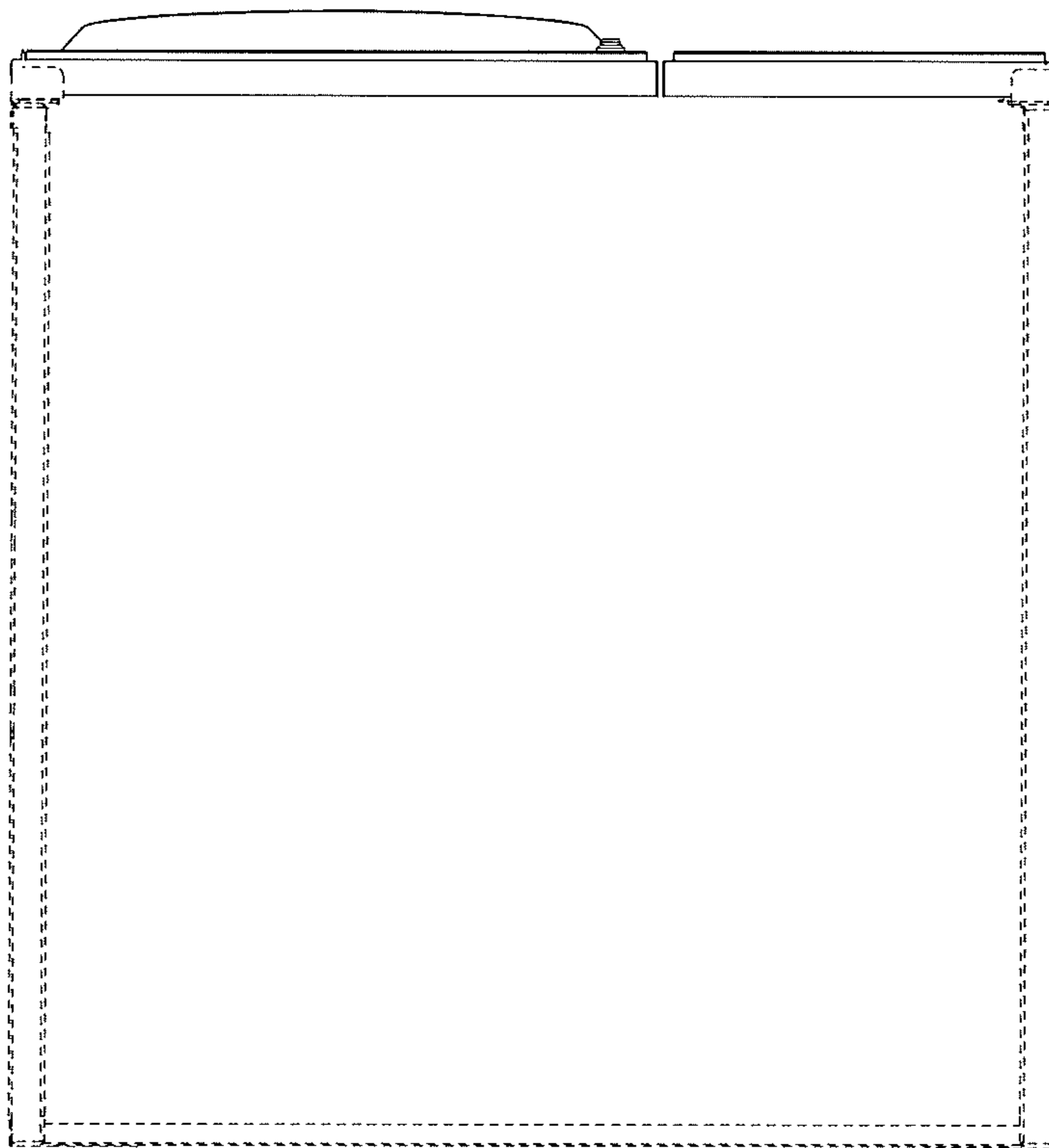

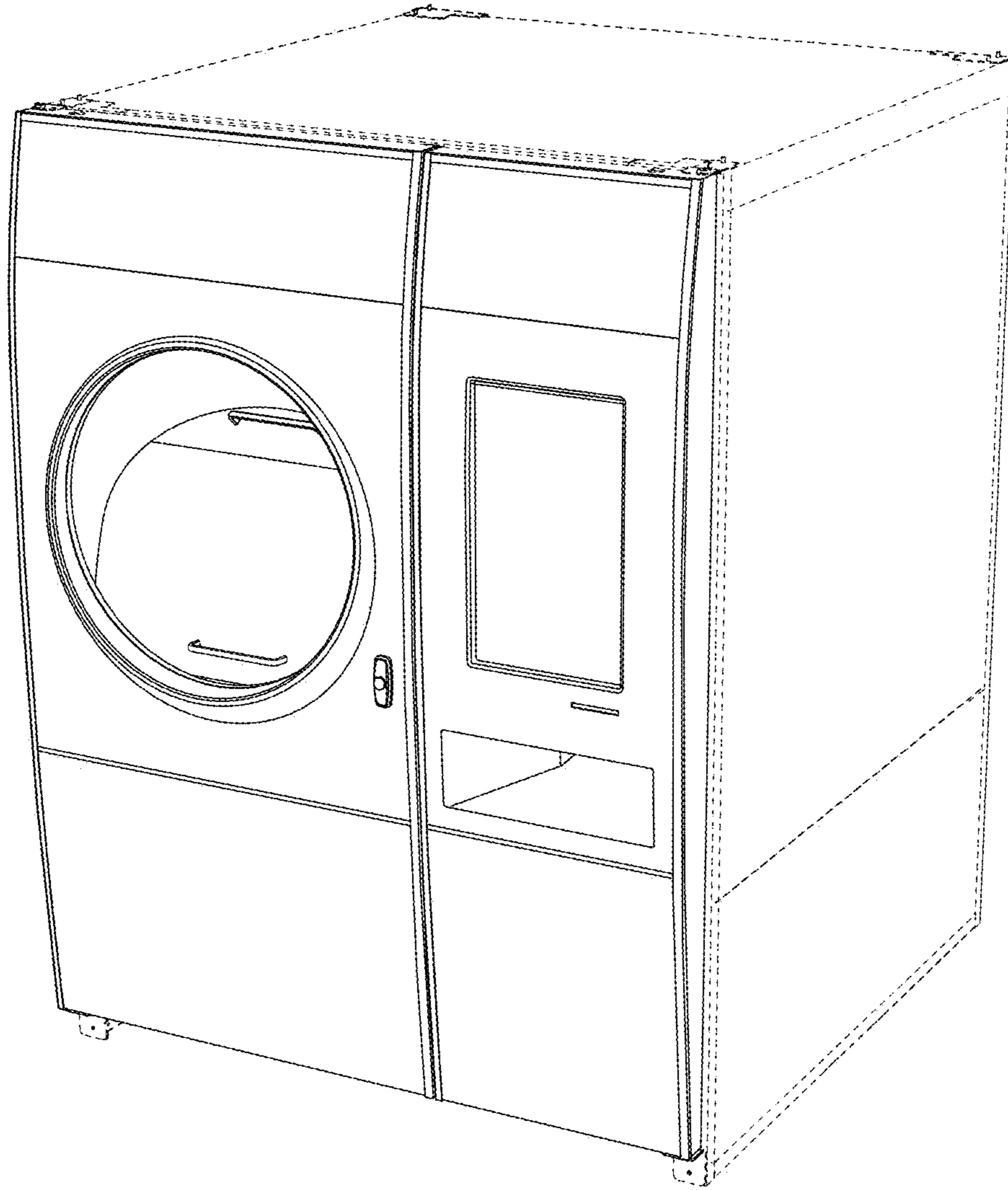

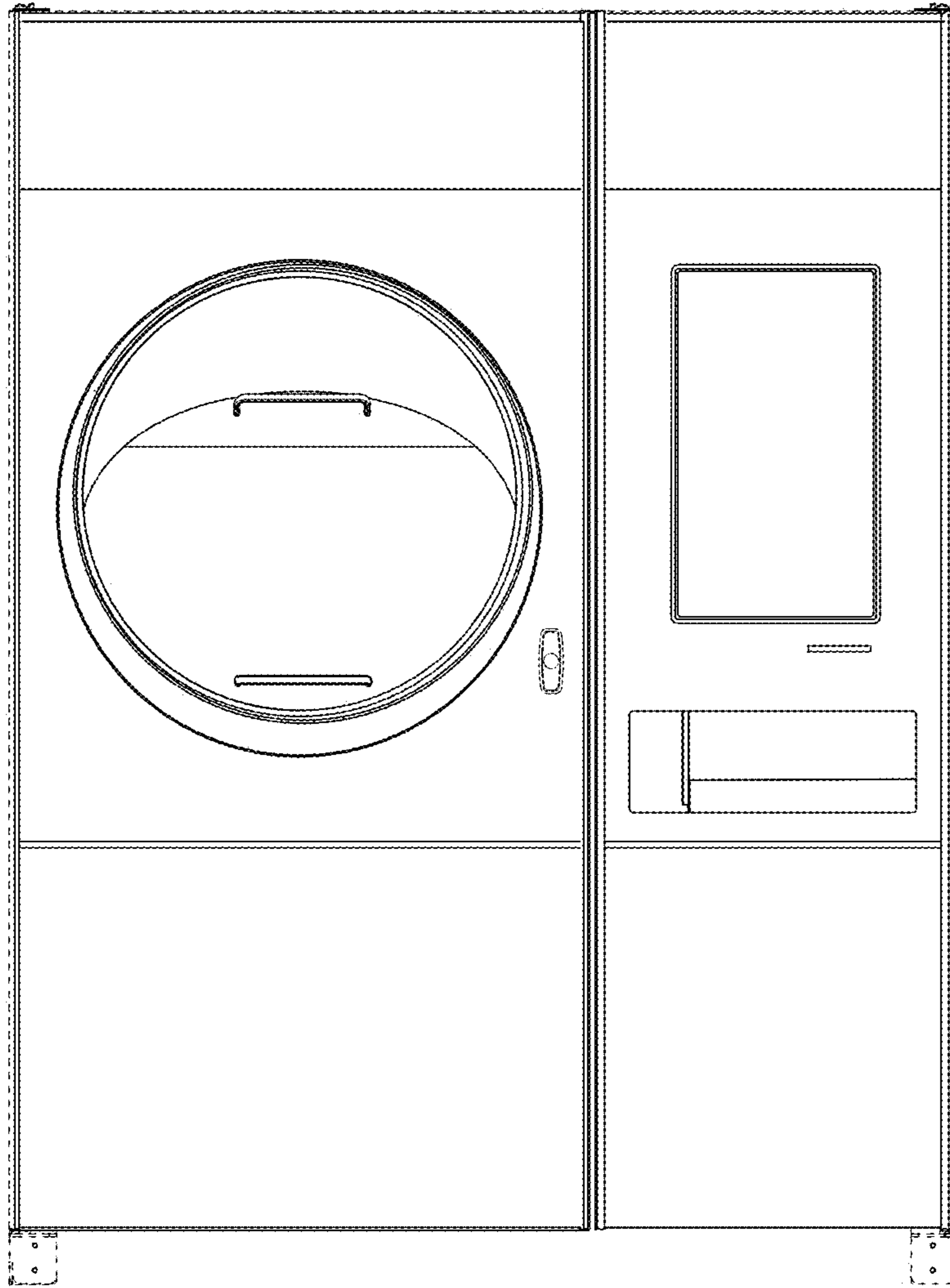

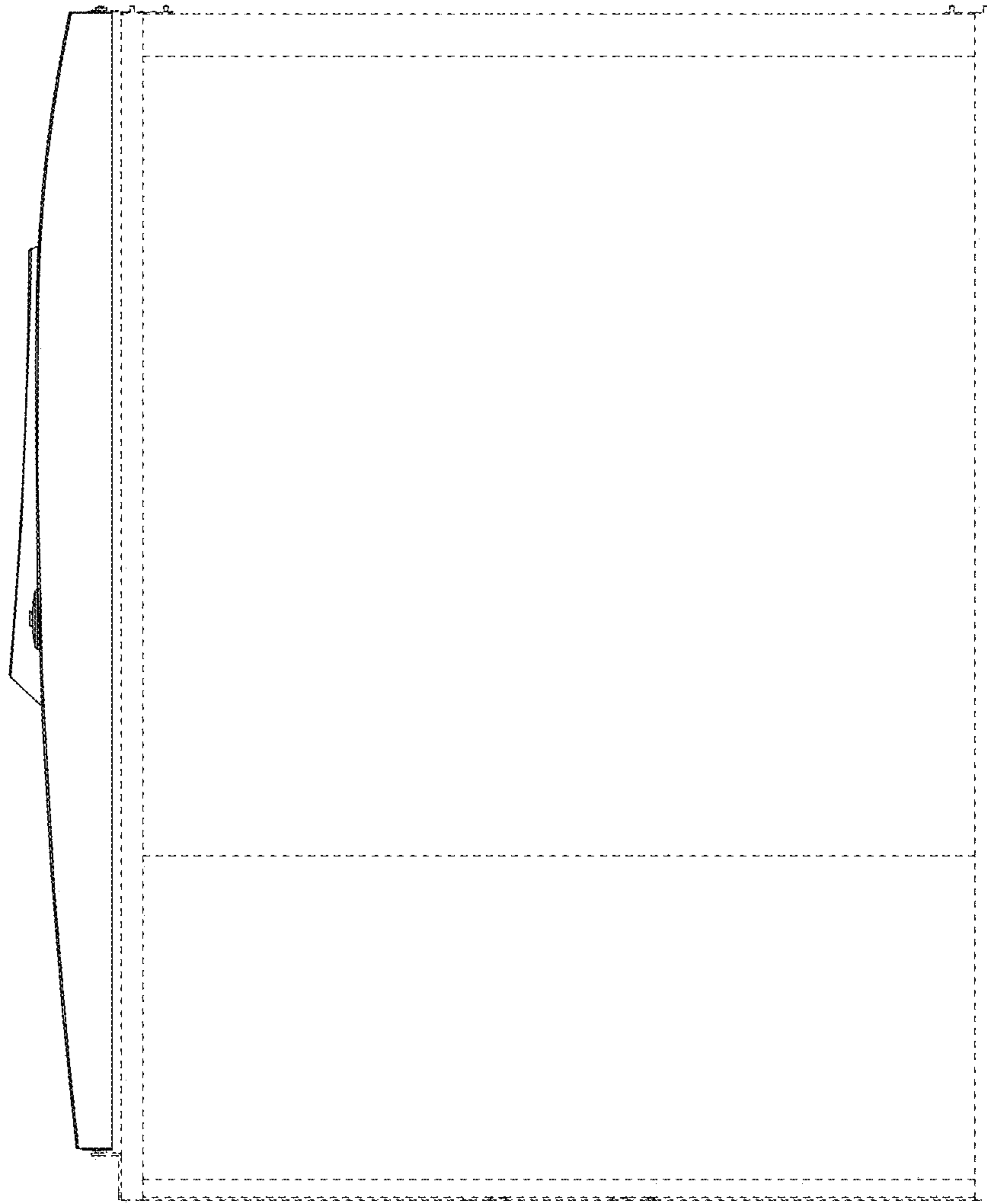

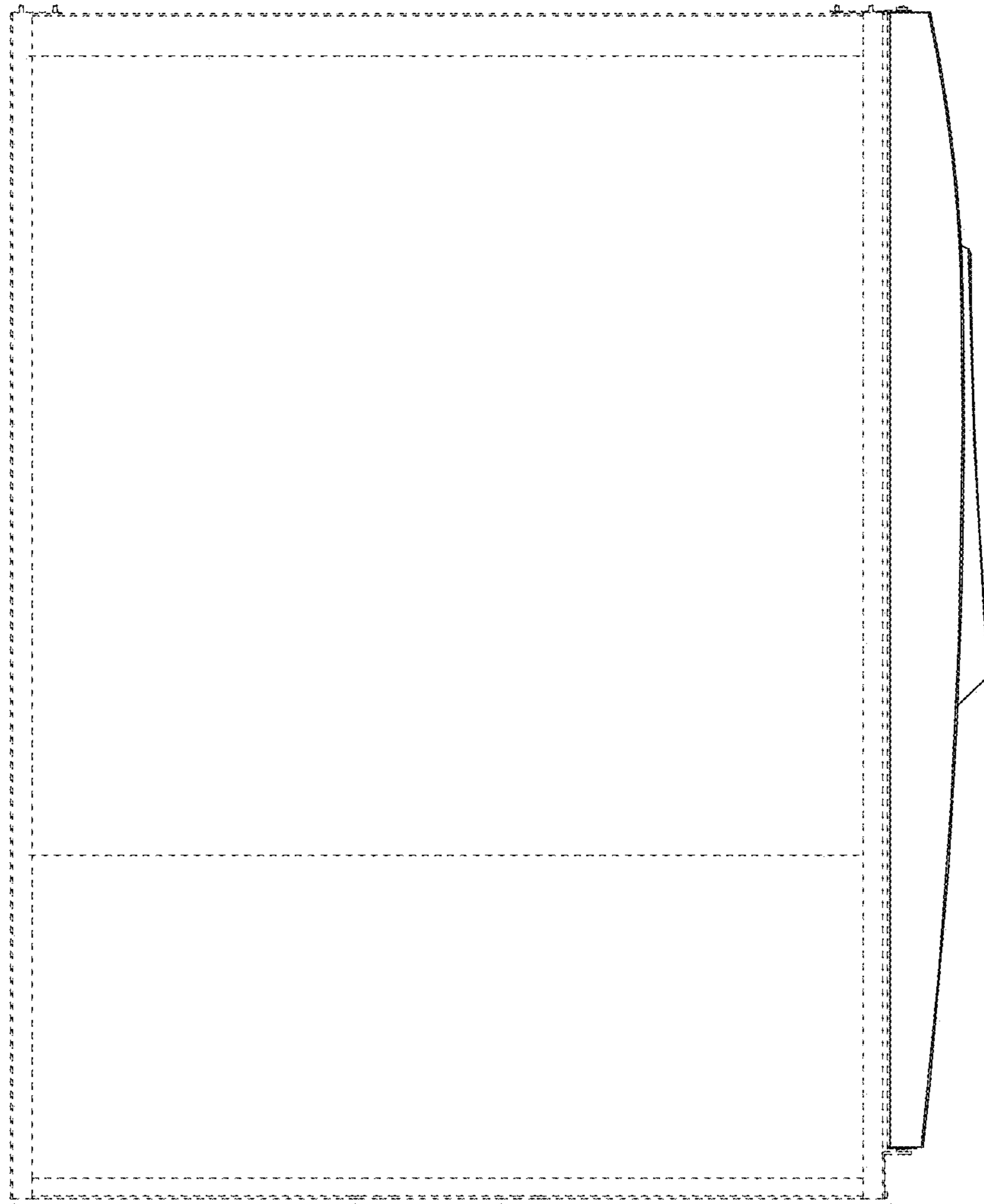

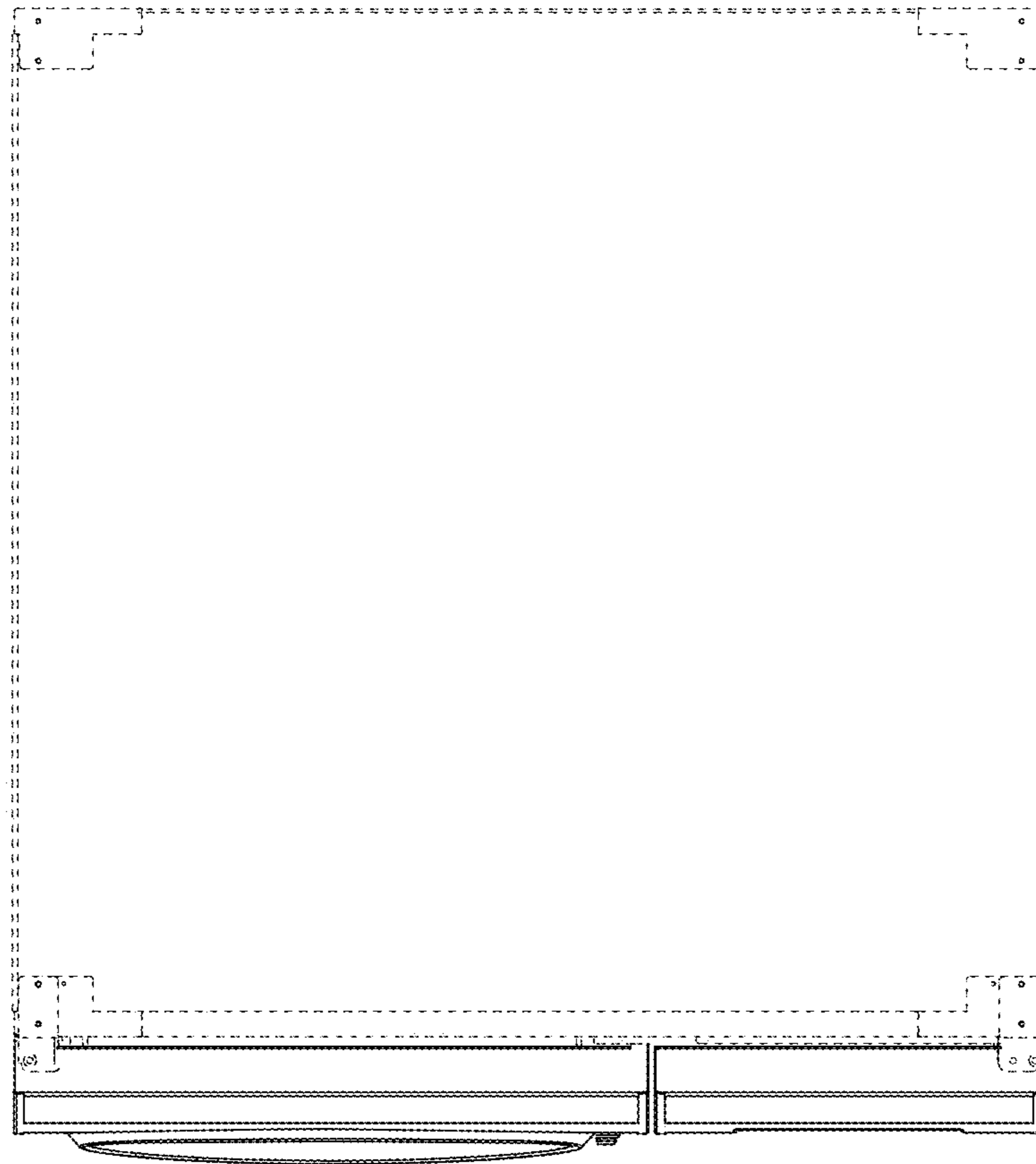

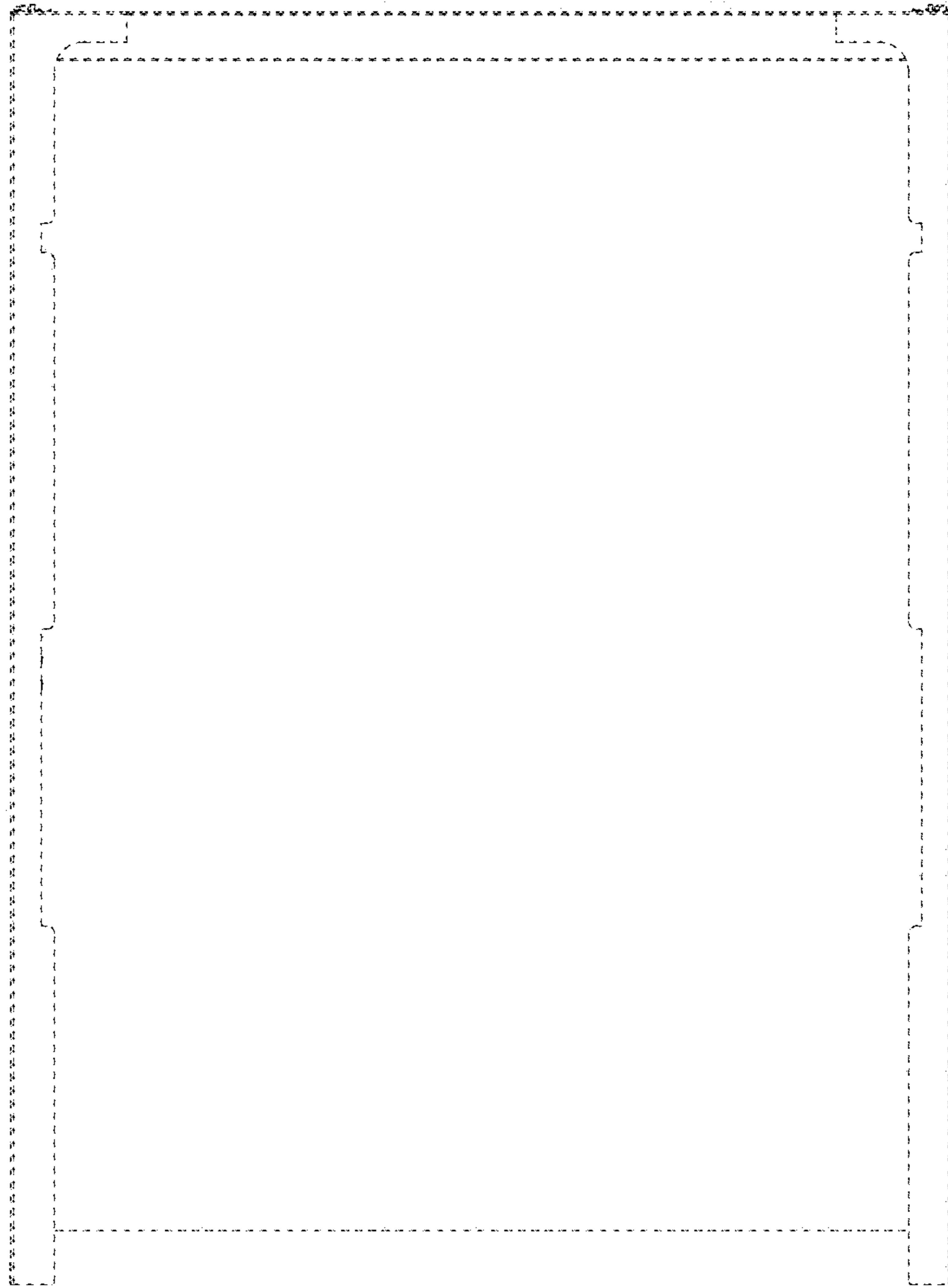

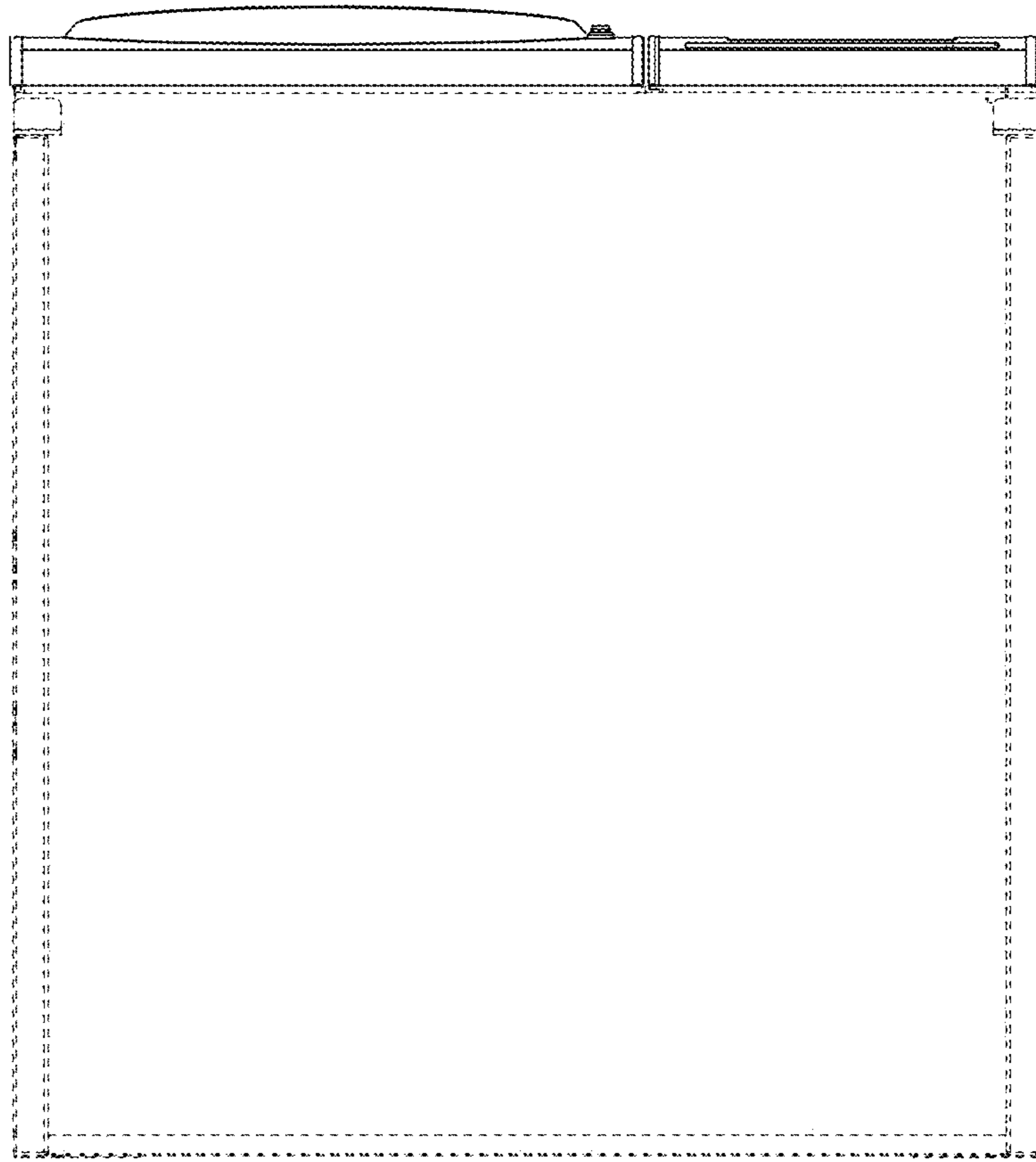
