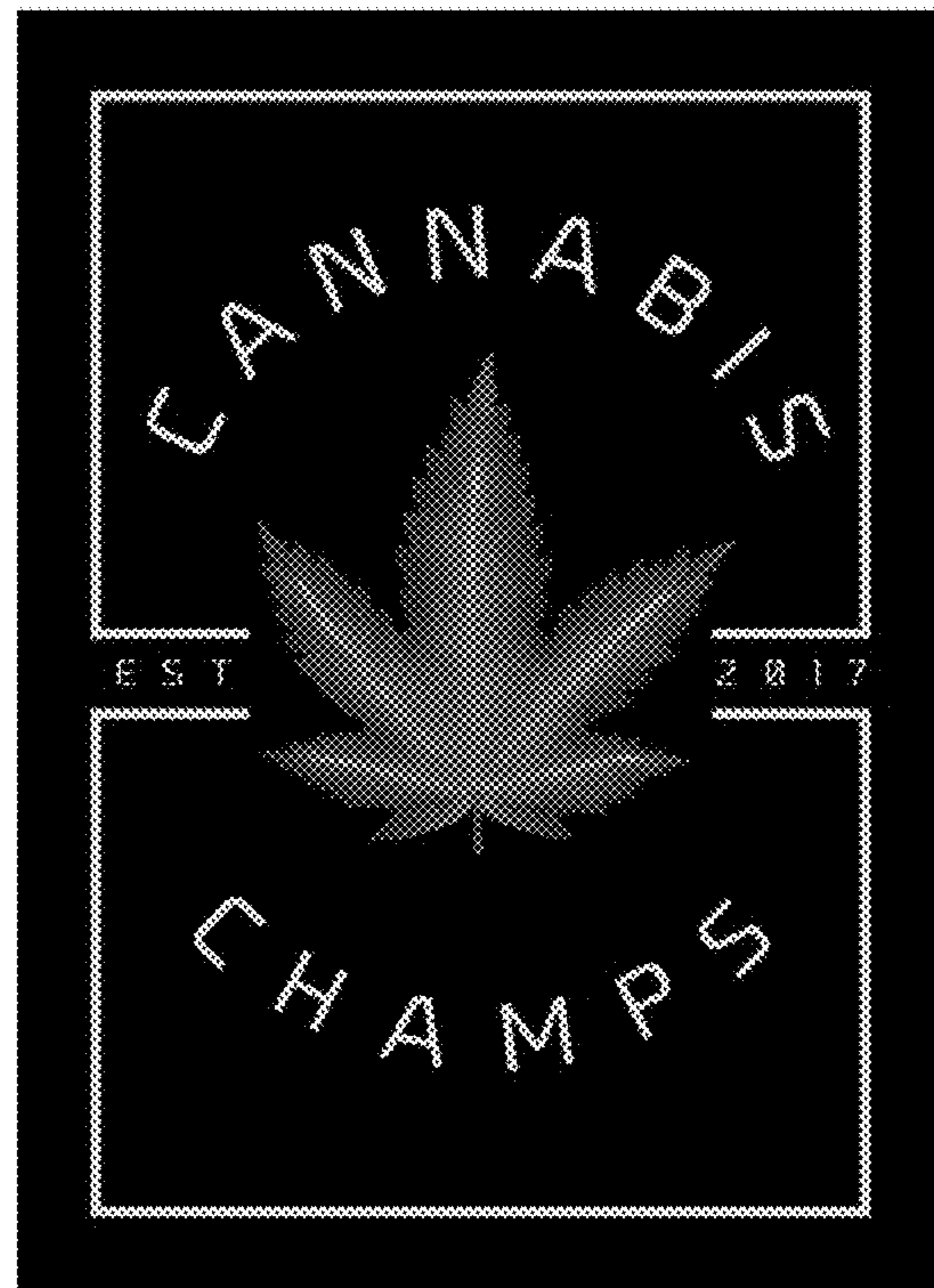
The ornamental design for a cannabis-related card game, as shown and described.

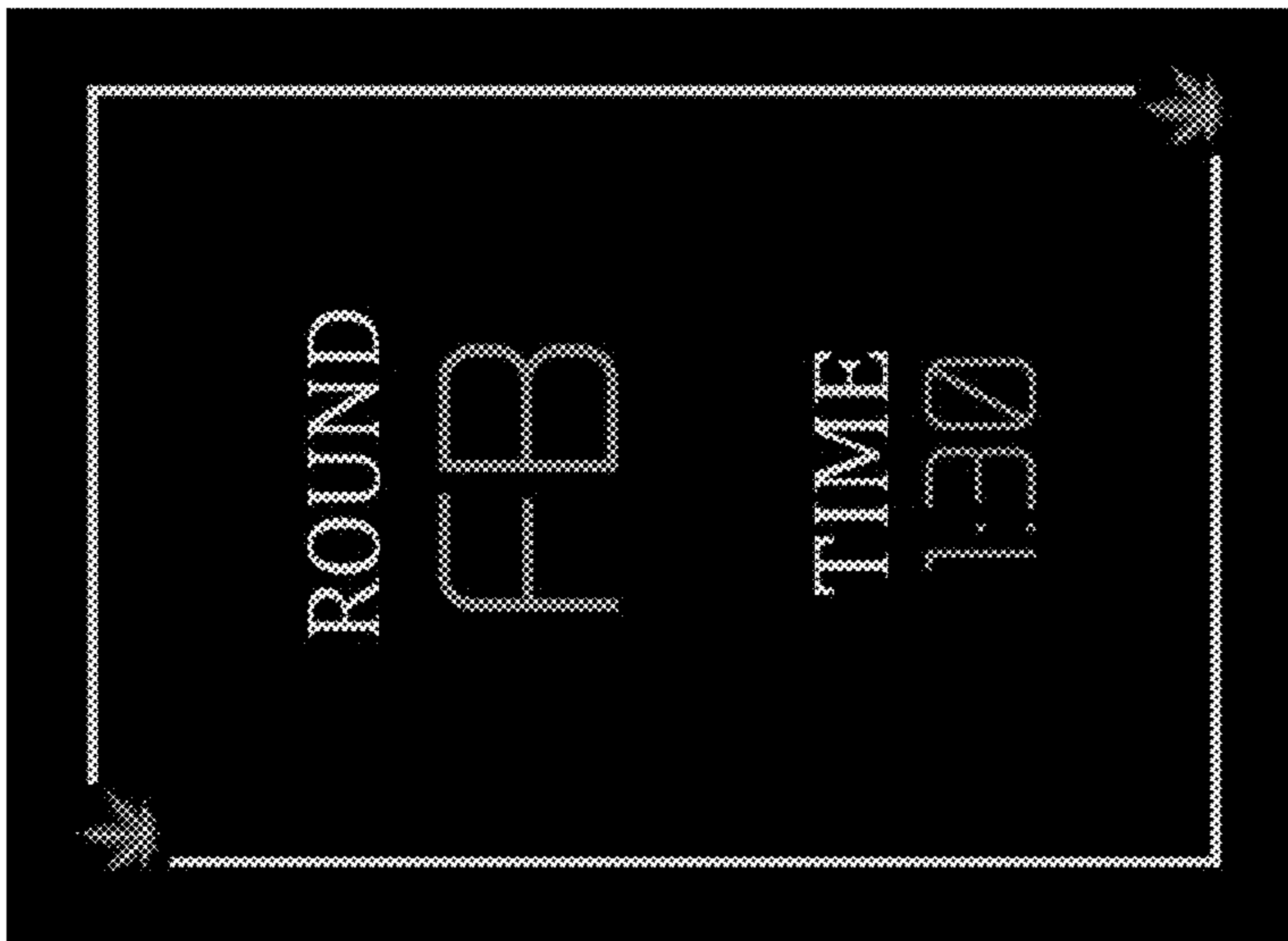

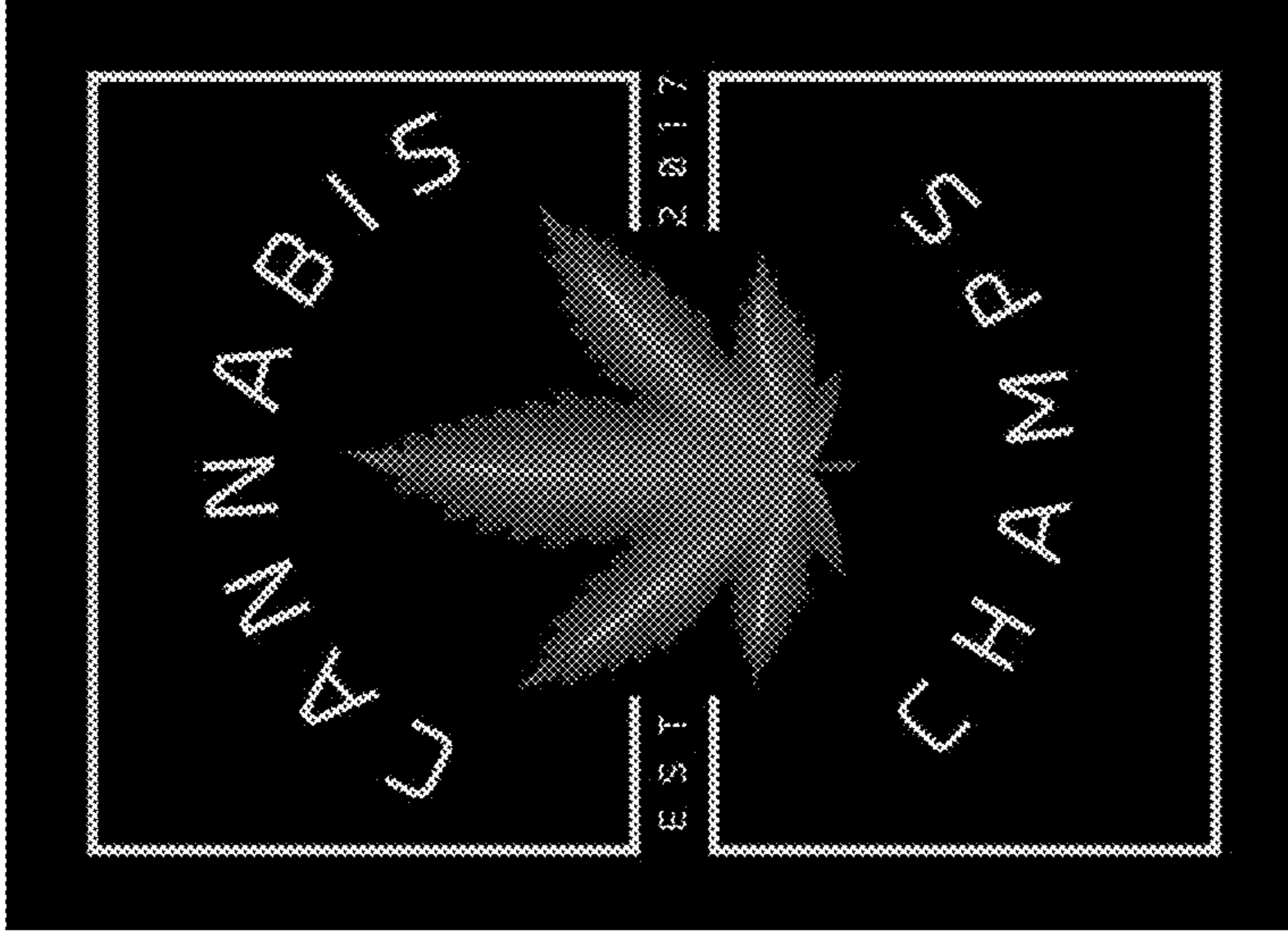

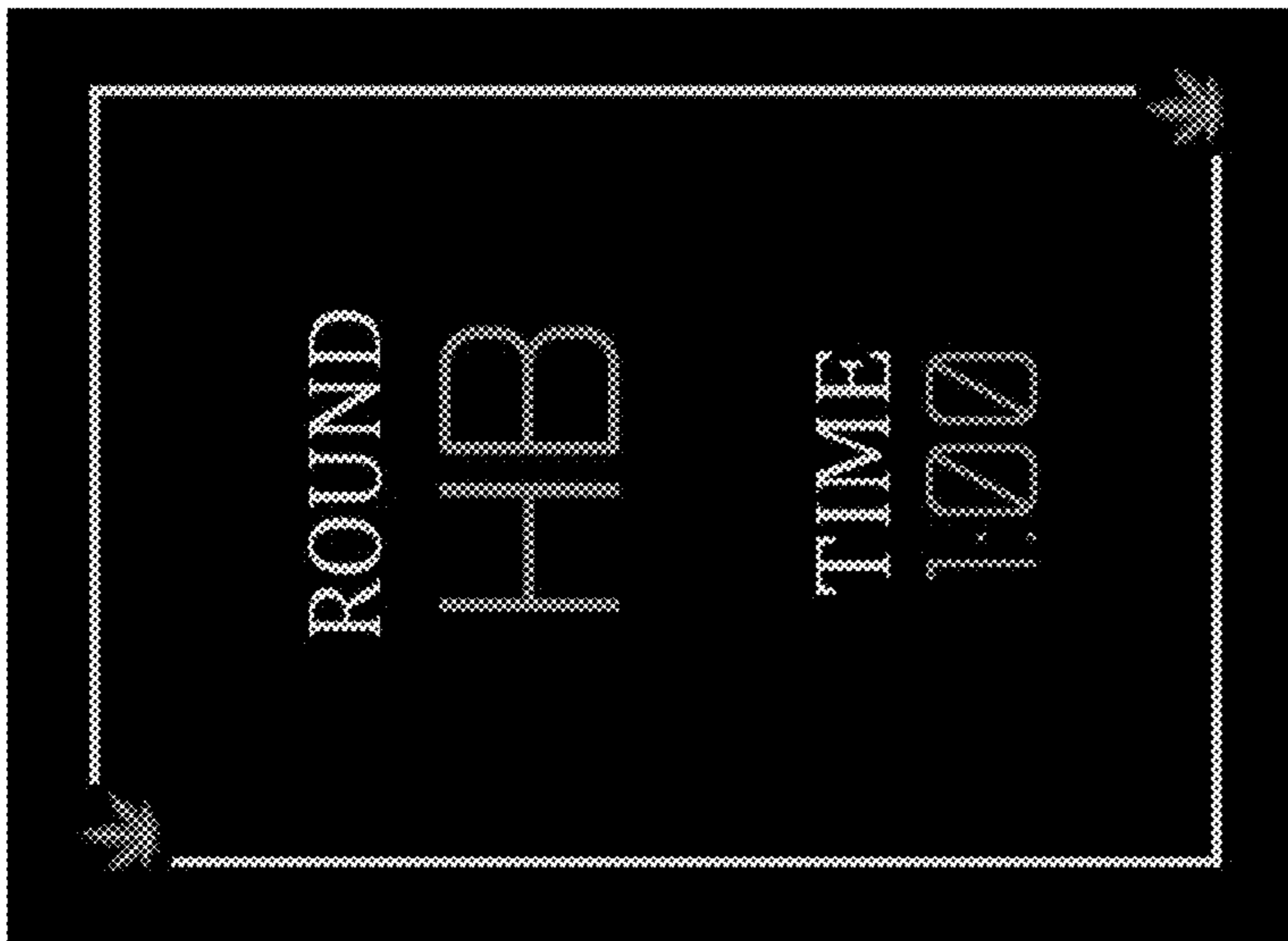

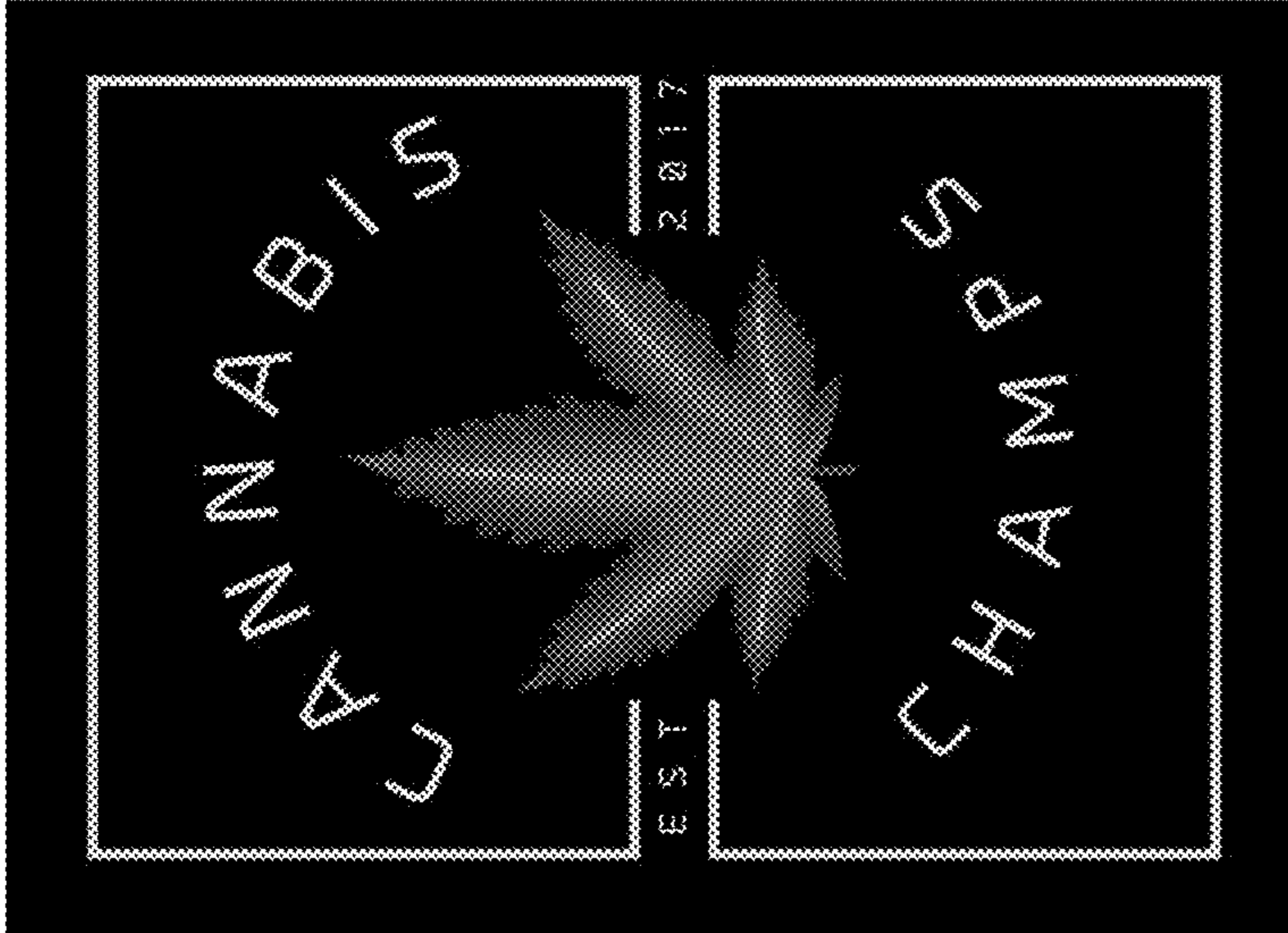

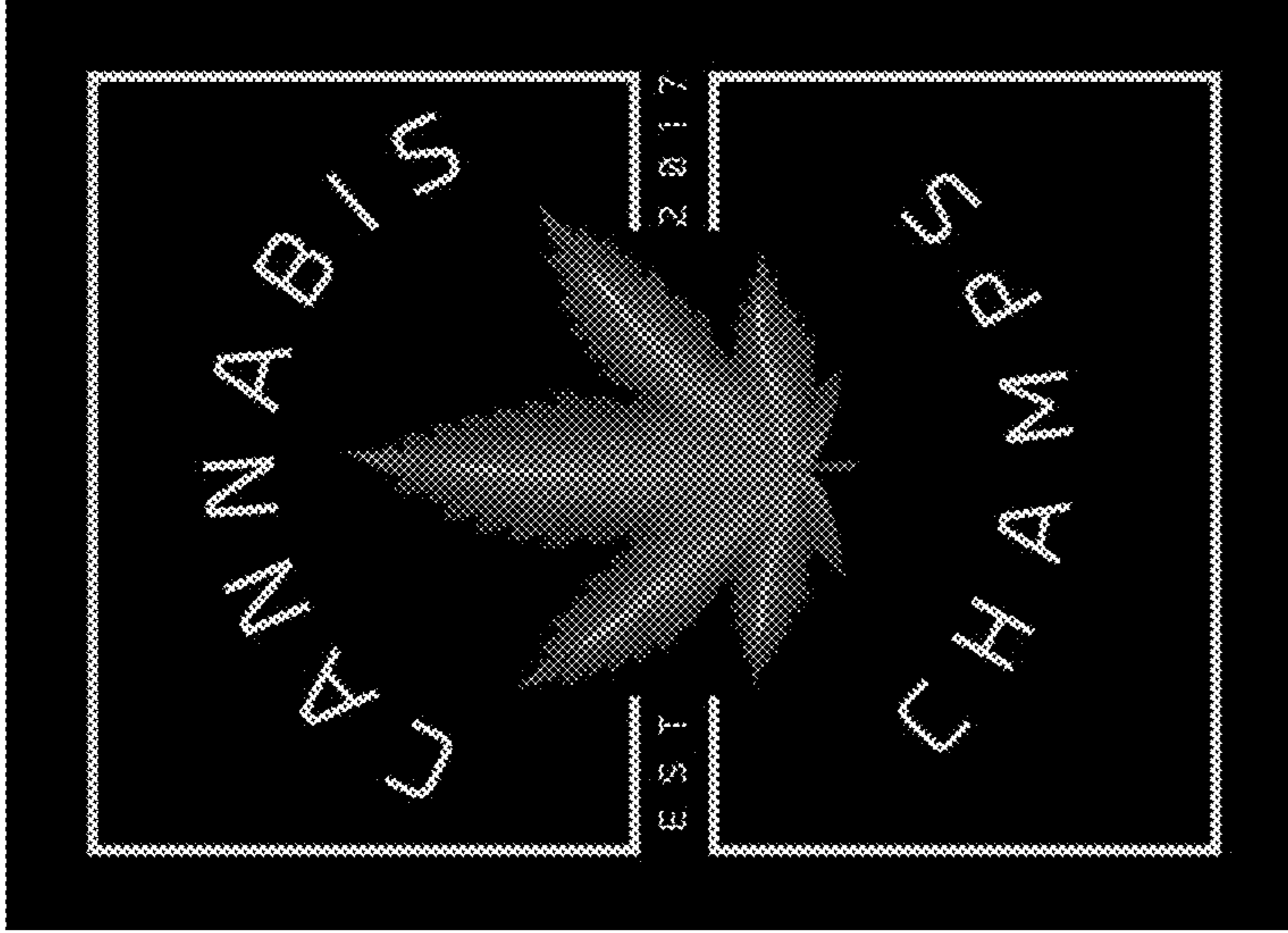

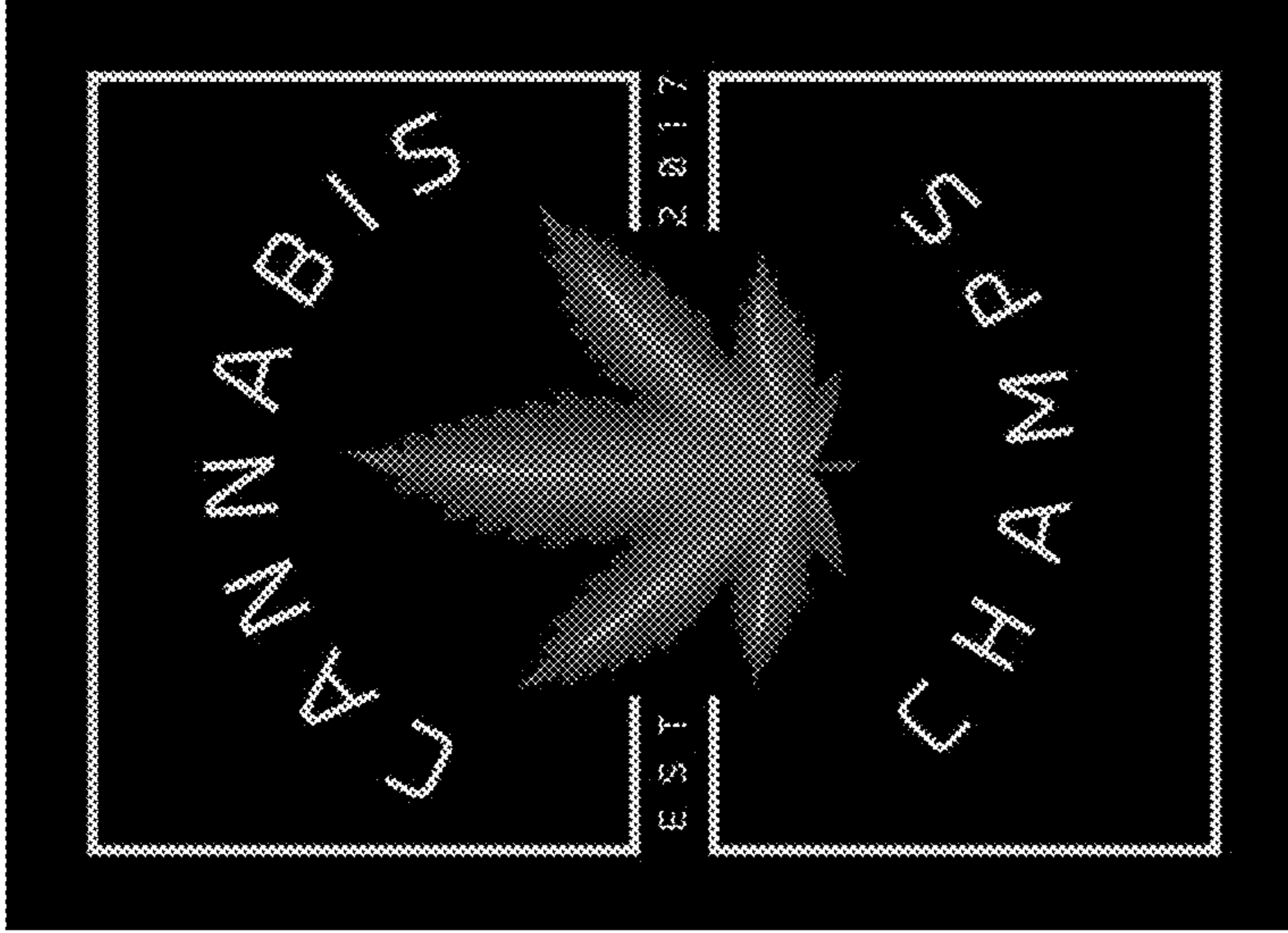

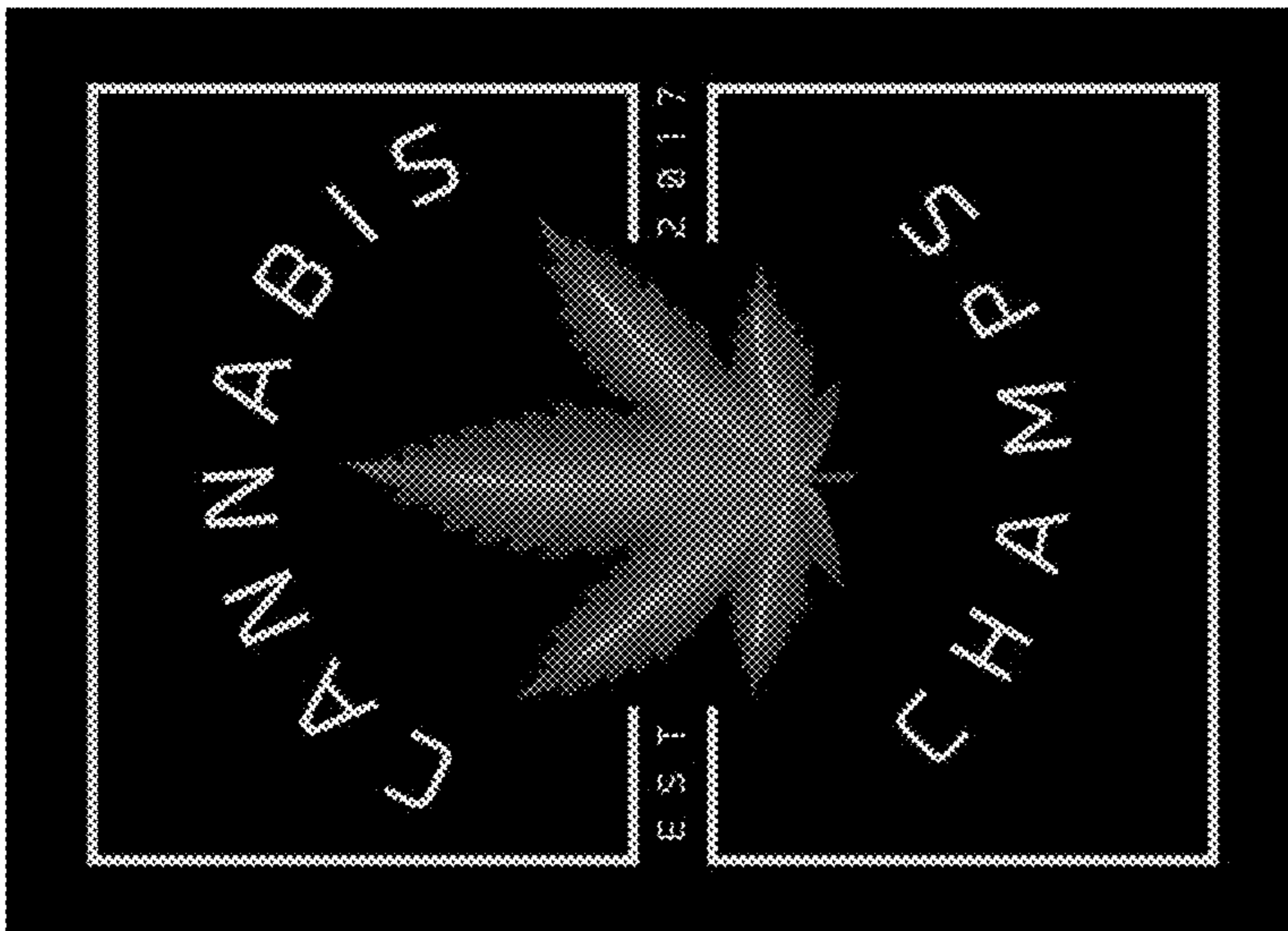

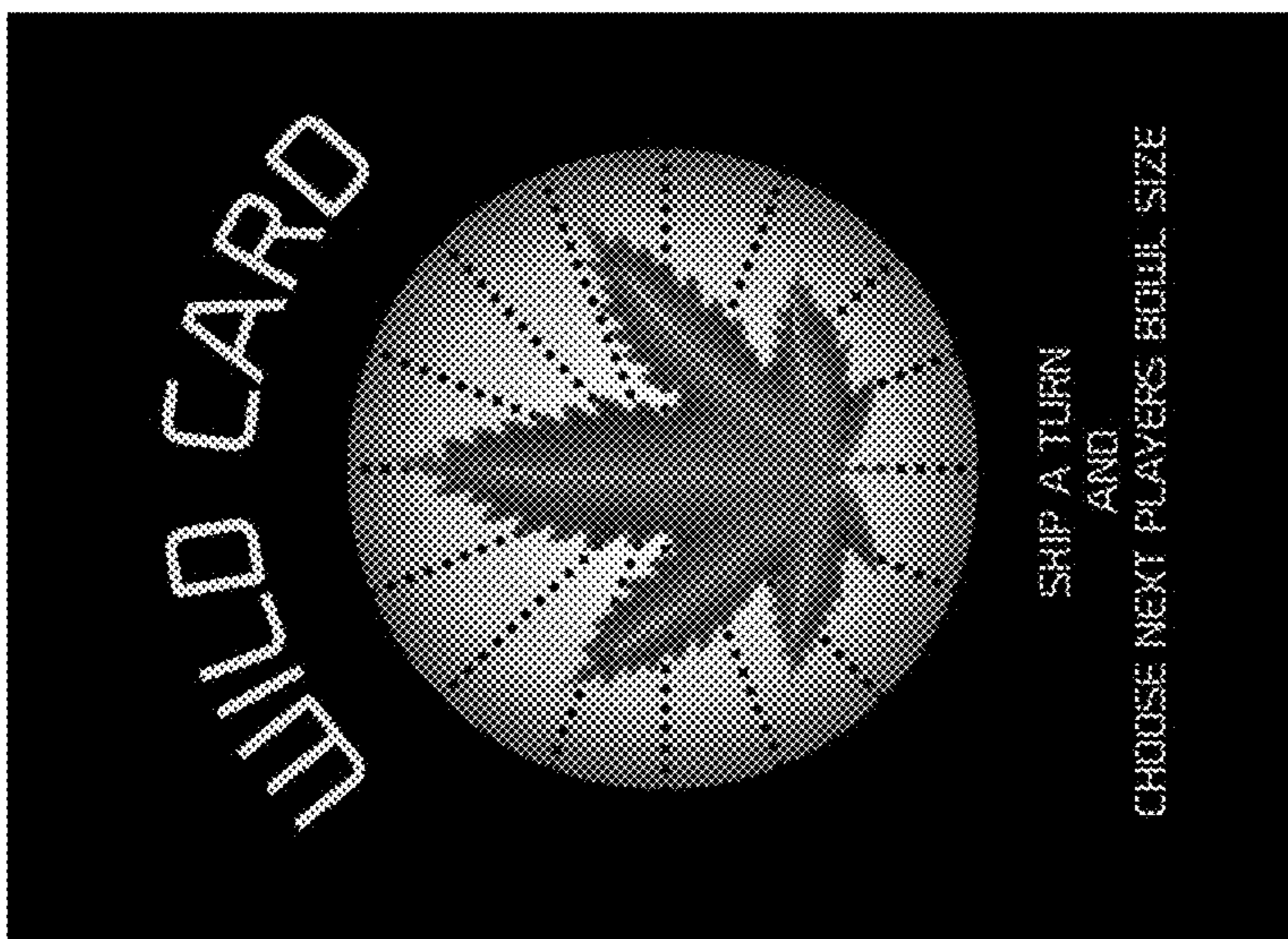
