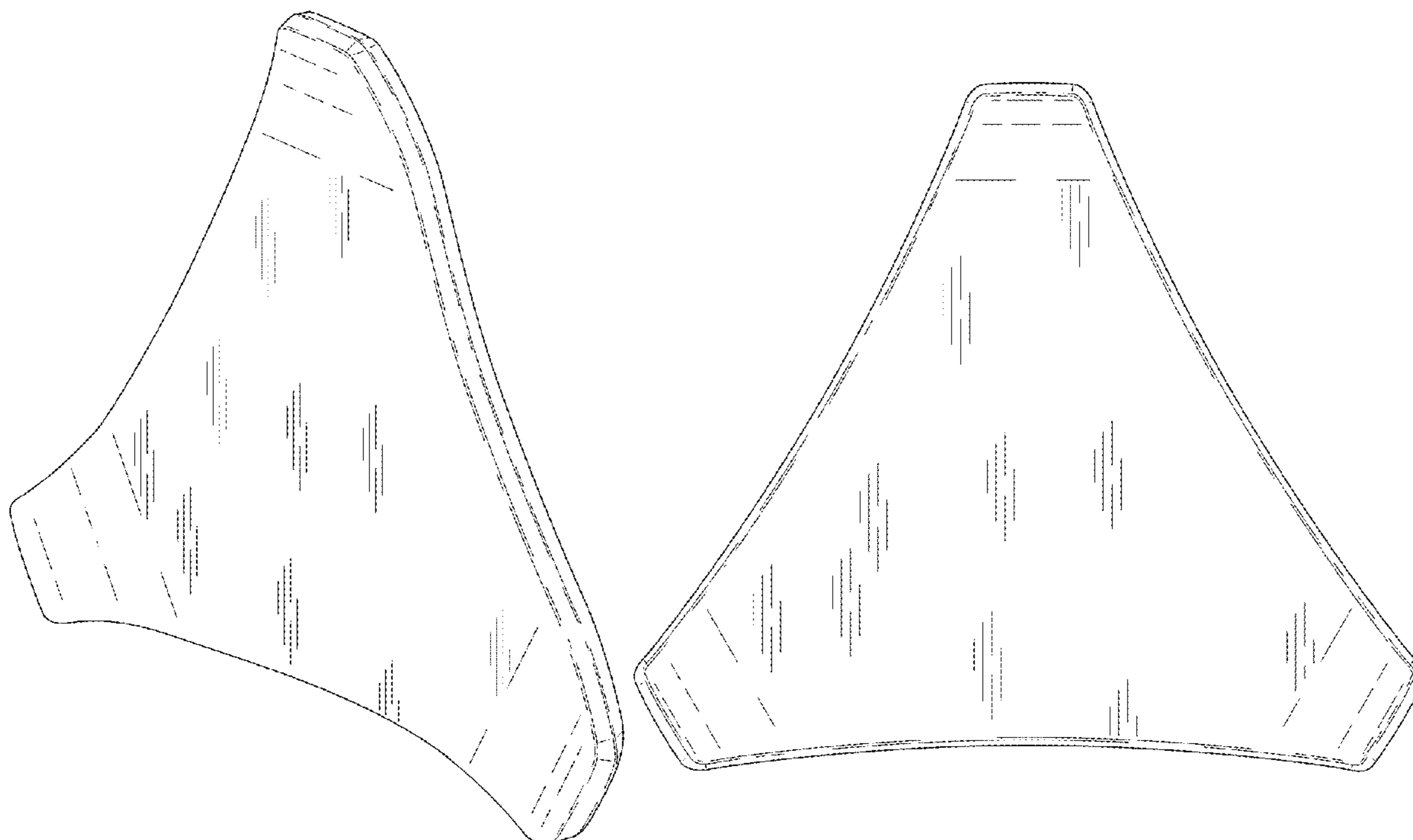
The ornamental design for a three-sided sports board with concave edges, as shown and described.

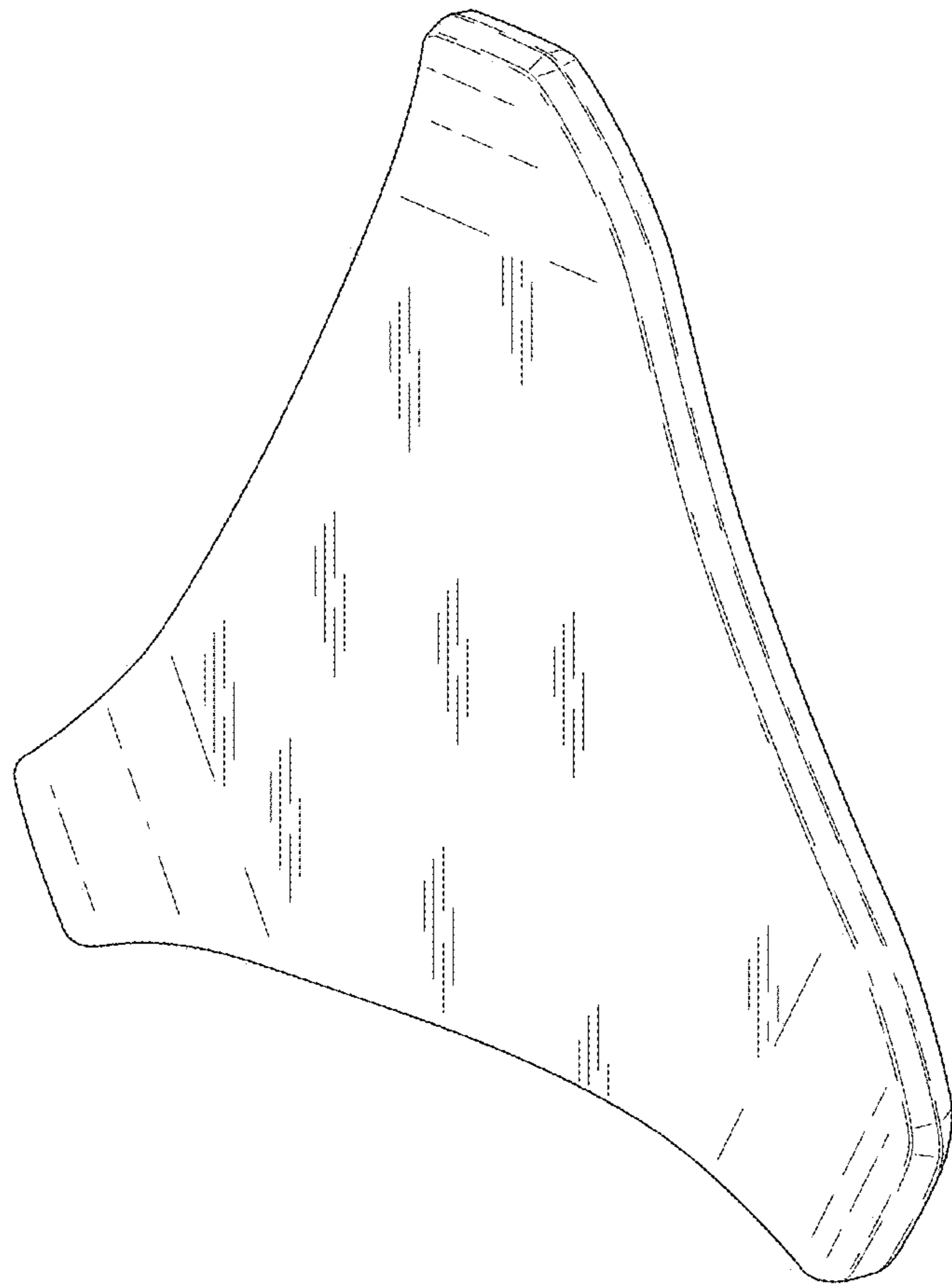
**DESCRIPTION**

FIG. 8 is an environmental top perspective view of the sports board.

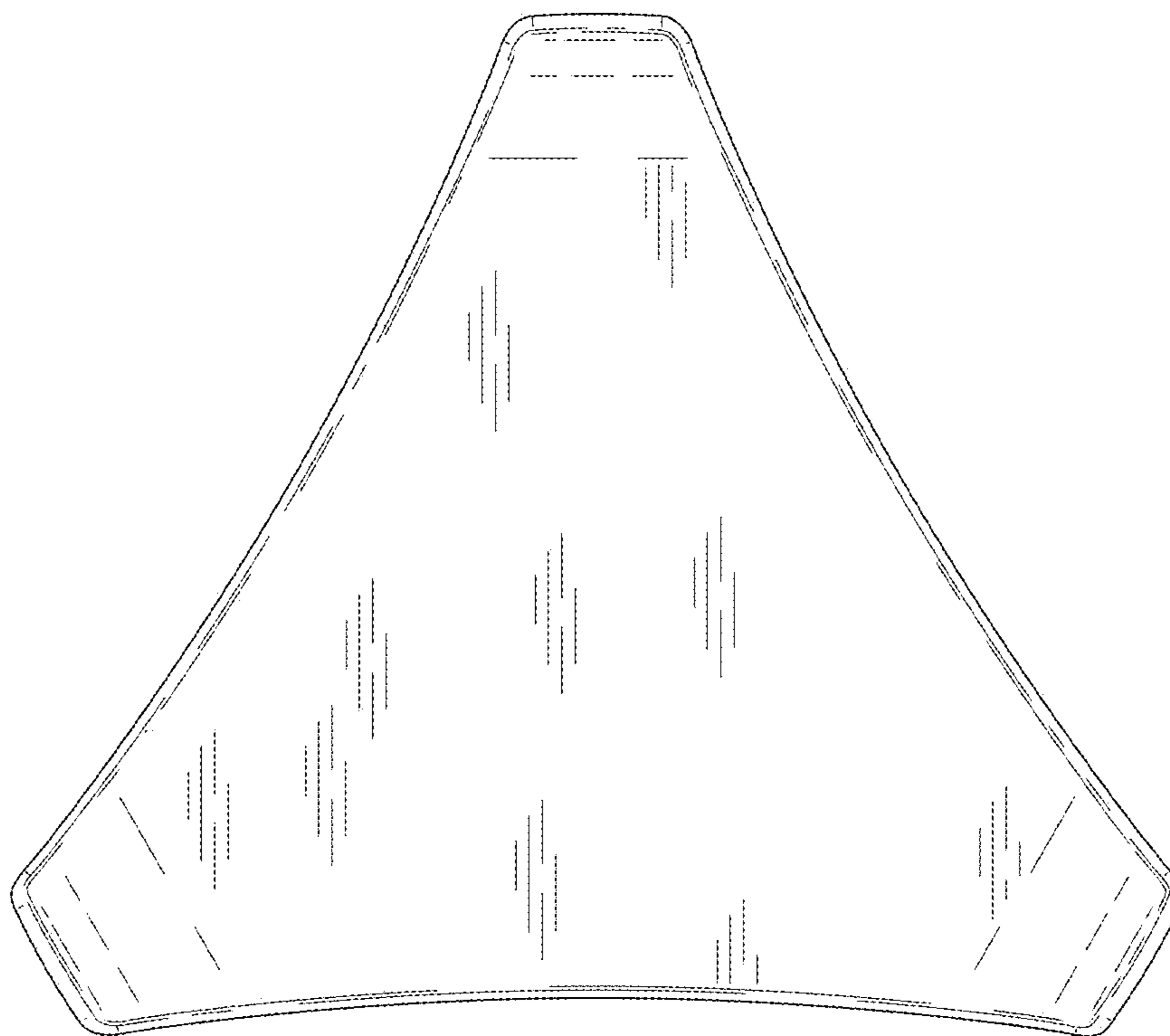
The broken lines shown in FIG. 8 represent unclaimed subject matter and form no part of the claimed design.

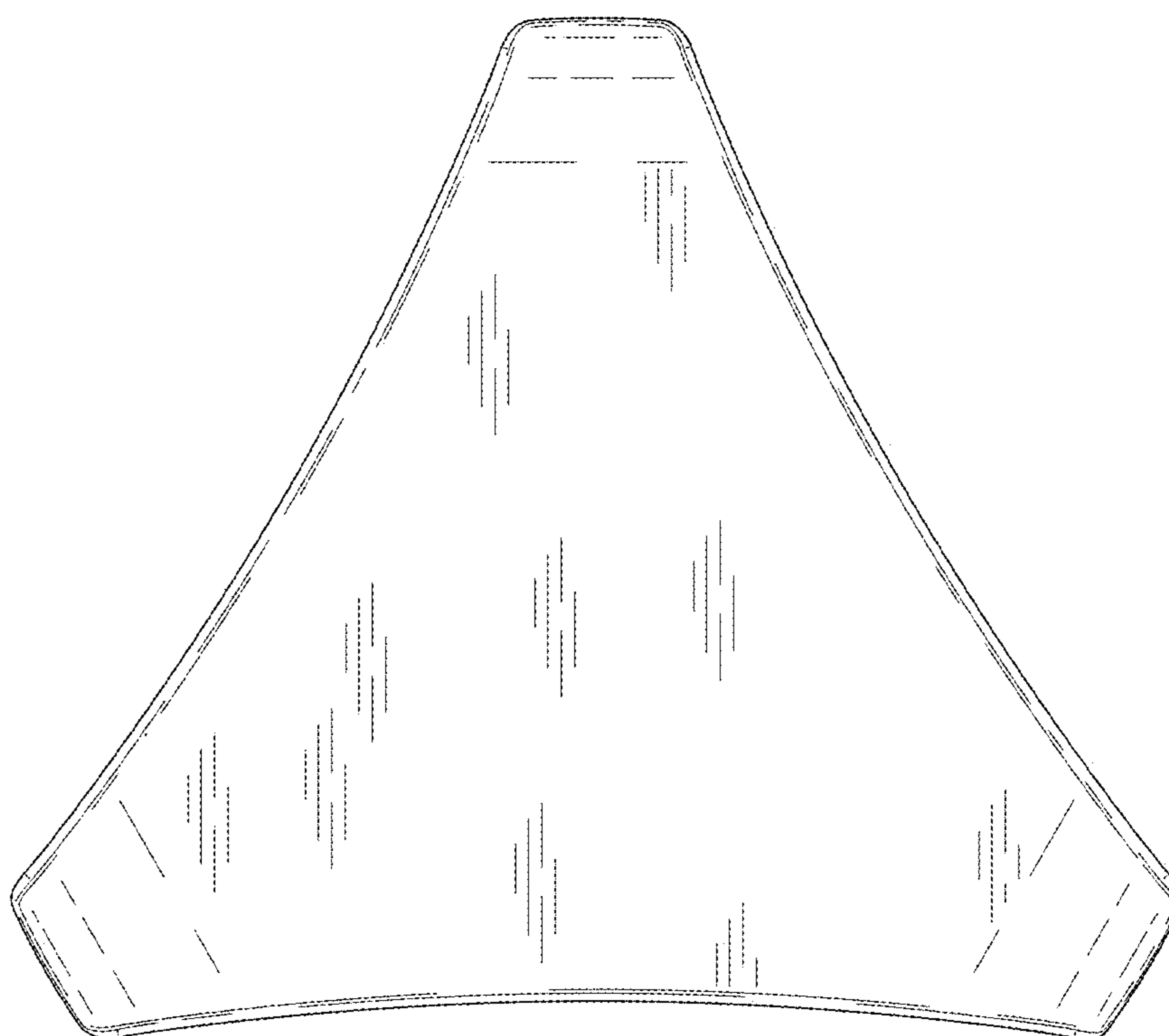




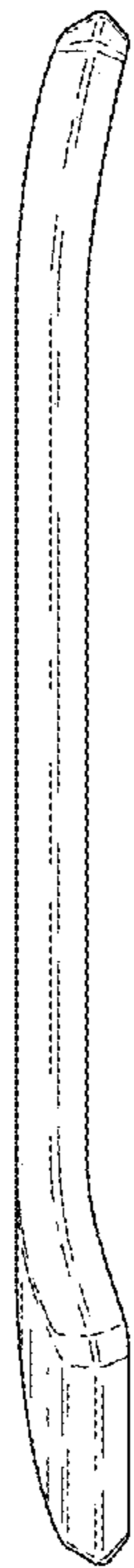

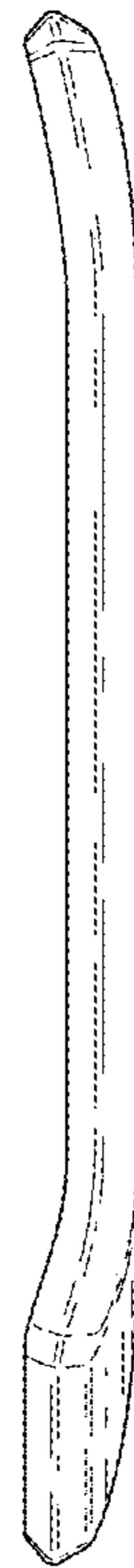

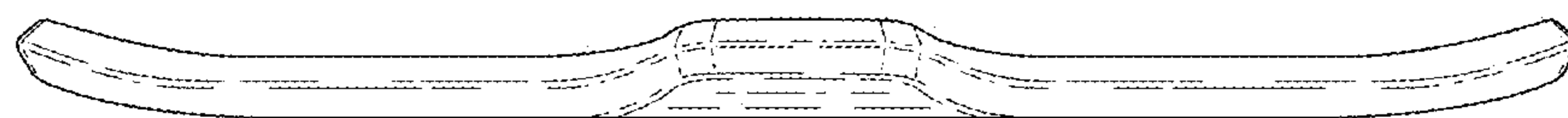

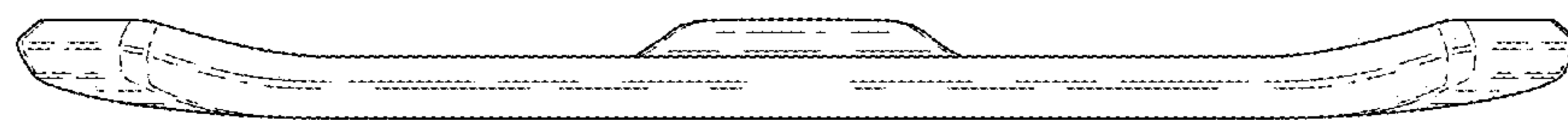
