FIG. 10 is a front plan view thereof;

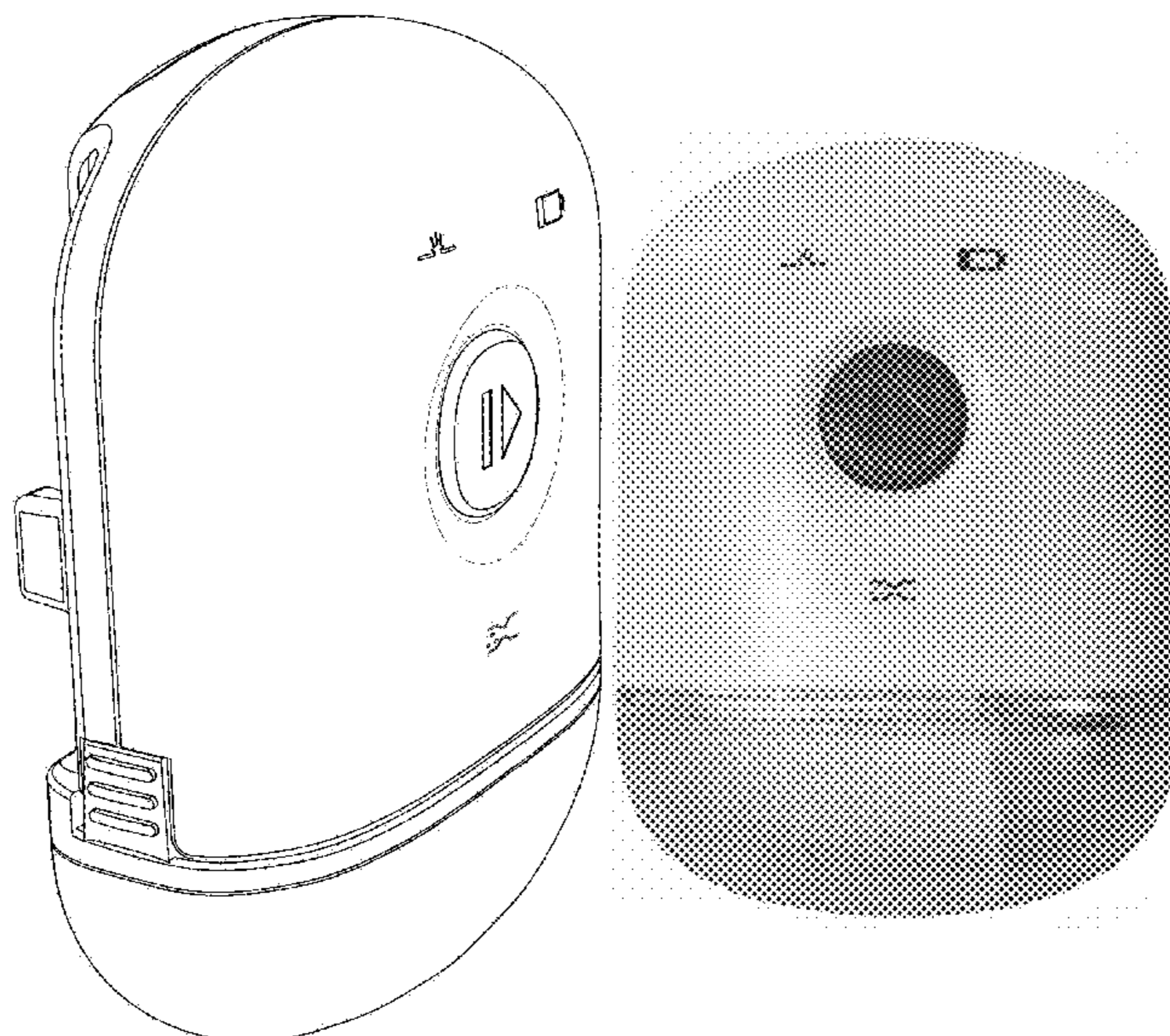
FIG. 11 is a rear elevational view thereof;

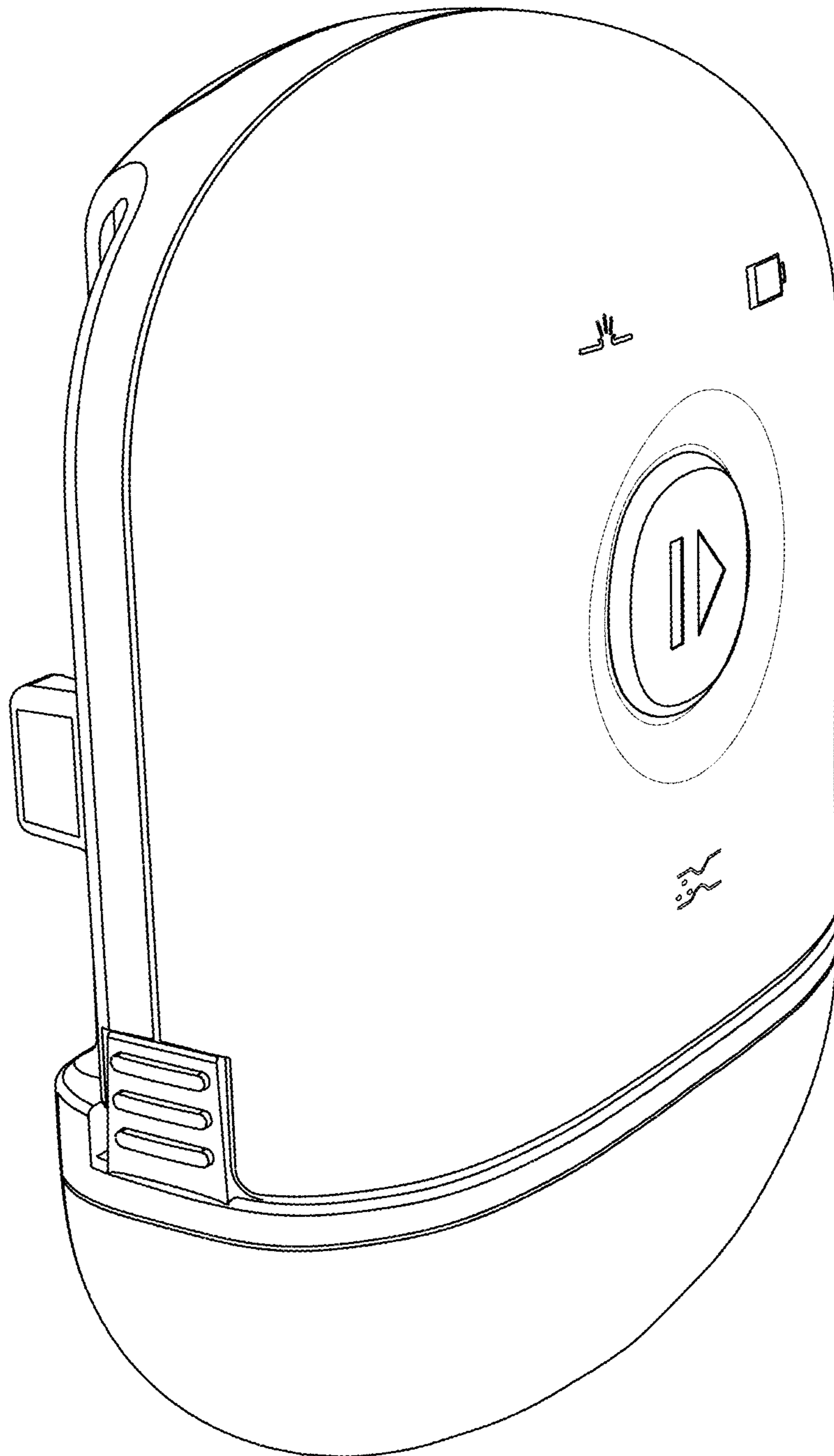

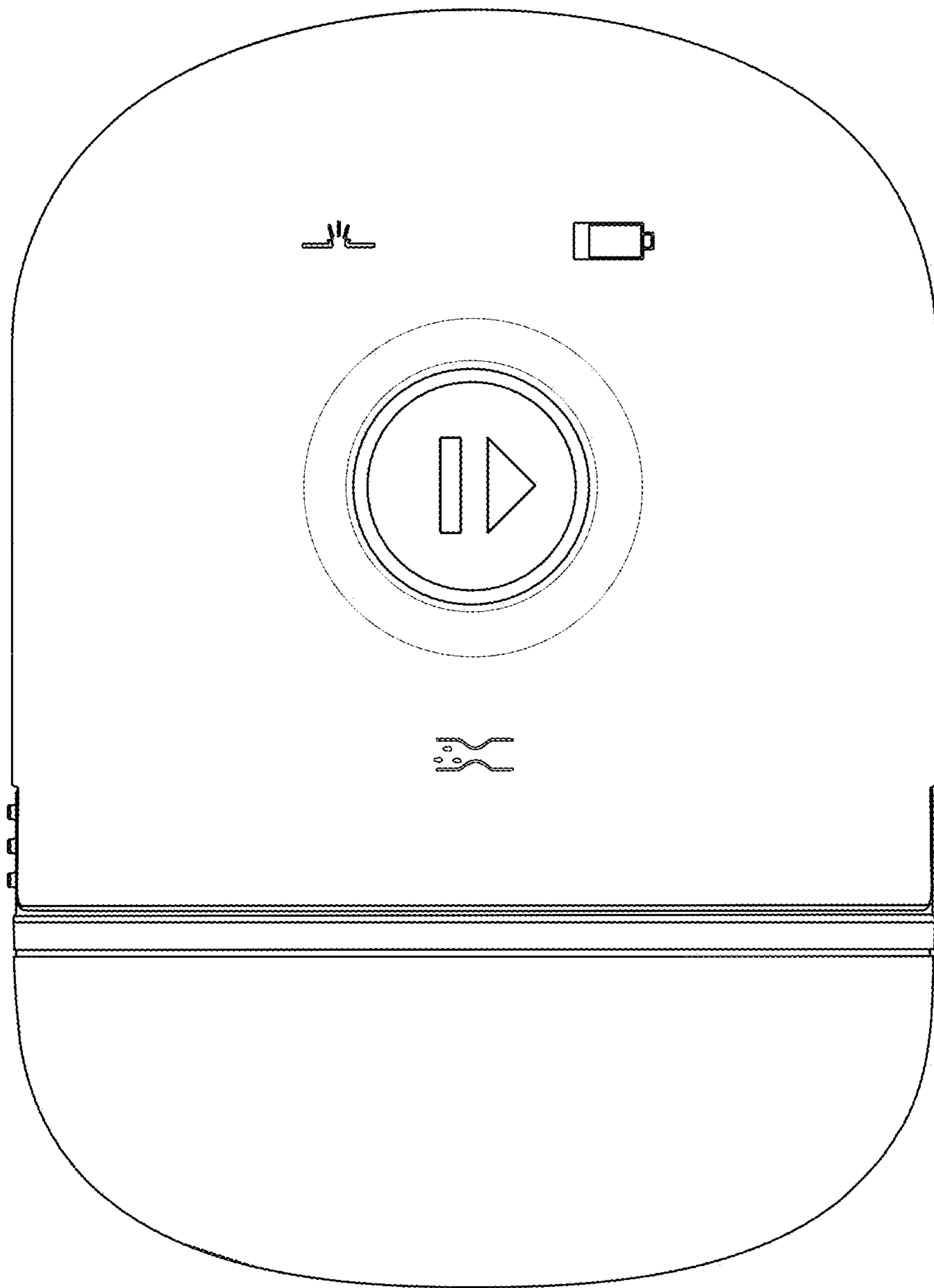
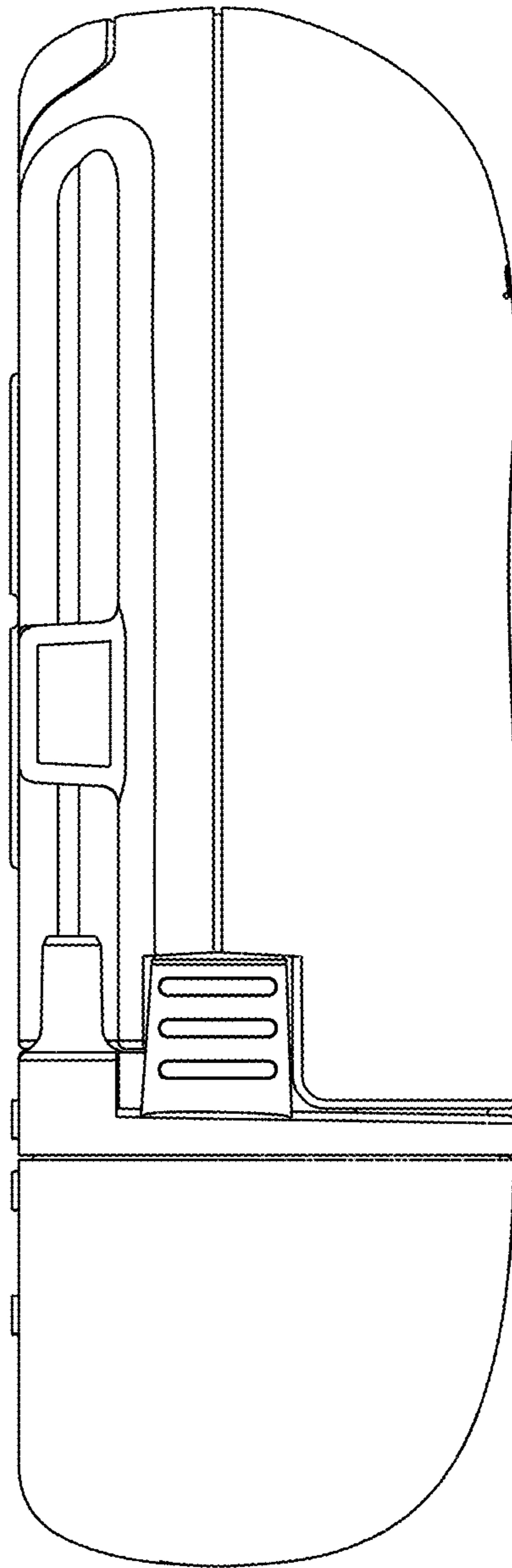
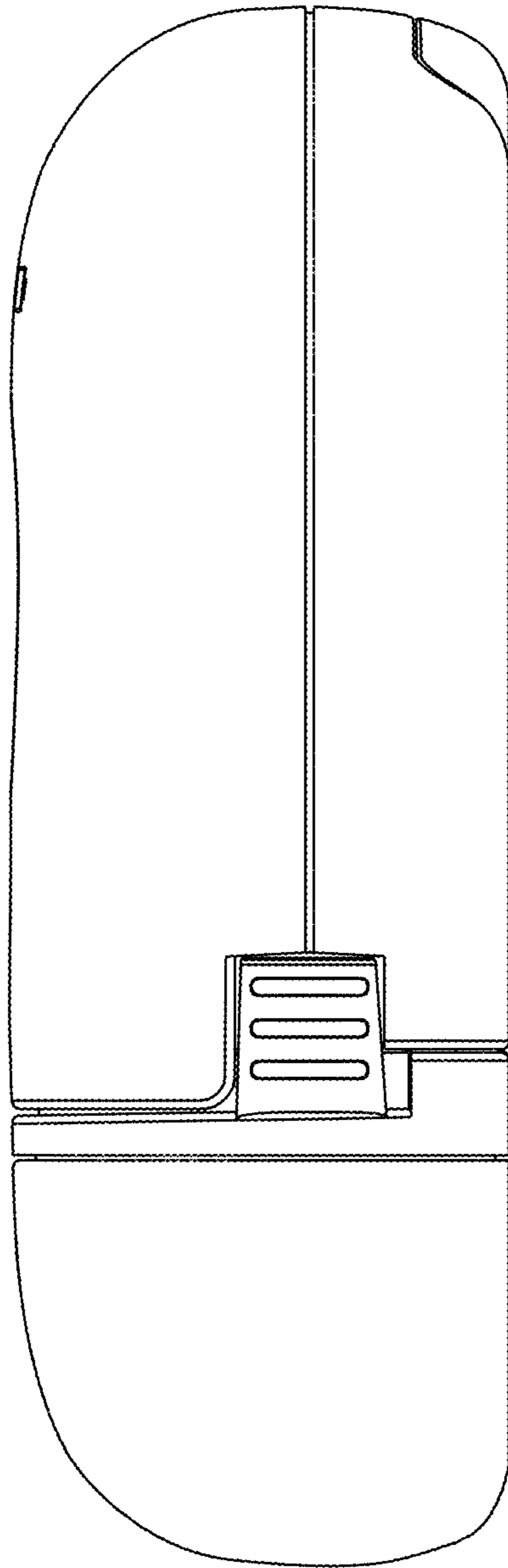

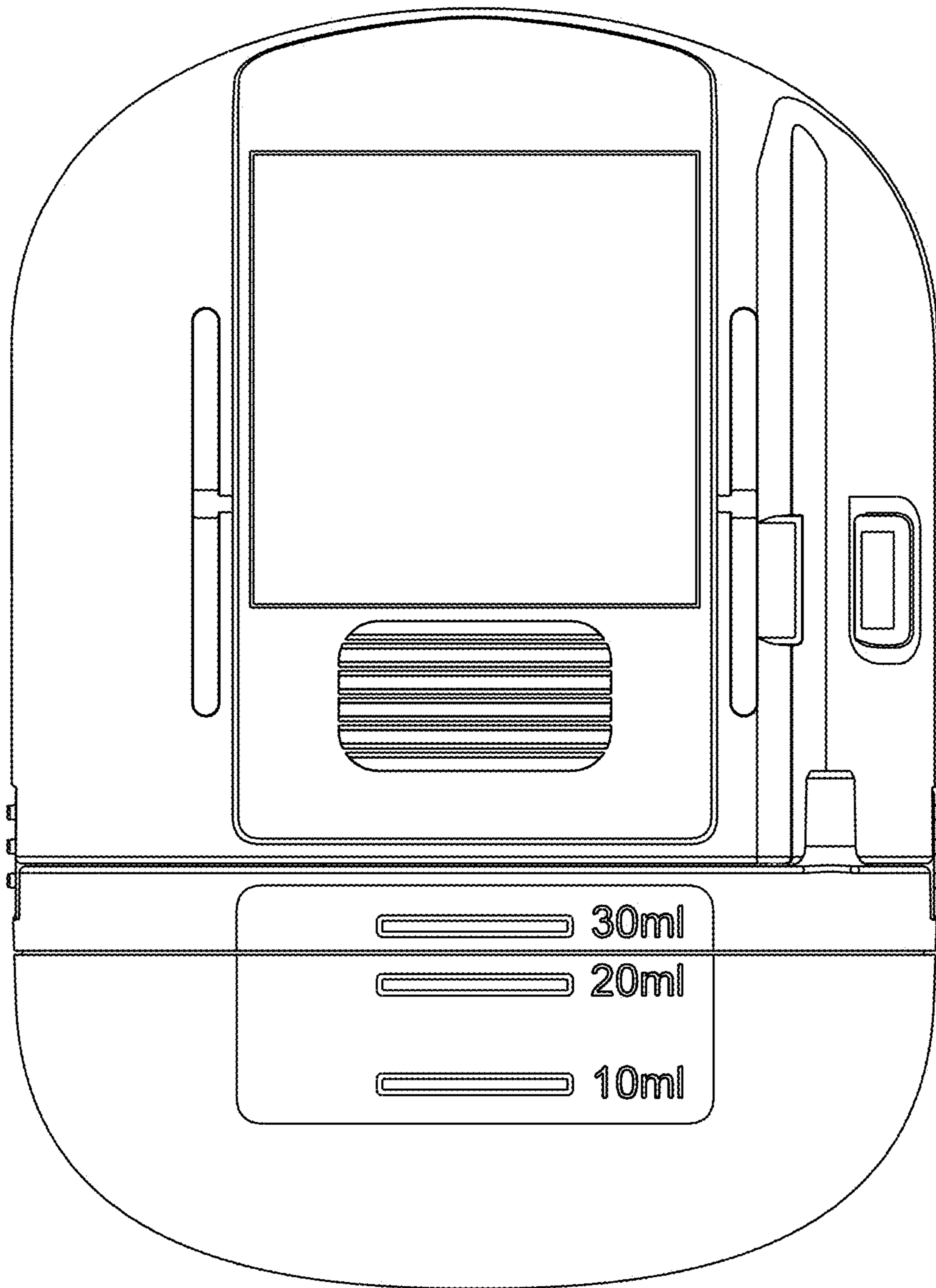
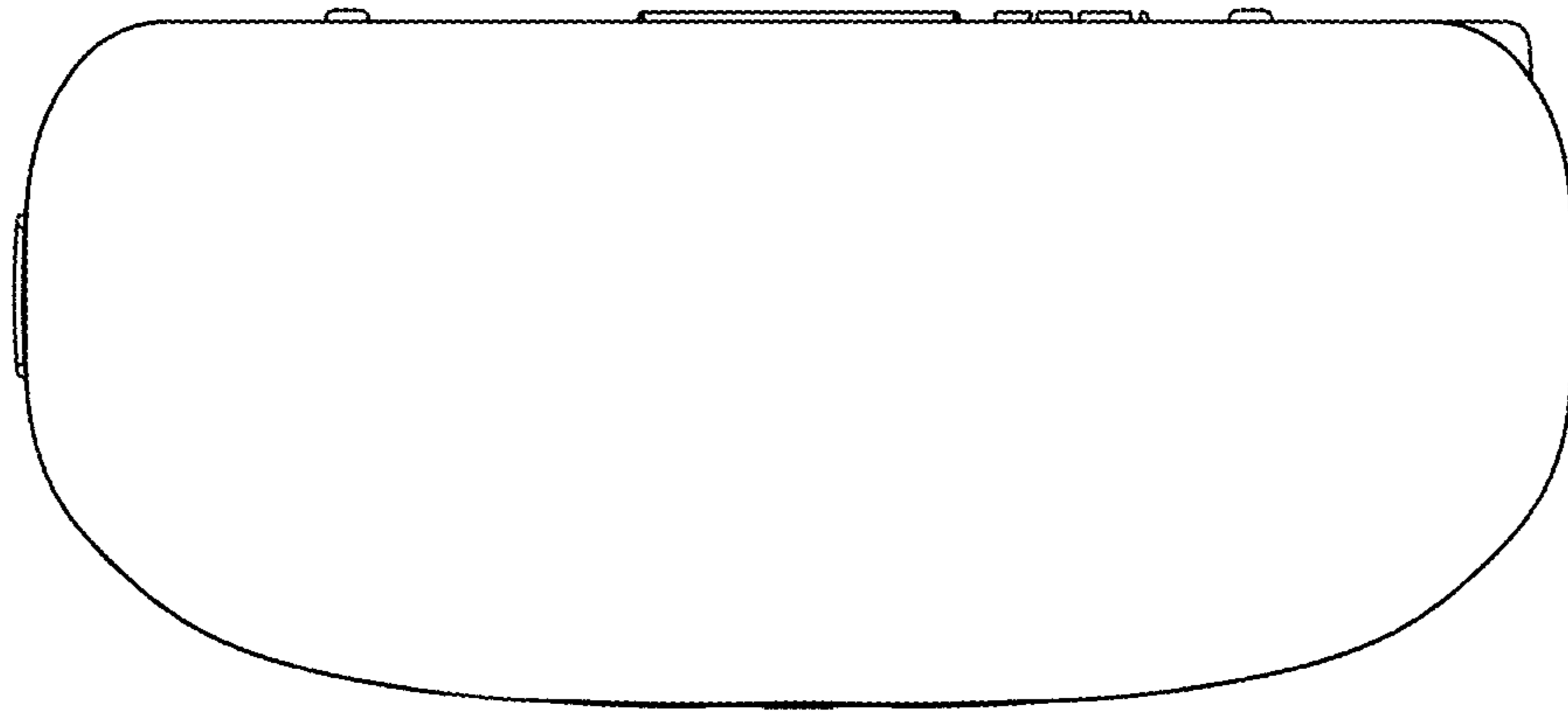
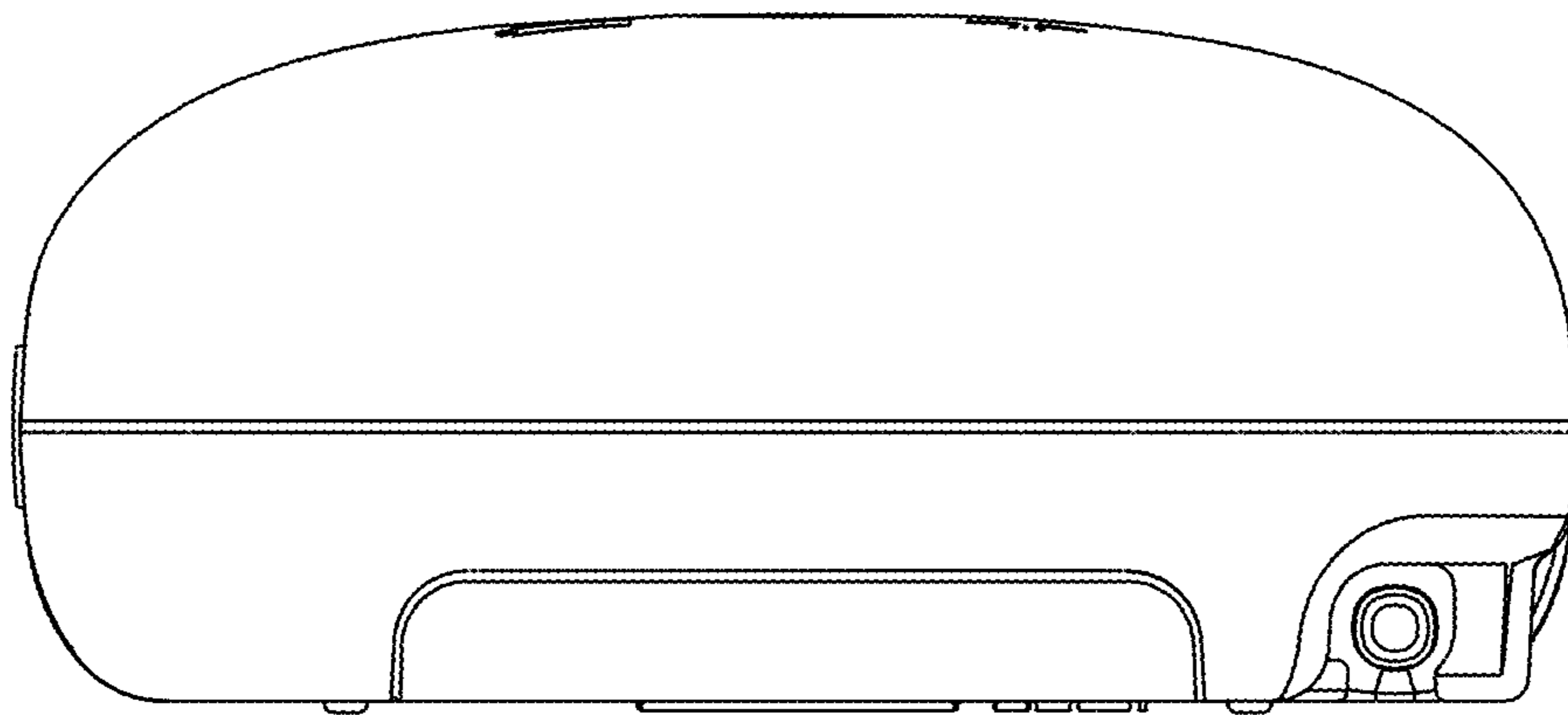

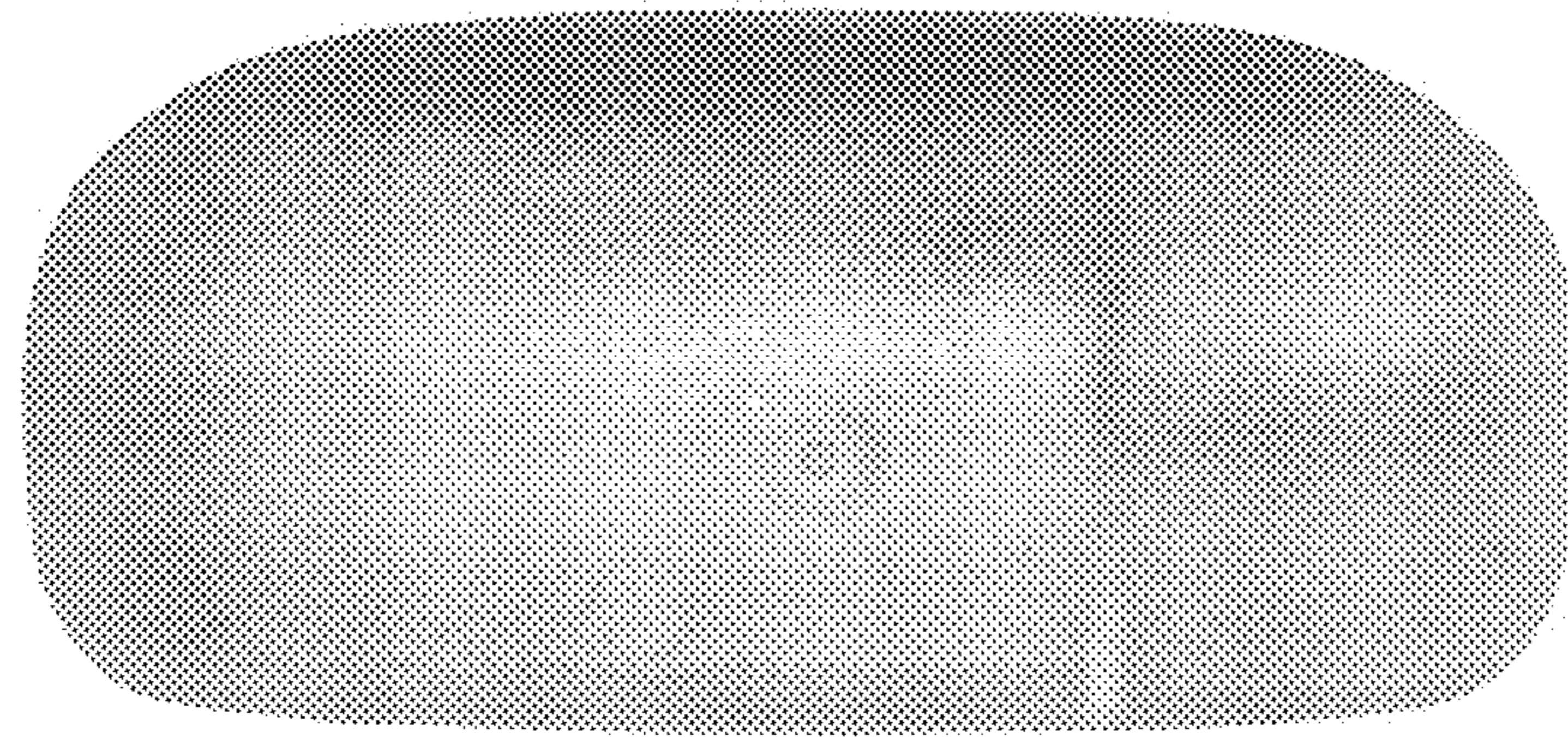

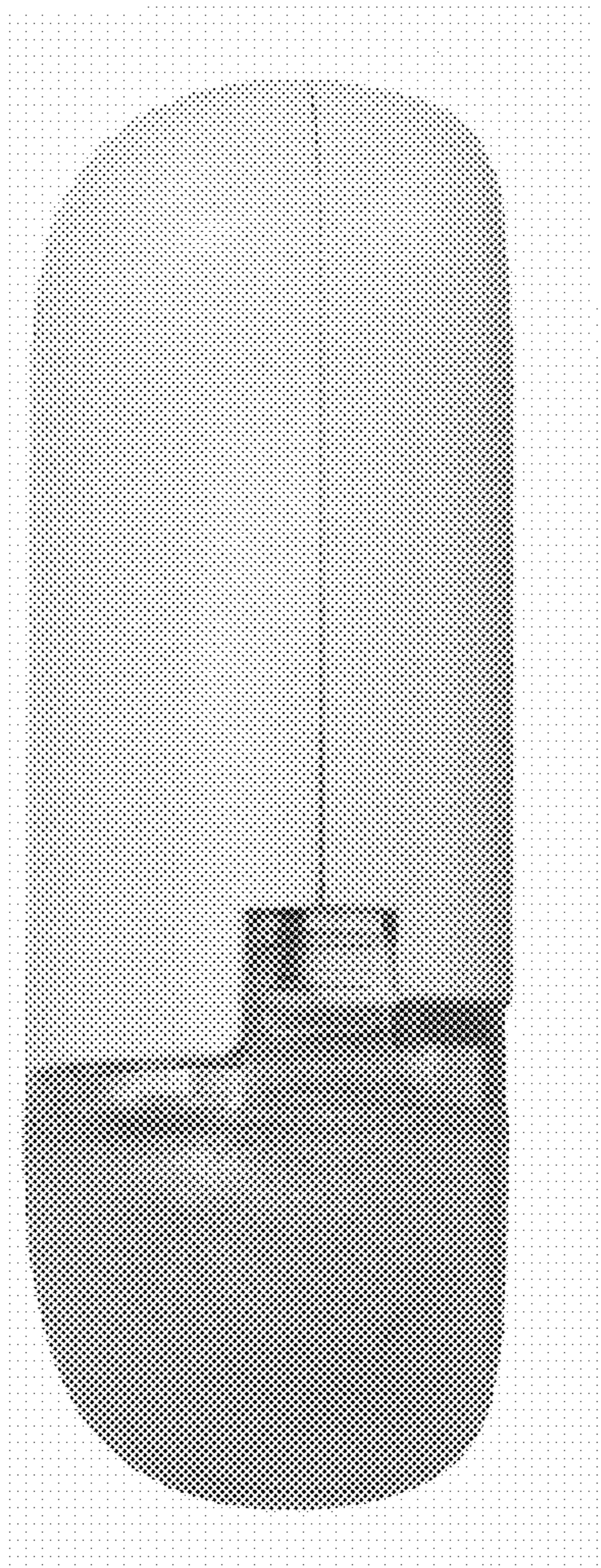

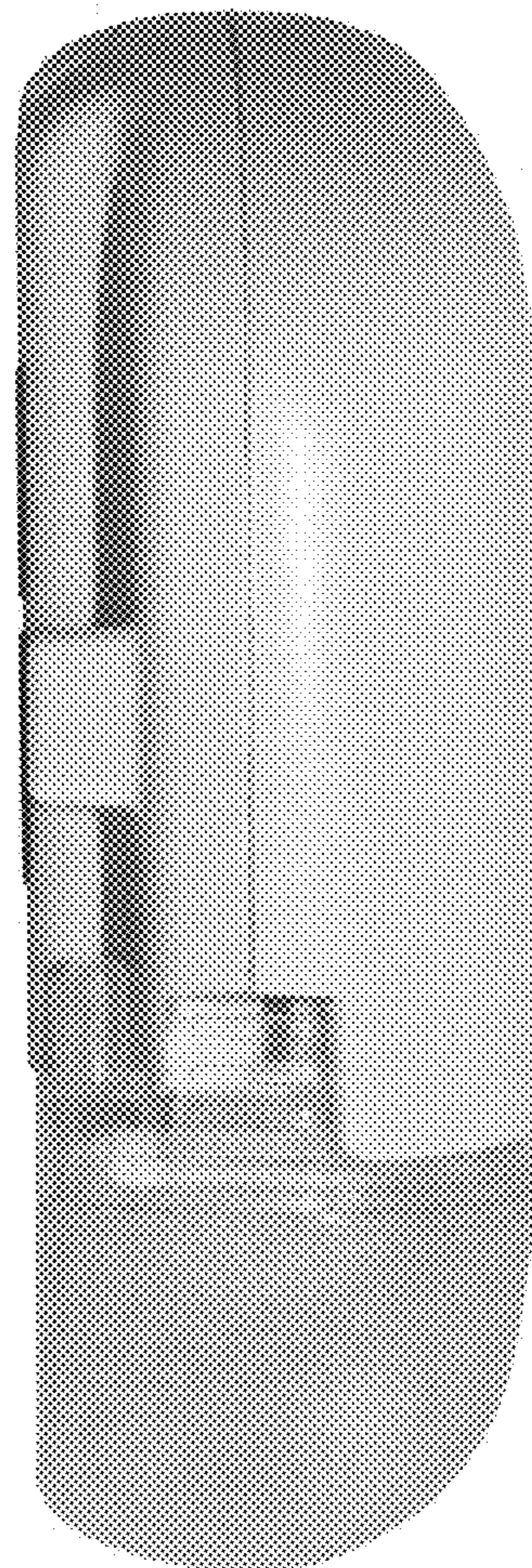
