I claim the ornamental design for an artificial turf padding layer panel, as shown and described.

FIG. 6 is a bottom view thereof;

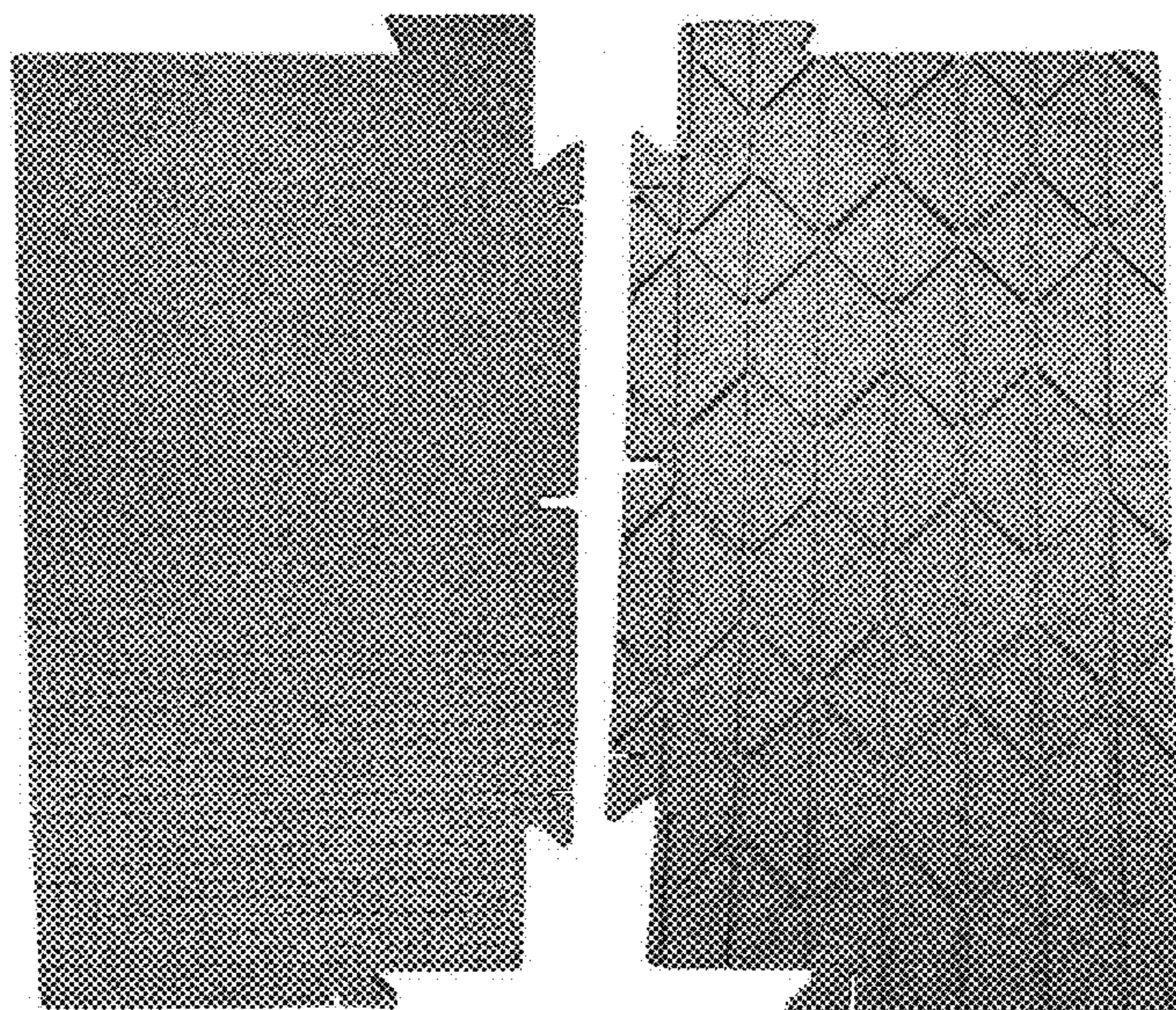
FIG. 7 is a bottom rear perspective view thereof;

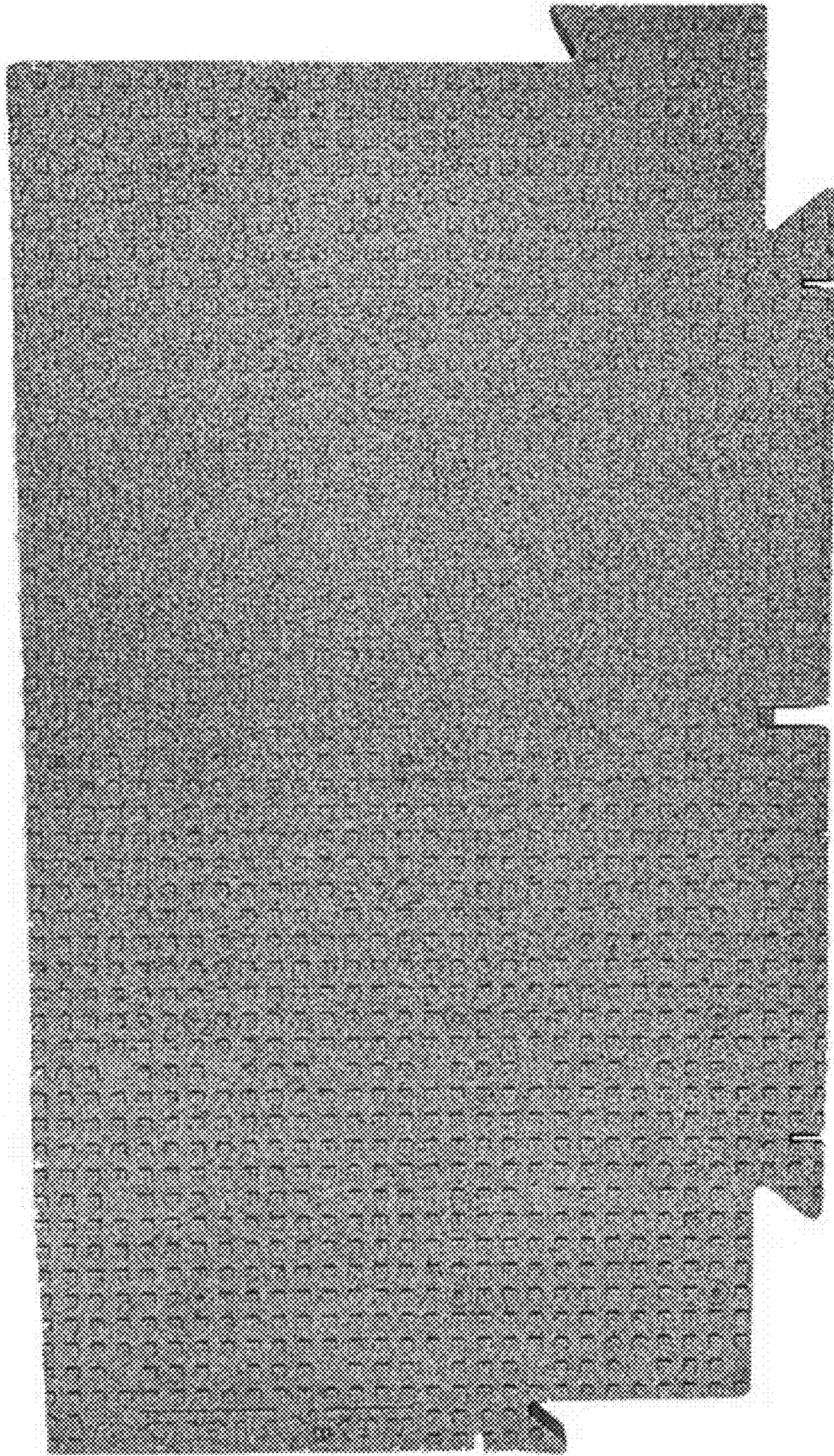

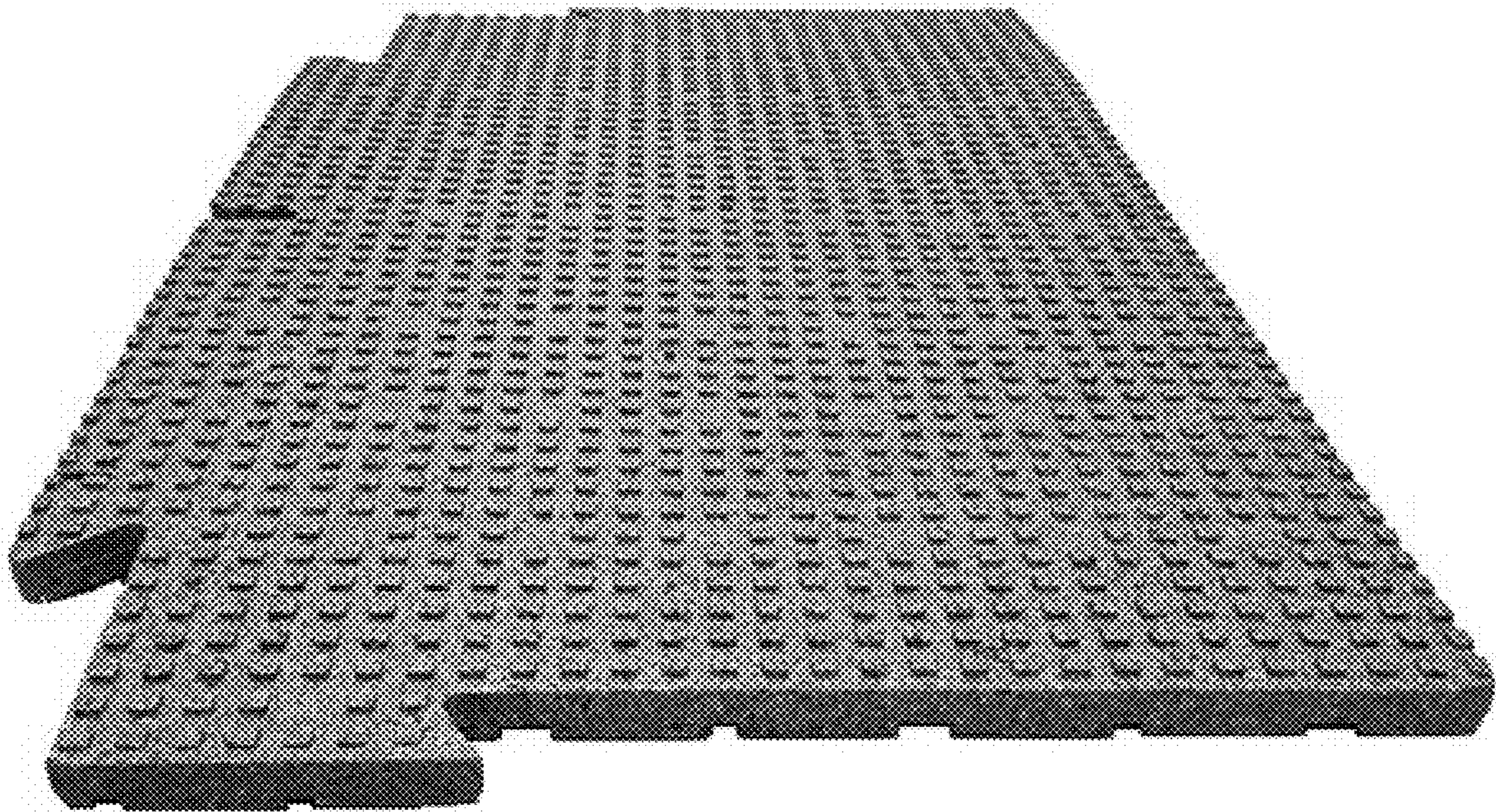

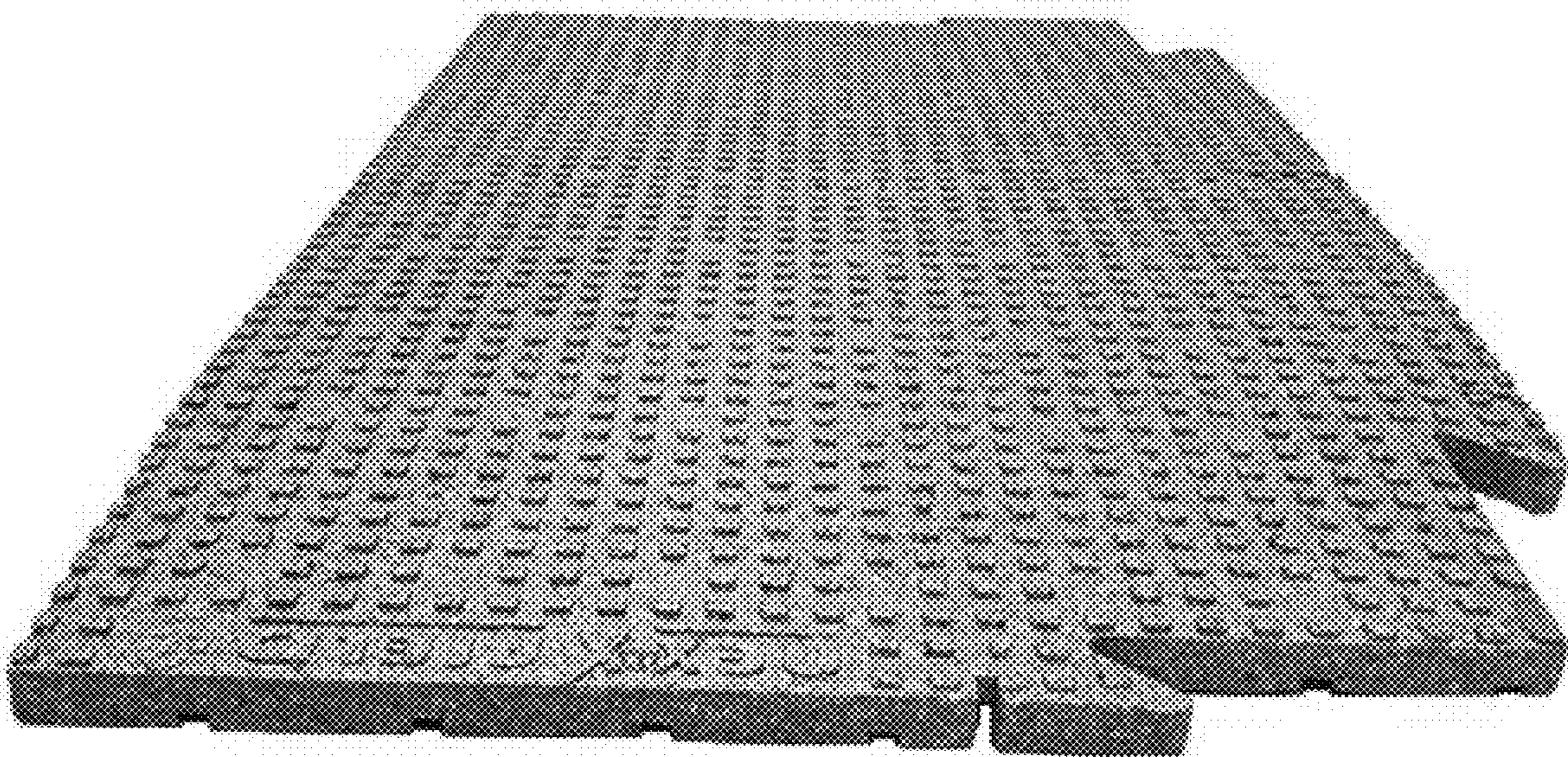

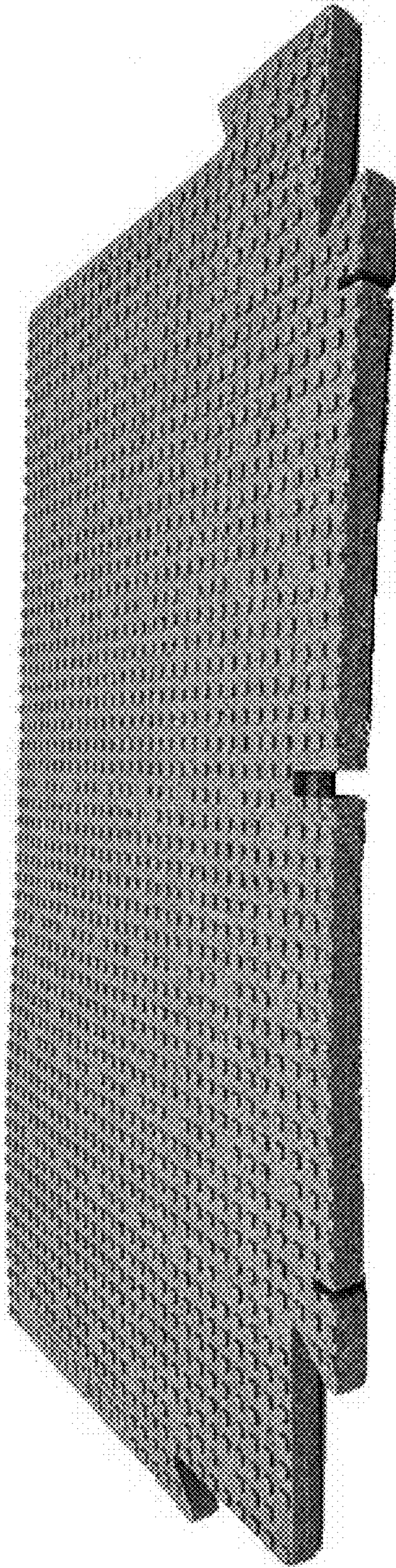

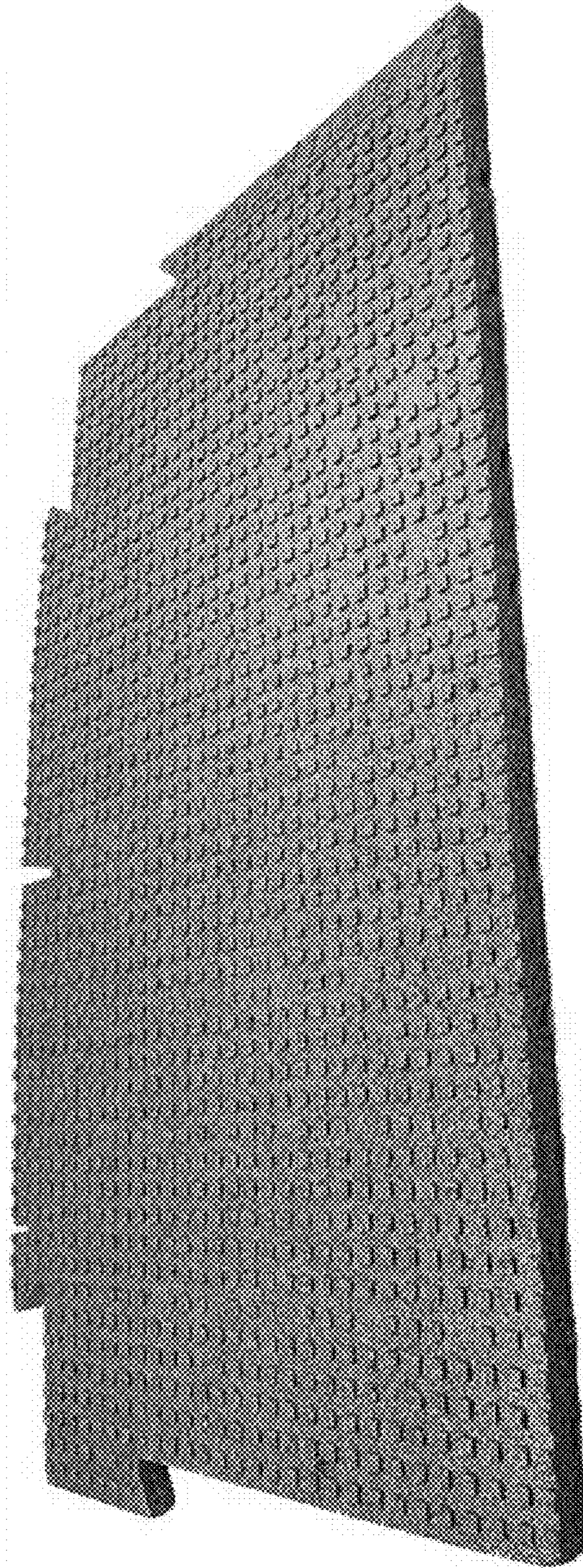

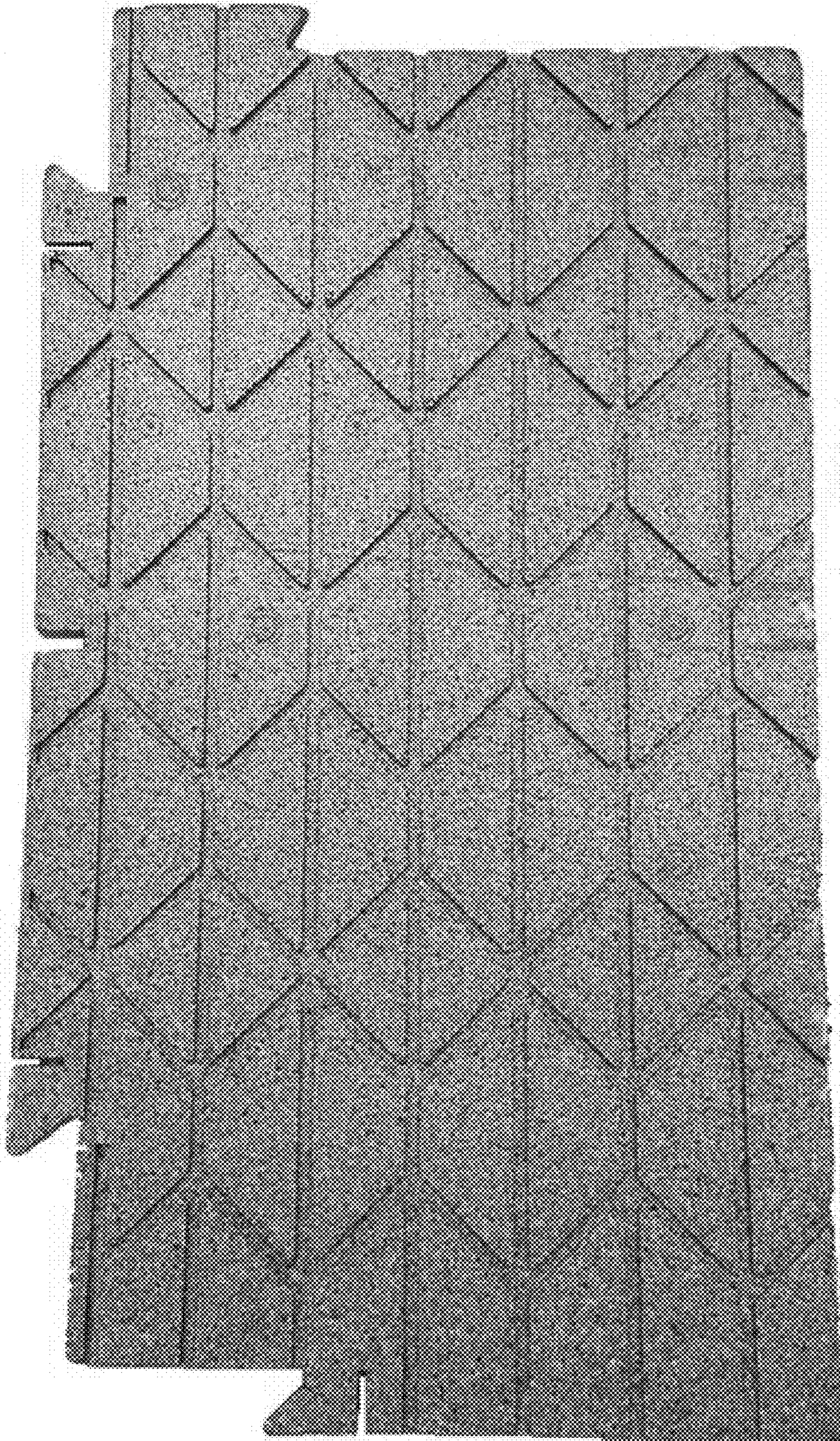

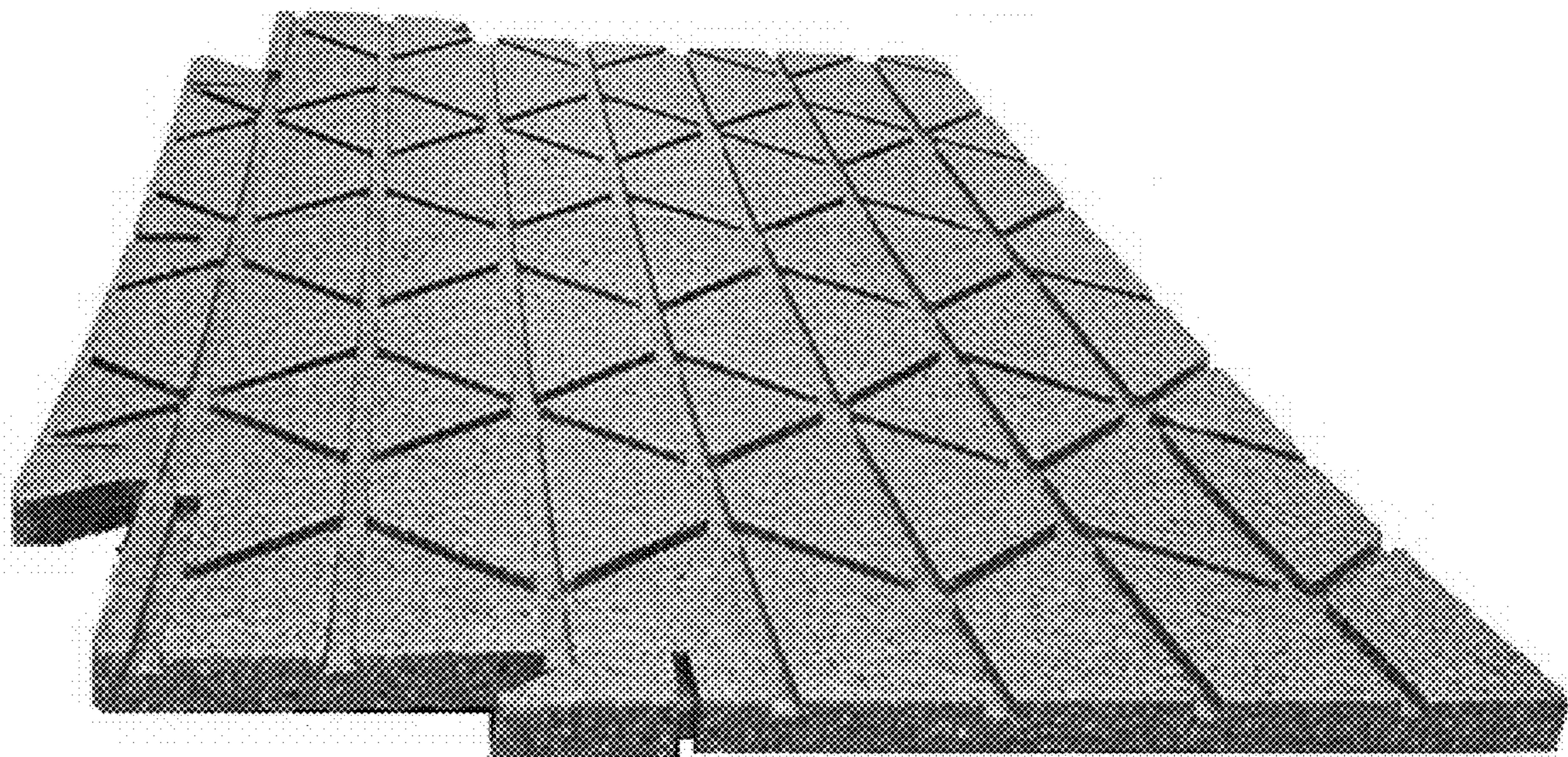

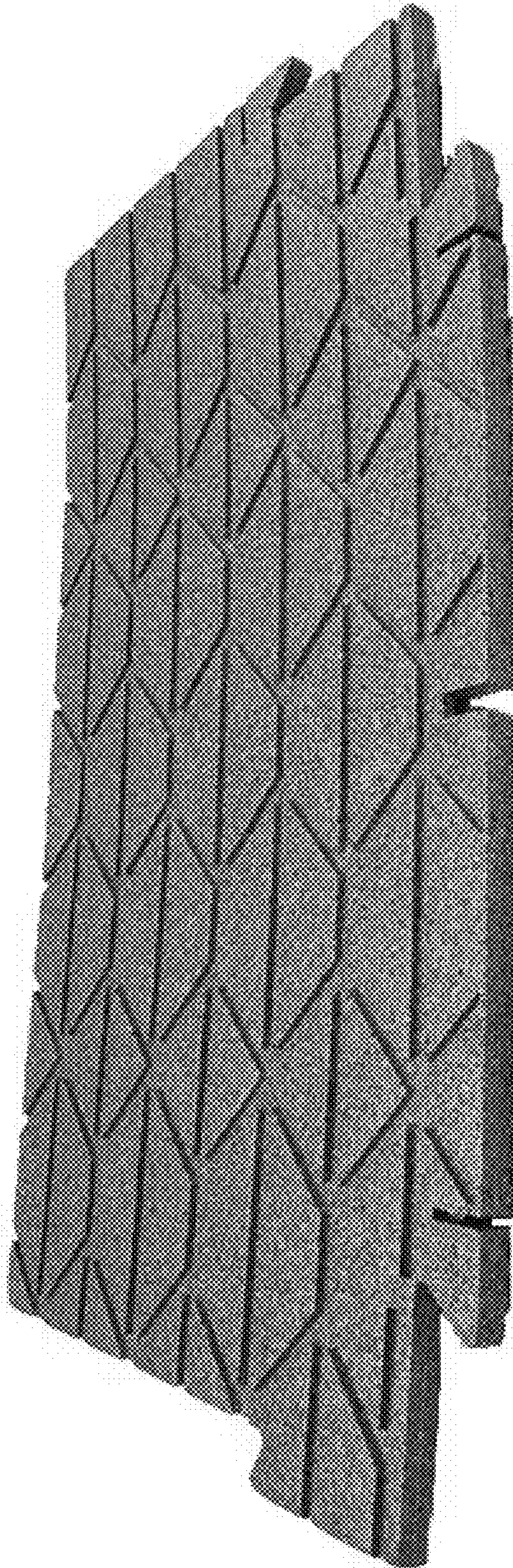

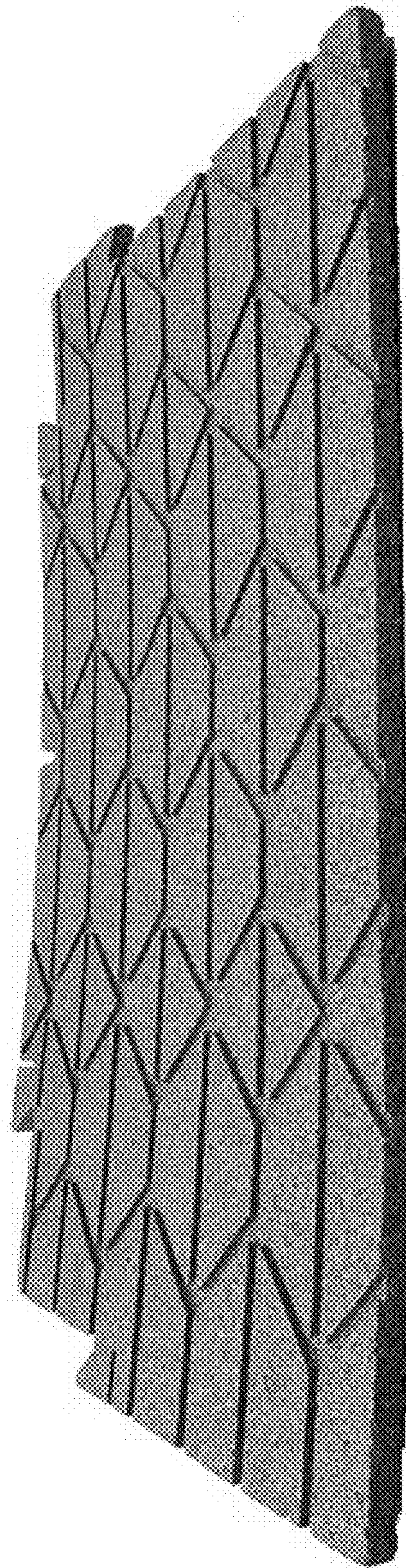
