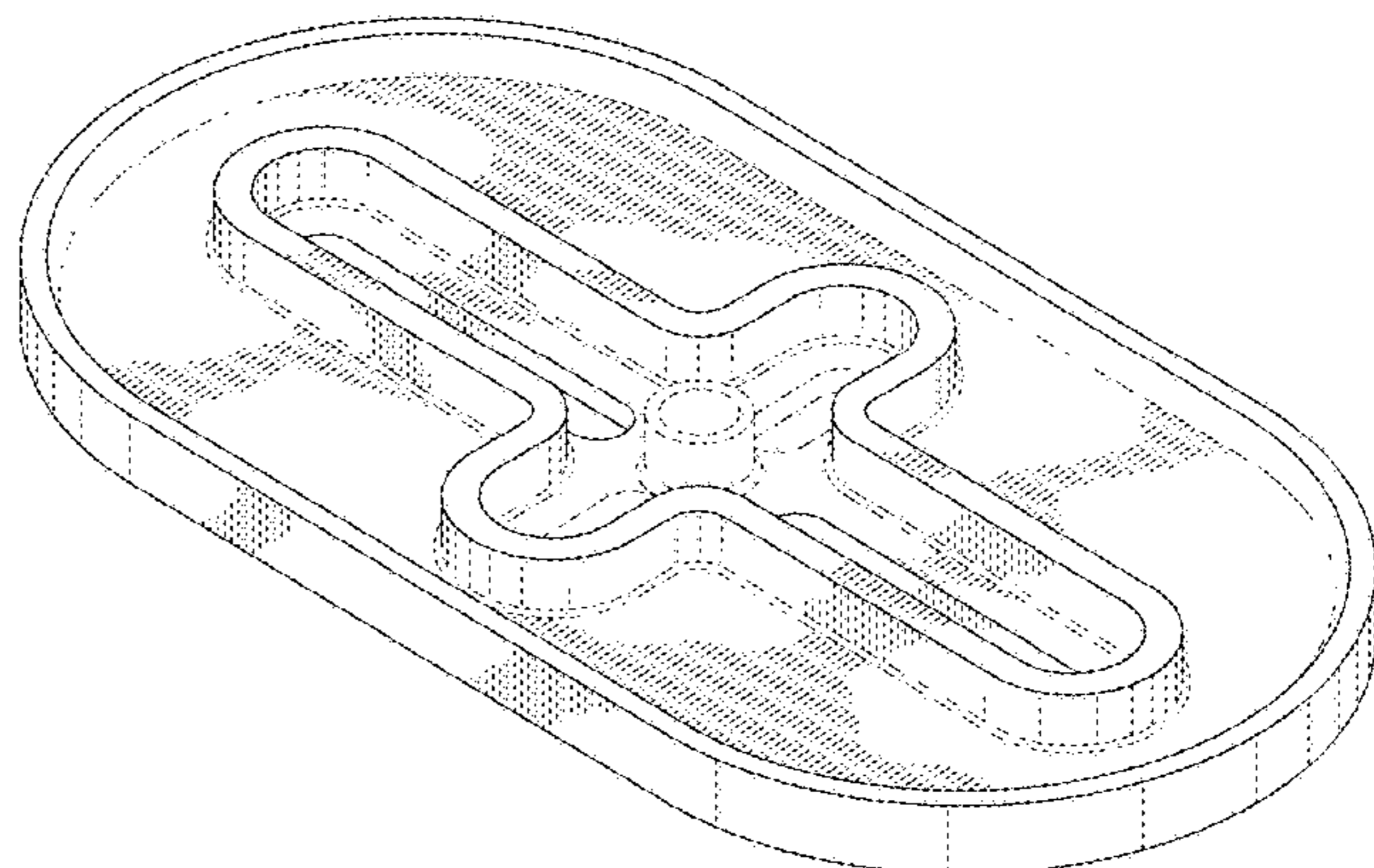
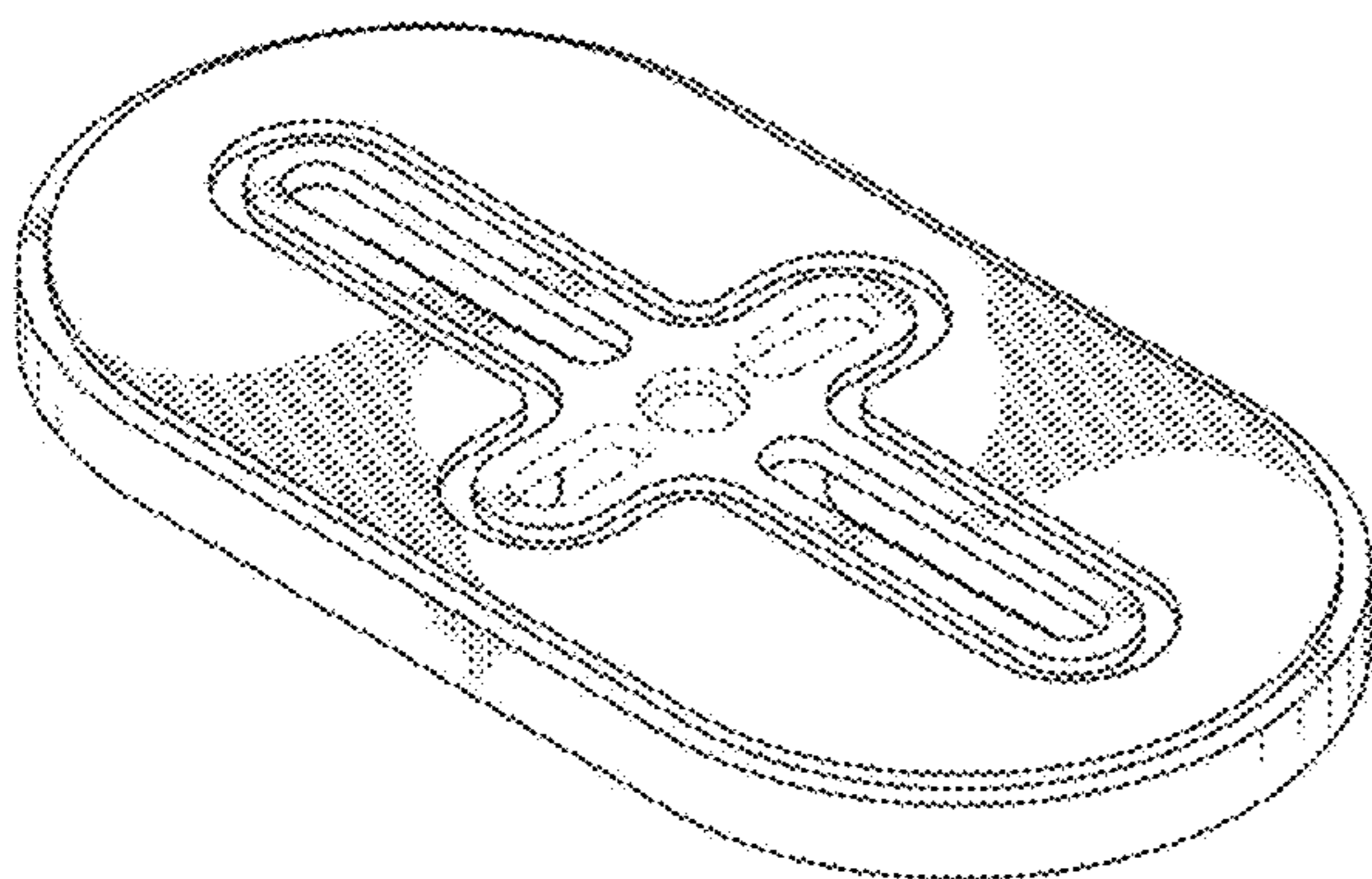
(57) **CLAIM**

The ornamental design for a shim for roof and wall panels, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shim for roof and wall panels showing our new design;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a rear view thereof; and,  
FIG. 8 is a bottom, rear, left perspective view thereof.  
The broken lines in FIGS. 1, 6, and 7 depict features of the shim that form no part of the claimed design.

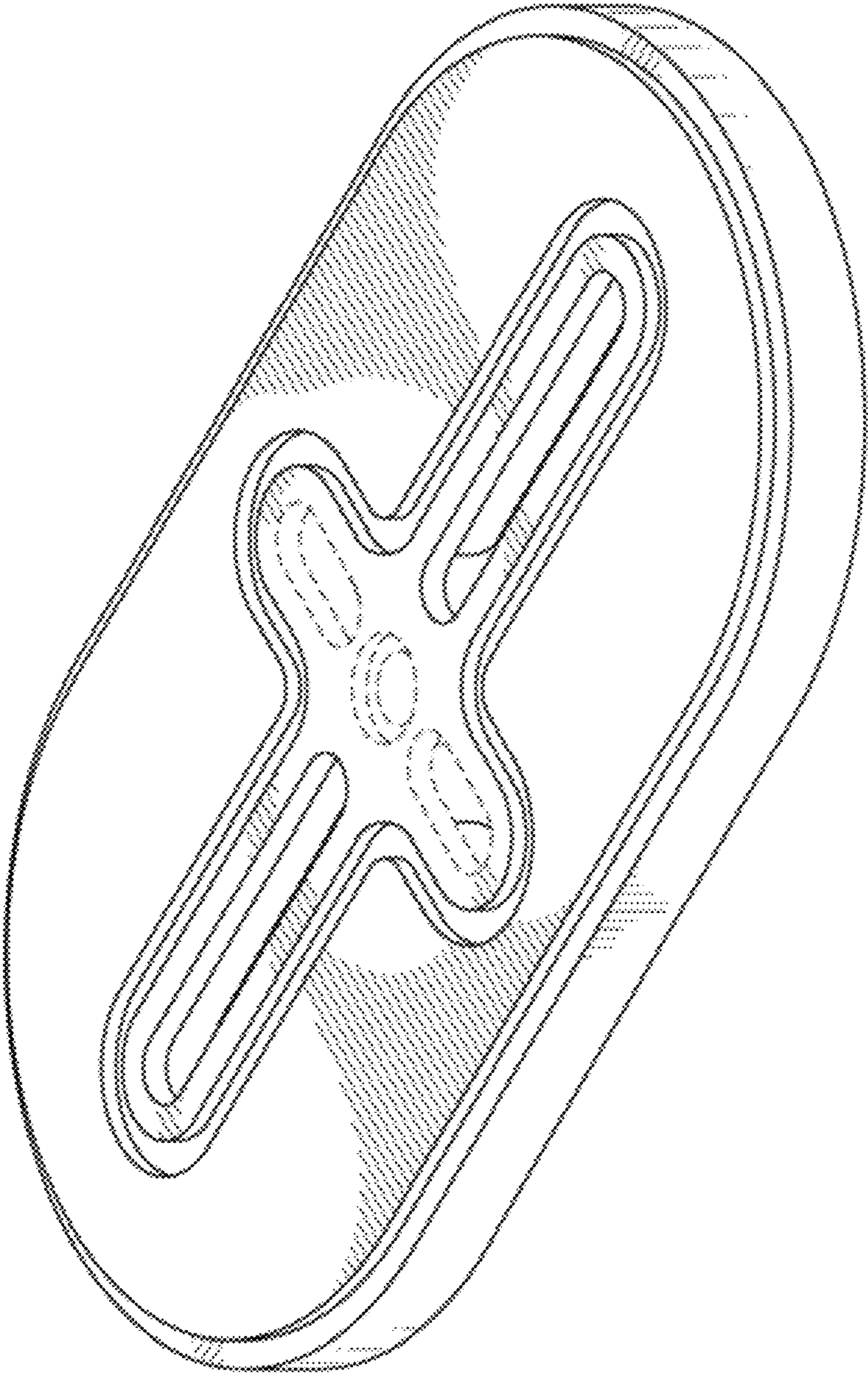

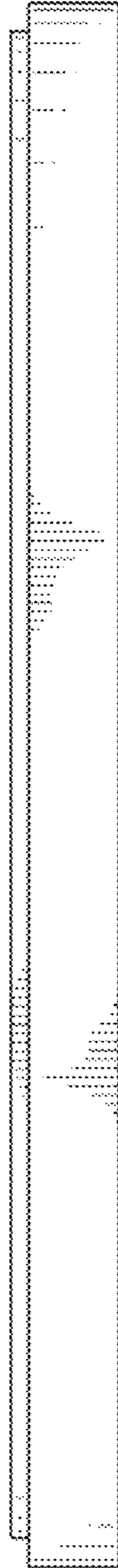

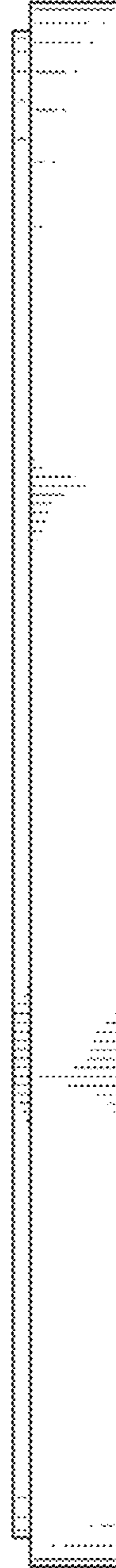

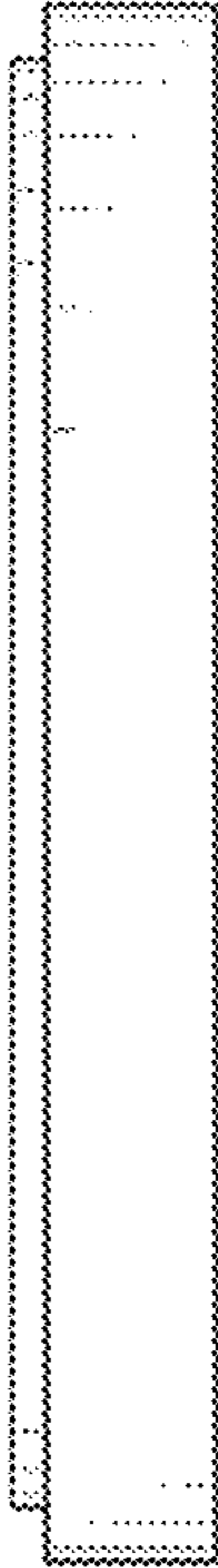

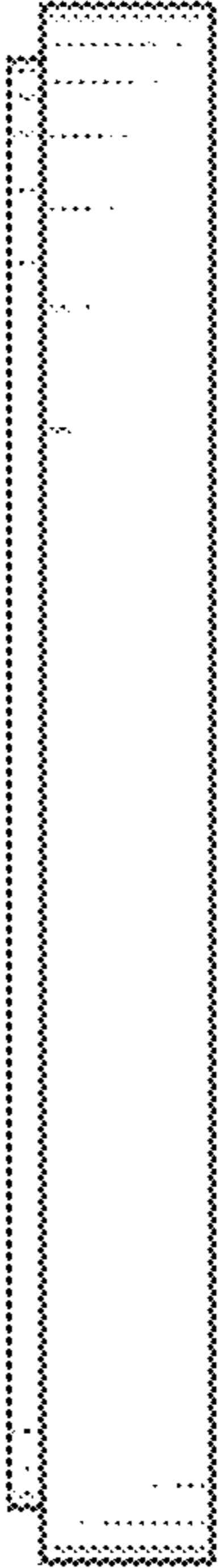

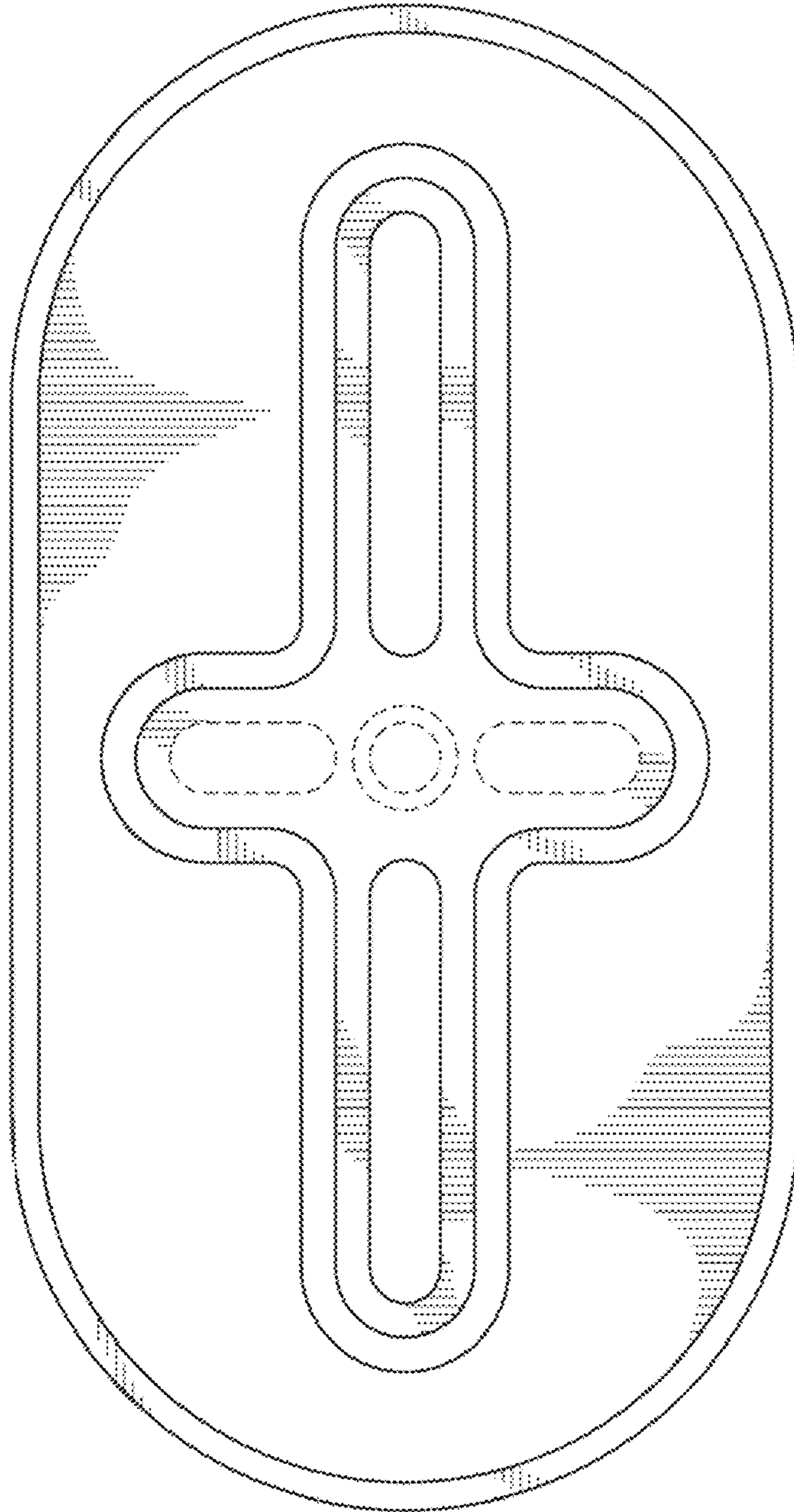

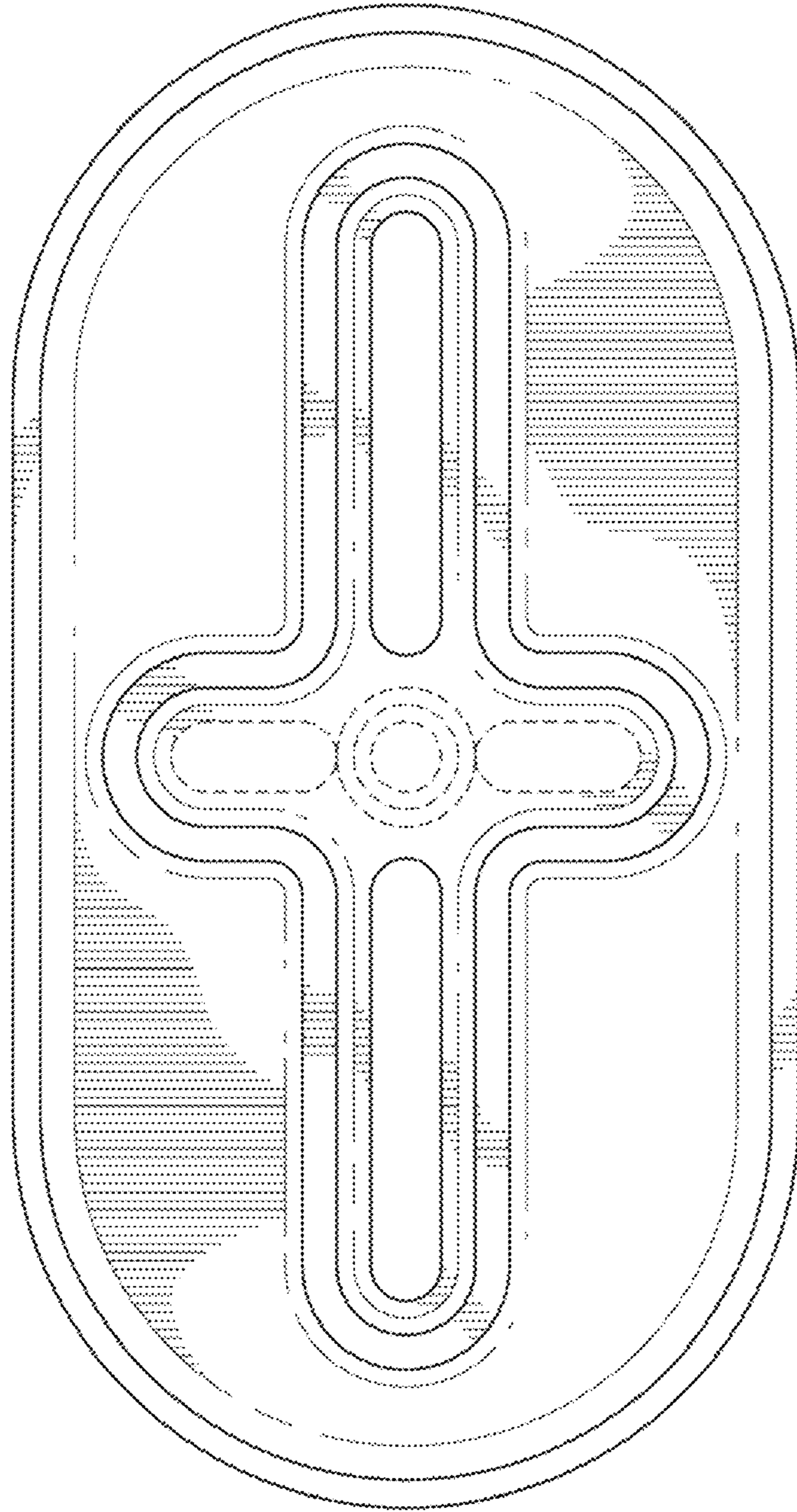

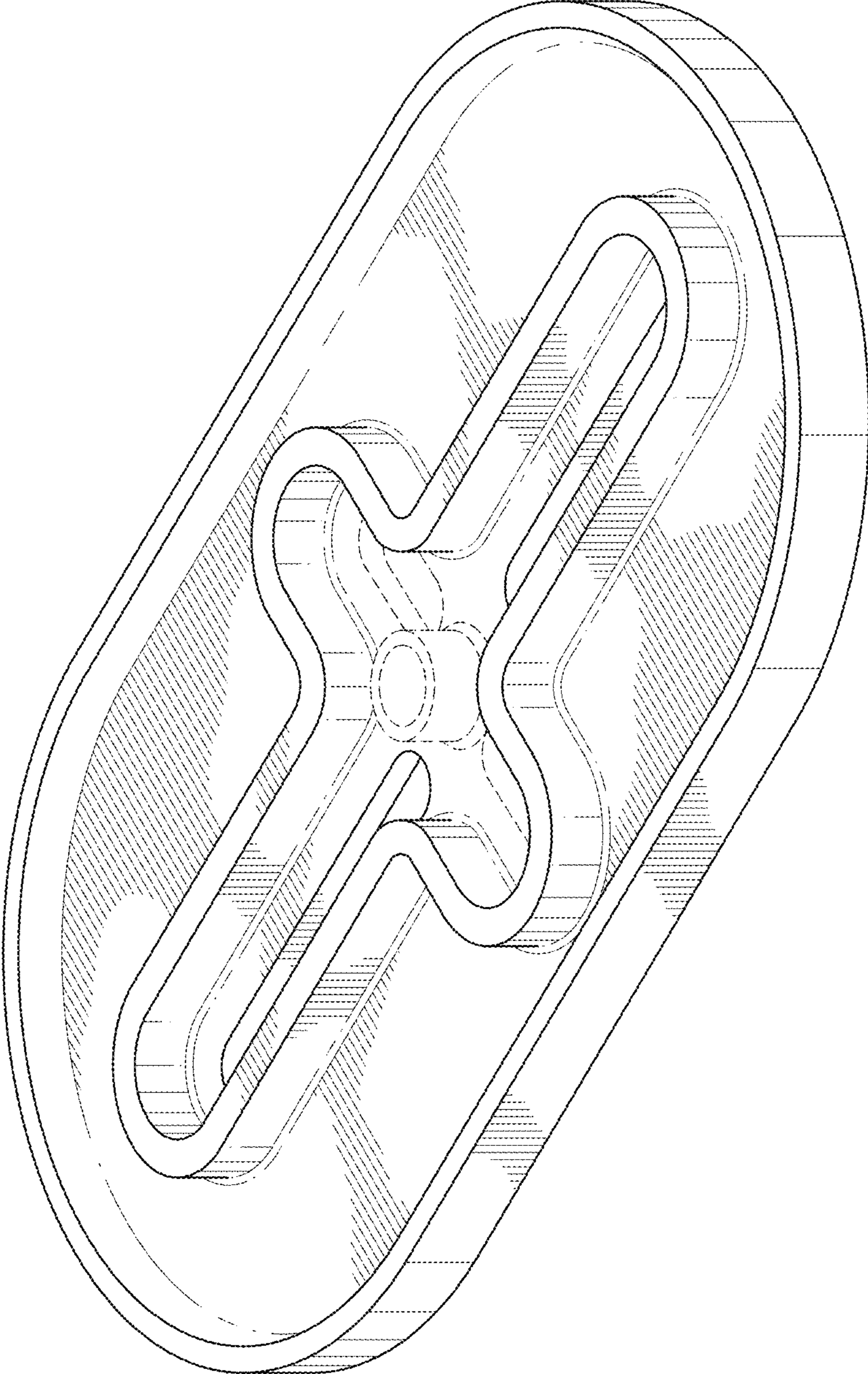
