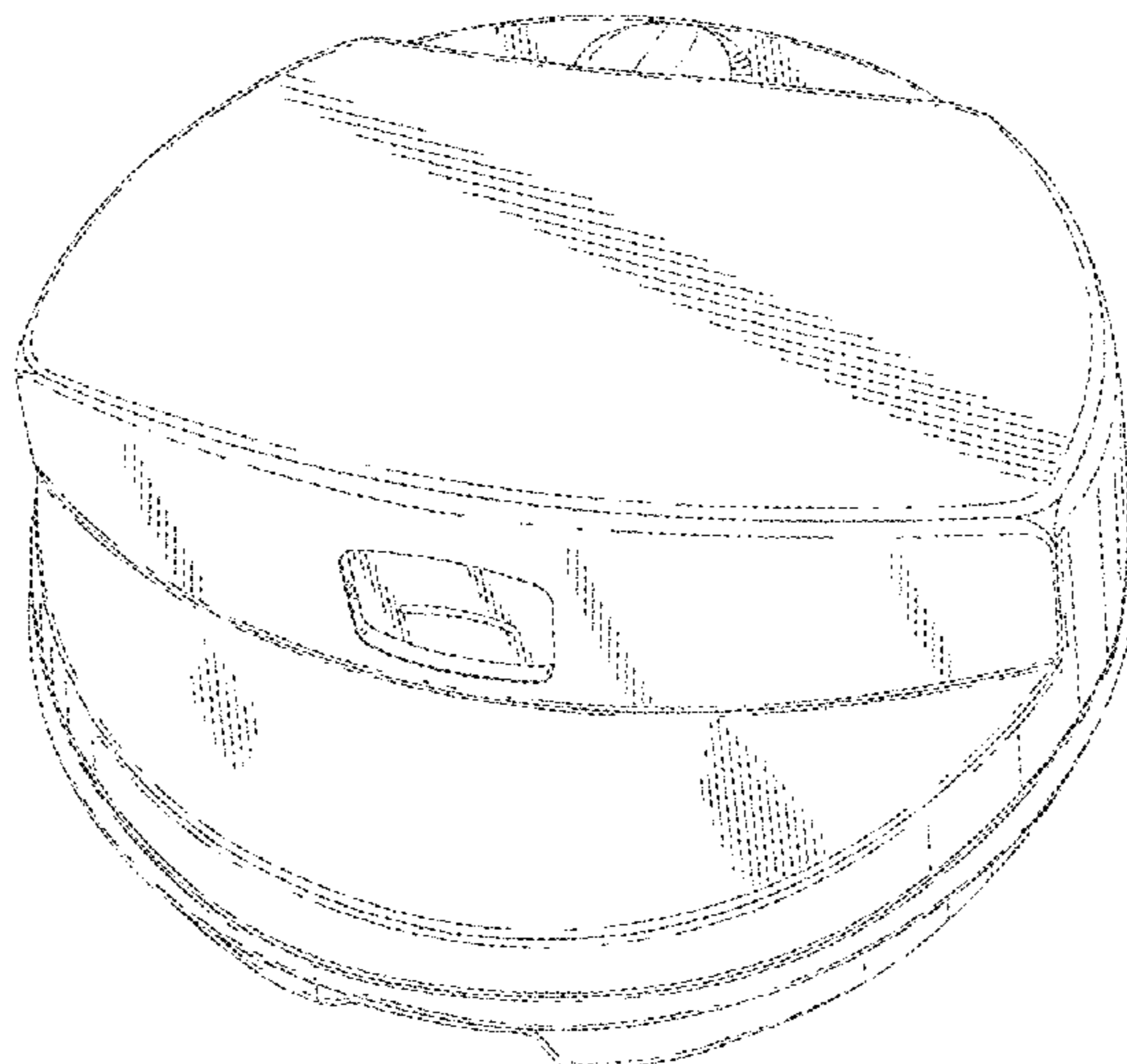
(57) **CLAIM**

The ornamental design for an electronic nail clipper, as shown and described.

DESCRIPTION

FIG. 1 is front perspective elevational view of an electronic nail clipper showing my new design, shown in environment use; FIG. 2 is a back, head-on elevational view thereof; and, FIG. 3 is a top plan view thereof. 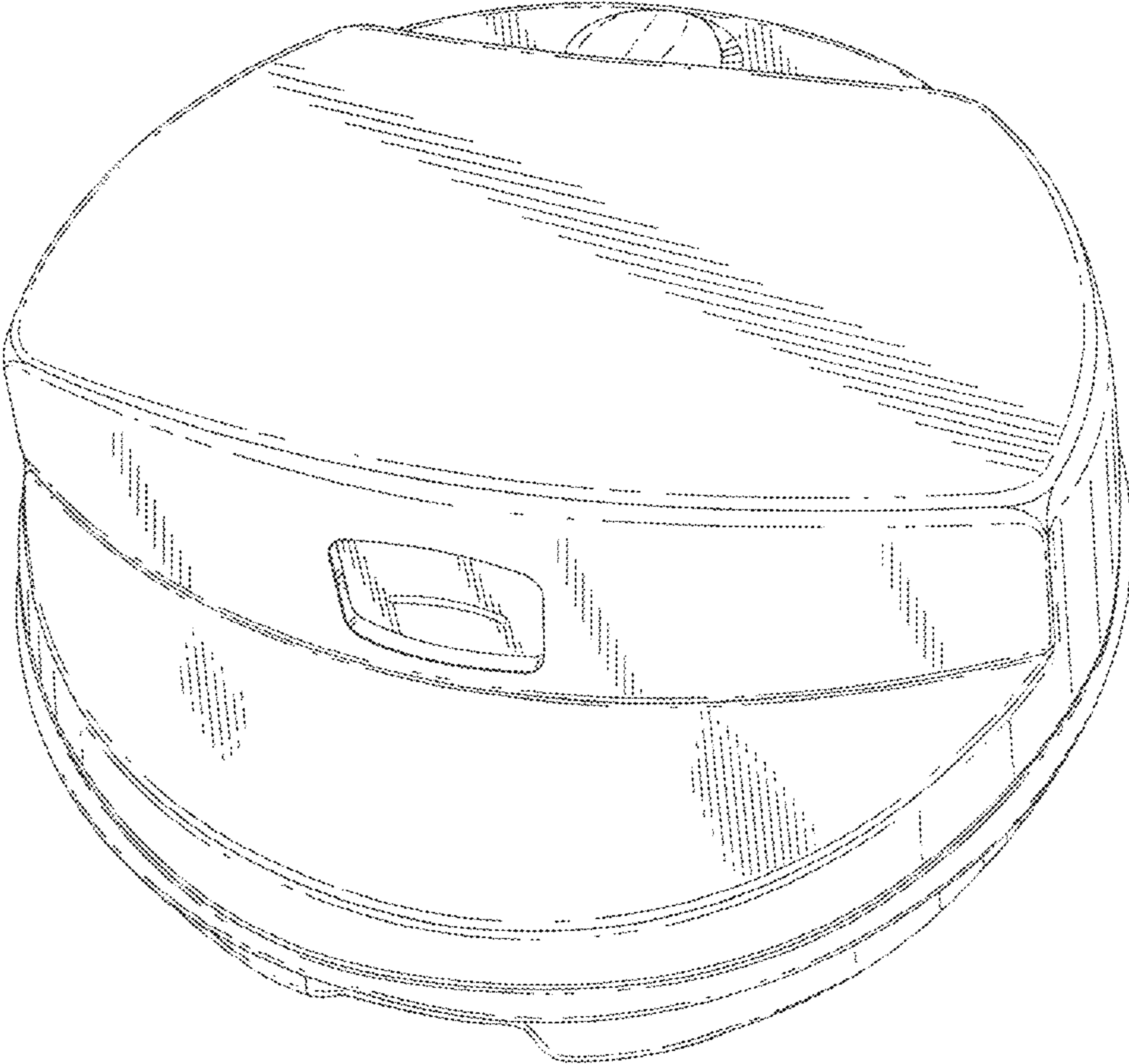

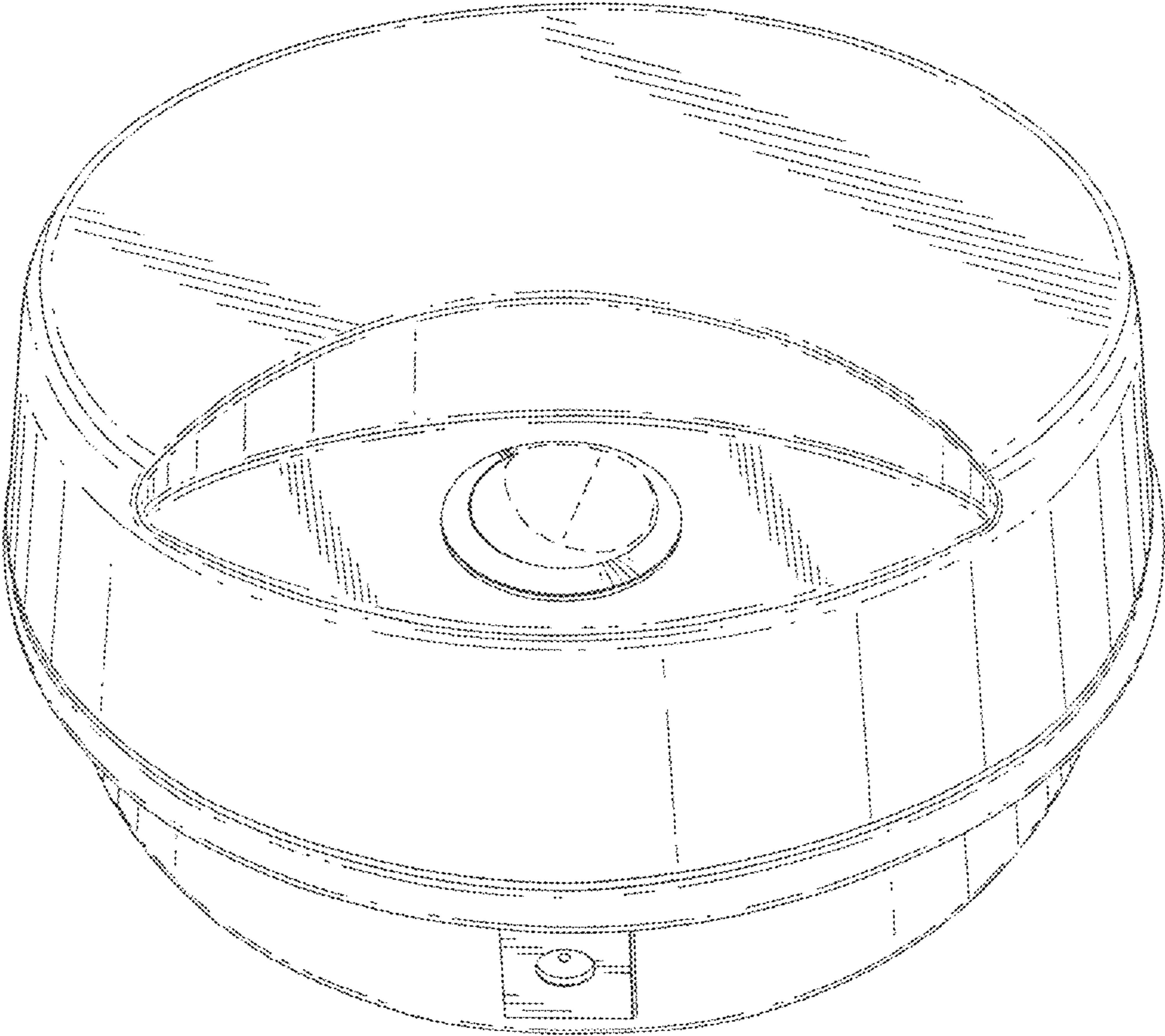

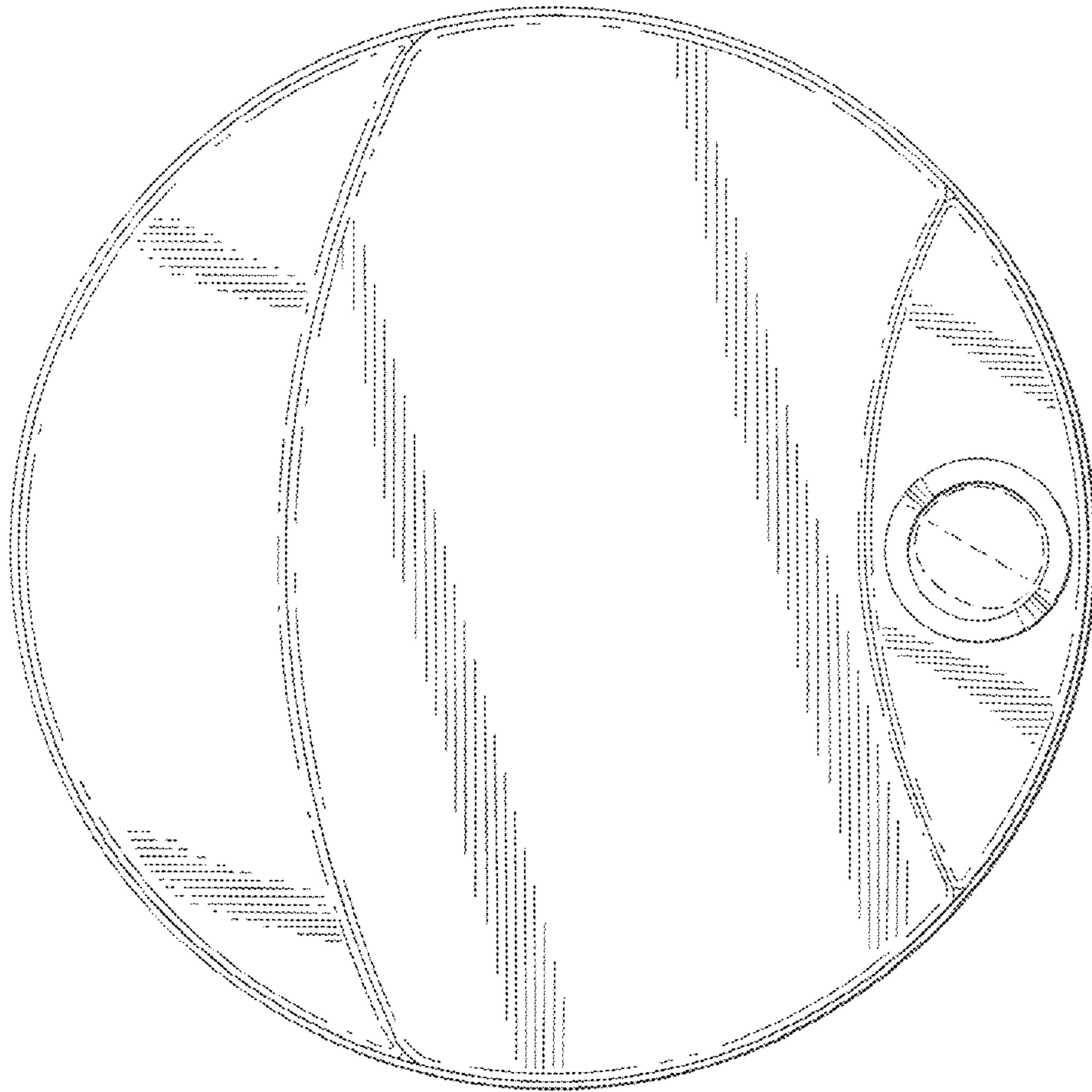
