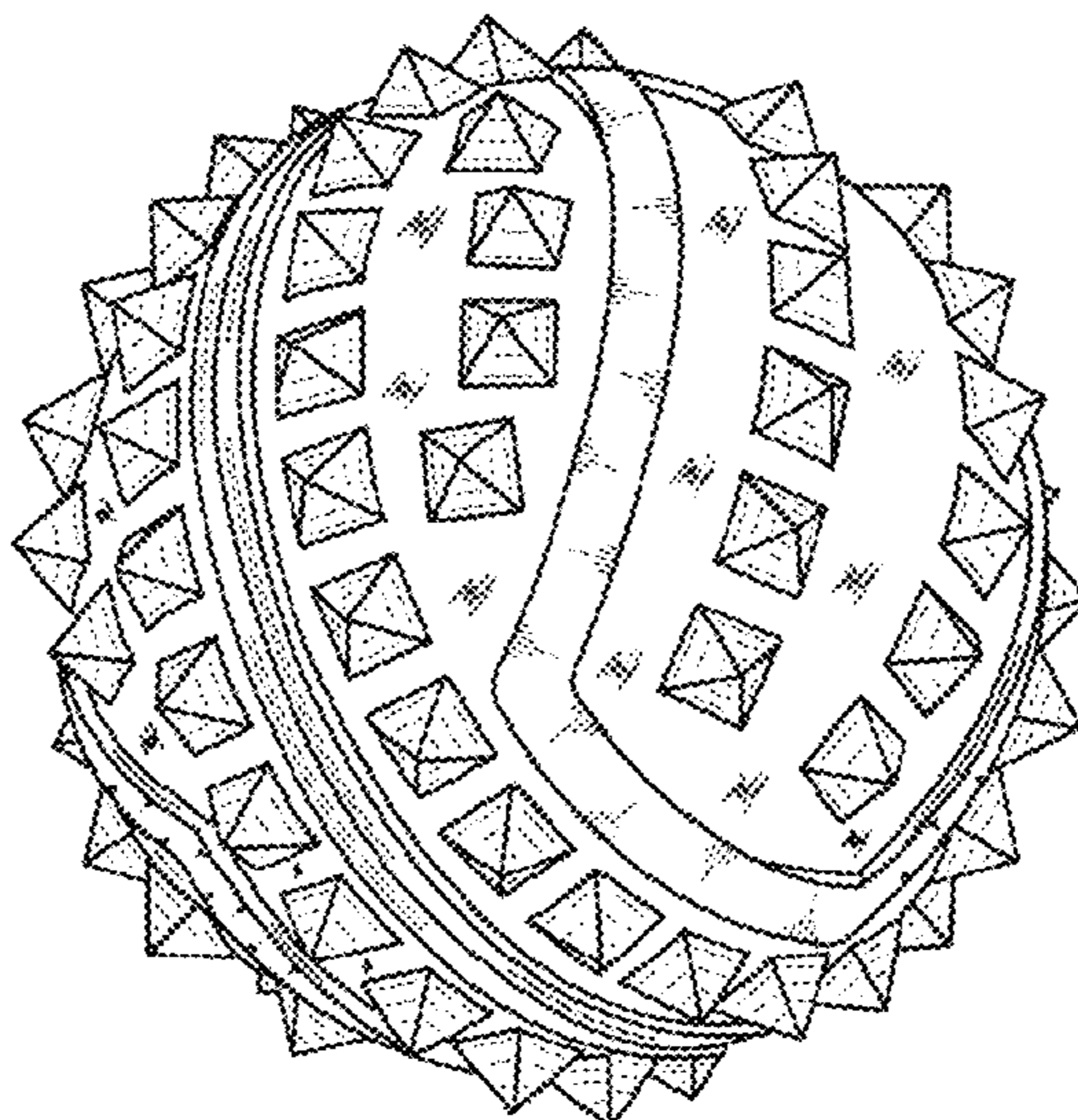
(57) **CLAIM**

The ornamental design for a spike ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a spike ball; FIG. 2 is a top view of the spike ball of FIG. 1; FIG. 3 is a bottom view of the spike ball of FIG. 1; FIG. 4 is a front view of the spike ball of FIG. 1 turned 90°; FIG. 5 is rear view of the spike ball of FIG. 1; FIG. 6 is a right side view of the spike ball of FIG. 1; FIG. 7 is a left side view of the spike ball of FIG. 8; FIG. 8 is a top perspective view of a spike ball in accordance with an alternate embodiment of the present invention; FIG. 9 is a top view of the spike ball of FIG. 8; FIG. 10 is a bottom view of the spike ball of FIG. 8; FIG. 11 is a front view of the spike ball of FIG. 8 turned 90°; FIG. 12 is a rear view of the spike ball of FIG. 8; FIG. 13 is a right side view of the spike ball of FIG. 8; and, FIG. 14 is a left side view of the spike ball of FIG. 8.

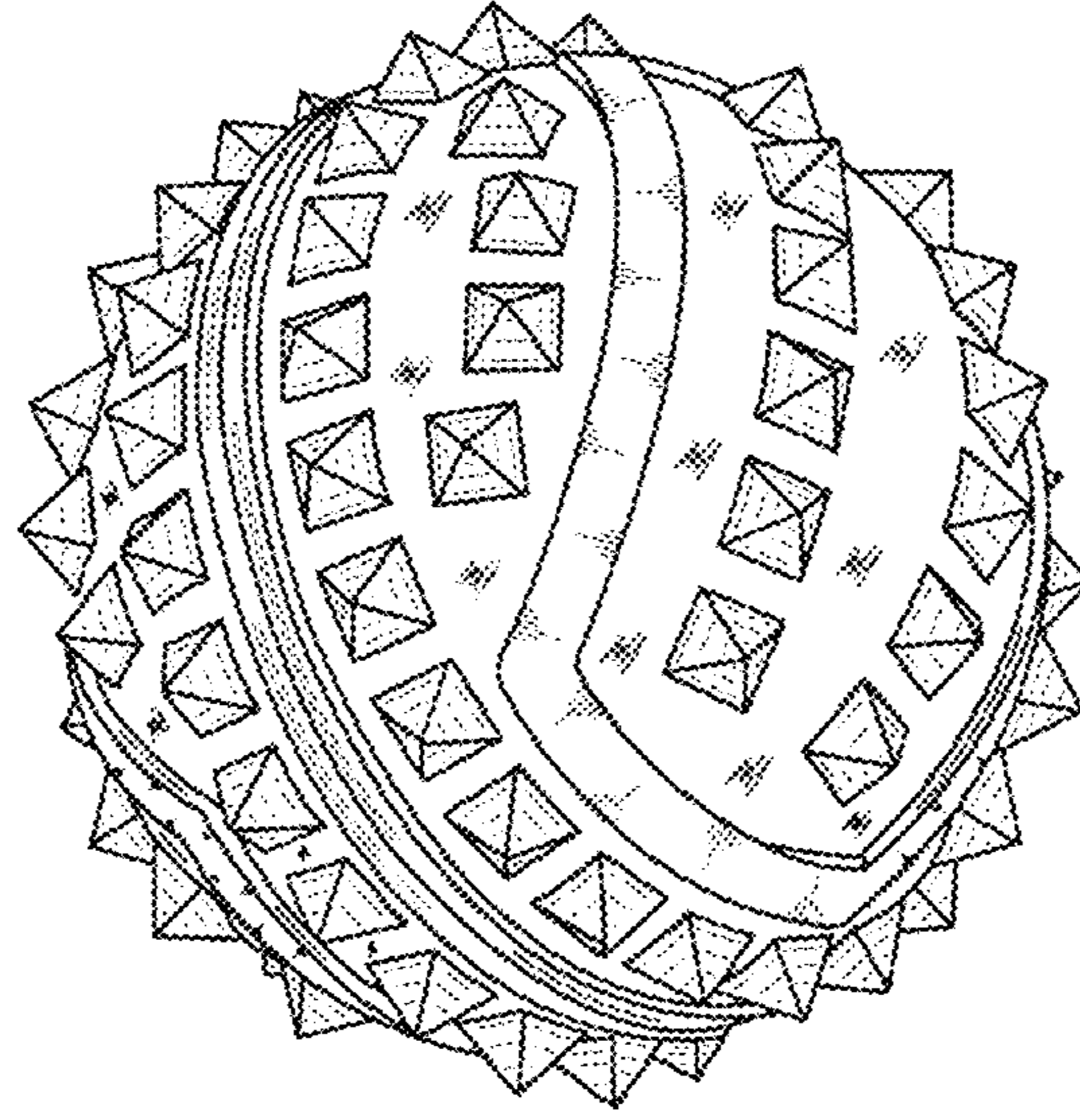

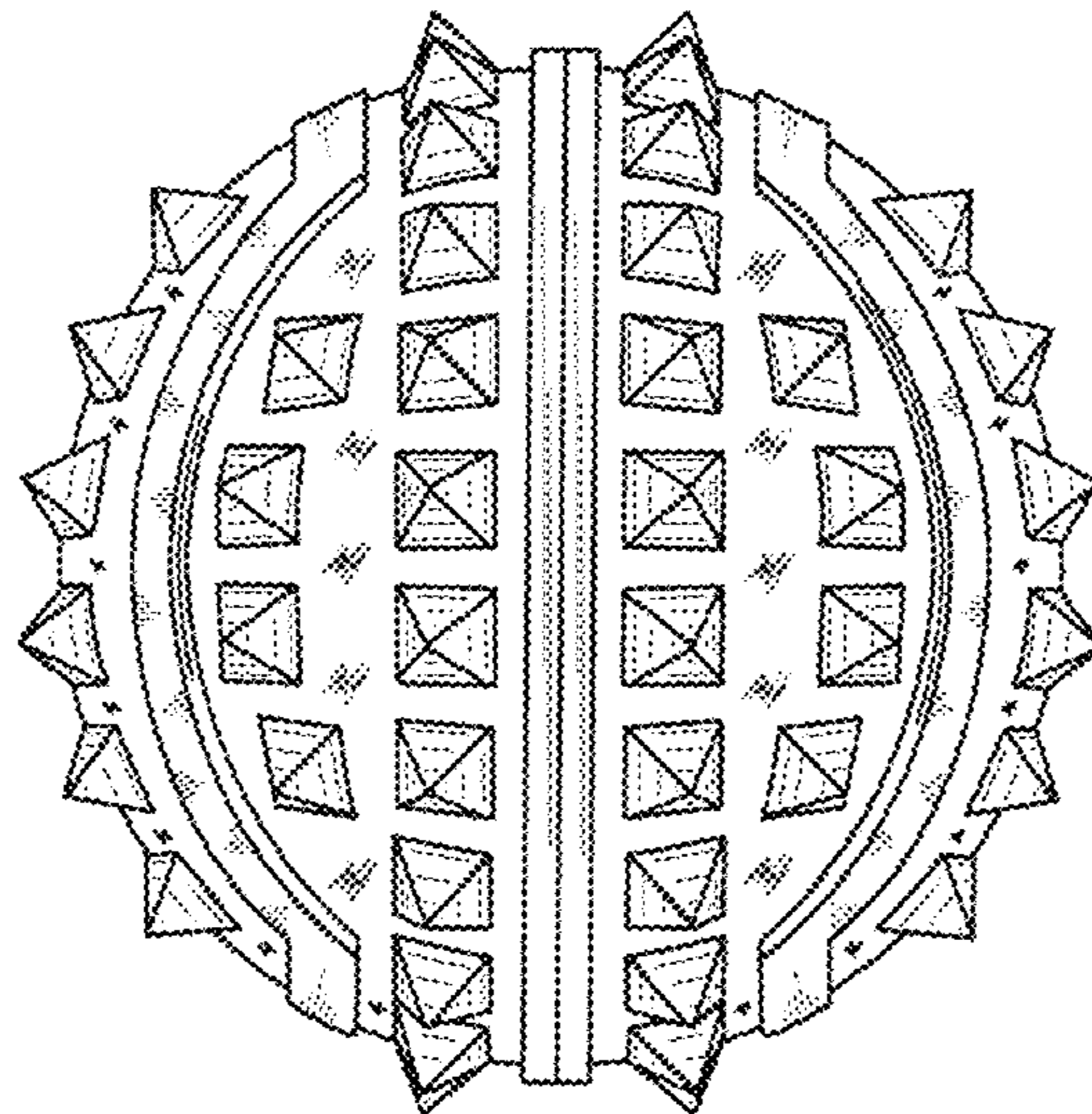

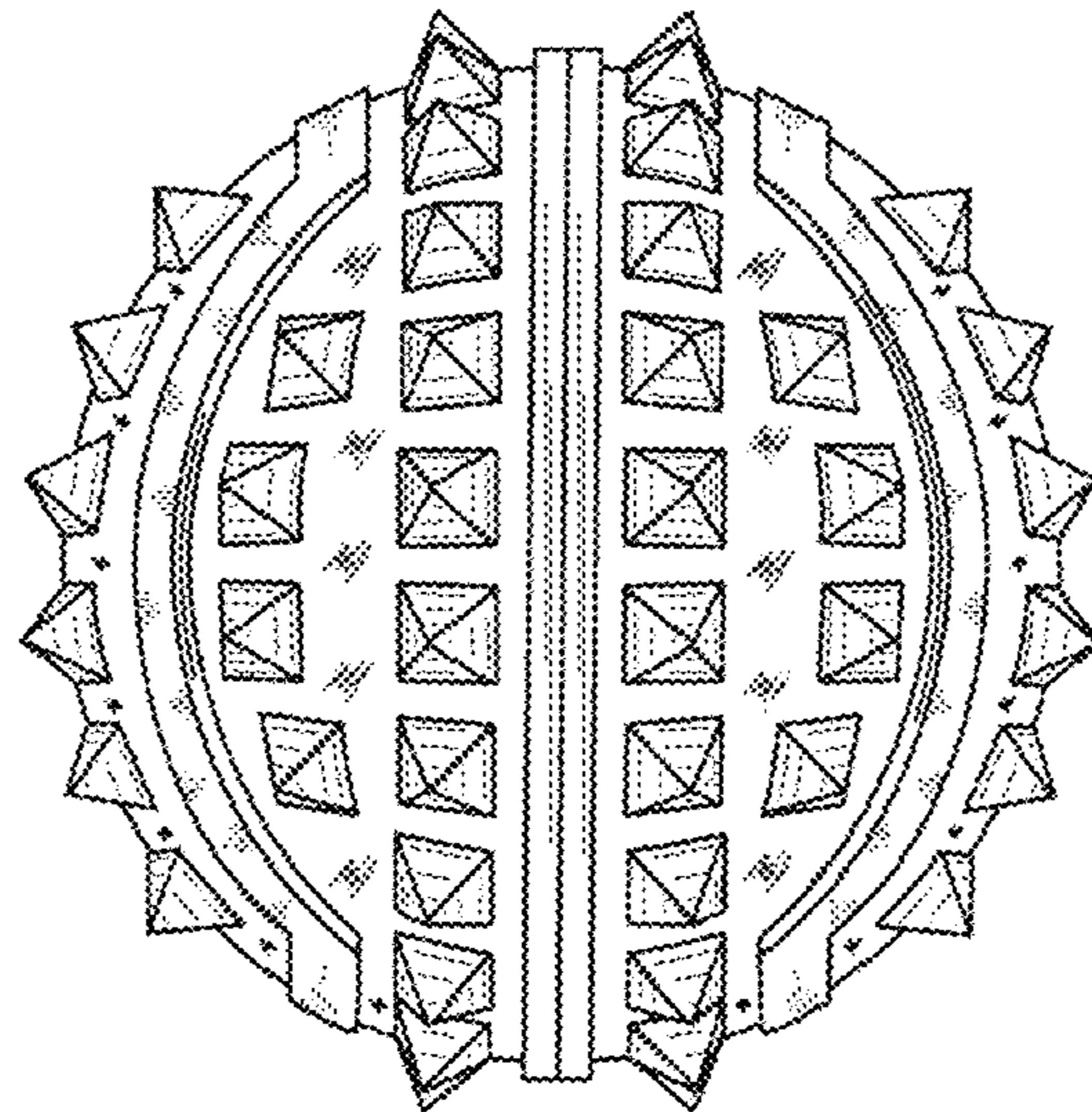

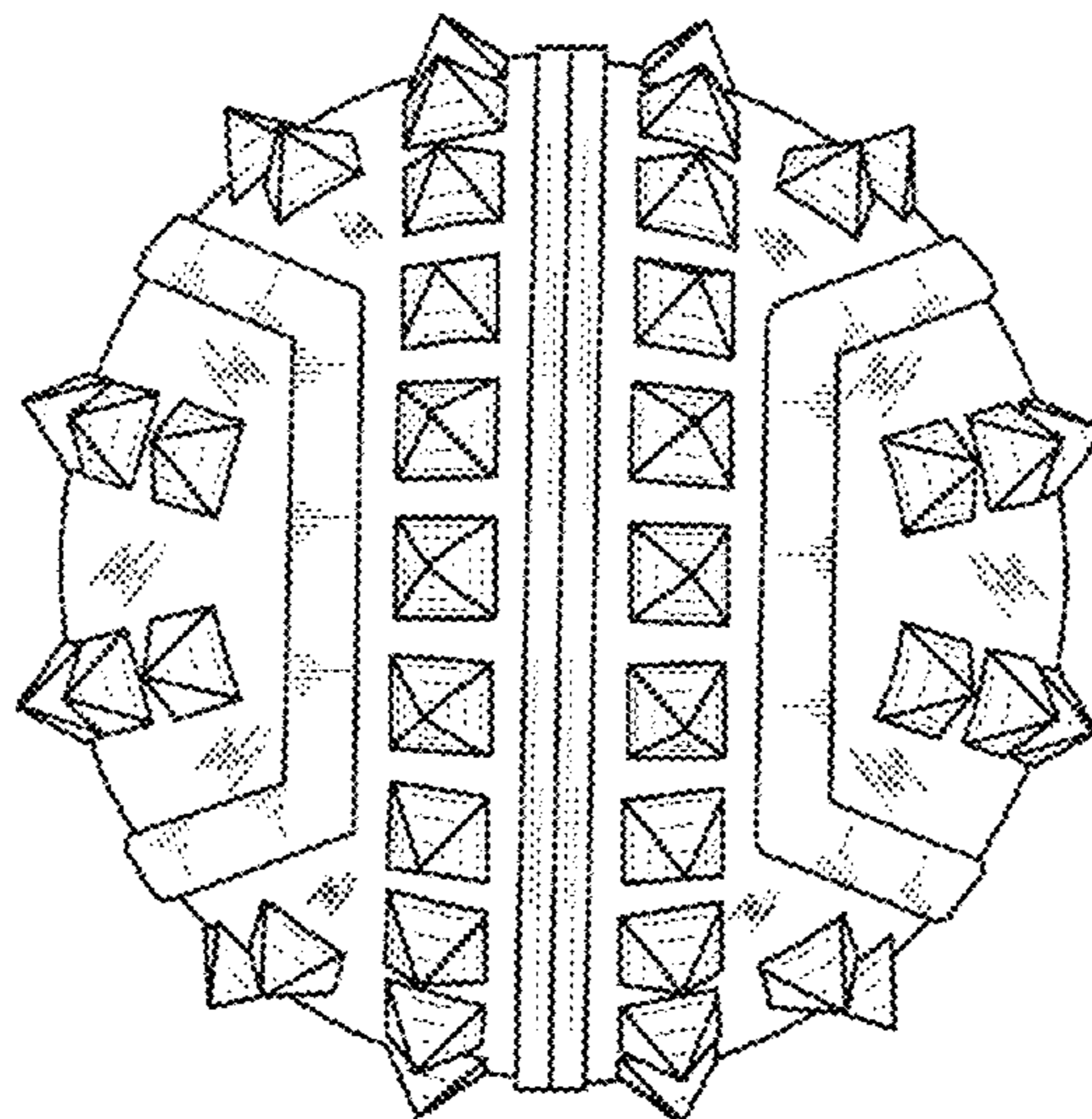

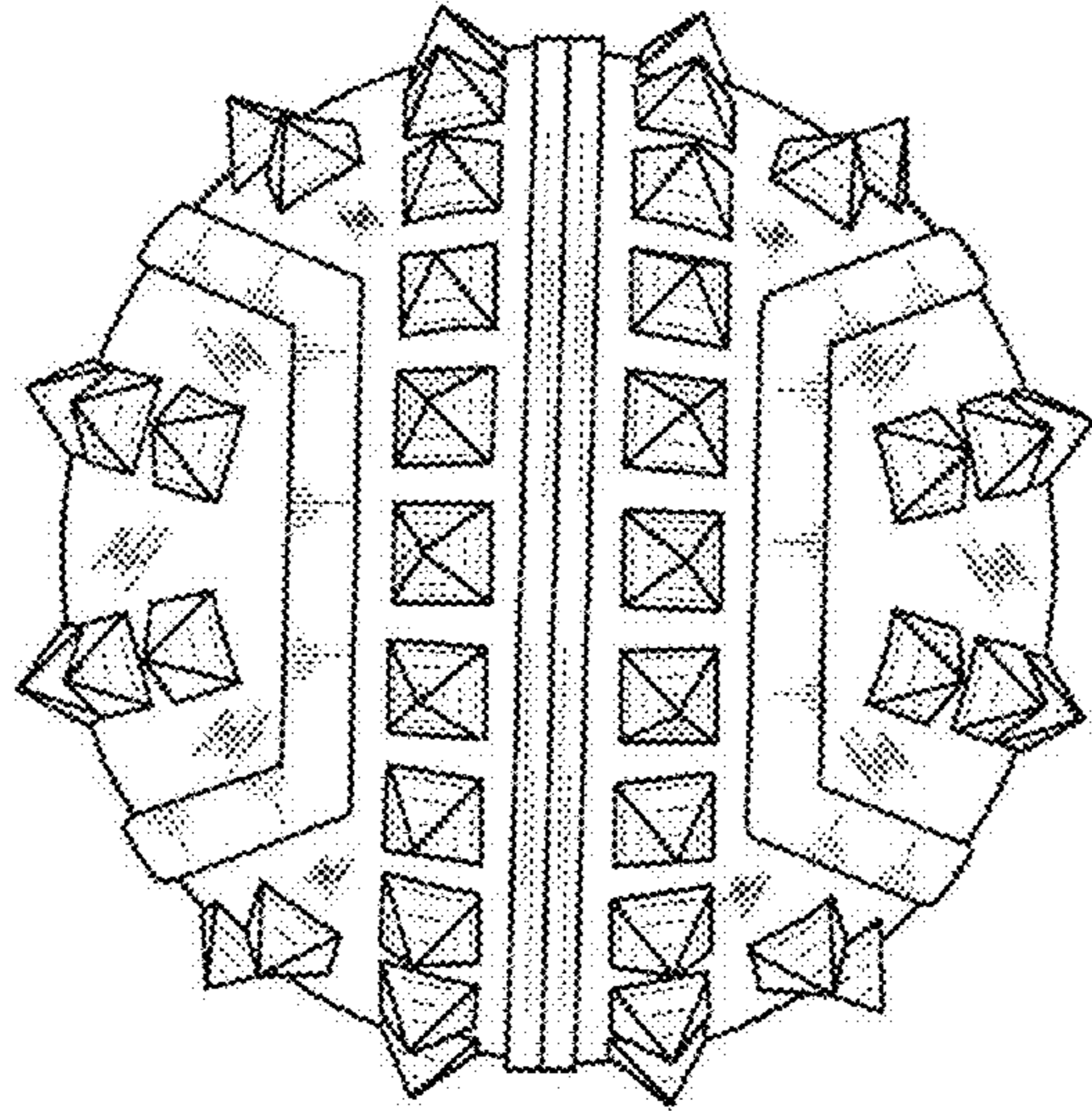

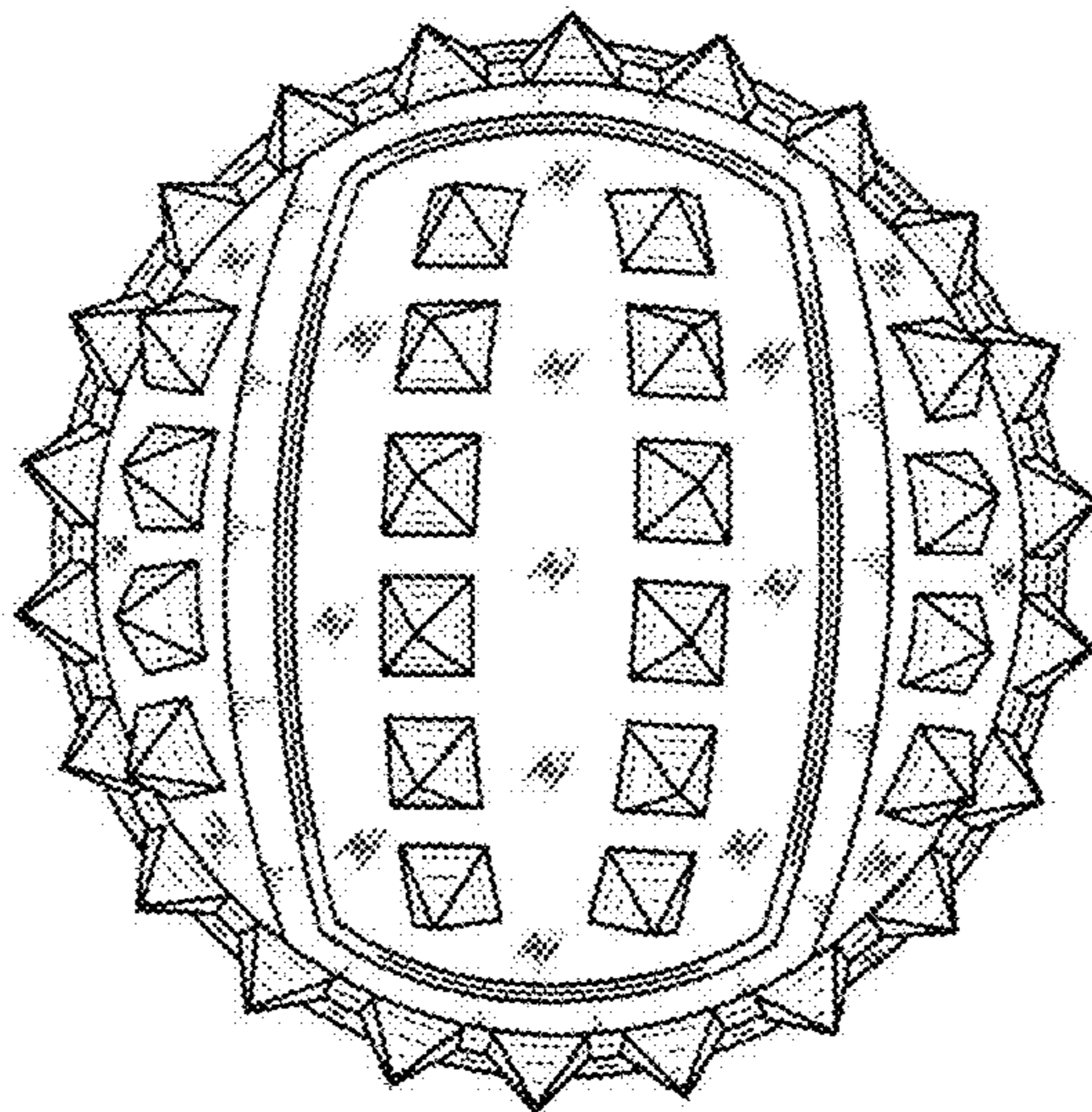

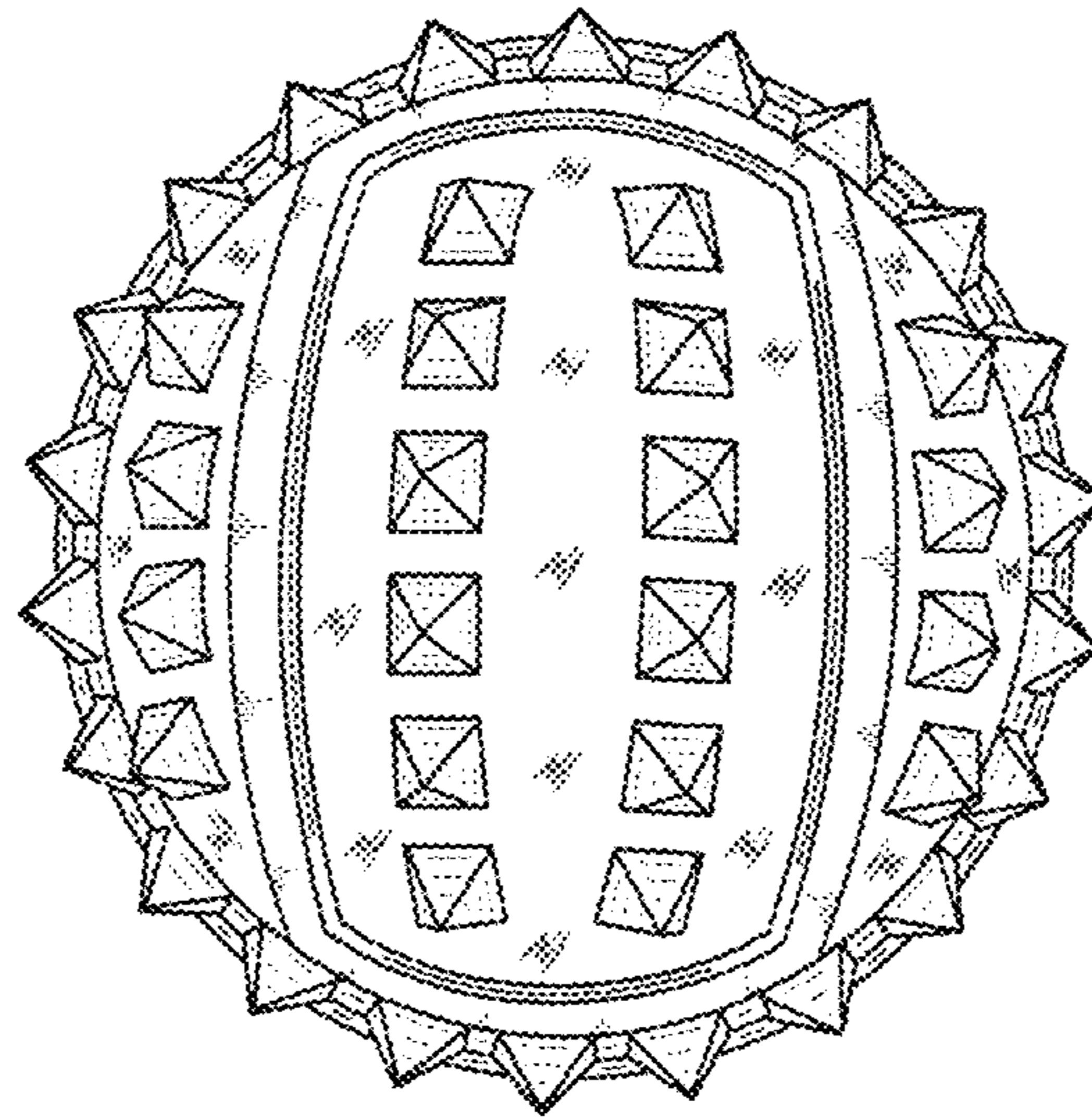

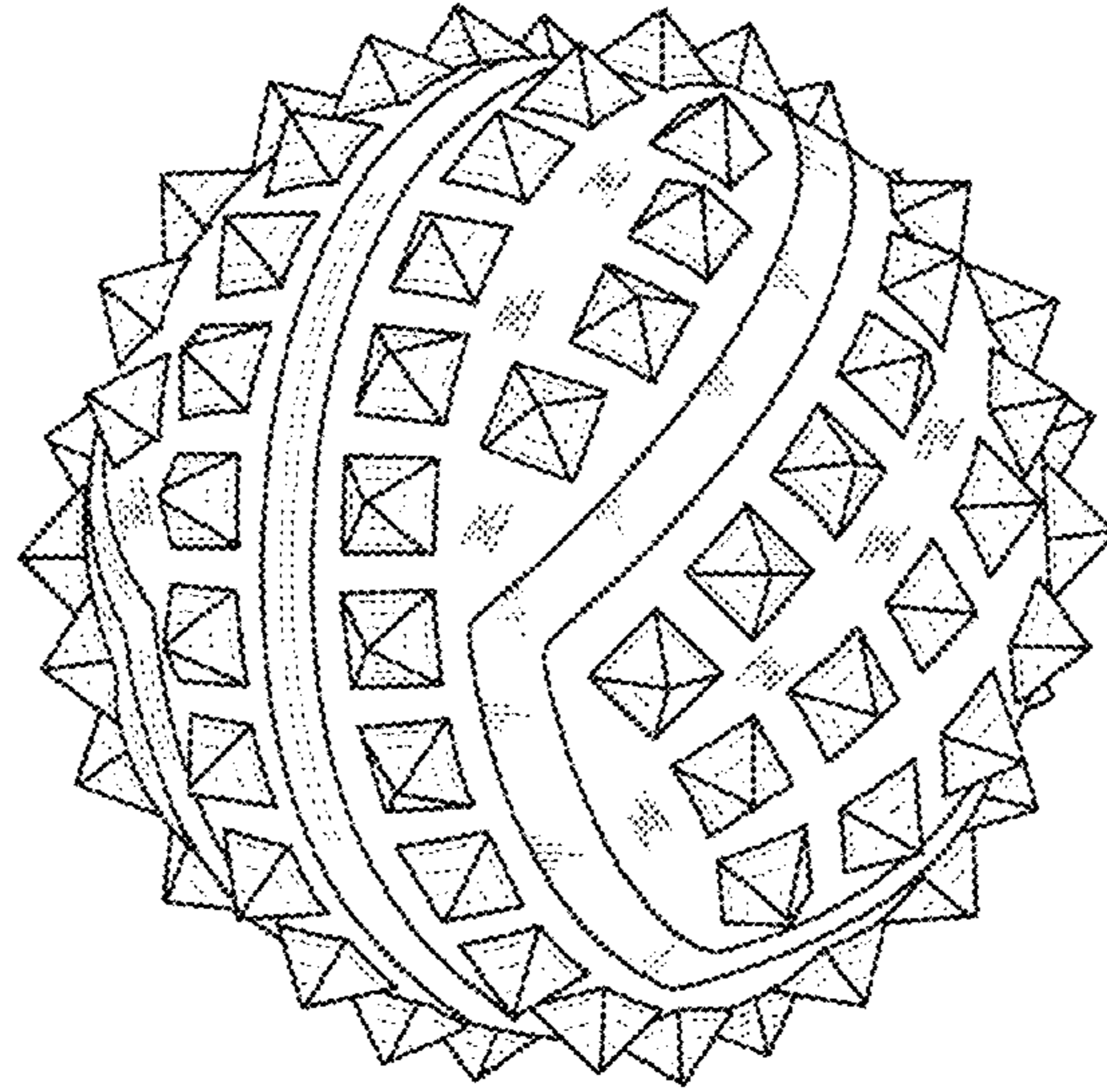

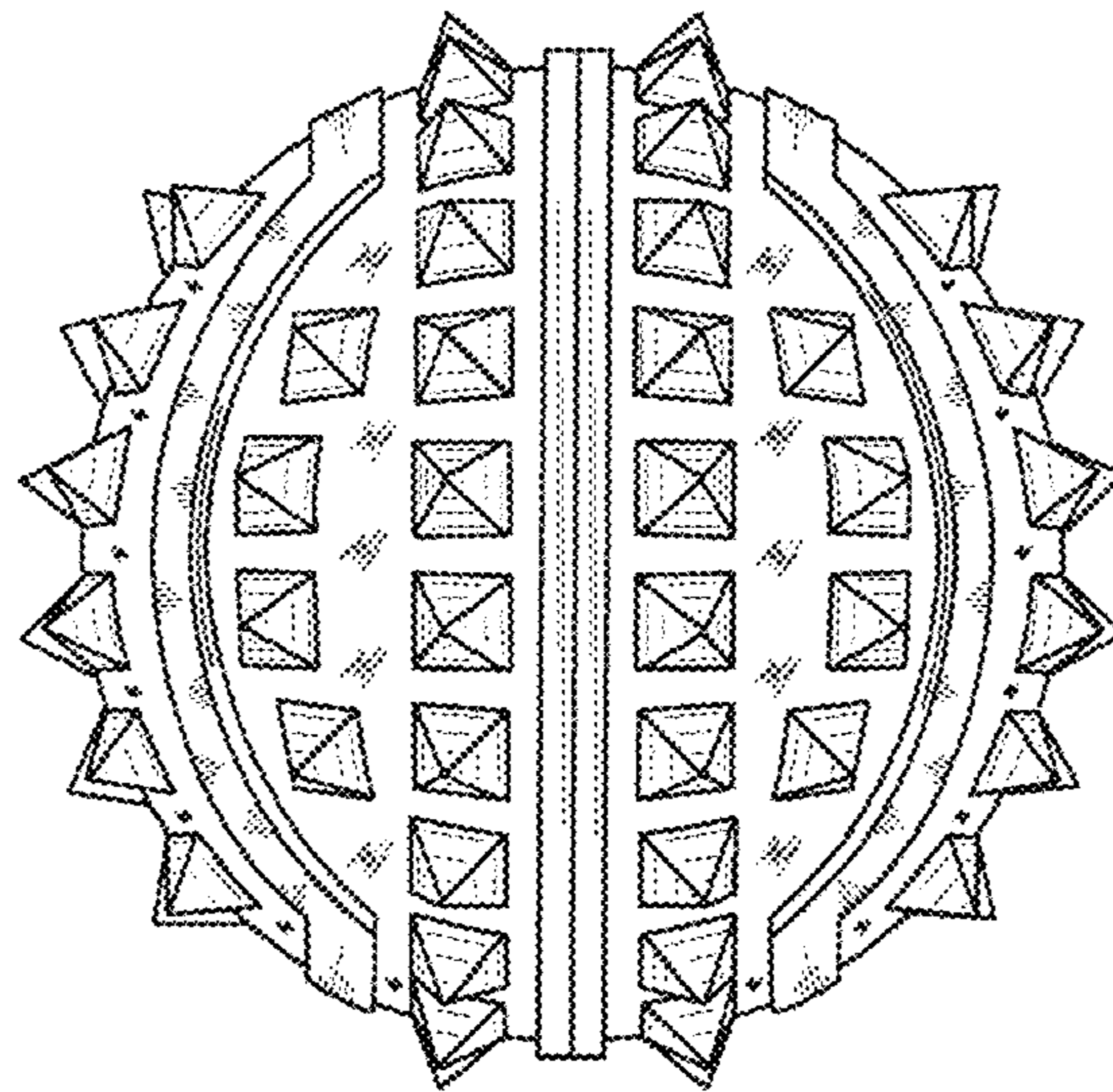

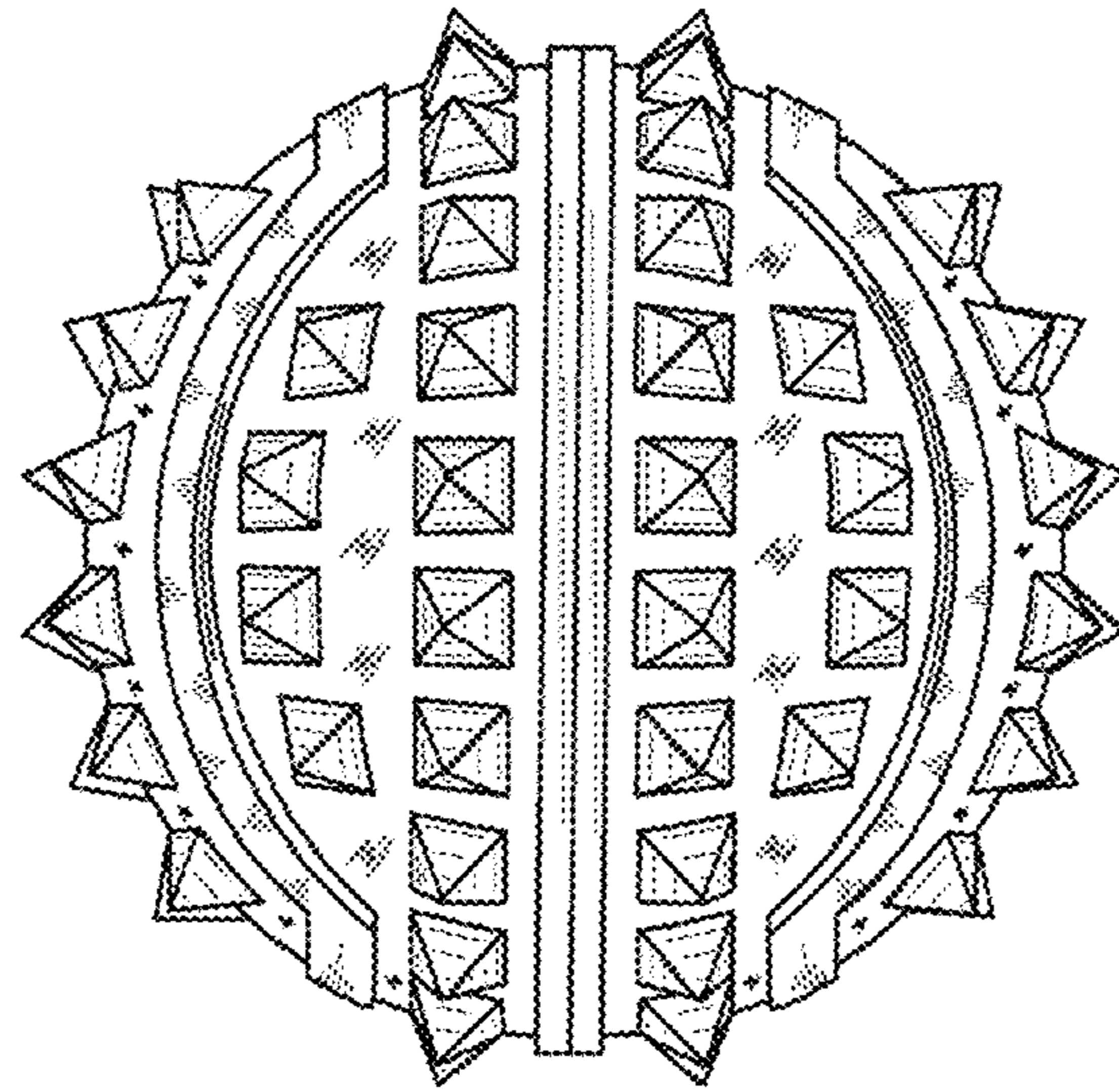

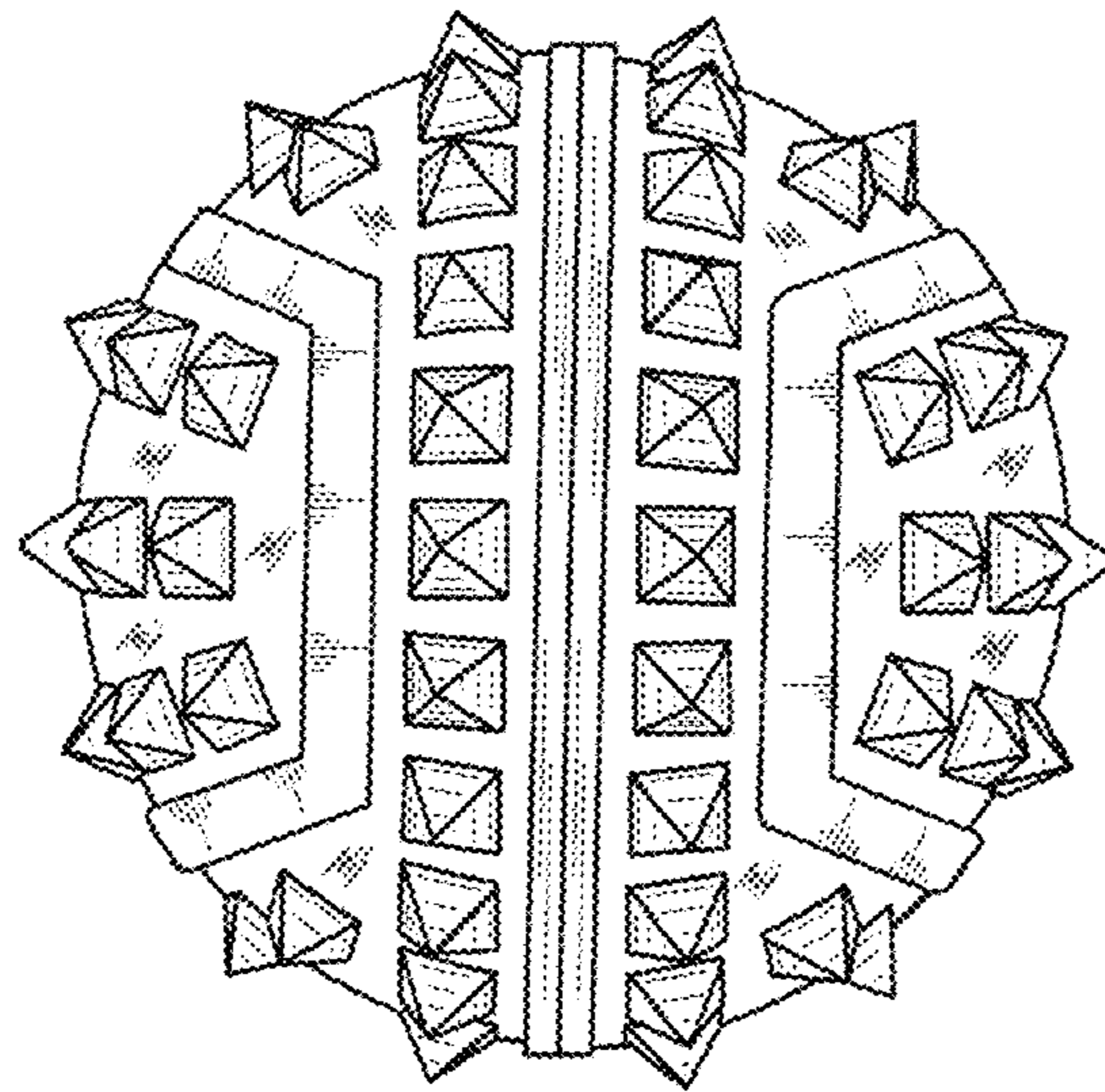

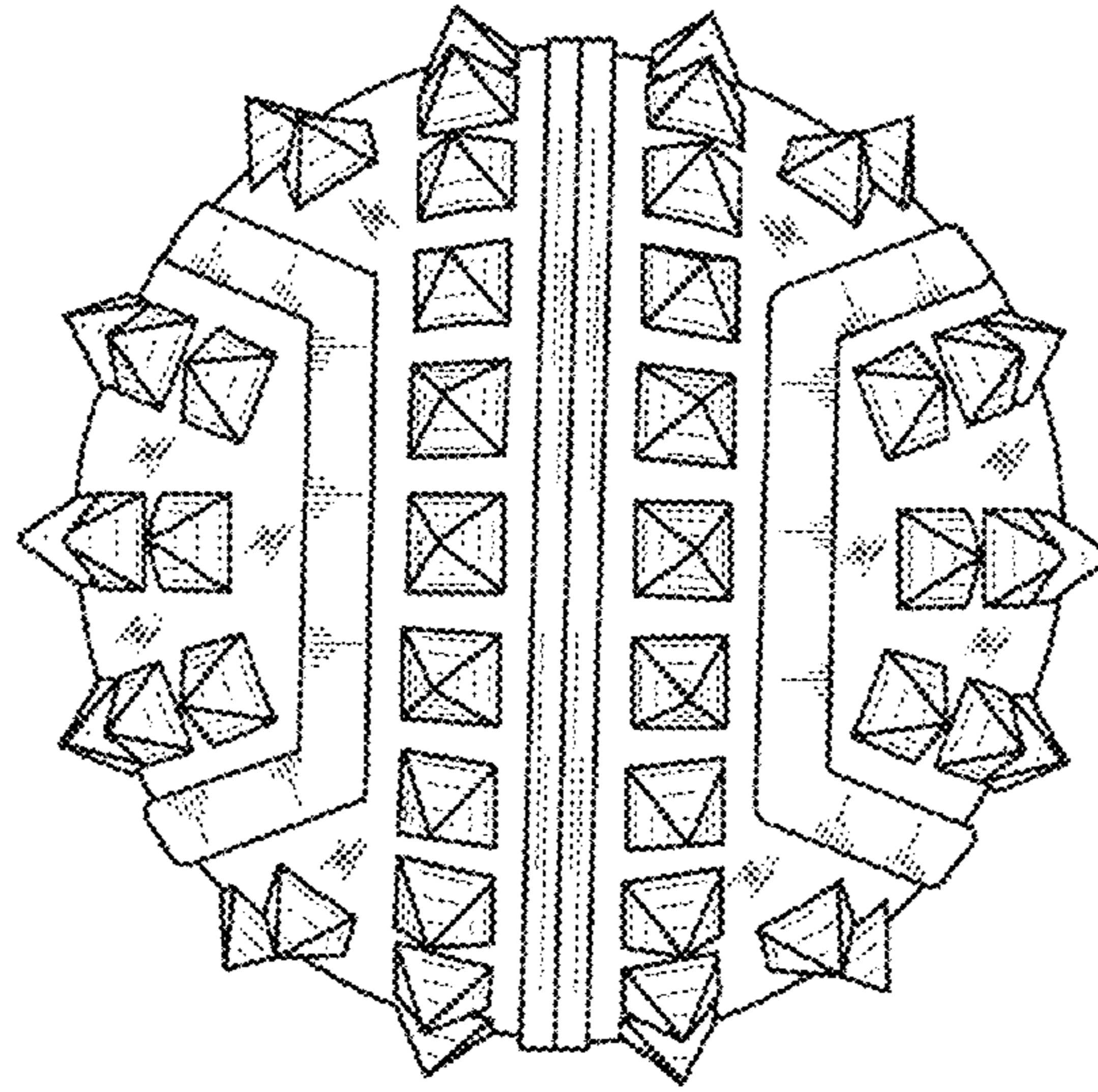

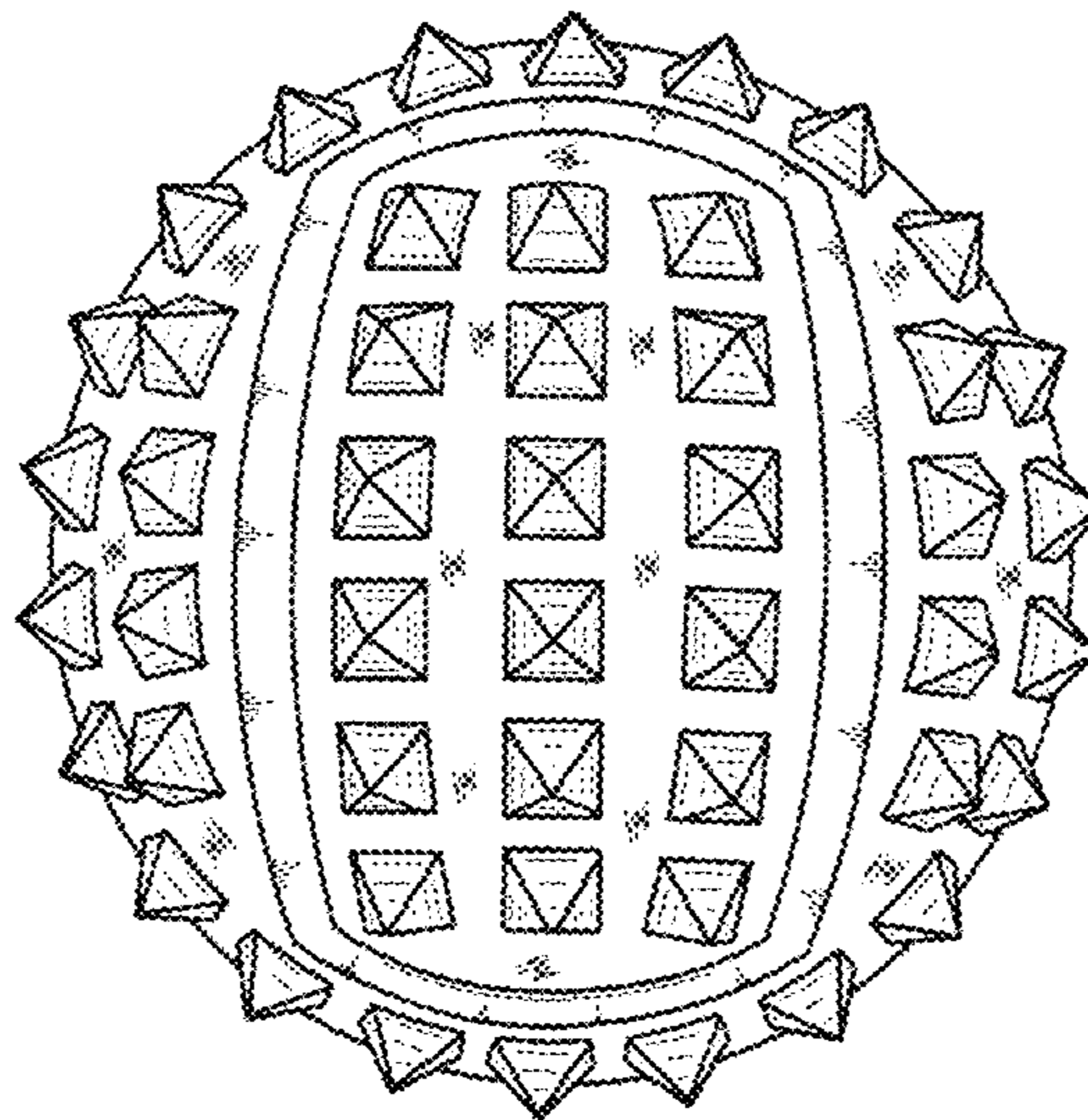

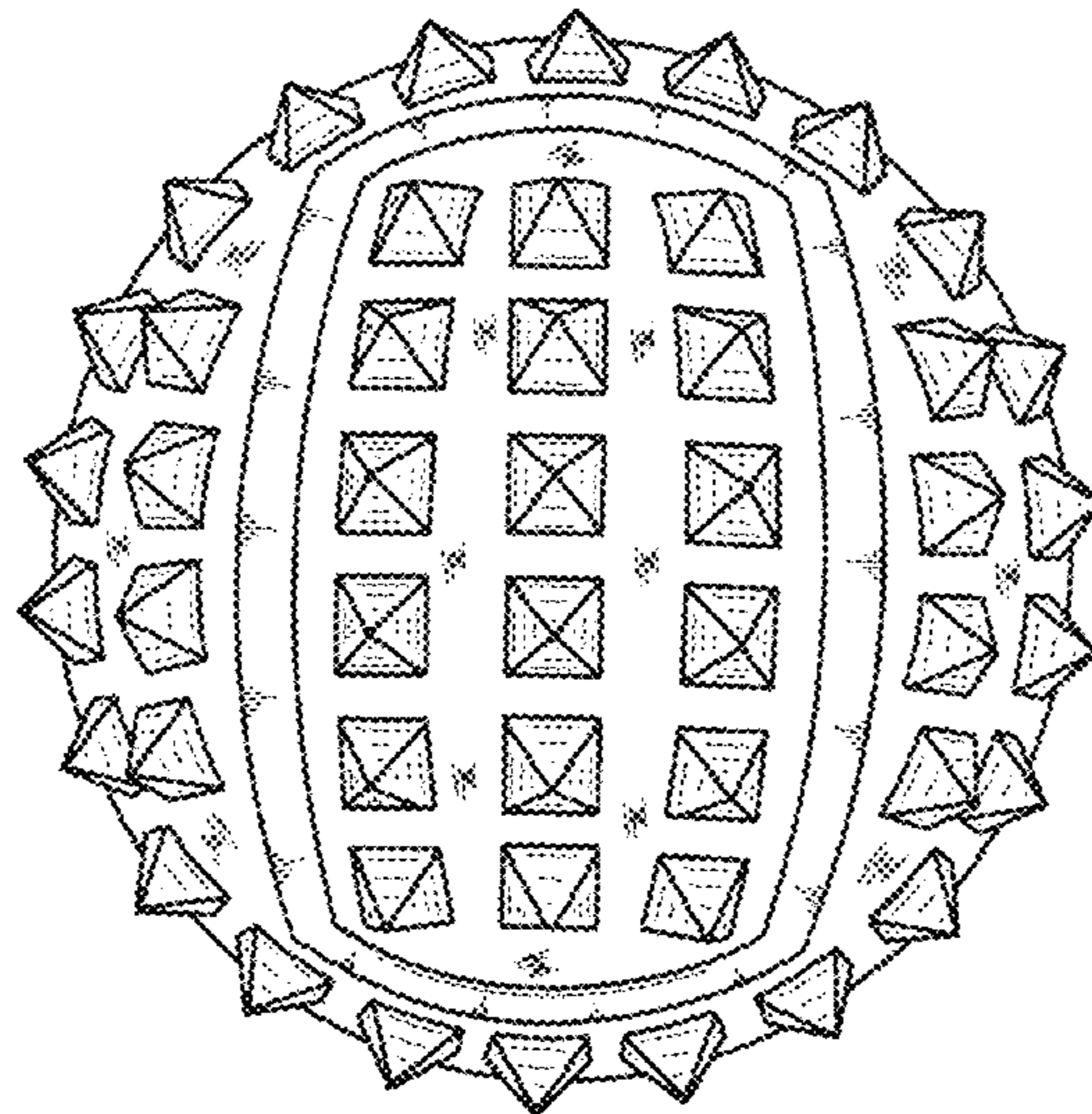
