(57) **CLAIM**

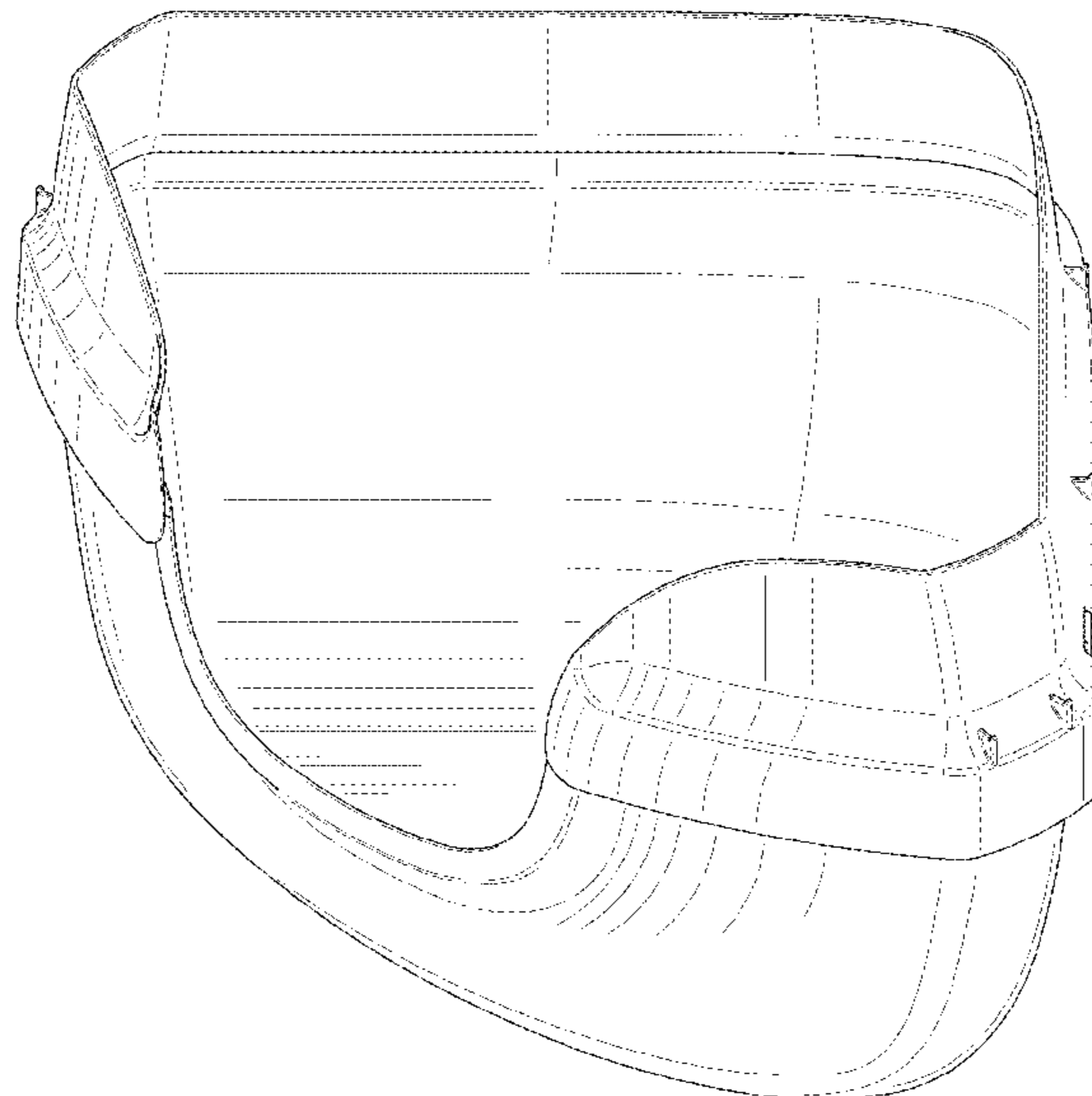
The ornamental design for a litter pan, as shown and described.

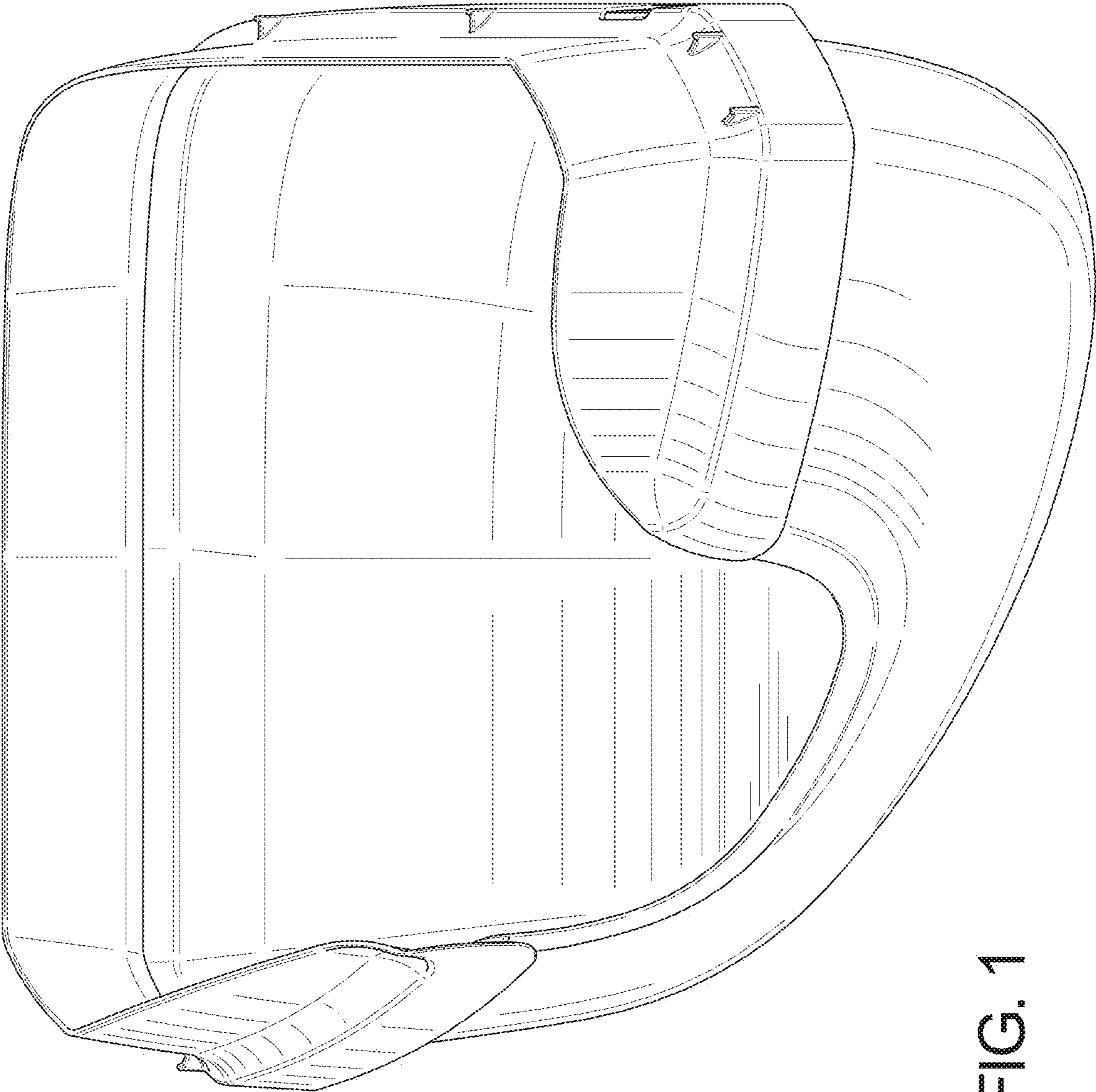

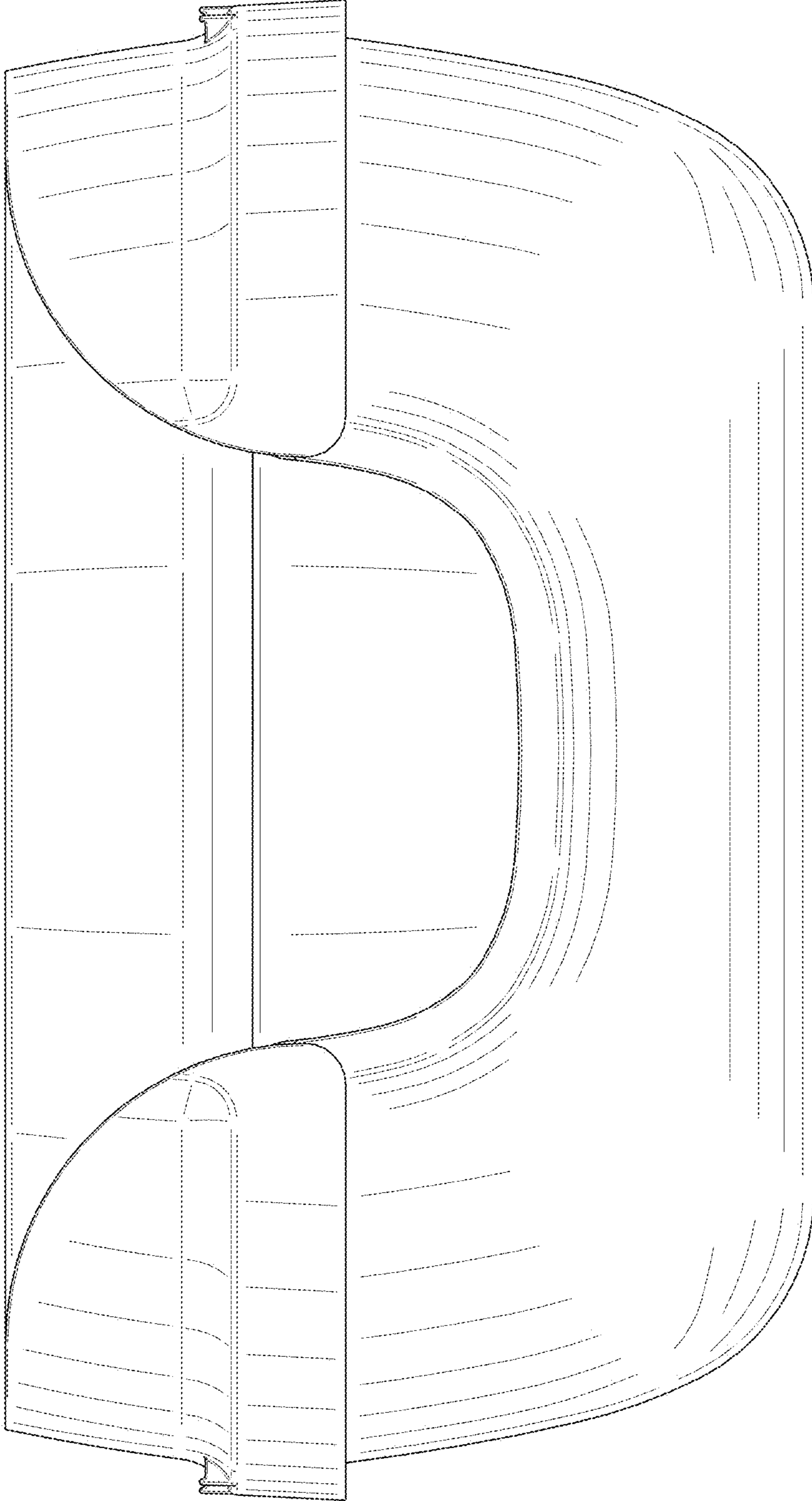

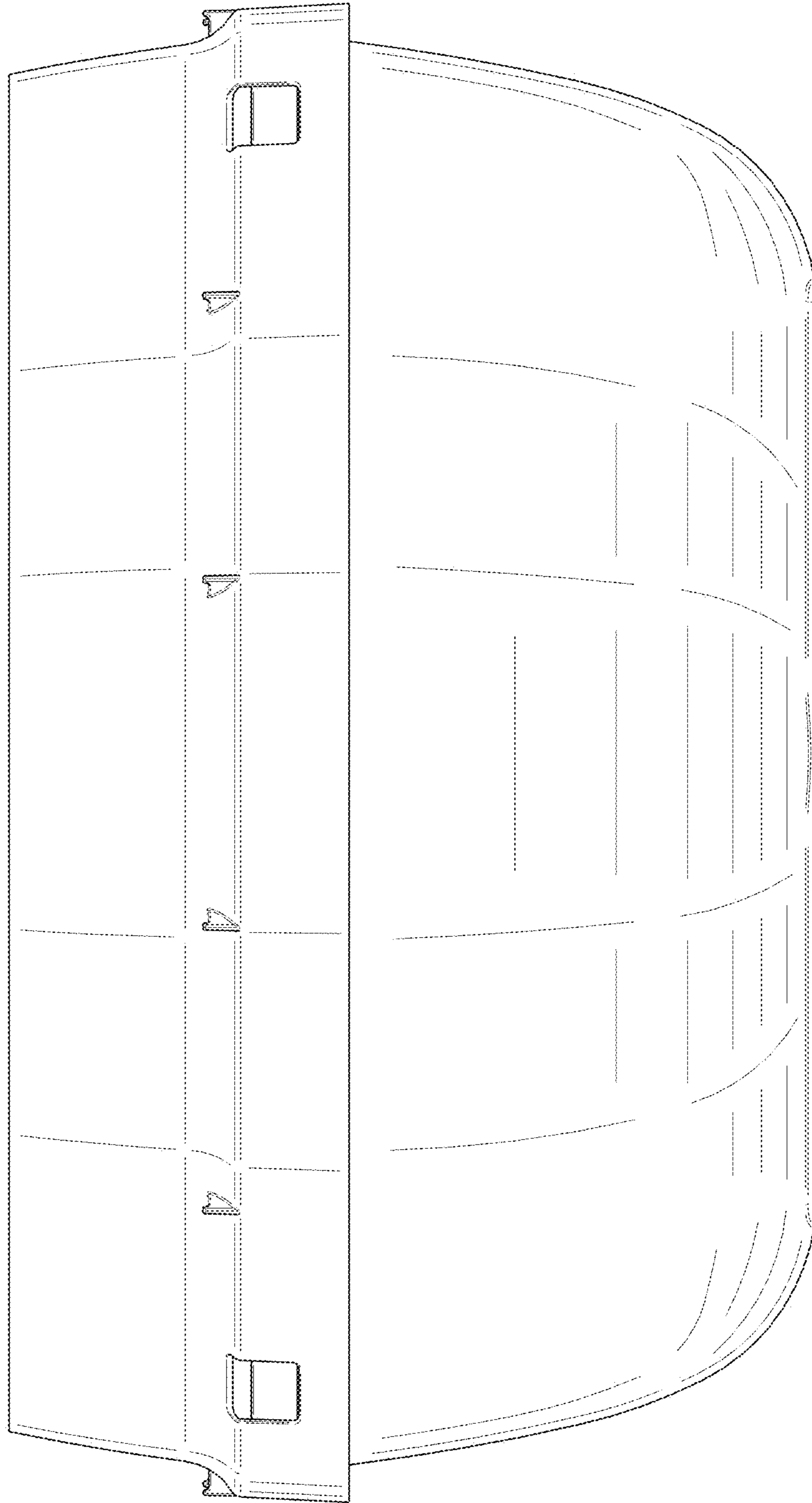

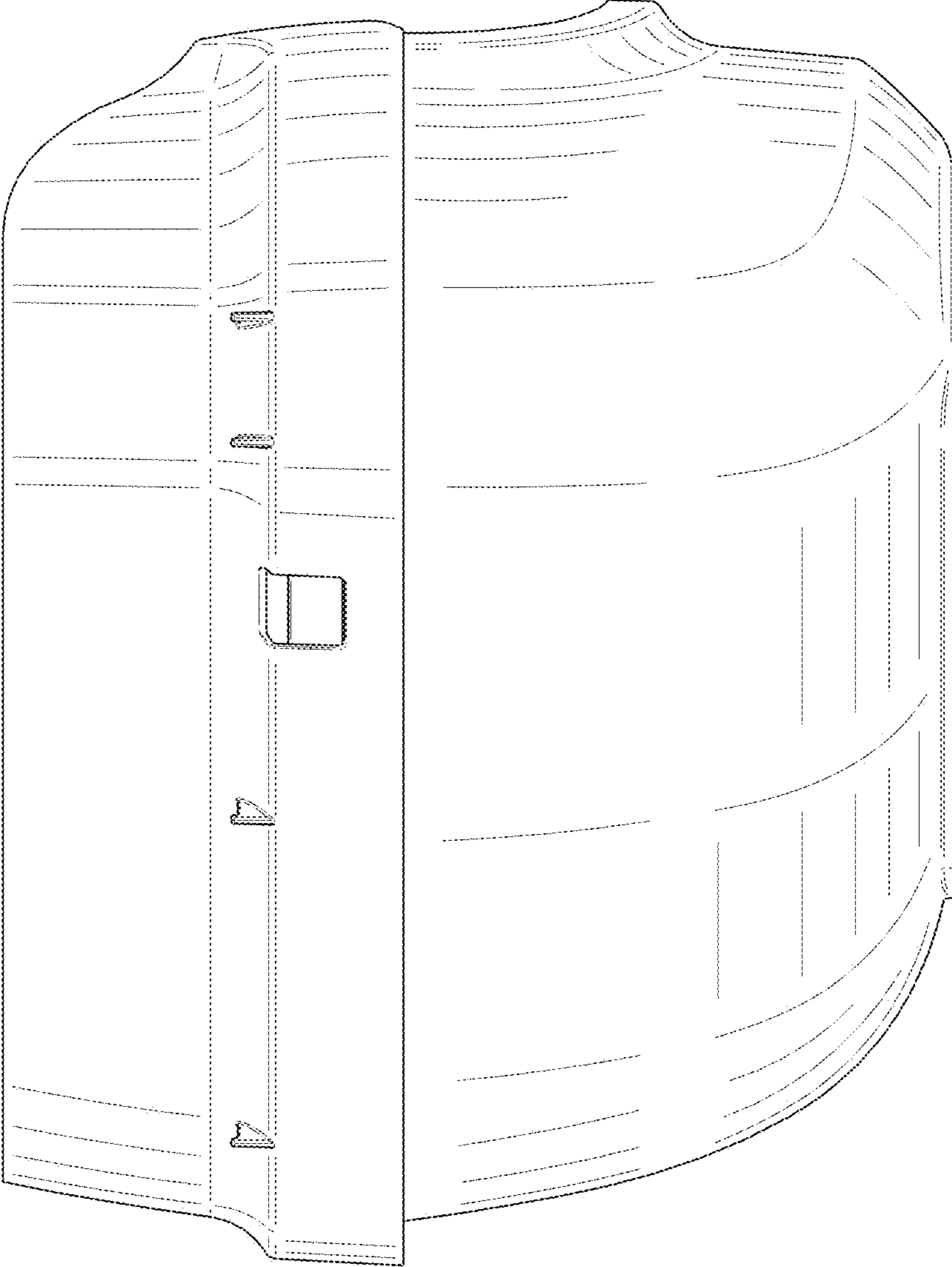

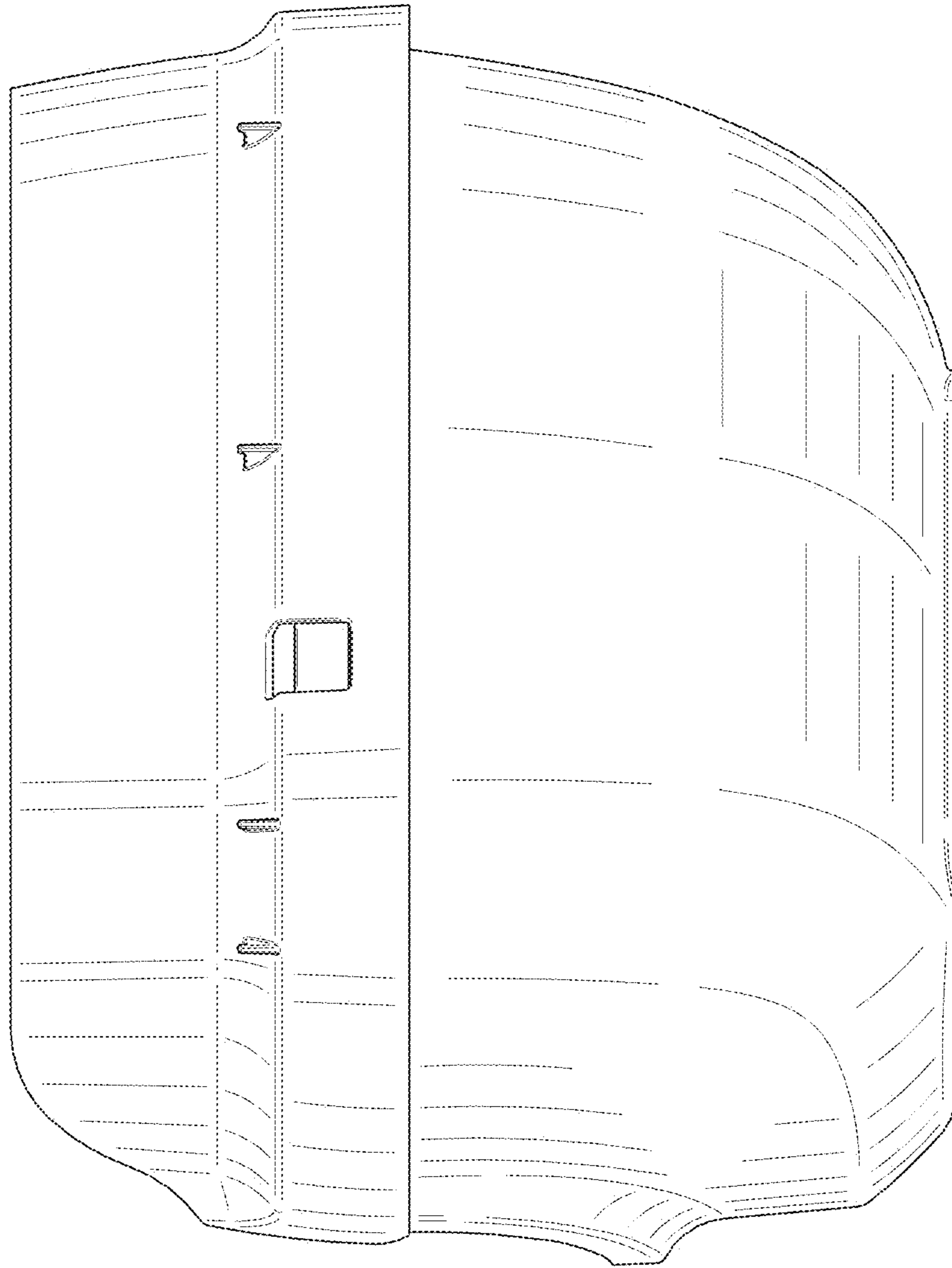

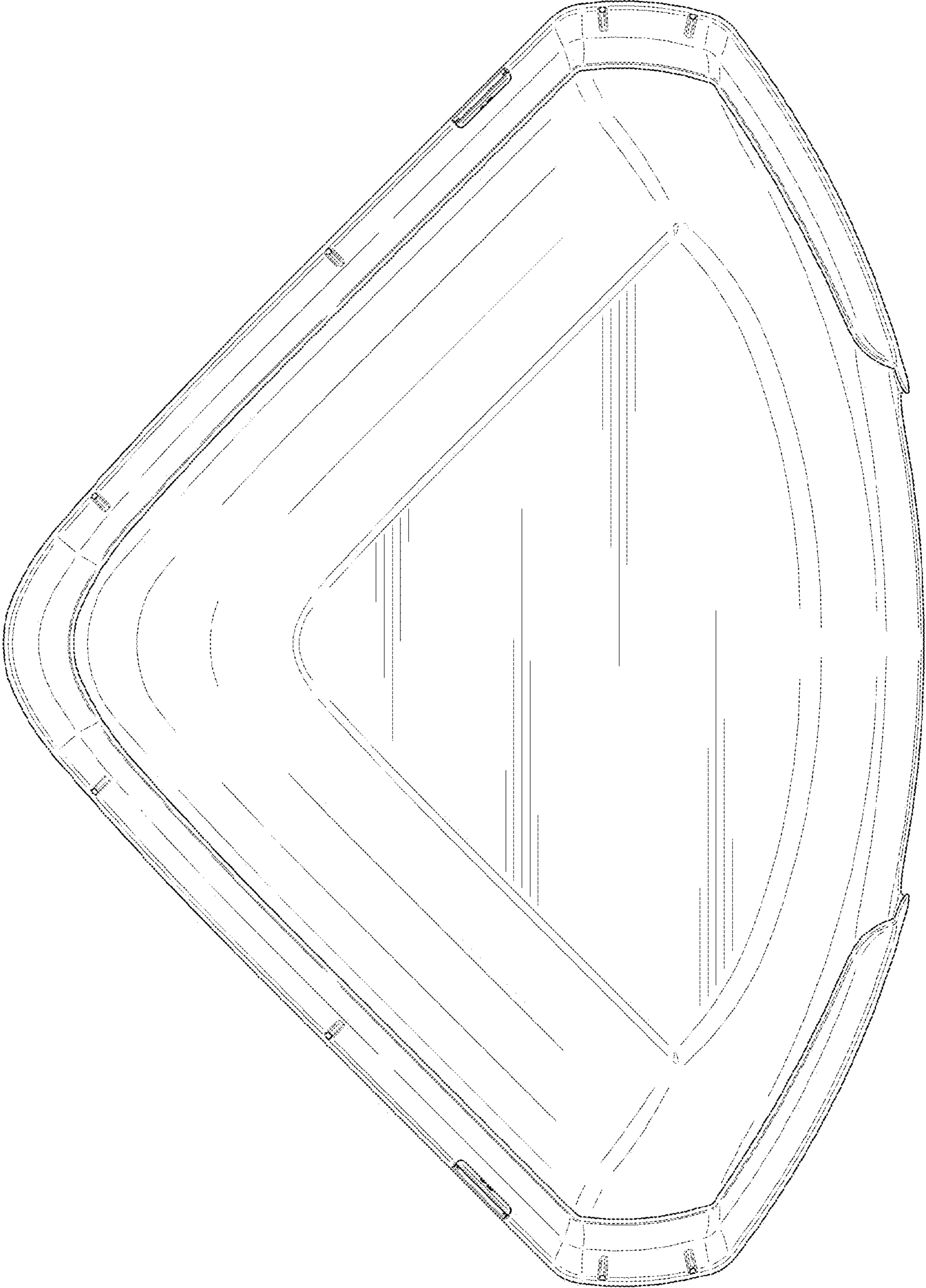

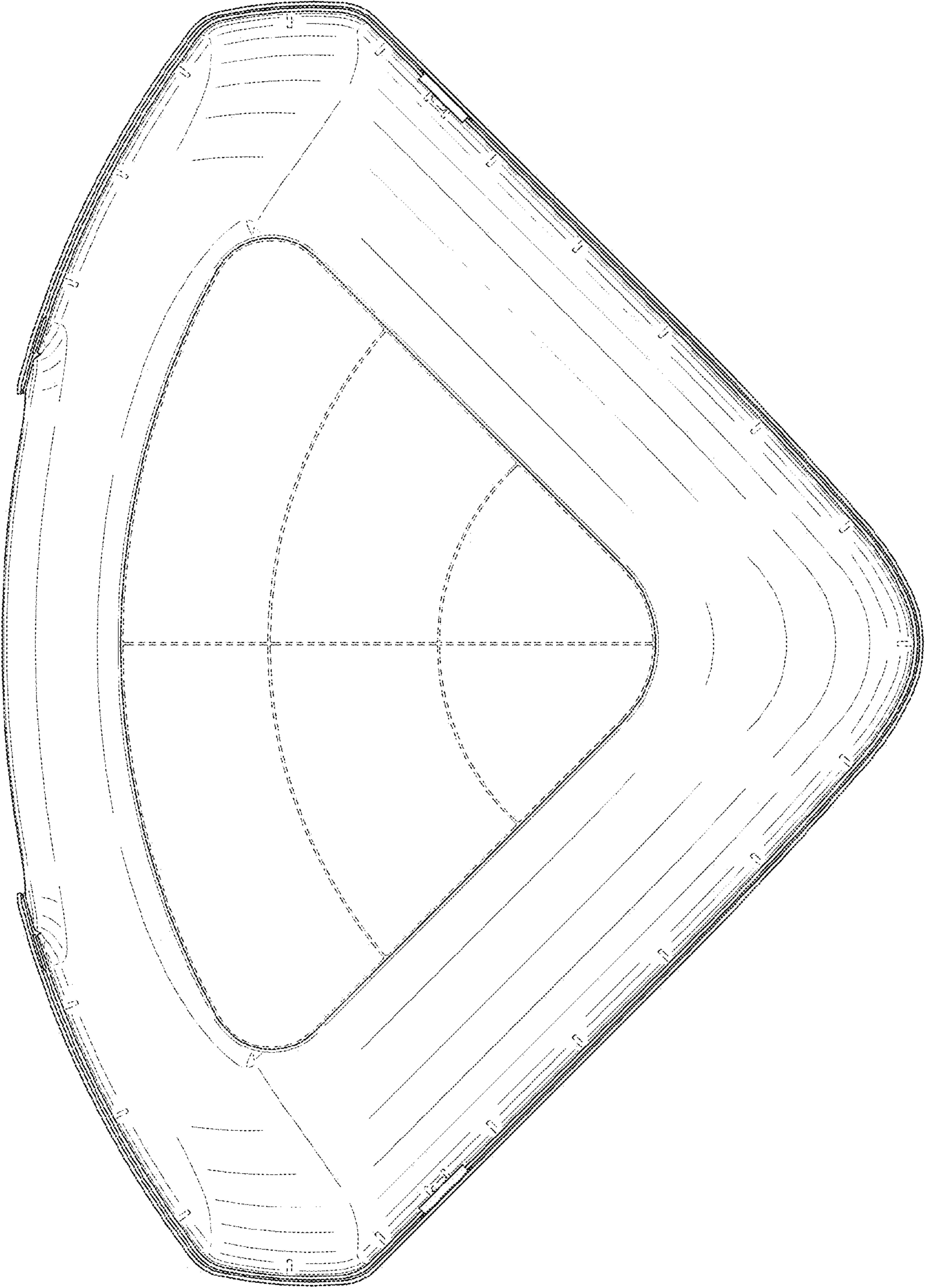
