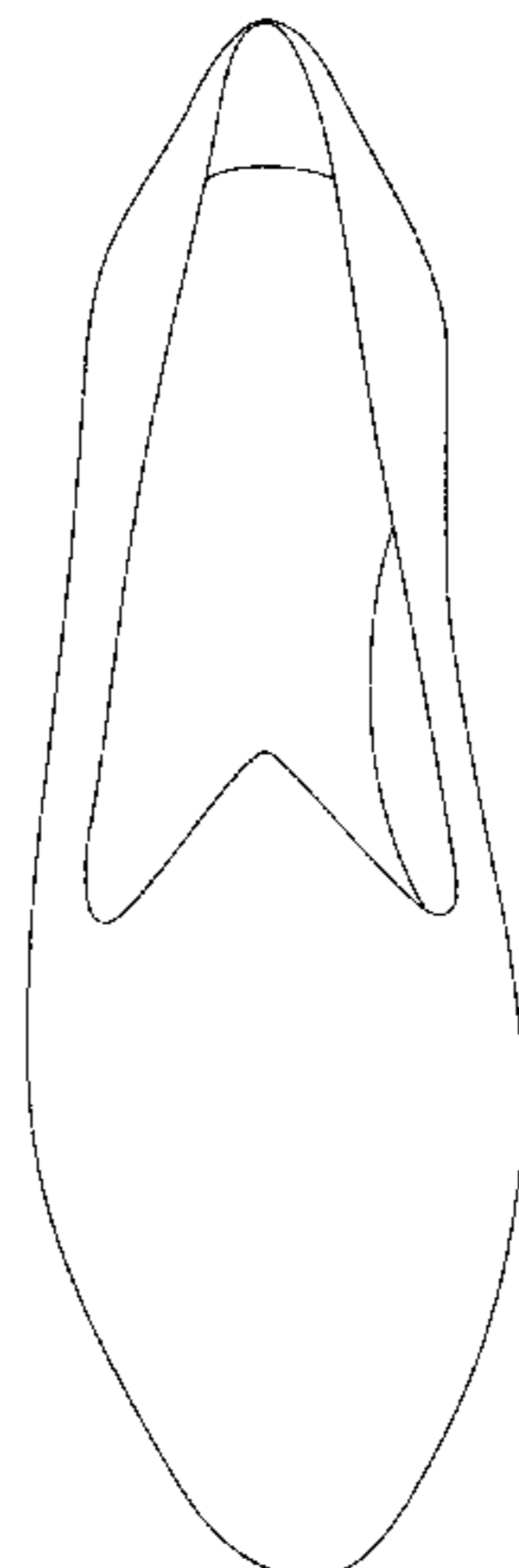

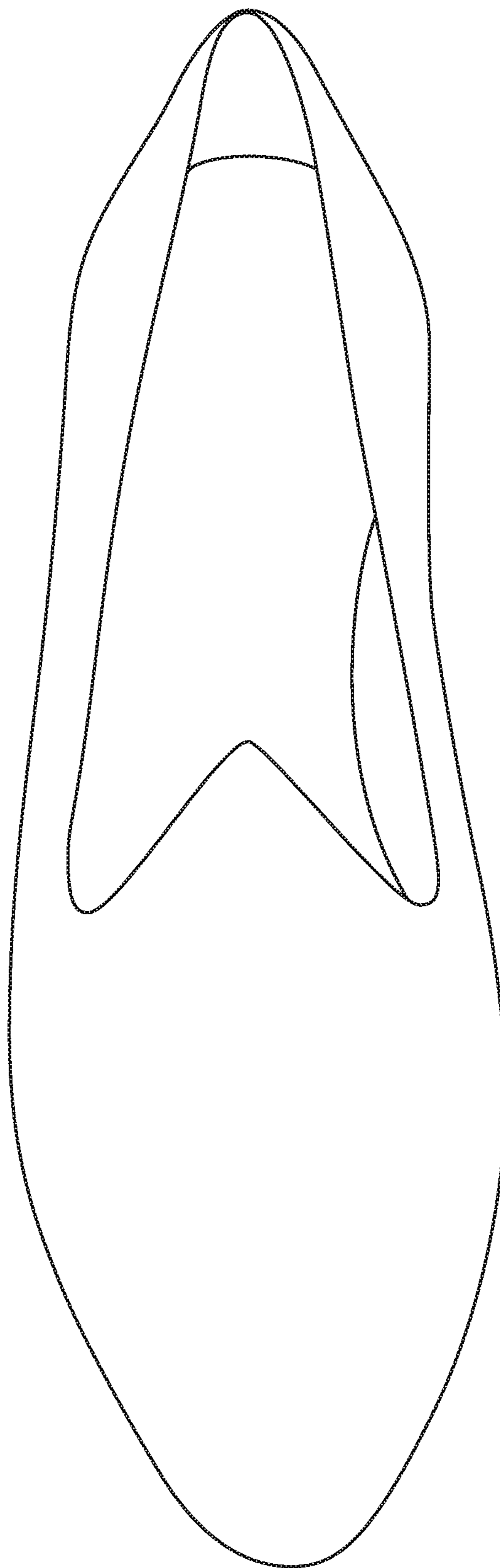
The ornamental design for footwear, as shown and described.

DESCRIPTION

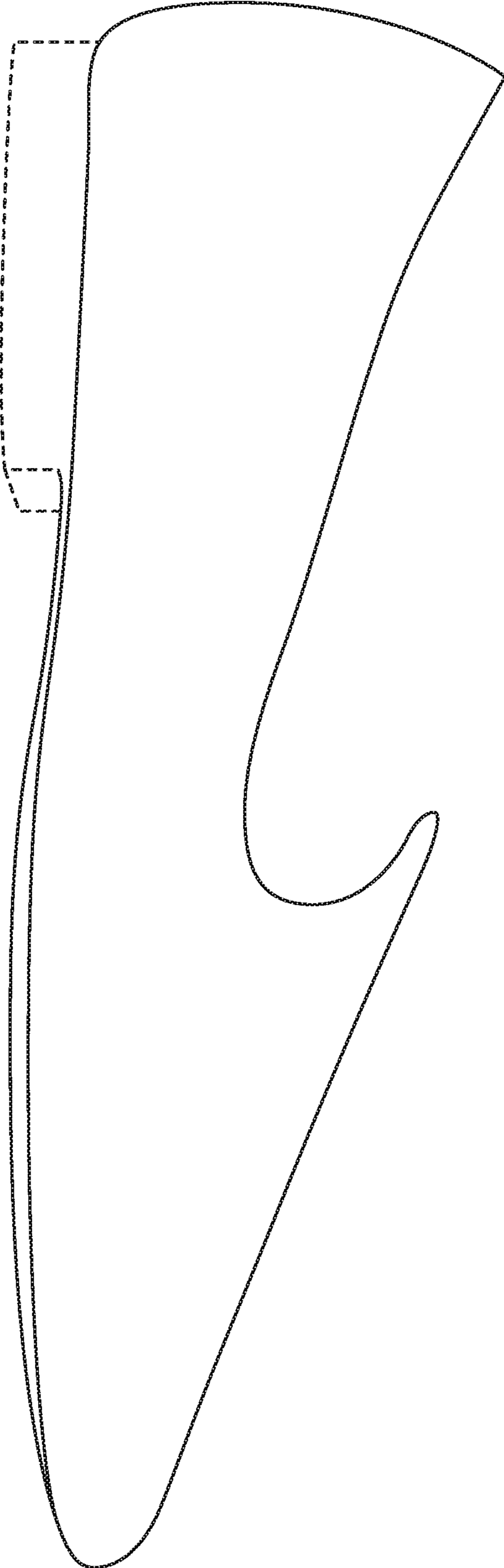
2.1 is a top view of footwear showing the new design.

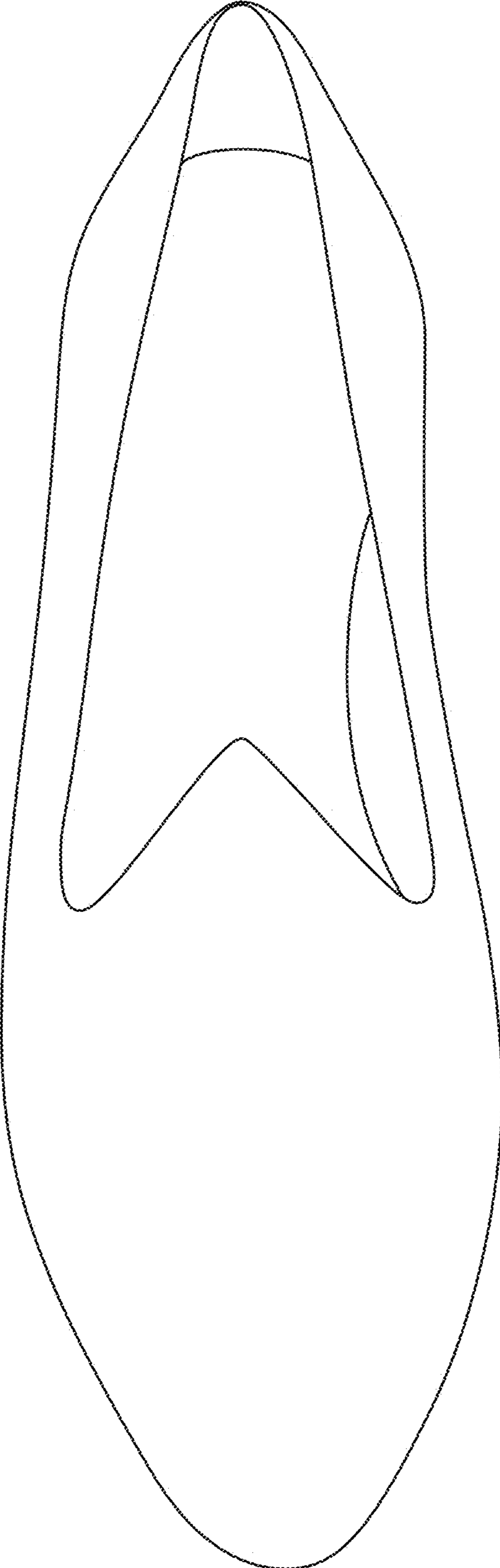




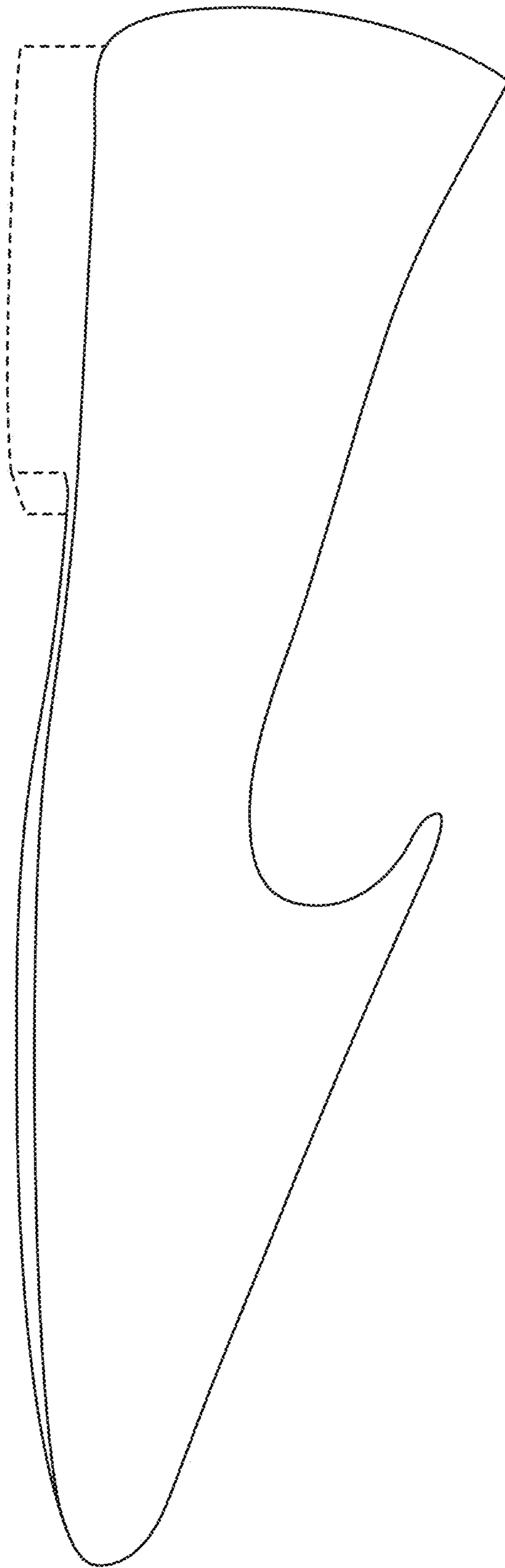
