(57) **CLAIM**

The ornamental design for a bag with interior liner having pockets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the bag with interior liner having pockets of my new design from the front, right, shown in a fastened configuration;

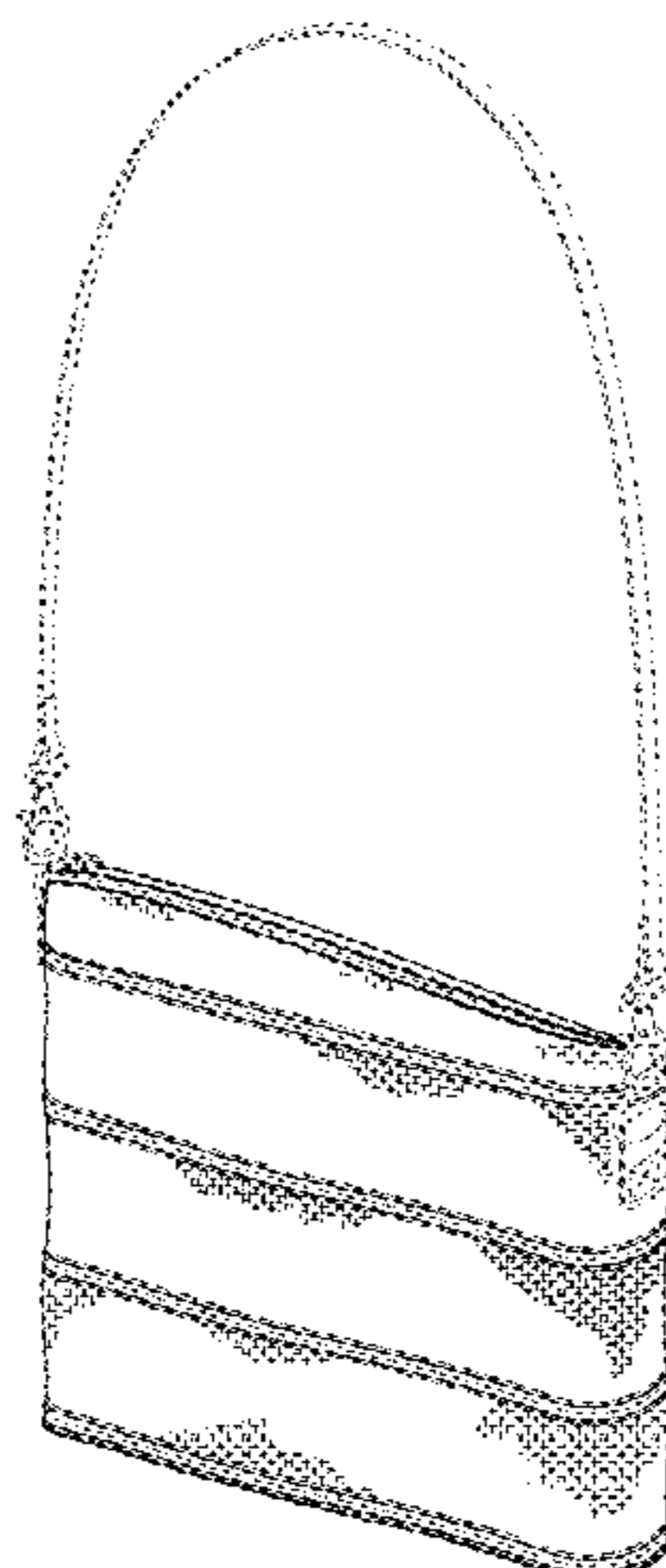


FIG. 22 is a top plan view thereof, shown in the fastened configuration;

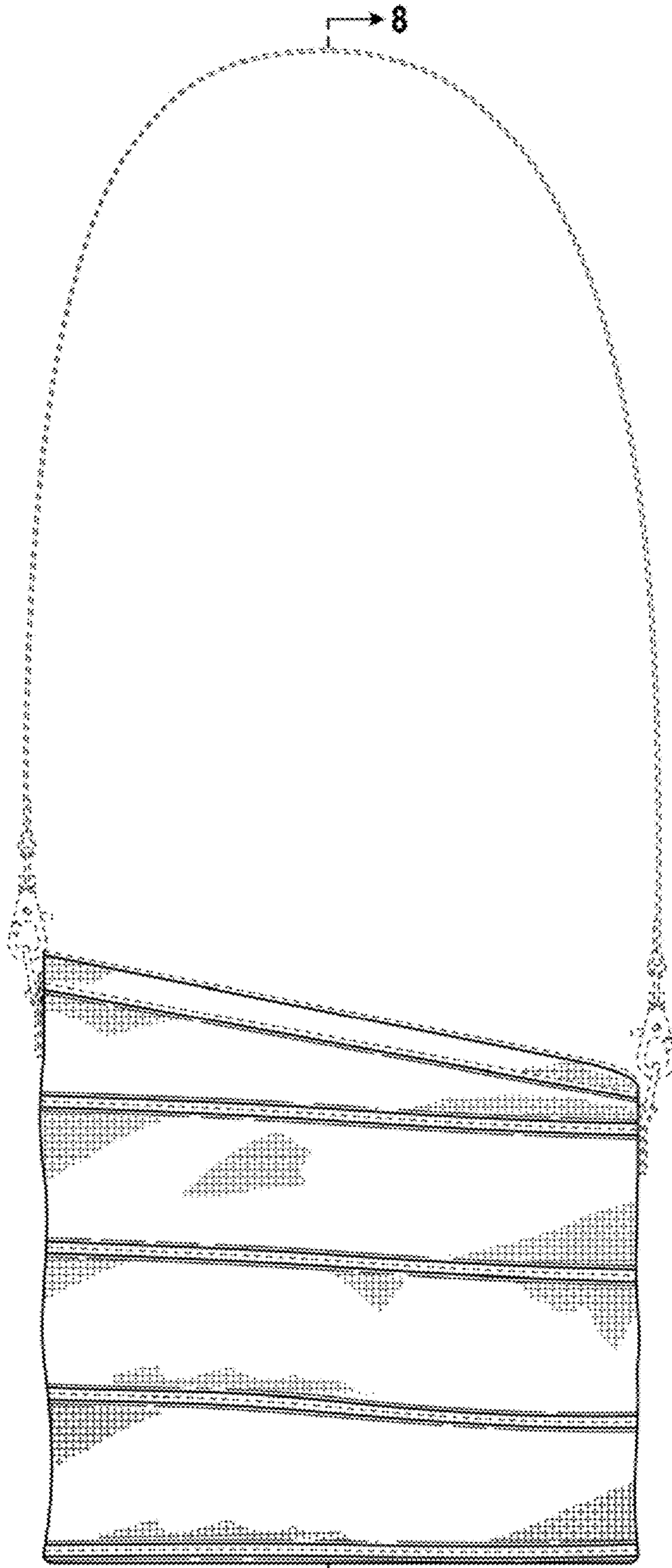

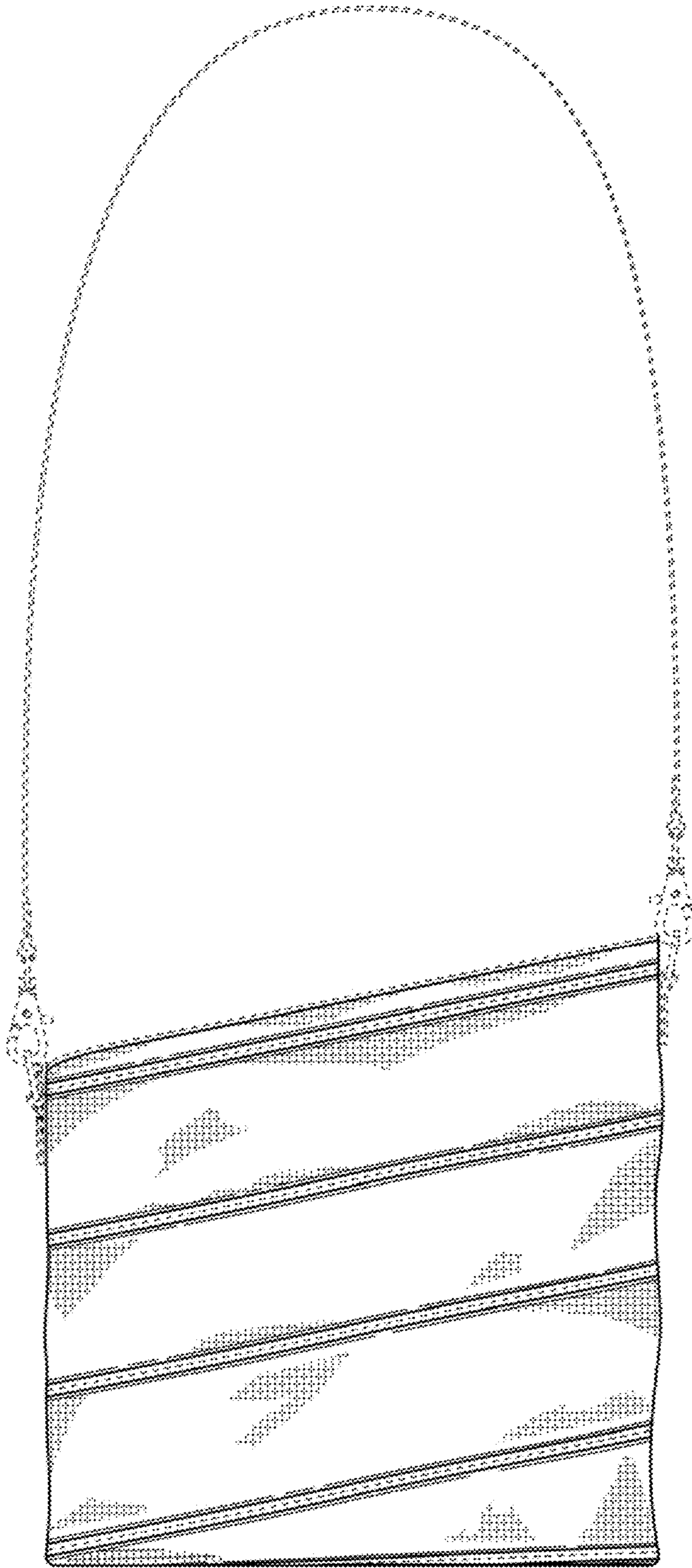

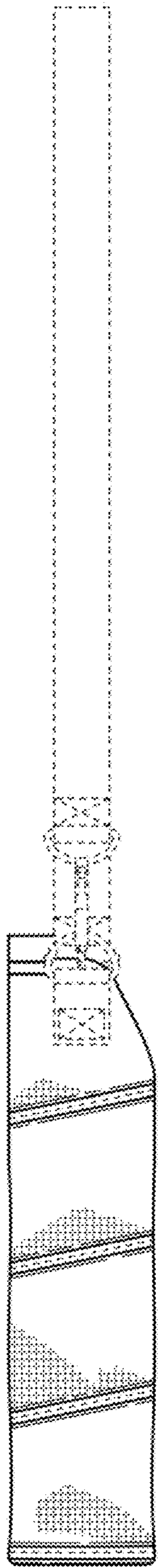

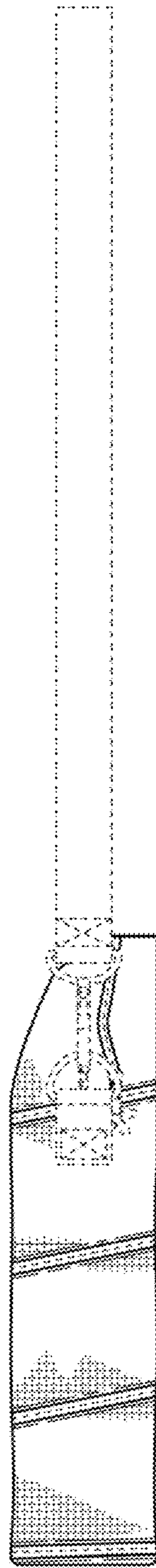

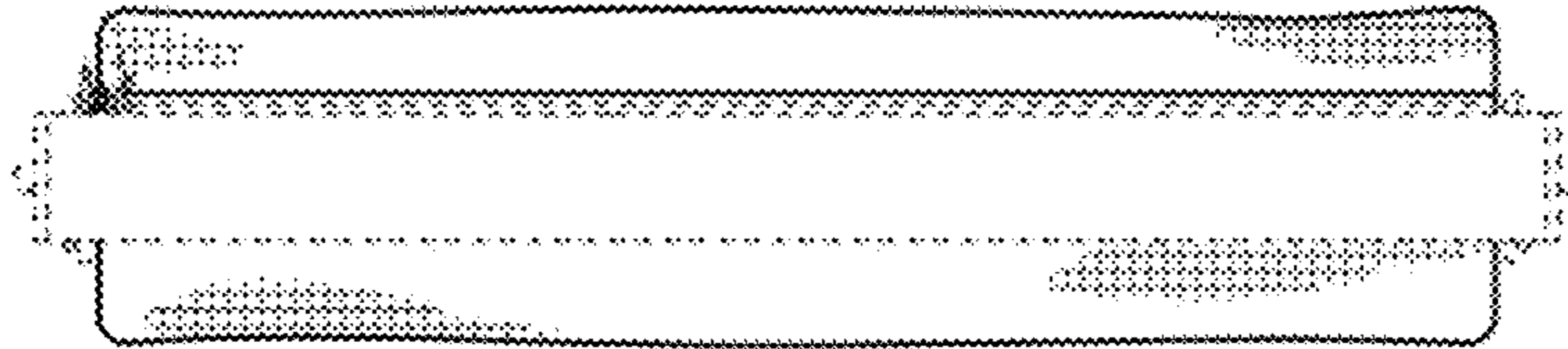

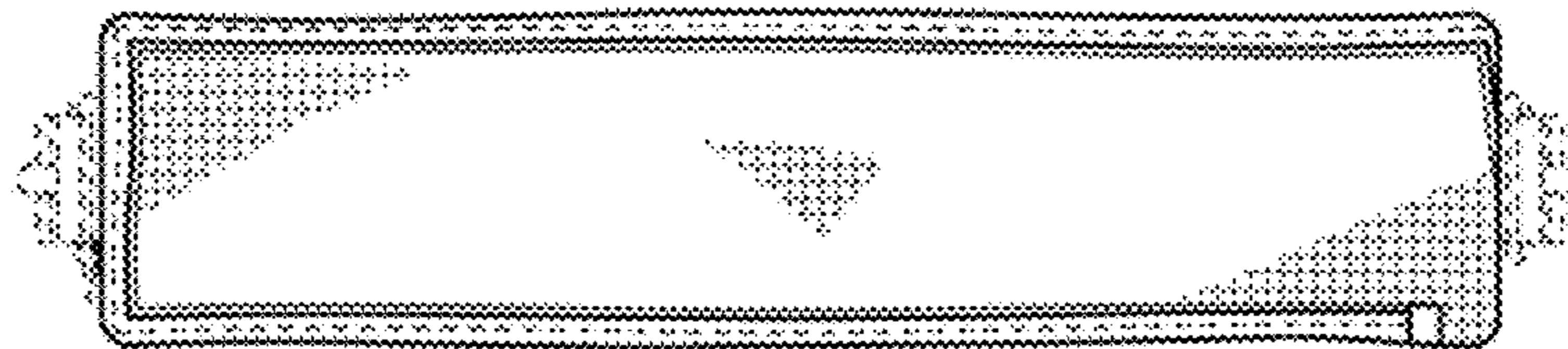

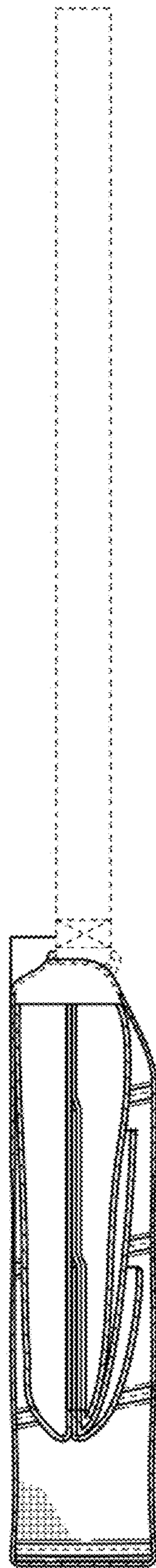

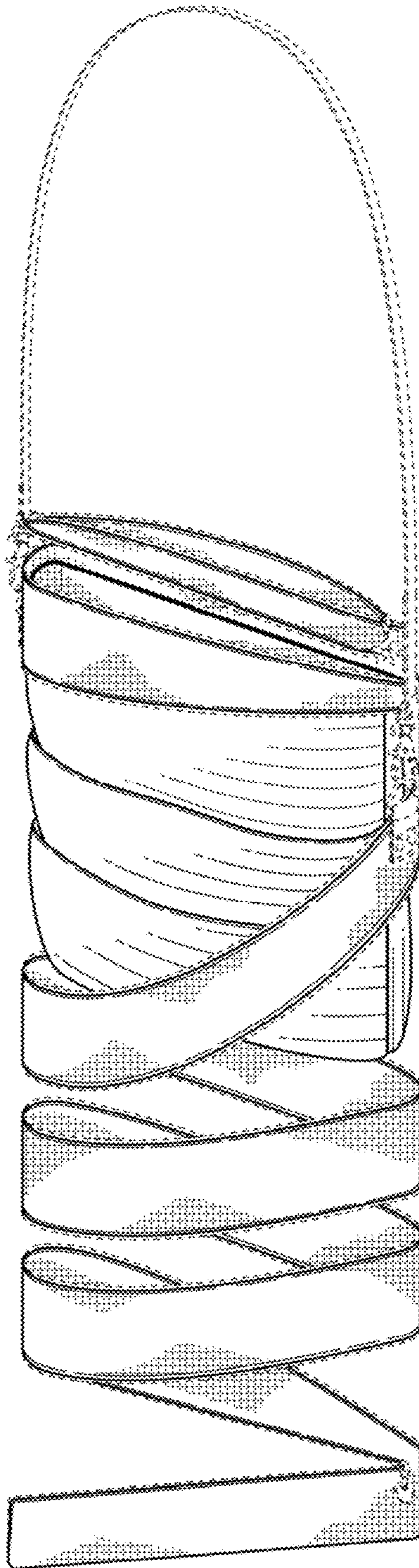

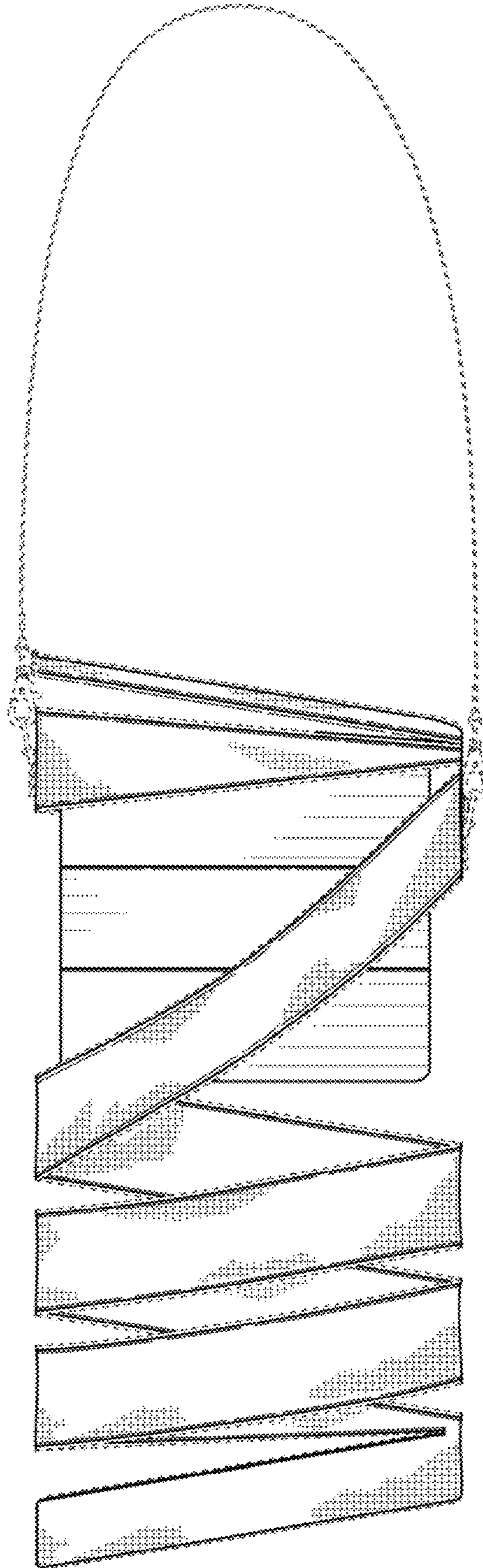

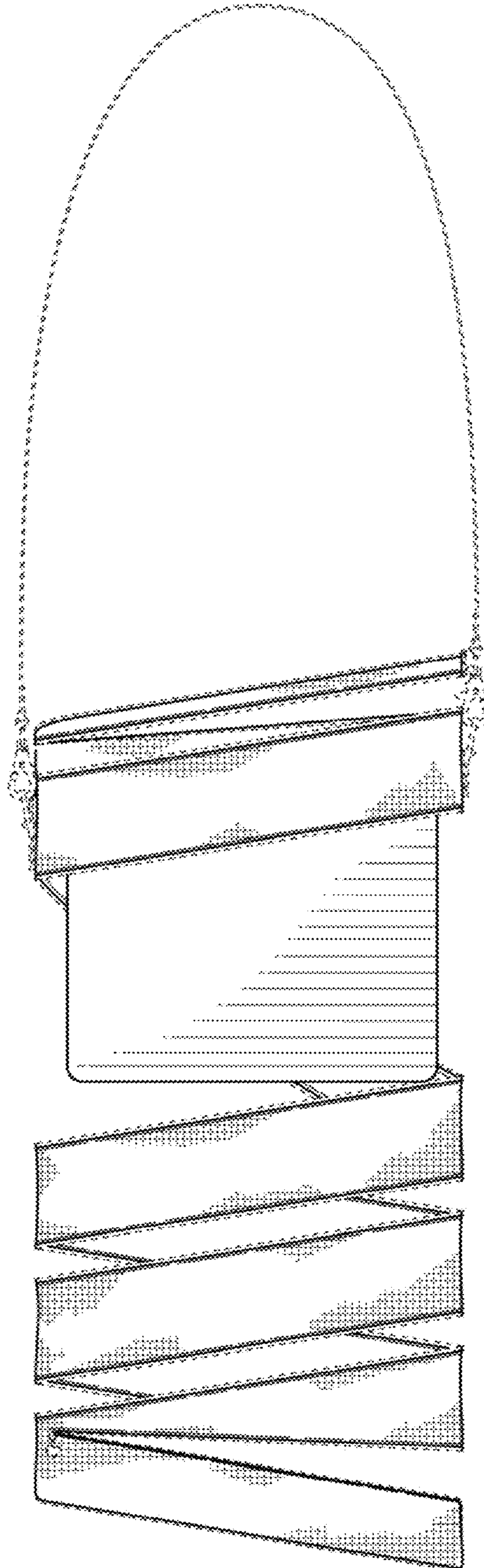

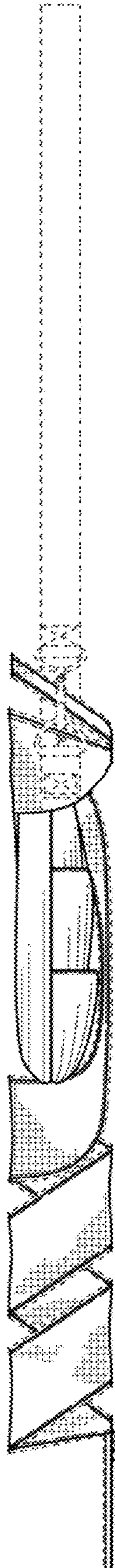

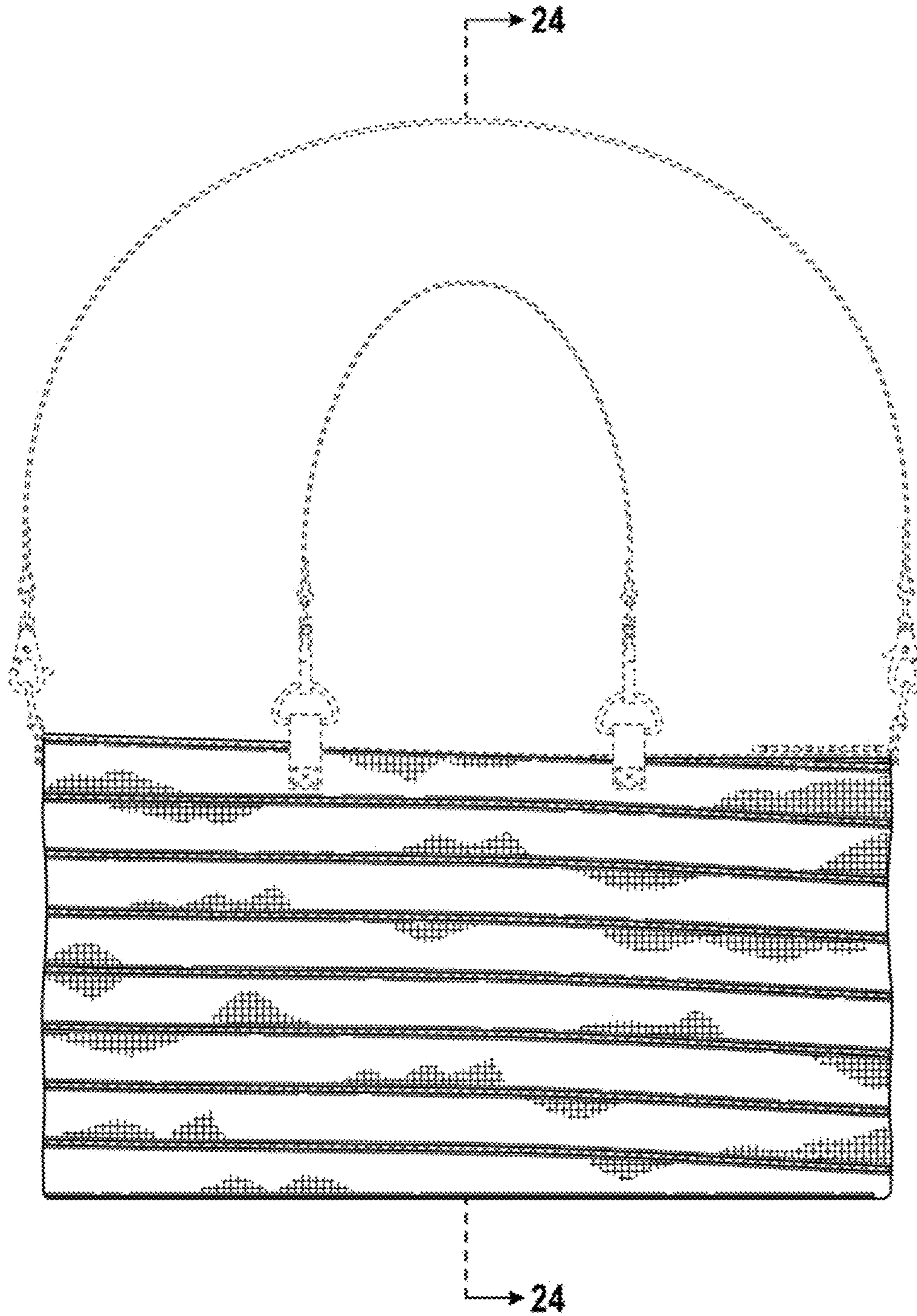

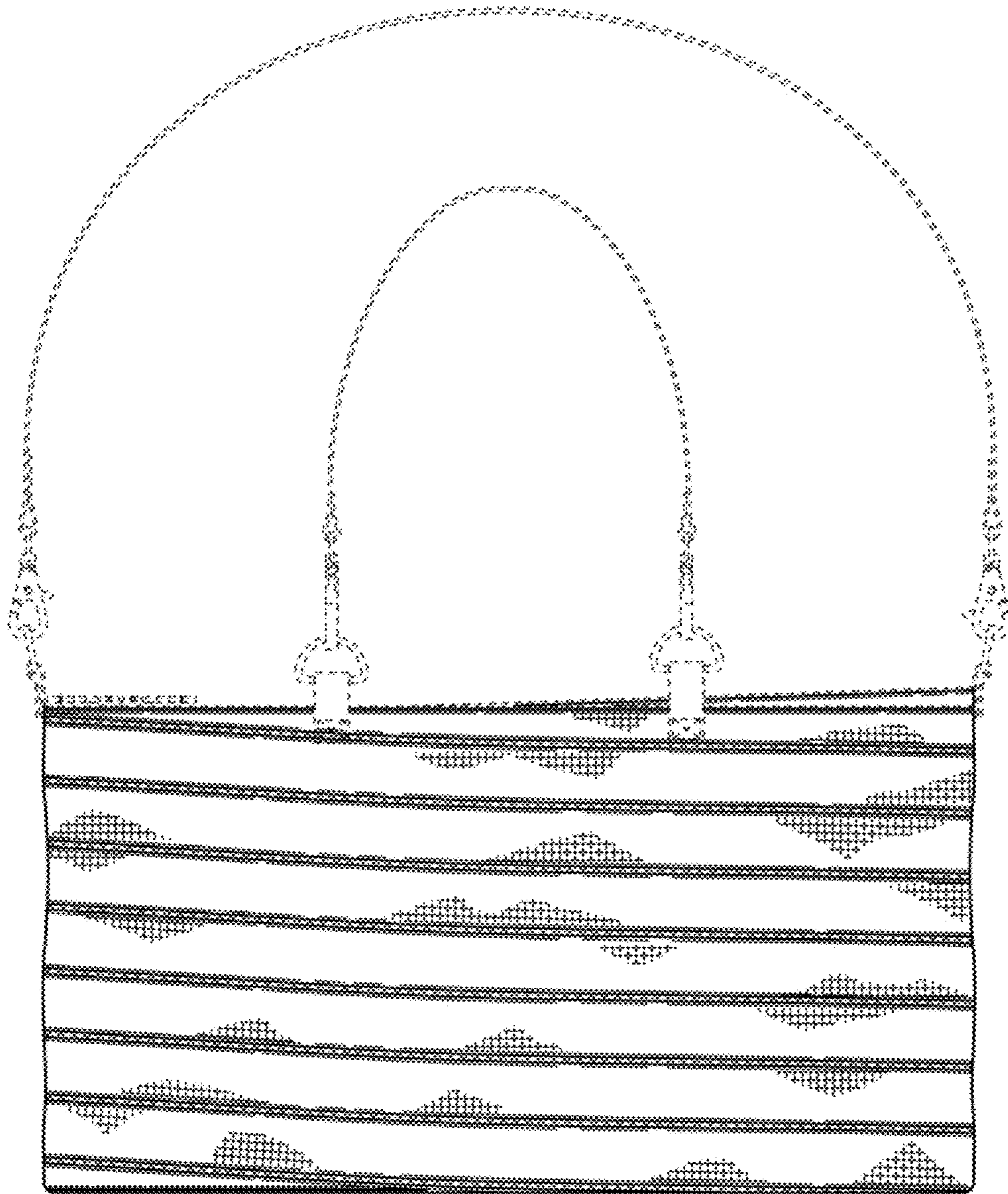

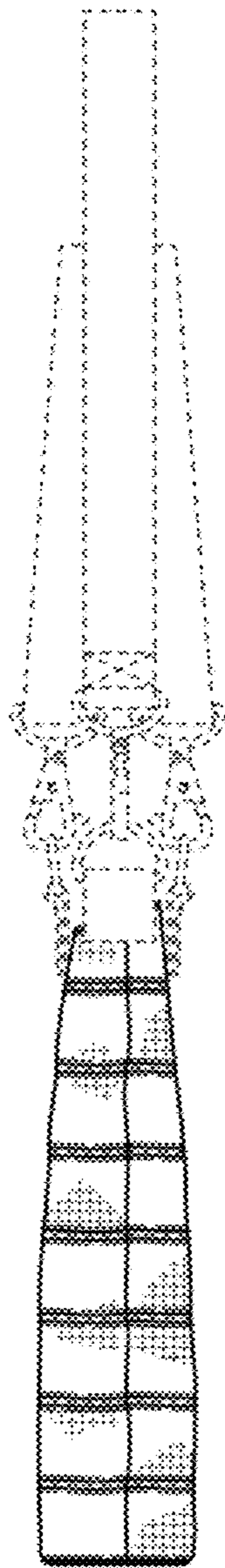

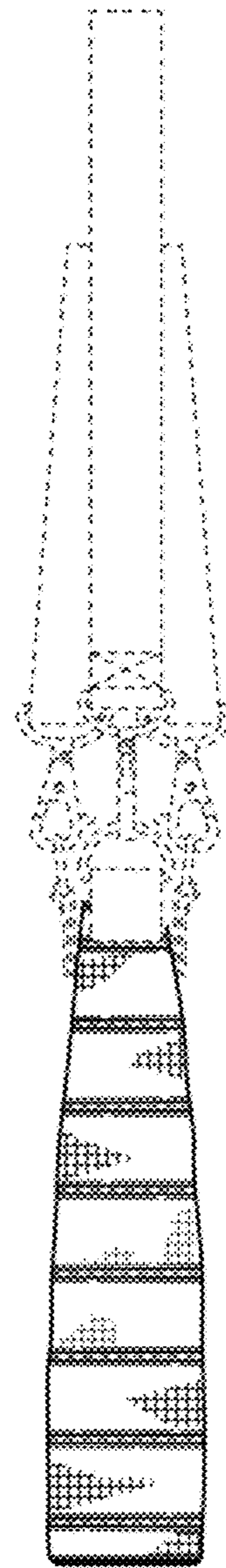

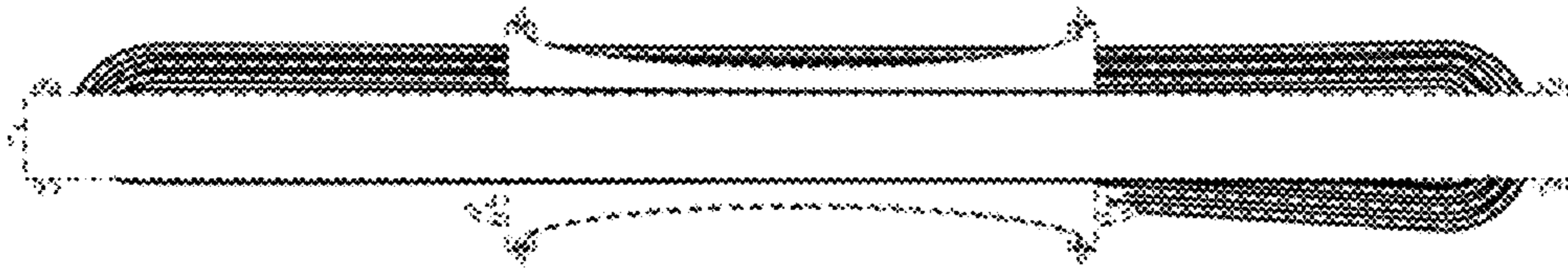

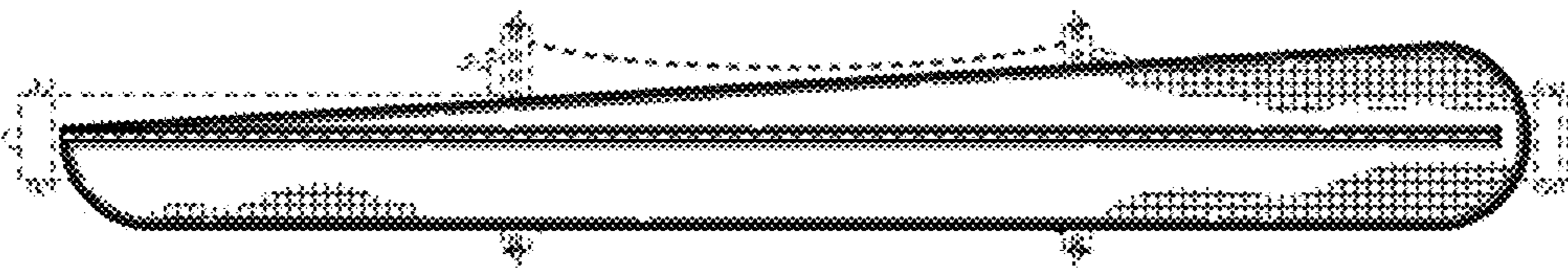

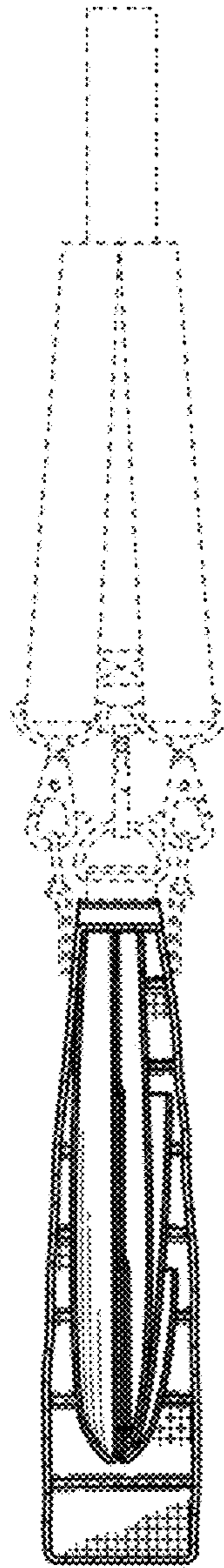

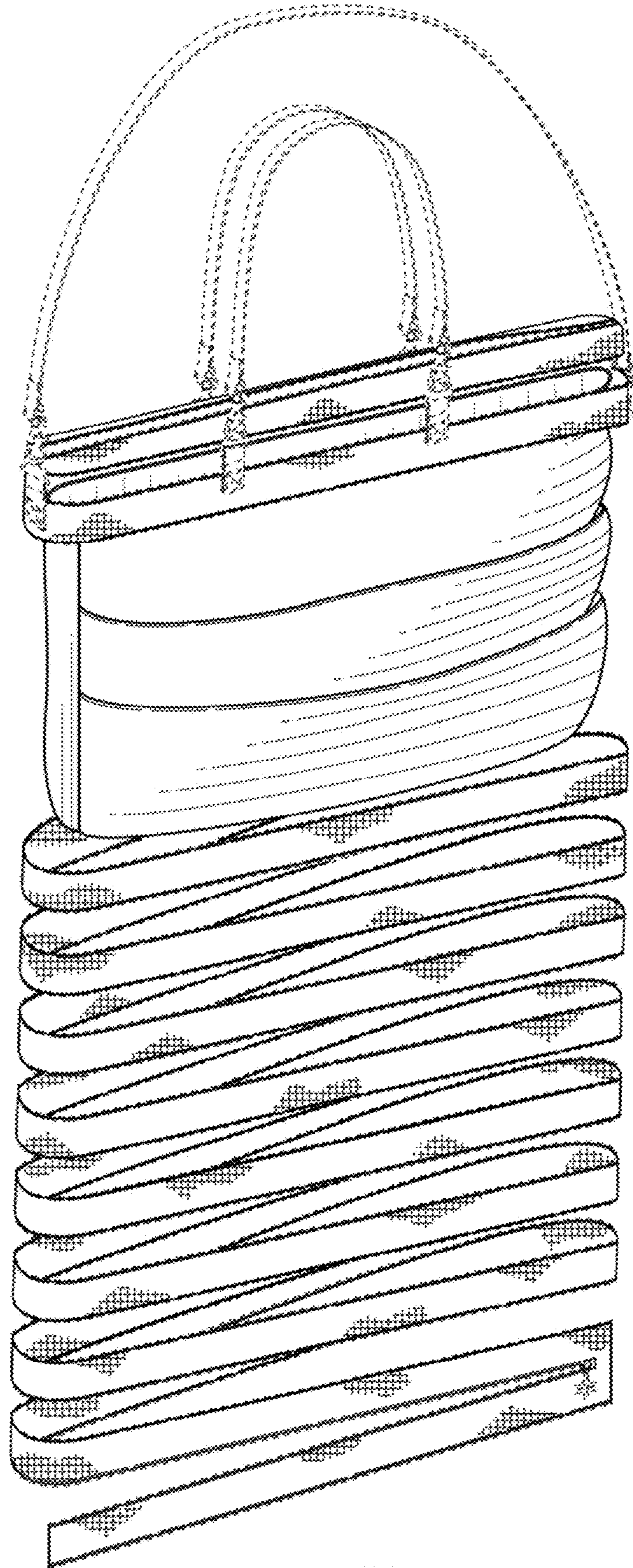

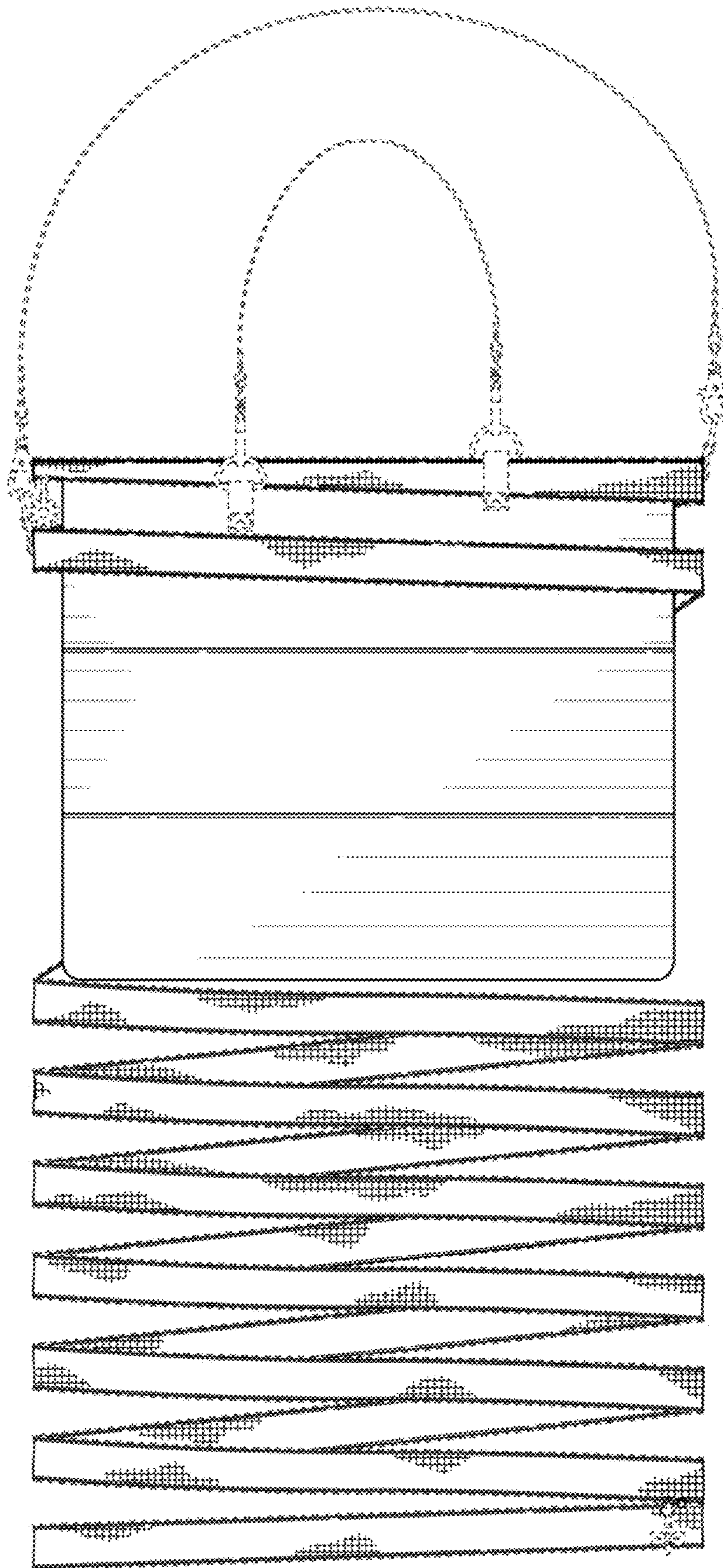

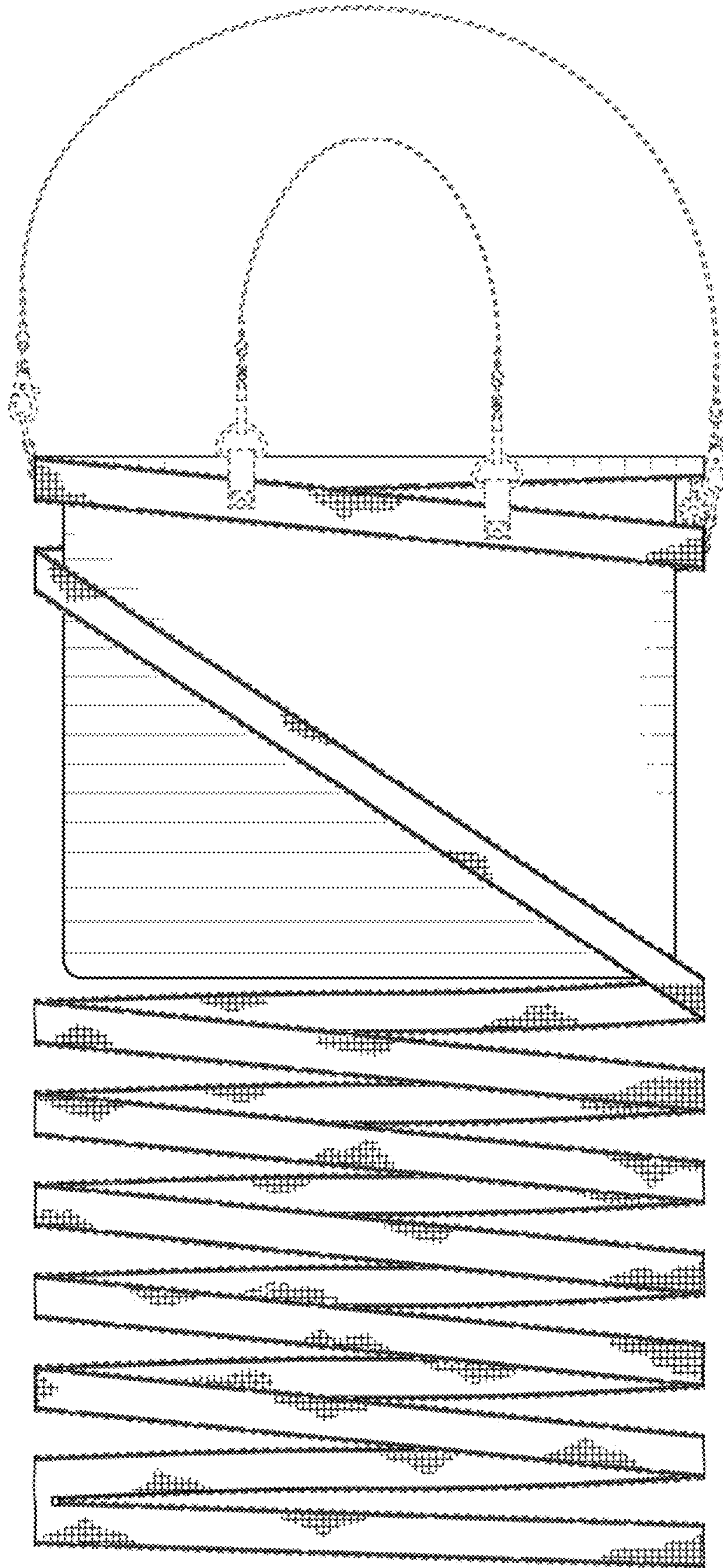

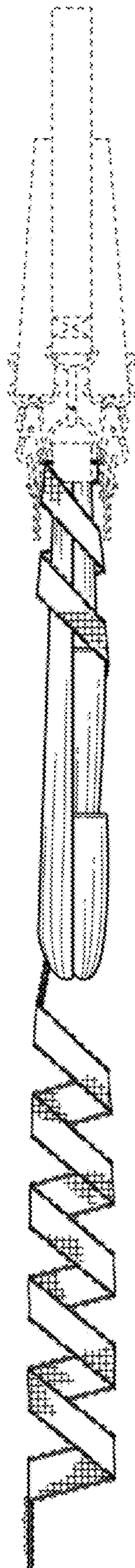

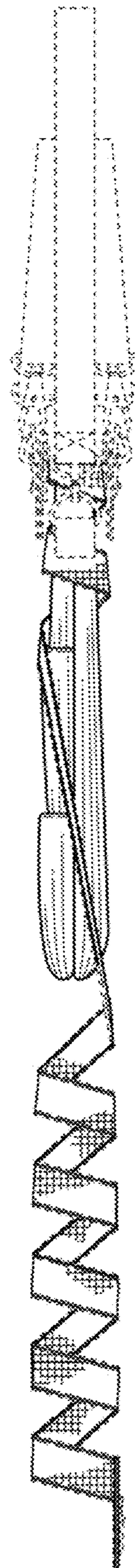

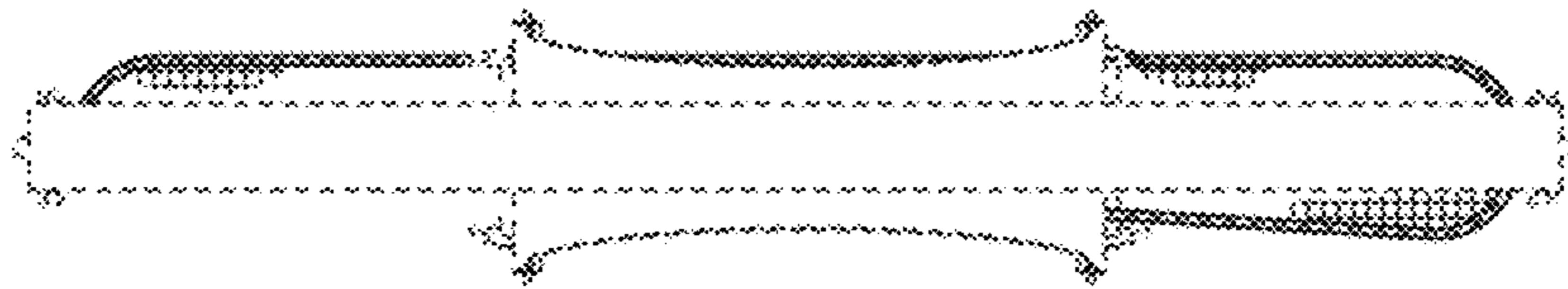

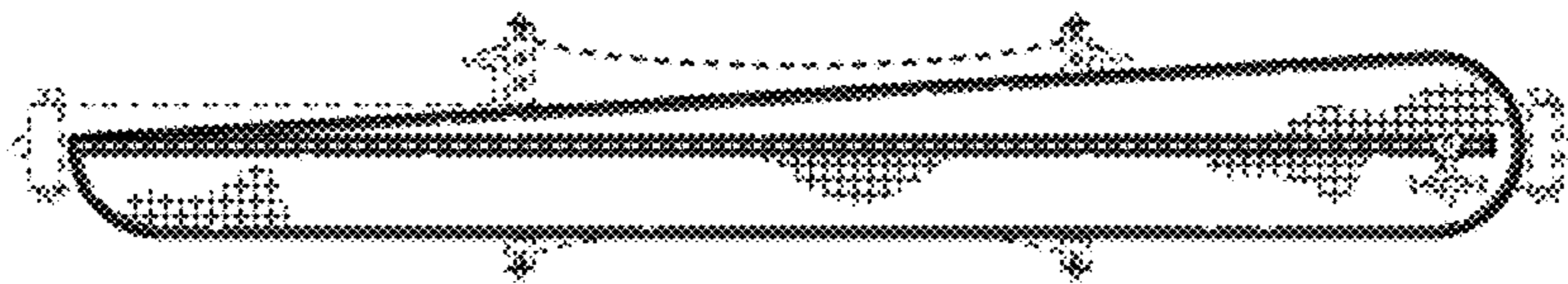
