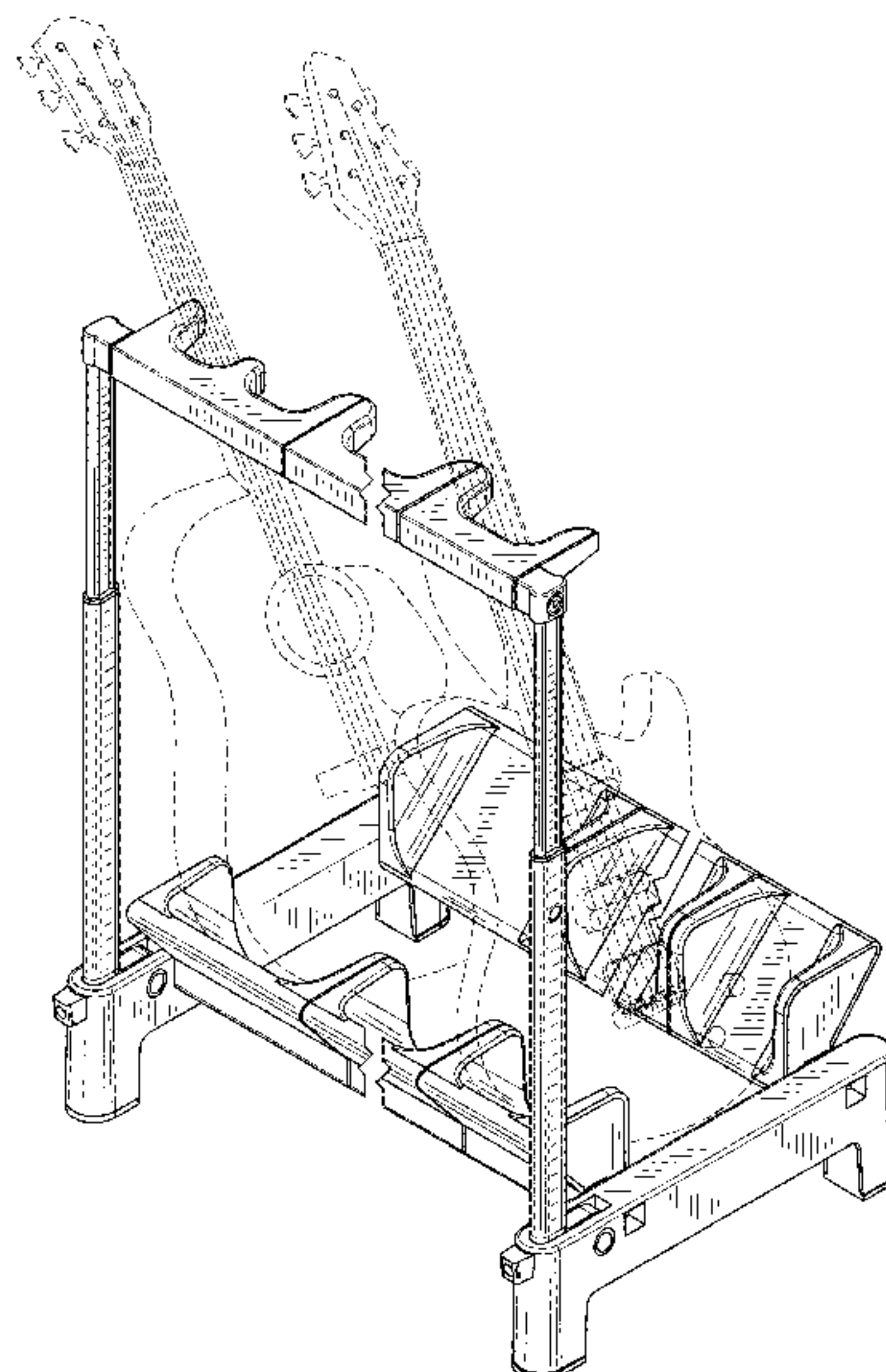
The ornamental design for a multiple guitar stand, as shown and described.

**DESCRIPTION**

FIG. 8 is a perspective view of a multiple guitar stand in the retracted position;

FIG. 10 is a right-view of a multiple guitar stand in the retracted position;  
FIG. 11 is a top view of a multiple guitar stand in the retracted position;  
FIG. 12 is a back view of a multiple guitar stand in the retracted position;  
FIG. 13 is a front view of a multiple guitar stand in the retracted position; and,  
FIG. 14 is a bottom view of a multiple guitar stand in the retracted position.

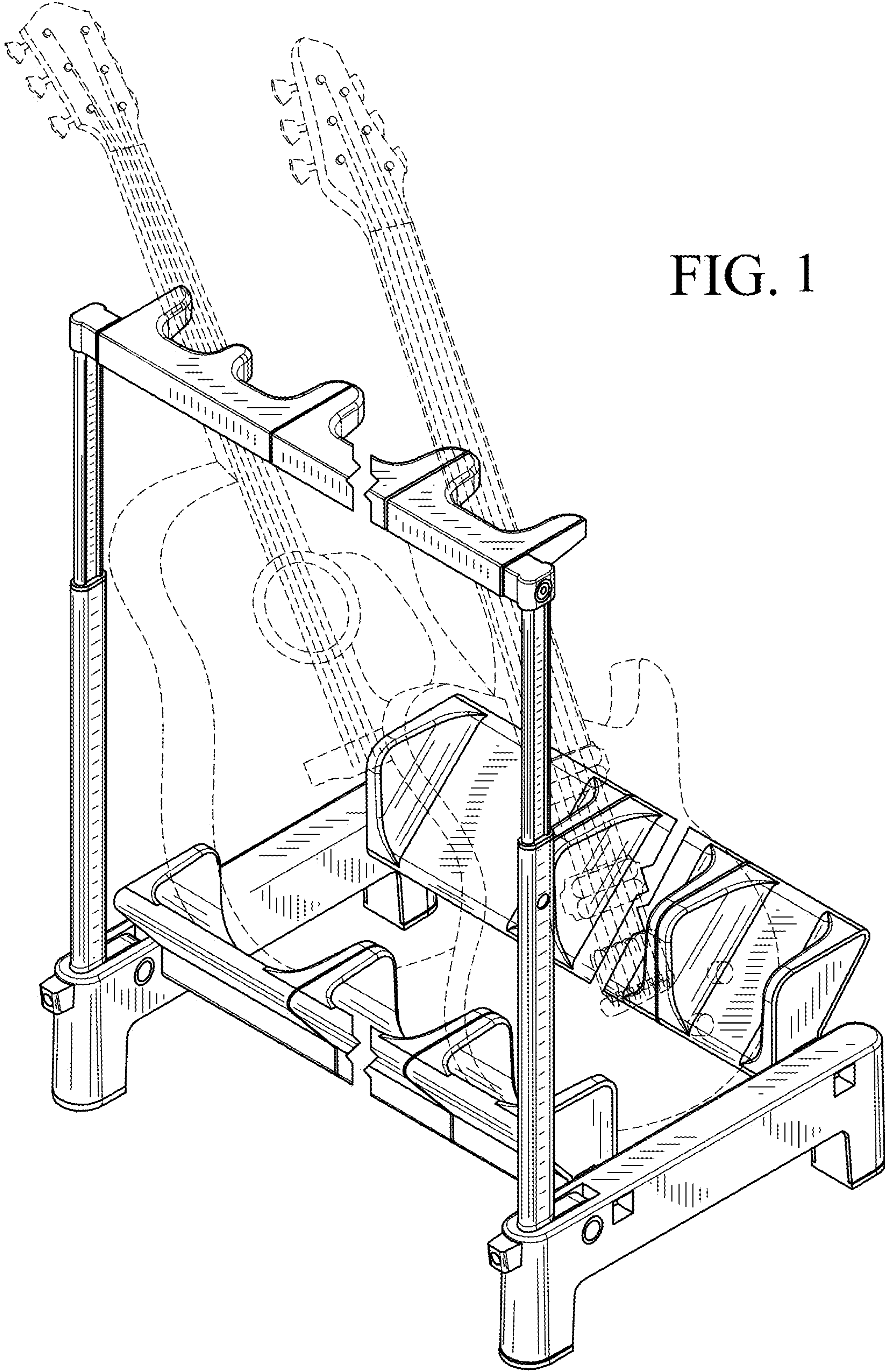

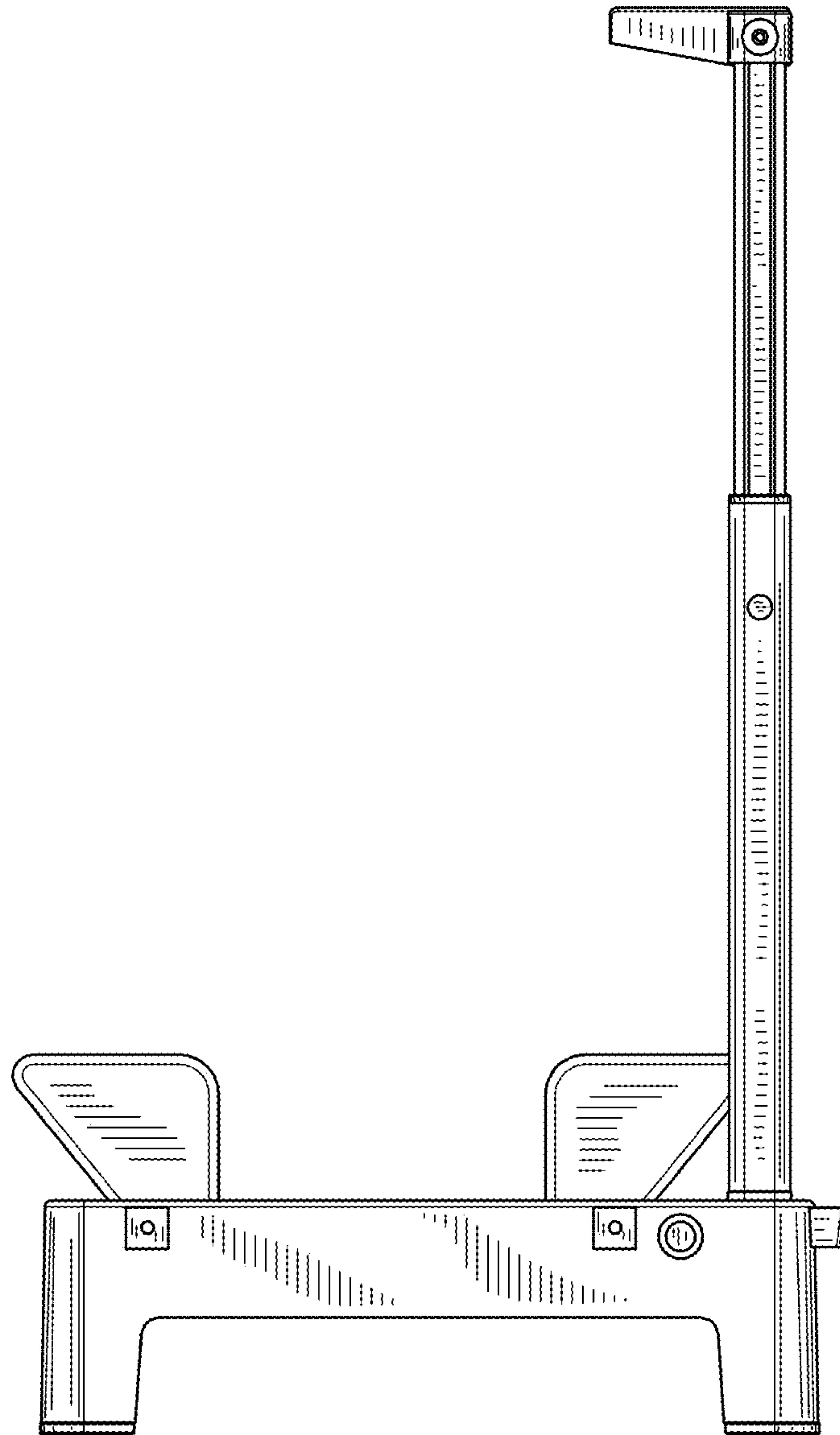

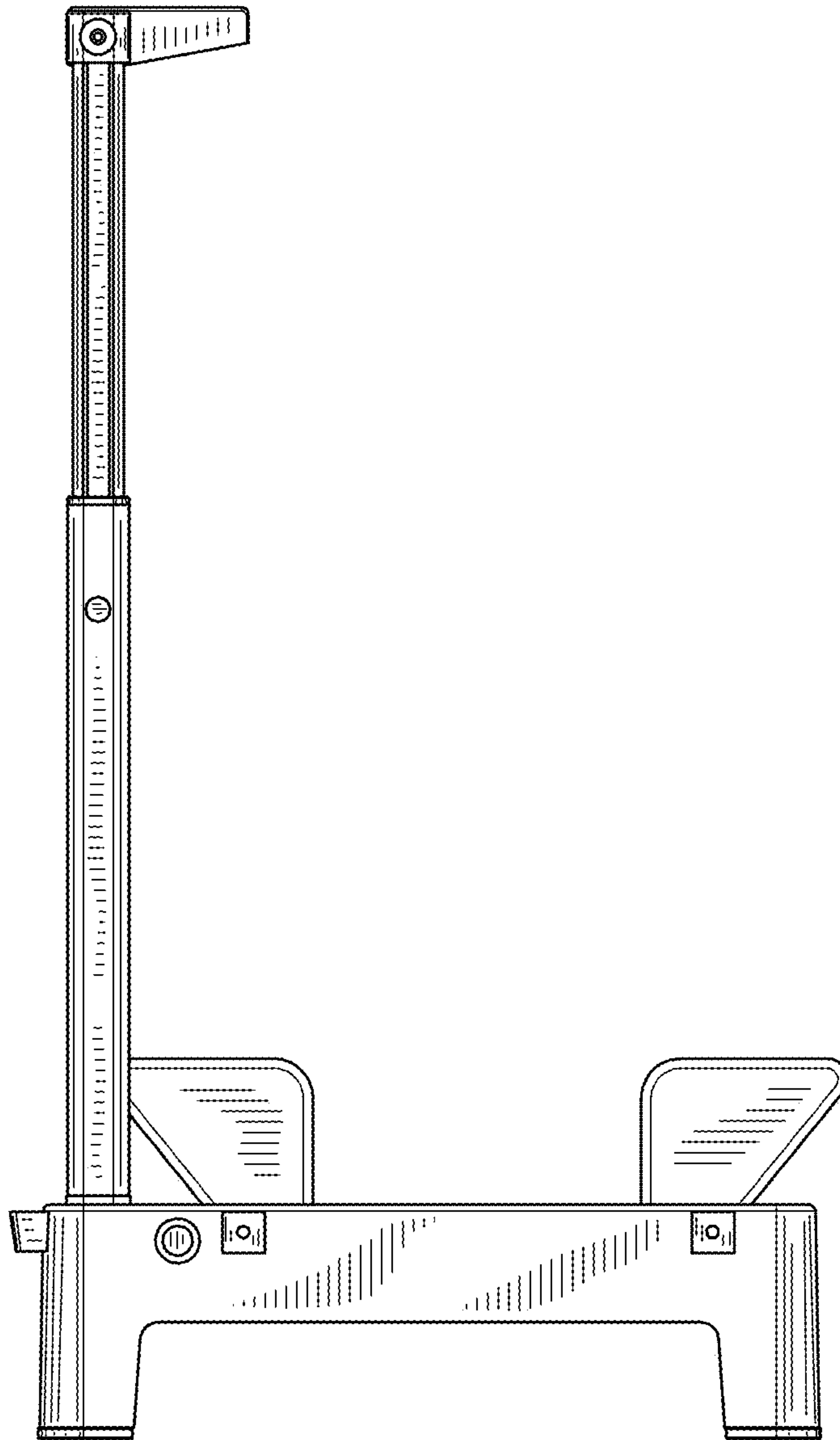

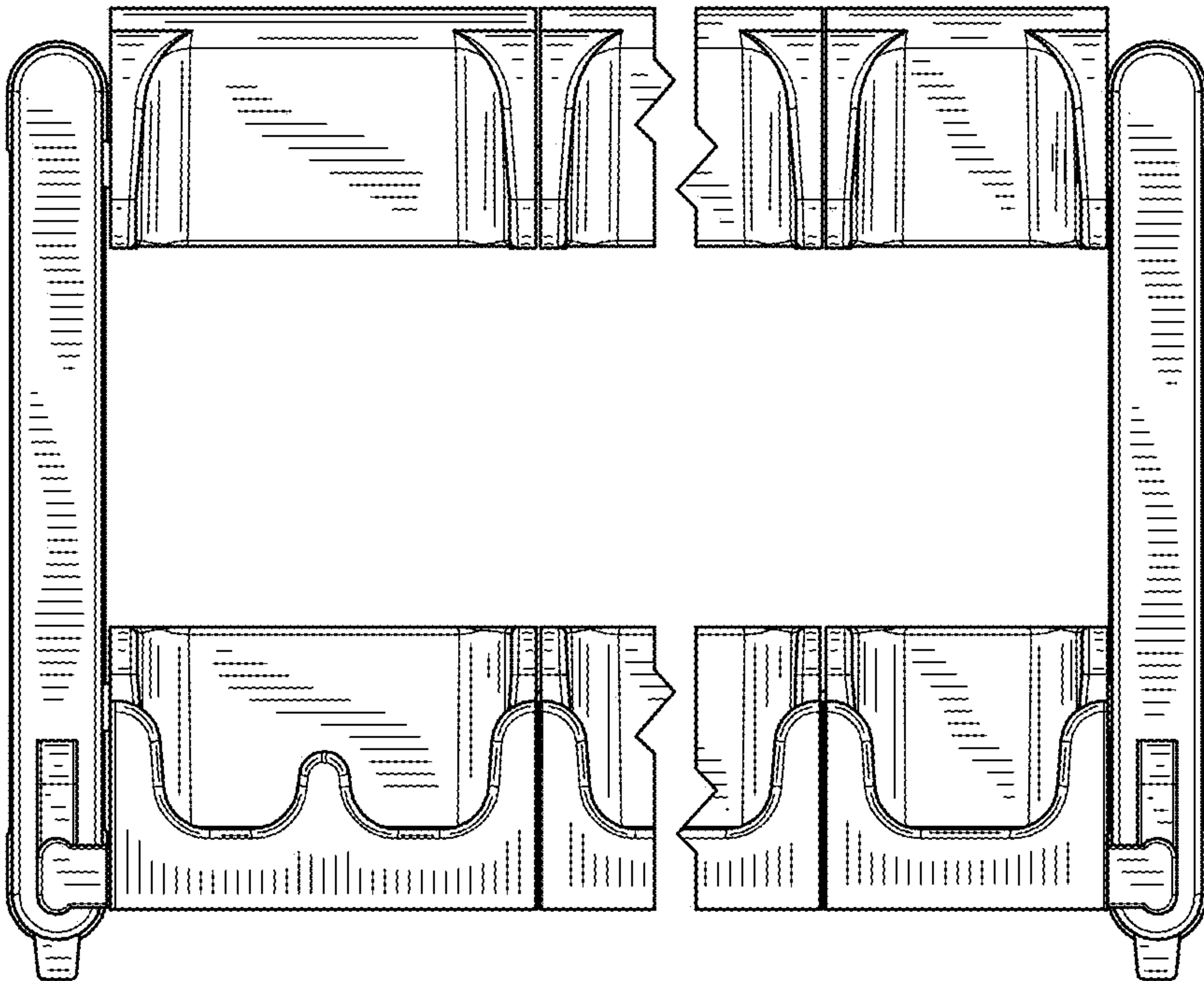

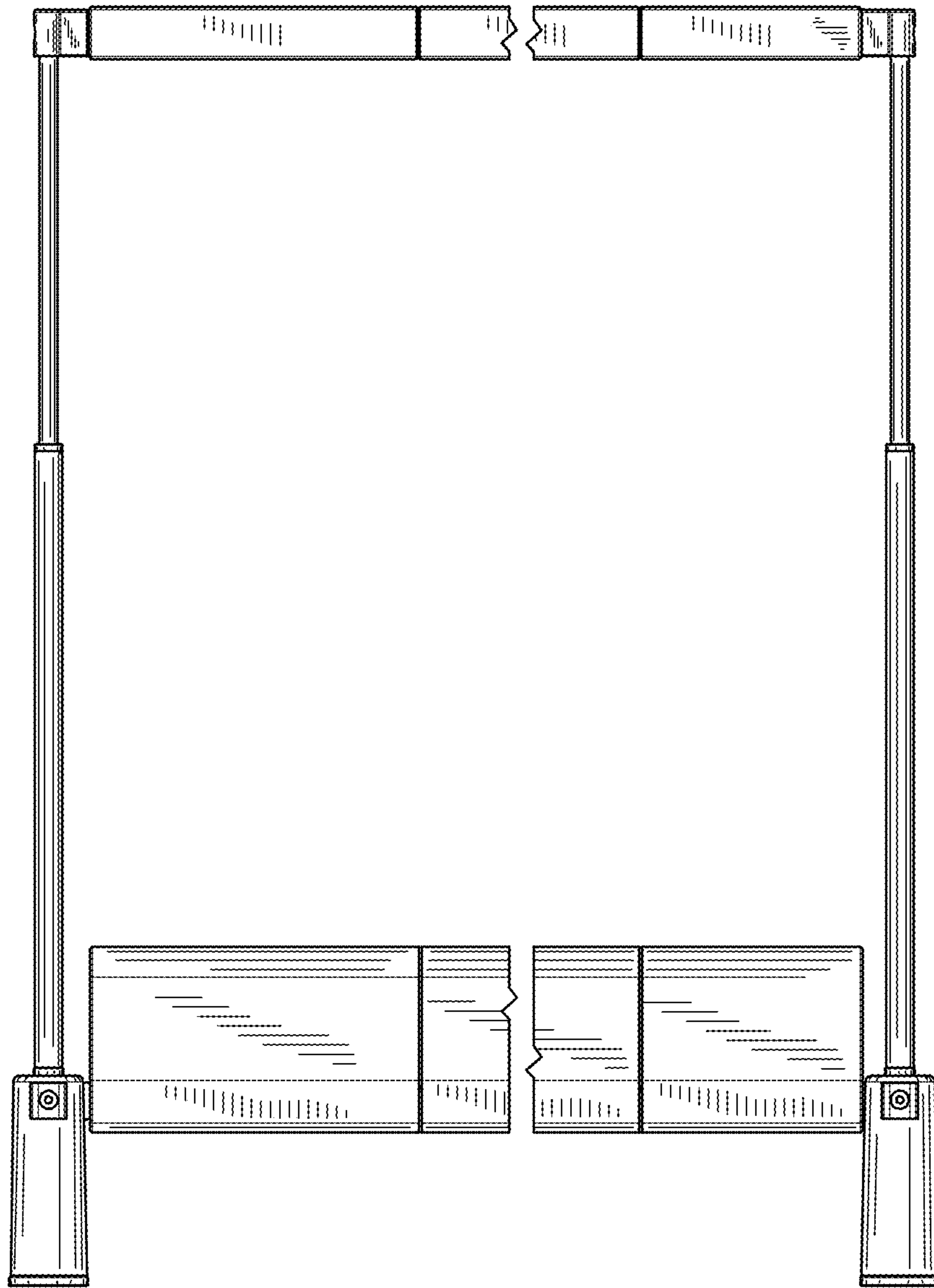

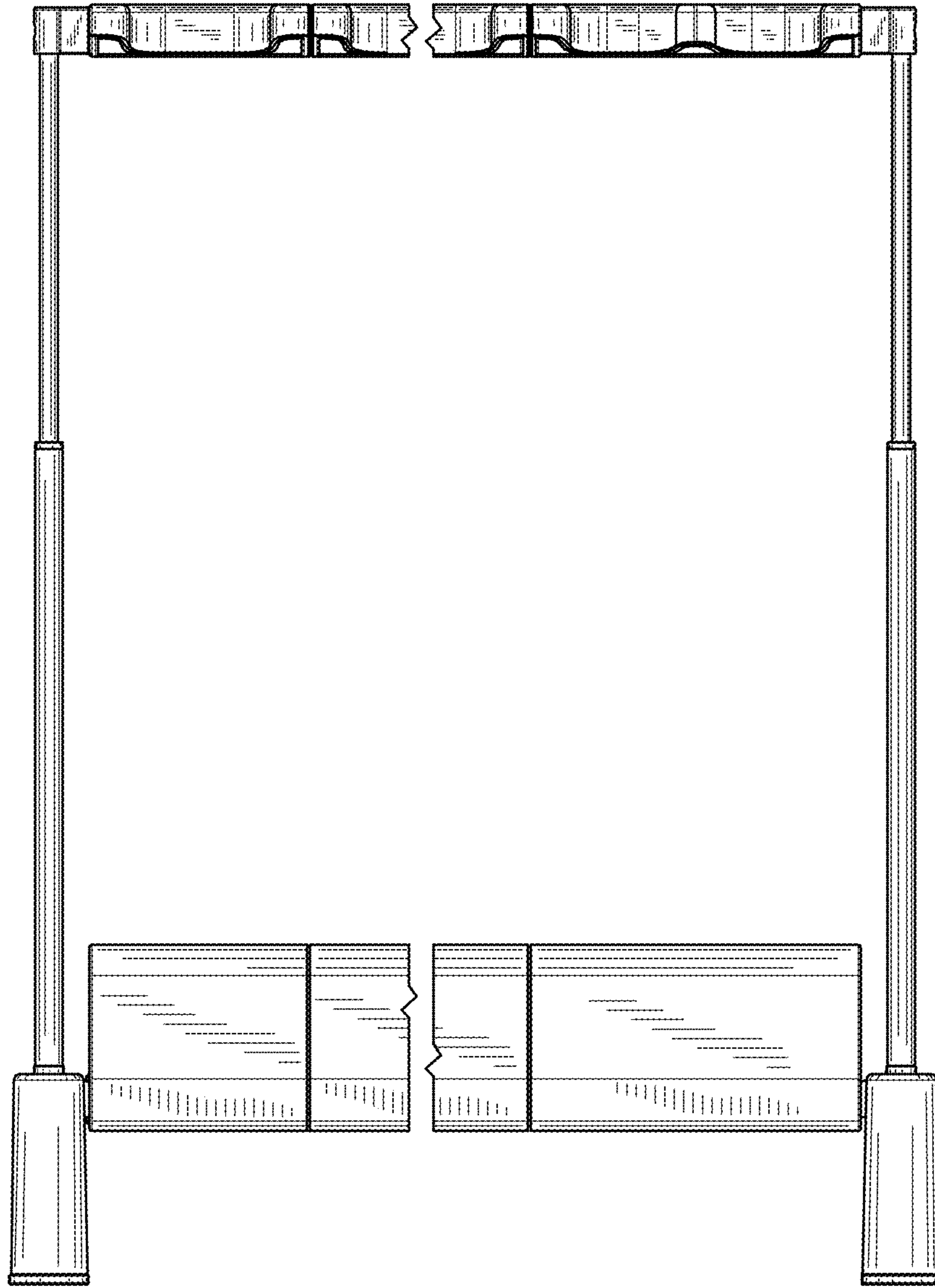

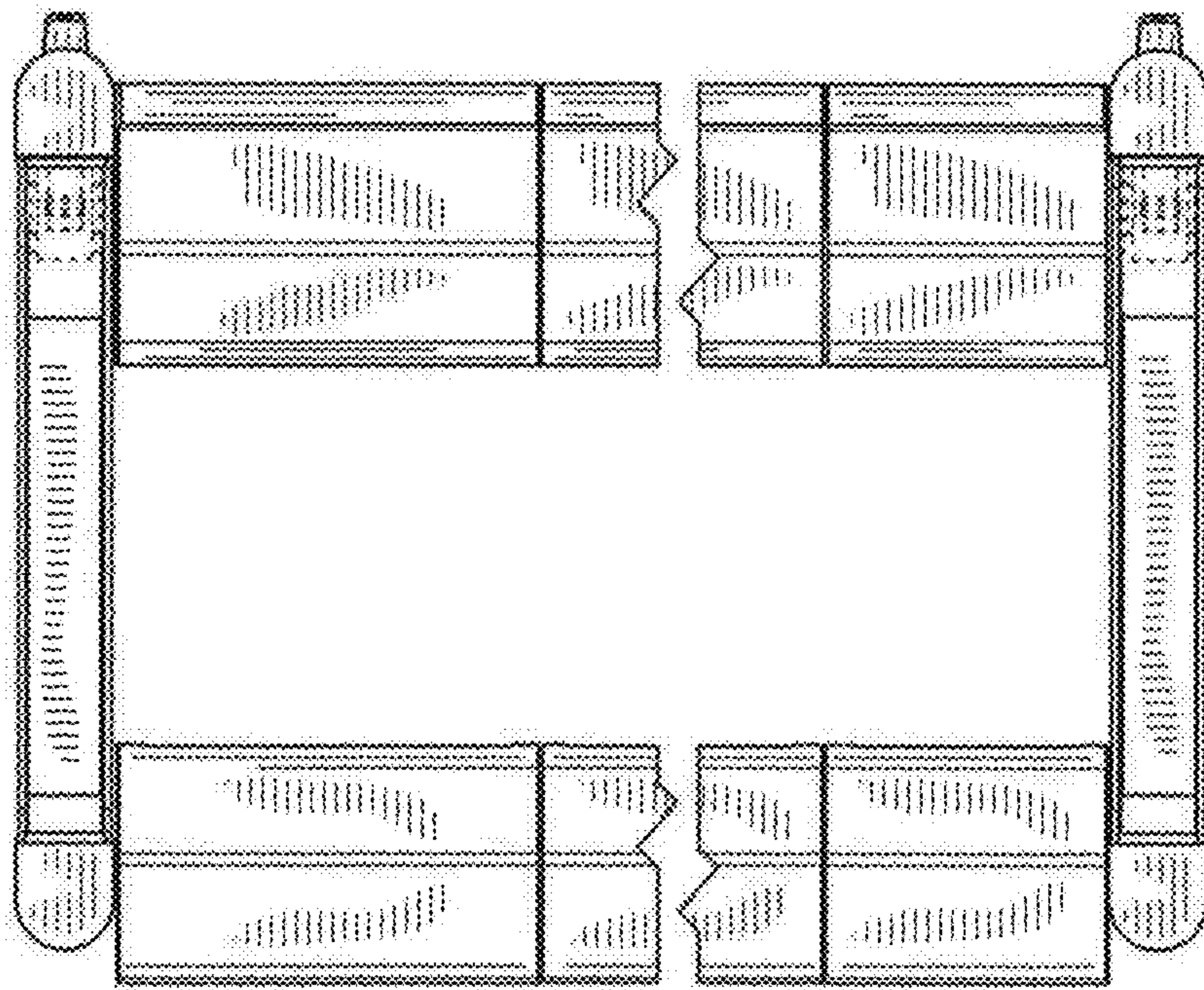

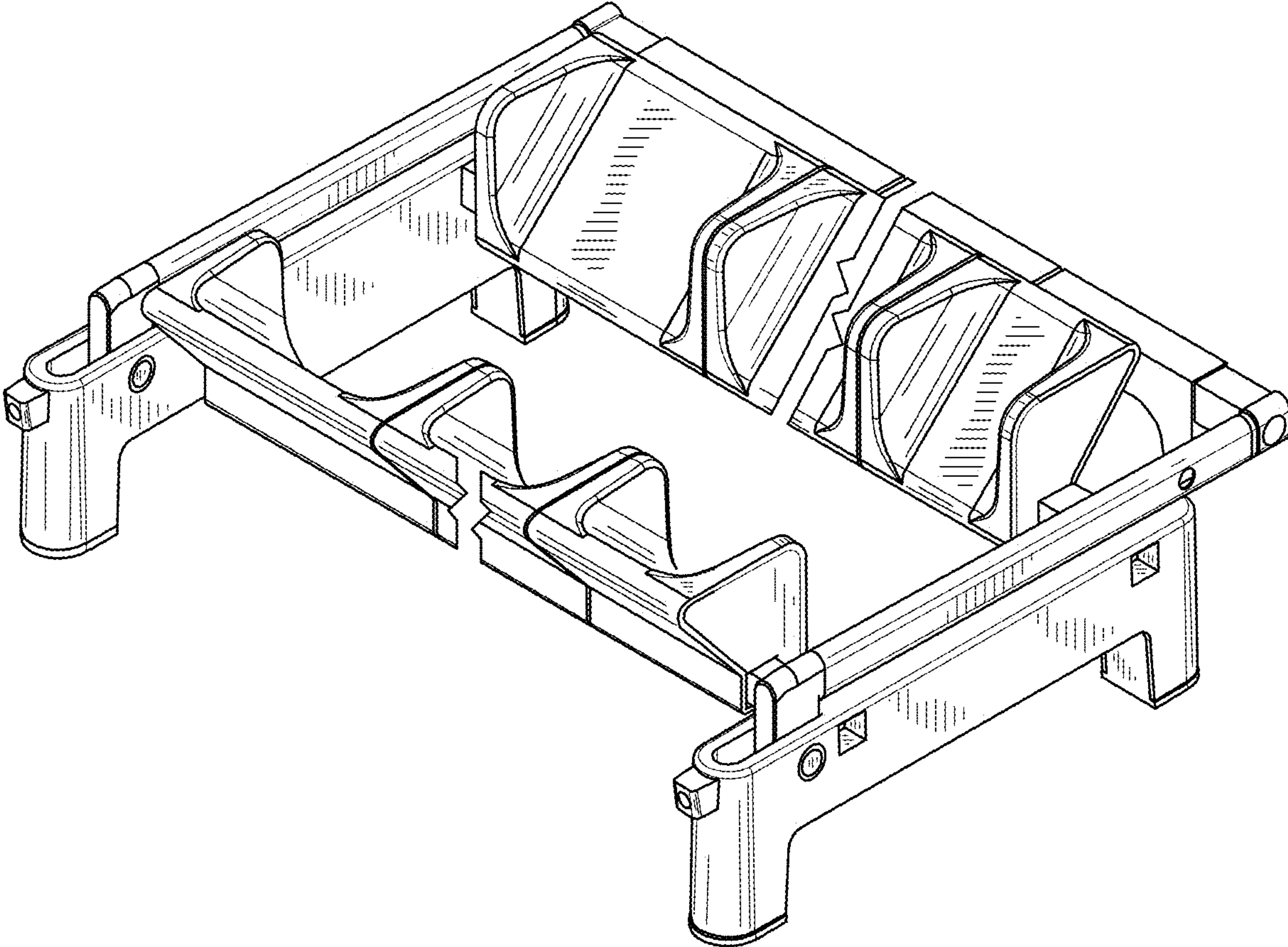

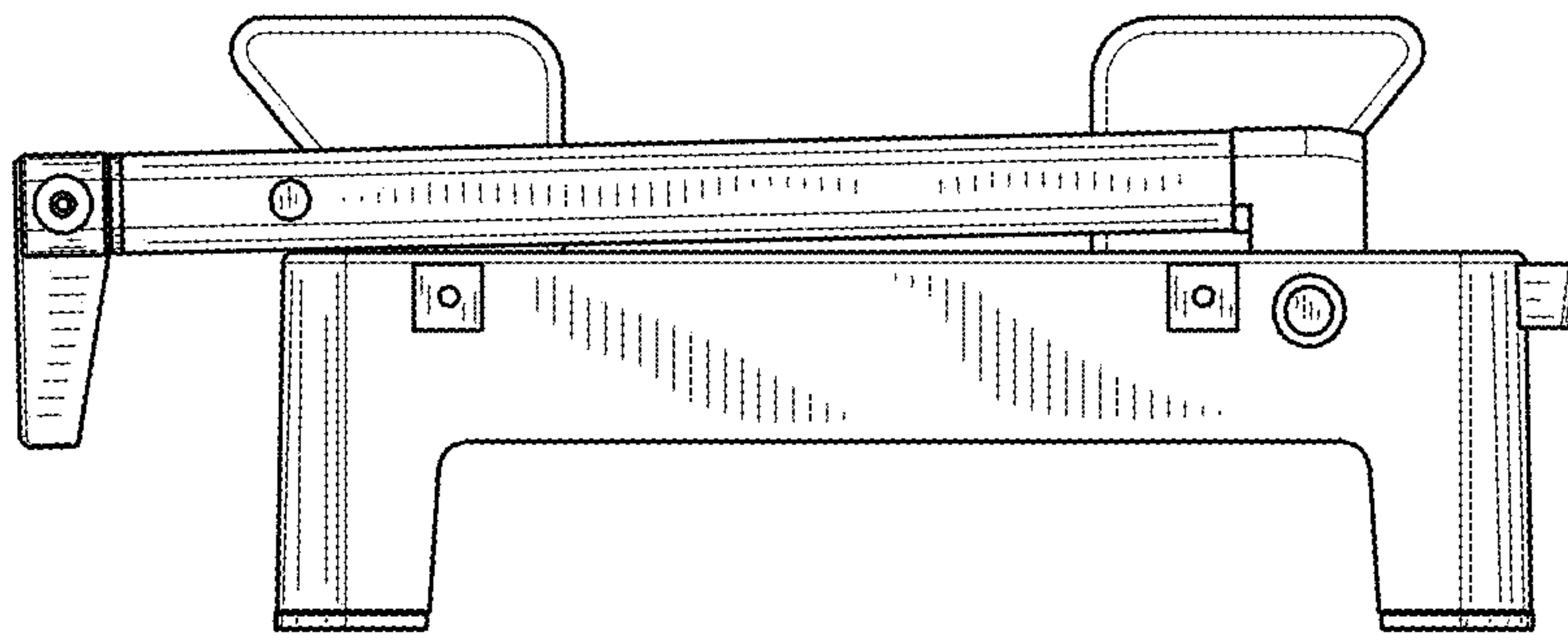

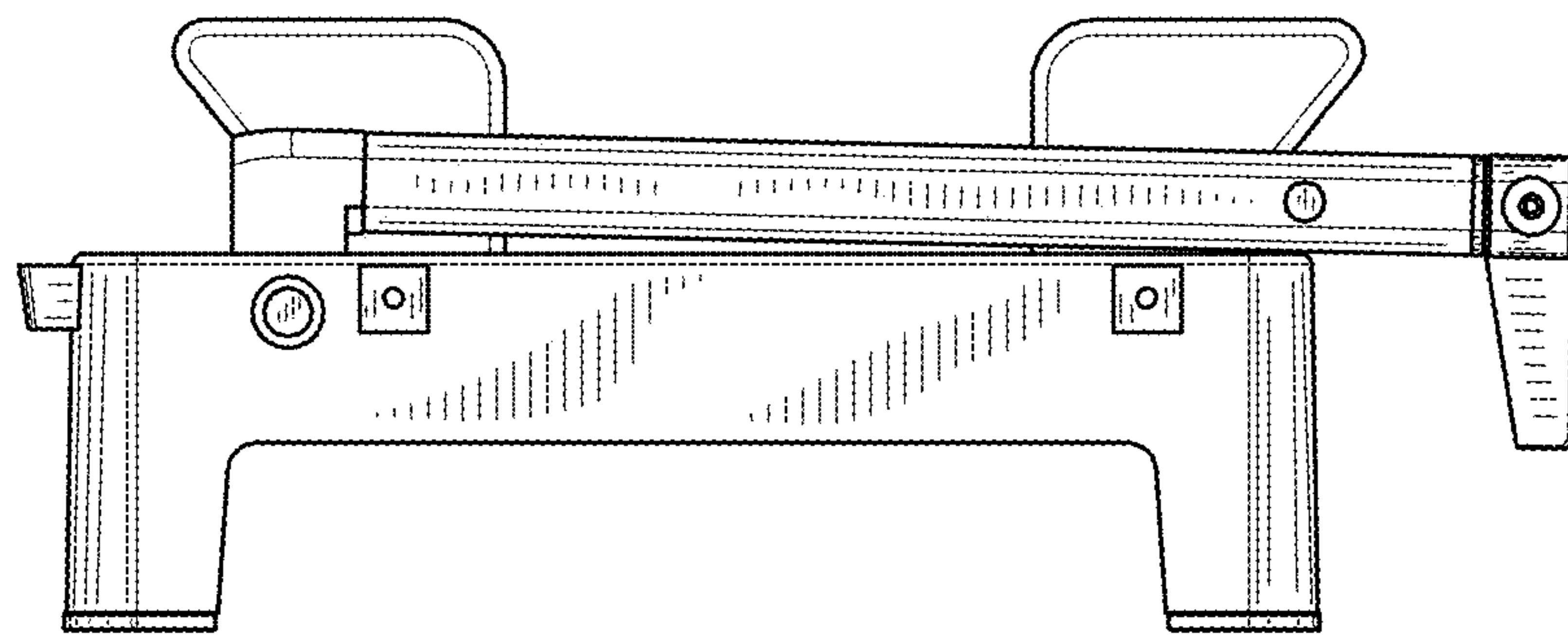

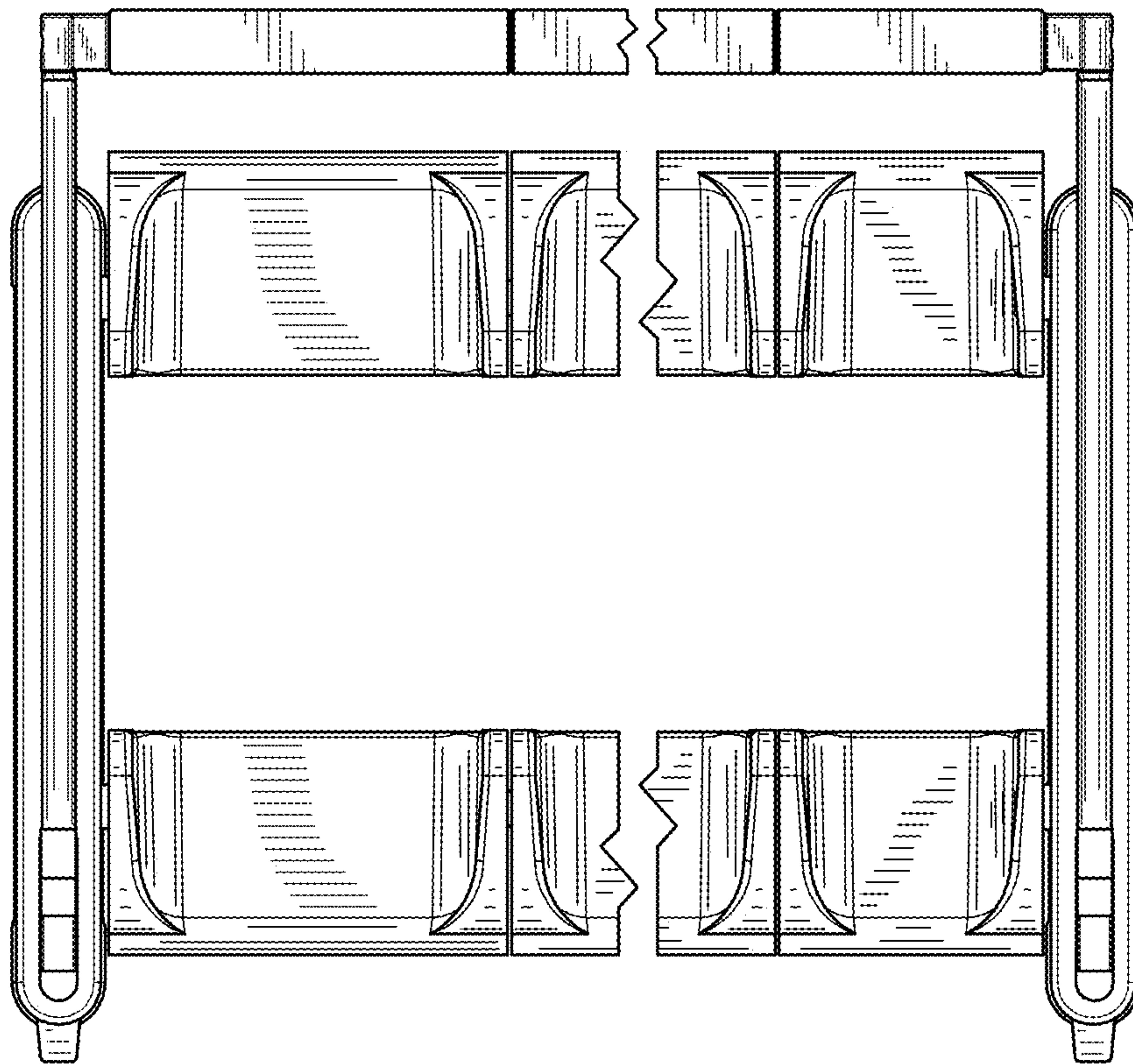

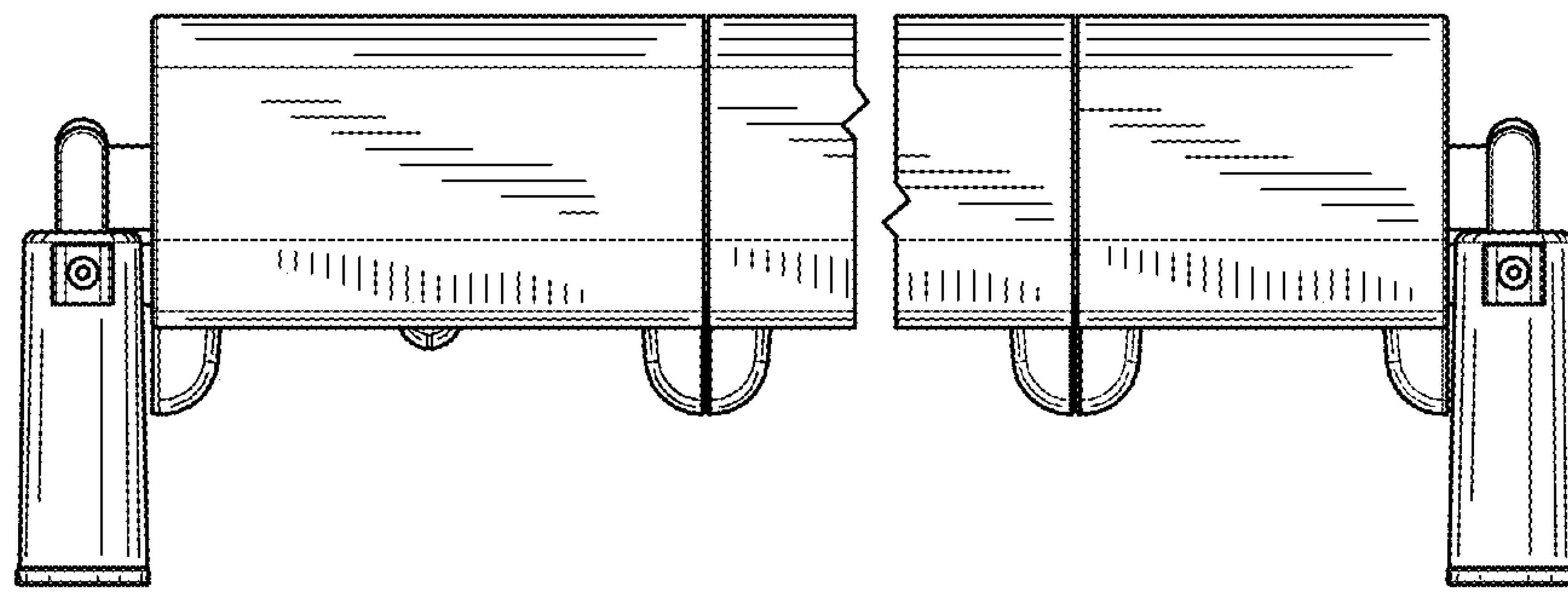

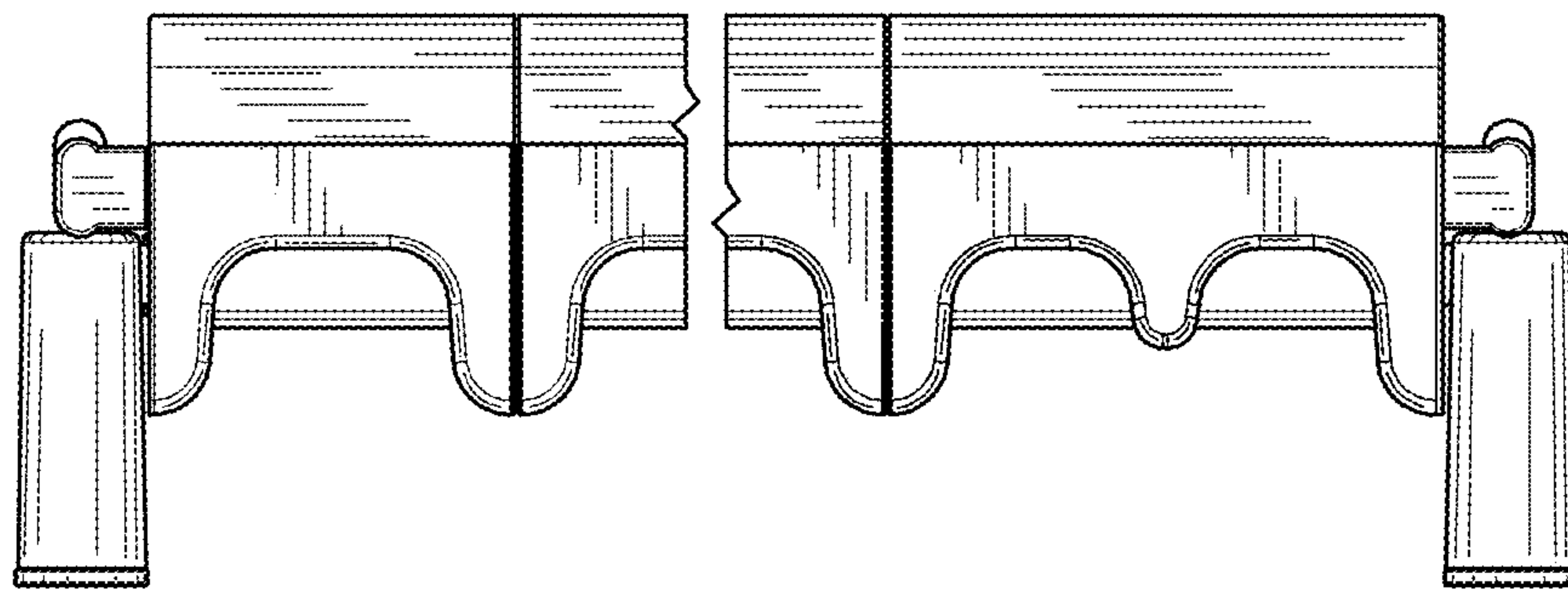

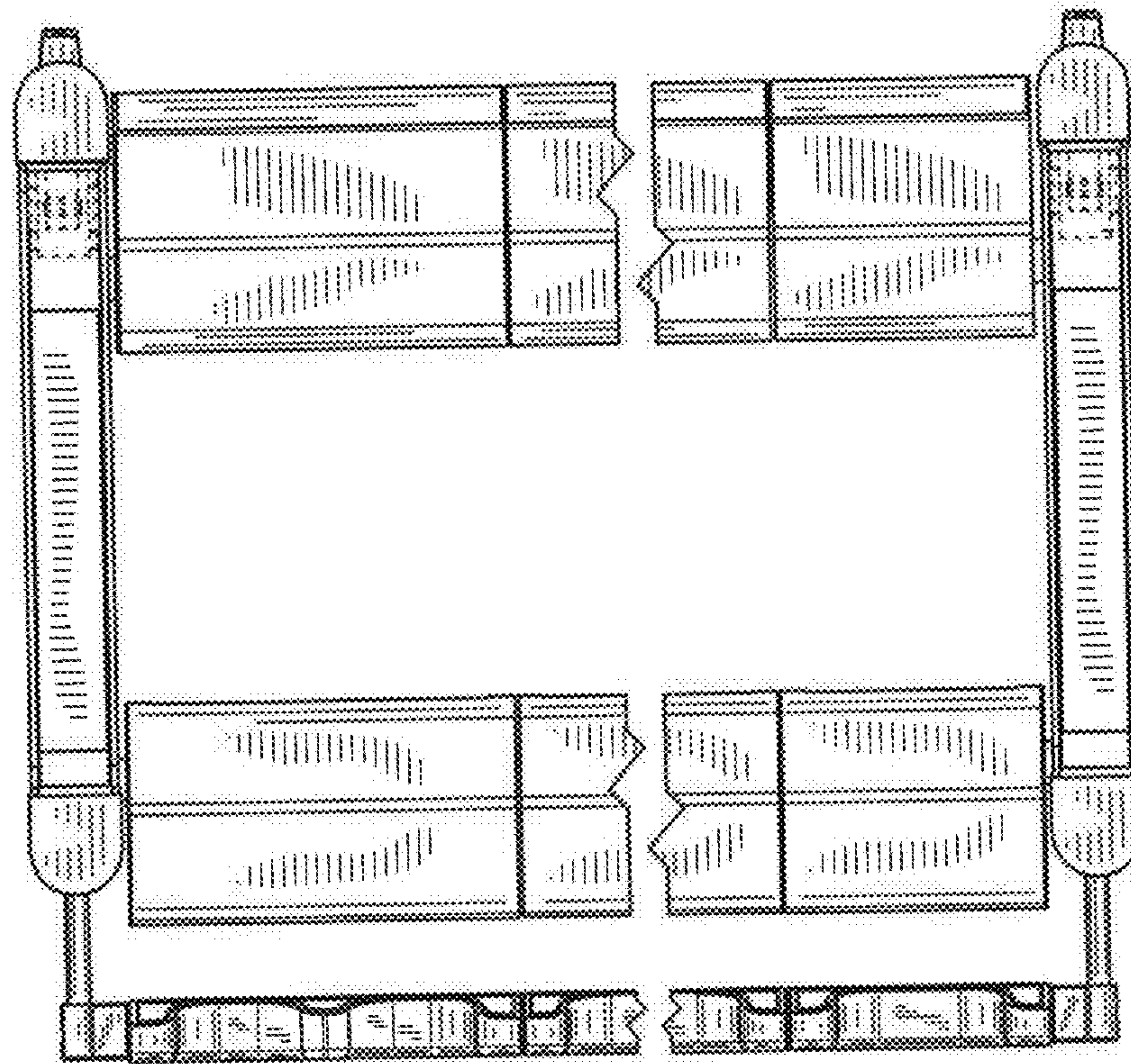
