(57) **CLAIM**

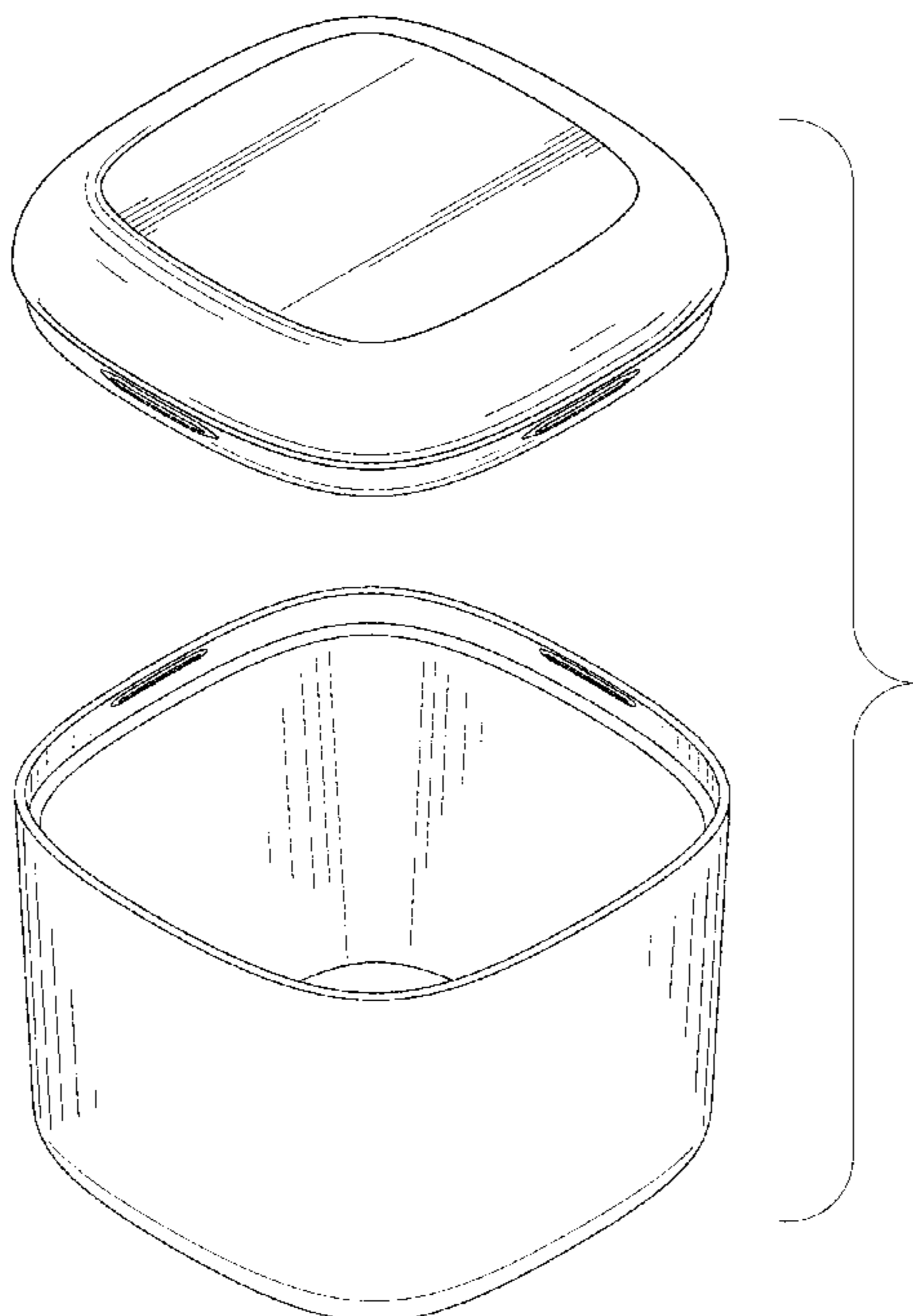
The ornamental design for a storage container, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, top perspective view of a storage container showing my new design;

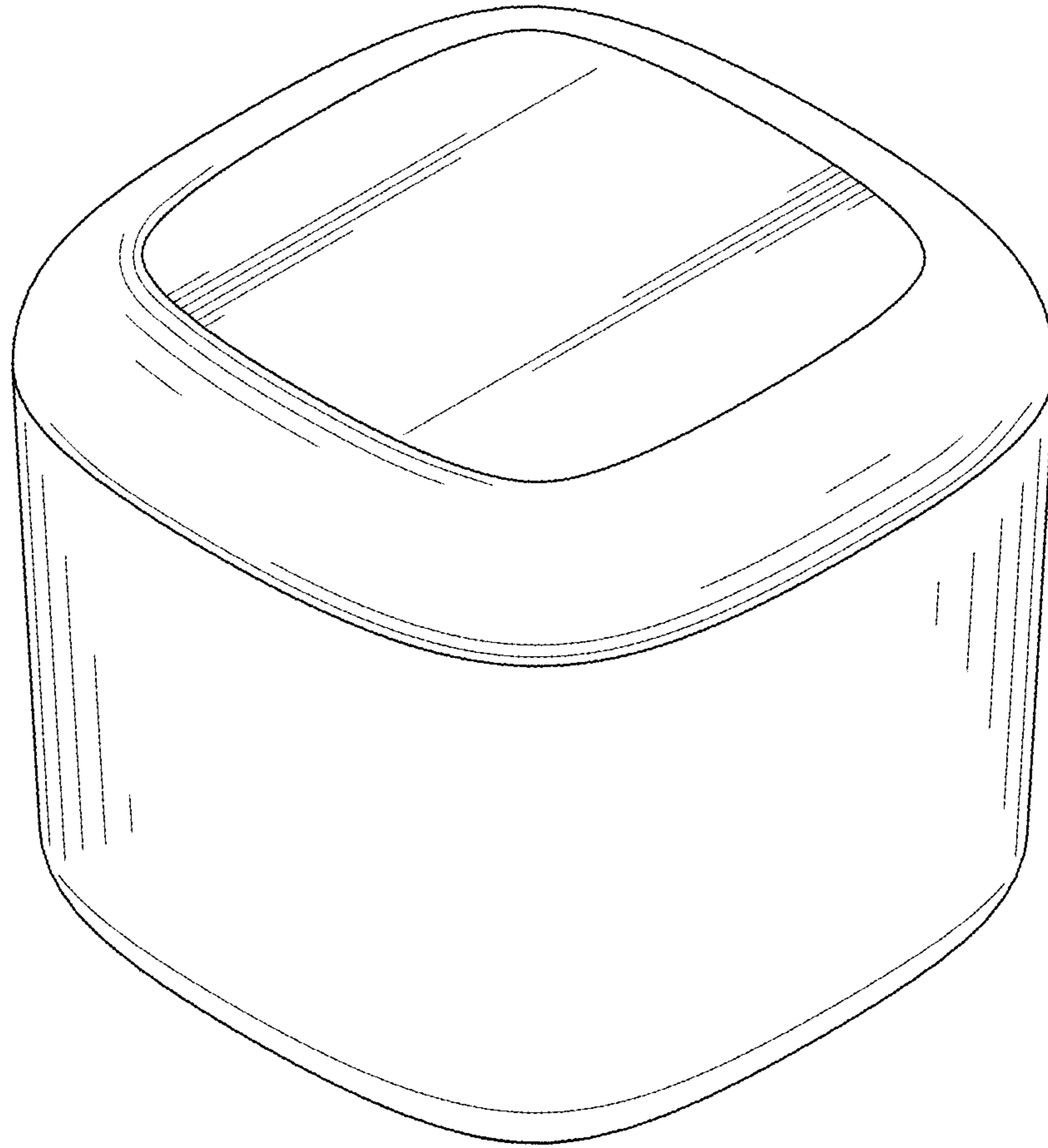

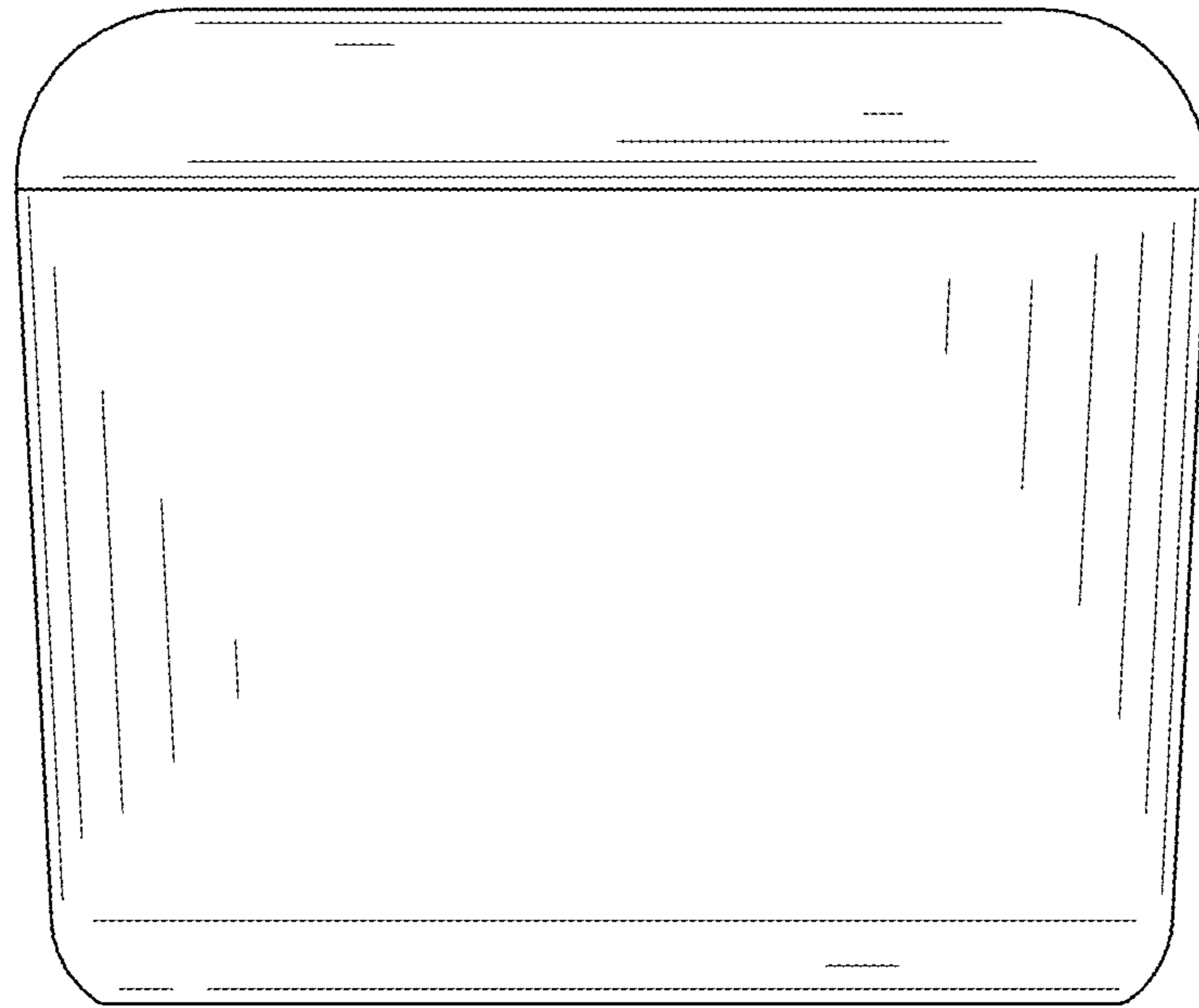

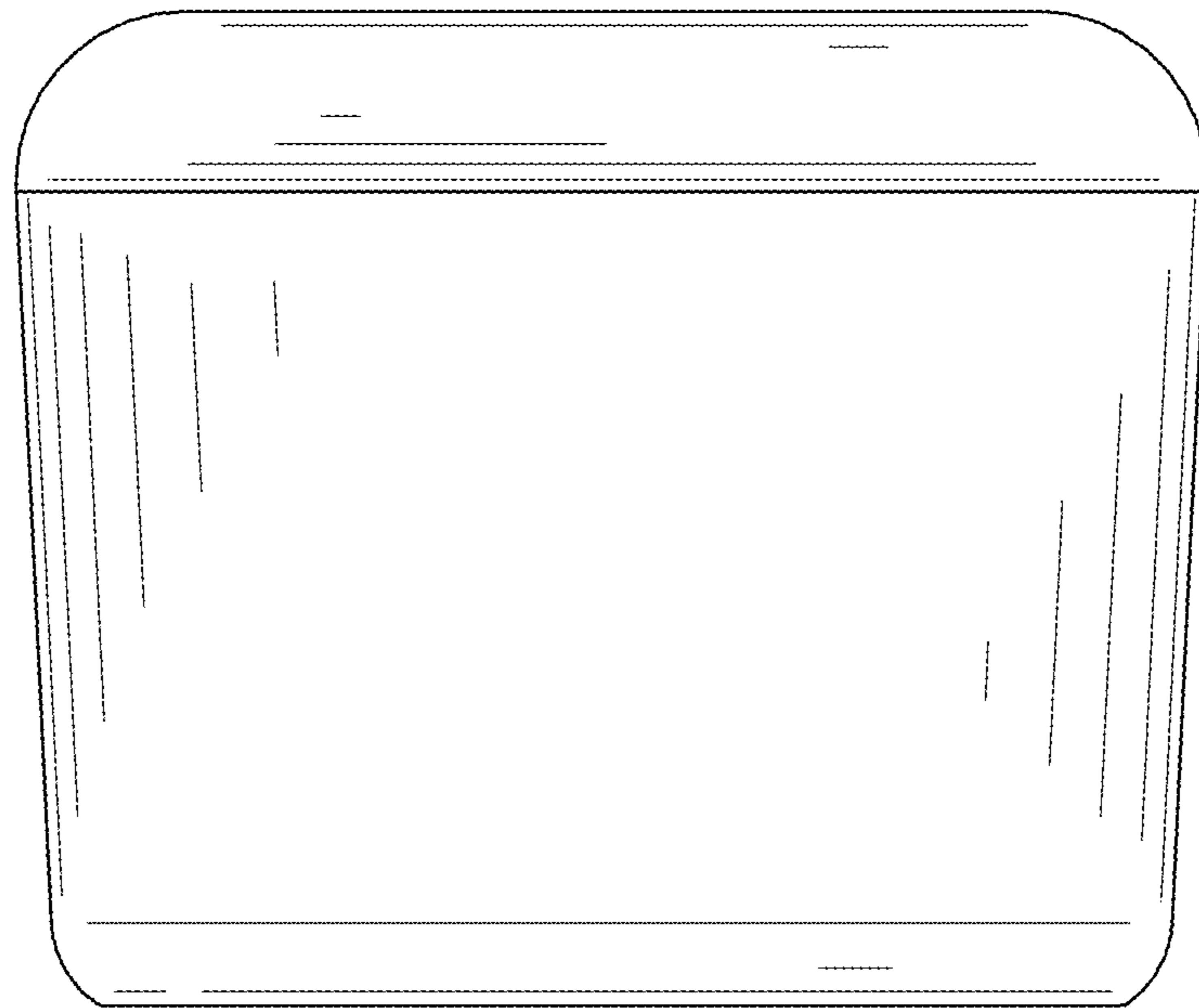

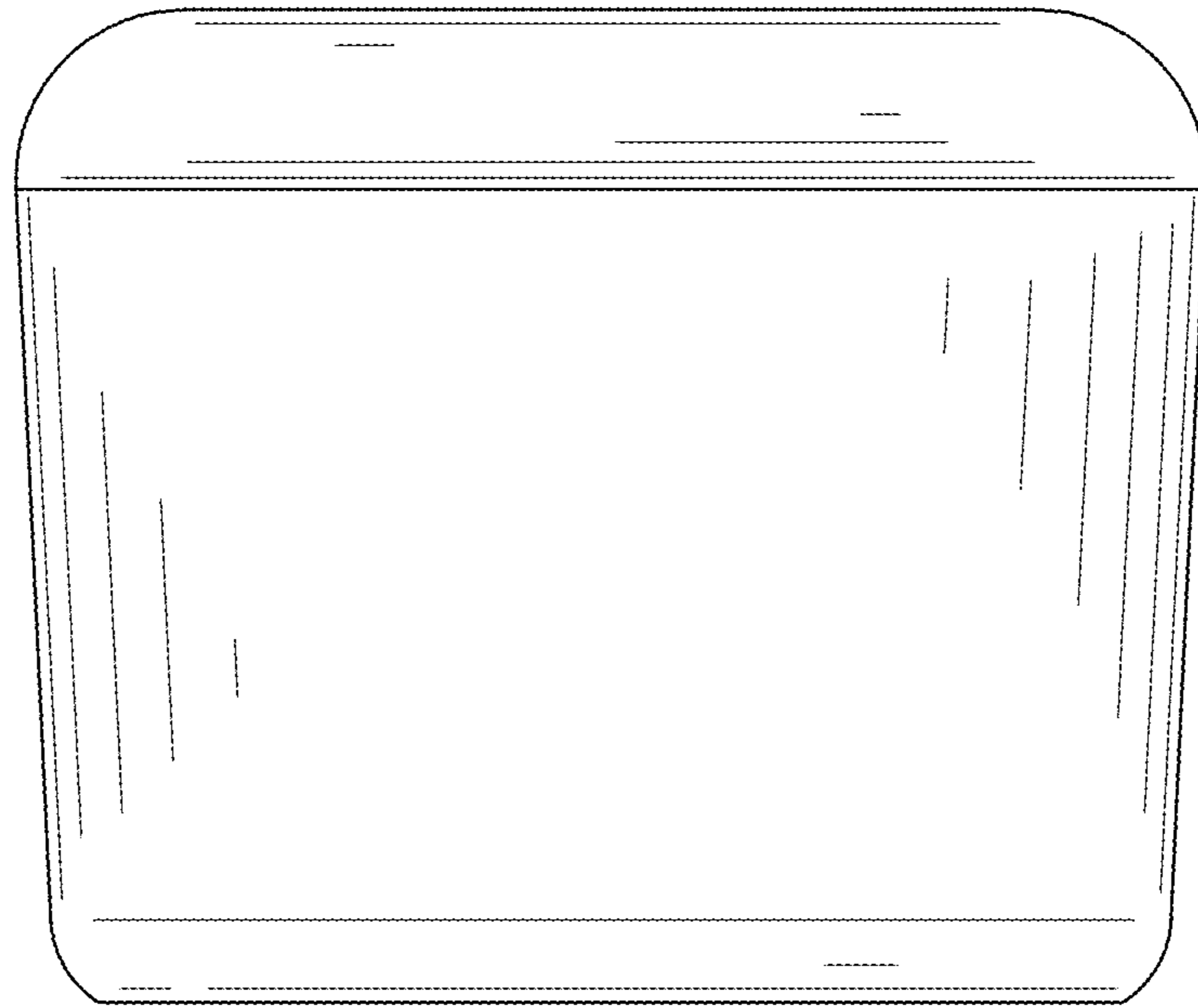

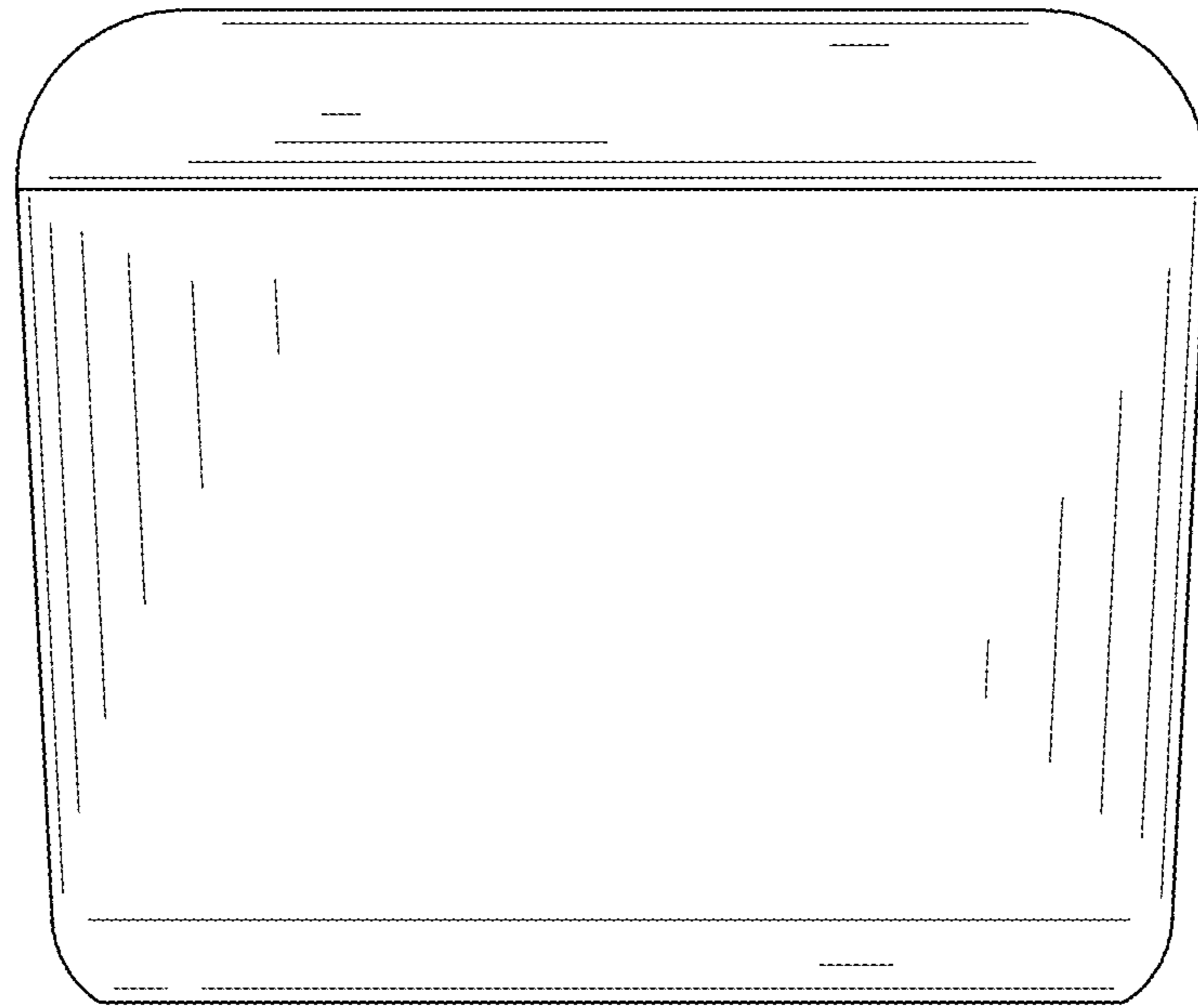

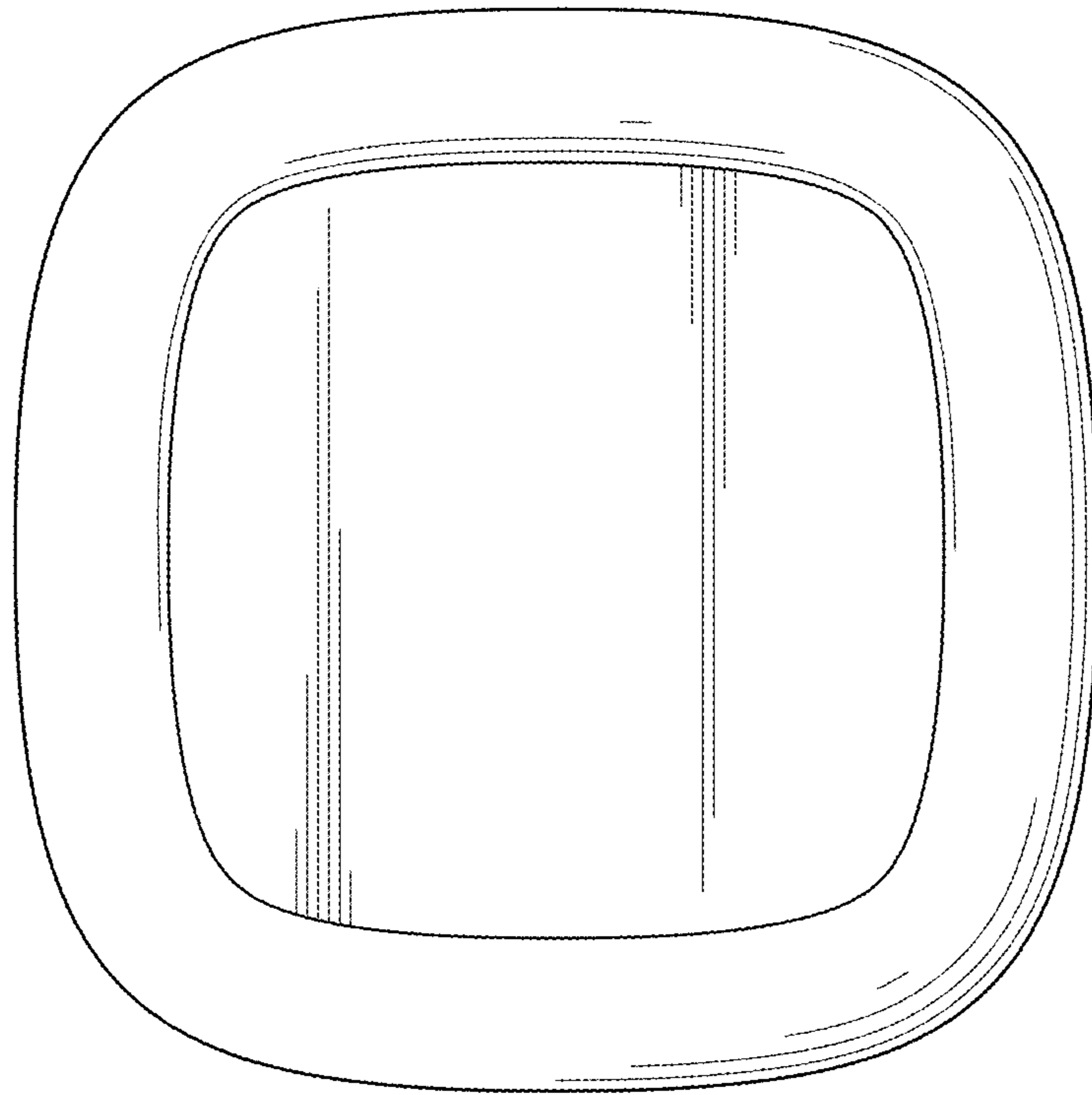

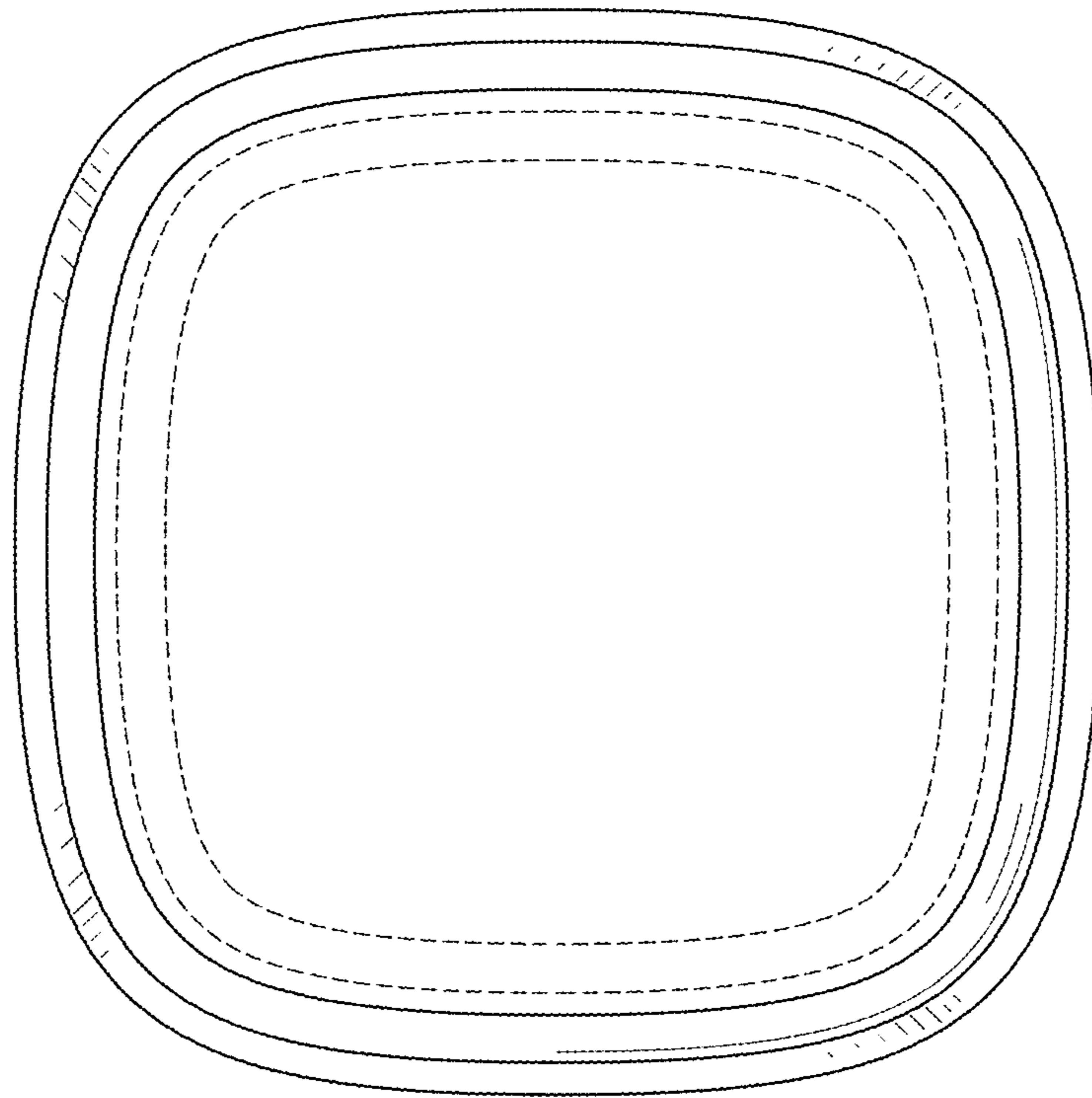

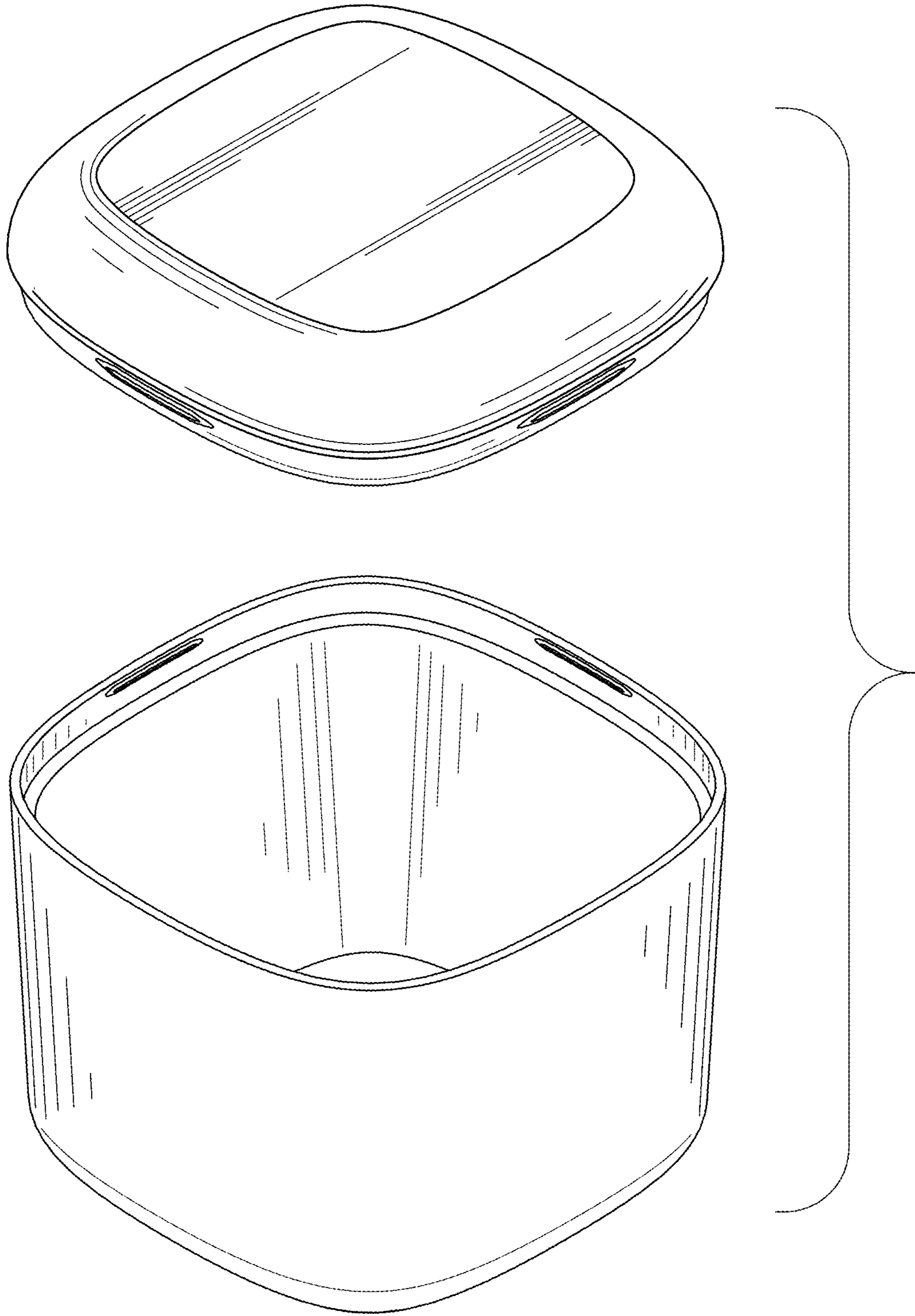
