(57) **CLAIM**

We claim the ornamental design for a cardboardless blister package for pills, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cardboardless blister package for pills of Applicant's design;

FIG. 2 is a front end elevational view thereof;

FIG. 3 is a rear end elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top end elevational view thereof;

FIG. 7 is a bottom end elevational view thereof;

FIG. 8 is a partial sectional view thereof, taken along line 8-8 in FIG. 2;

FIG. 9 is a front perspective view of a second embodiment of a cardboardless blister package for pills of Applicant's design;

FIG. 20 is a left side elevational view thereof;

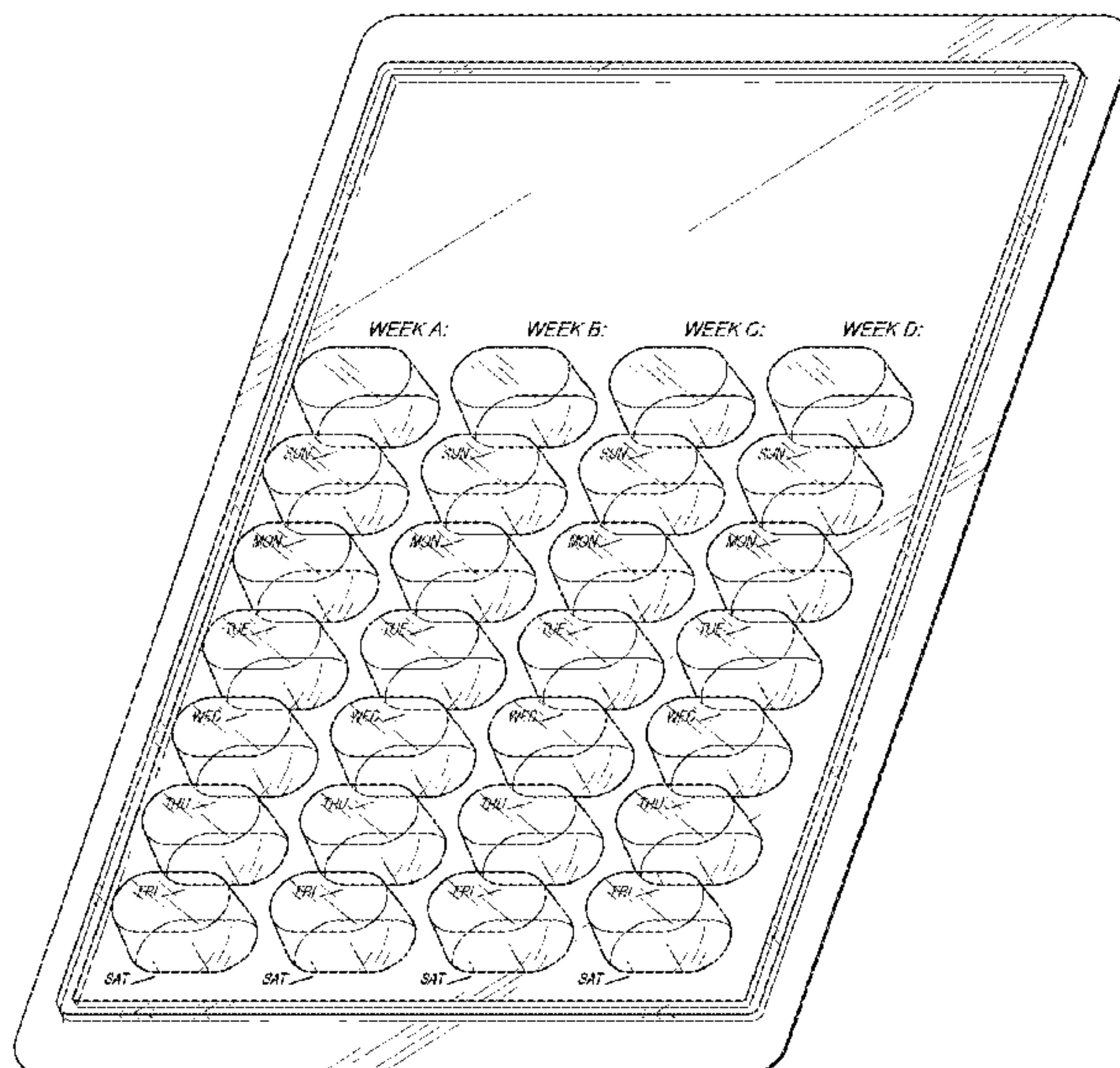
FIG. 21 is a right side elevational view thereof;

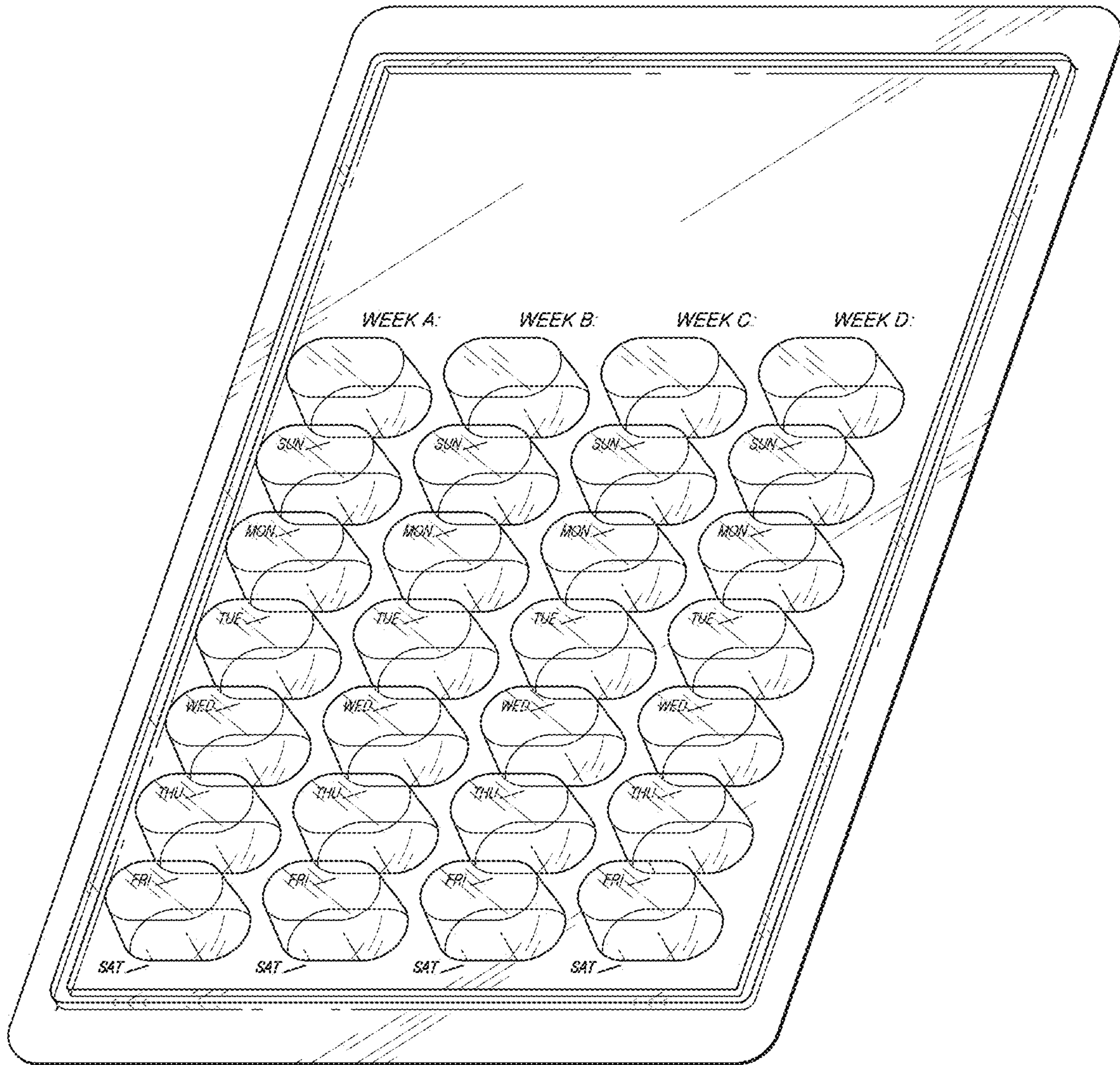

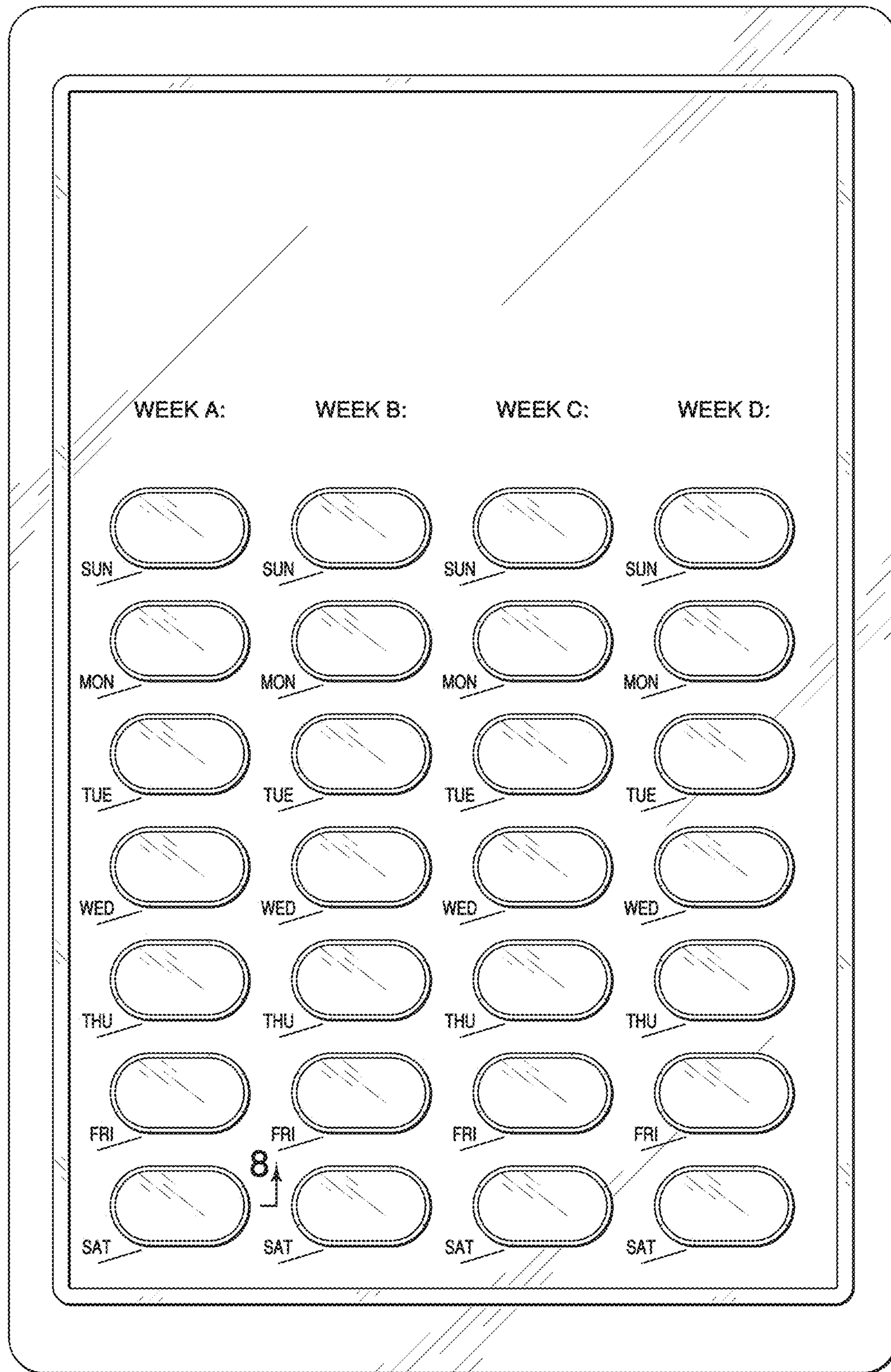

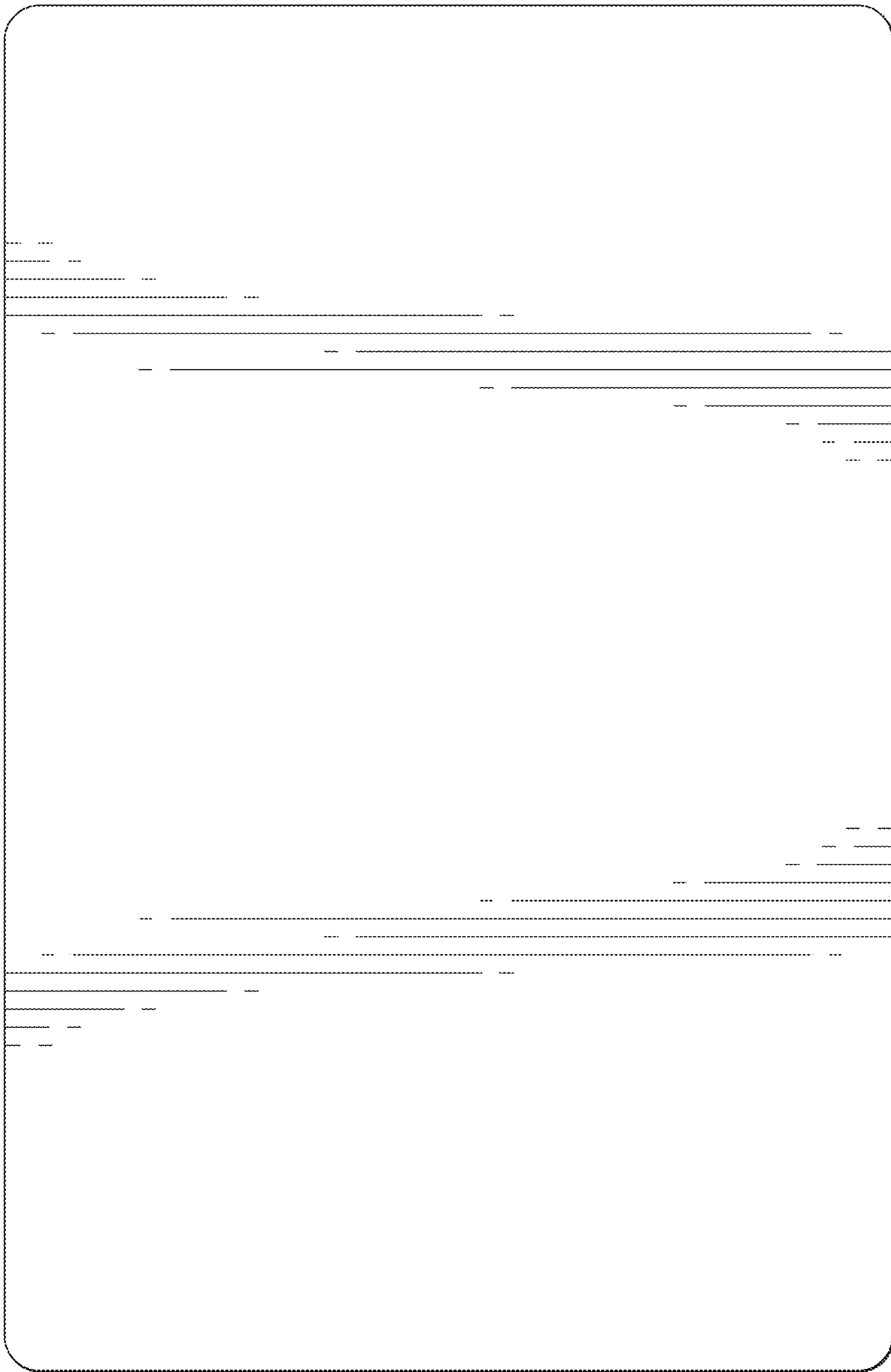

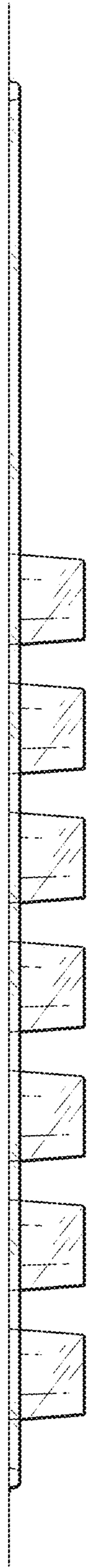

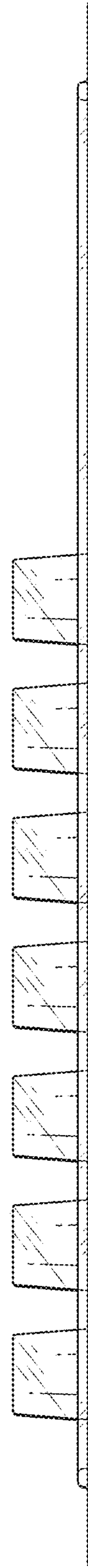

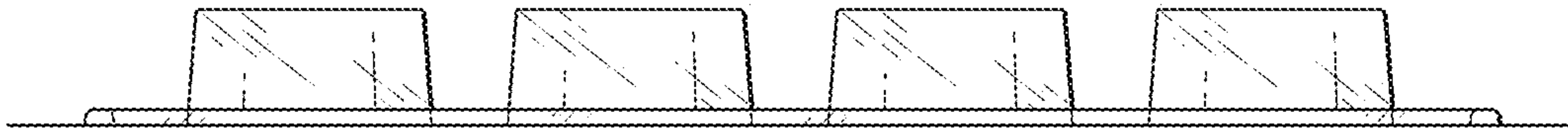

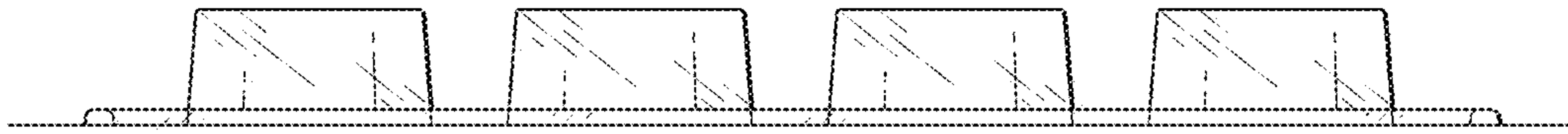

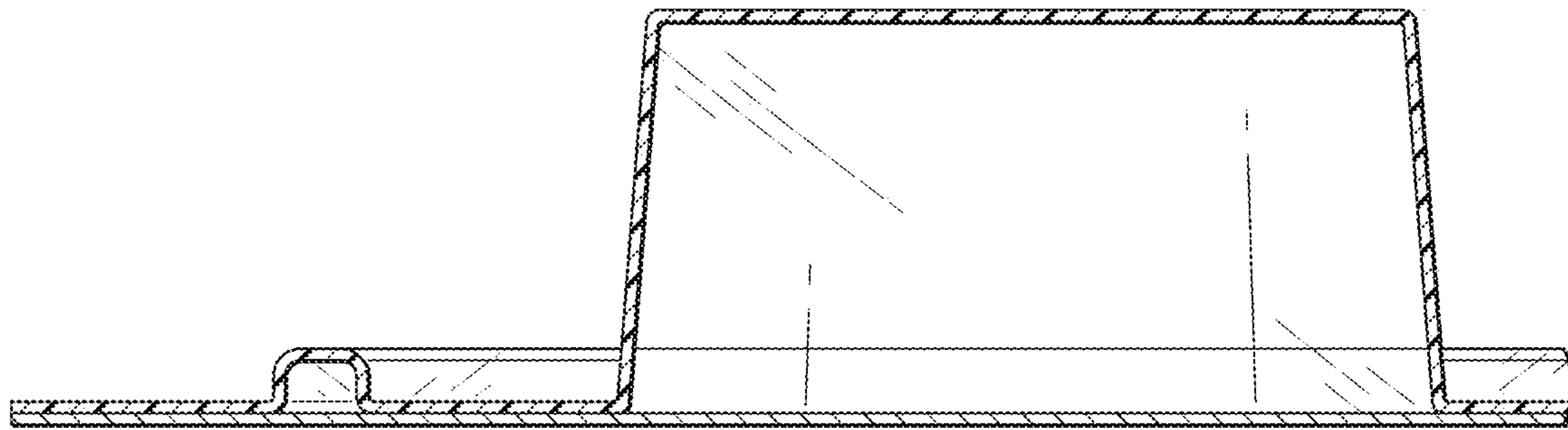

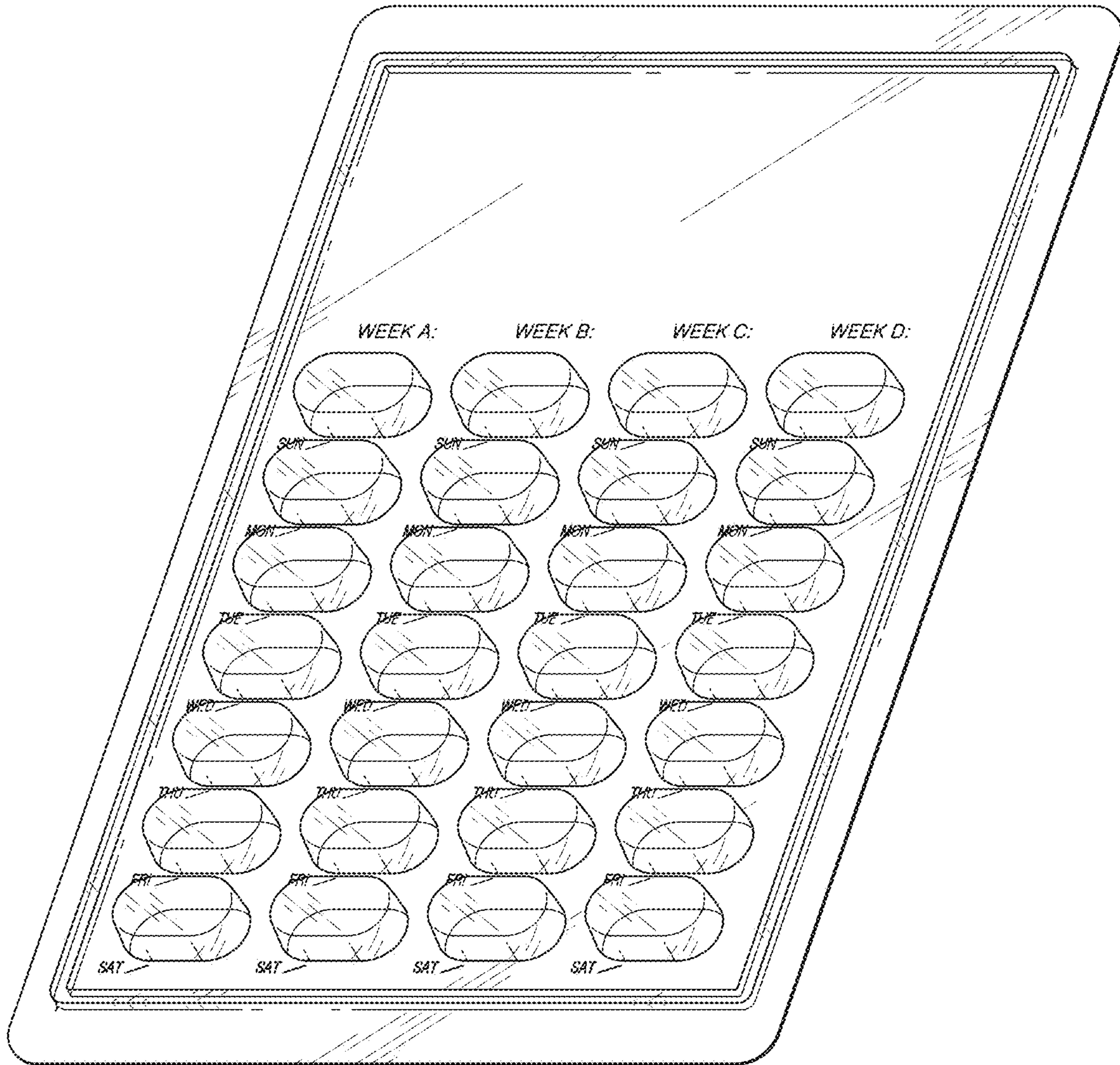

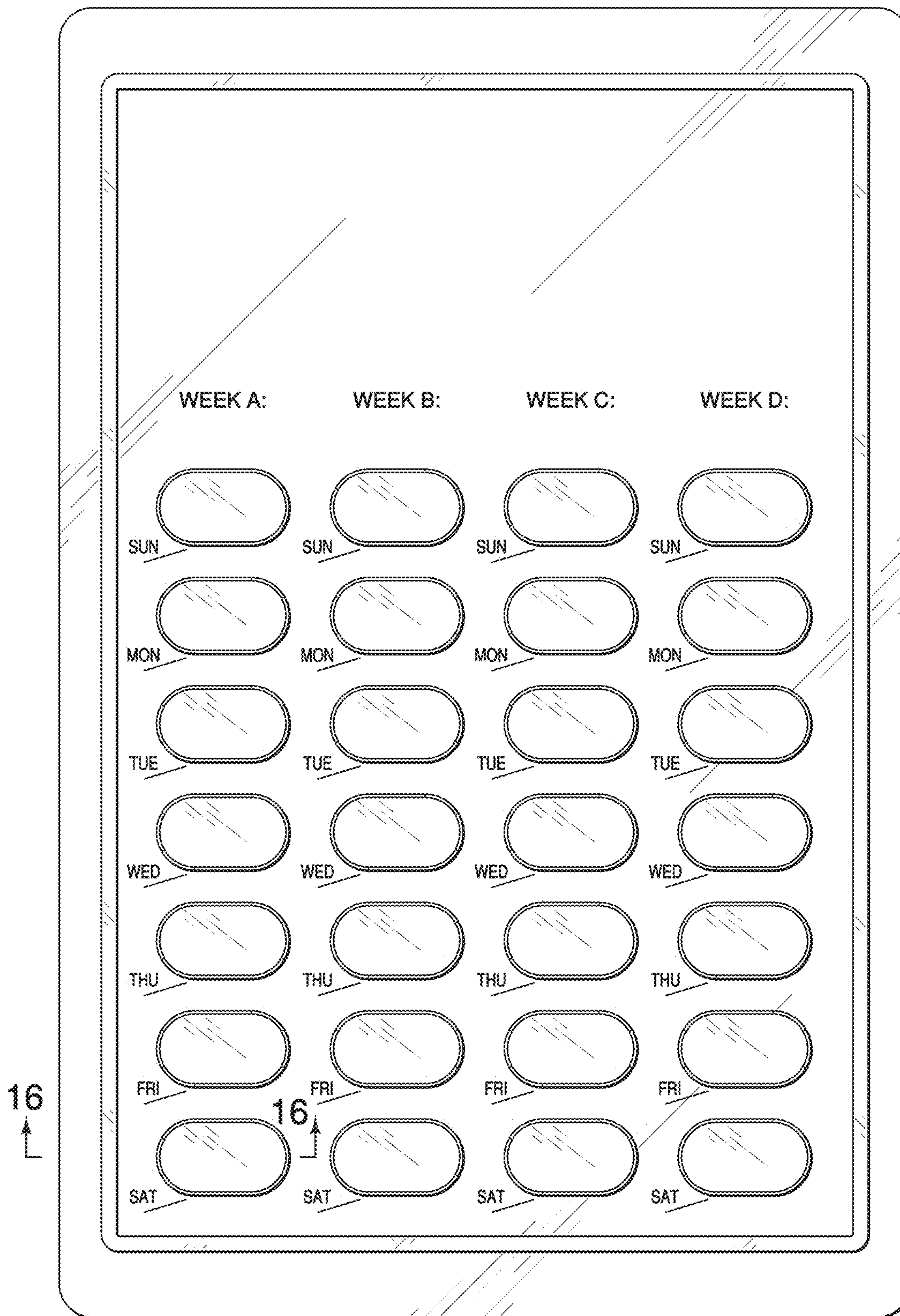

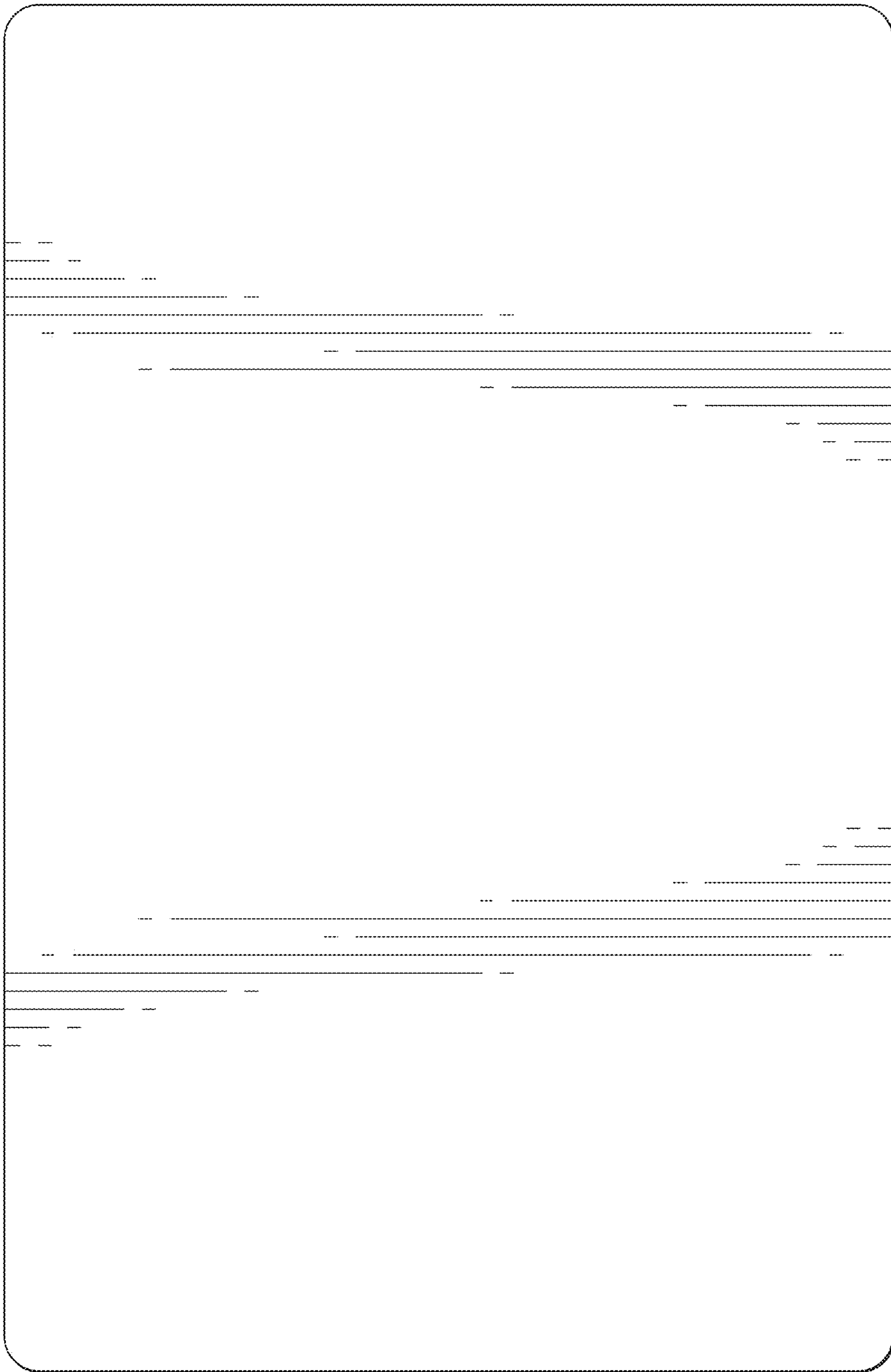

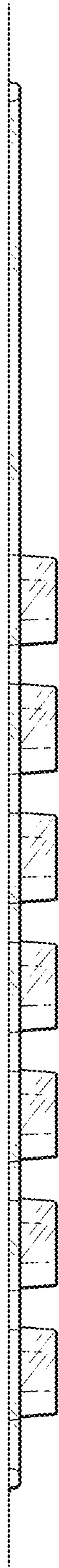

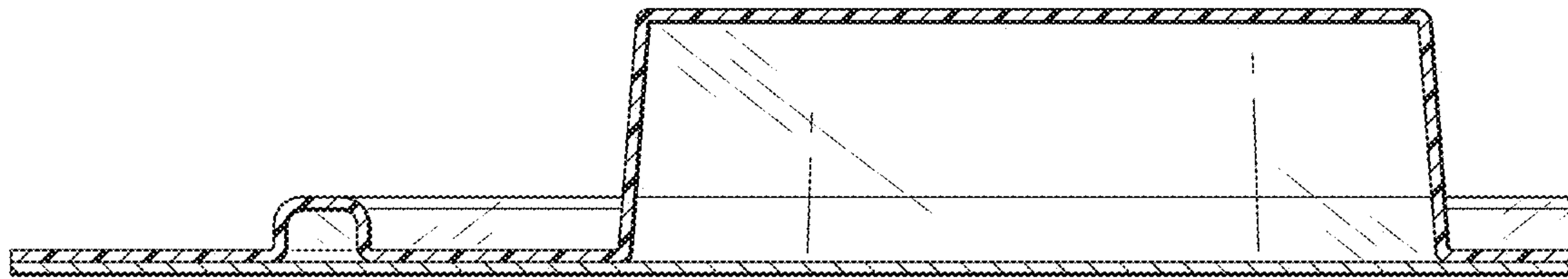

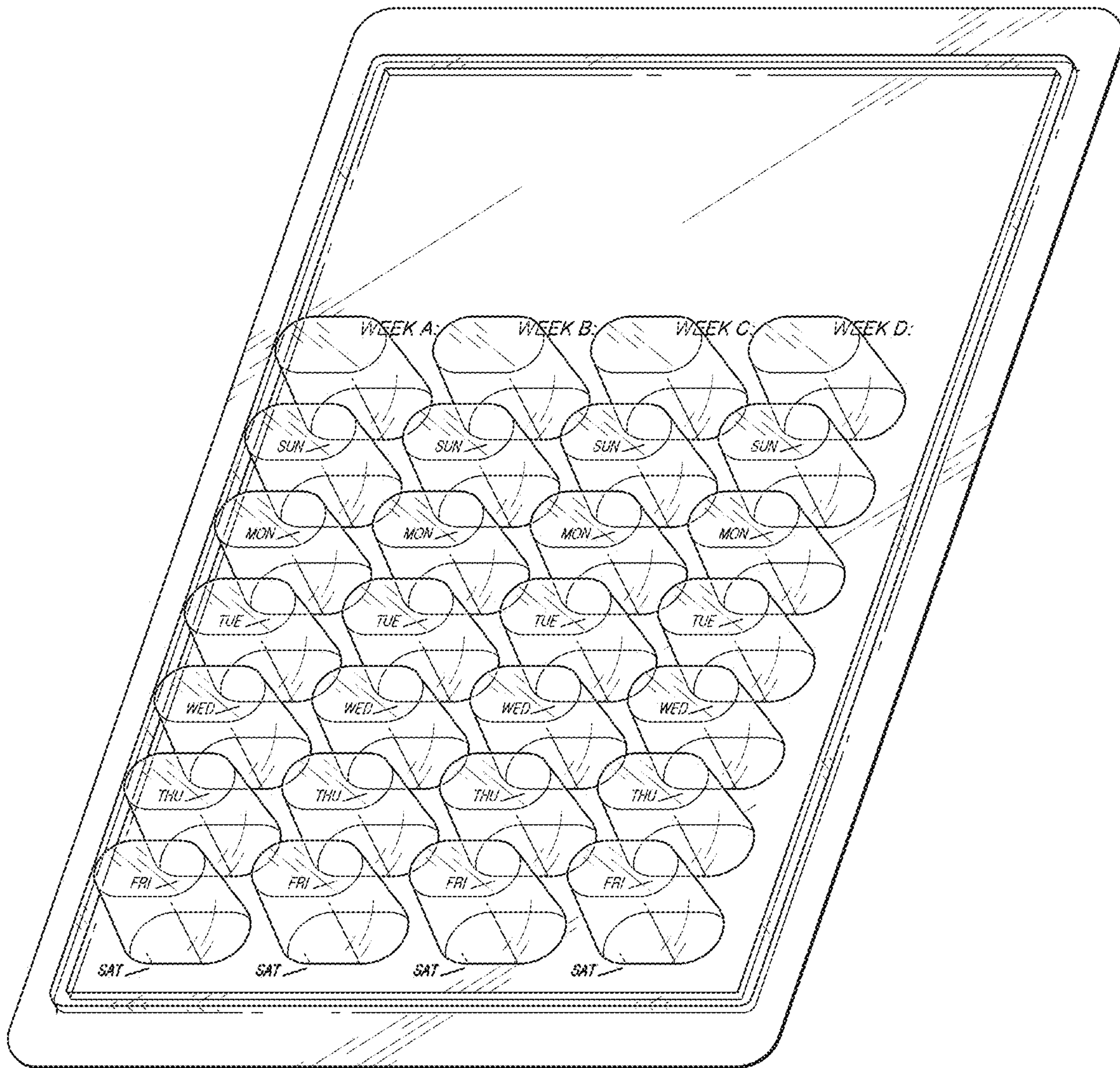

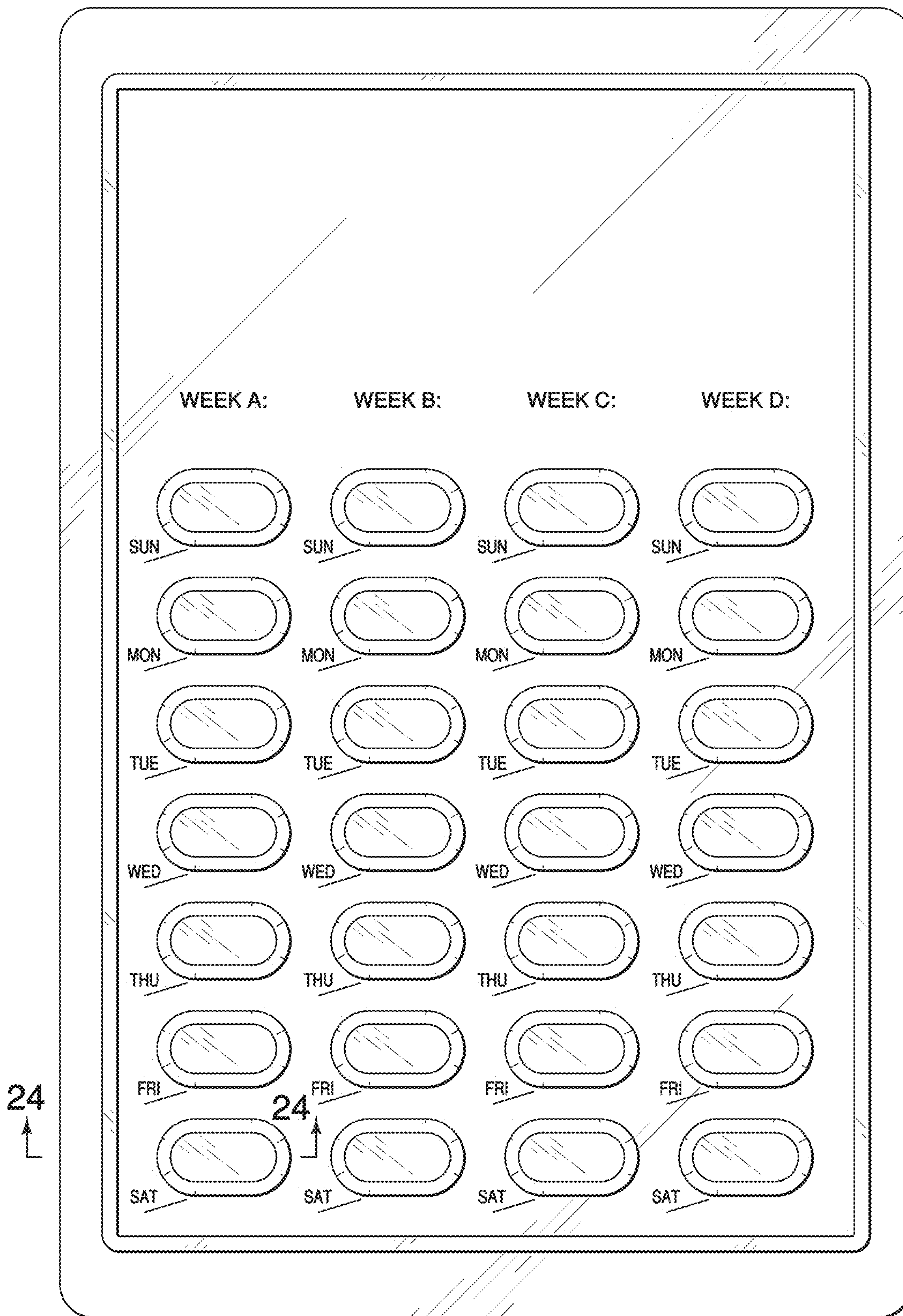

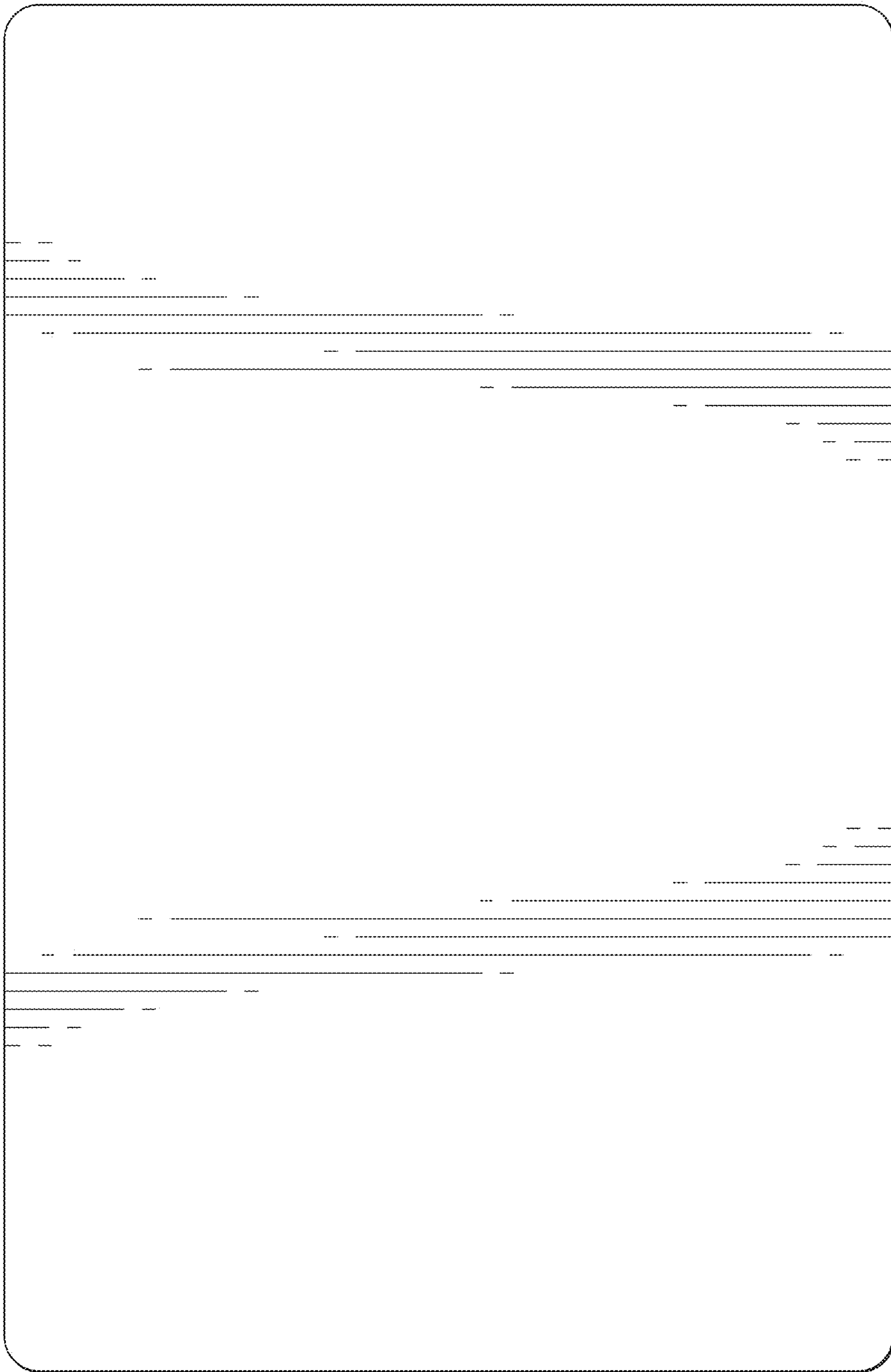

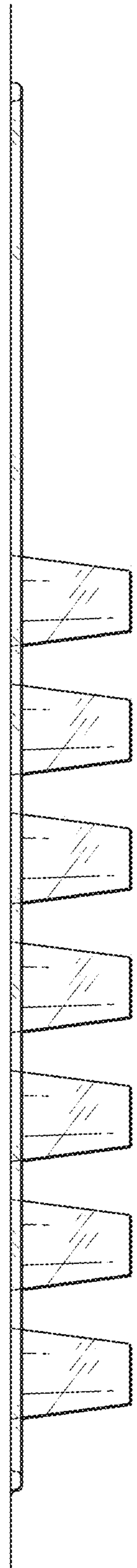

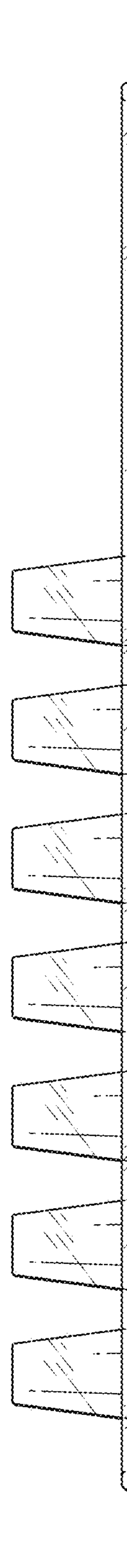

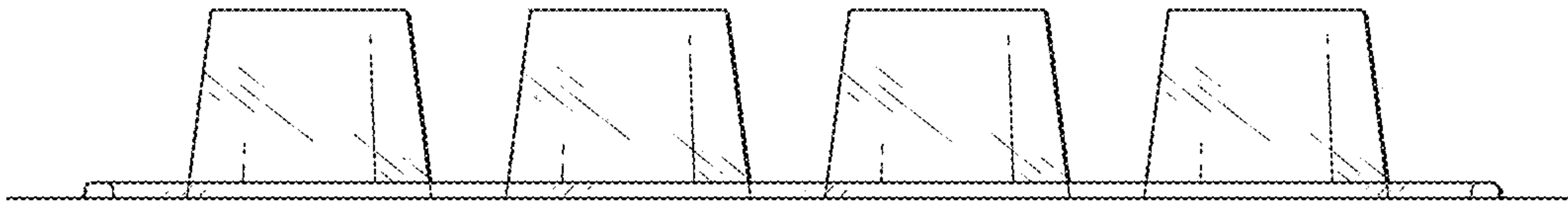

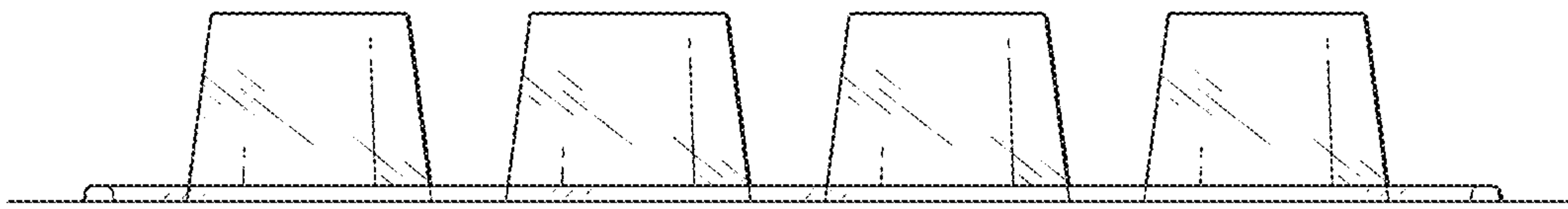

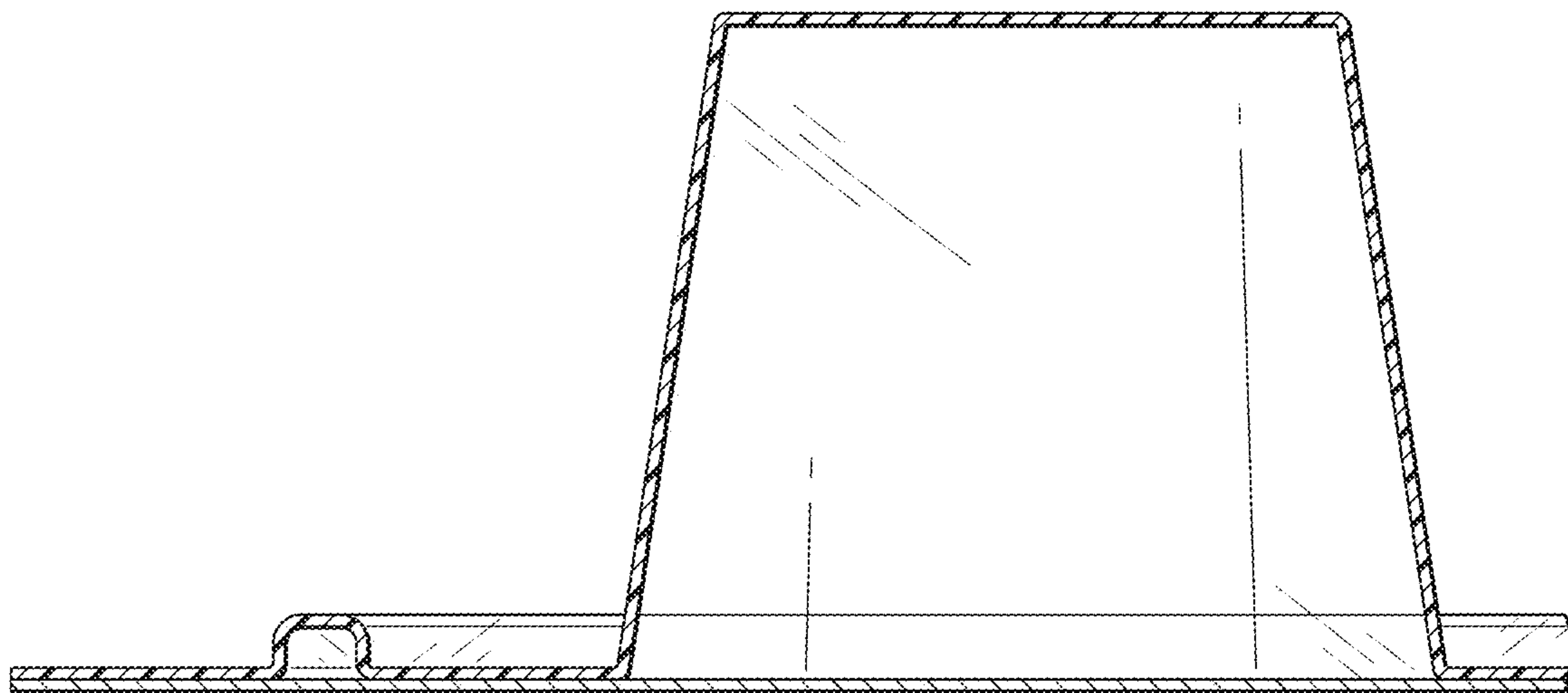
