(57) **CLAIM**

We claim the ornamental design for a tire tread, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the tire tread according to the new design.

FIG. 2 is a bottom perspective view of the tire tread shown in FIG. 1.

FIG. 3 is a front elevation view of the tire tread shown in FIG. 1.

FIG. 4 is a rear elevation view of the tire tread shown in FIG. 1.

FIG. 5 is left side elevation view of the tire tread shown in FIG. 1.

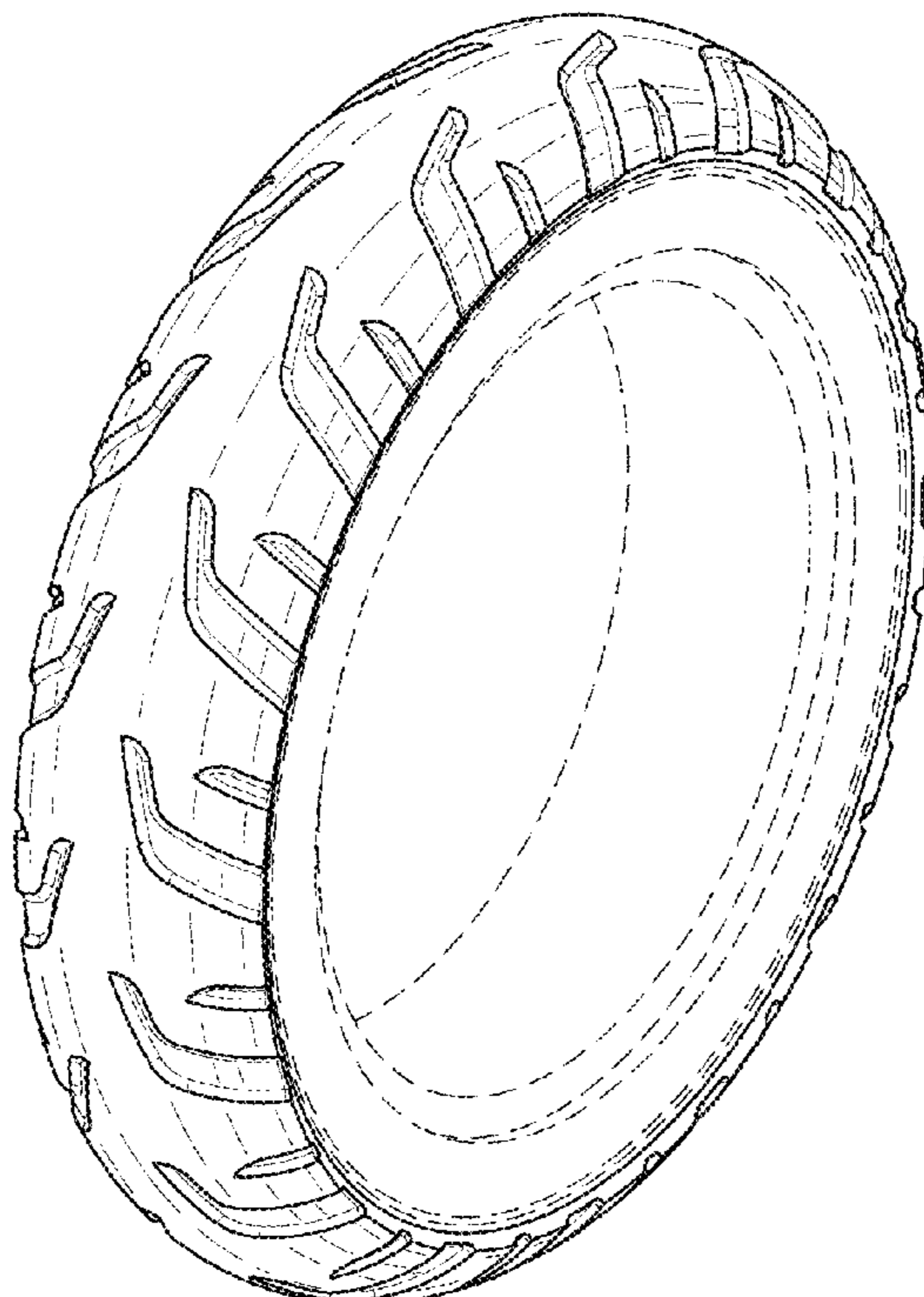
FIG. 6 is a right side elevation view of the tire tread shown in FIG. 1.

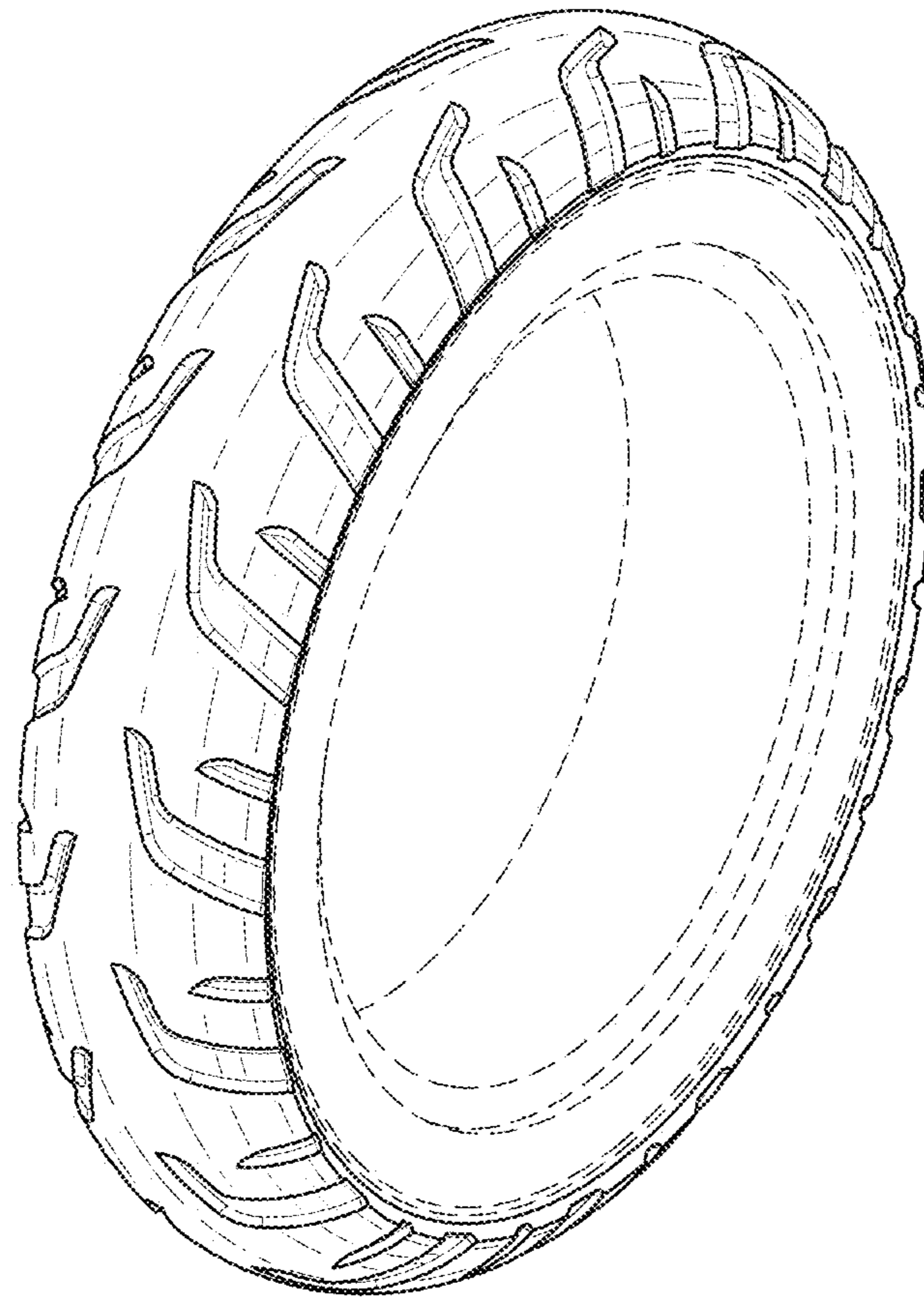

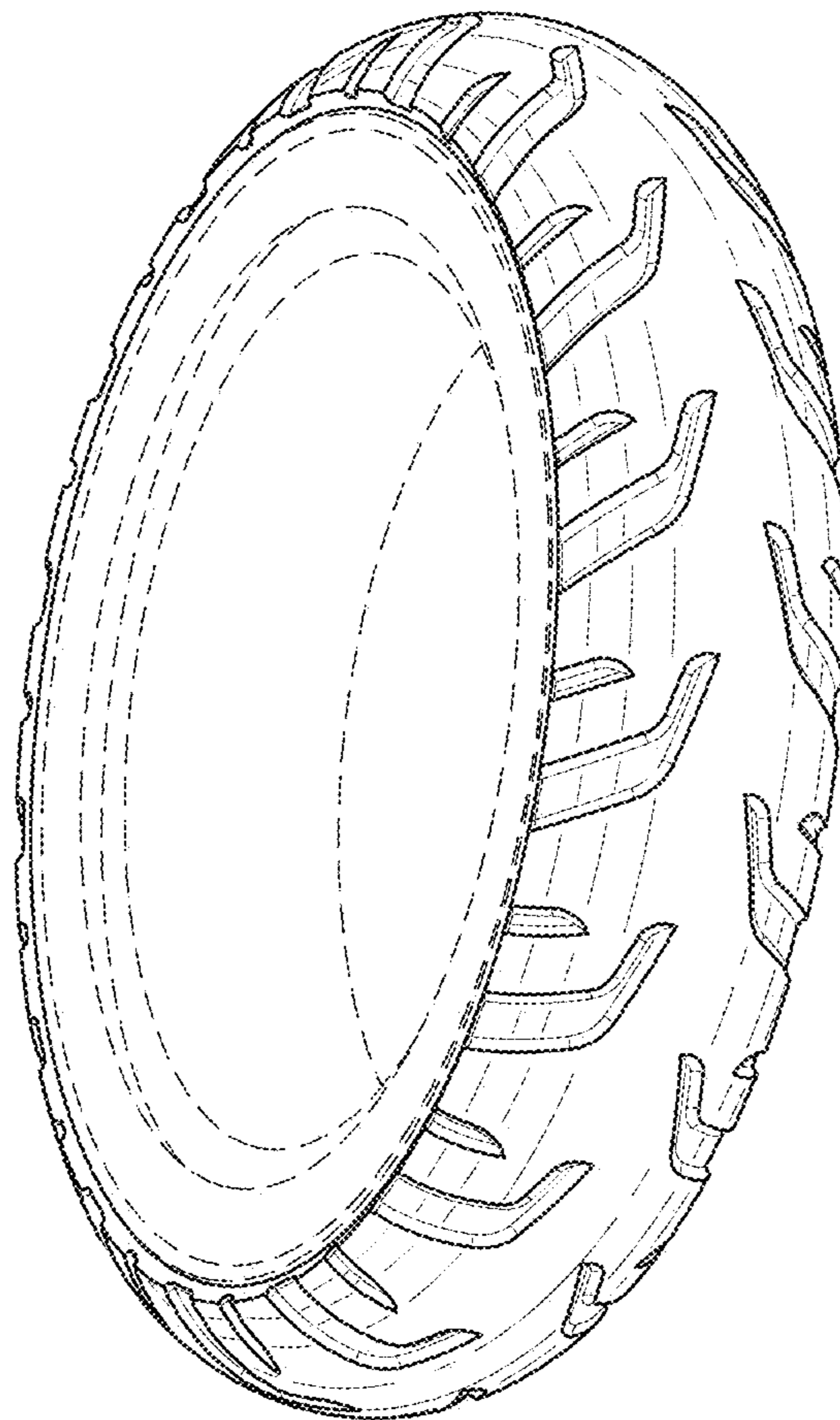

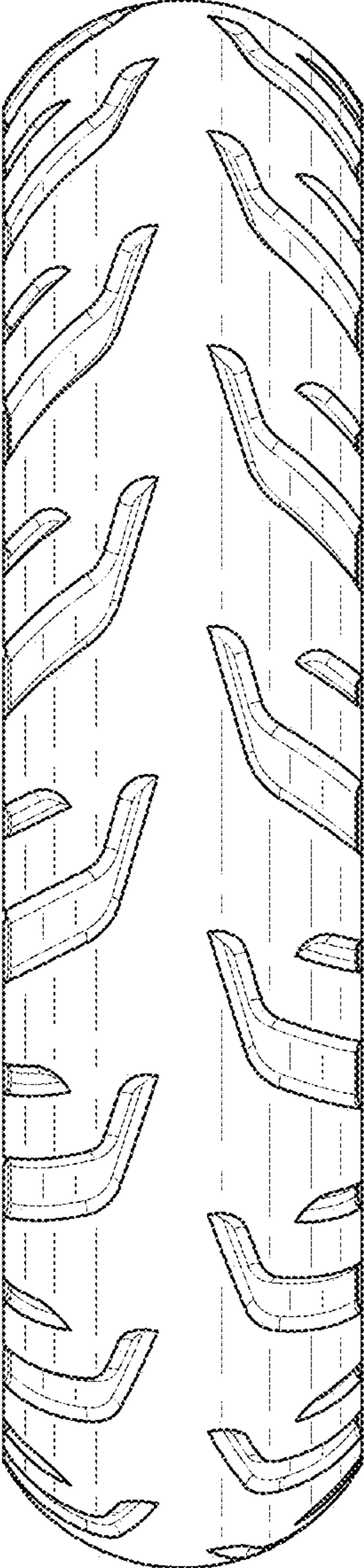

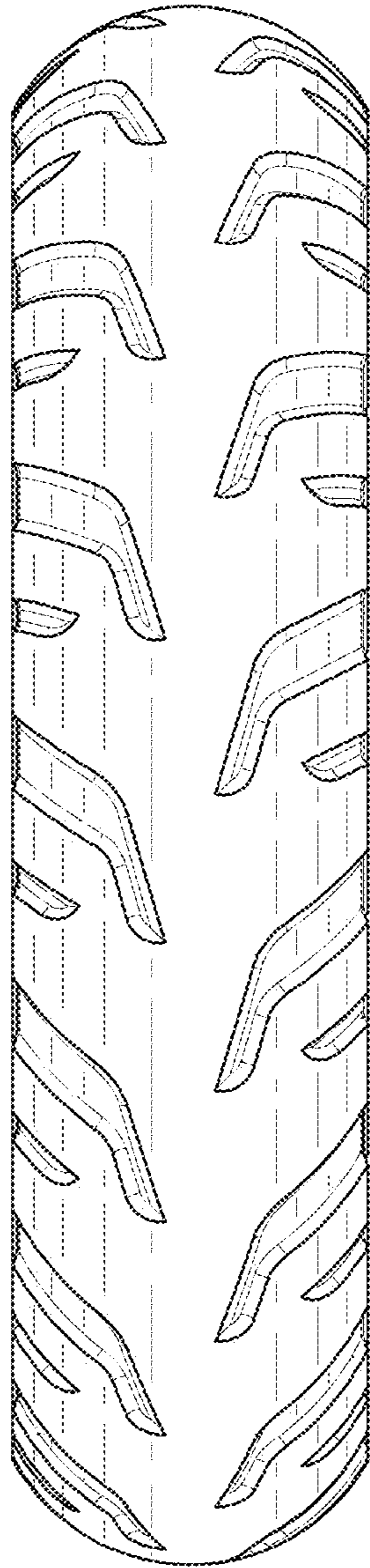

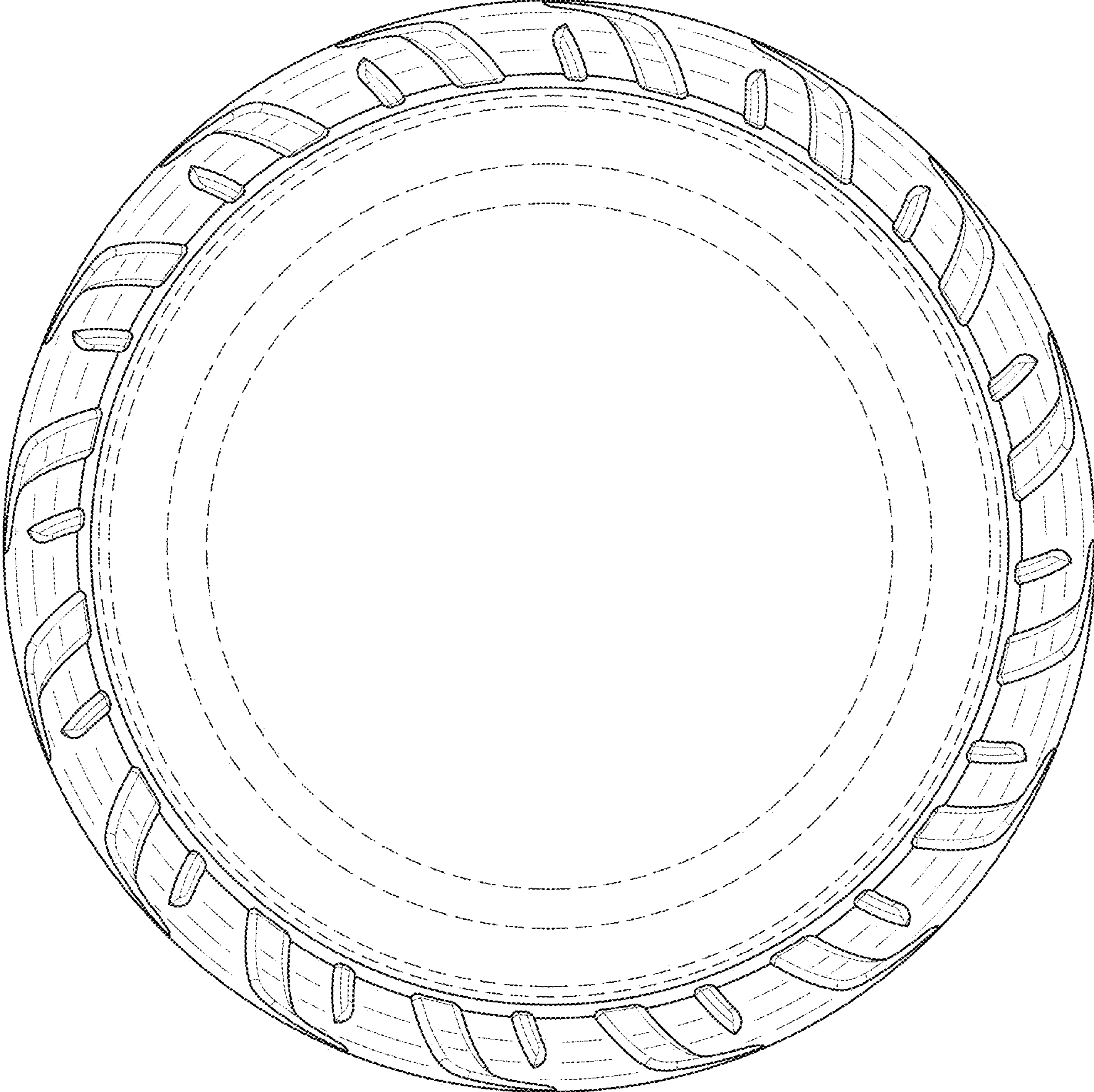

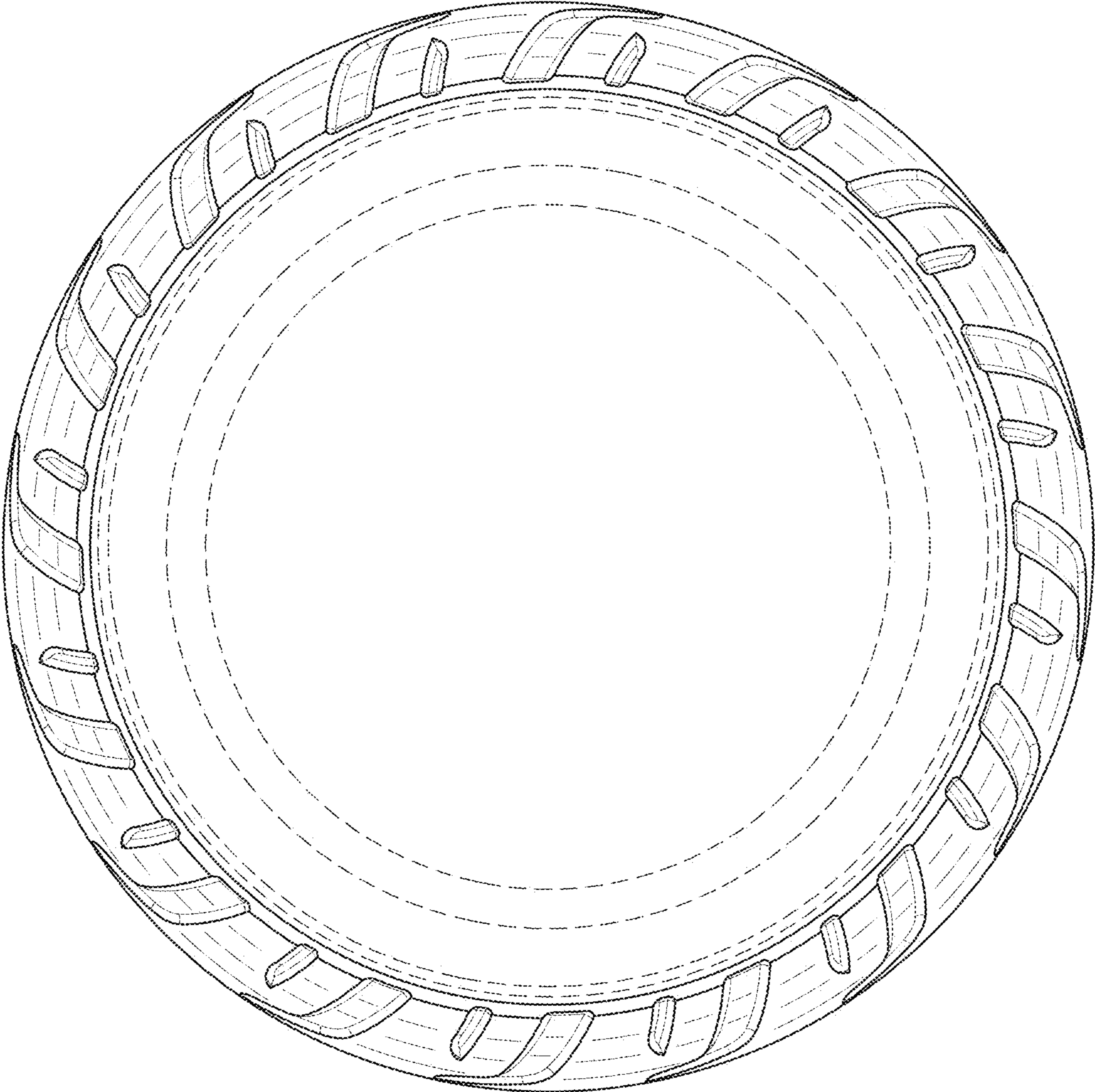

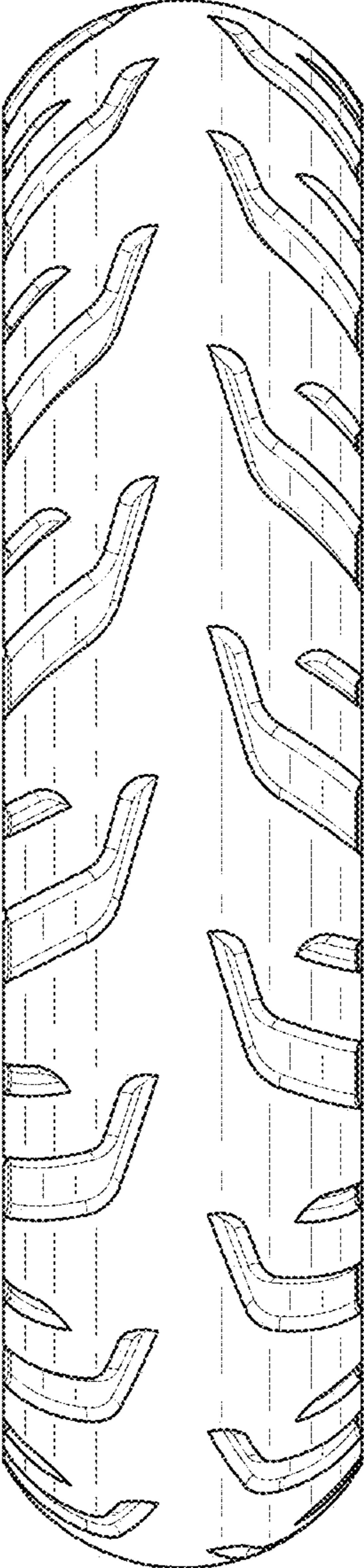

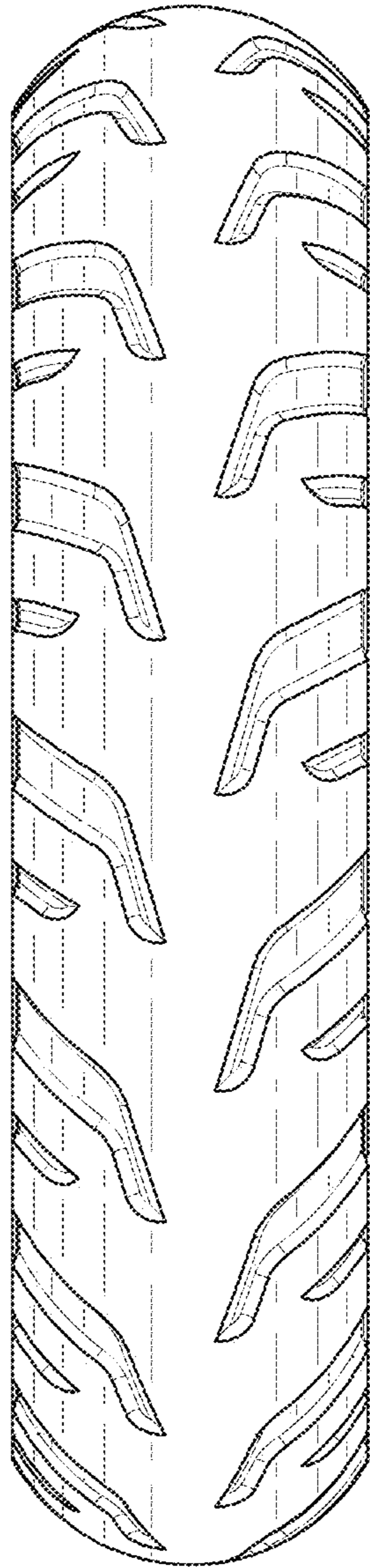
