 FIG. 8 is a bottom plan view of the mobile power pack of FIG. 1.

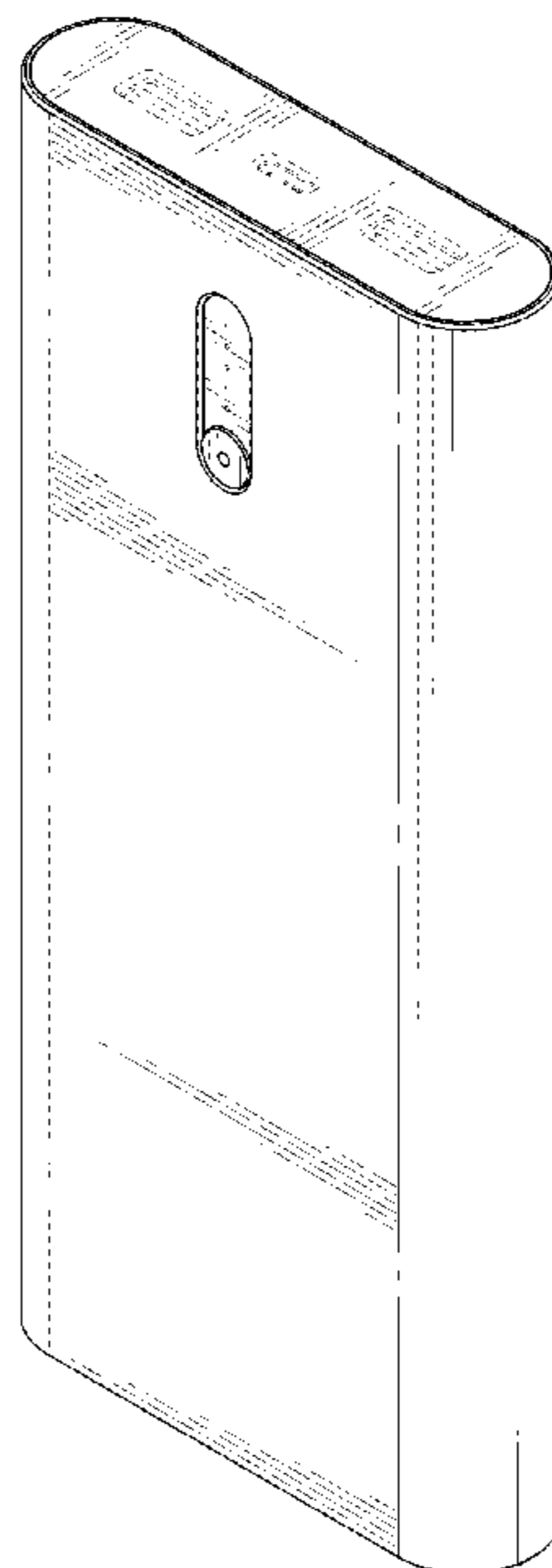

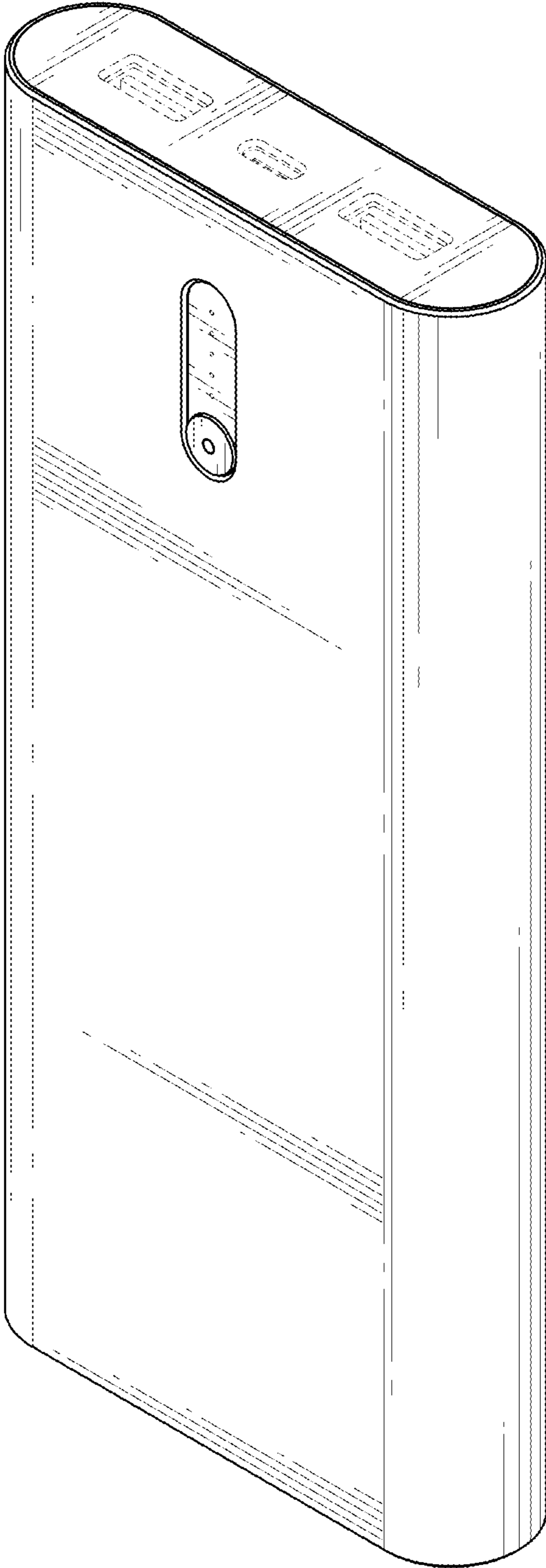

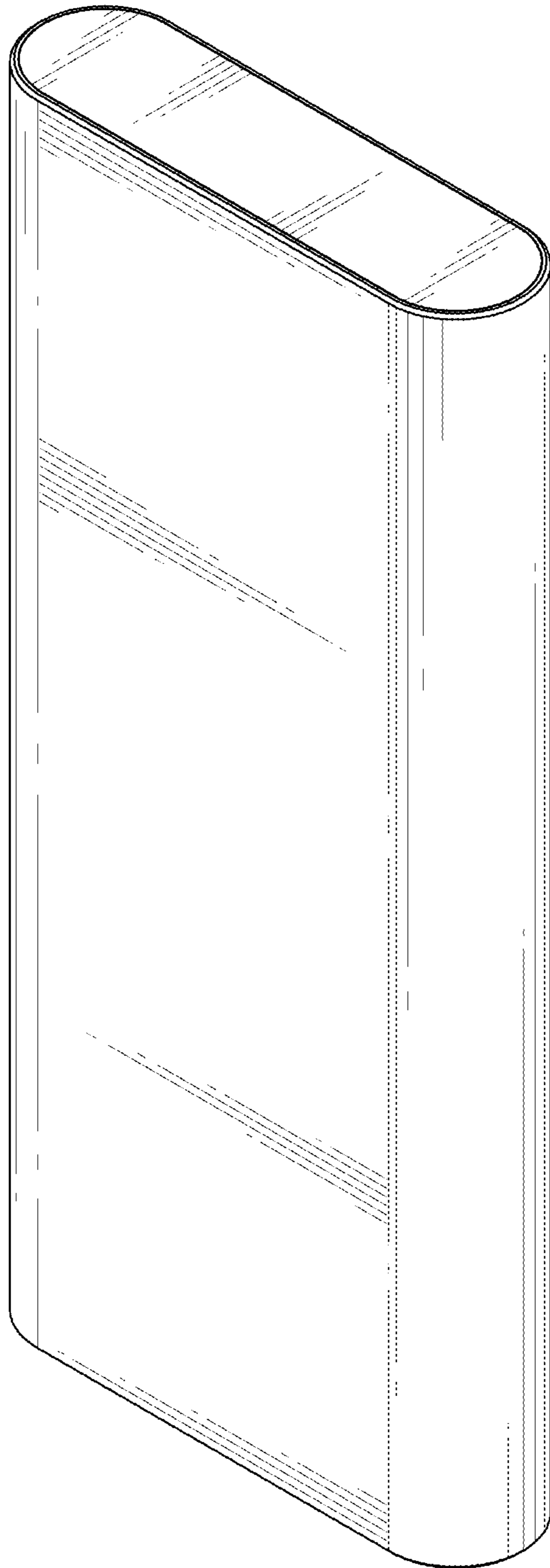

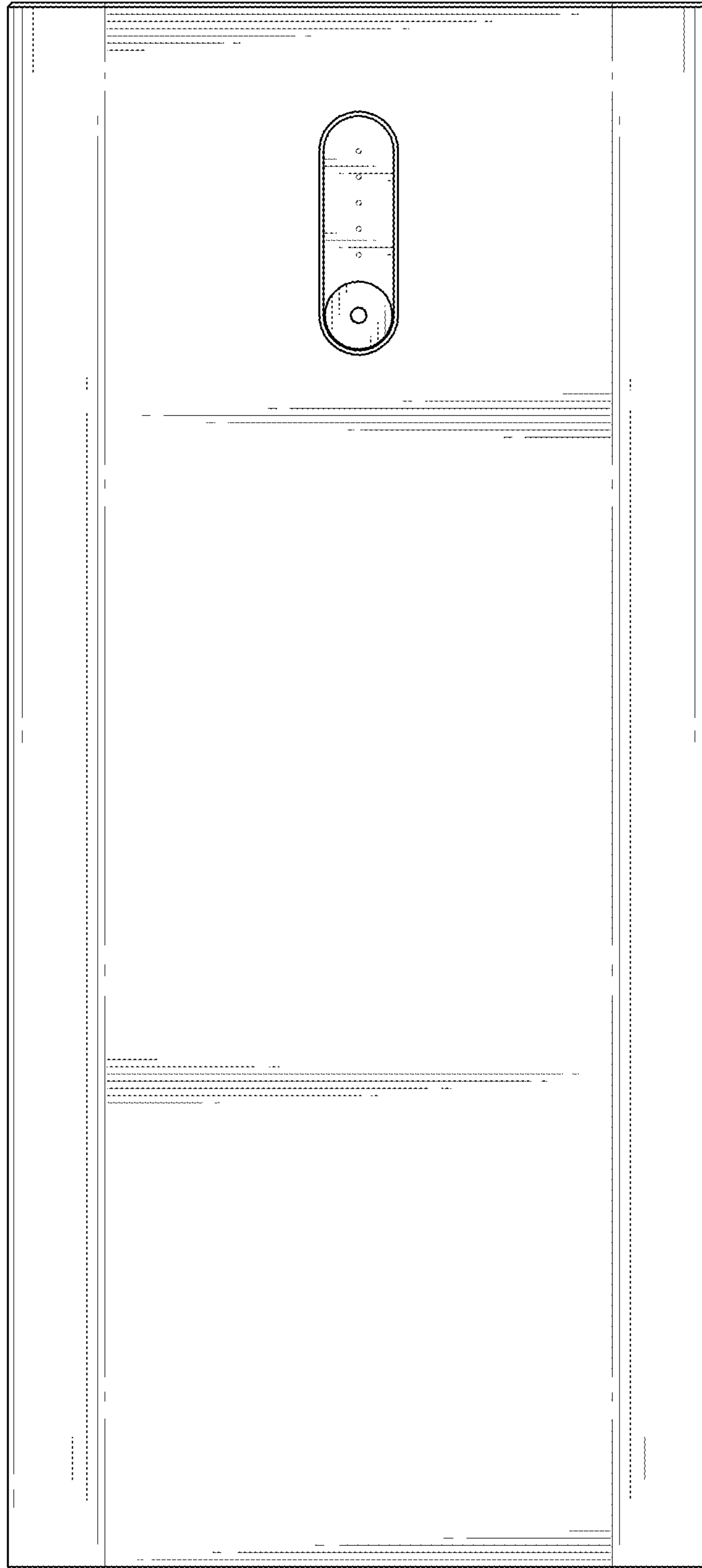

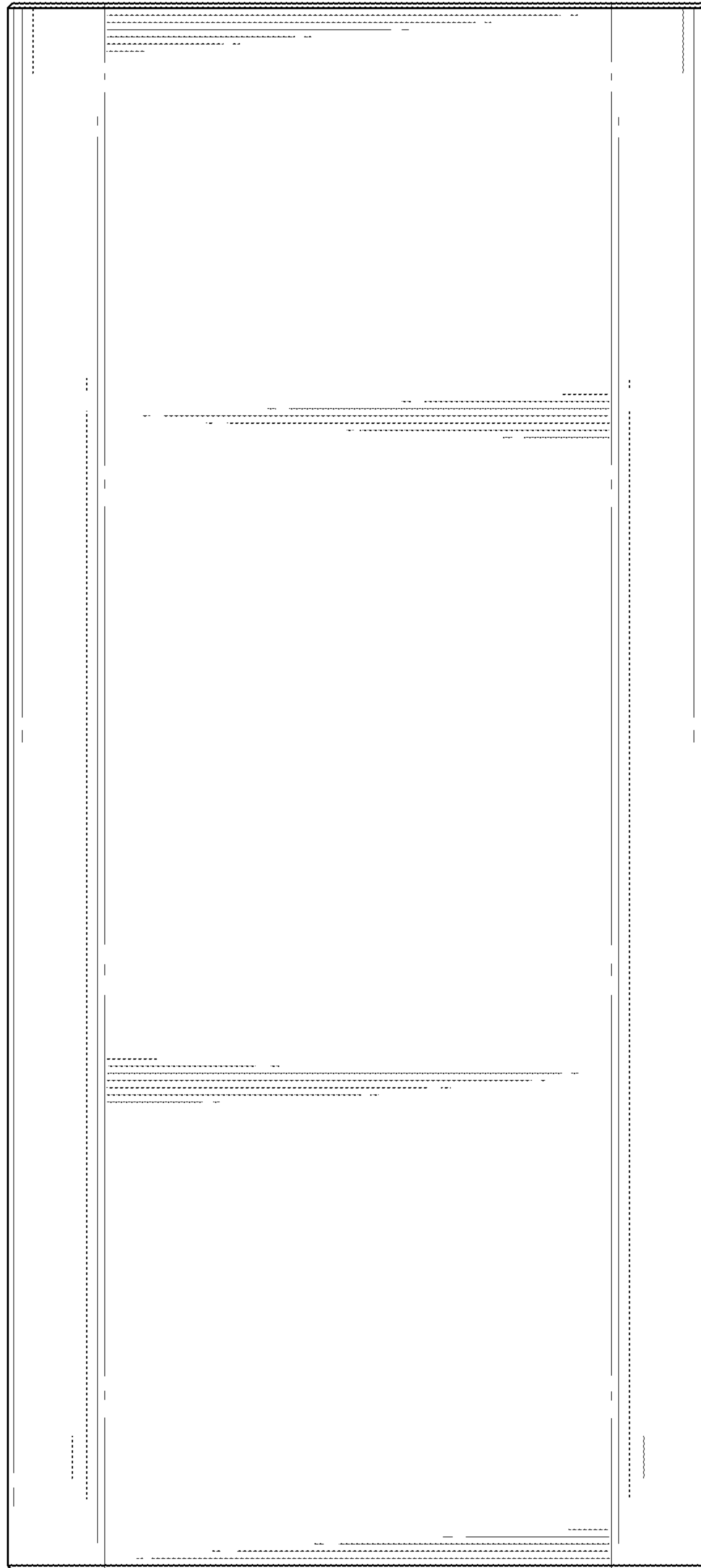

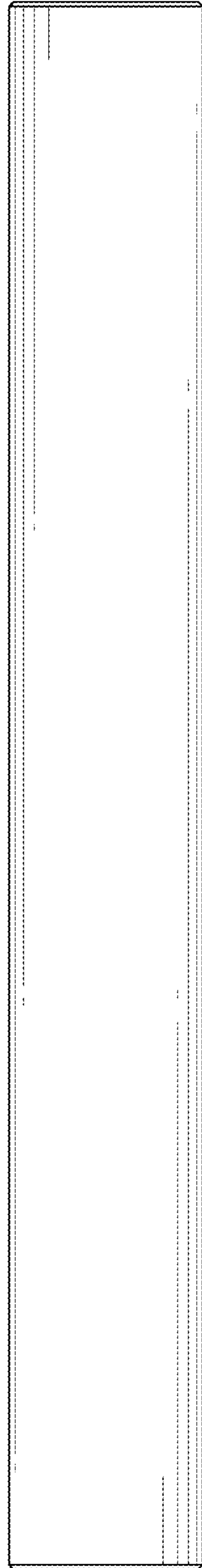

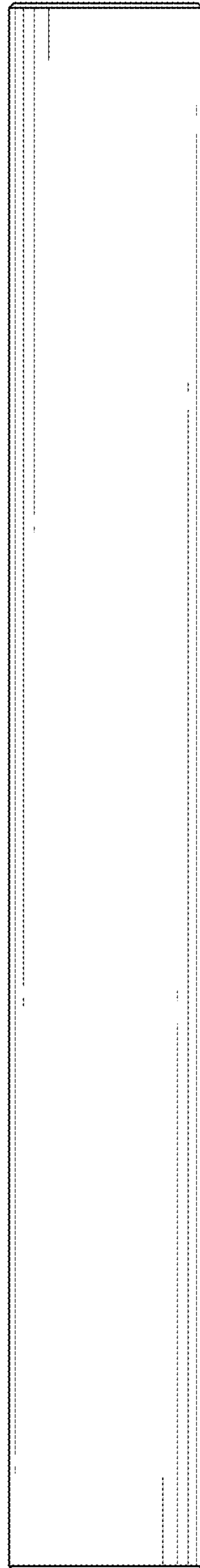

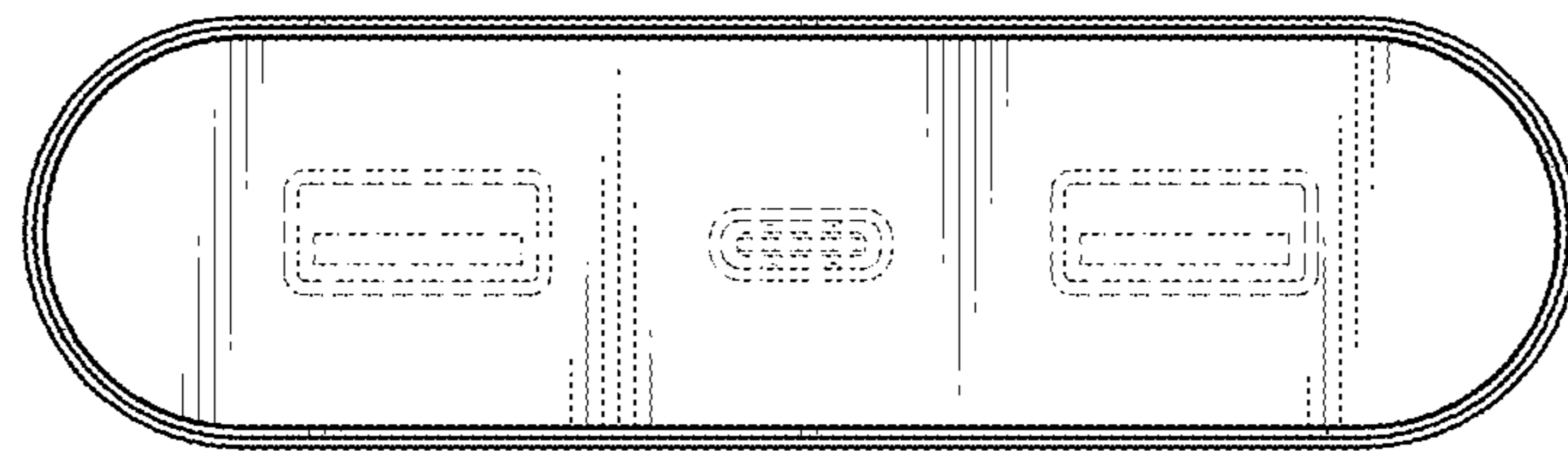

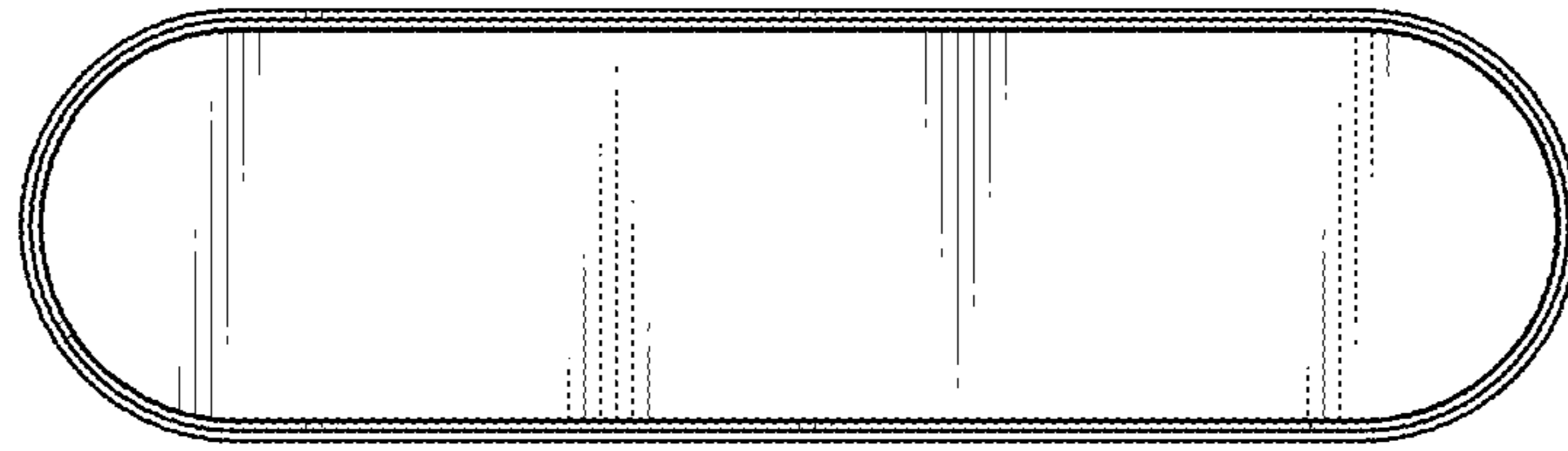
