The ornamental design for the speaker box for an automobile, as shown and described.

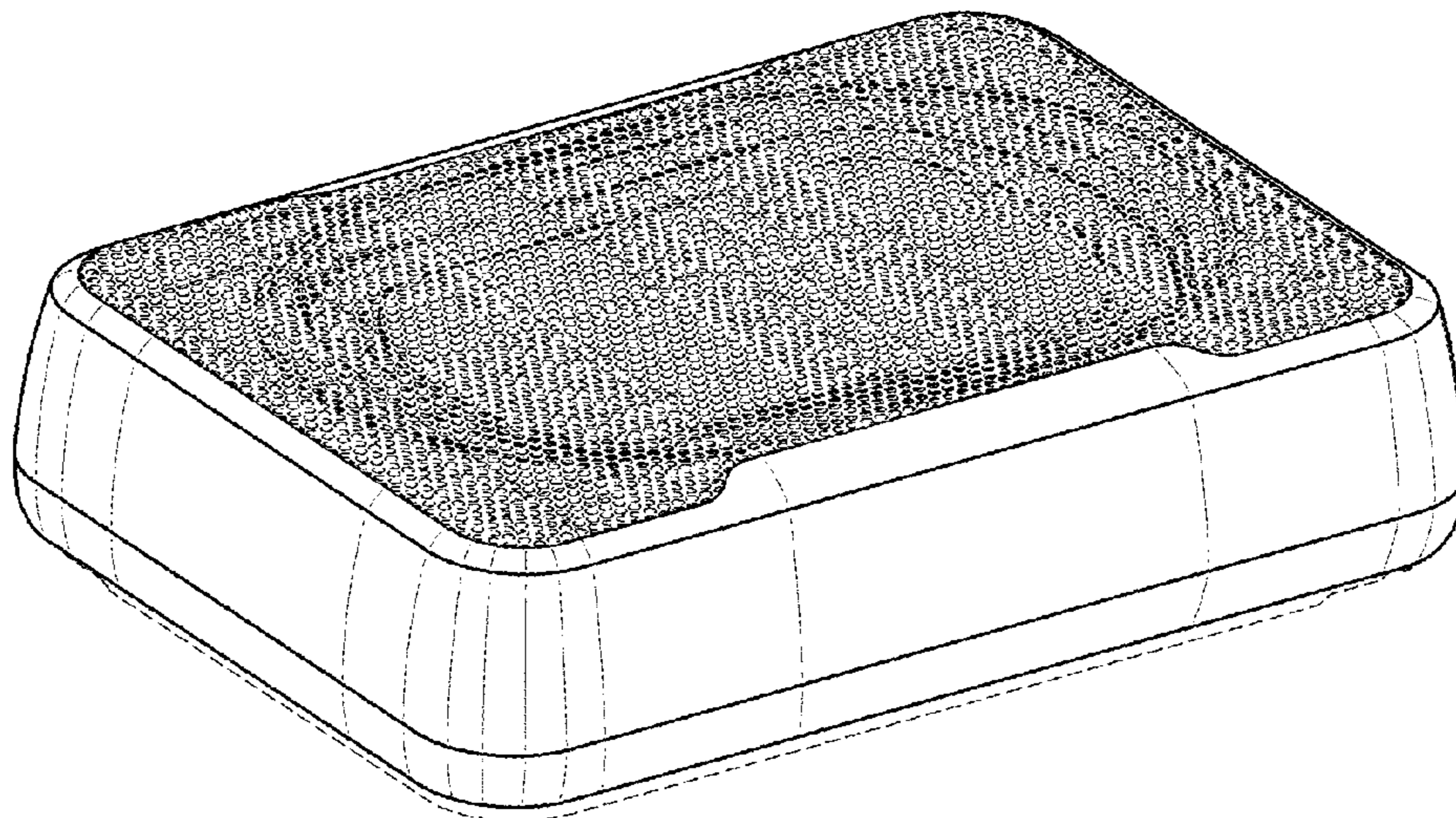
**DESCRIPTION**

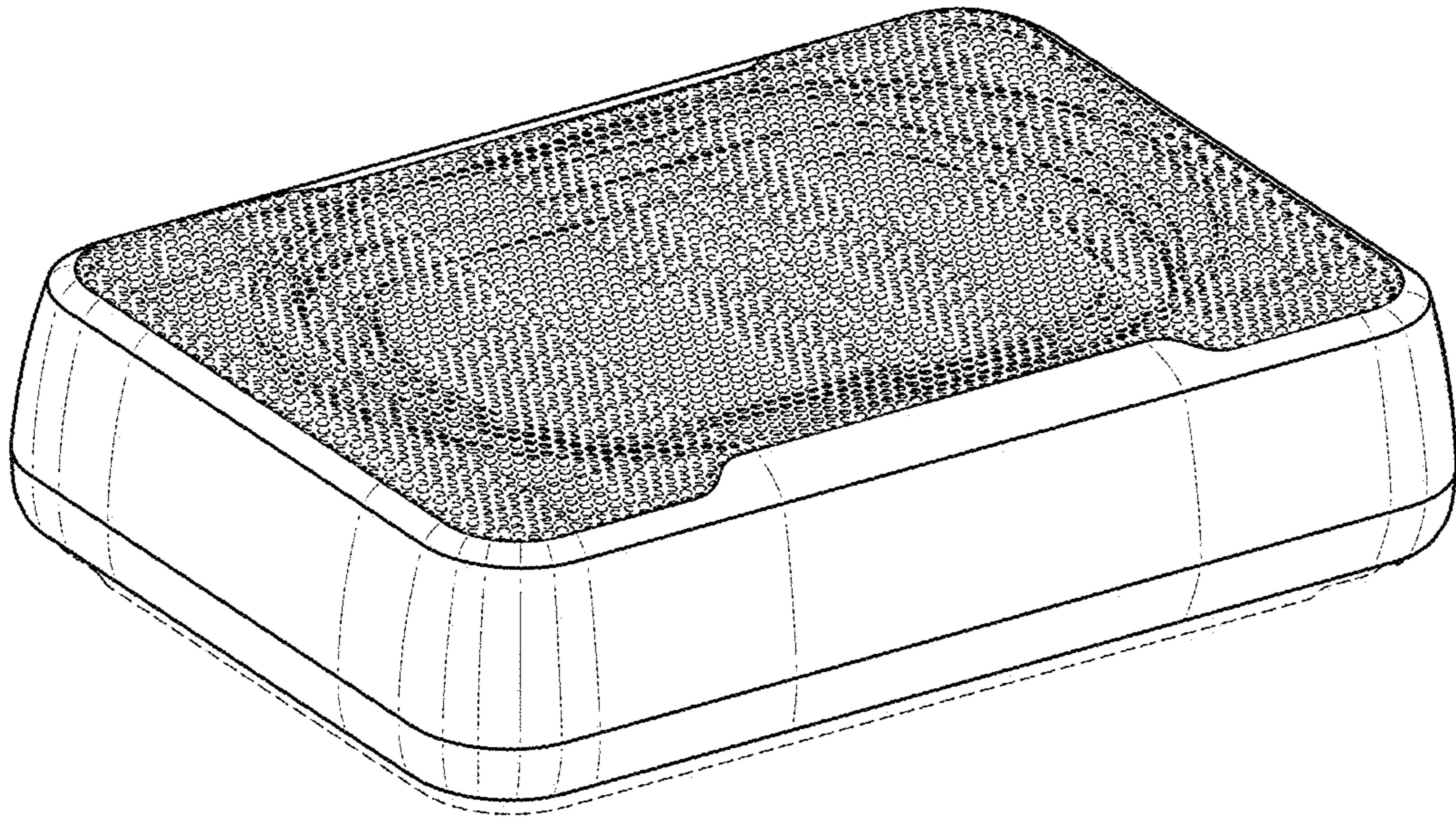

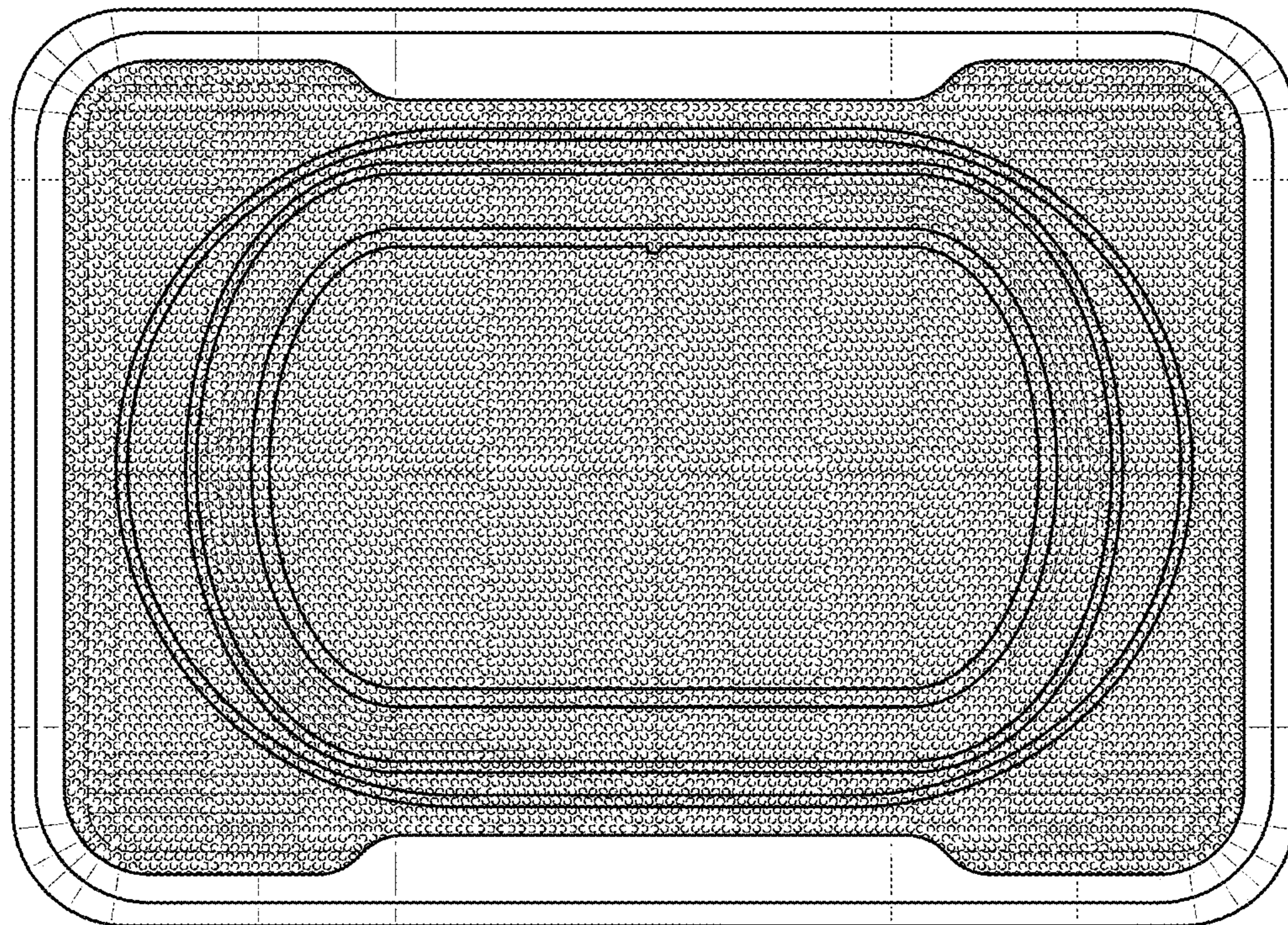

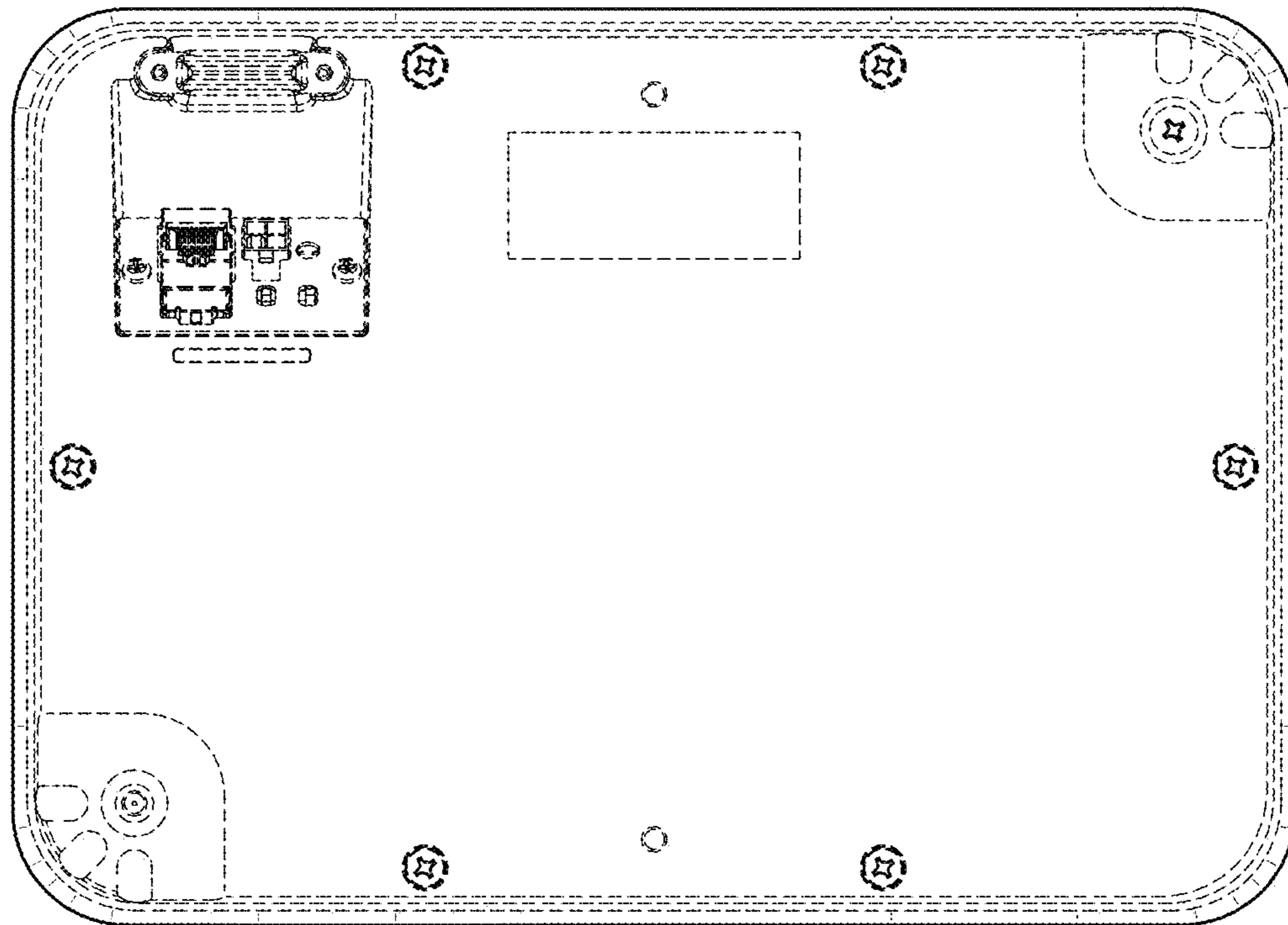

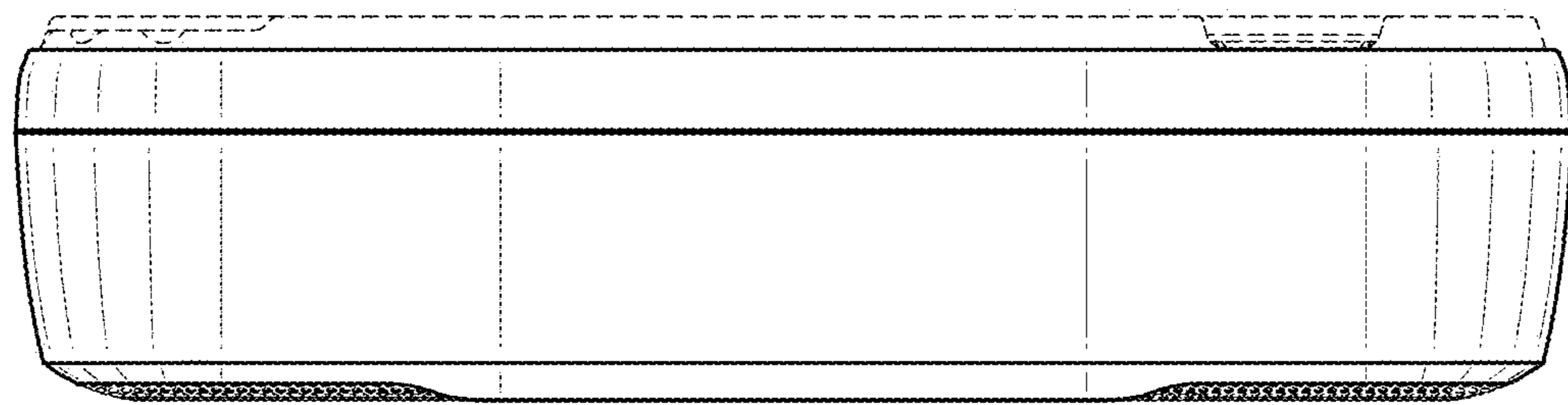

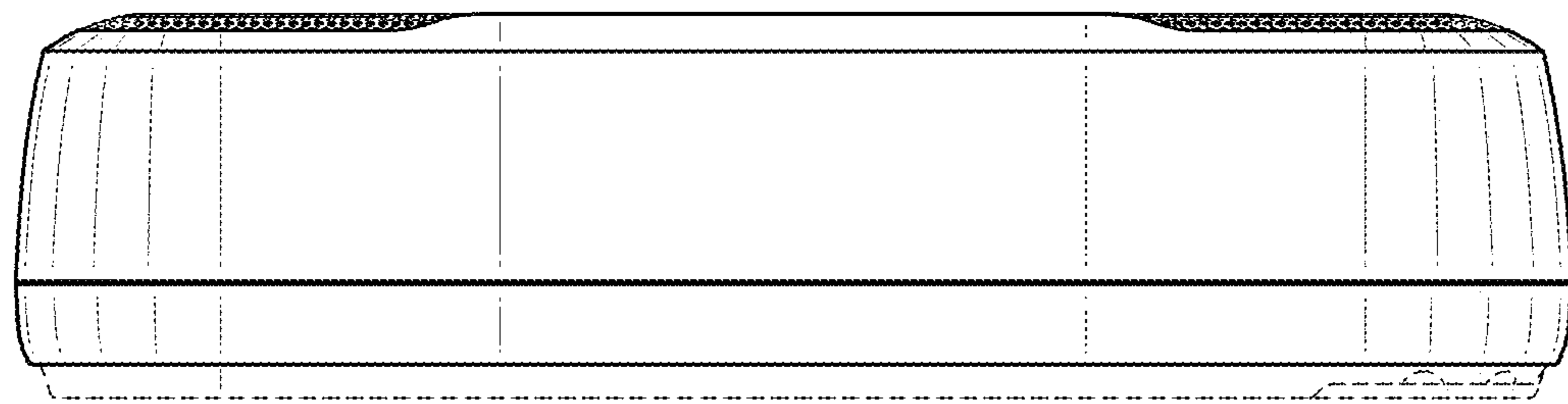

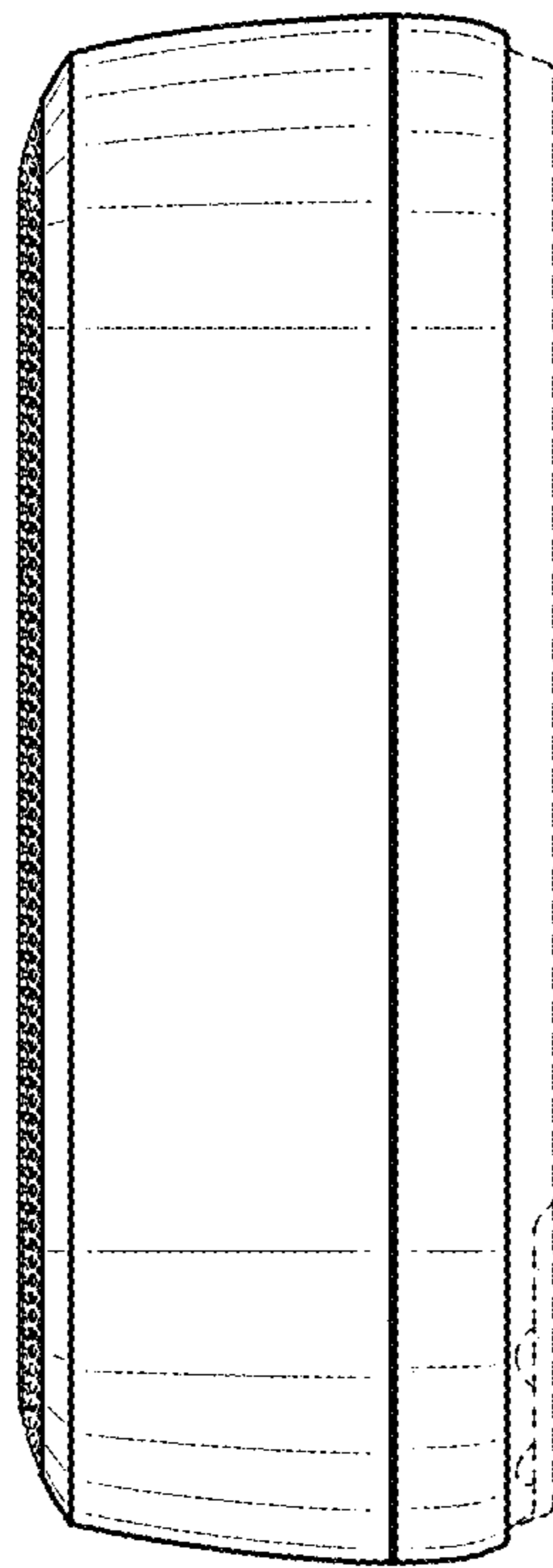

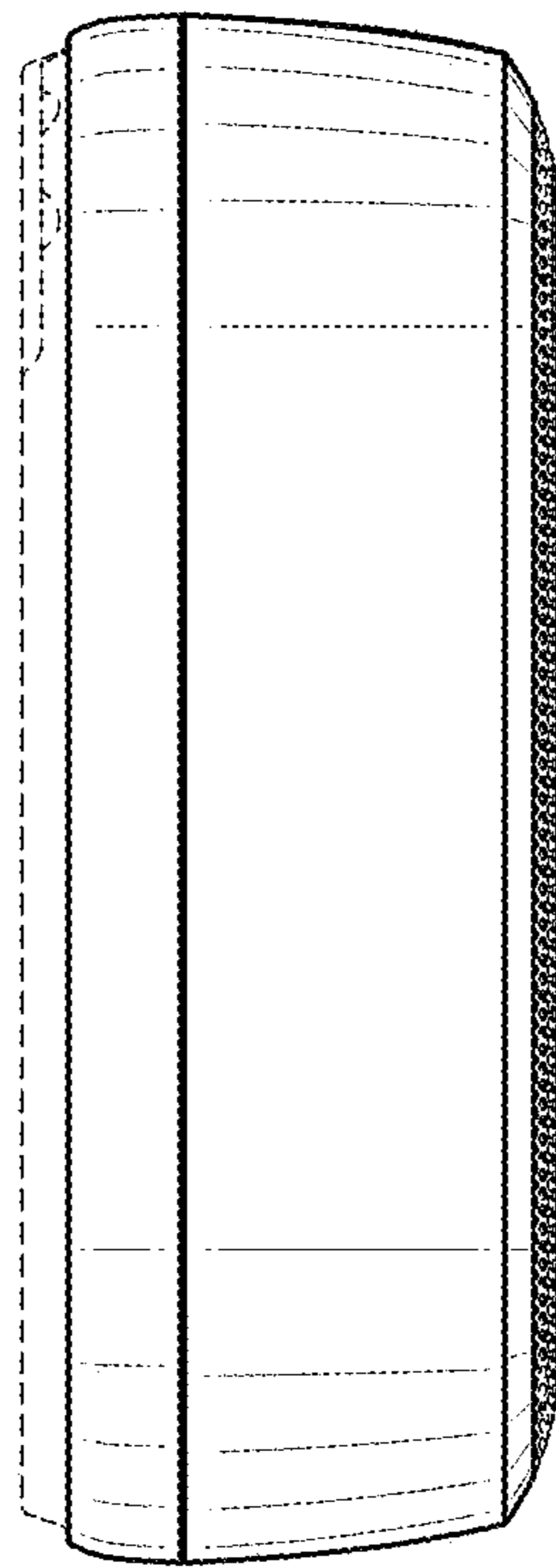
