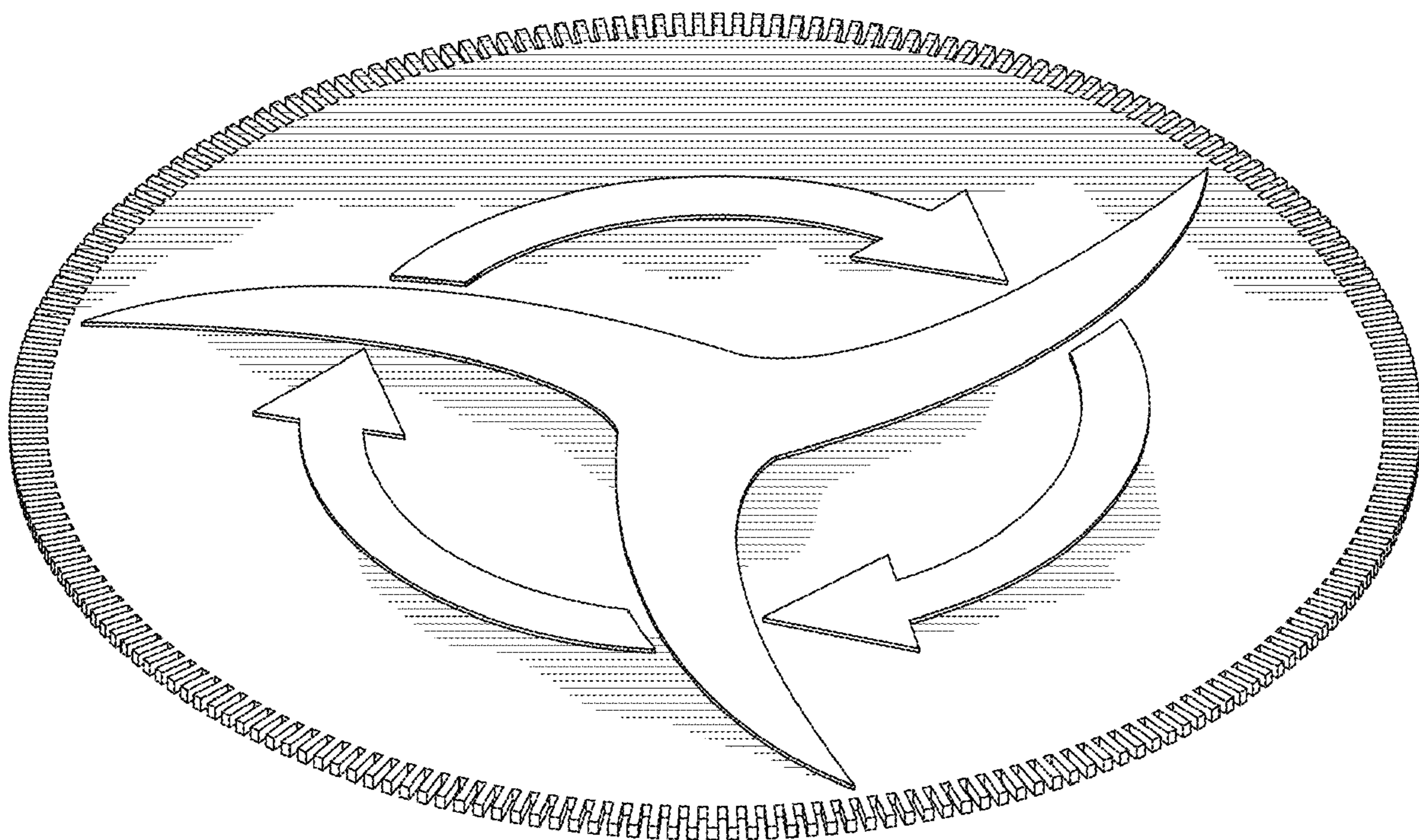
The ornamental design for a cryptocurrency coin, as shown and described.

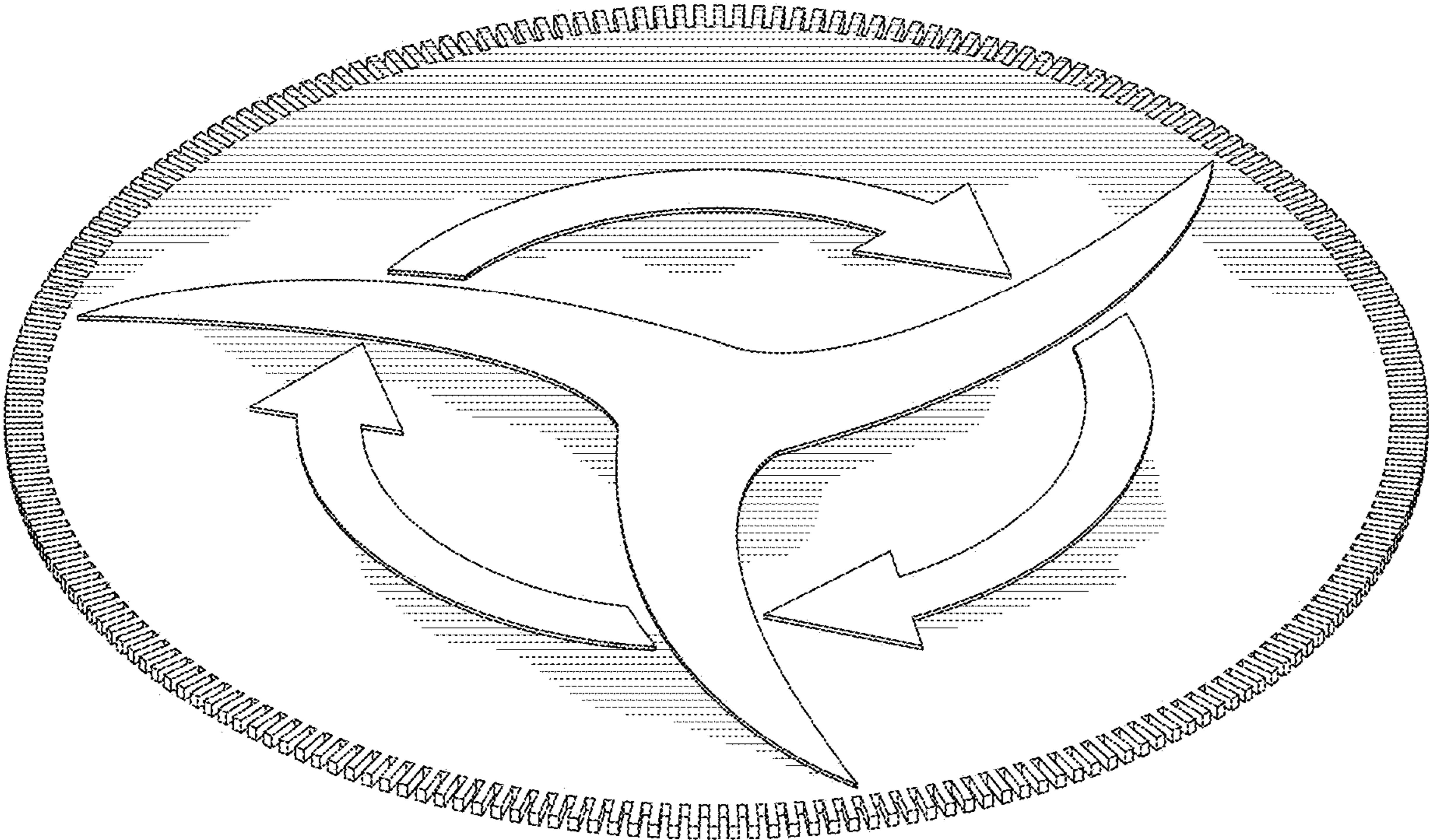

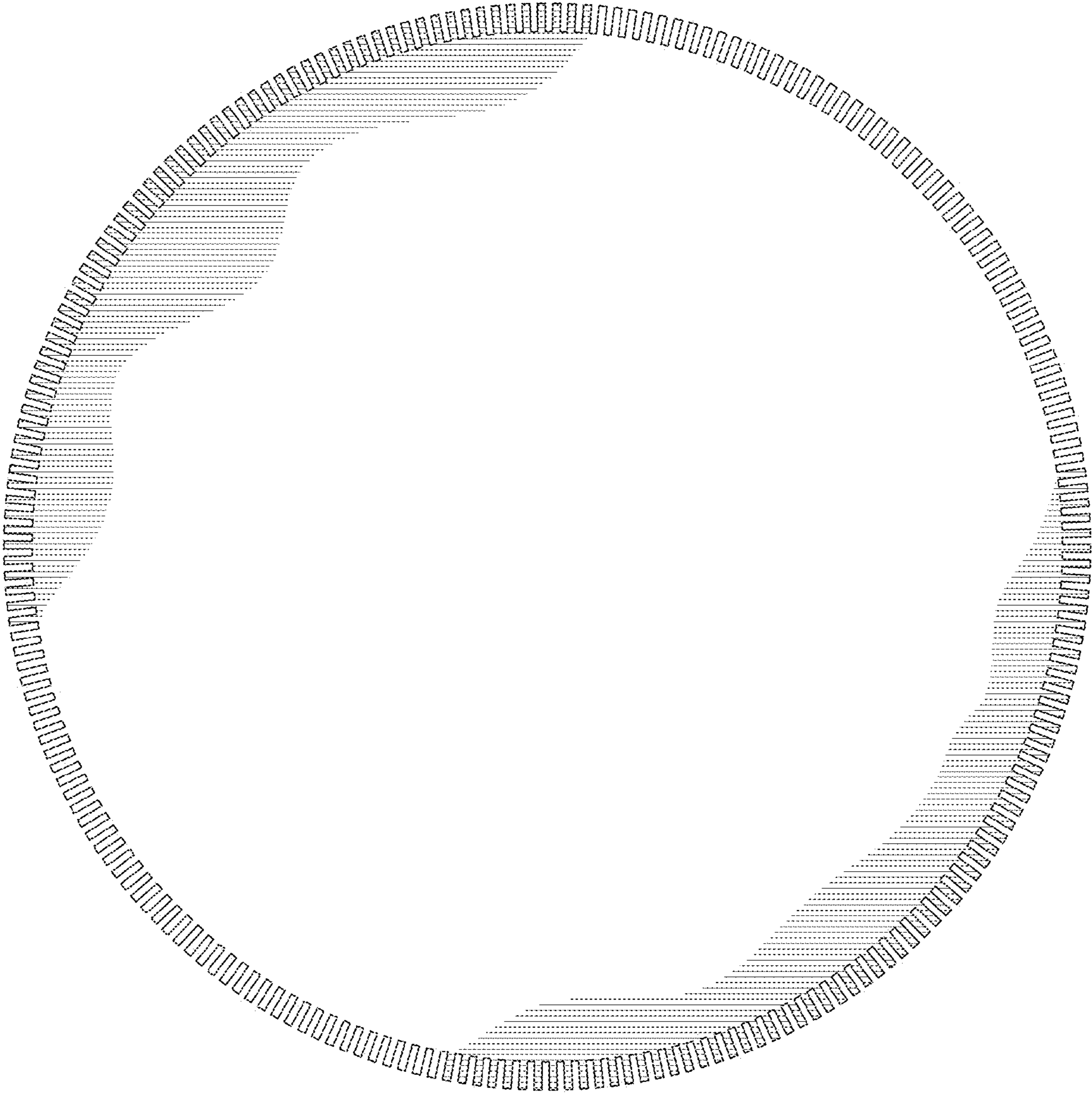

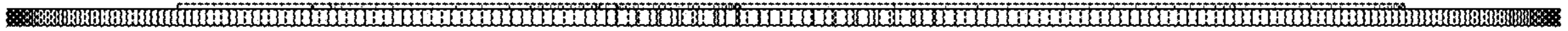

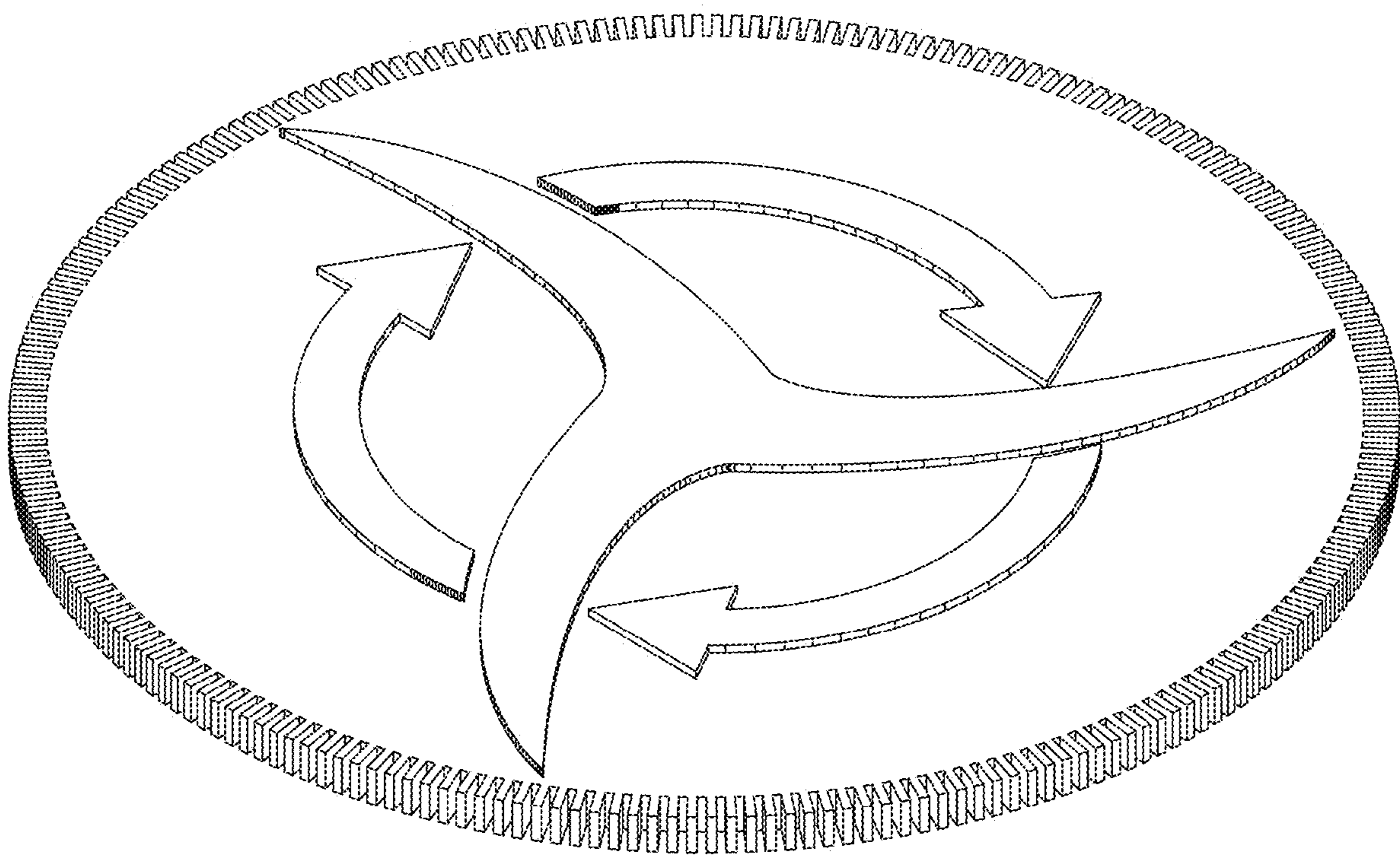
