(57) **CLAIM**

I claim the ornamental design for a faucet spout, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a faucet spout showing my new design;

FIG. 2 is a Front view of the faucet spout as shown in FIG. 1;

FIG. 3 is a Back view of the faucet spout as shown in FIG. 1;

FIG. 4 is a Right-side view of the faucet spout as shown in FIG. 1;

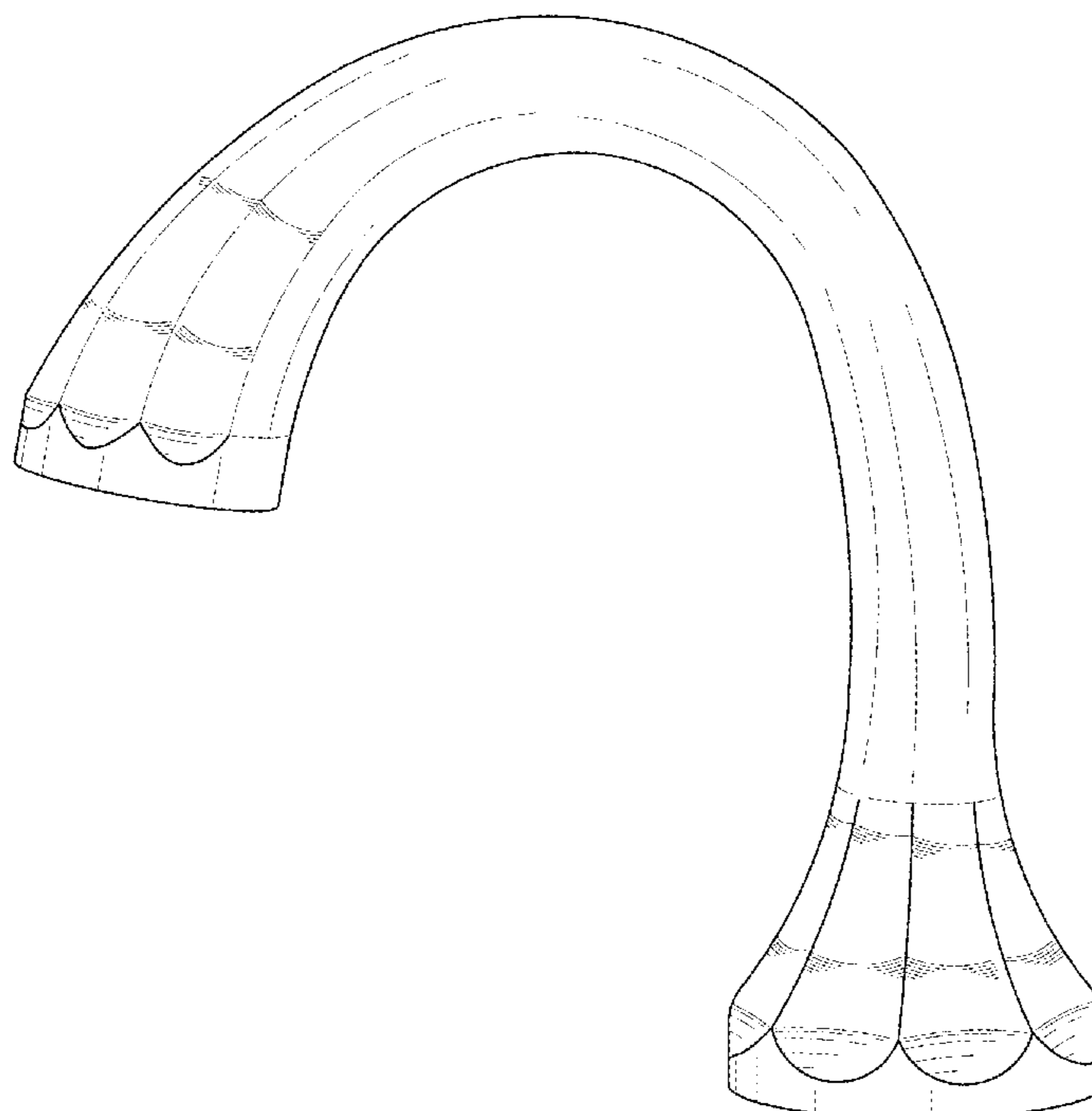
FIG. 5 is a Left-side view of the faucet spout as shown in FIG. 1;

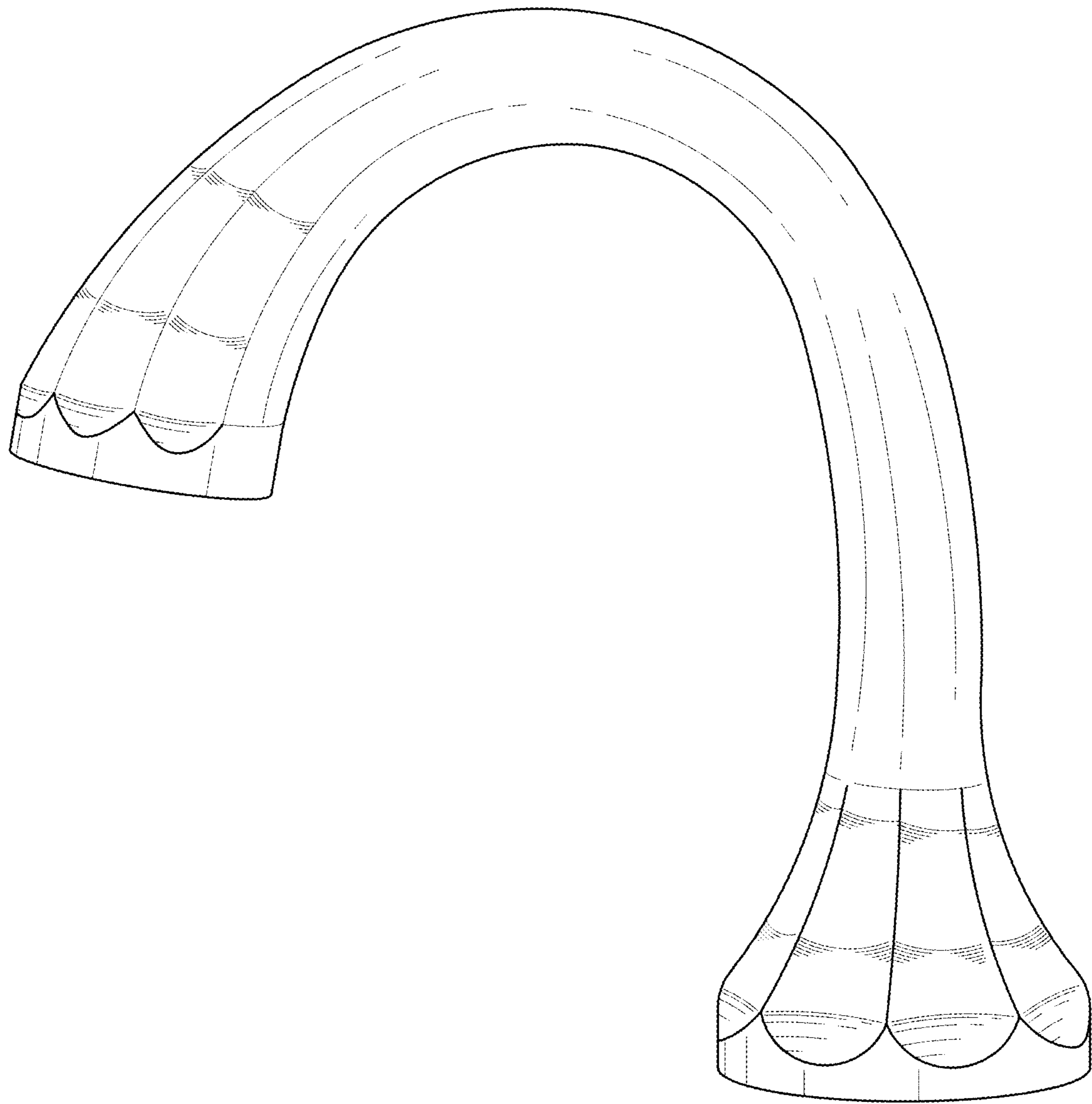

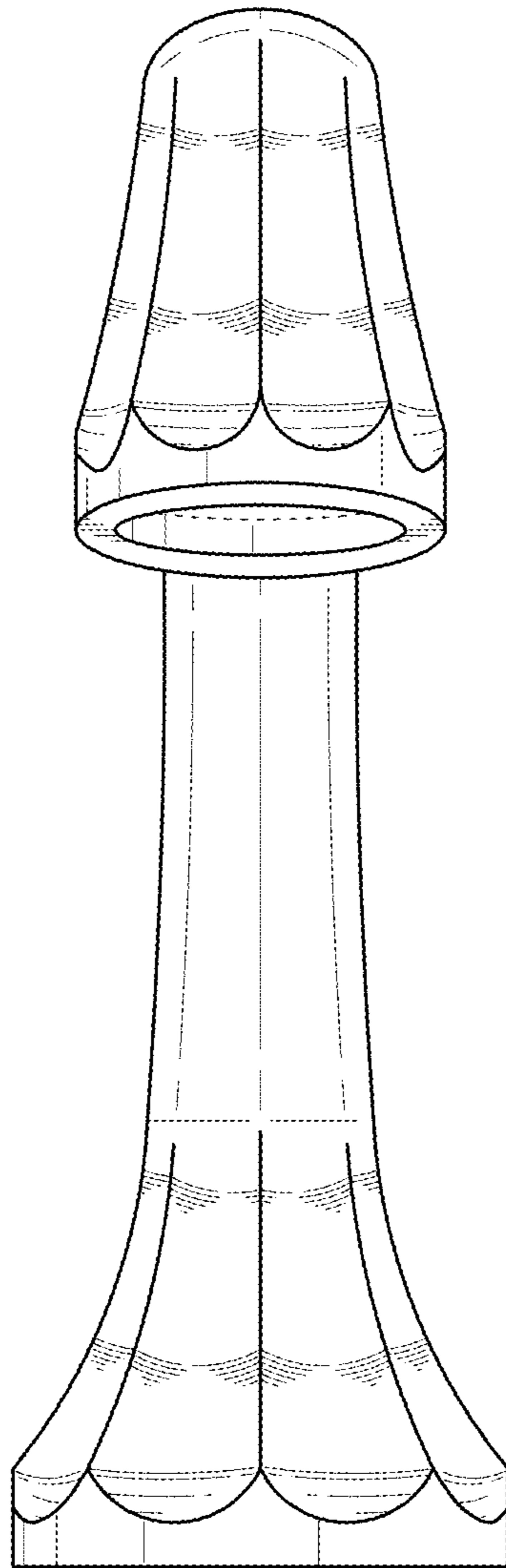

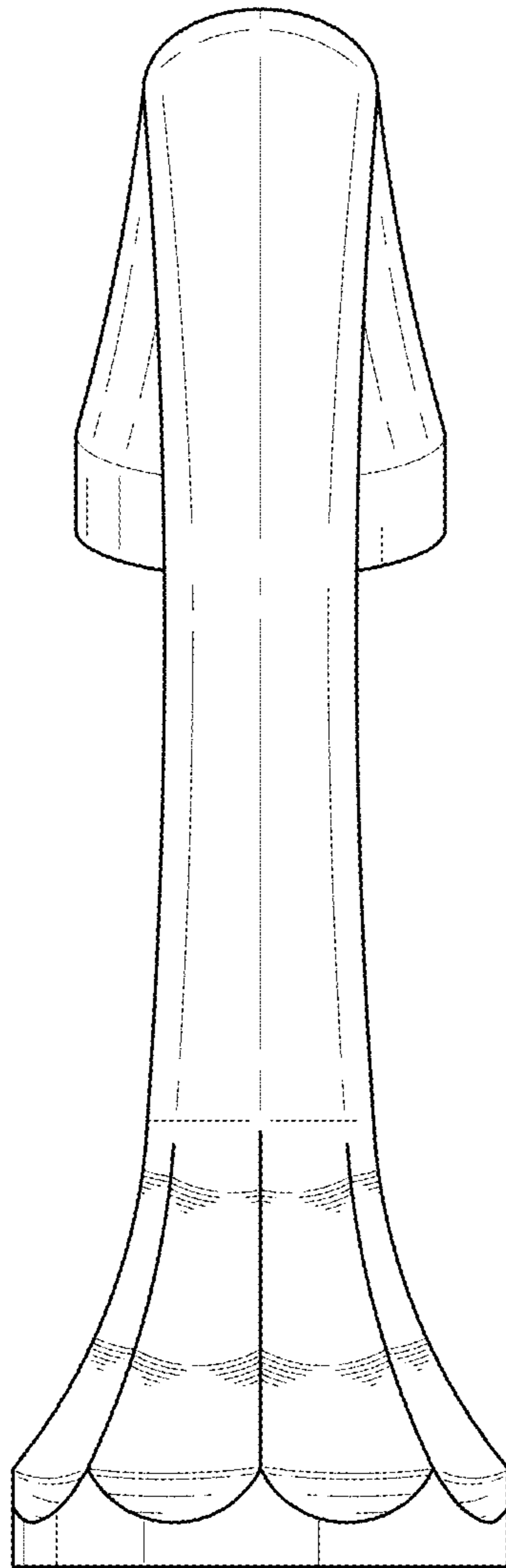

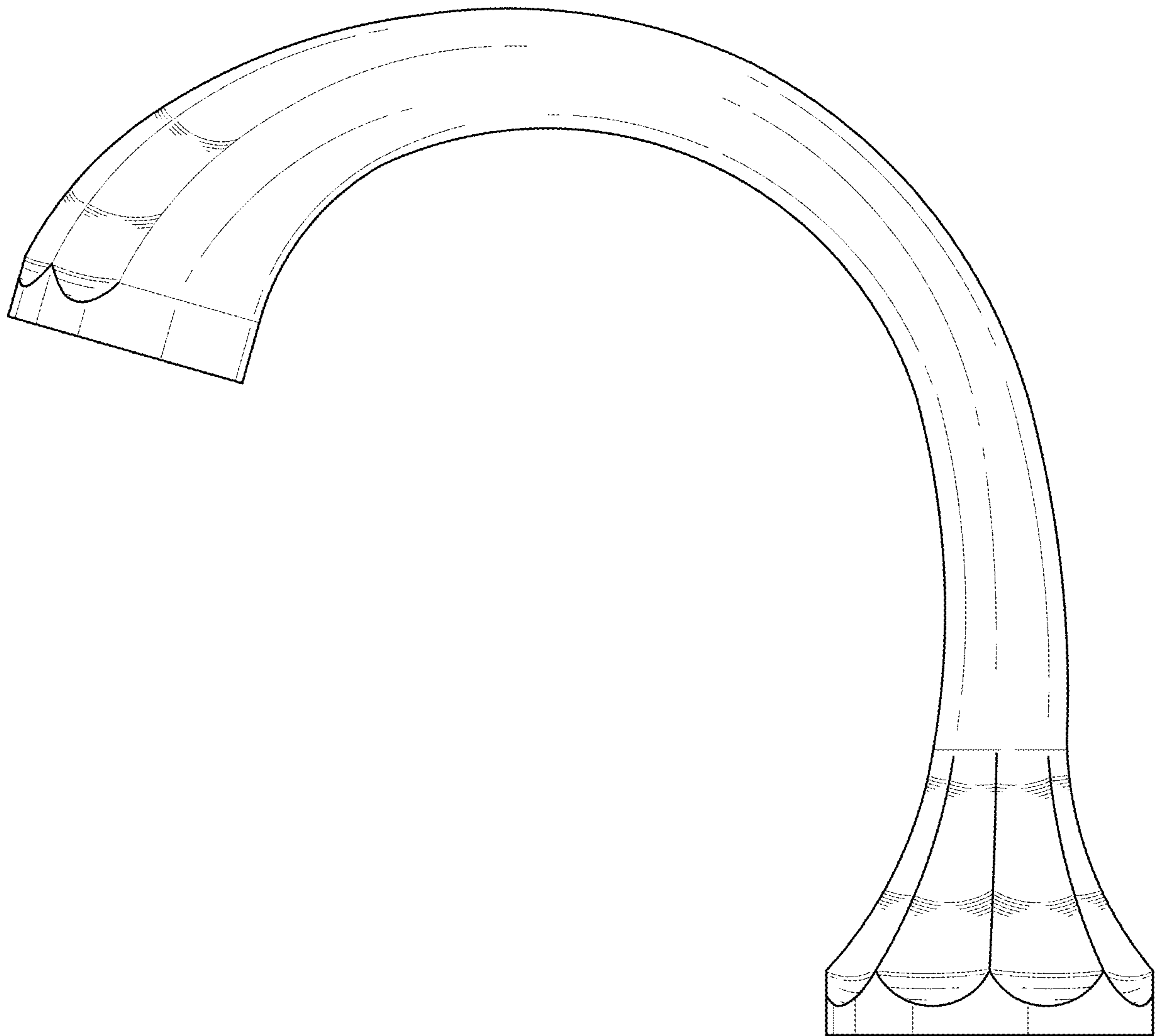

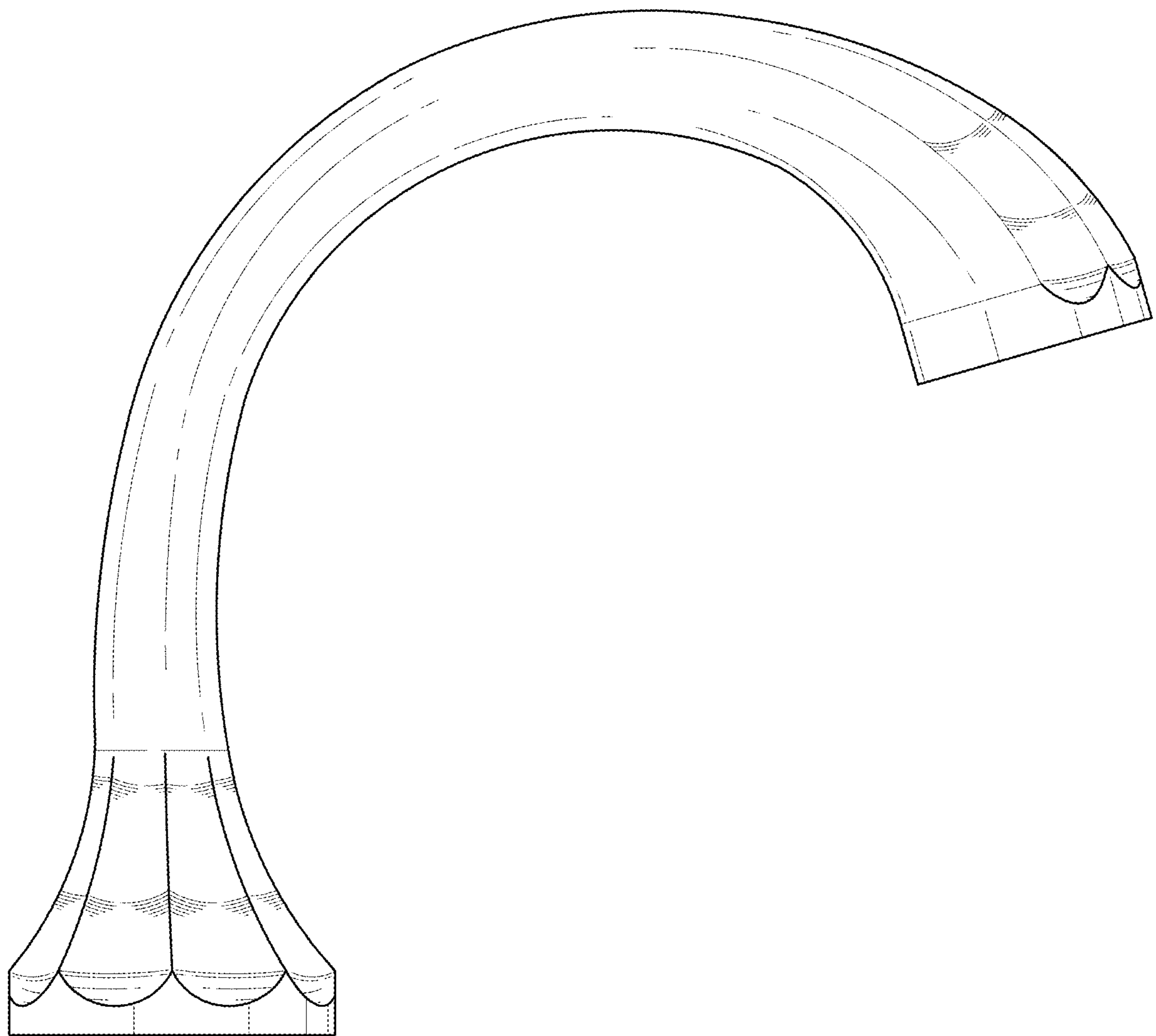

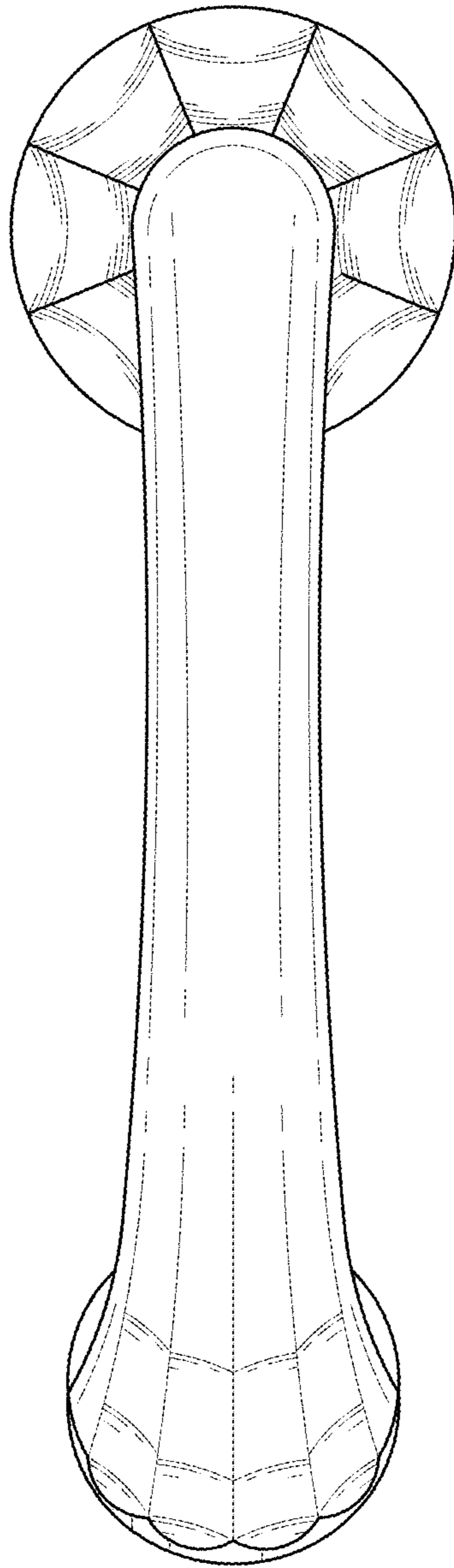

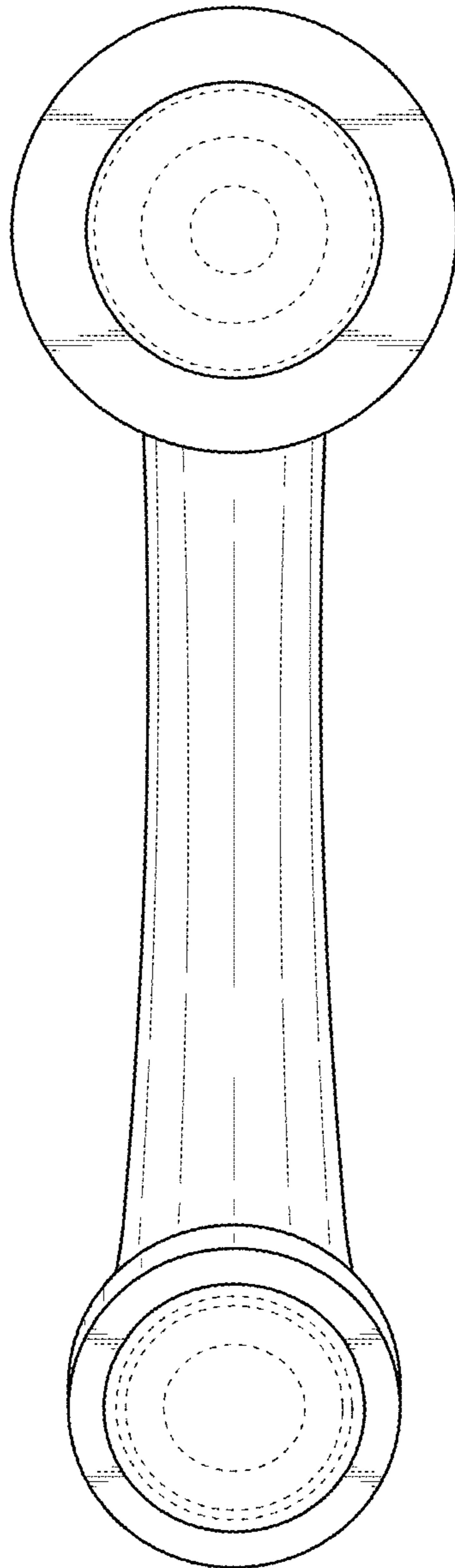
