(57) **CLAIM**

The ornamental design for a set of mosaic tiles, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a set of mosaic tiles showing my new design according to a first embodiment.

FIG. 2 is right-side view of my new design shown in FIG. 1.

FIG. 3 is left-side view of my new design shown in FIG. 1.

FIG. 4 is top view of my new design shown in FIG. 1.

FIG. 5 is a bottom view of my new design shown in FIG. 1.

FIG. 6 is a front view of a set of mosaic tiles showing my new design according to a second embodiment.

FIG. 7 is right-side view of my new design shown in FIG. 6.

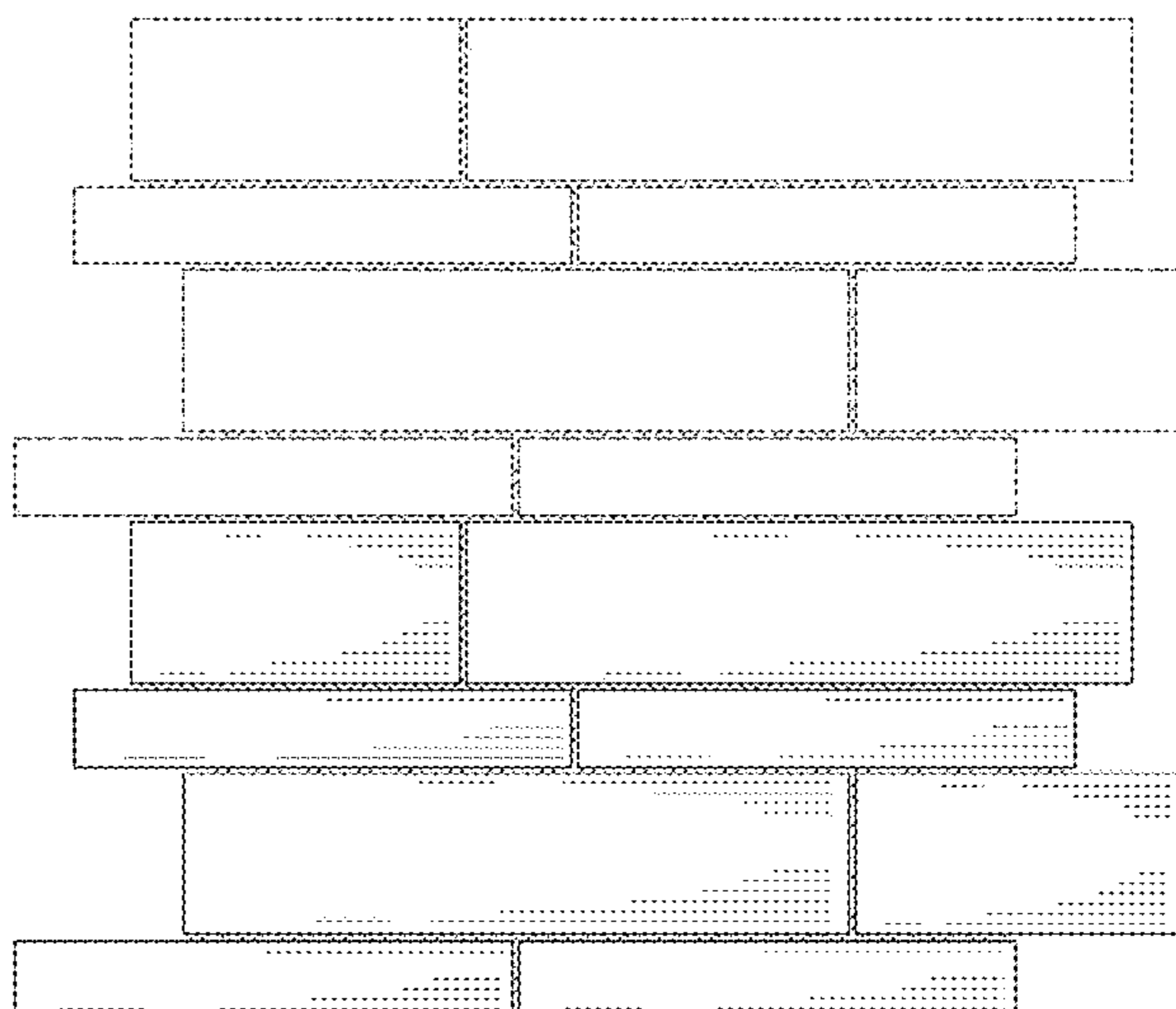
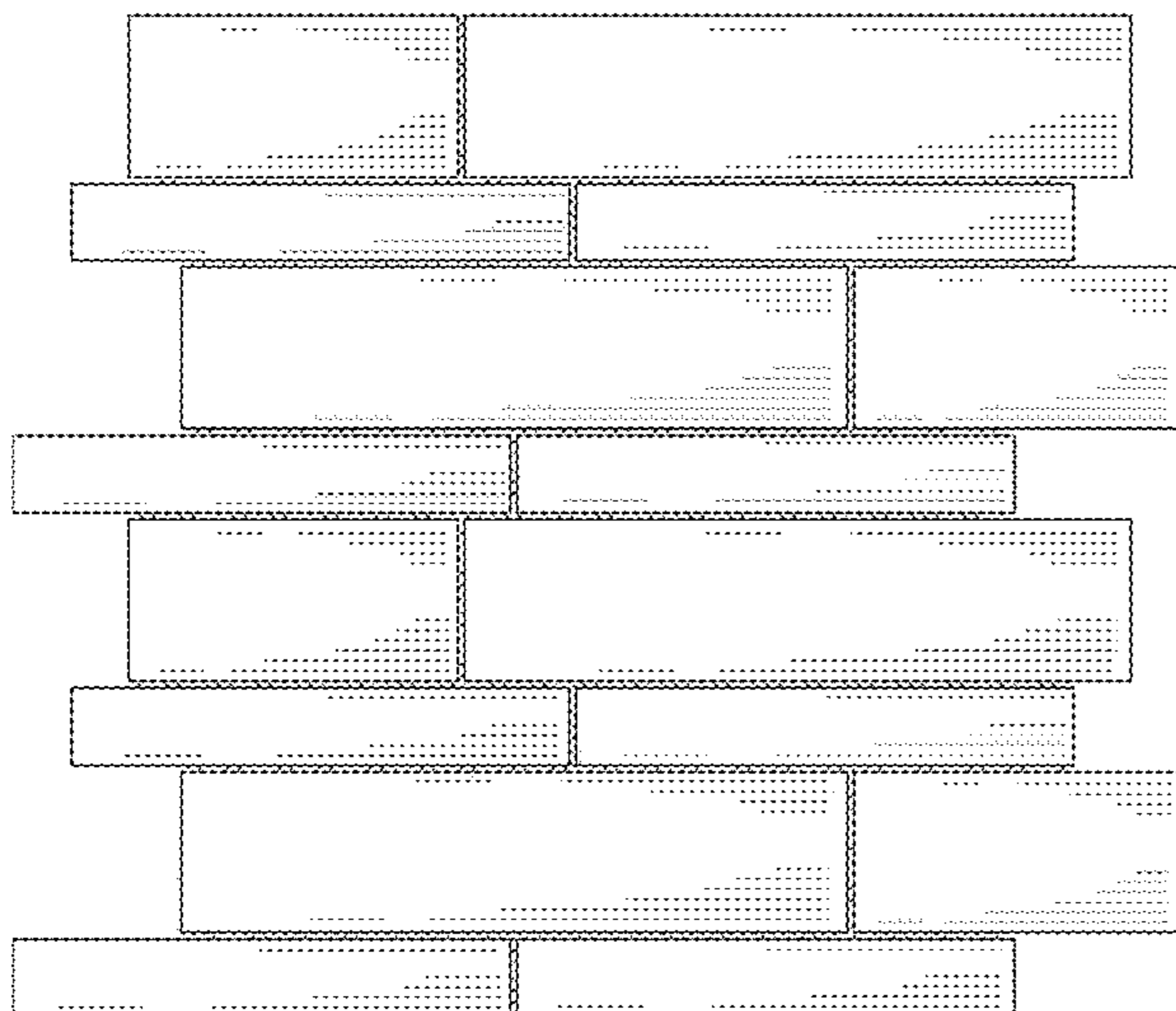
FIG. 8 is left-side view of my new design shown in FIG. 6.

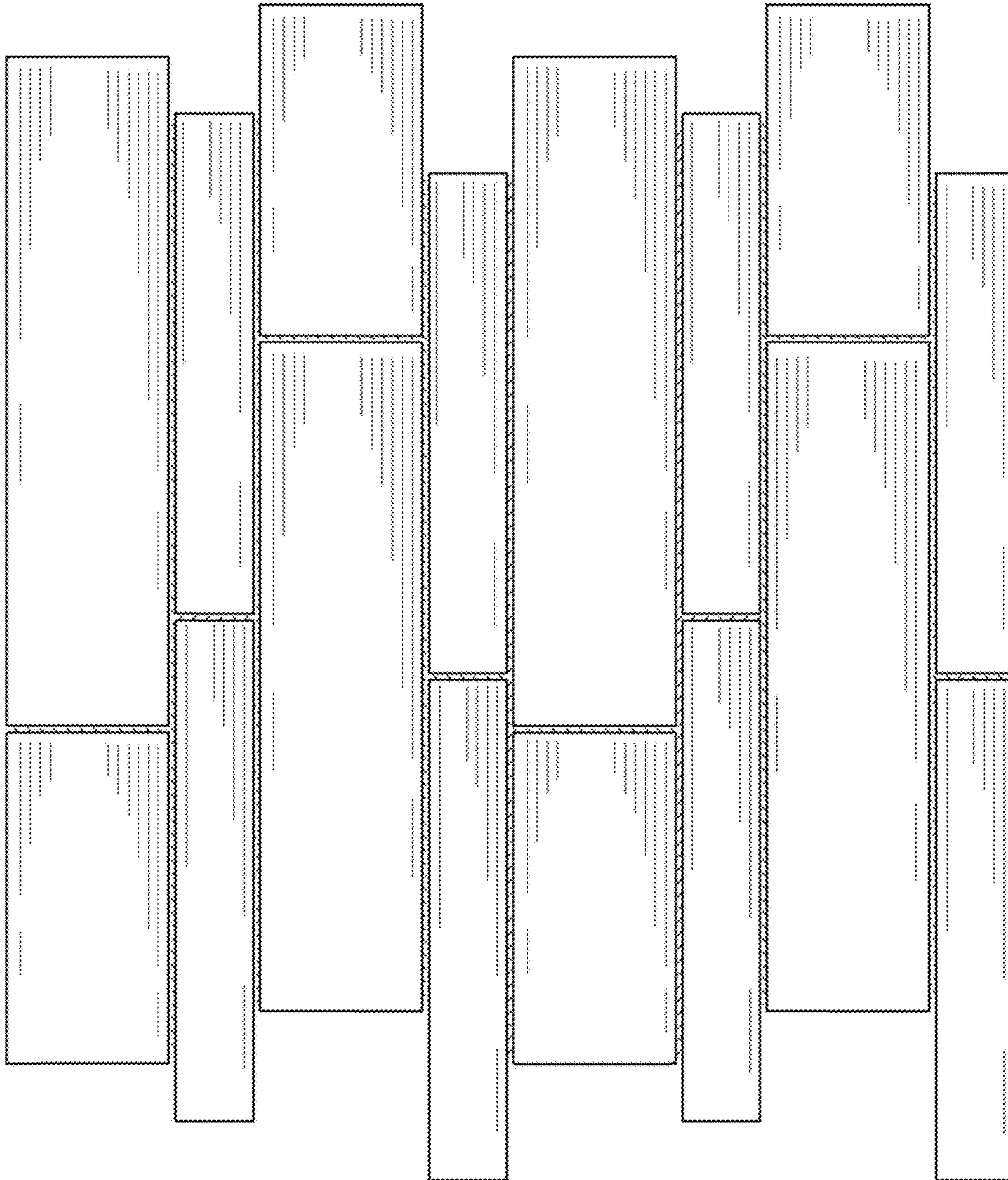

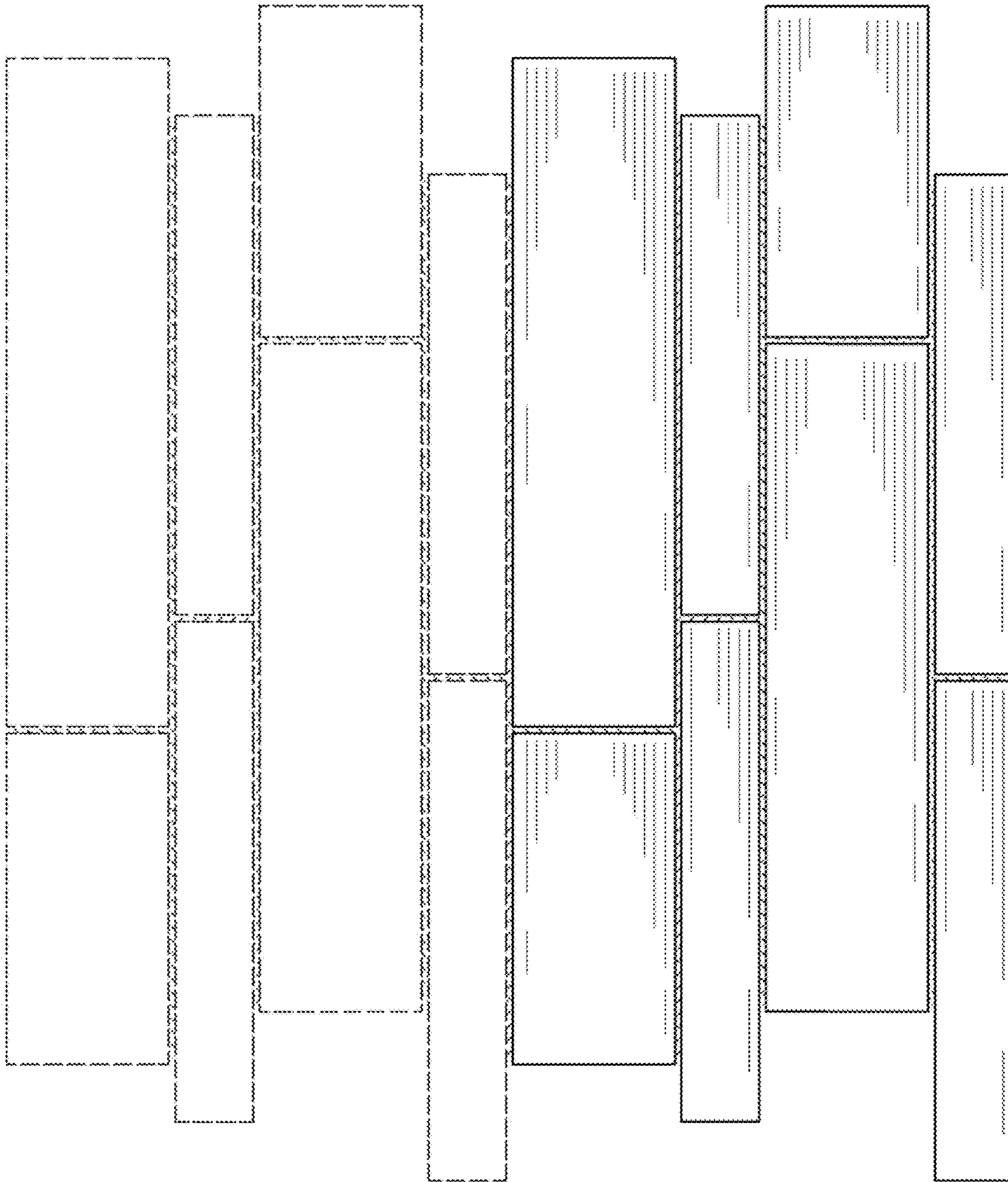

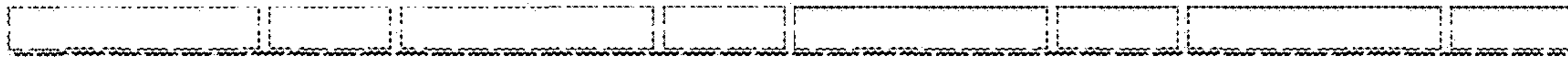

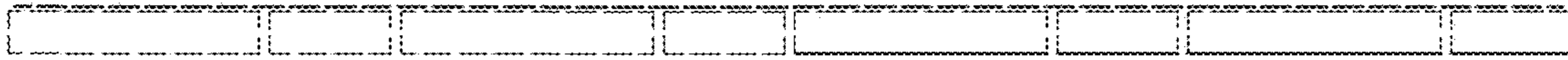
