(57) **CLAIM**

I claim the ornamental design for a pet-accessible vehicle window covering, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pet-accessible vehicle window covering according to an embodiment of the invention.

FIG. 2 is a perspective view of the pet-accessible vehicle window covering installed in an exemplary vehicle window according to an embodiment of the invention.

FIG. 3 is a right view of the pet-accessible vehicle window covering as shown in FIG. 1;

FIG. 4 is a left view of the pet-accessible vehicle window covering as shown in FIG. 1;

FIG. 5 is a top view of the pet-accessible vehicle window covering as shown in FIG. 1;

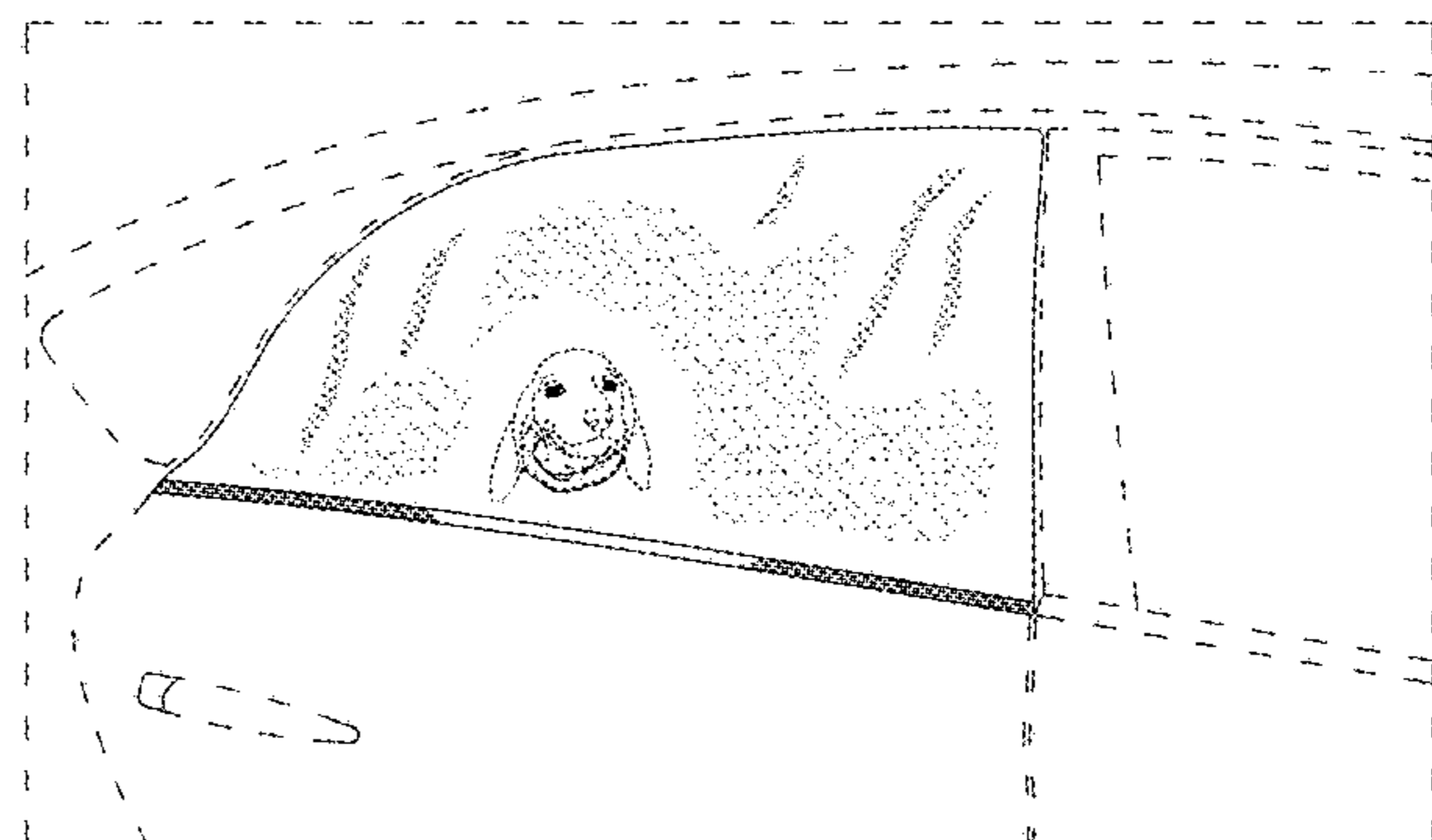
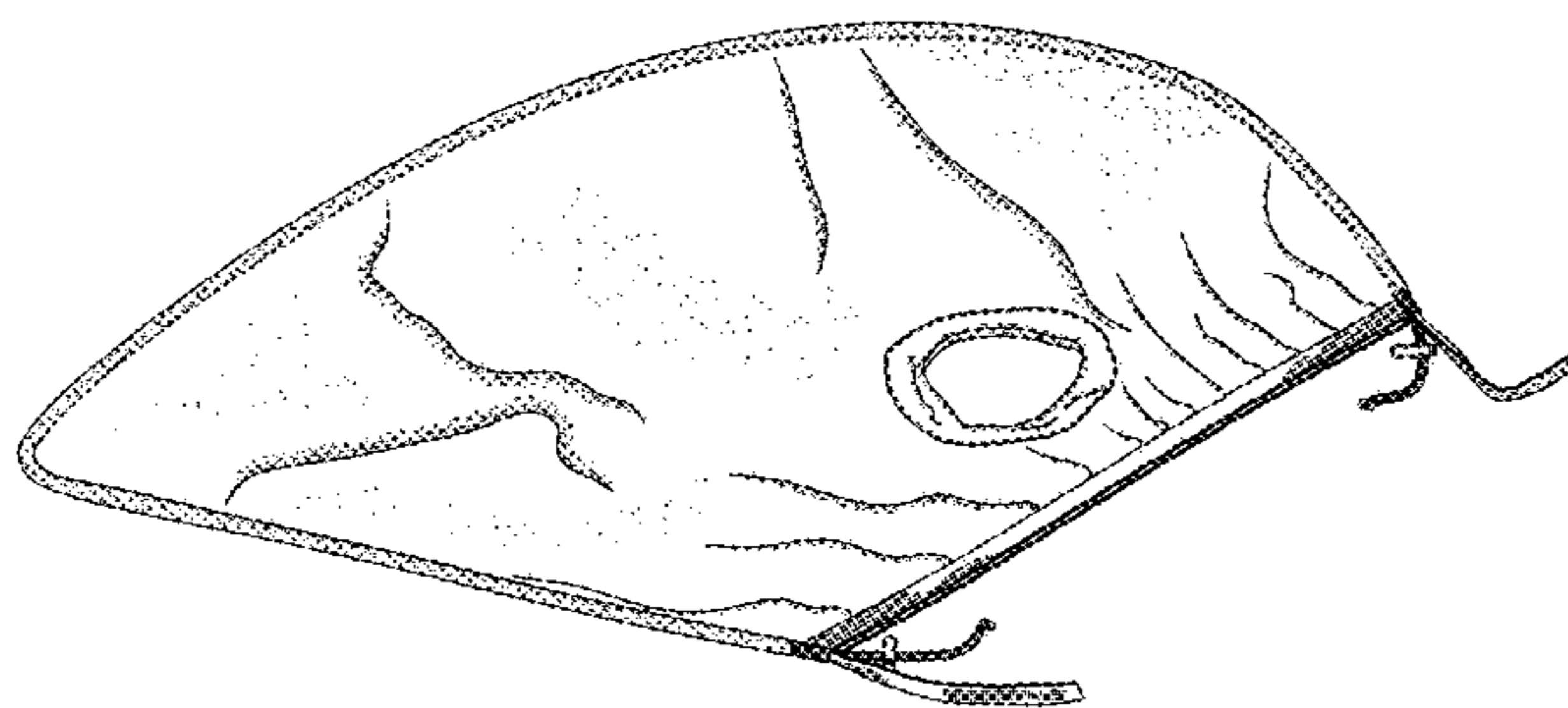
FIG. 6 is a bottom view of the pet-accessible vehicle window covering as shown in FIG. 1;

FIG. 7 is a front-side view of the pet-accessible vehicle window covering as shown in FIG. 1; and,

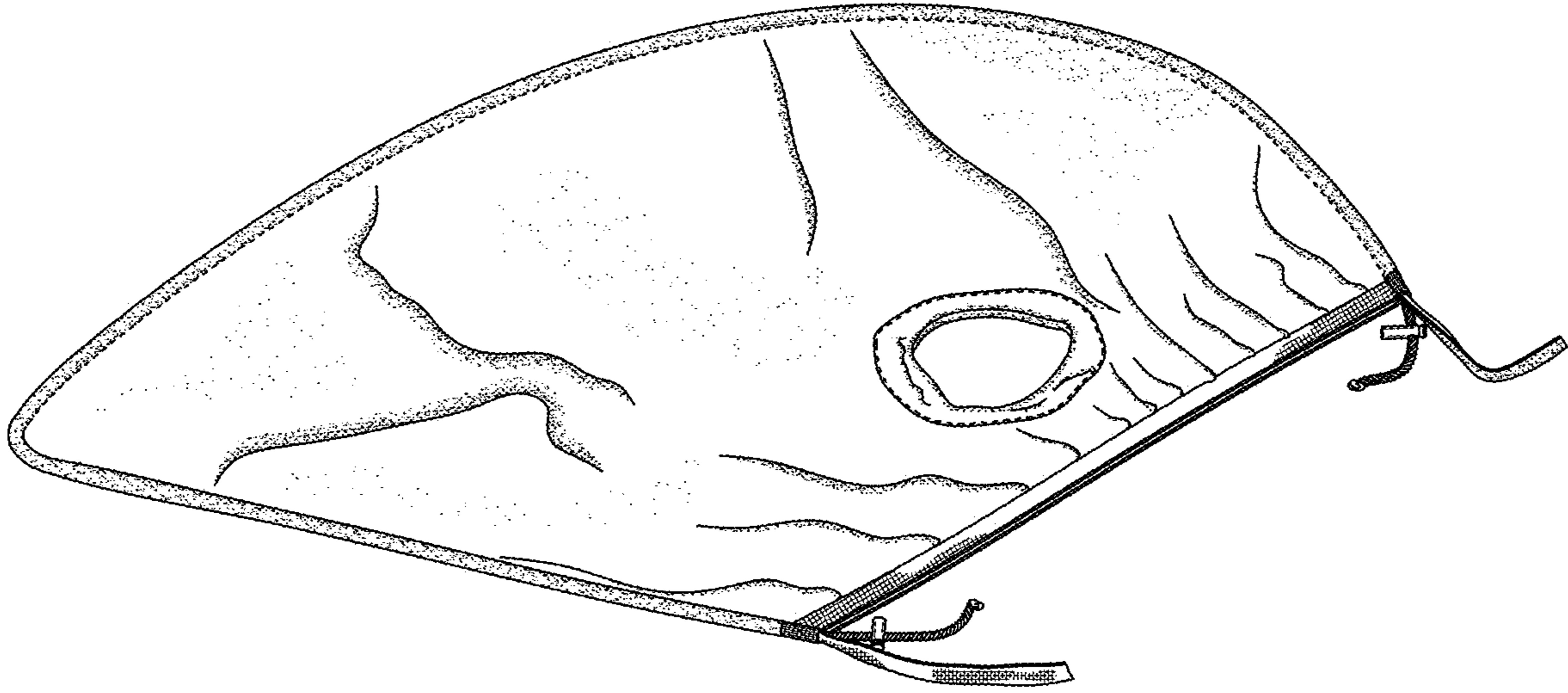

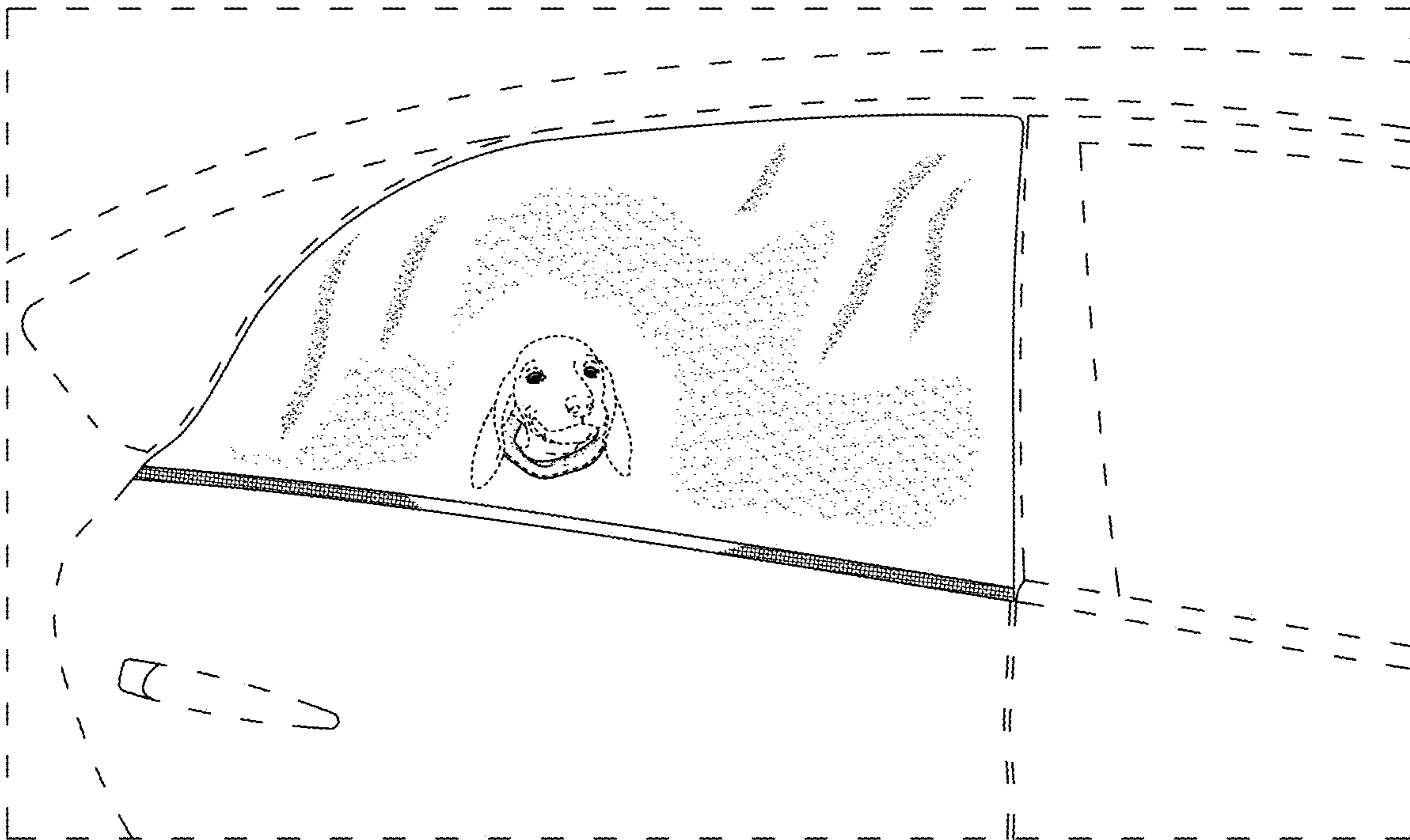

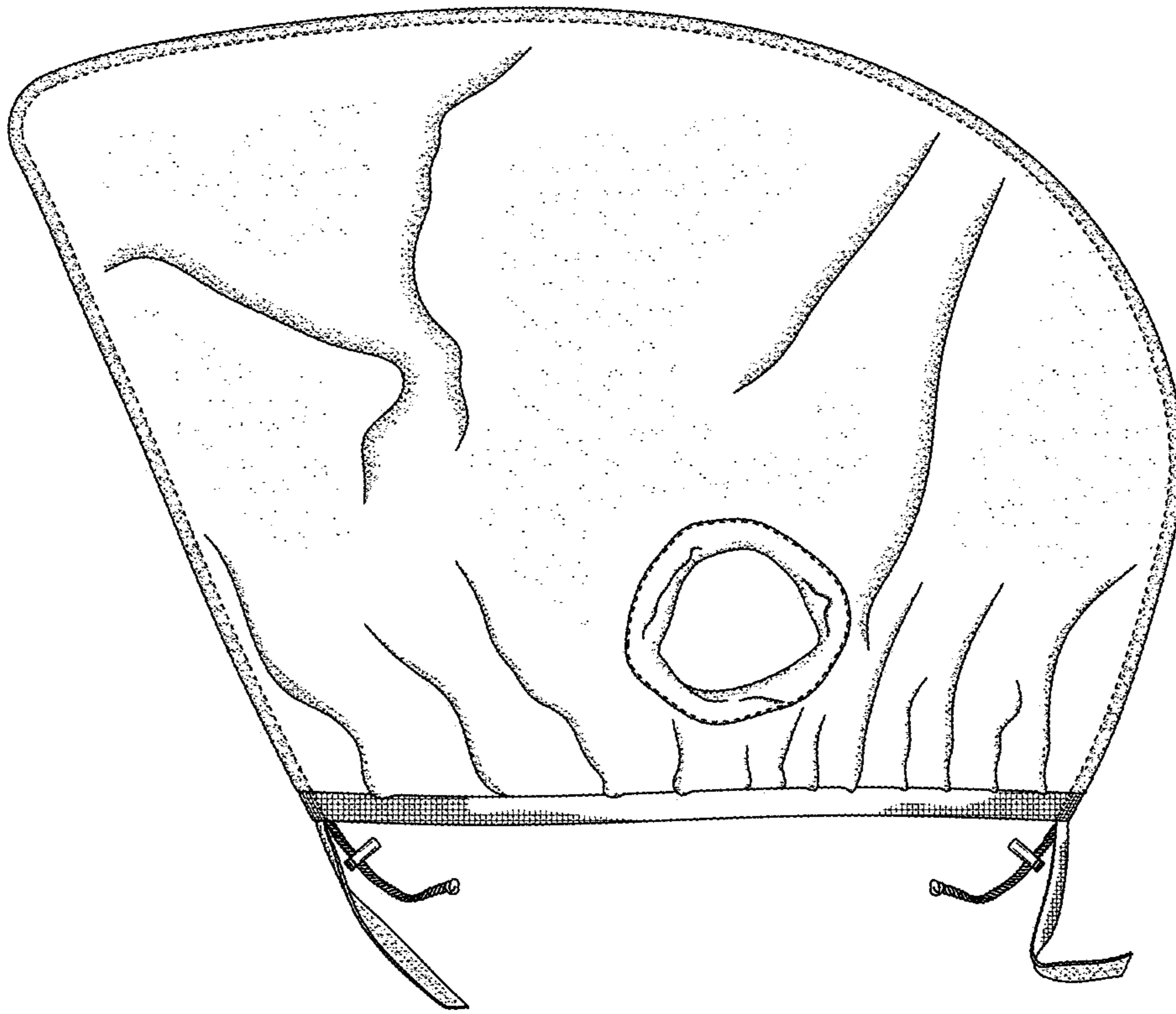

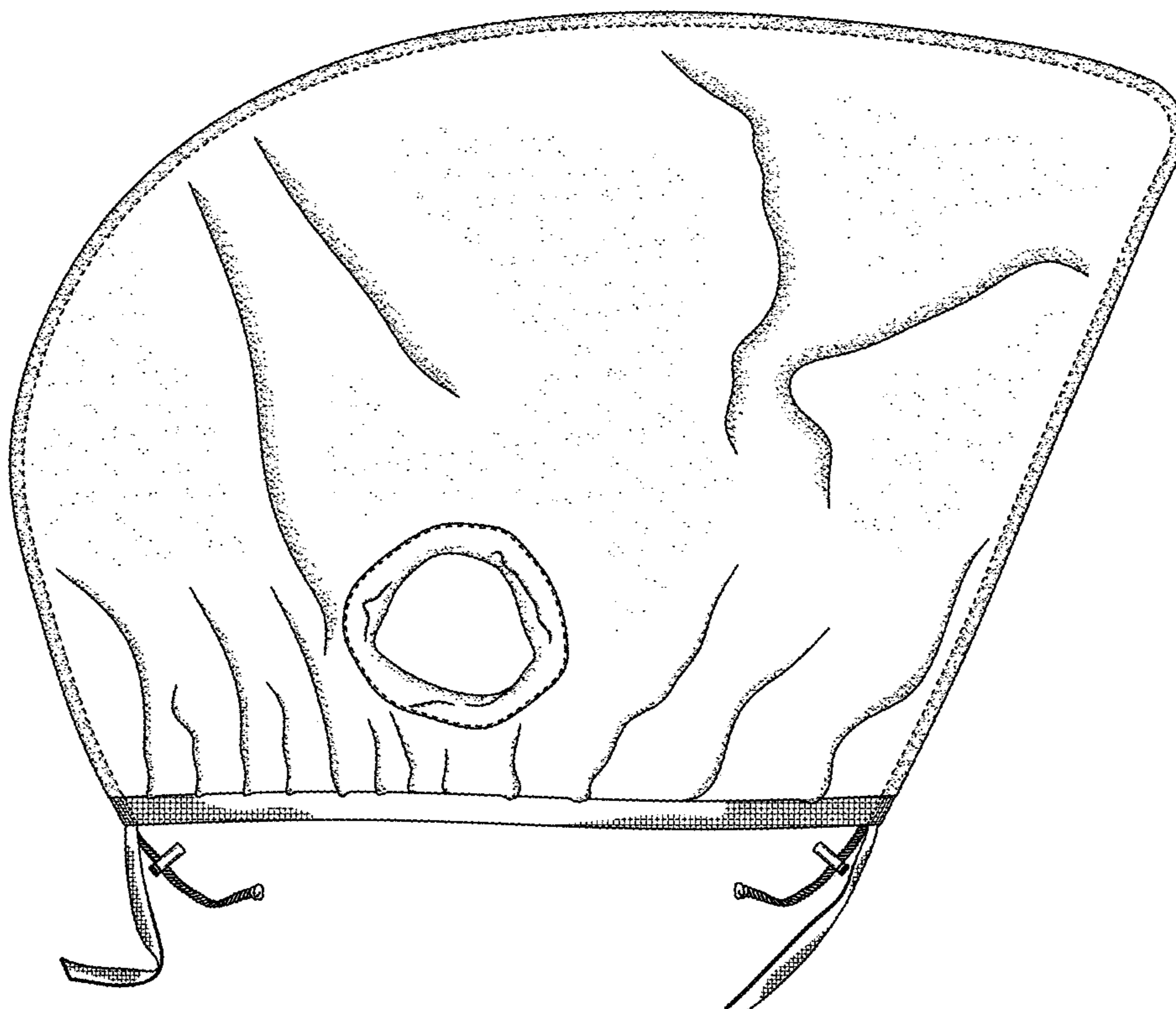

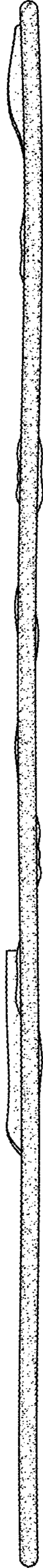

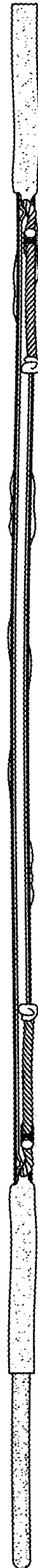

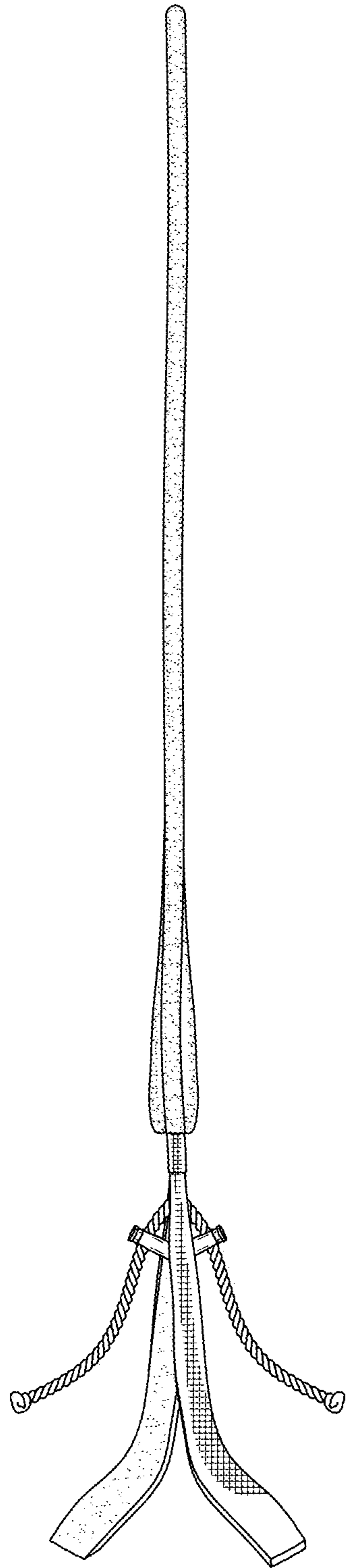

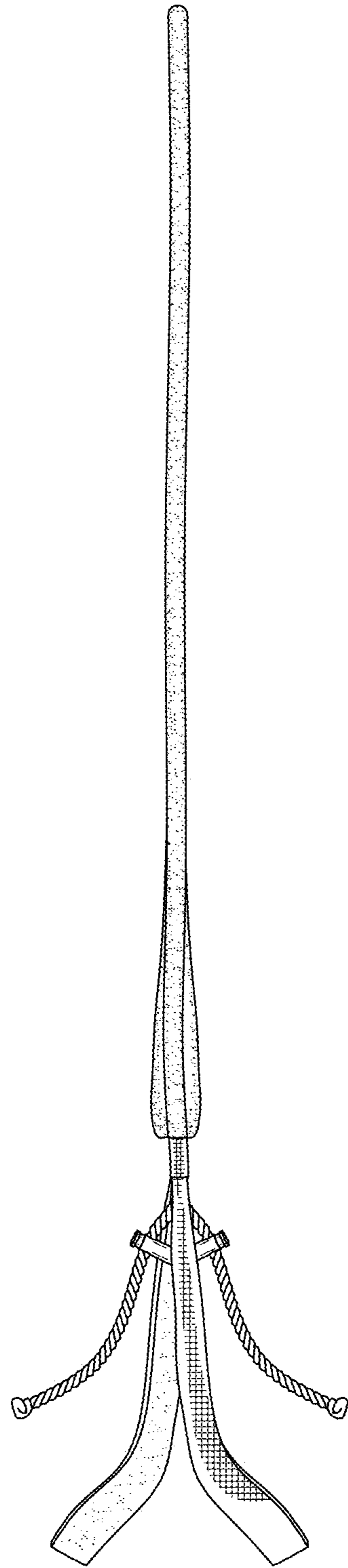
