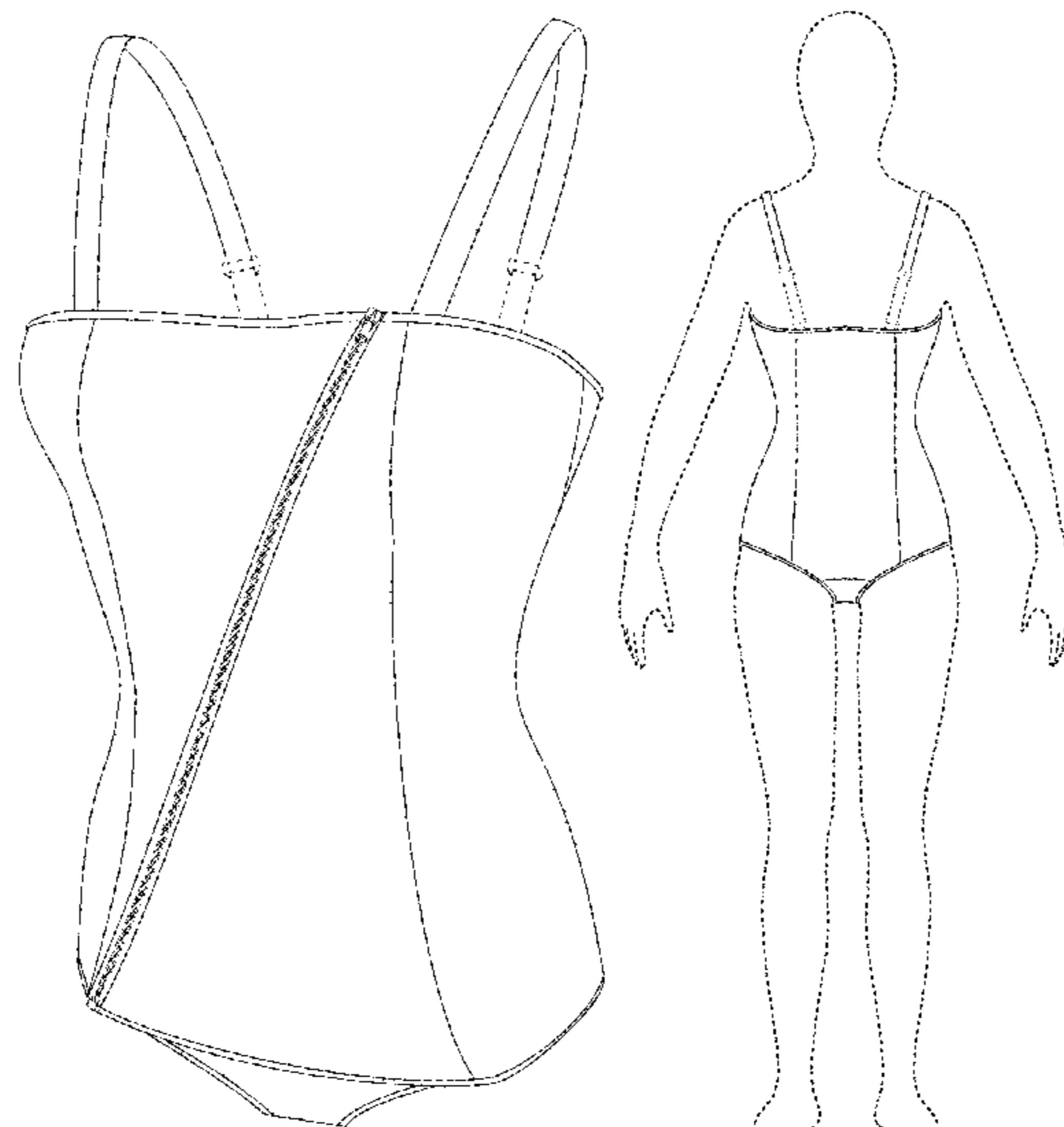
(57) **CLAIM**

The ornamental design for a swimsuit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the swimsuit that is the present invention.  
FIG. 2 is a front view of the swimsuit shown in FIG. 1, presented as worn.  
FIG. 3 is a reduced back view of swimsuit shown in FIG. 1, presented as worn.  
FIG. 4 is right side view of the swimsuit shown in FIG. 1, presented as worn.  
FIG. 5 is a left side view of the swimsuit shown in FIG. 1, presented as worn.  
FIG. 6 is a top view of the swimsuit shown in FIG. 1; and, FIG. 7 is a bottom view of the swimsuit shown in FIG. 1. In FIGS. 2-5, the broken lines showing portions of the human figure illustrate the design as worn and form no part of the claimed design. In FIGS. 1-7, the portions of the swimsuit depicted as broken lines form no part of the claimed design.

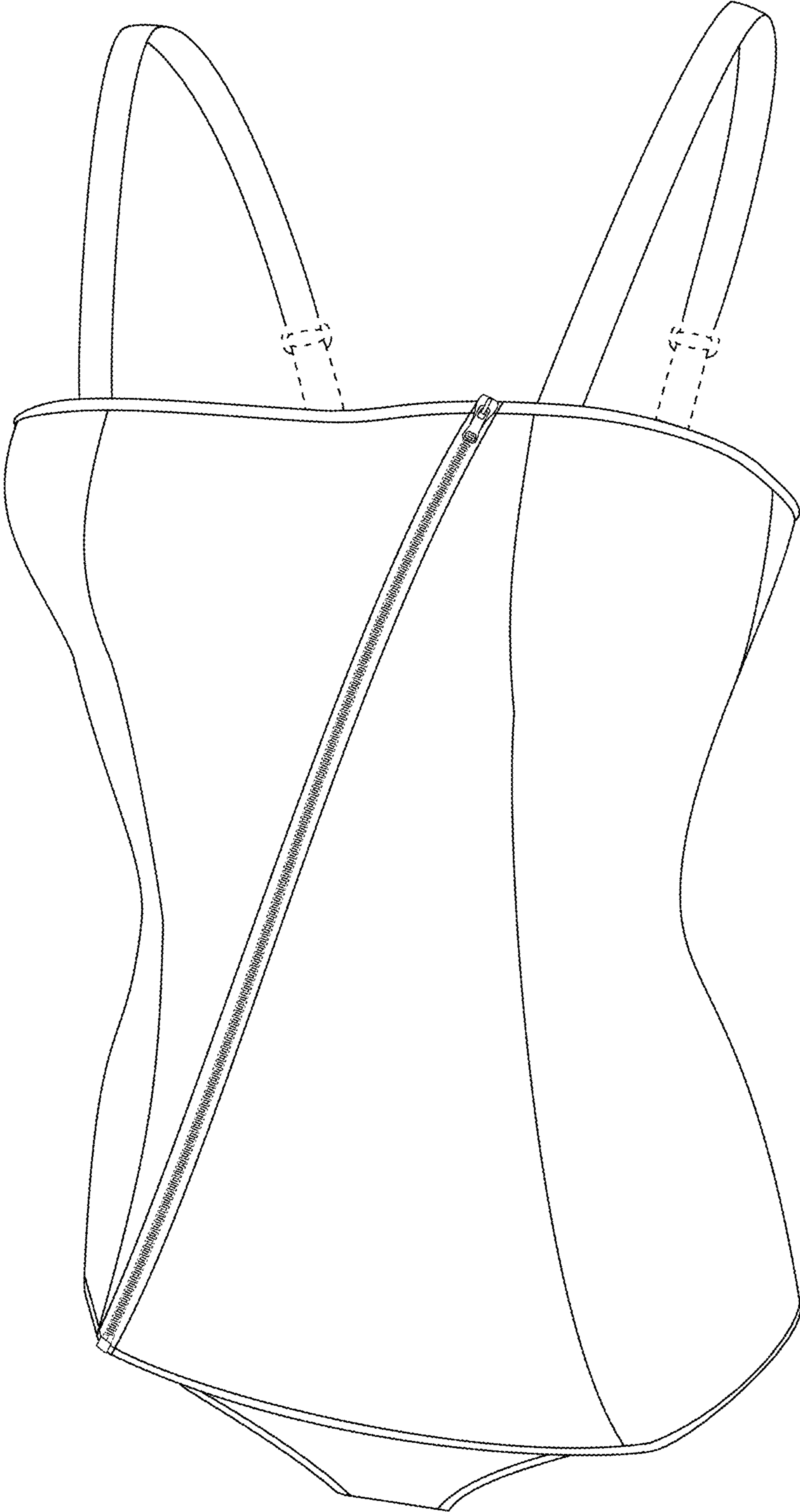

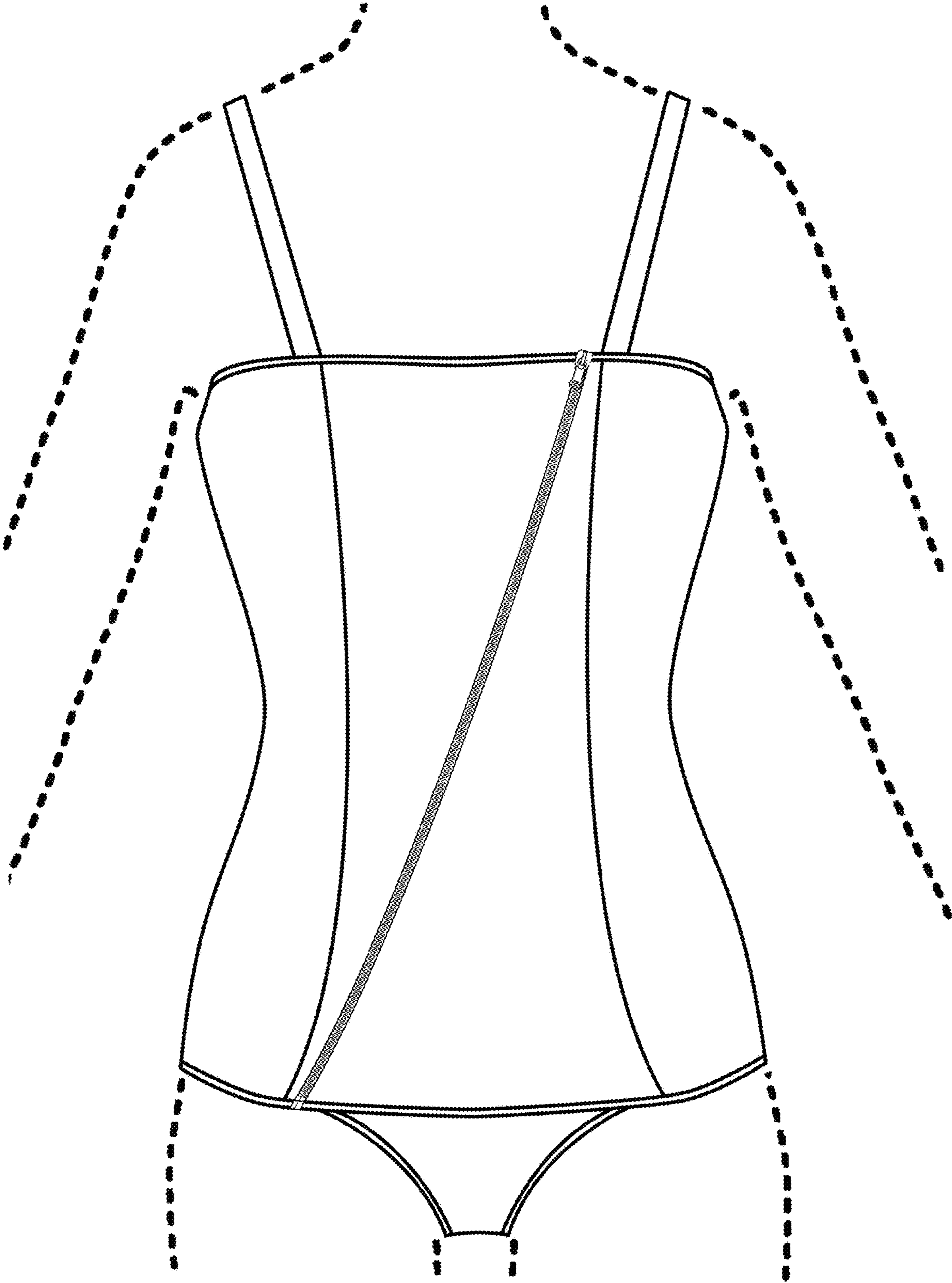

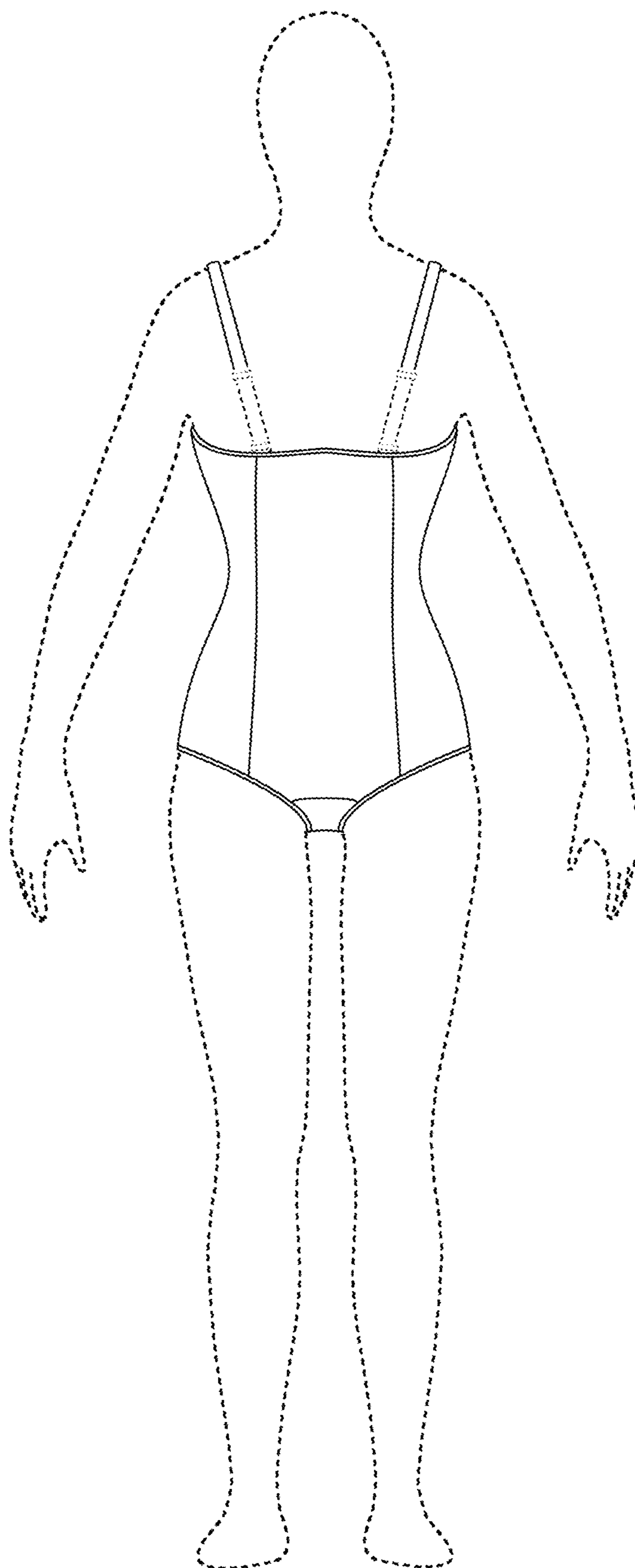

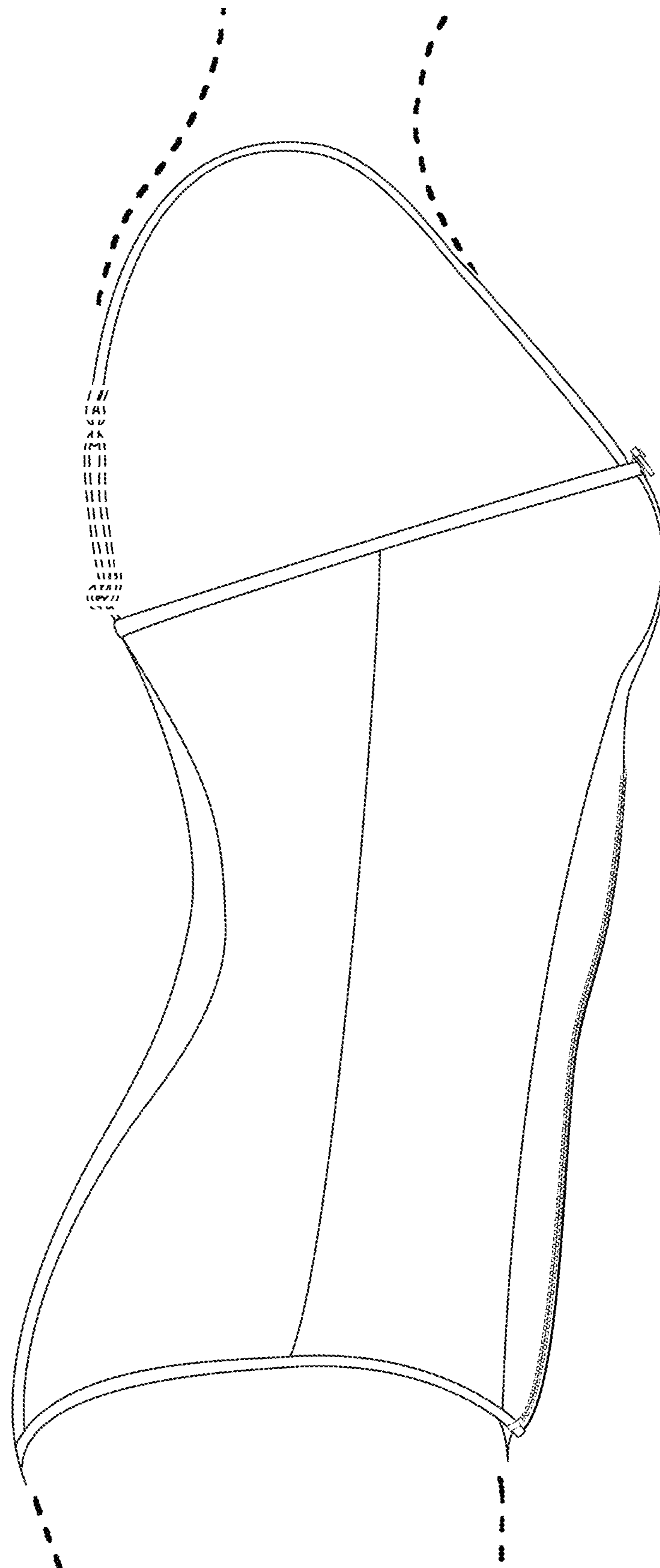

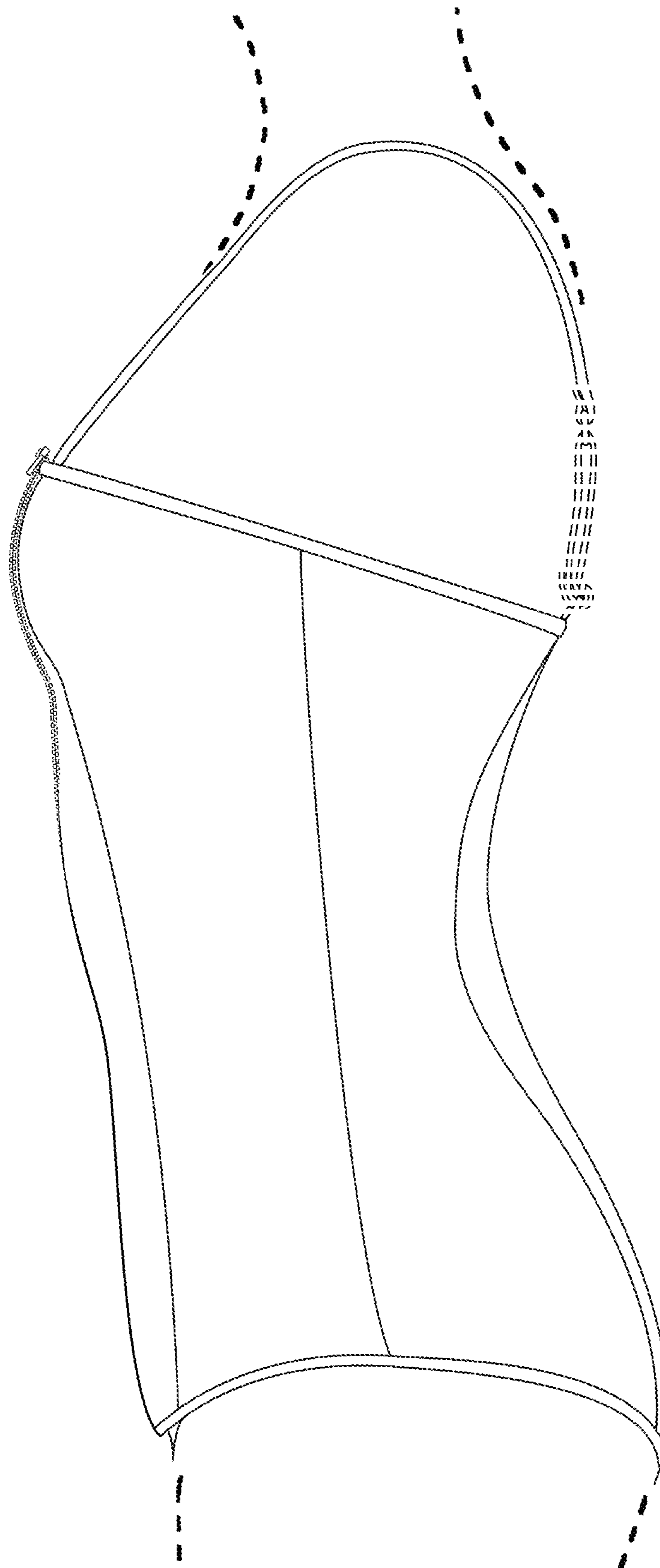

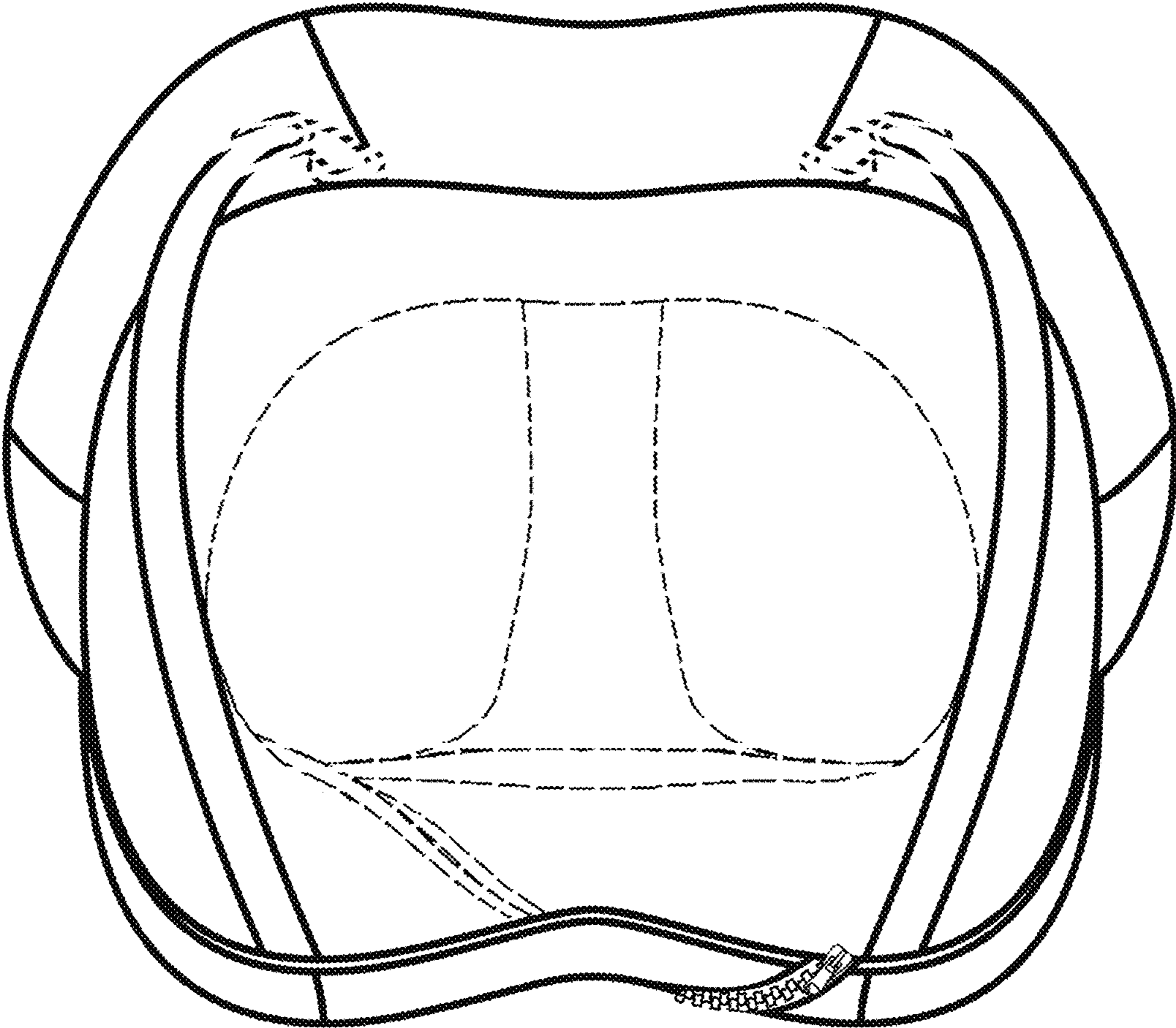

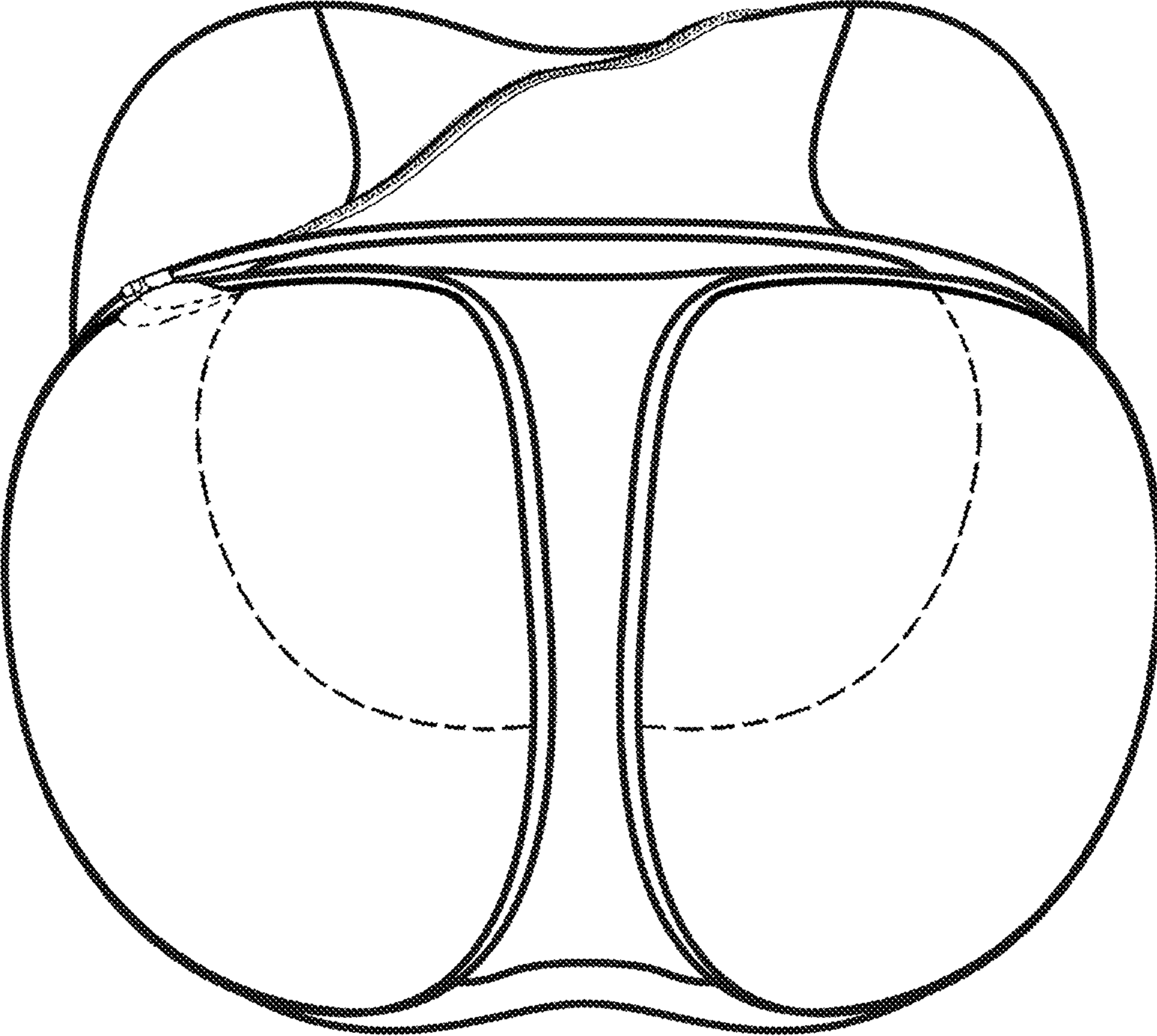
