DESCRIPTION

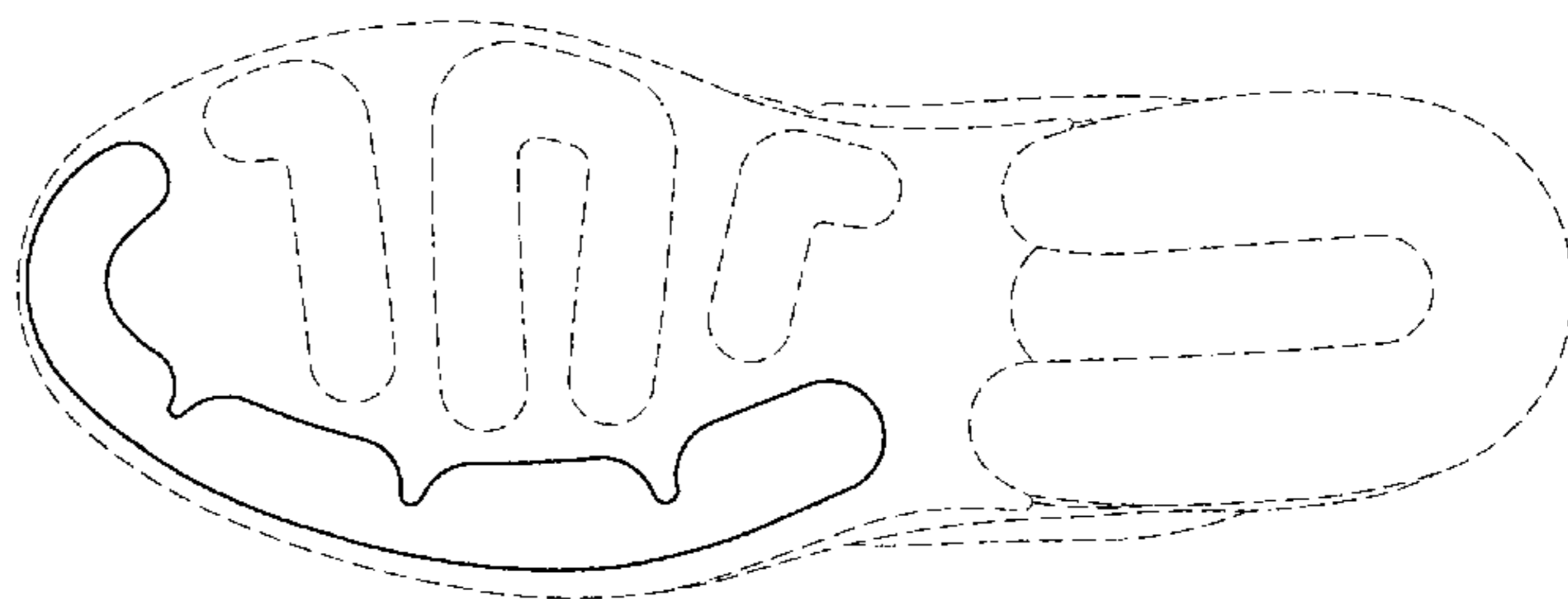
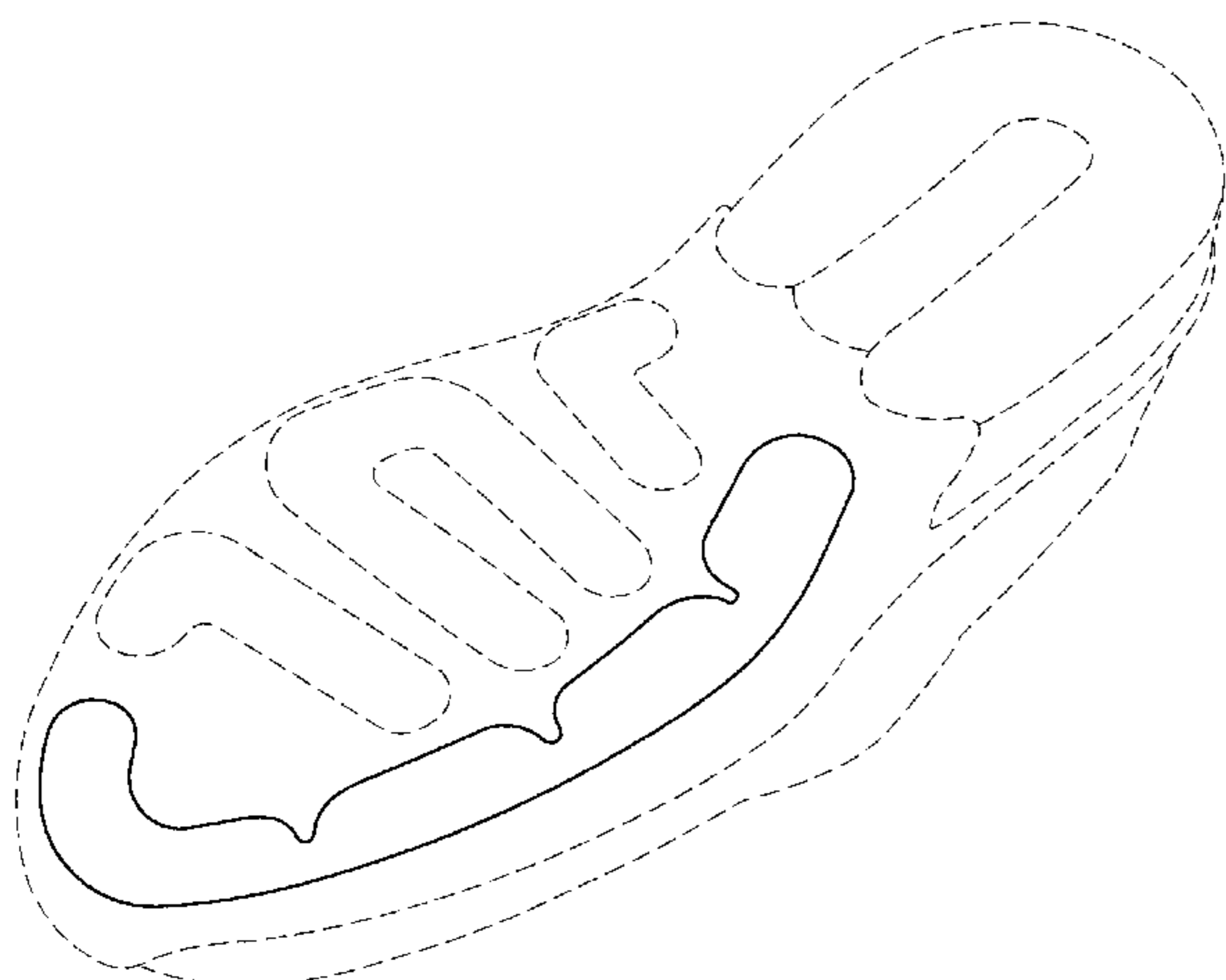
FIG. 1 is a front, first side perspective view of a shoe showing my design;

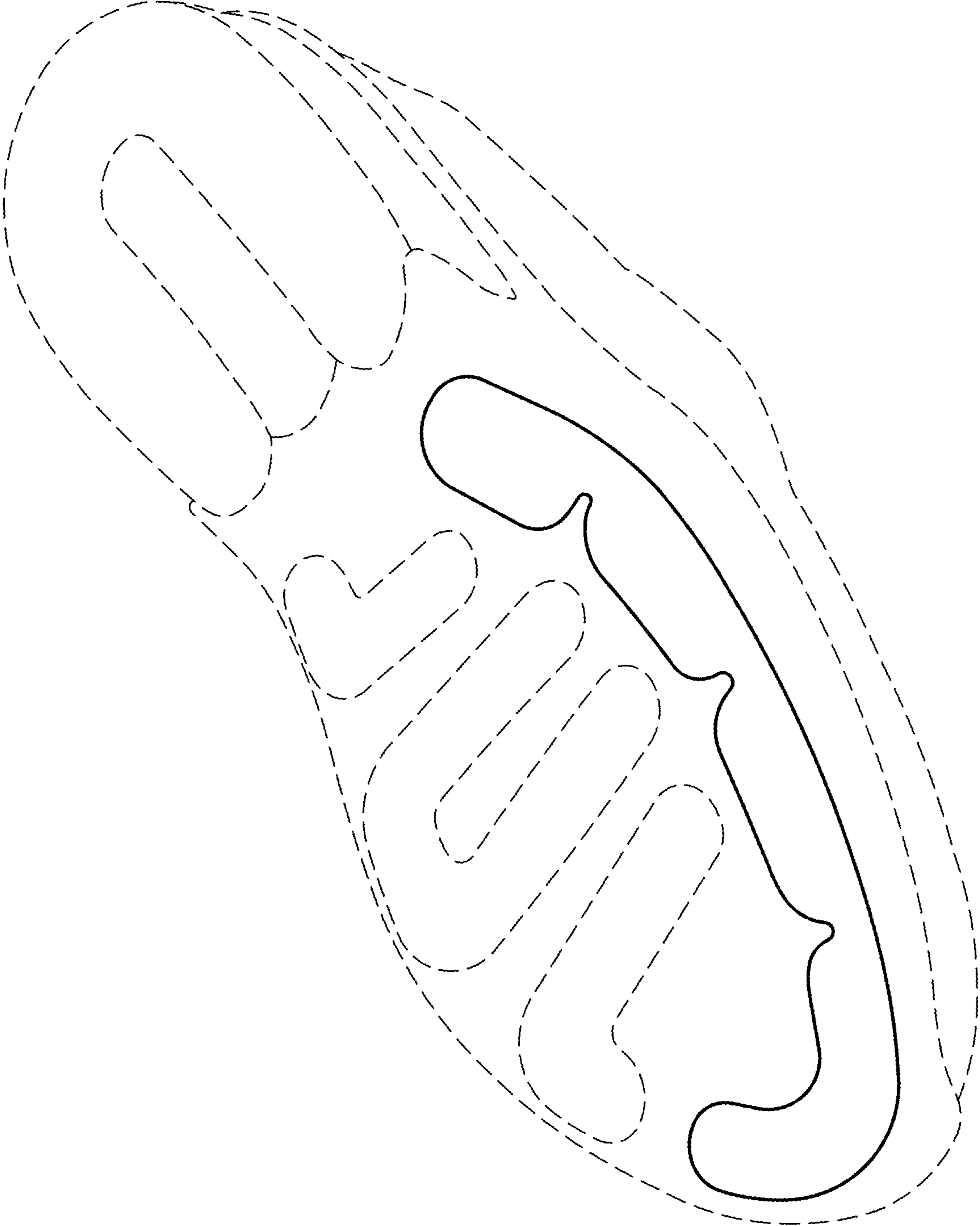

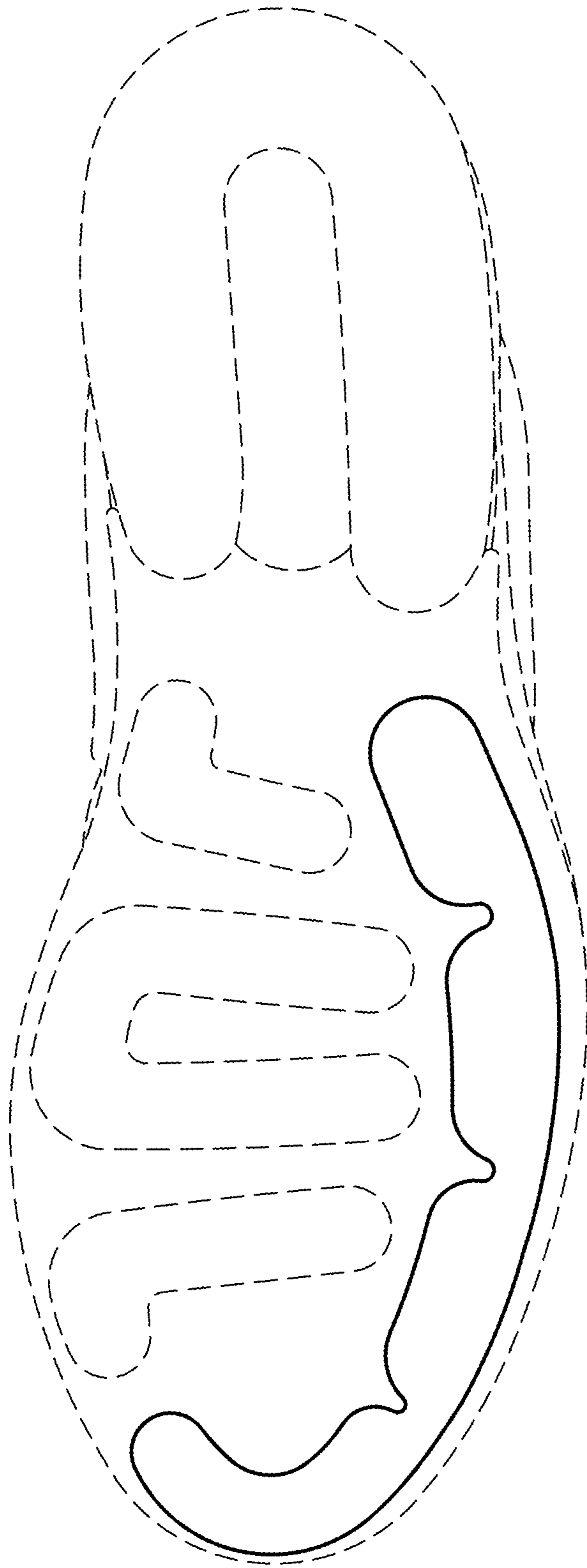

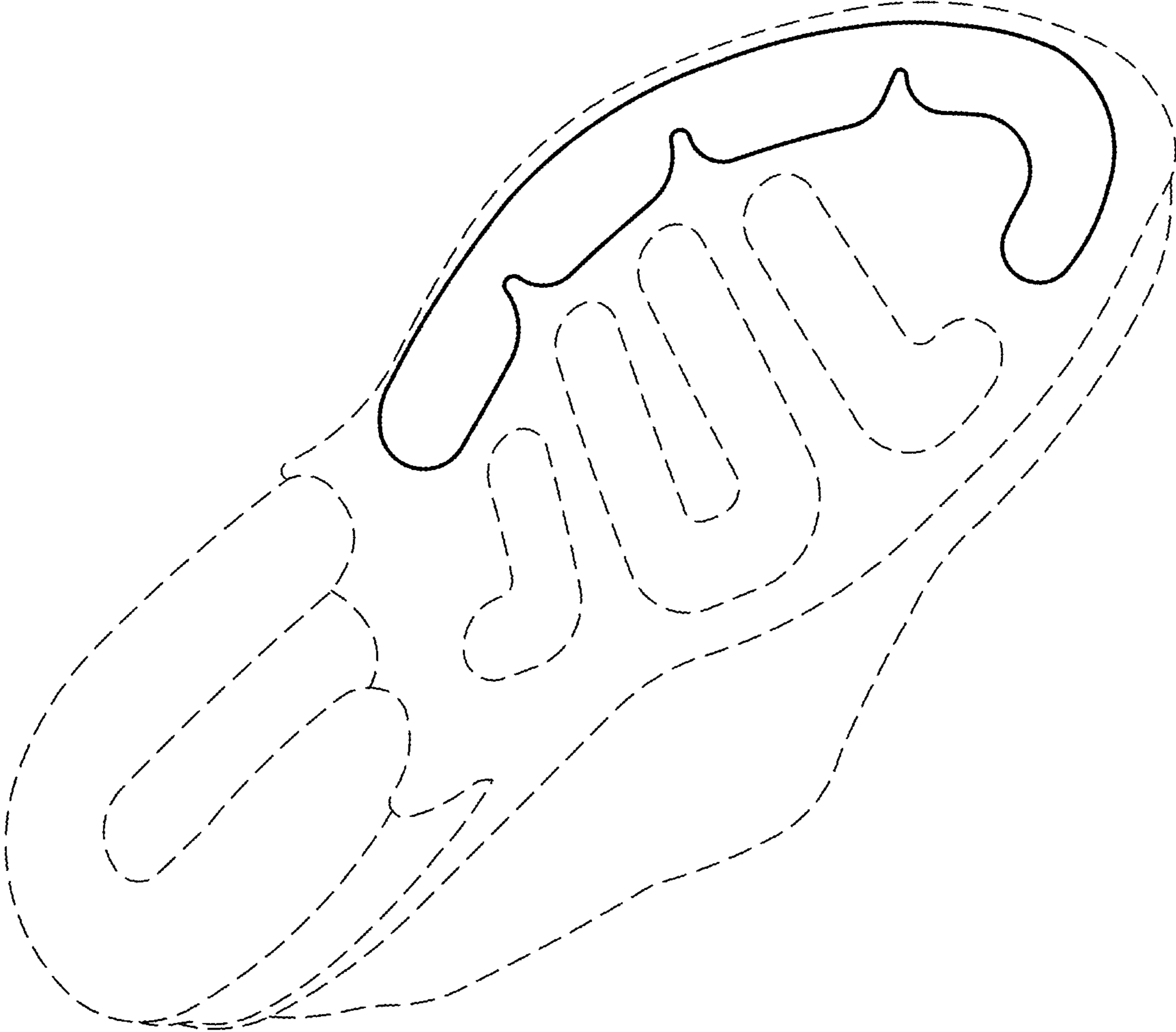
