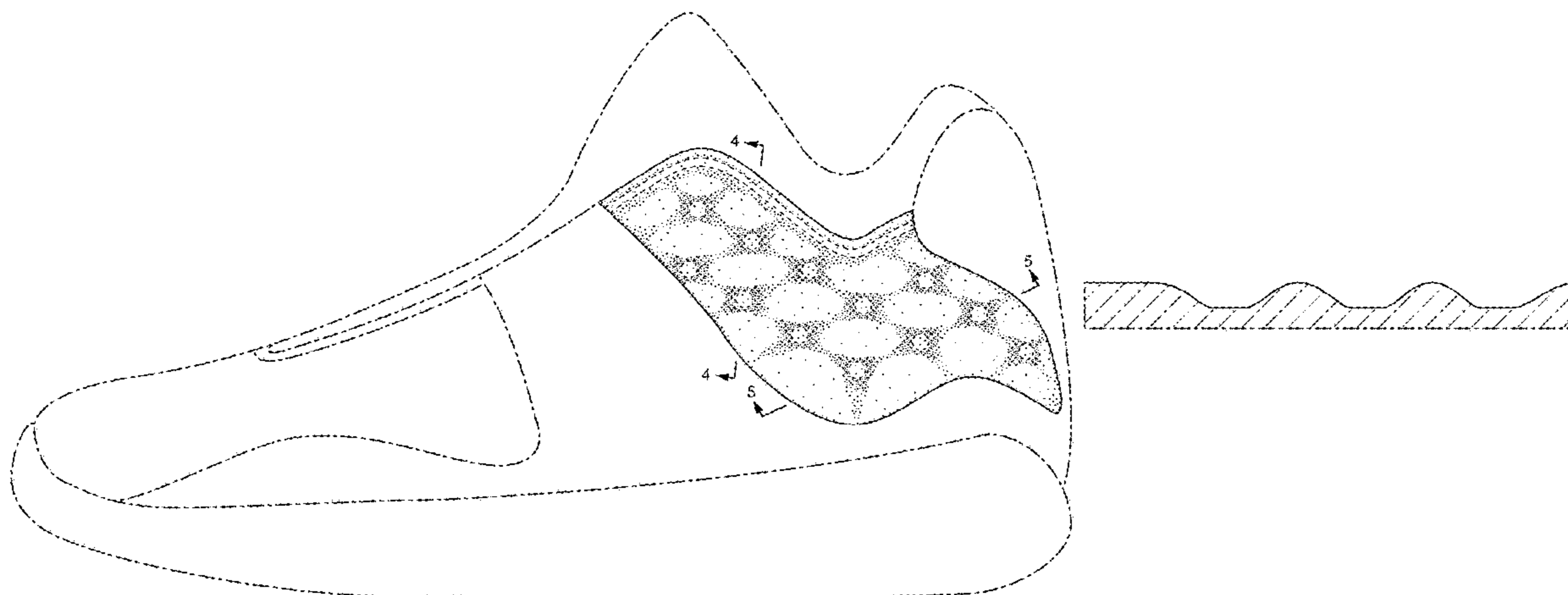
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is a cross section taken through line 4-4 of FIG. 2;  
and,  
FIG. 5 is a cross section taken through line 5-5 of FIG. 2.  
The even-length broken lines within the shaded area represent stitching. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

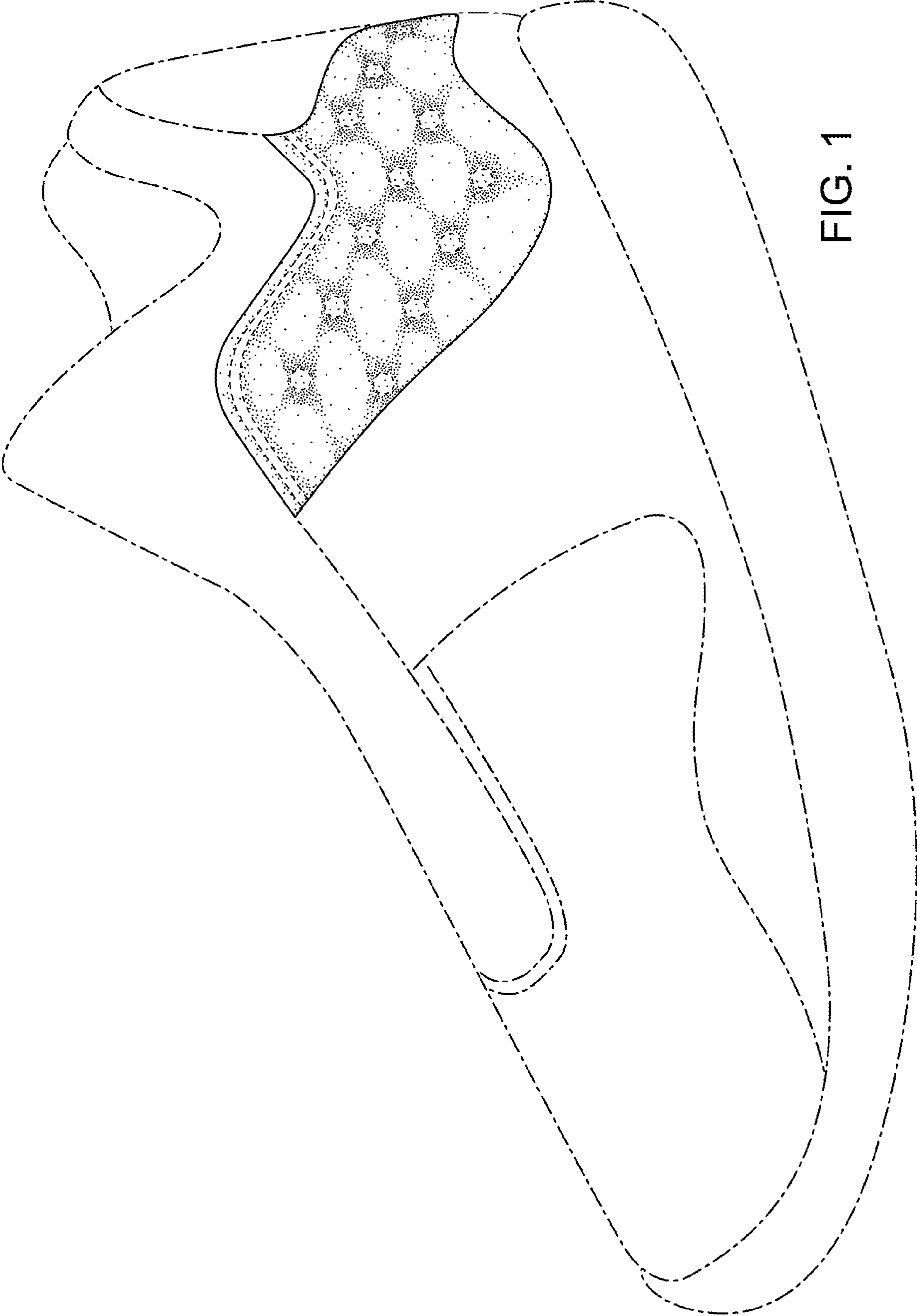

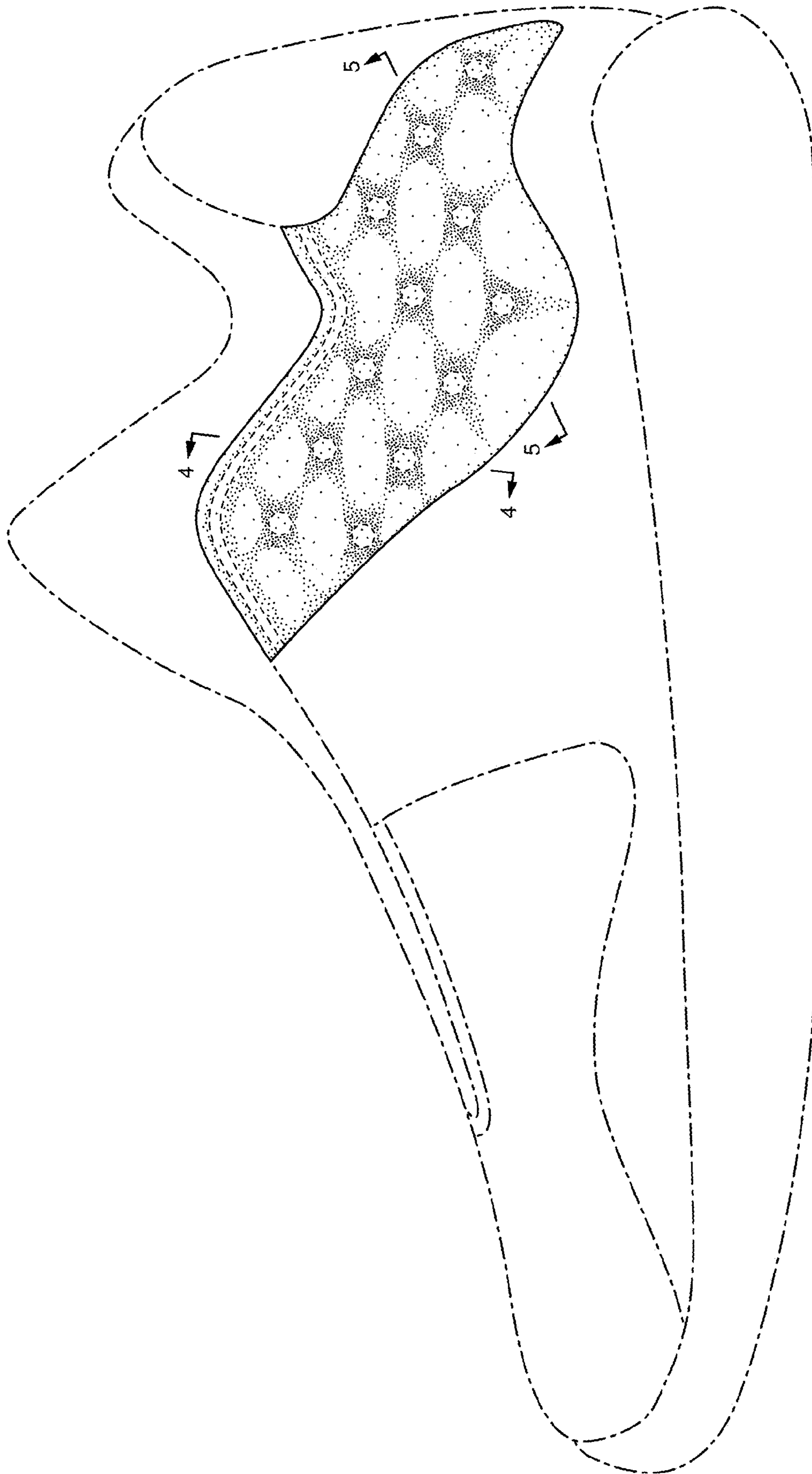

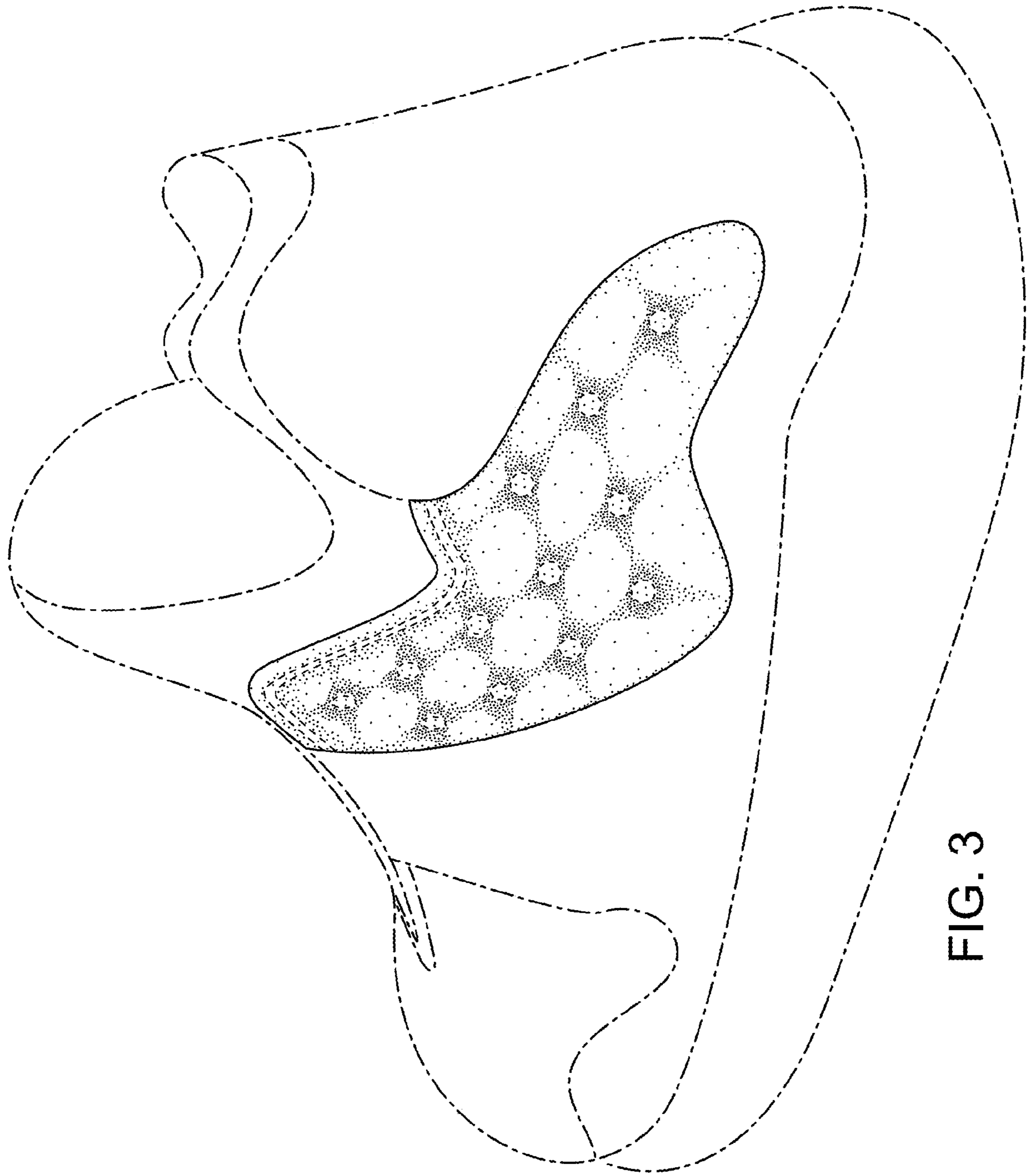
