FIG. 3 is a rear view of the vehicle under-seat container thereof;

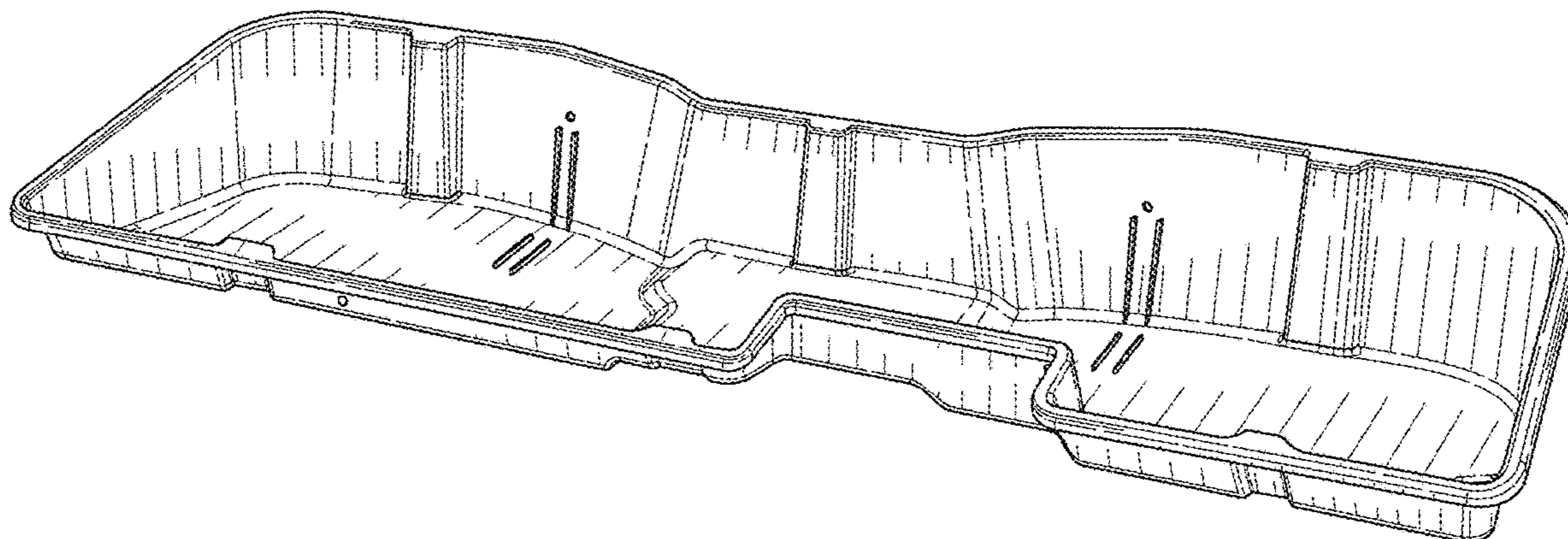
FIG. 4 is a right view of the vehicle under-seat container thereof;

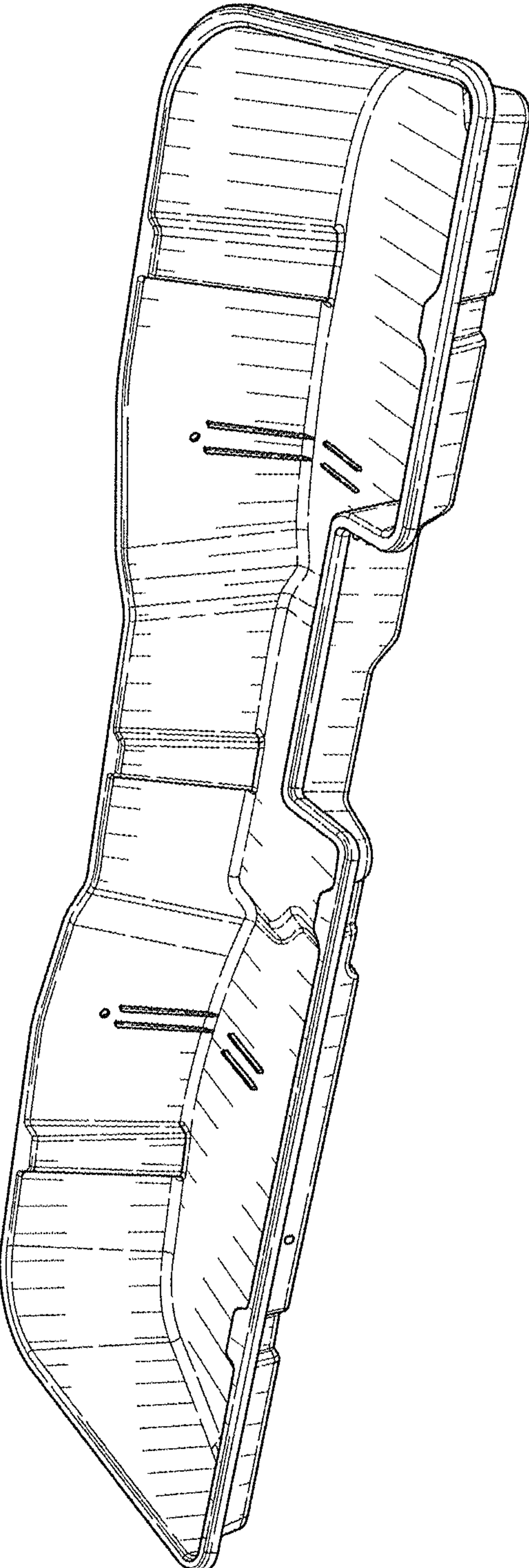

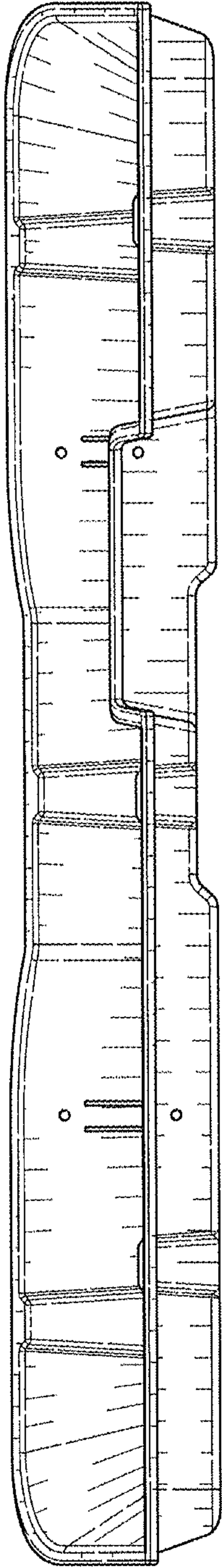

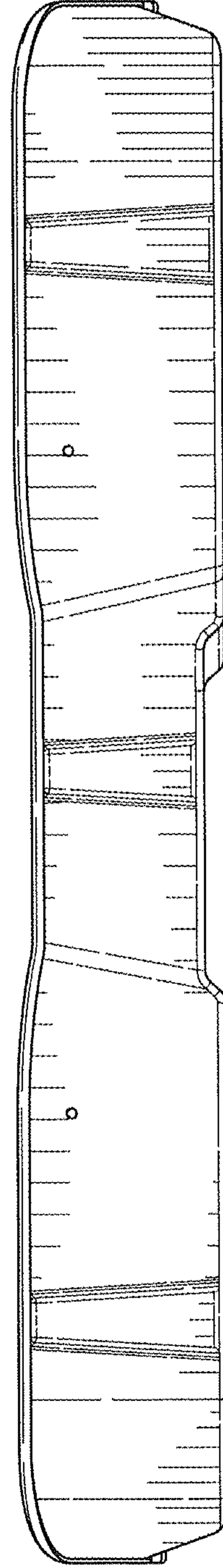

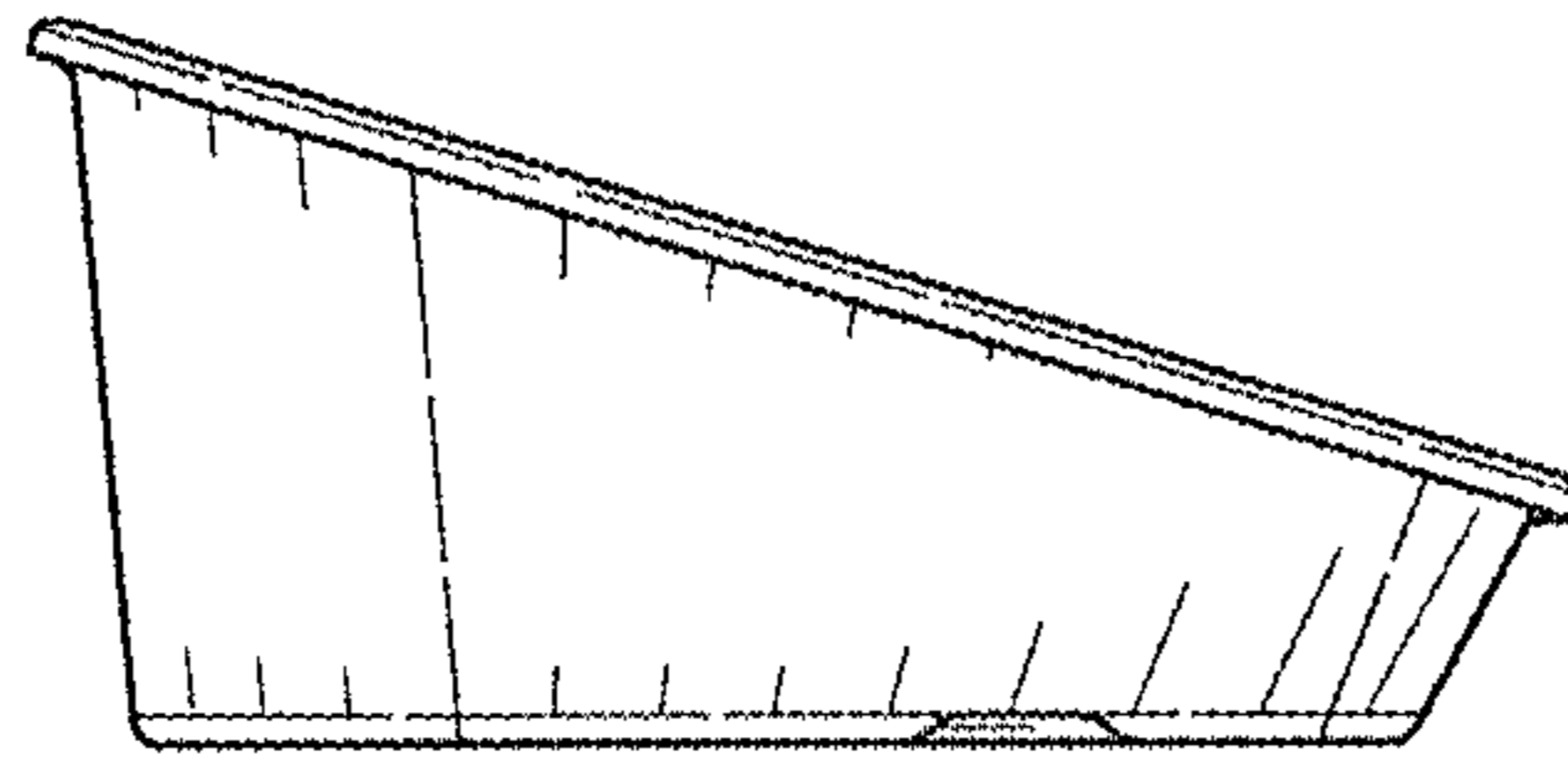

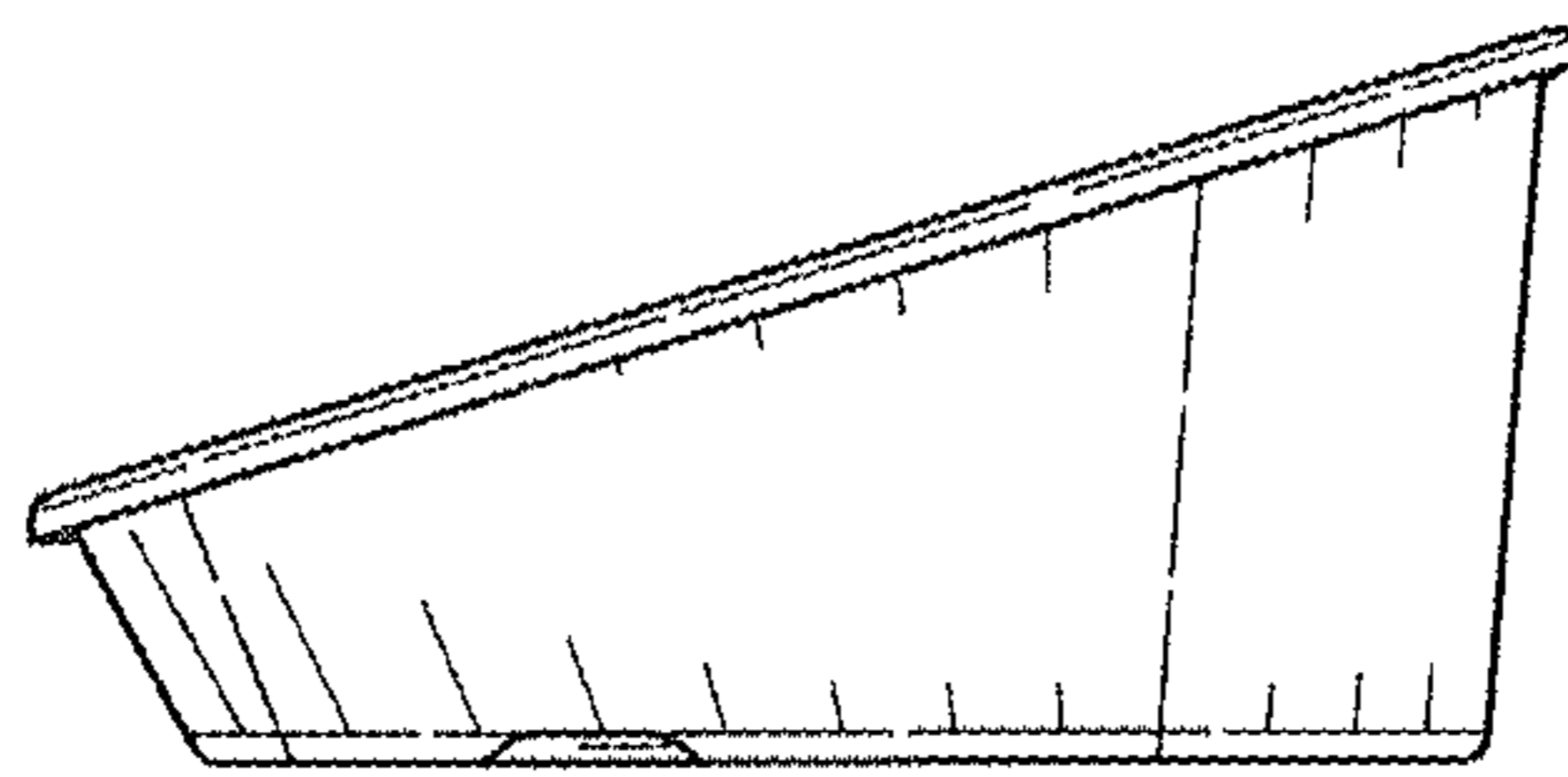

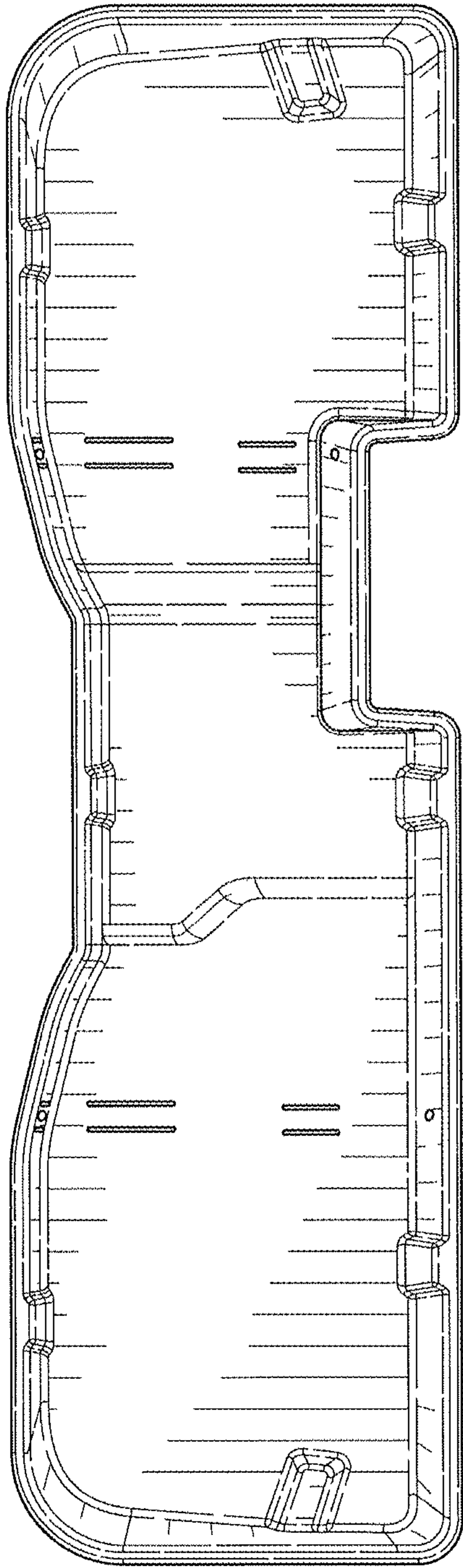

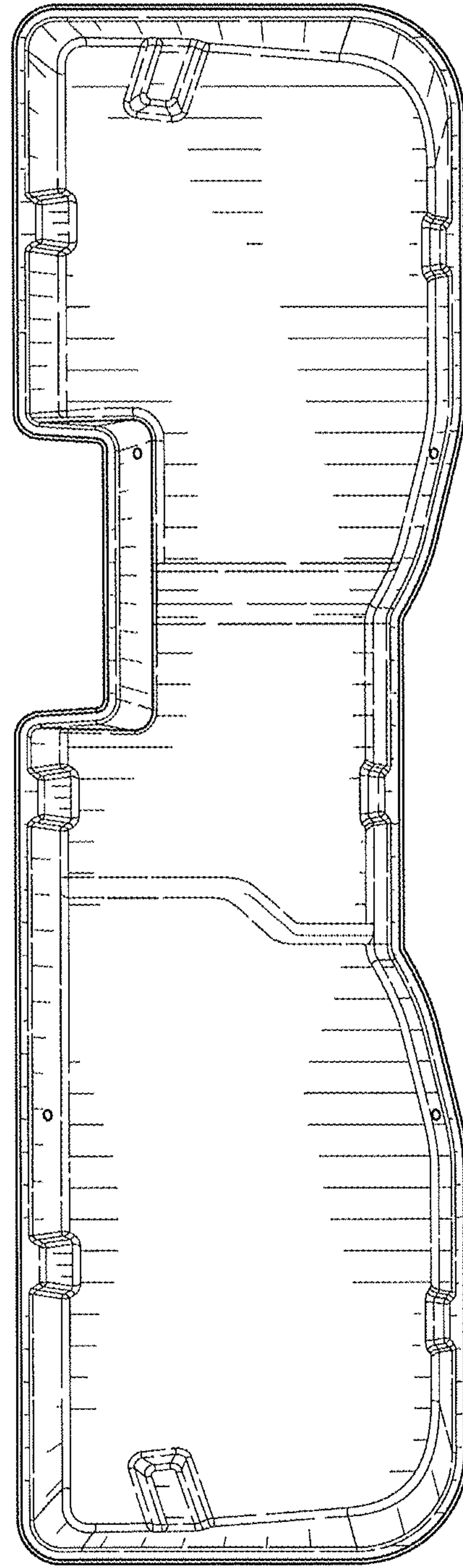
