(57) **CLAIM**

We claim the ornamental design for an embossed wipe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embossed wipe incorporating the ornamental design of the present invention. FIG. 2 is a top plan view of the embossed wipe of FIG. 1. FIG. 3 is a bottom plan view of the embossed wipe of FIG. 1. FIG. 4 is a front perspective view of the embossed wipe of FIG. 1. FIG. 5 is a left side perspective view of the embossed wipe of FIG. 1. FIG. 6 is a rear perspective view of the embossed wipe of FIG. 1. FIG. 7 is a right side perspective view of the embossed wipe of FIG. 1. FIG. 8 is a front view of the embossed wipe of FIG. 1. FIG. 9 is a left side view of the embossed wipe of FIG. 1. FIG. 10 is a rear view of the embossed wipe of FIG. 1; and, FIG. 11 is a right side view of the embossed wipe of FIG. 1.

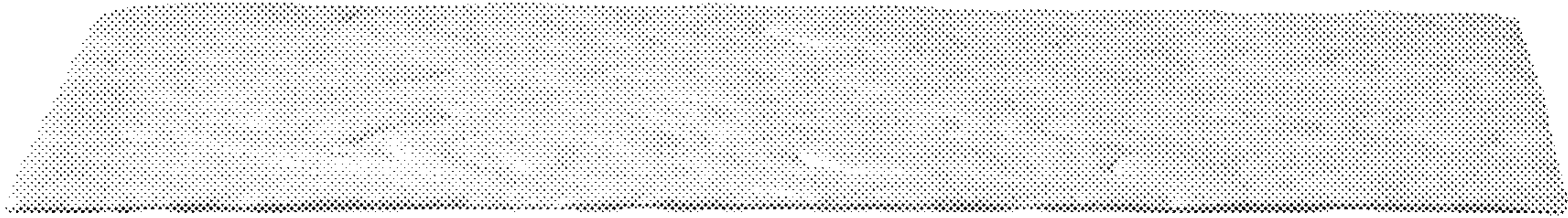

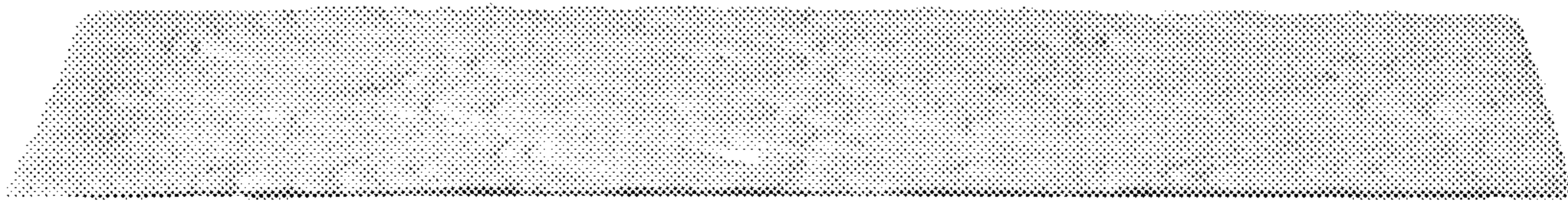

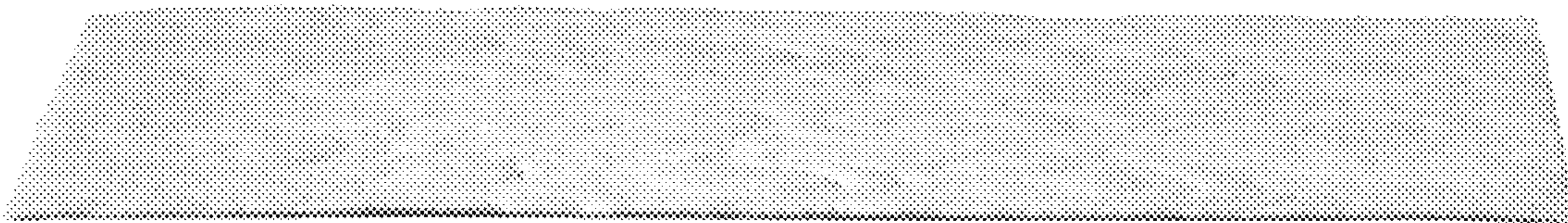

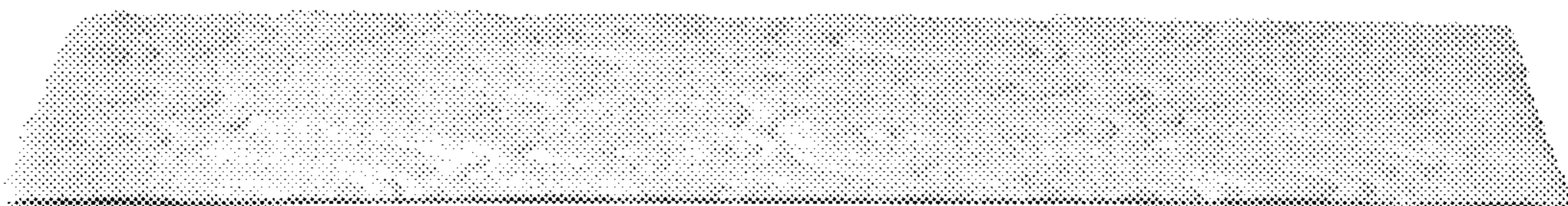

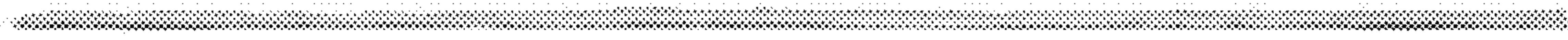
