**CLAIM**

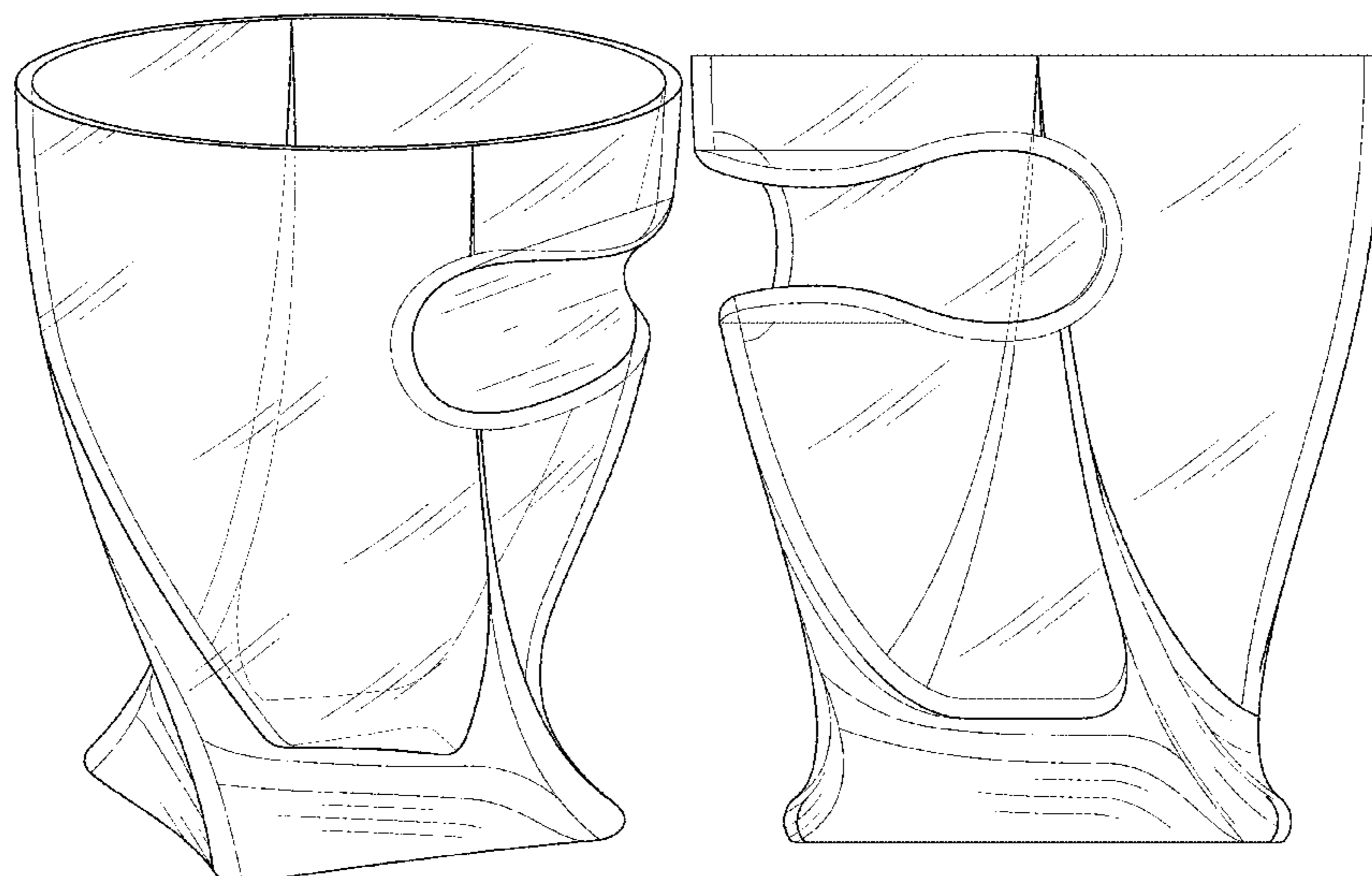
The ornamental design for a twisted whiskey glass with a cigar rest, as shown and described.

**DESCRIPTION**

FIG. 1 is an environmental perspective view of a twisted whiskey glass with a cigar rest showing my new design; FIG. 2 is an alternate perspective view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

The broken lines showing a drink, ice, and a cigar in FIG. 1 depict environmental matter and form no part of the claimed design.

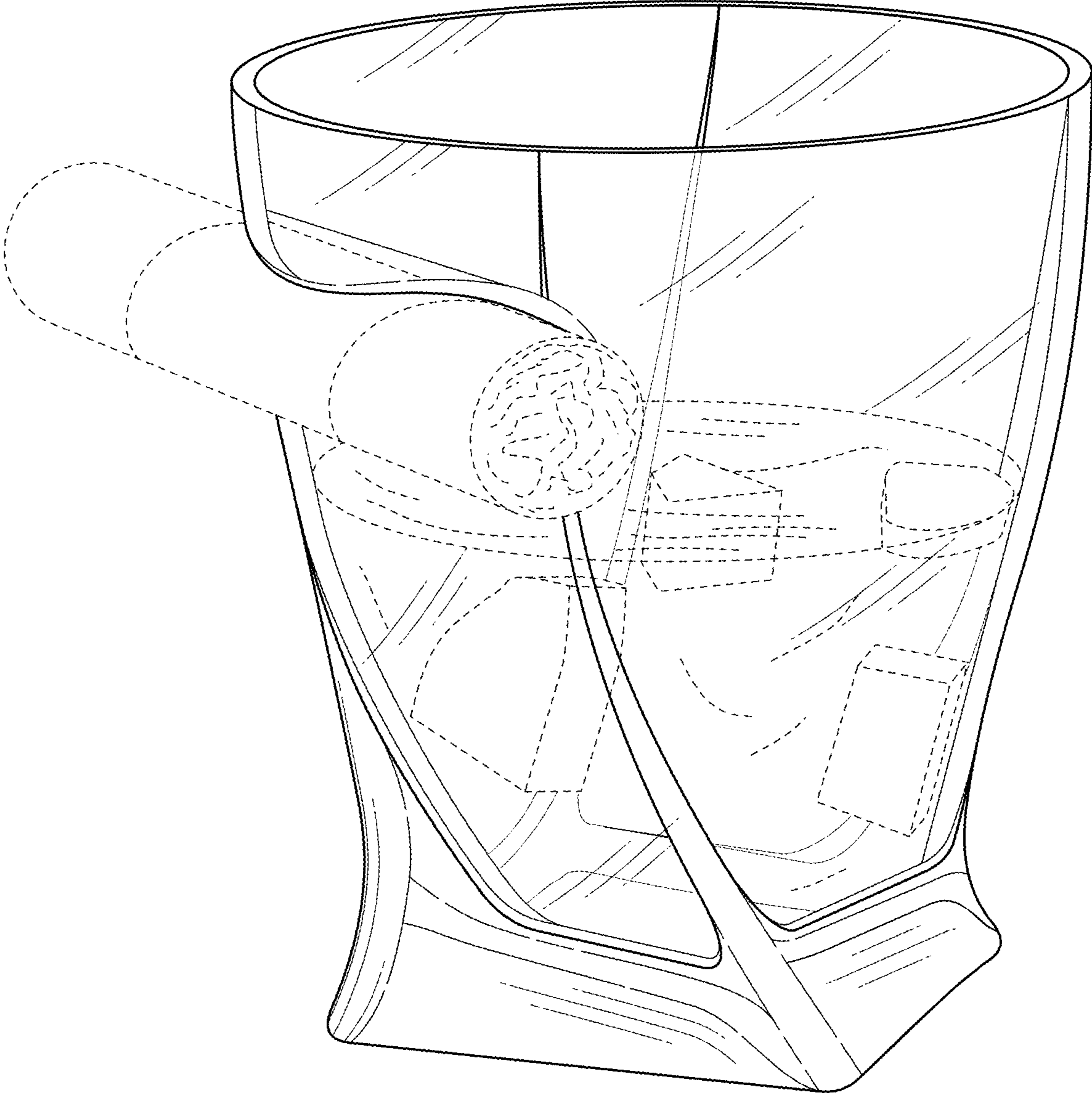

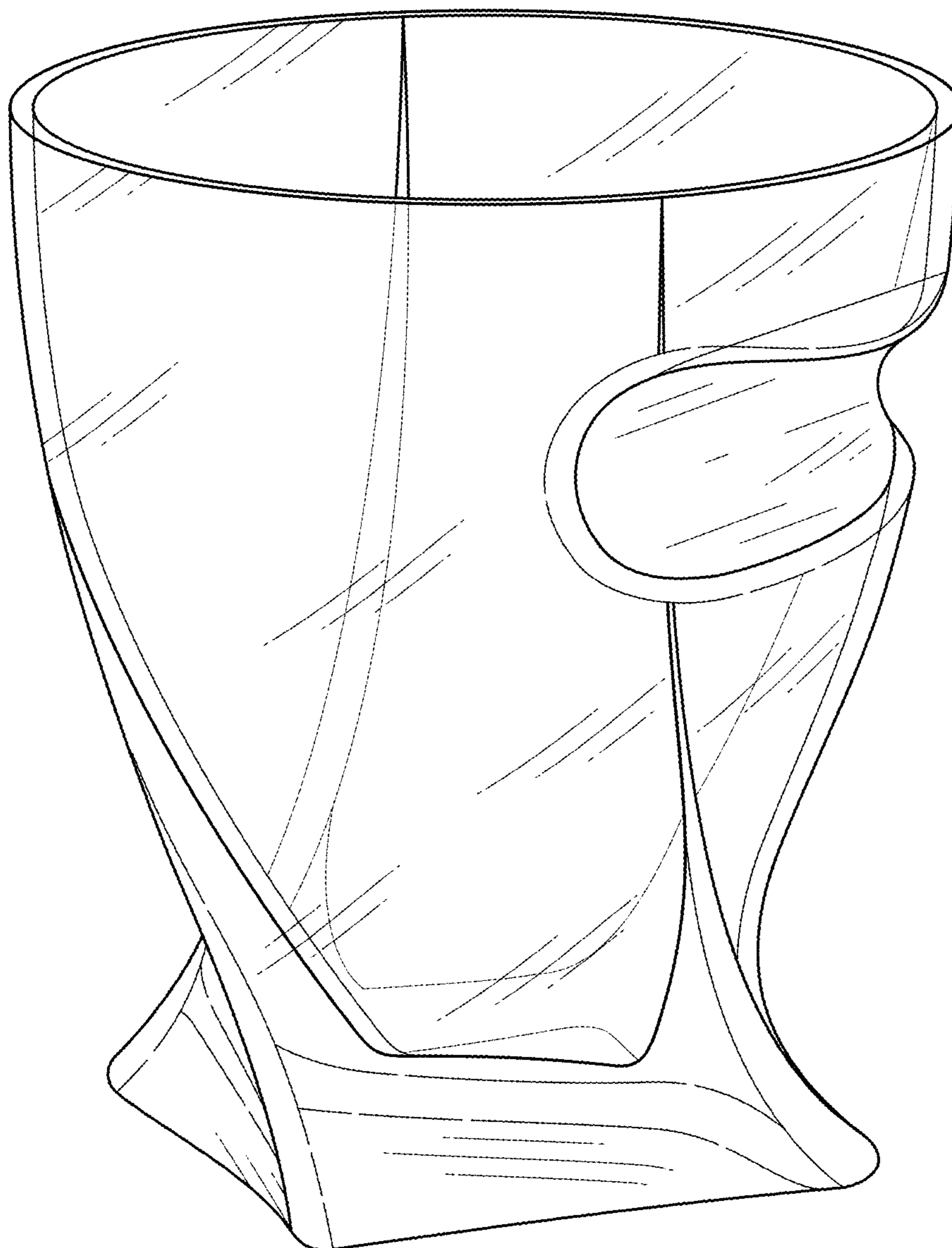

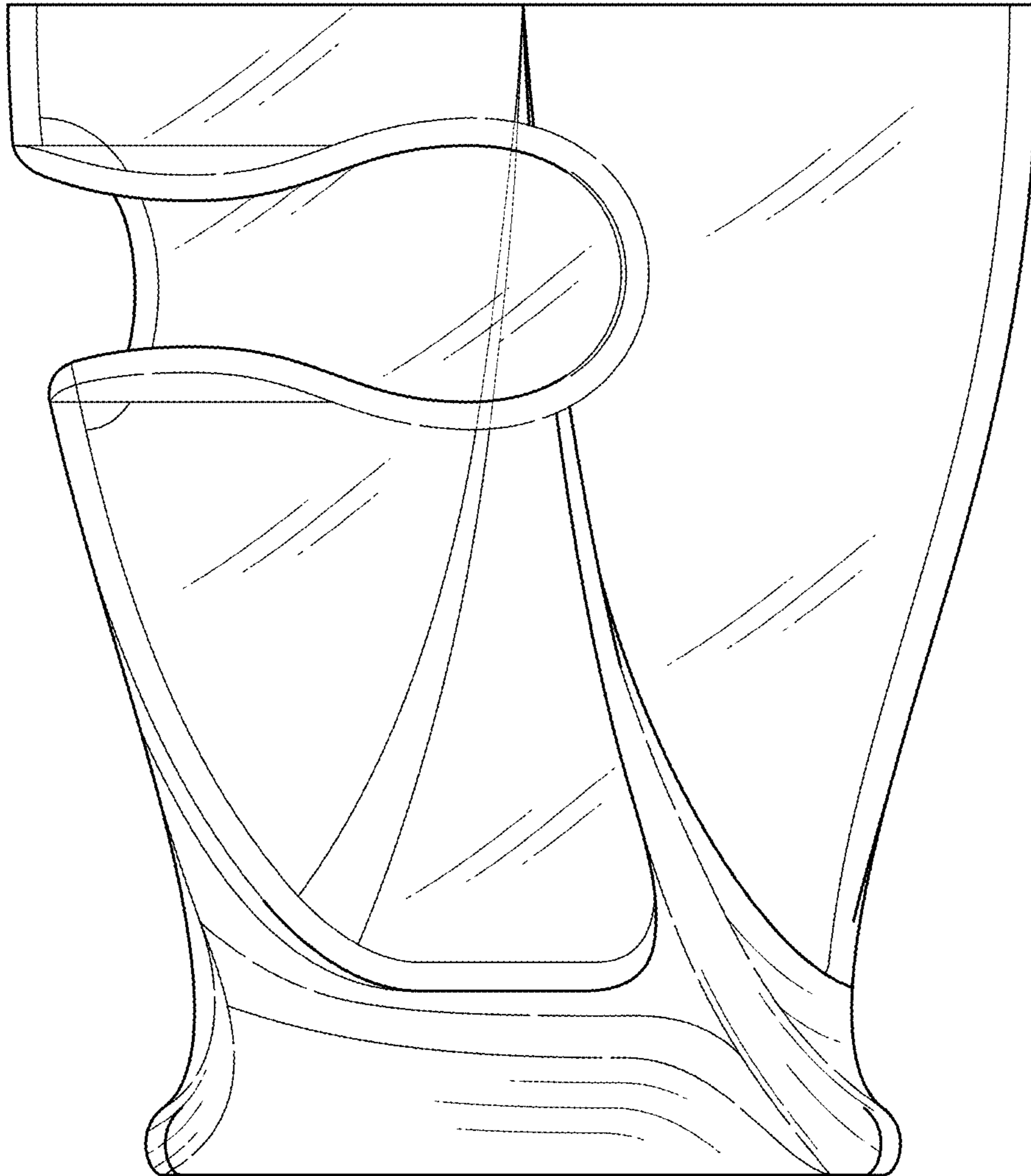

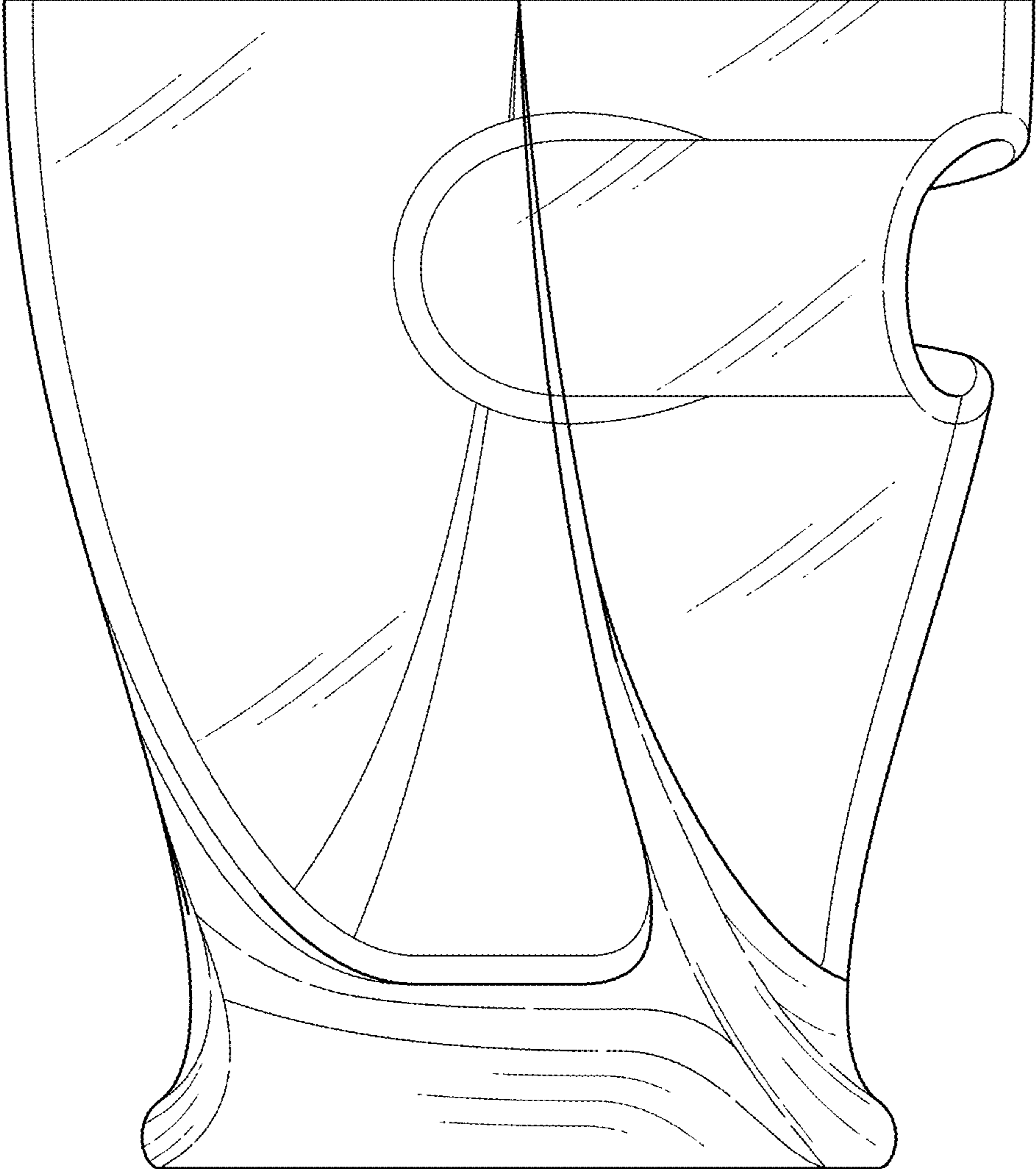

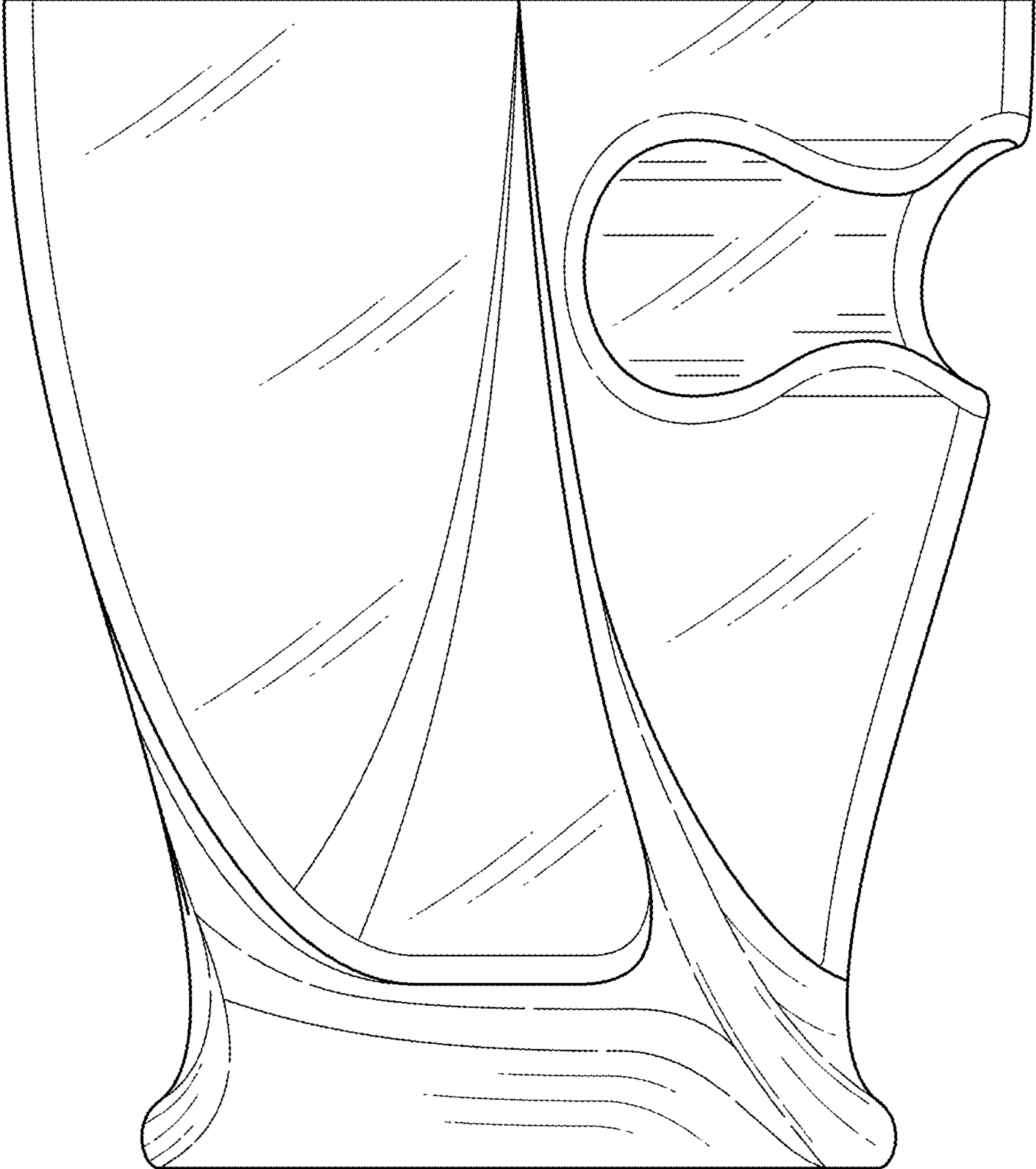

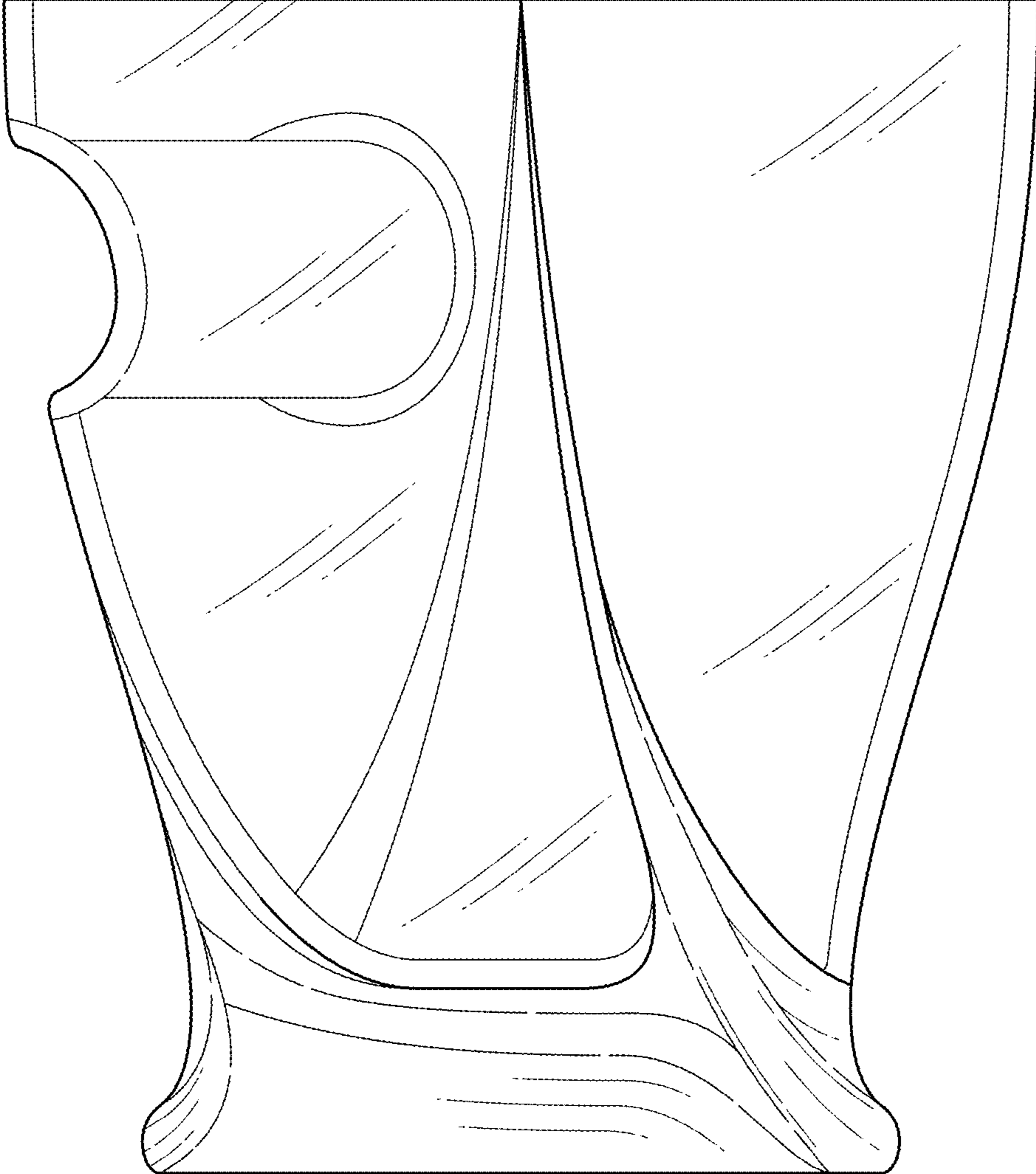

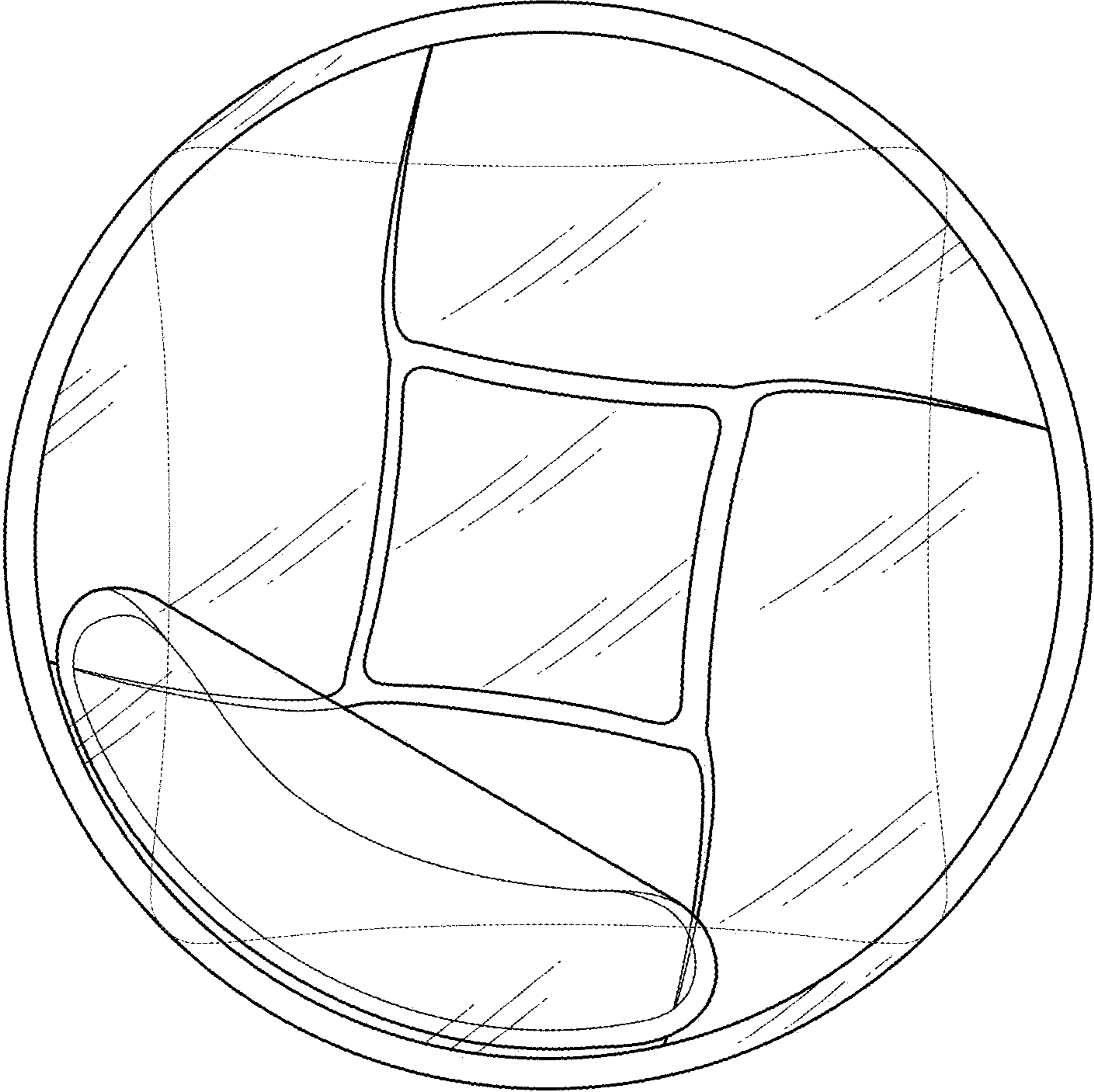

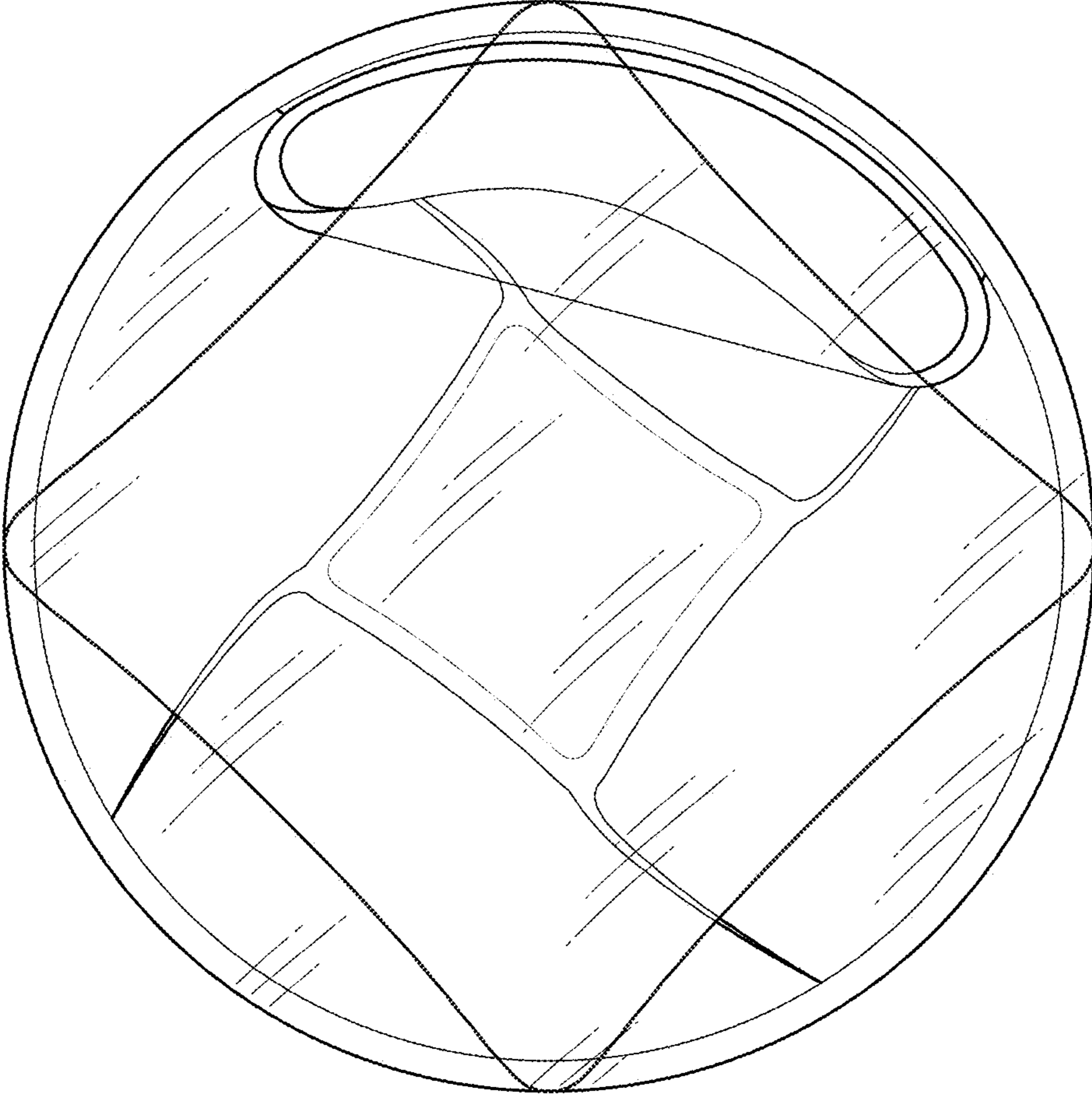
