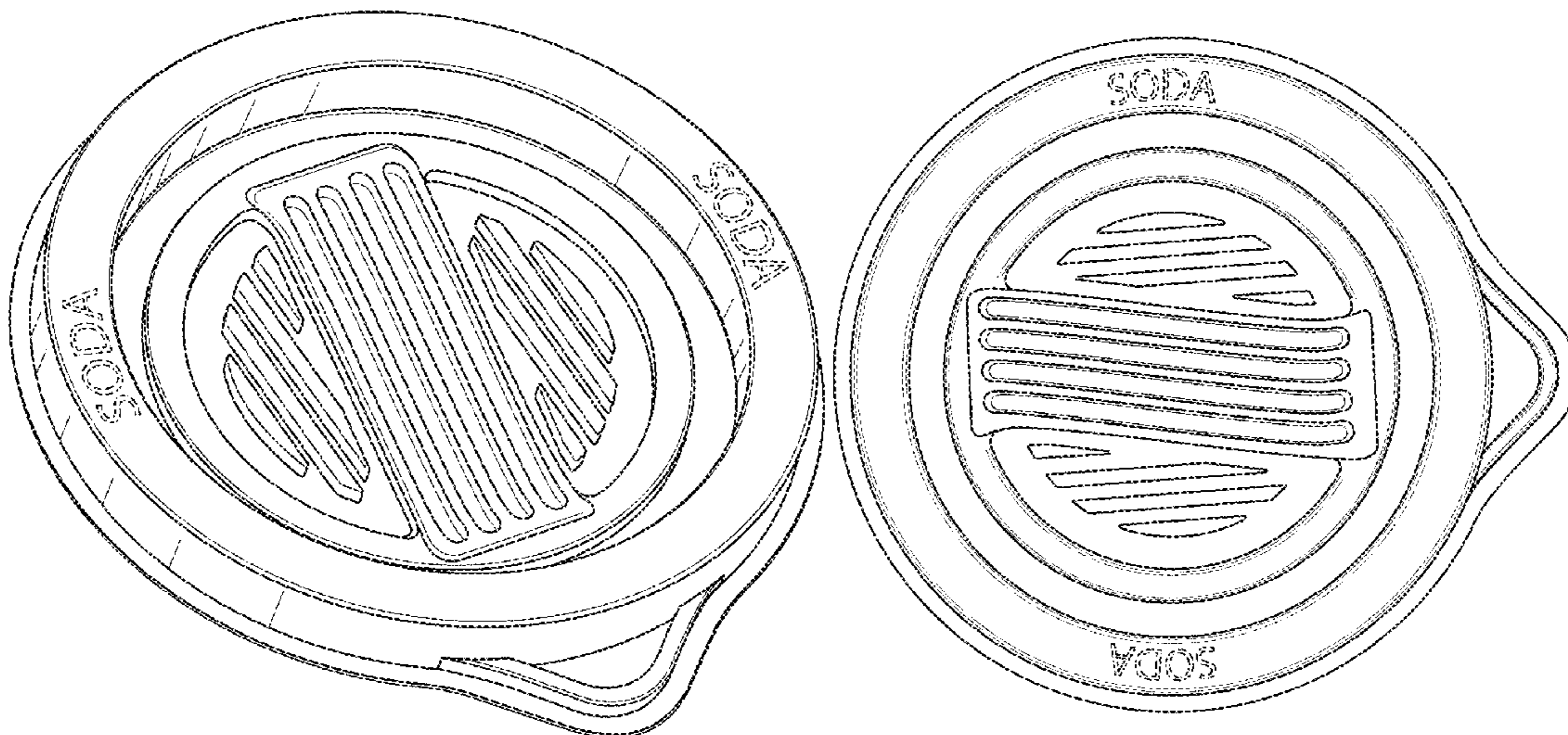
The ornamental design for a beverage can protective cover, as shown and described.

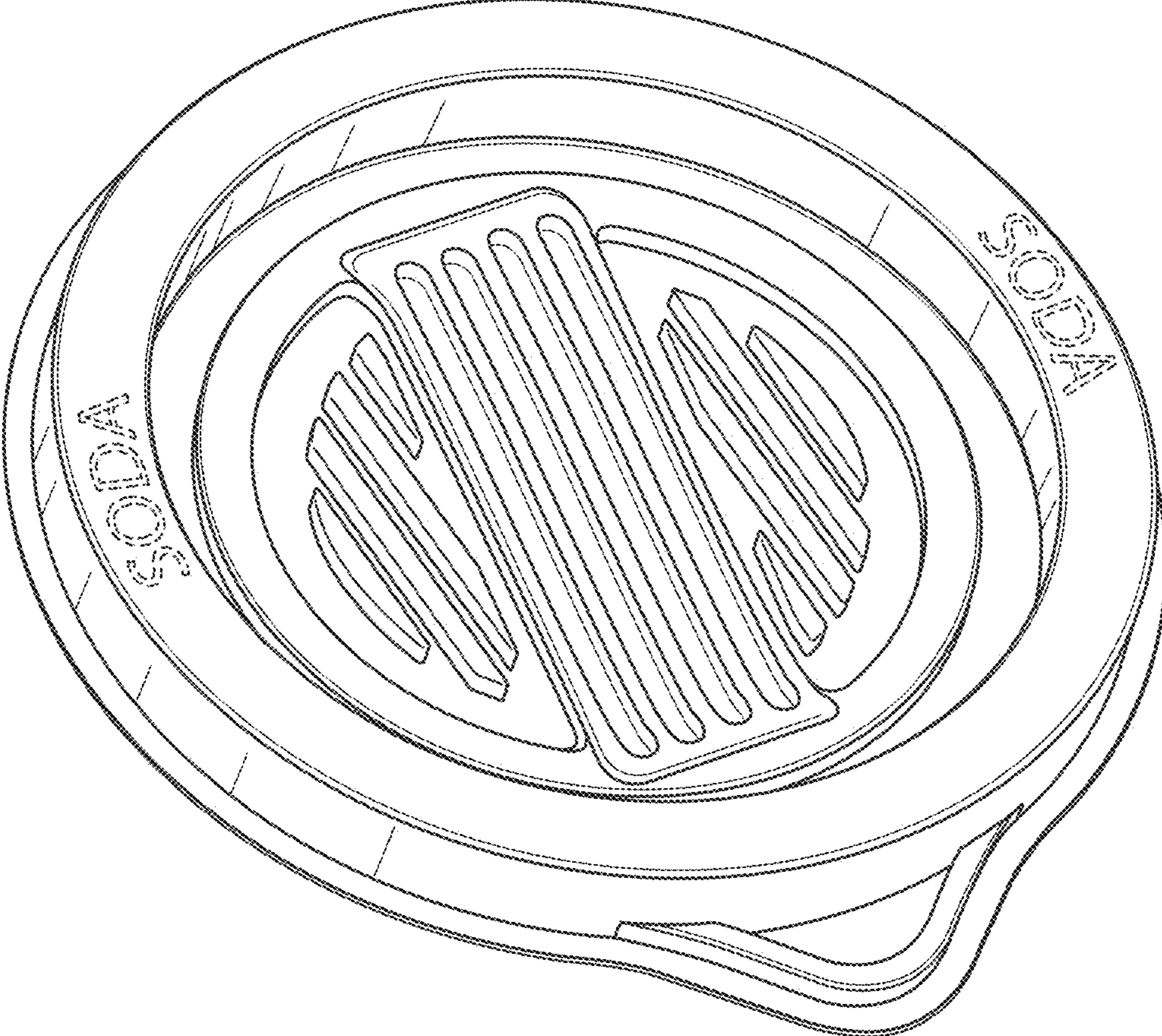

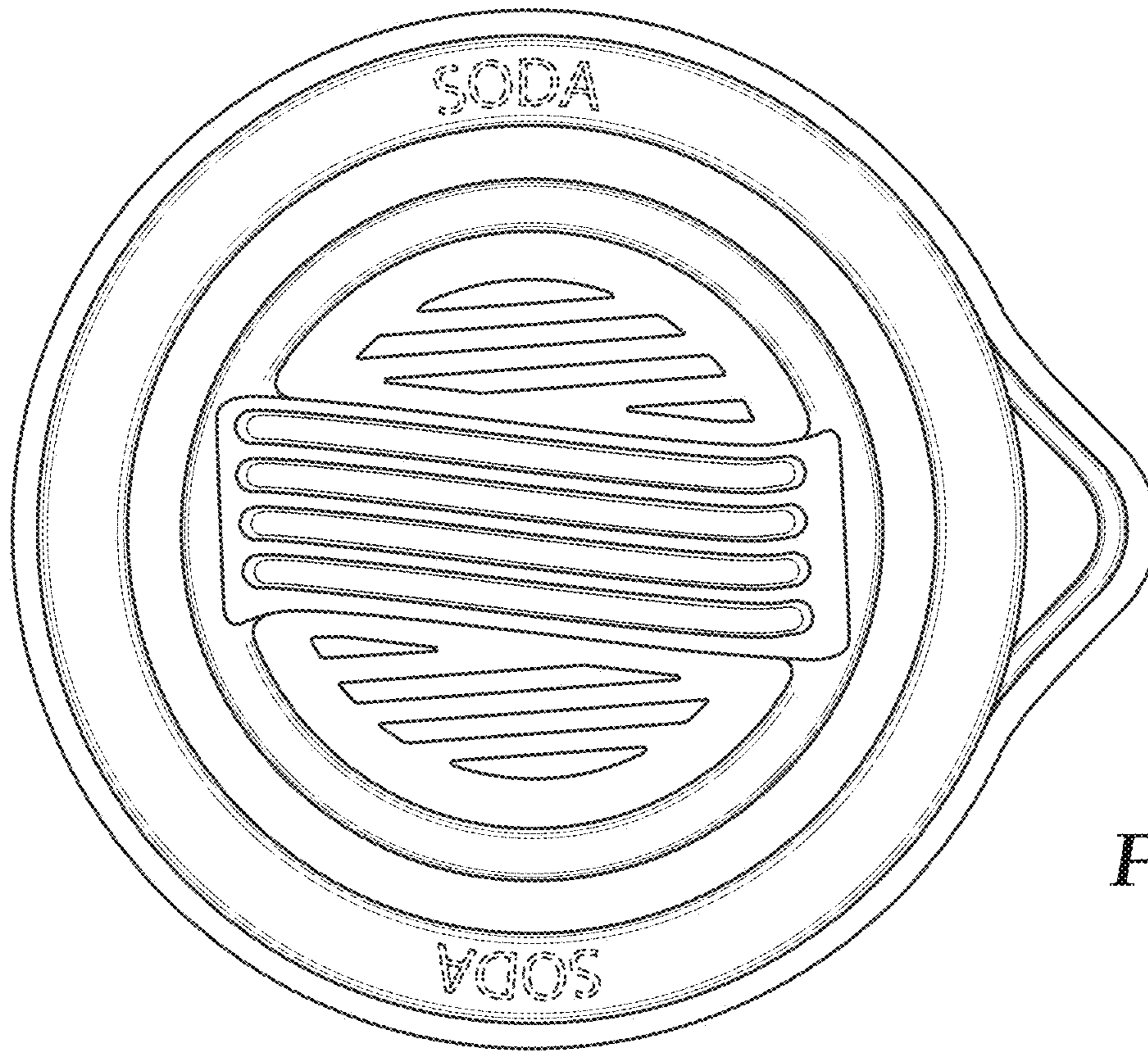

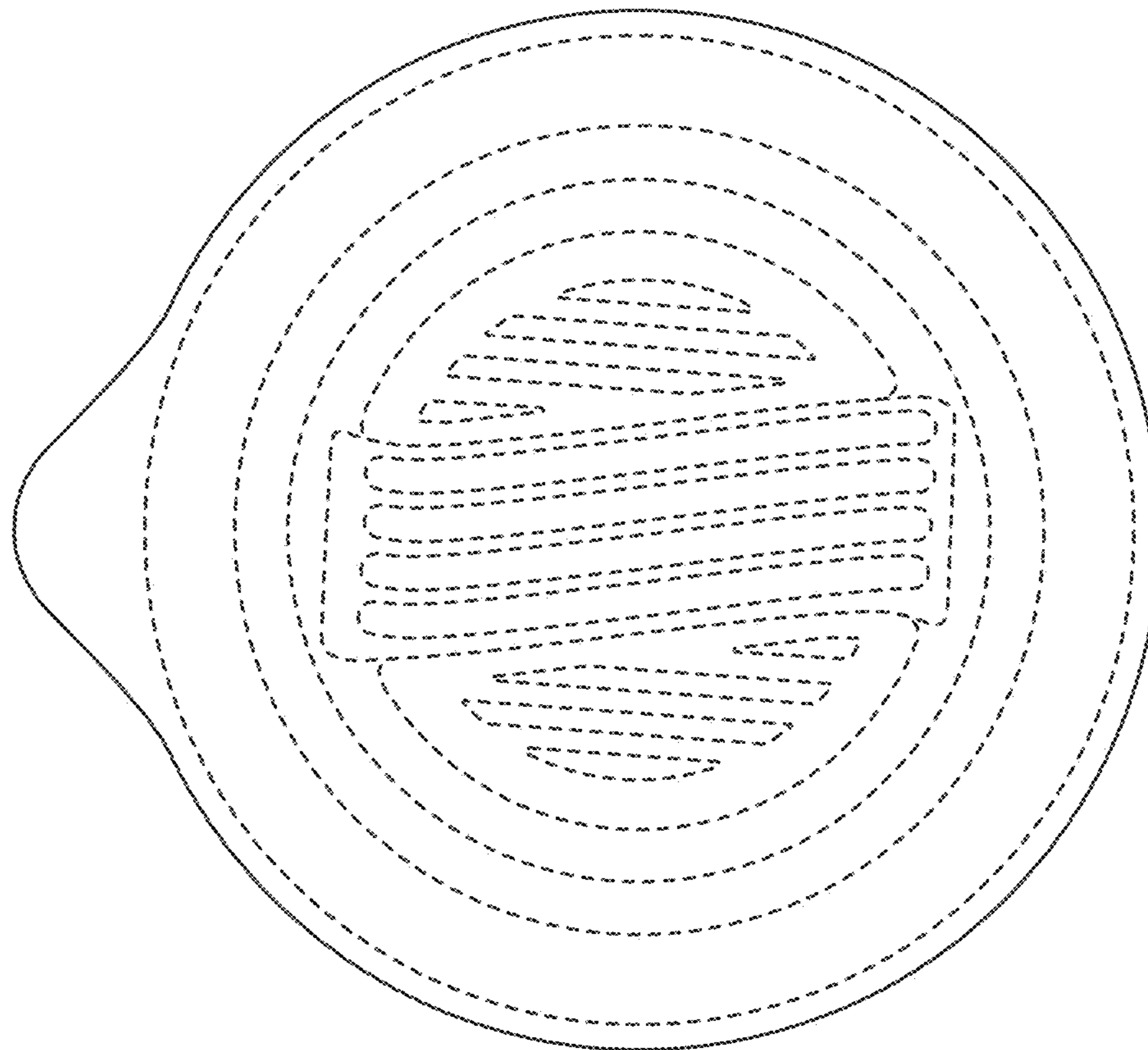
