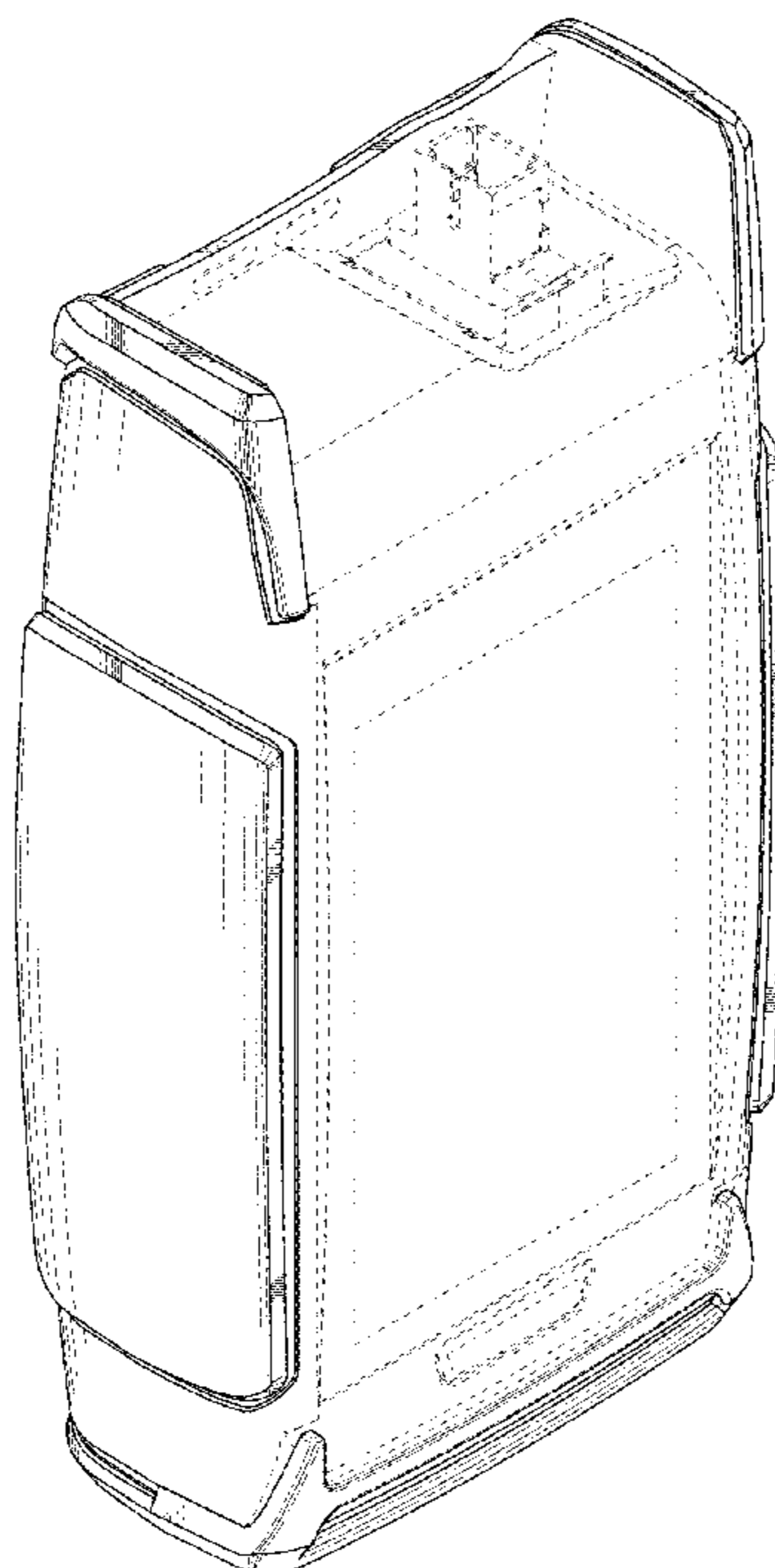
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is perspective view of a portable test instrument, showing the new design;

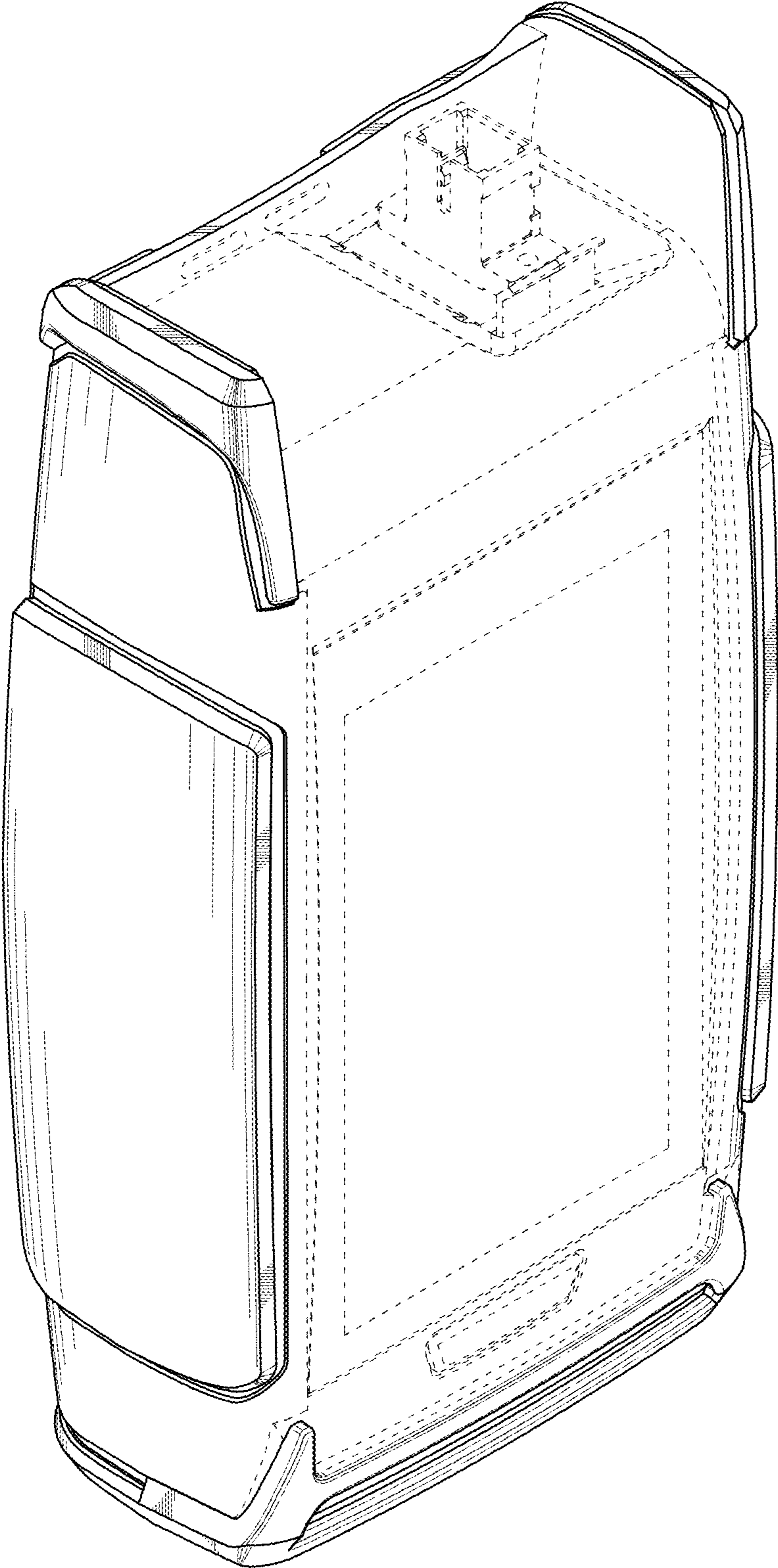

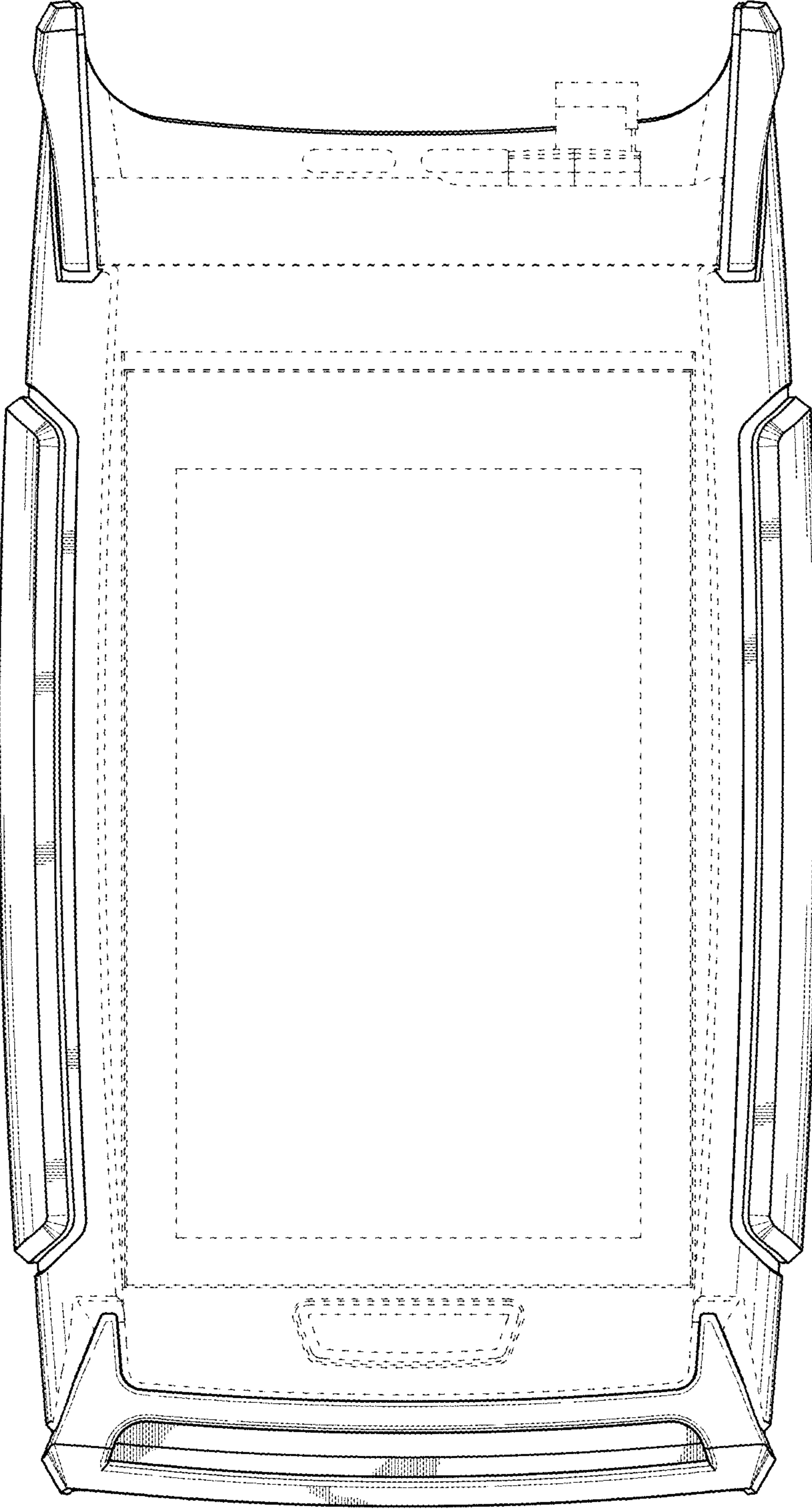

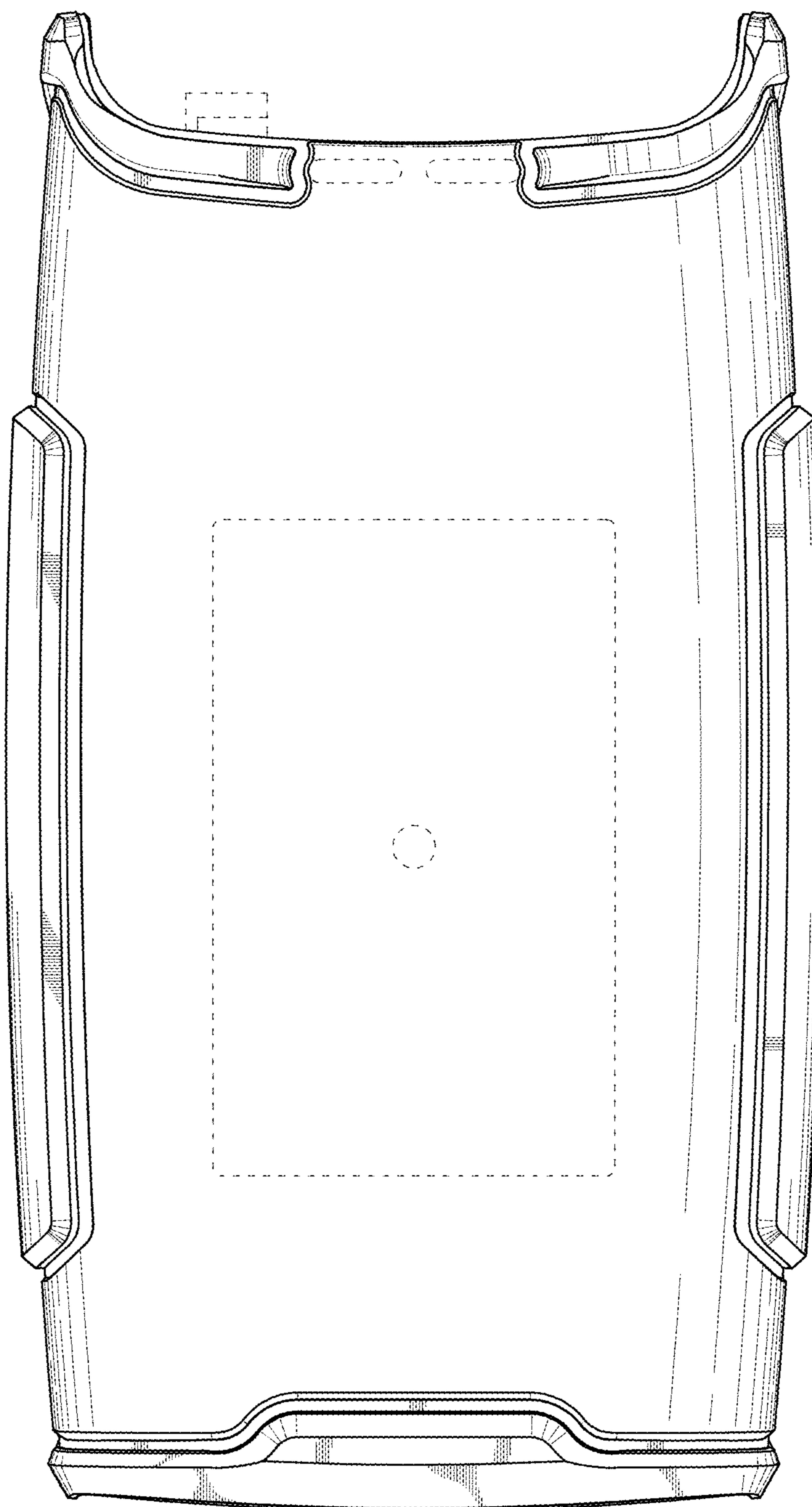

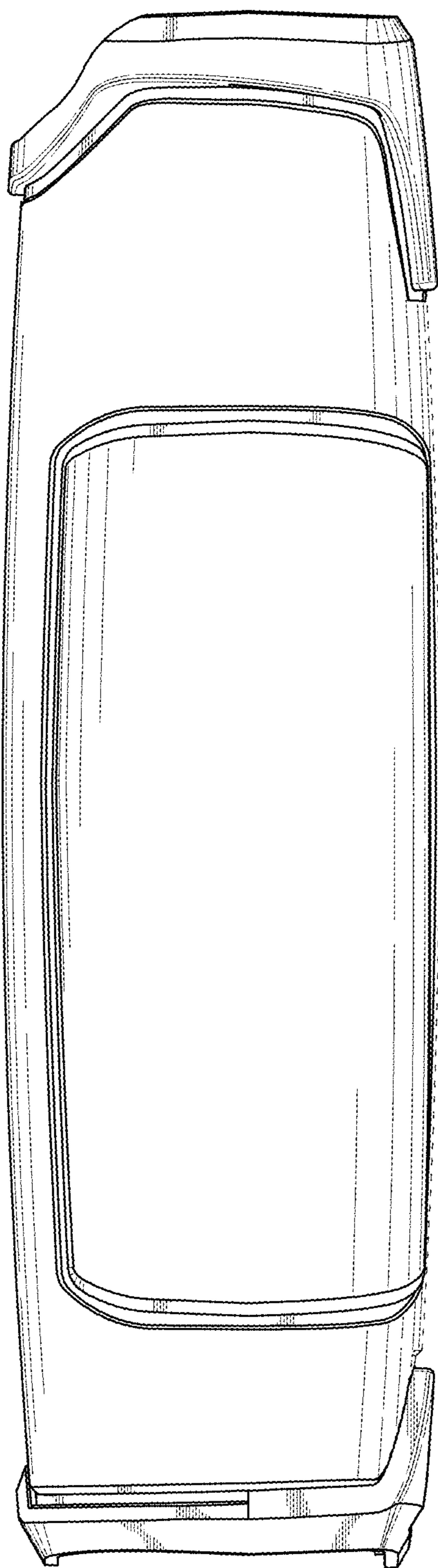

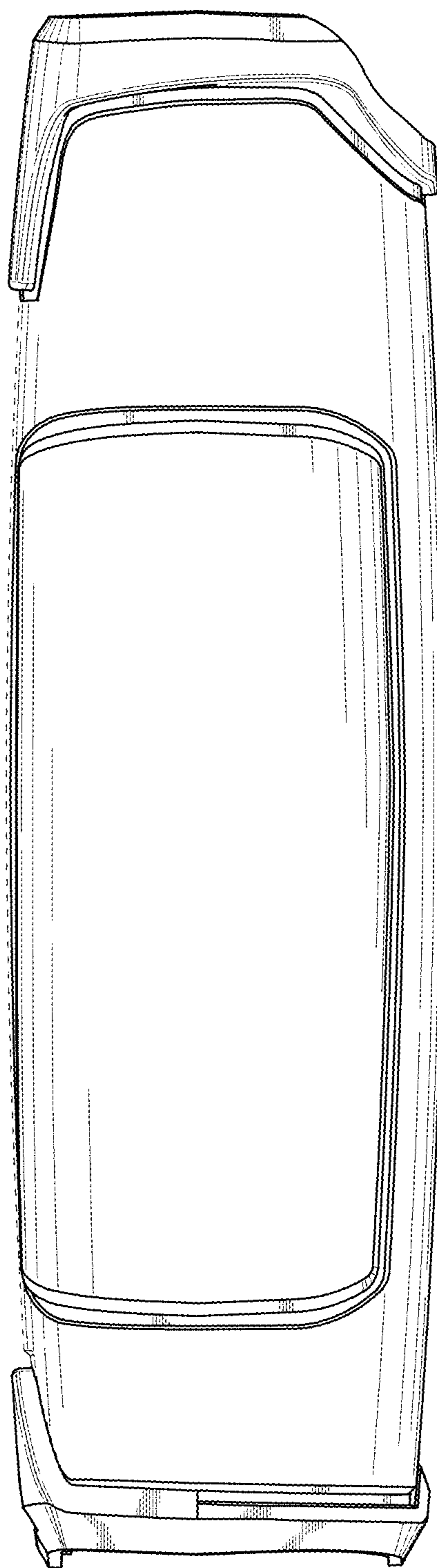

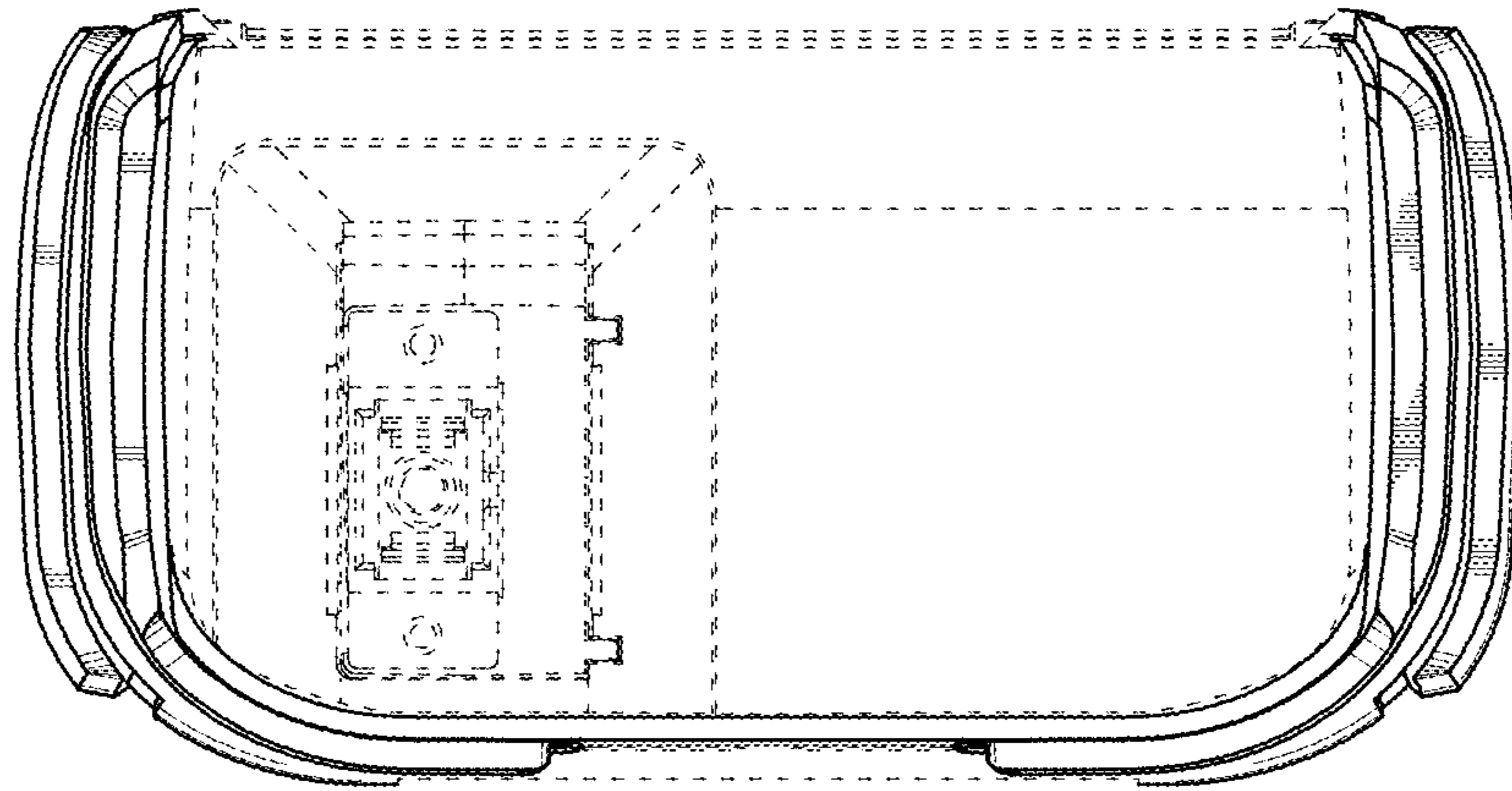

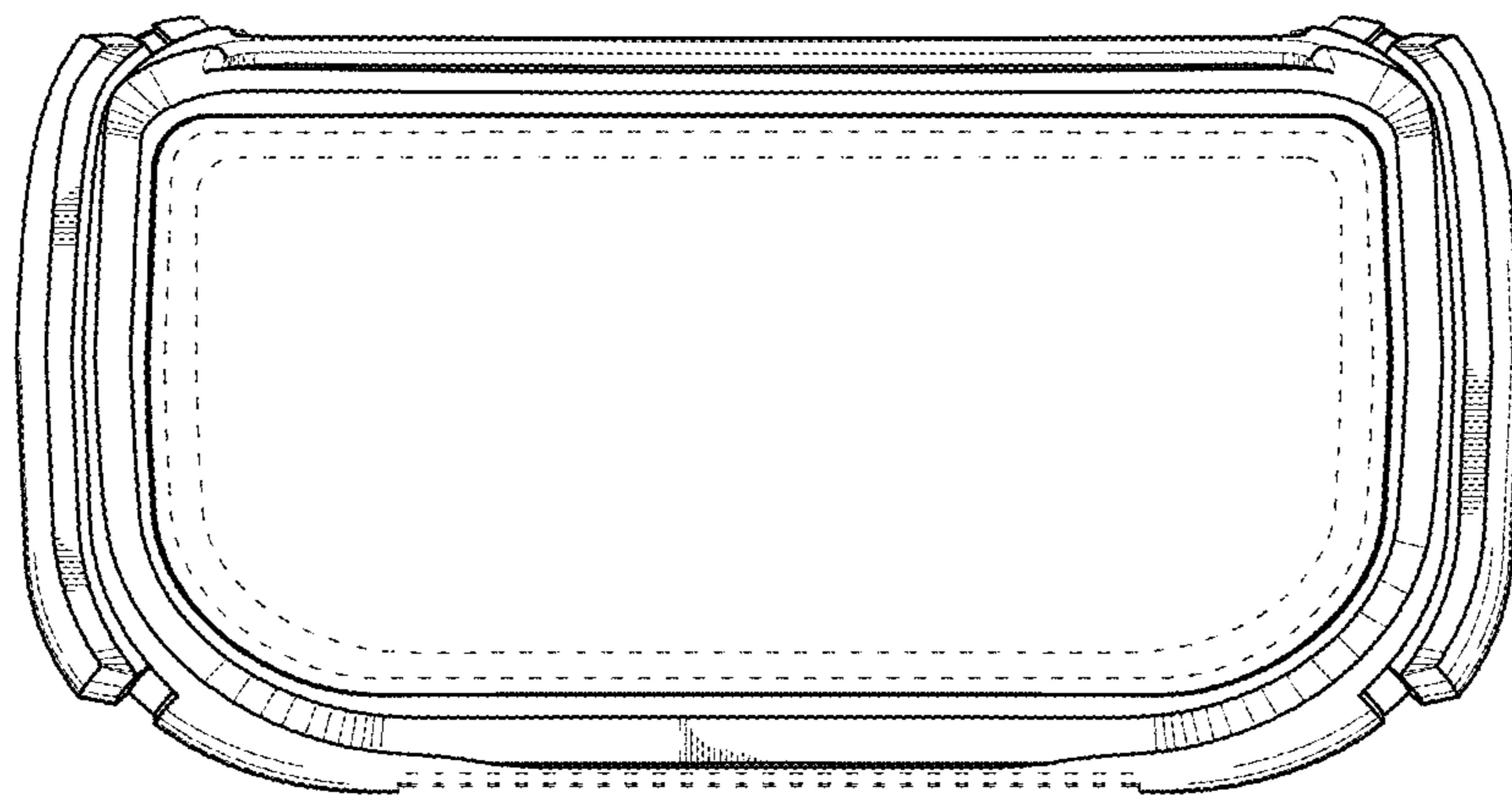
