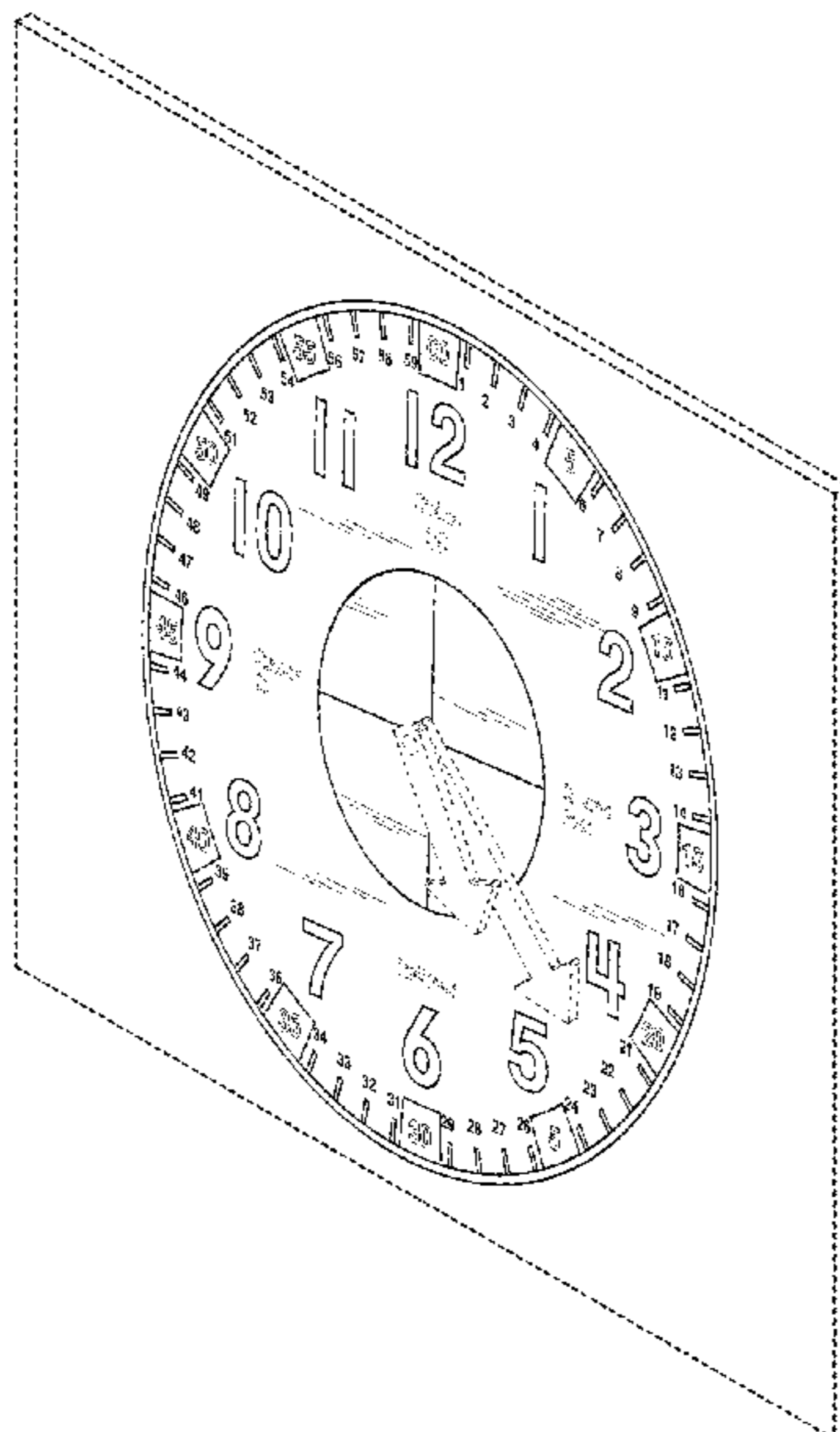
(57) **CLAIM**

An ornamental design for a game clock, as shown and
described.

DESCRIPTION

FIG. 1 is a front perspective view of a new design for game
clock;
FIG. 2 is a front thereof;
FIG. 3 is a left view thereof;
FIG. 4 is a right view thereof; and,
FIG. 5 is a front view of another embodiment of the game
clock.
The solid line showing illustrates the claimed features within
the design for the claimed article of manufacture.
The broken lines shown in the drawings depict portions of
the game clock that form no part of the claimed design.
The shading is provided to illustrate contour only and no
particular color, material, or finish is claimed.

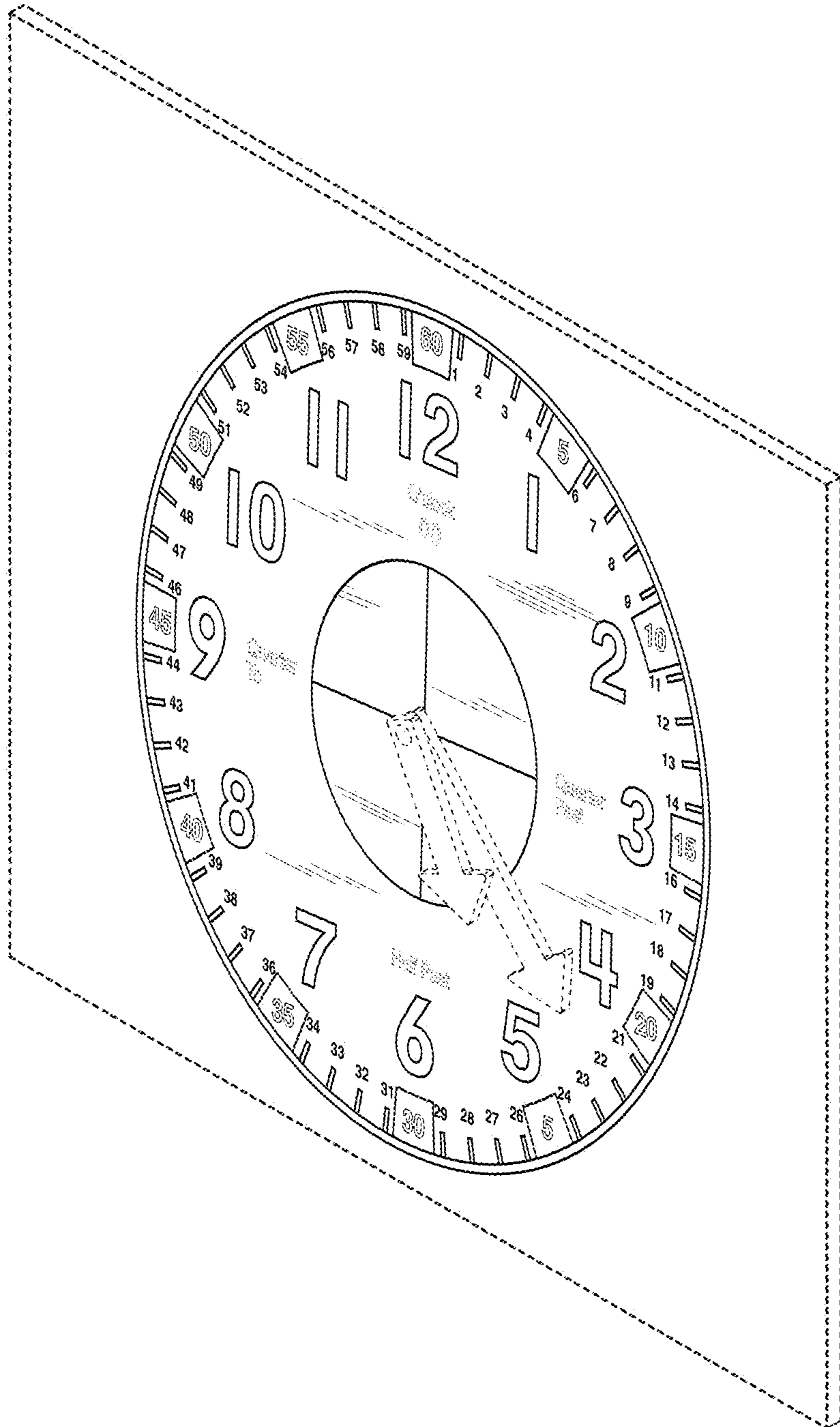

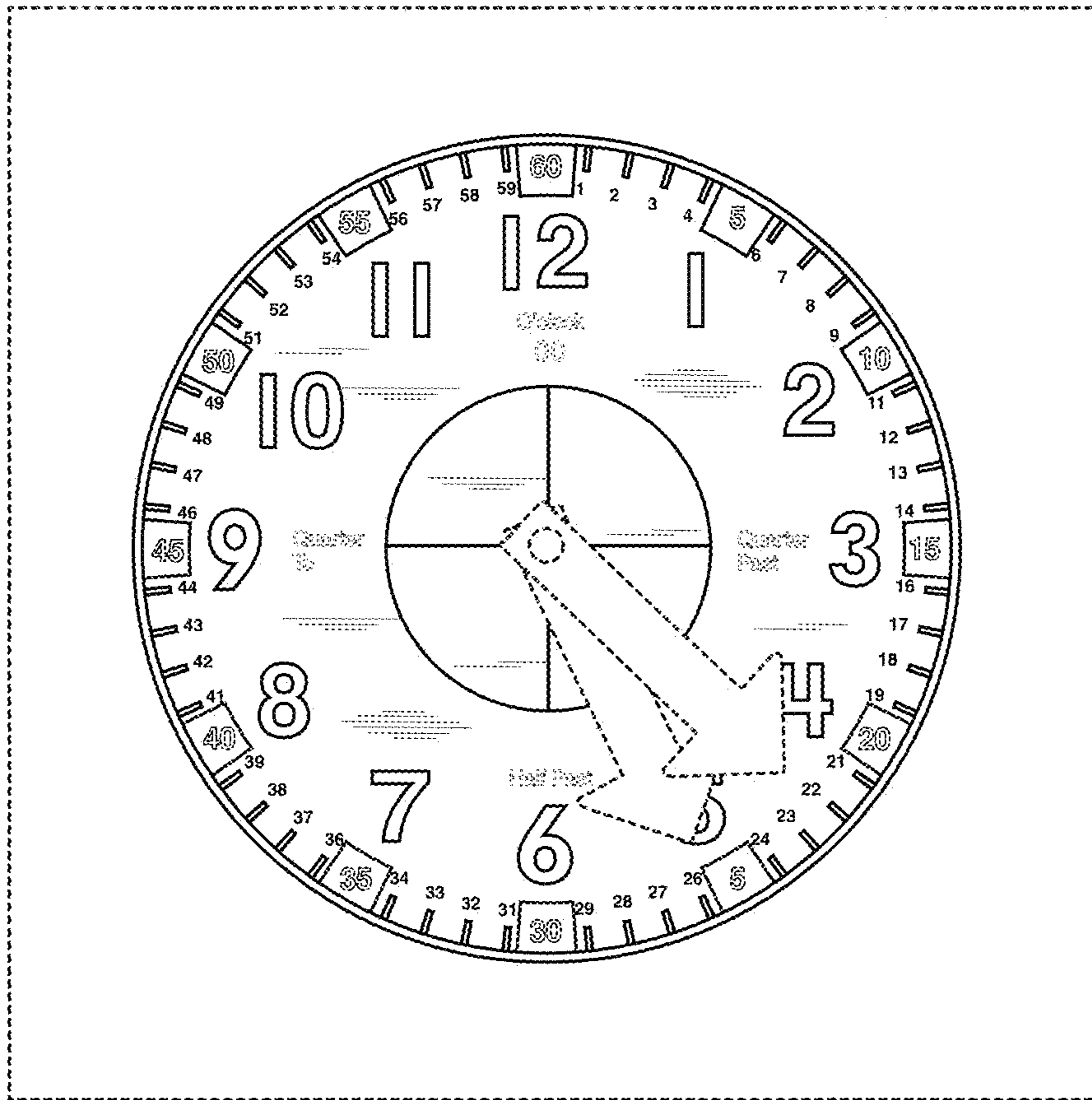

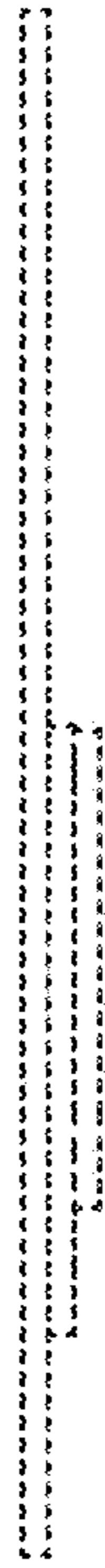

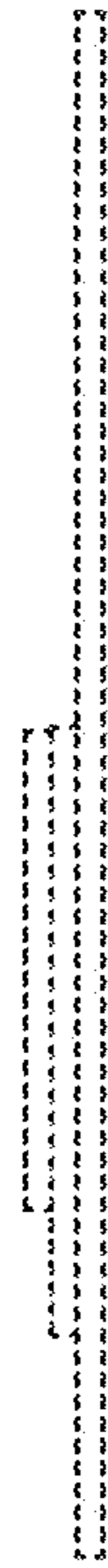

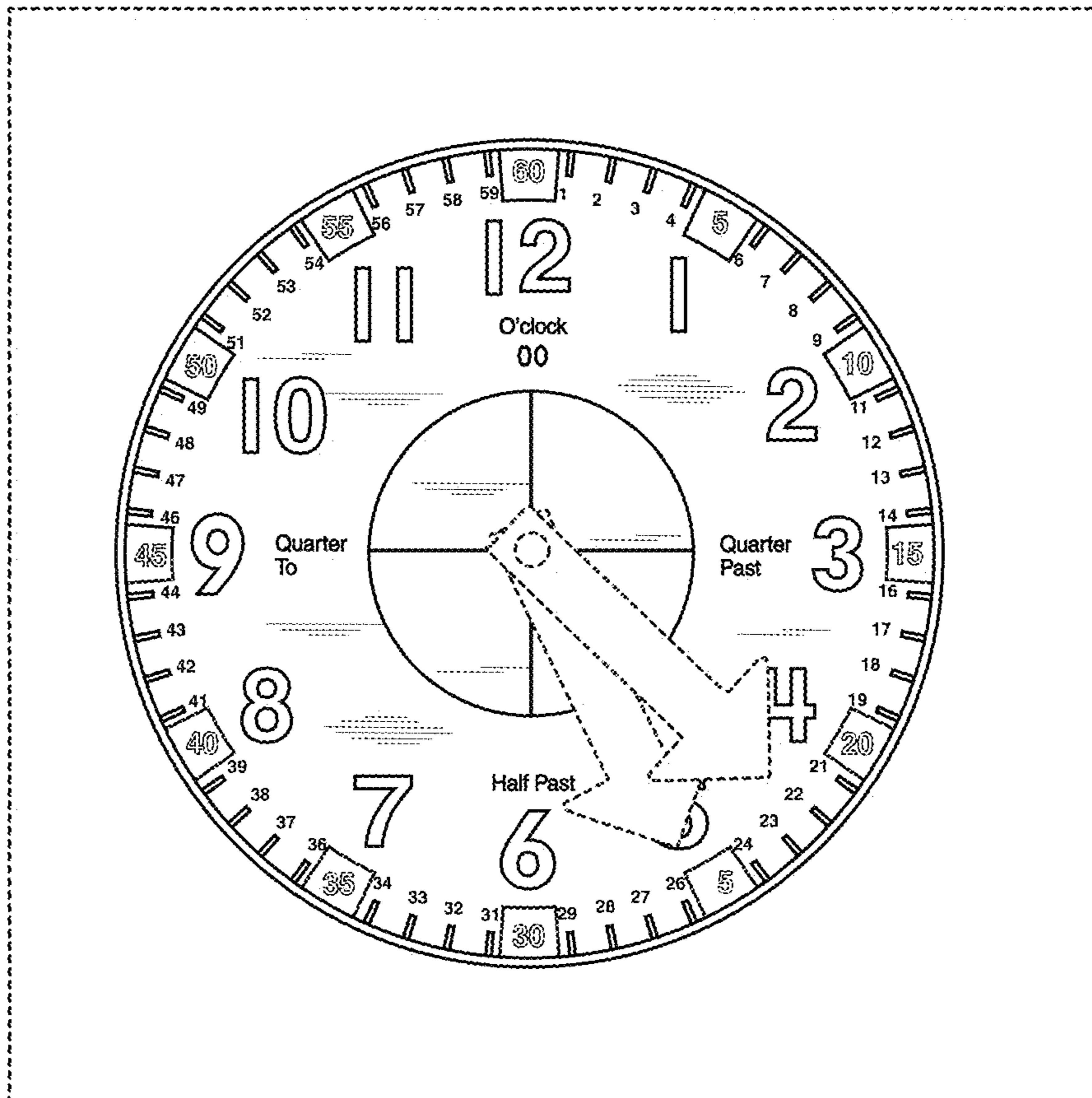
