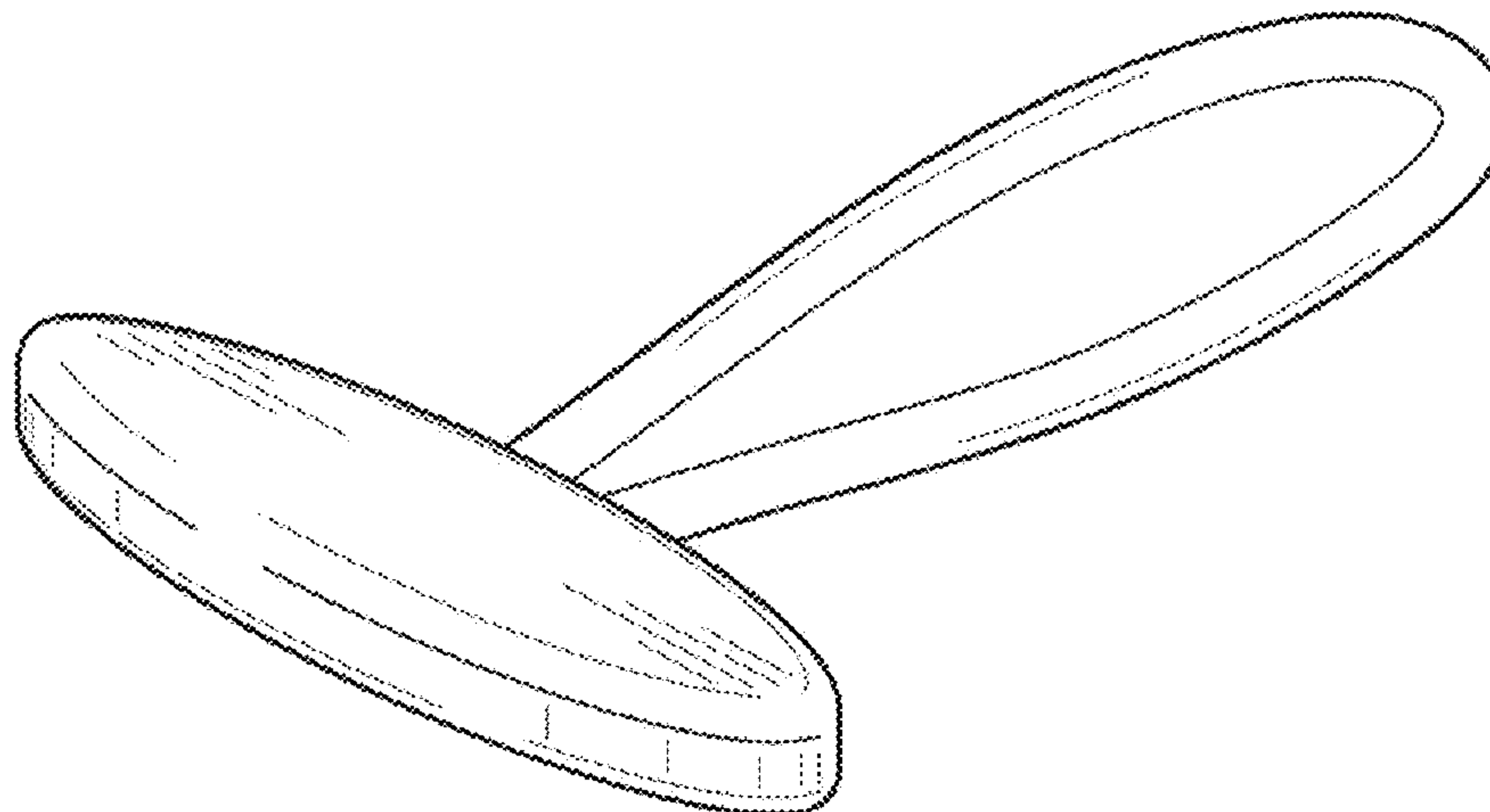

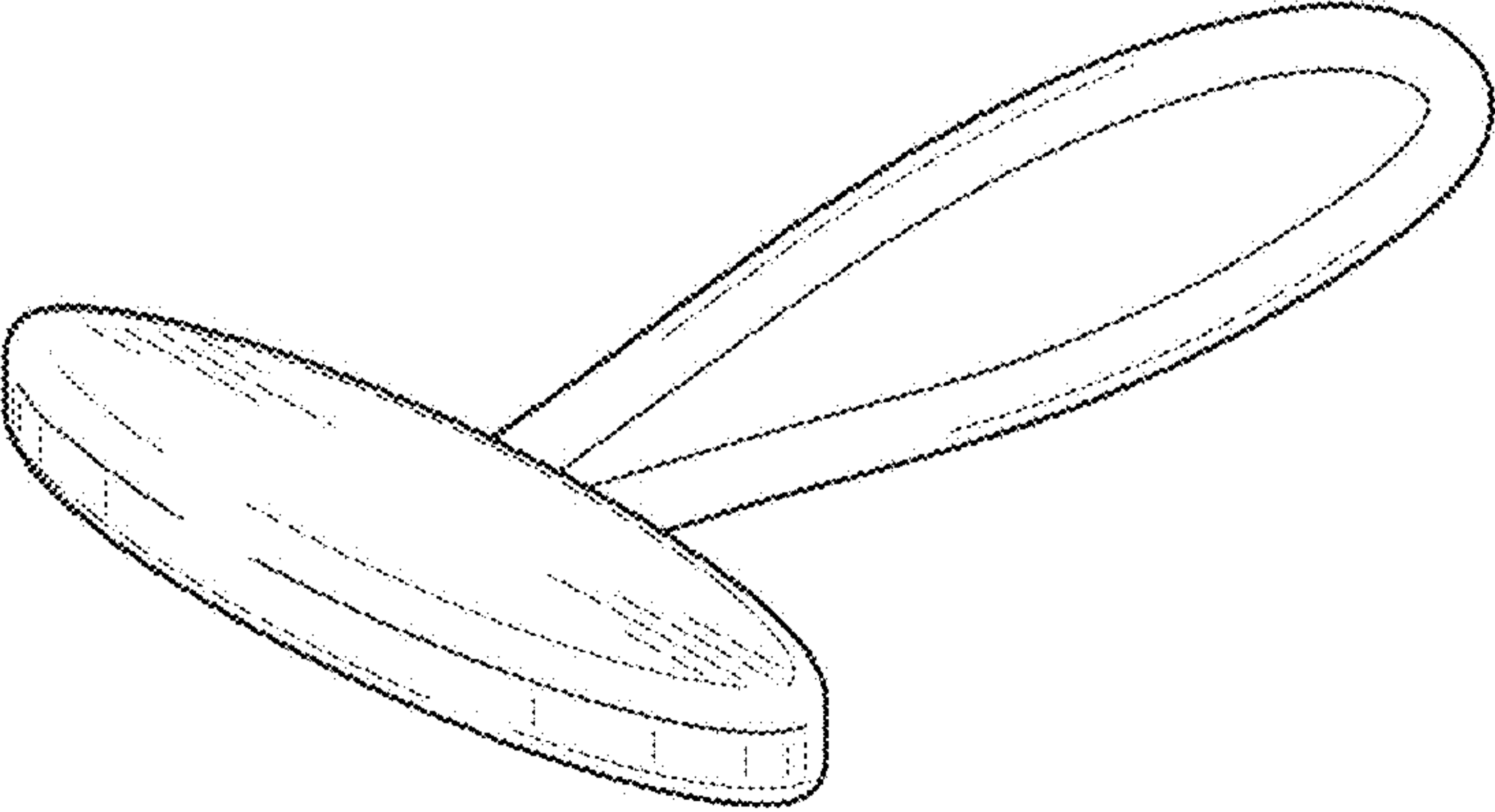
I claim the ornamental design for a zipper pull, as shown and described.

**DESCRIPTION**

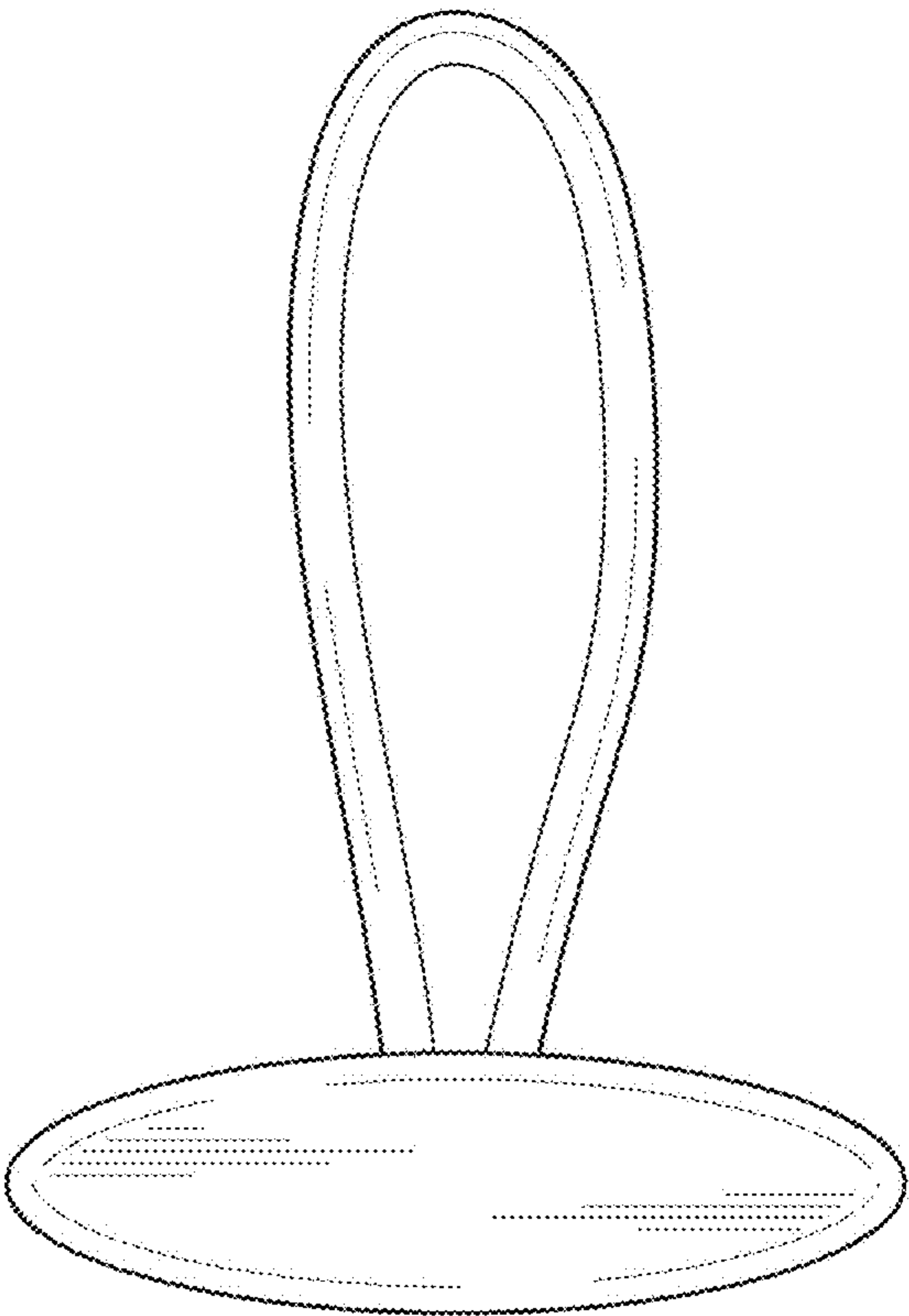
FIG. 1 is a perspective view showing my new design.

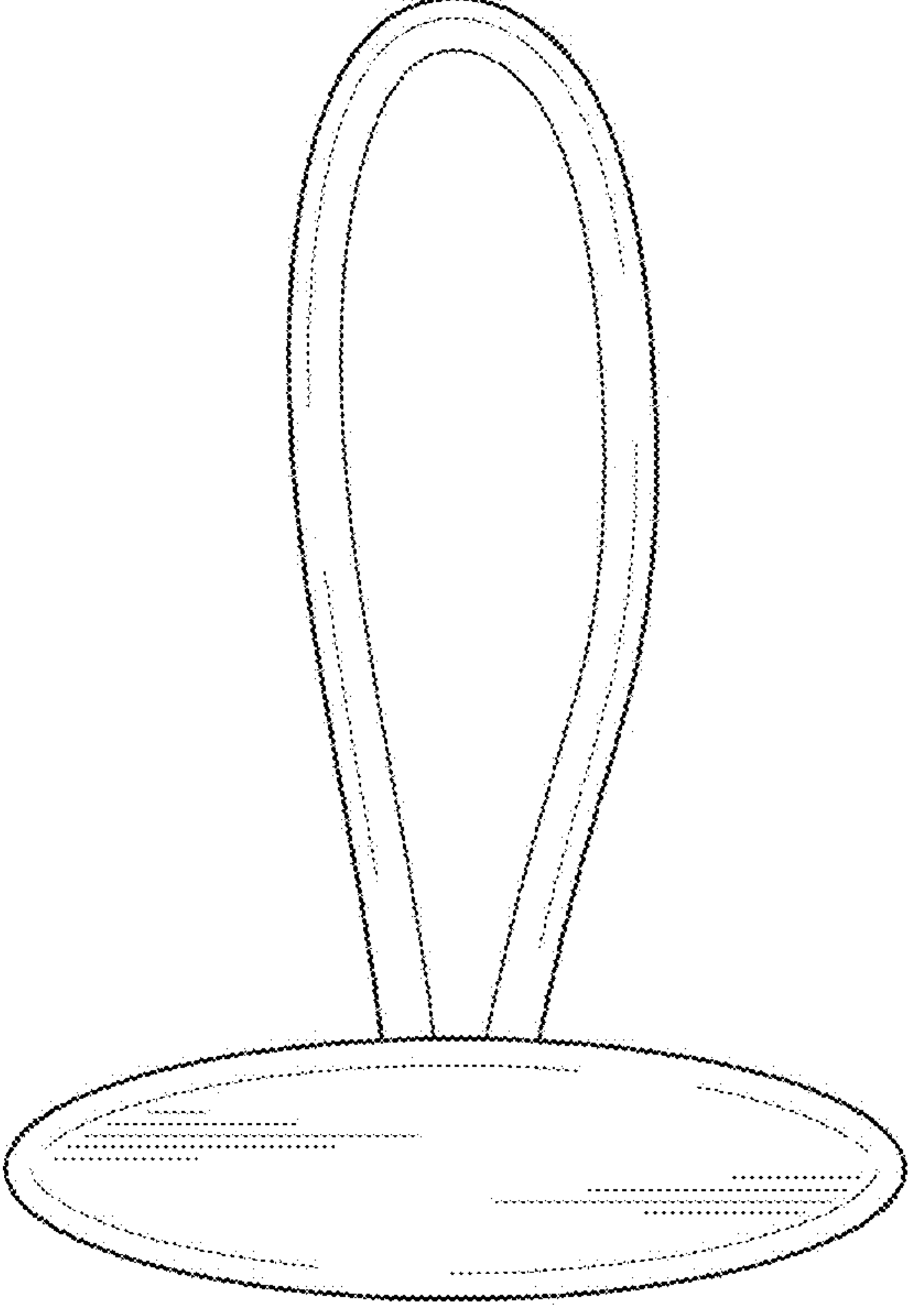




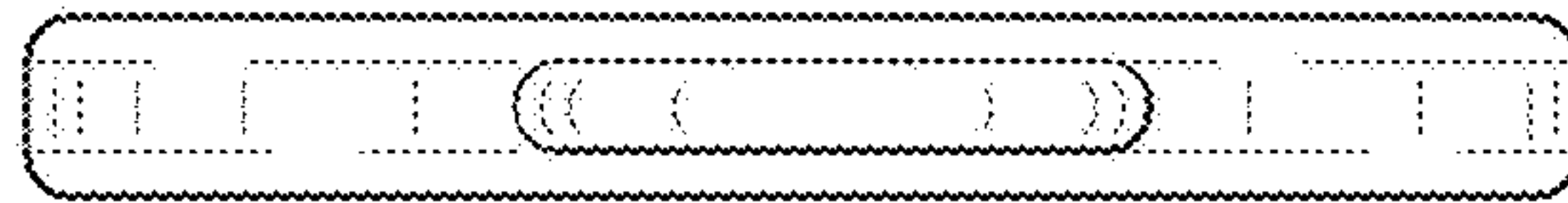

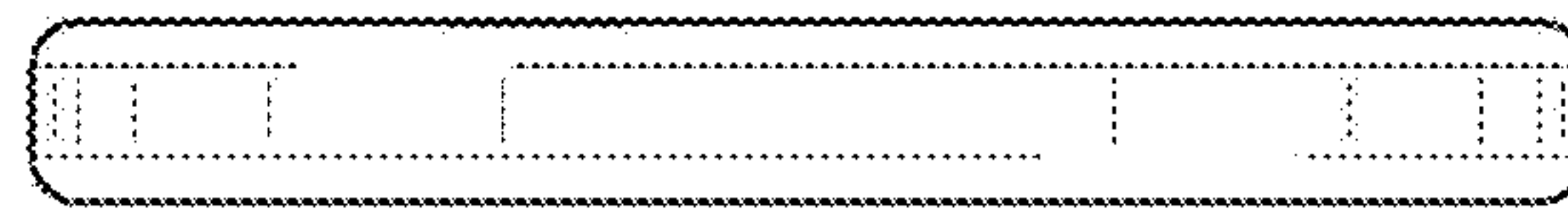

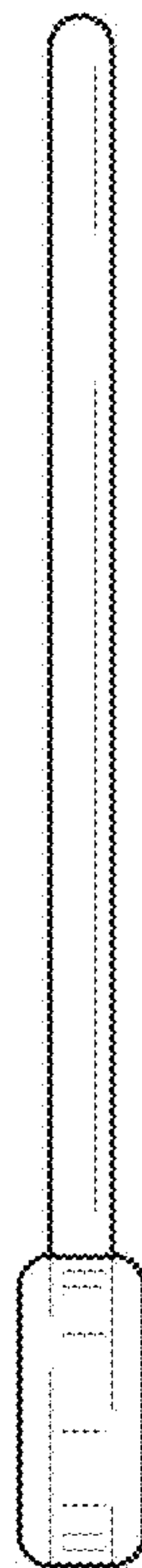
