DESCRIPTION

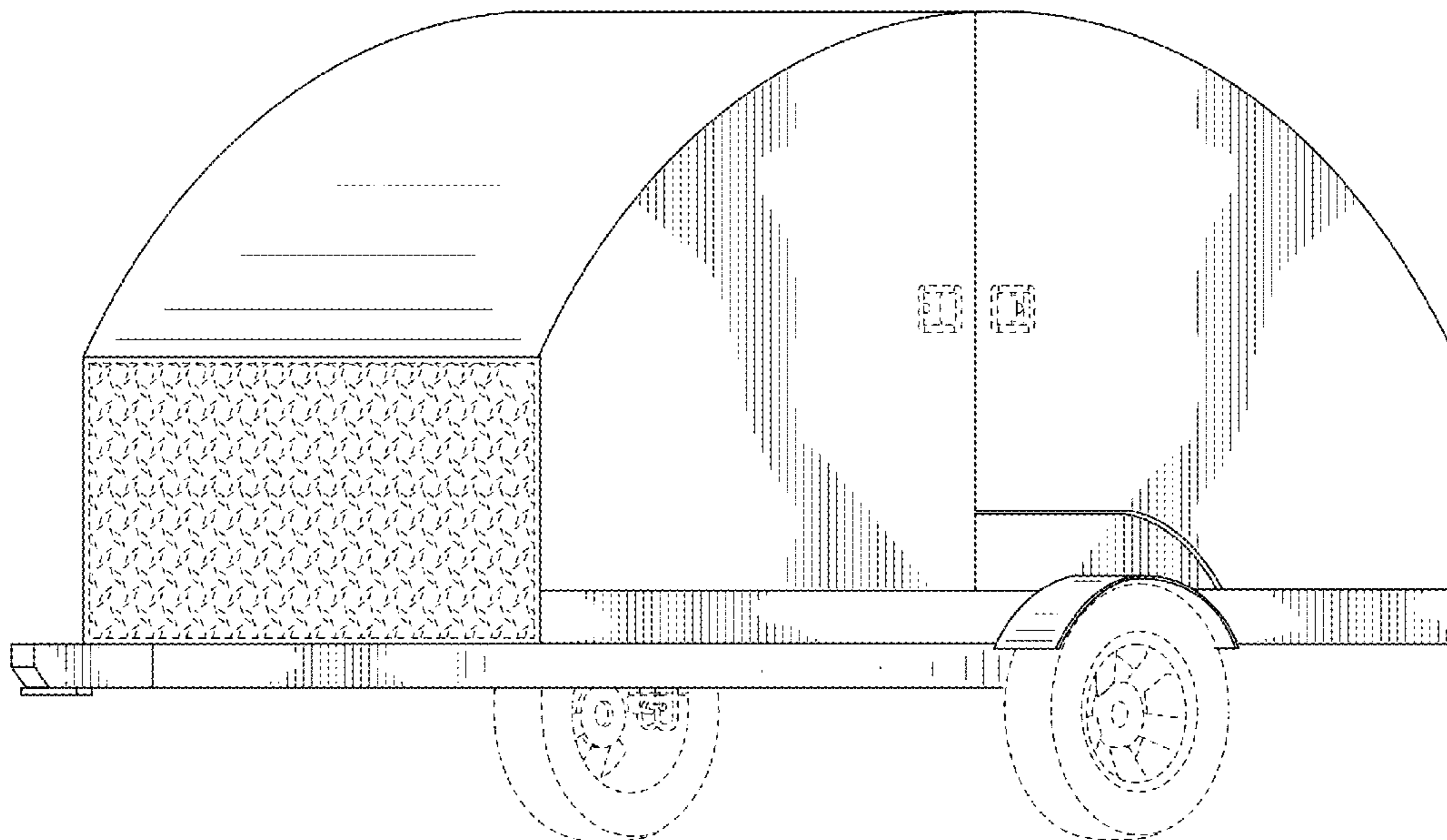
FIG. 1 is a front, left, side perspective view of a trailer in accordance with the present invention;

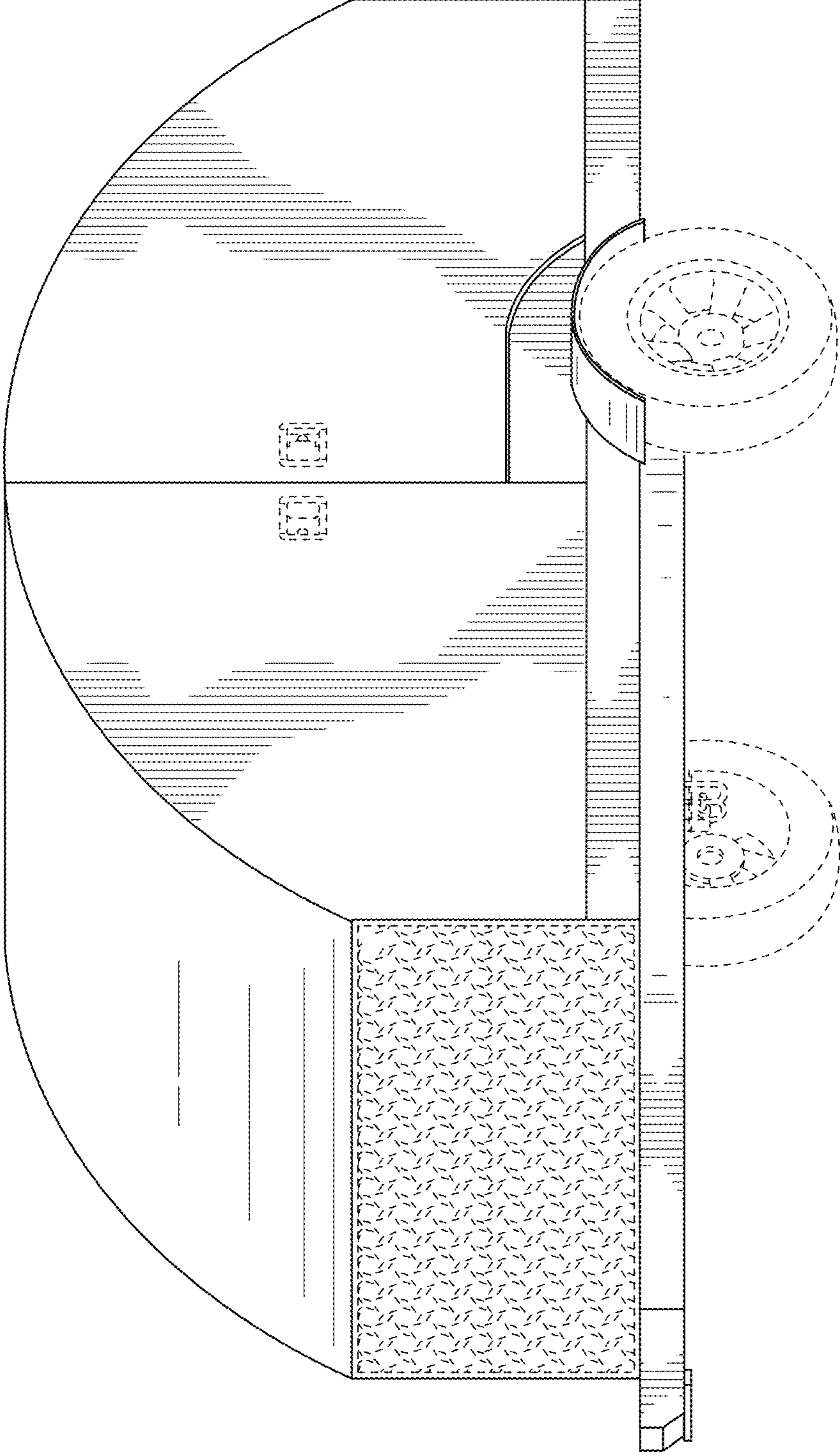

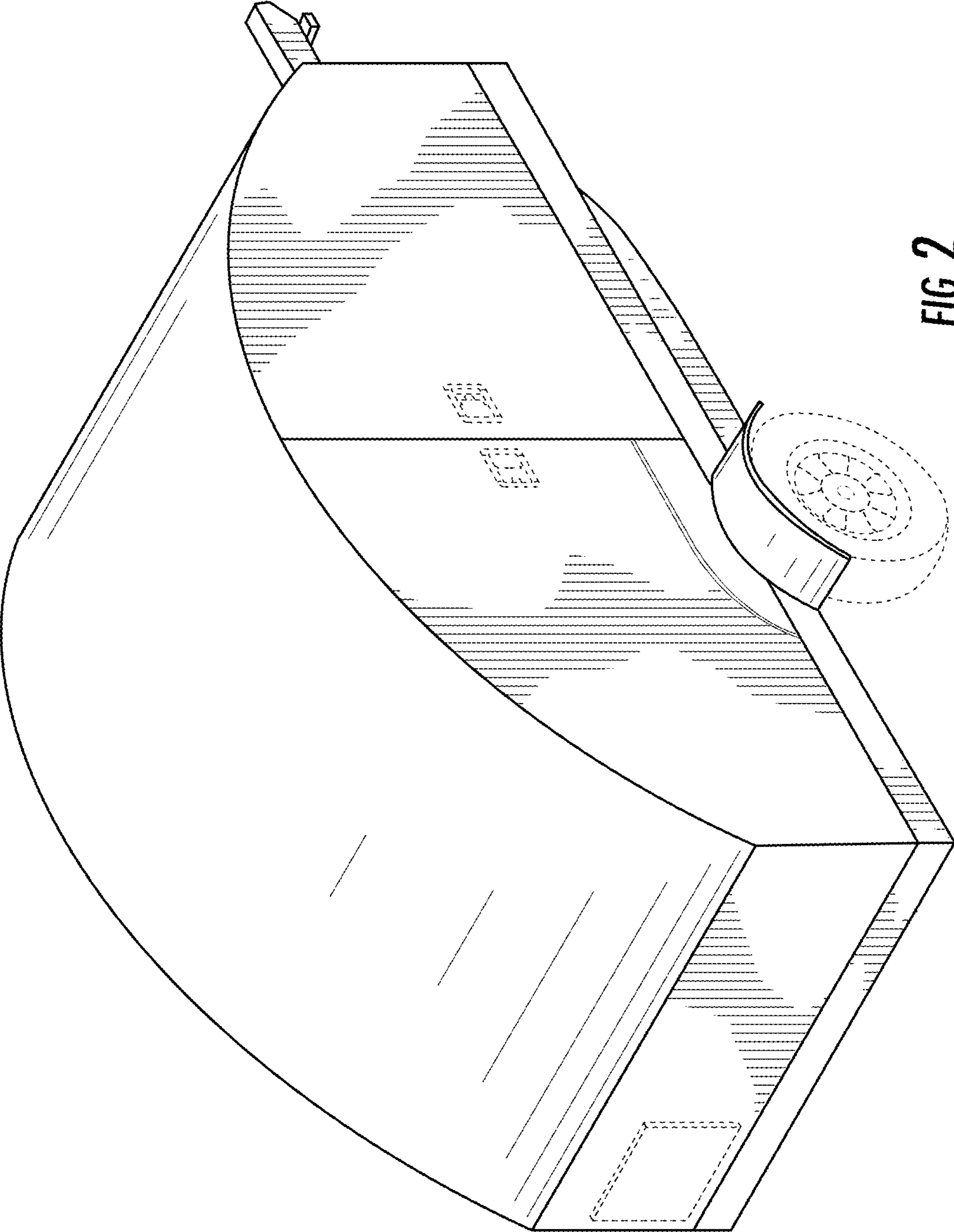

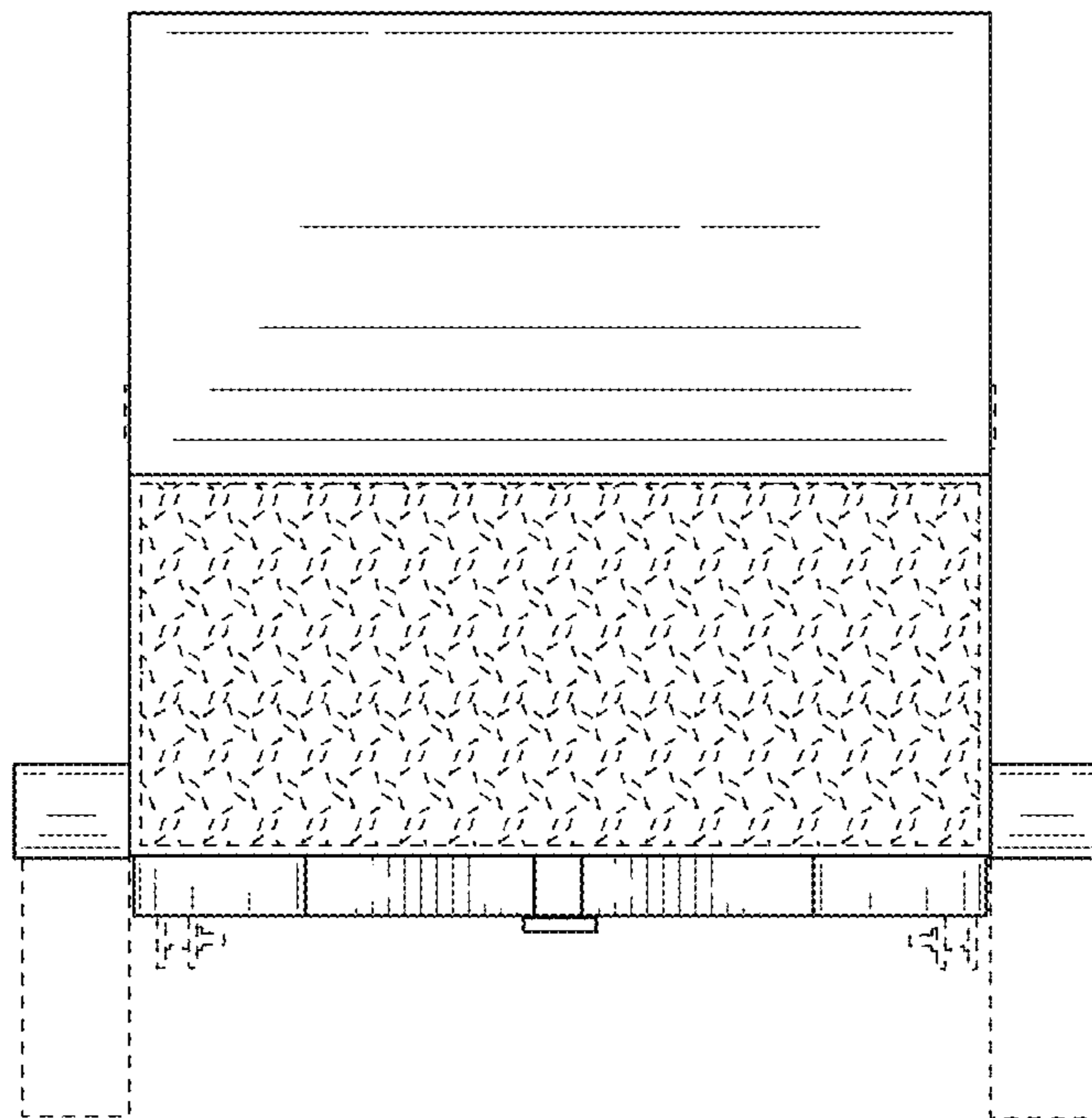

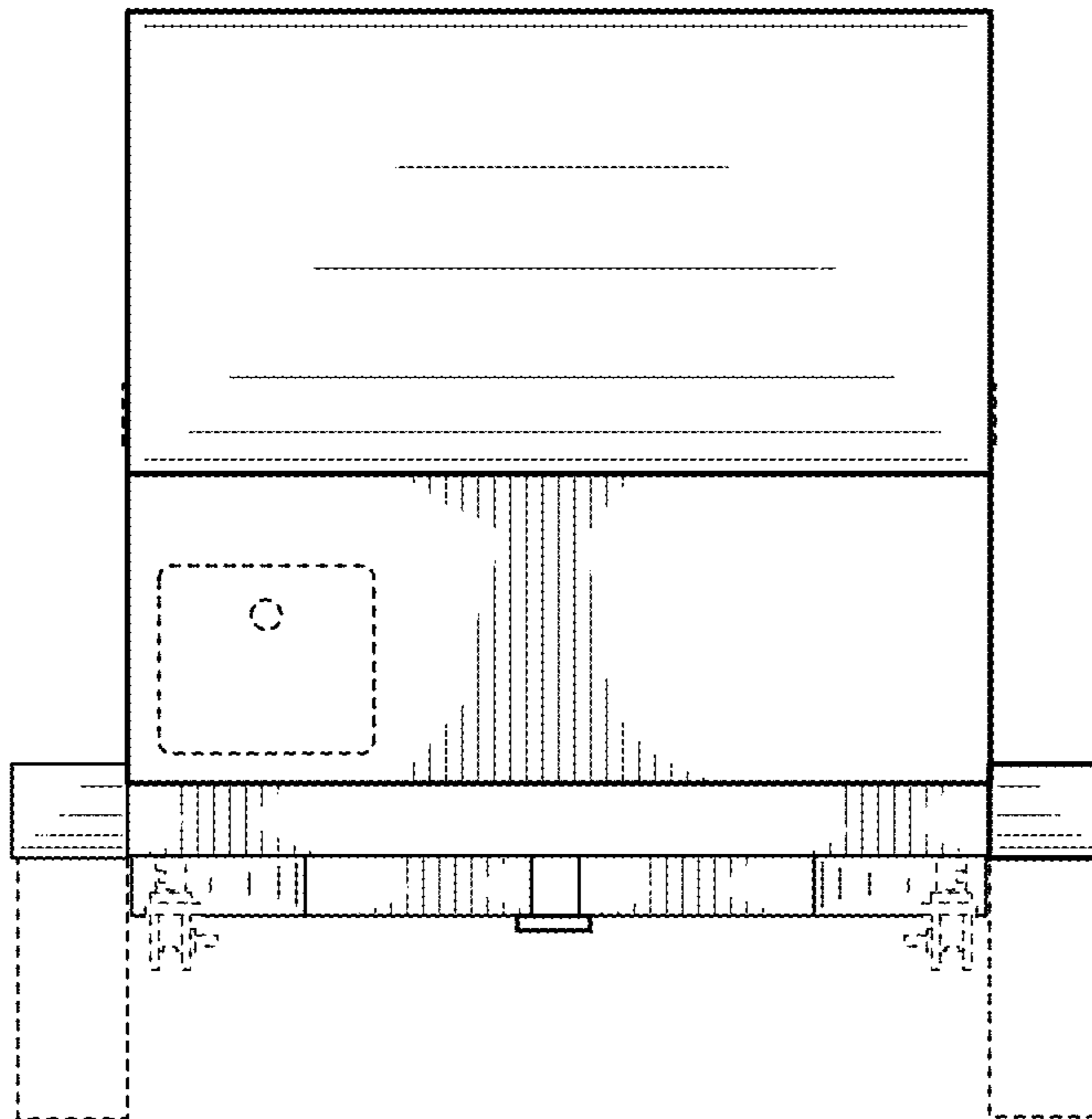

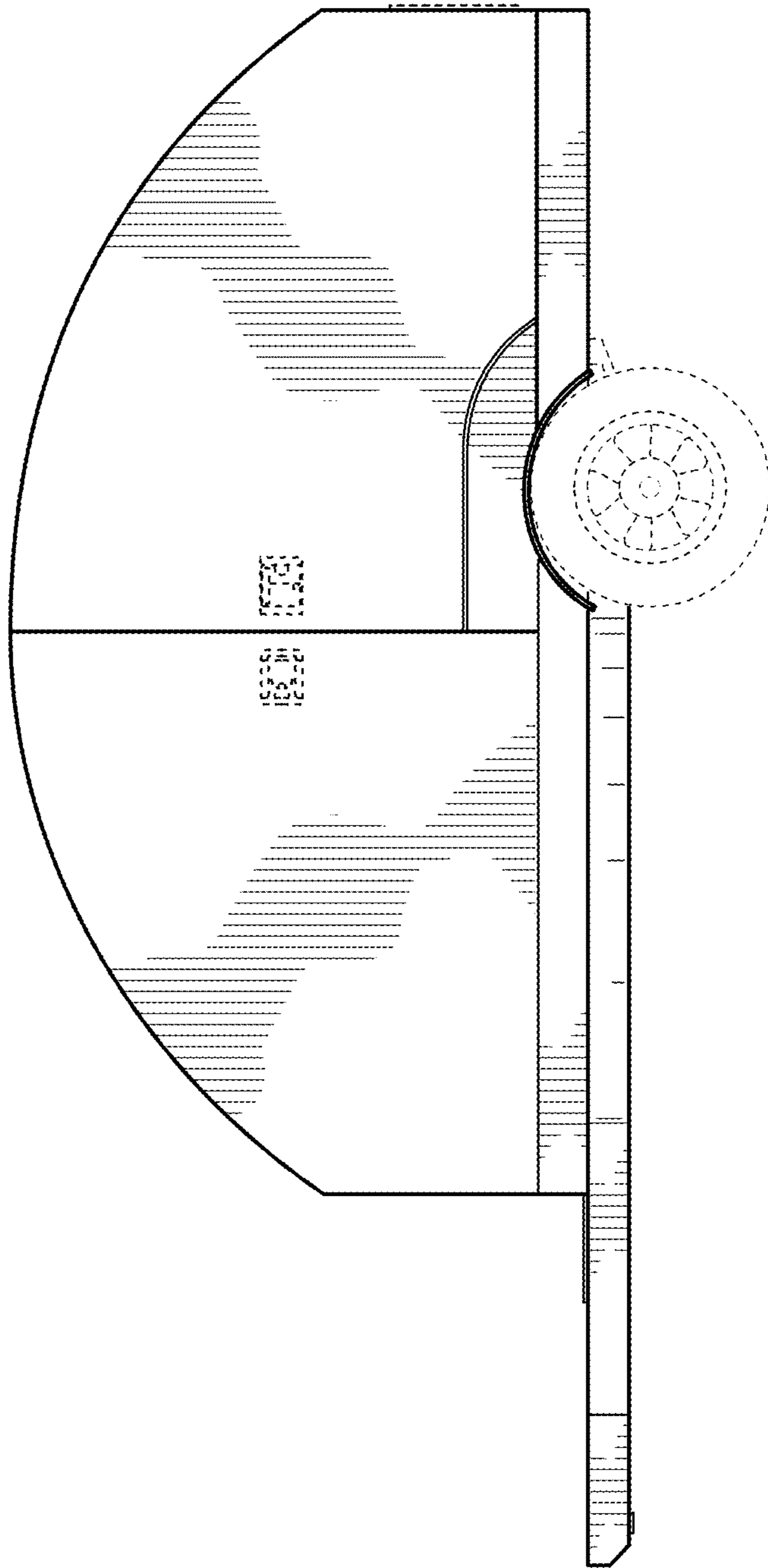

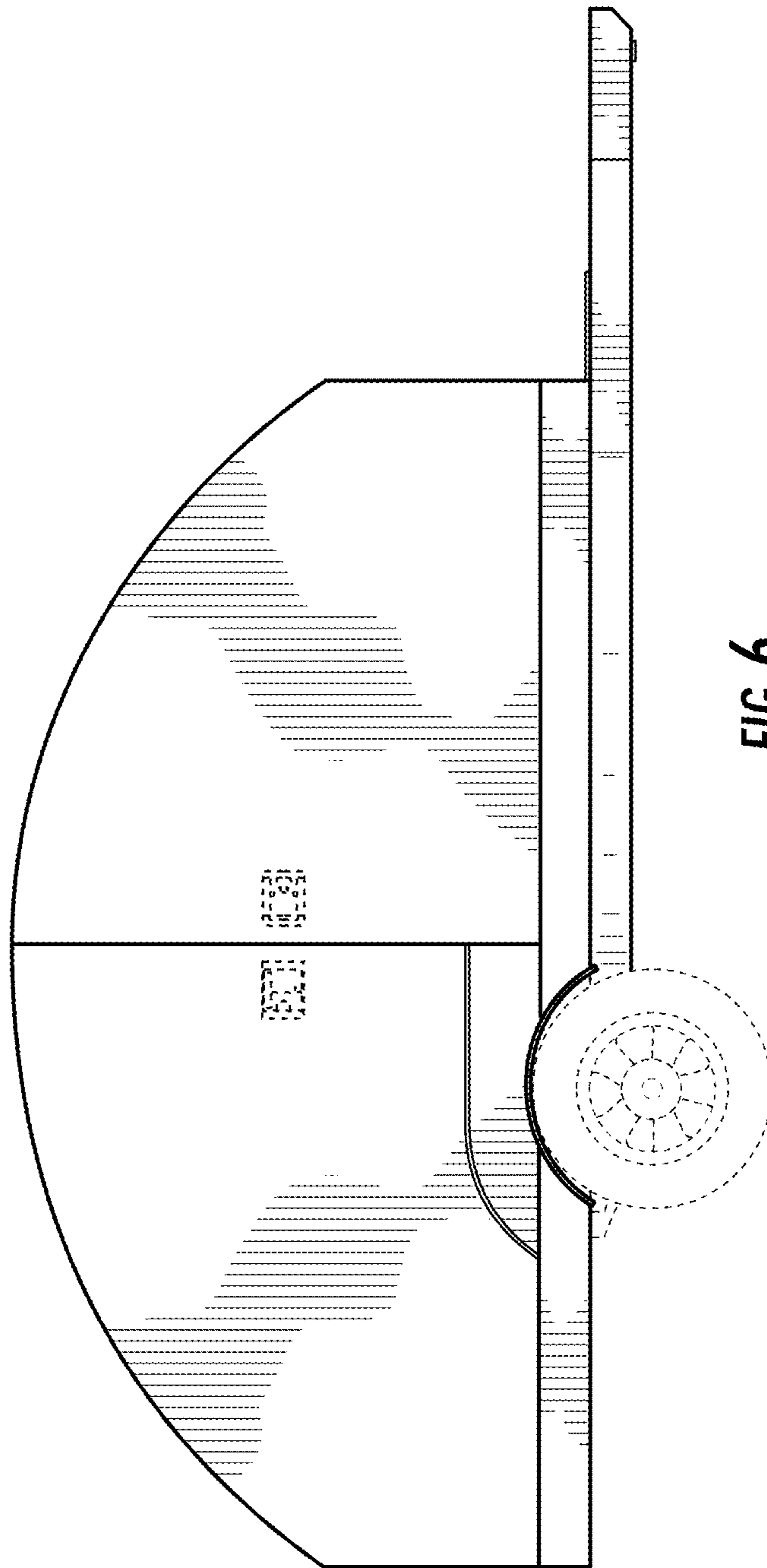

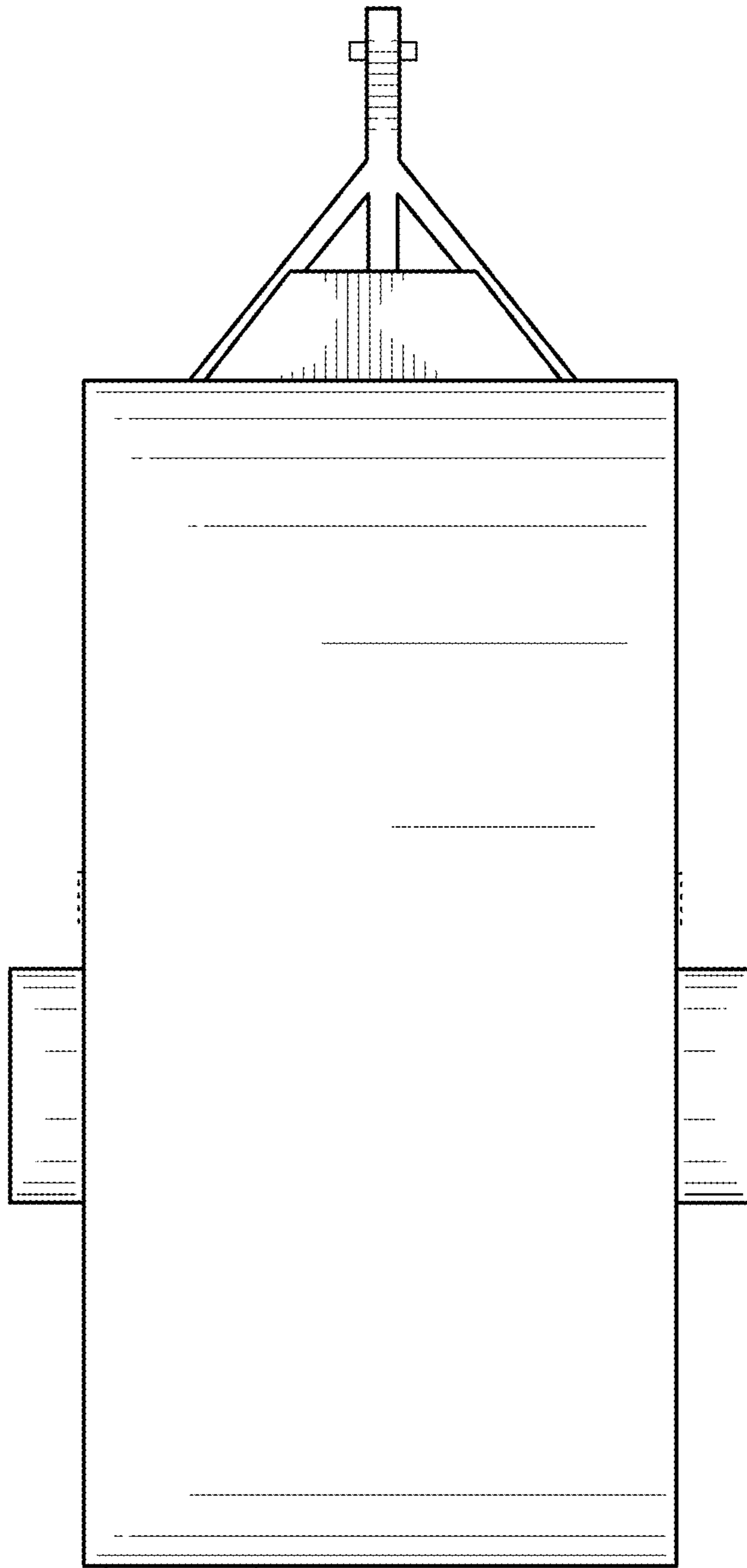

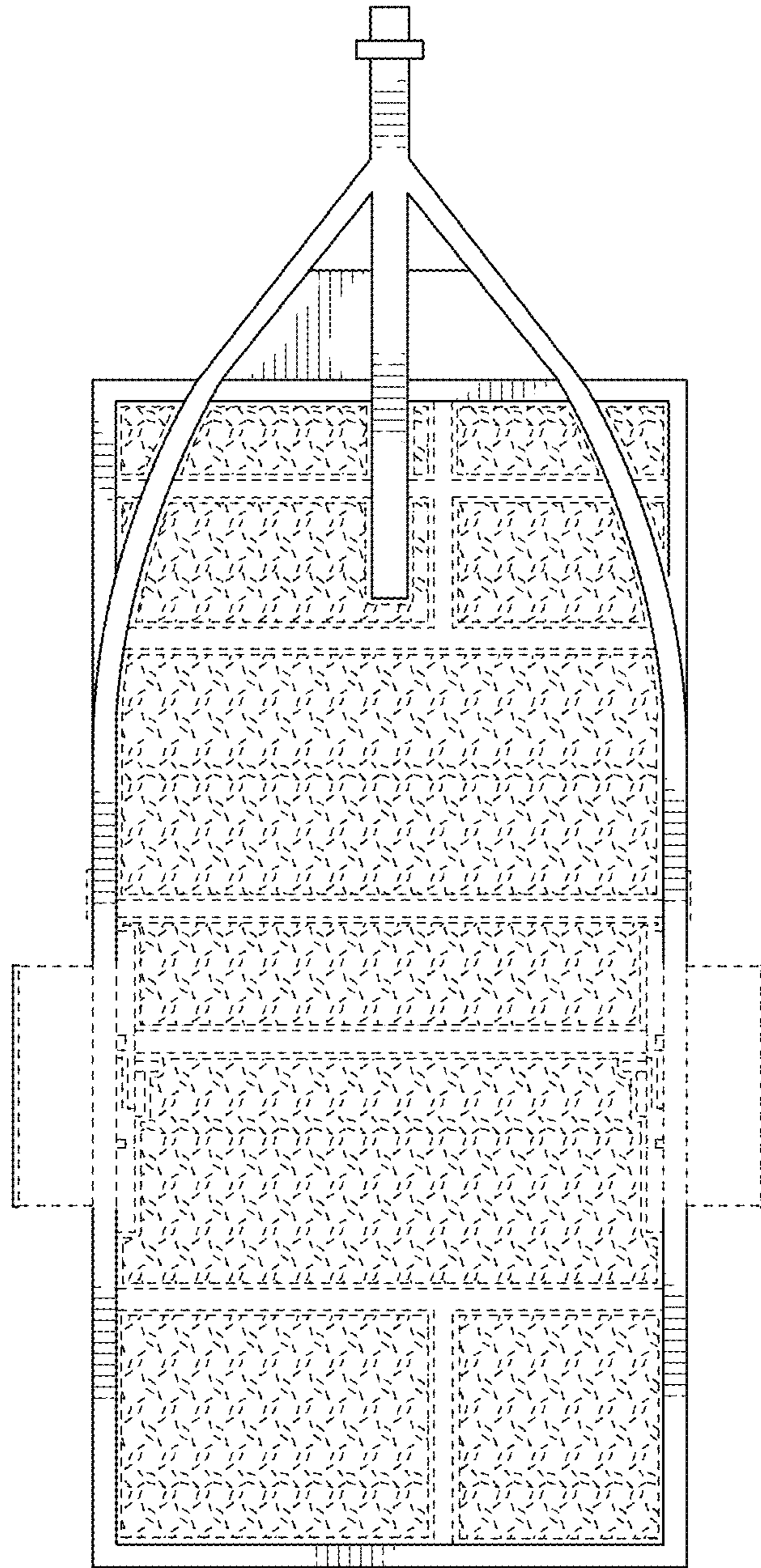
