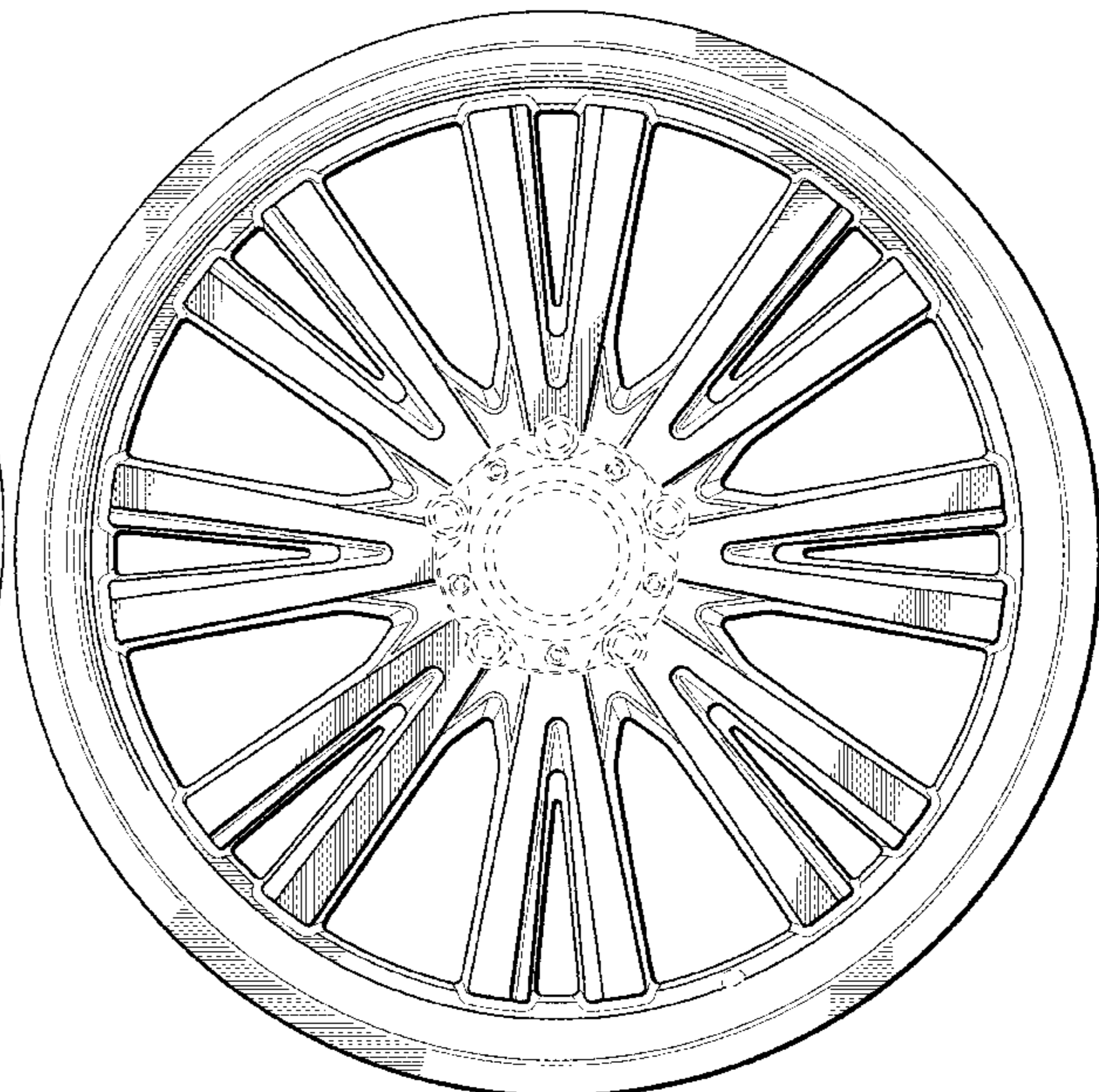
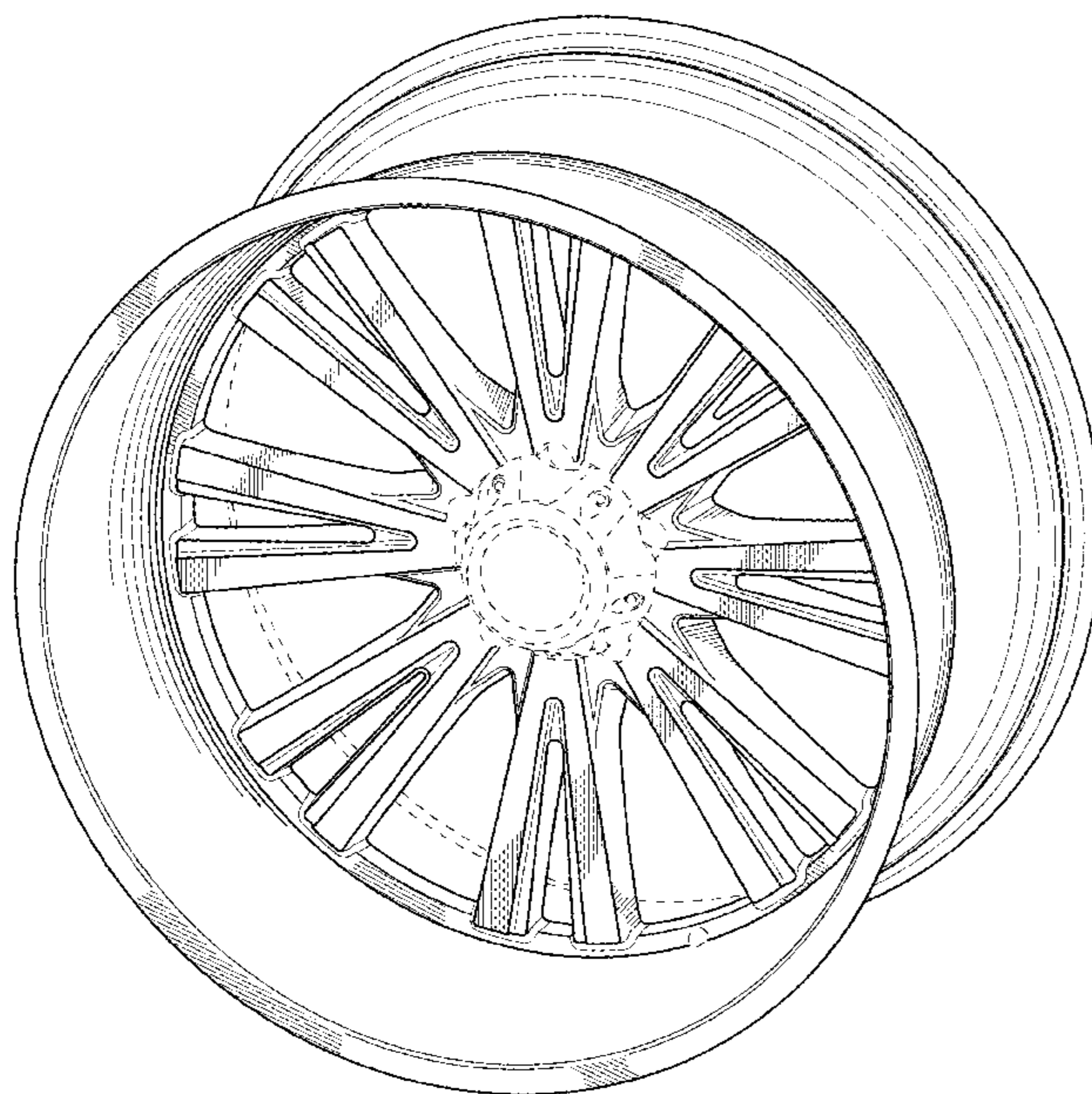
FIG. 1—Top, front, right side perspective view of a motor vehicle wheel;

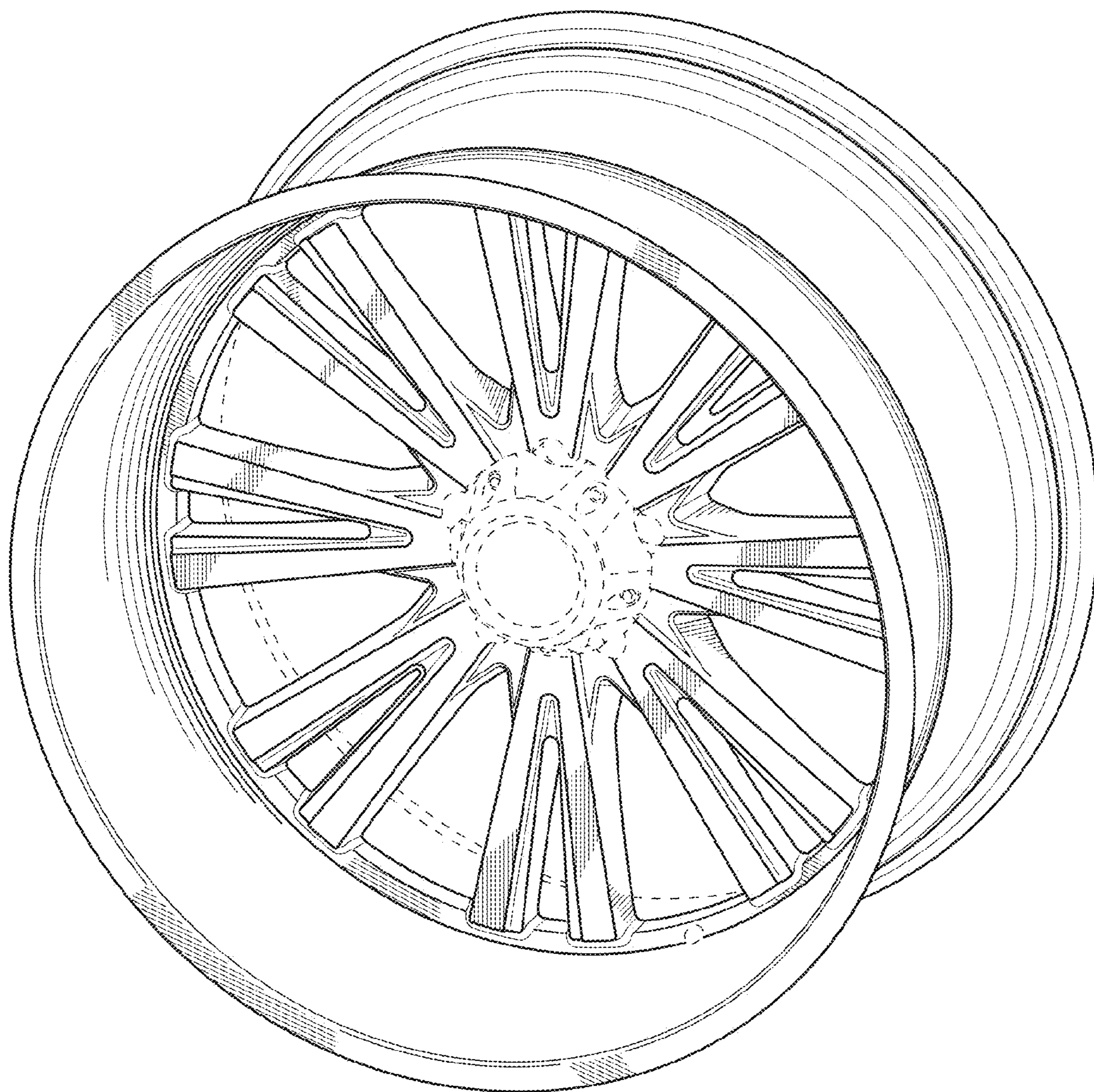
