(57) **CLAIM**

The ornamental design for a tire tread, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire including the tire tread of the present application taken from the front;

FIG. 2 is a front view thereof;

FIG. 3 is a side view thereof, the opposite side being identical;

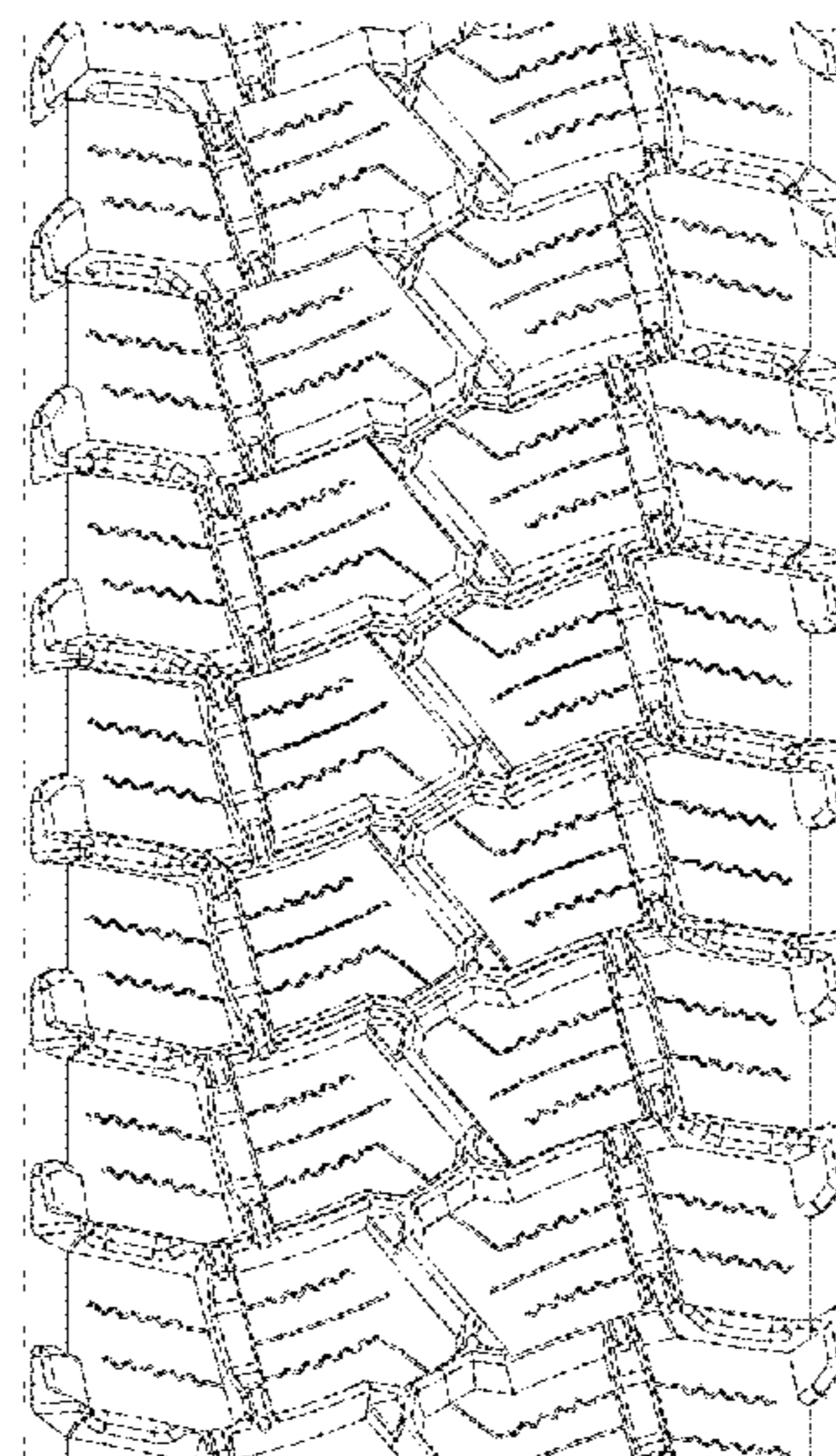
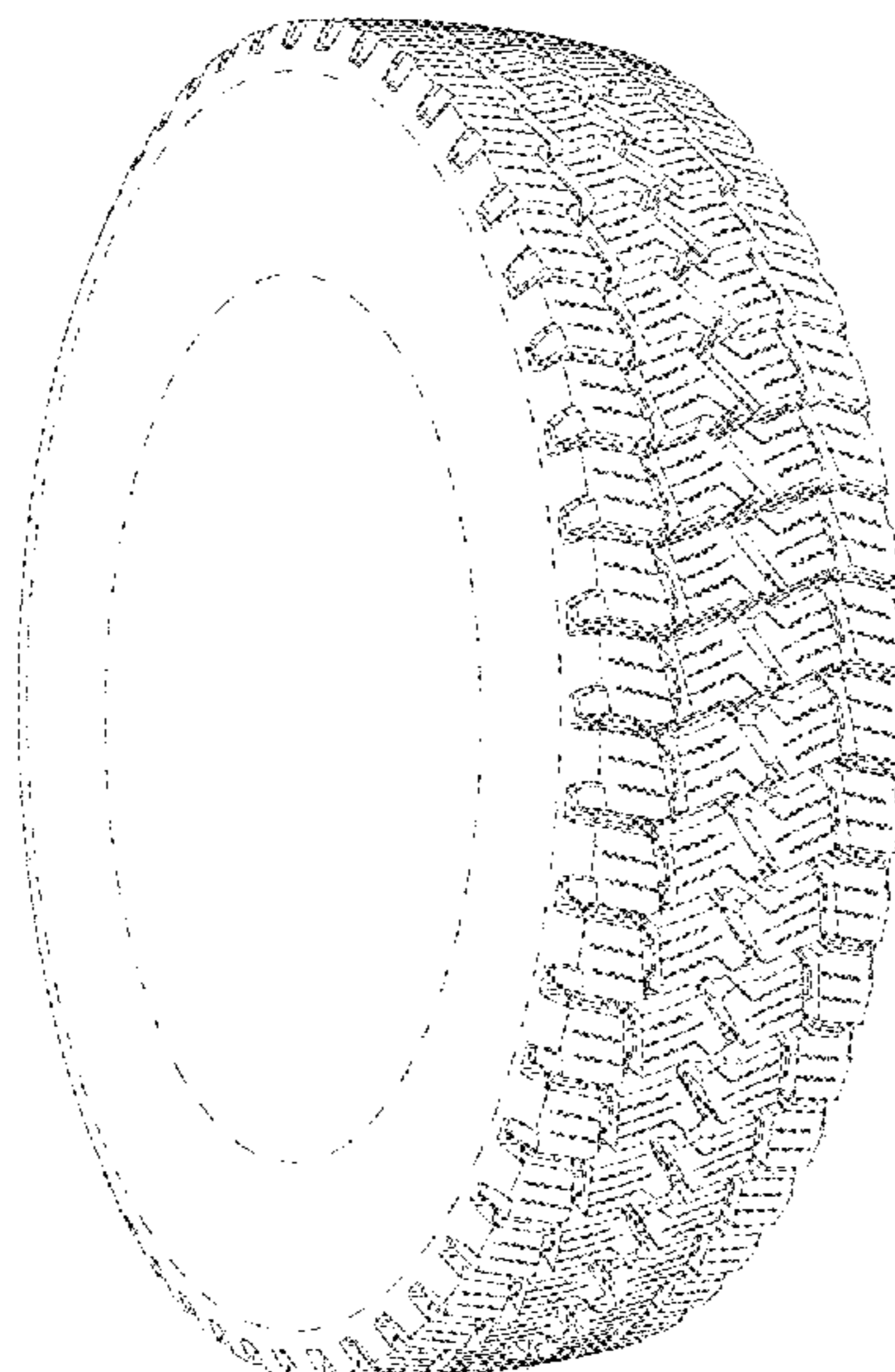
FIG. 4 is an enlarged partial, perspective view taken from the front and side thereof;

FIG. 5 is an enlarged, partial front view thereof; and,

FIG. 6 is an enlarged, partial side view thereof.

The broken lines and the region between the broken lines defining the inner bead and the sidewall depict subject matter that forms no part of the claimed tire tread design, and are included for the purpose of illustrating the full tire. Likewise, the tire interior forms no part of the claim. The tread pattern is understood to repeat uniformly throughout the circumference of the tire.

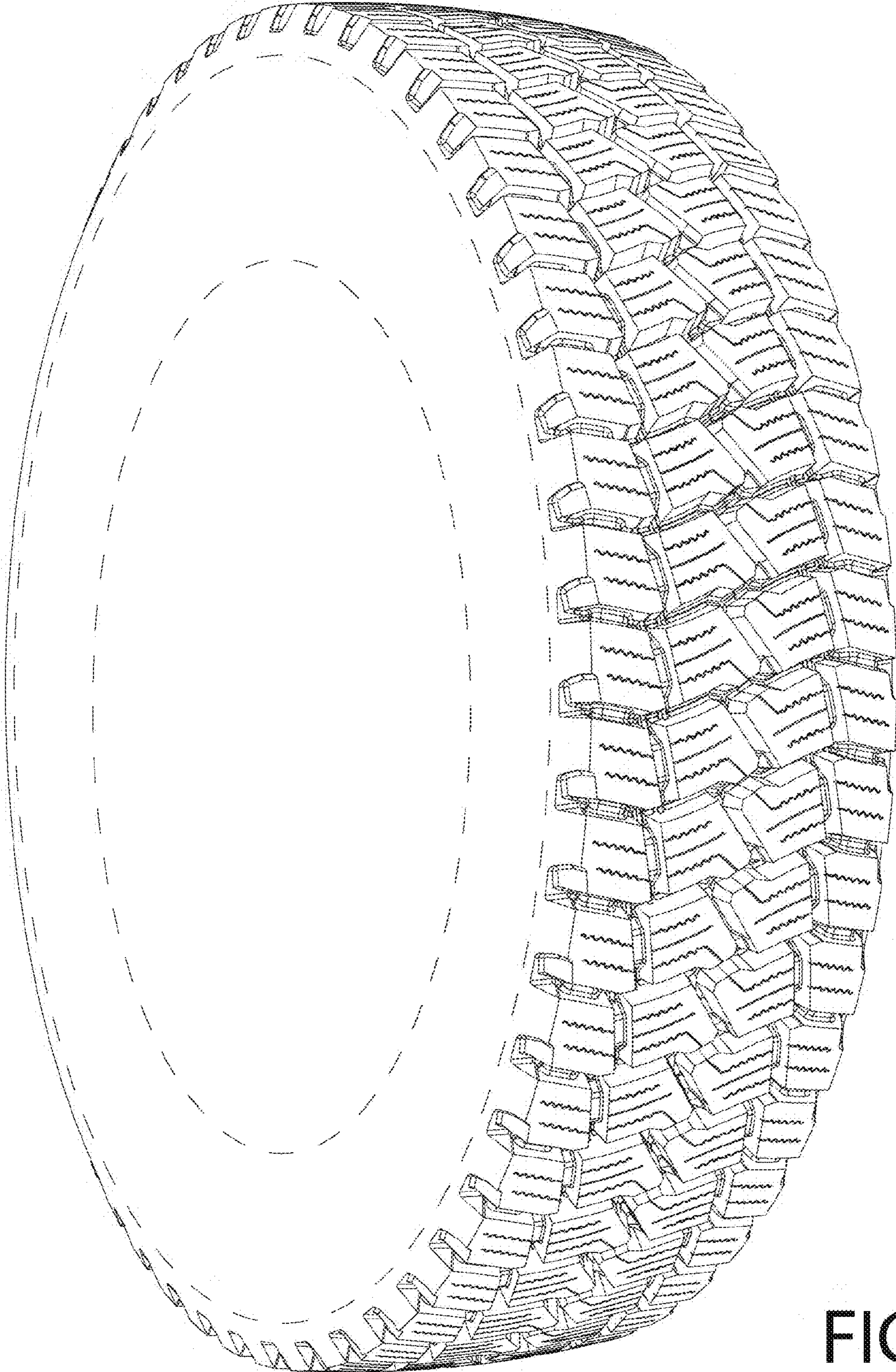

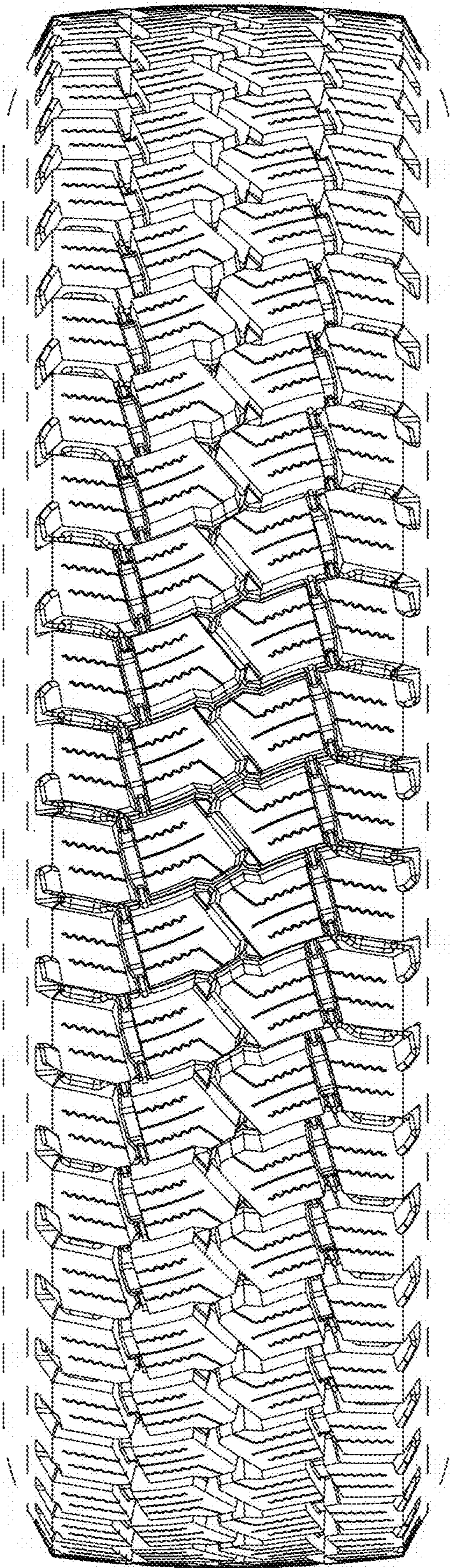

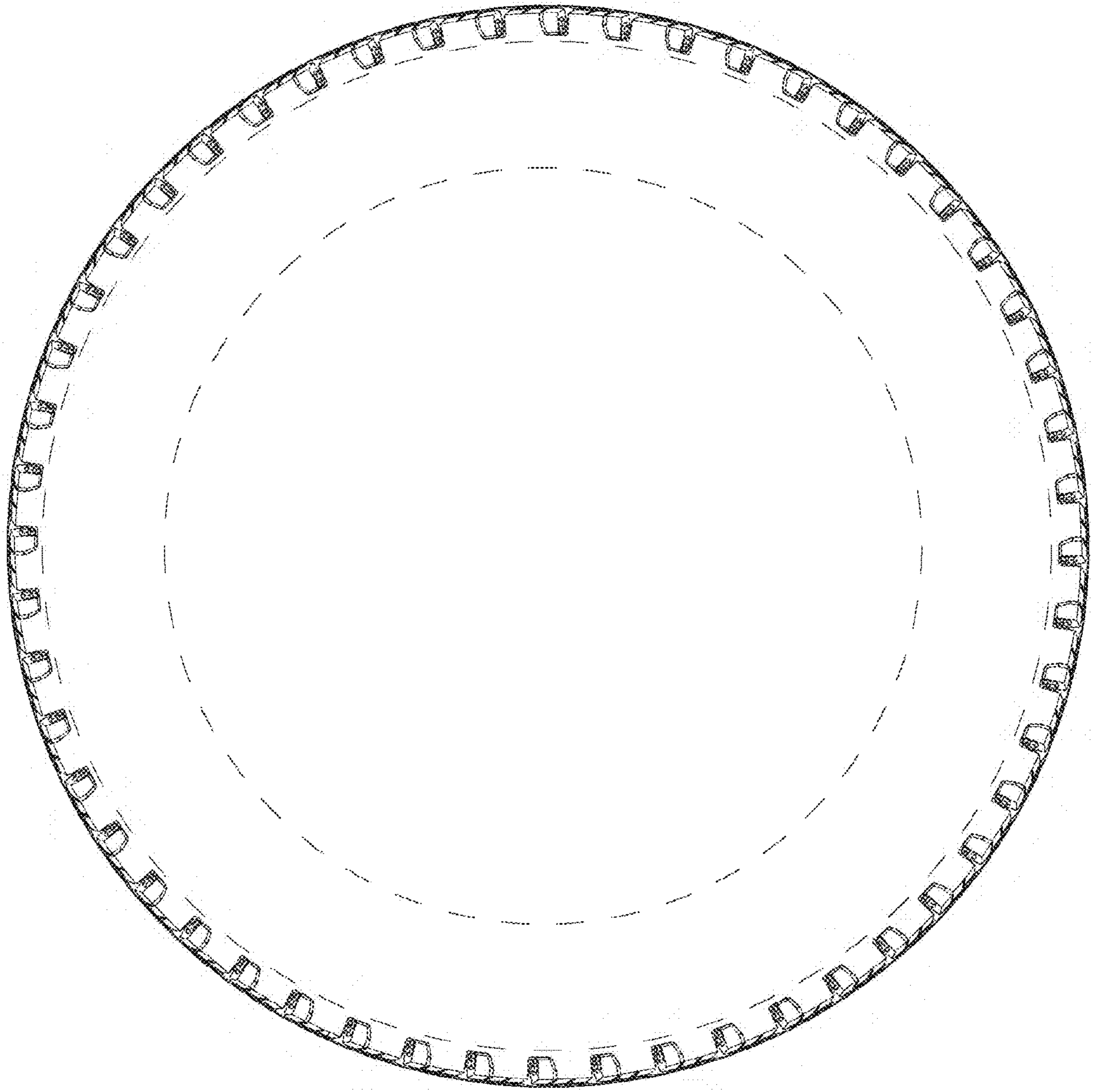

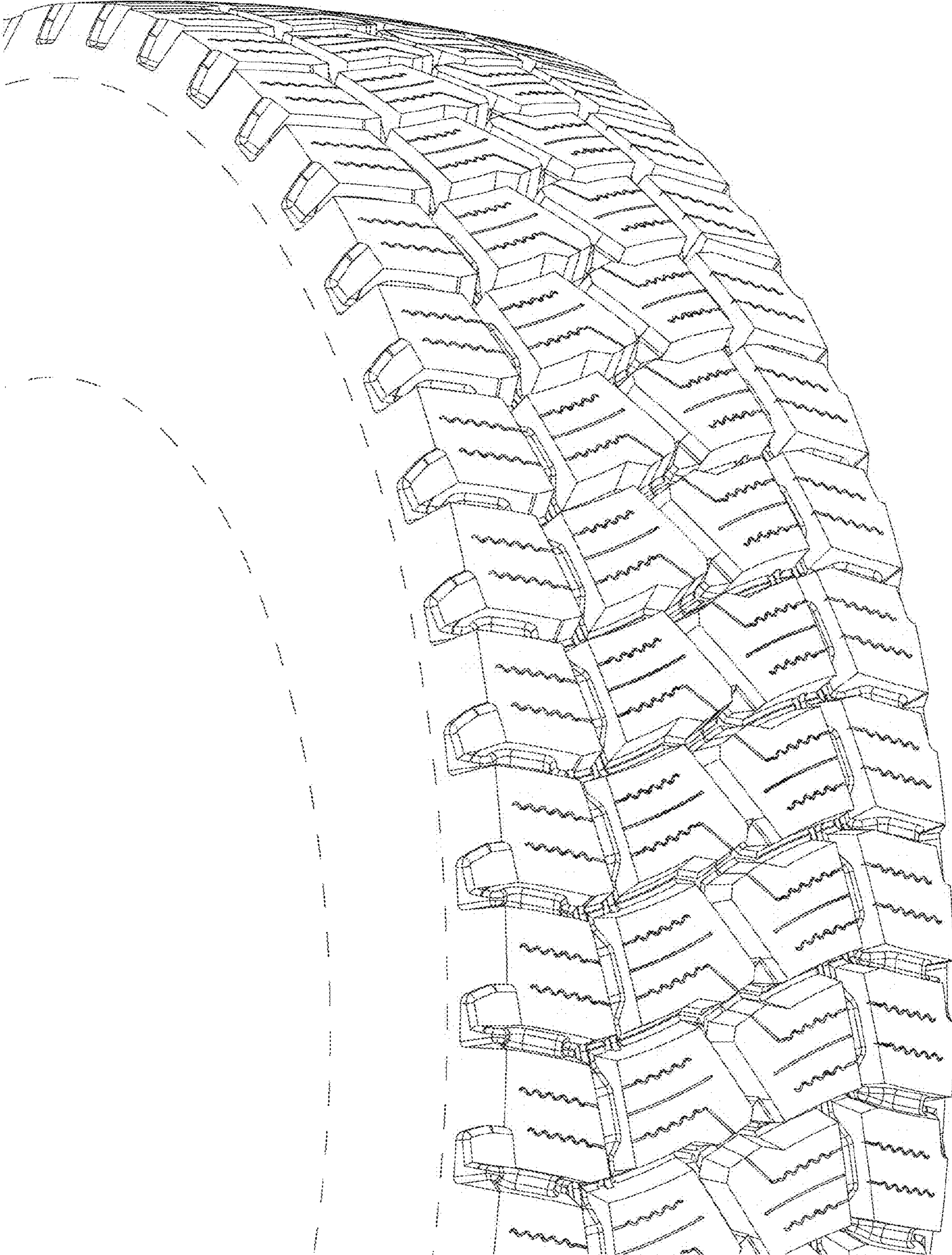

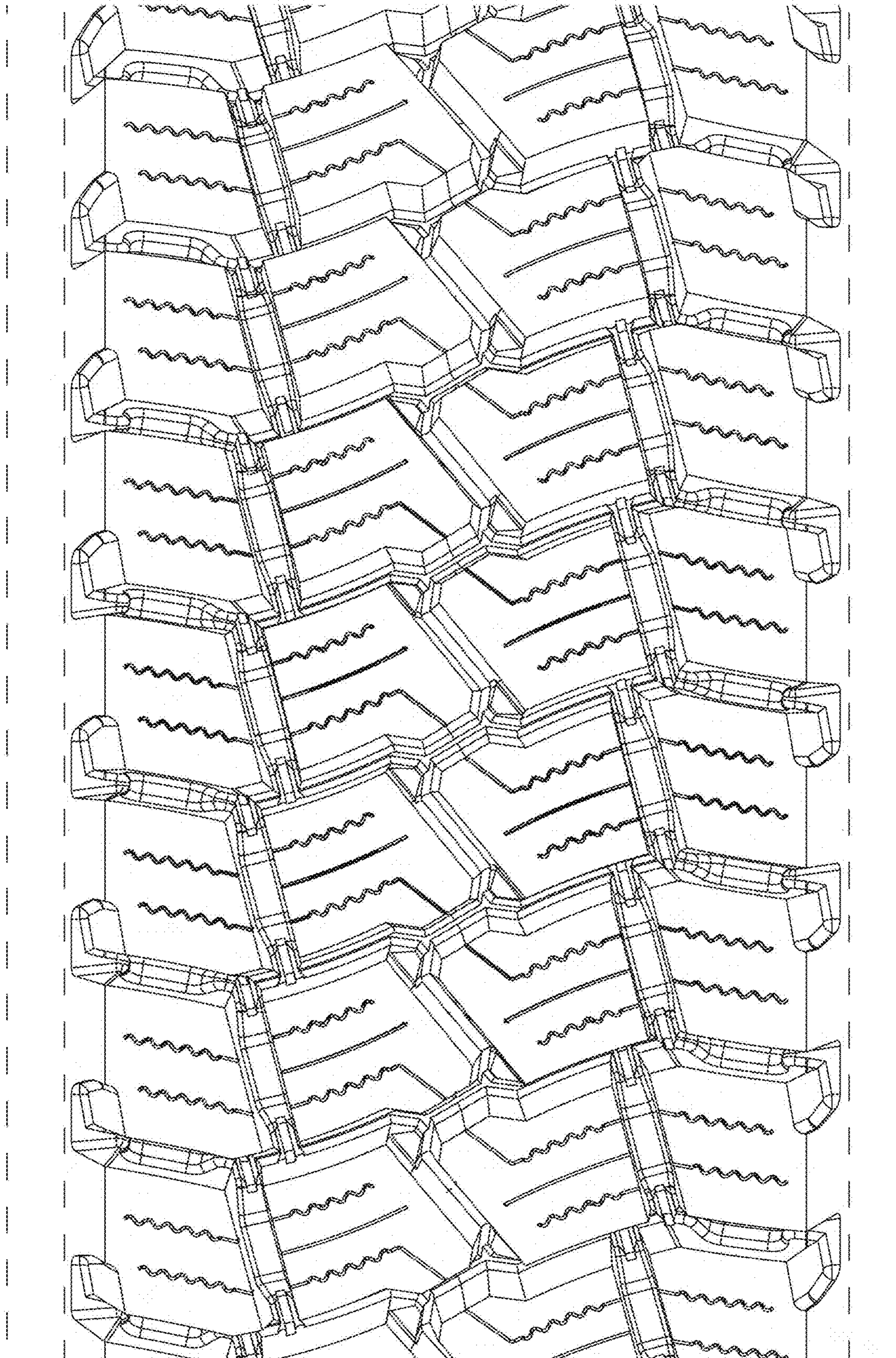

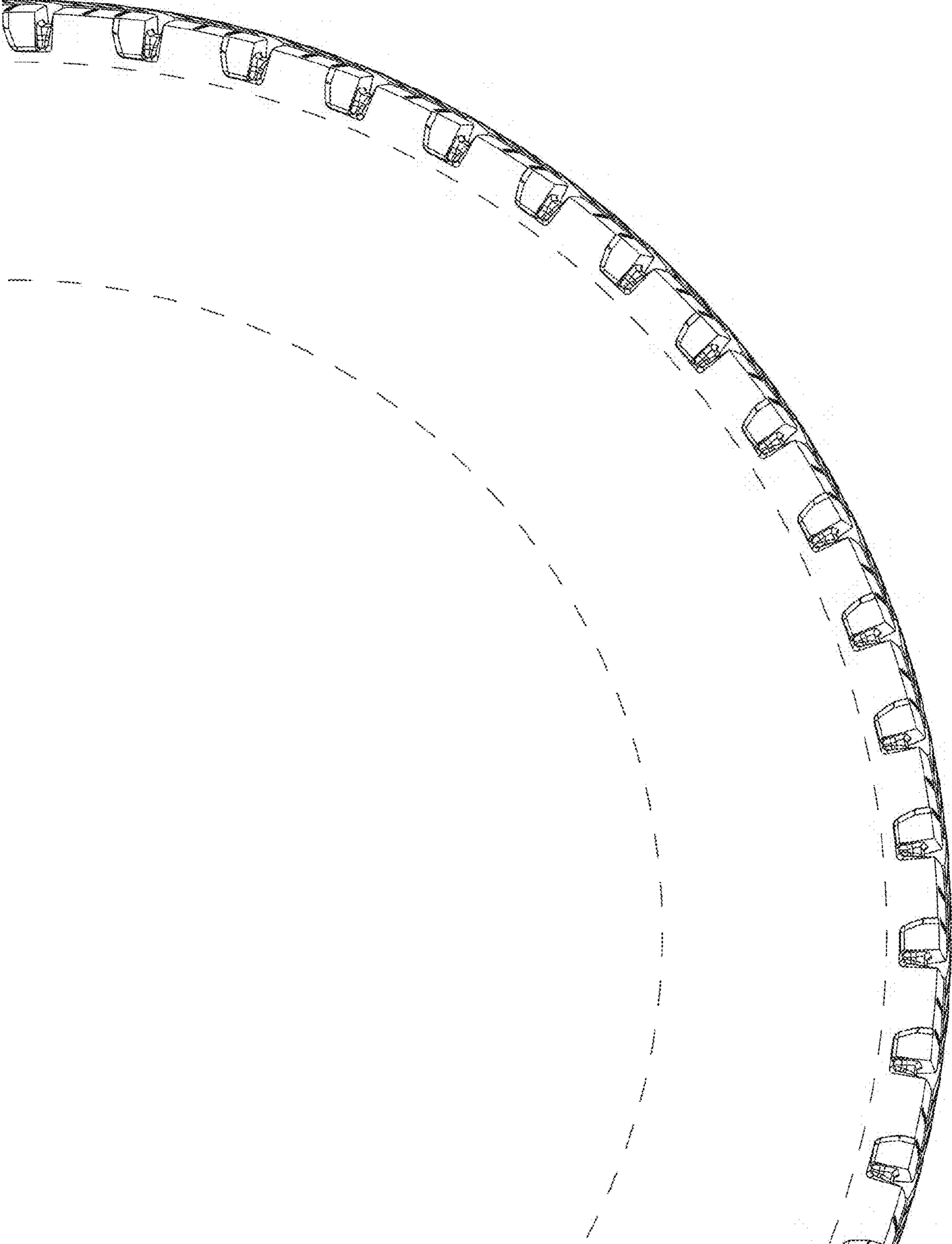
