(57) **CLAIM**

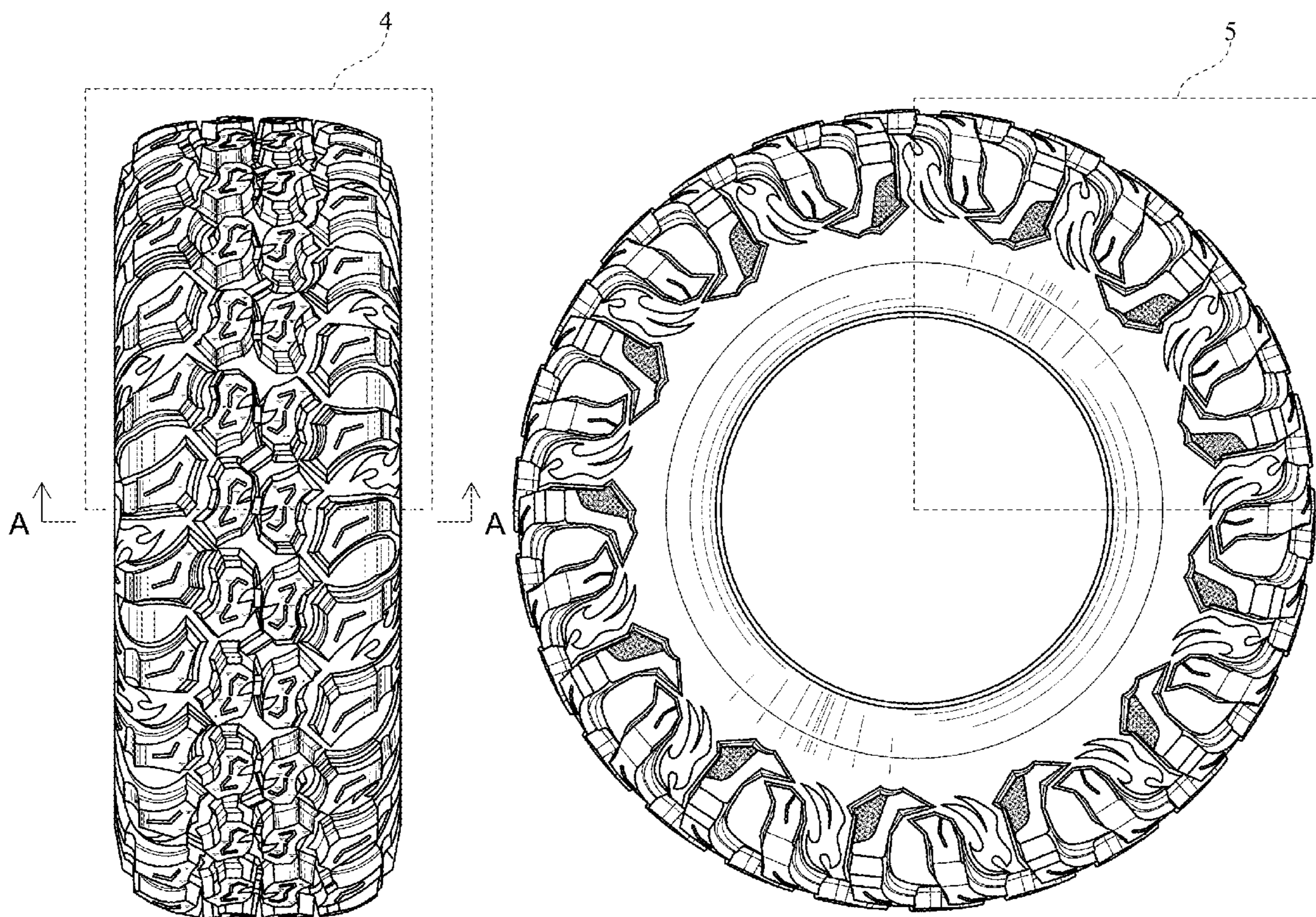
The ornamental design for all-terrain vehicle tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of all-terrain vehicle tire, showing my new design;

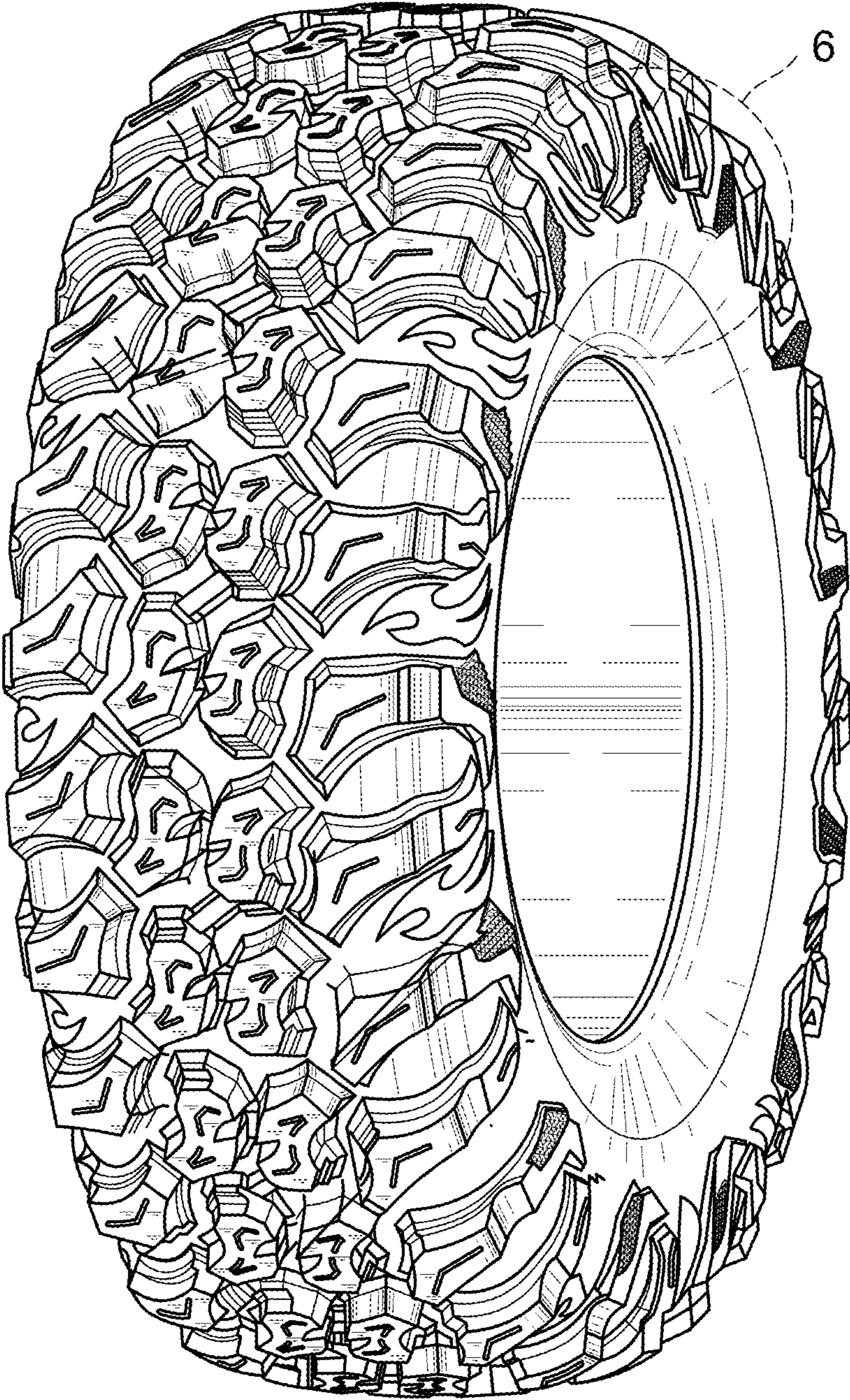

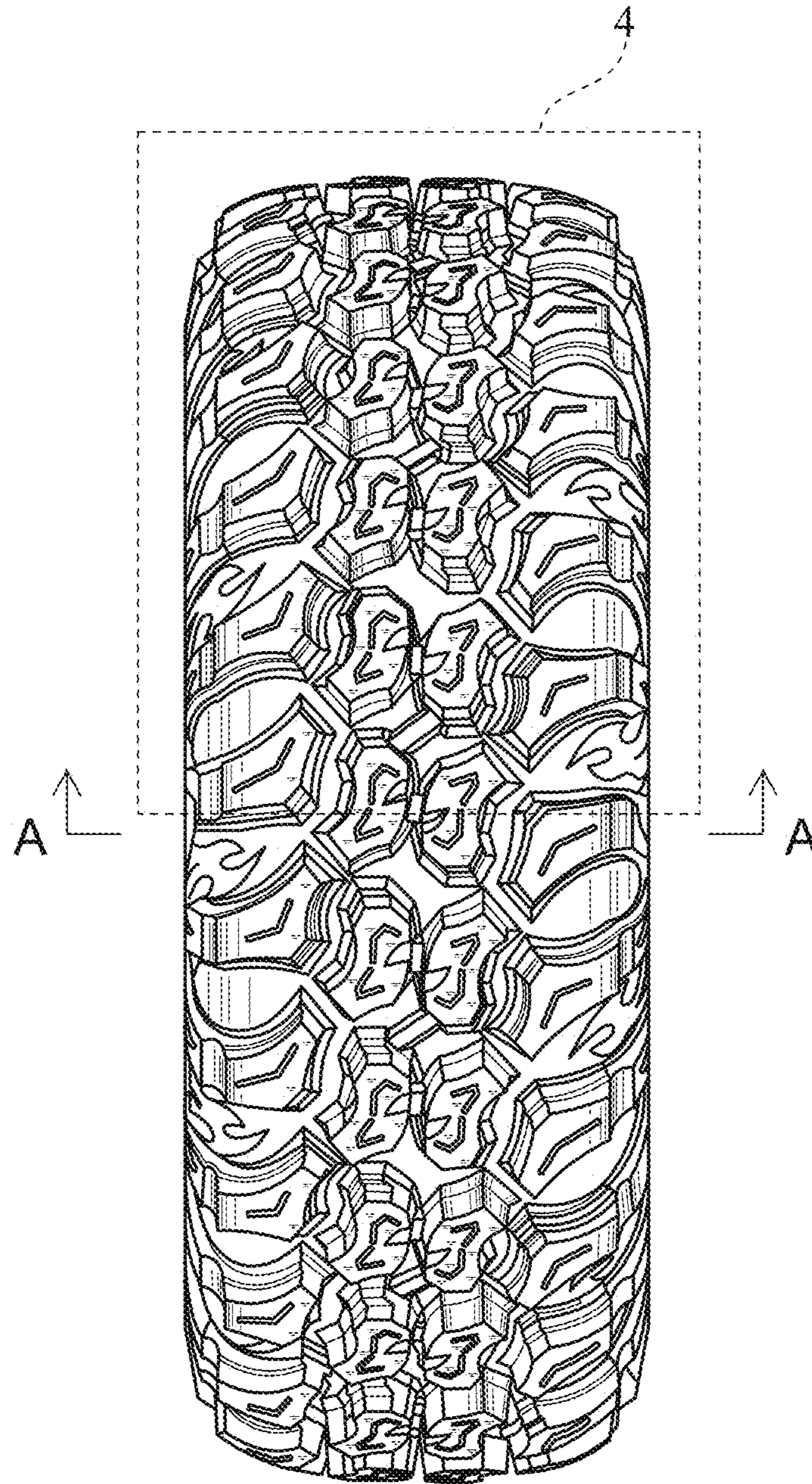

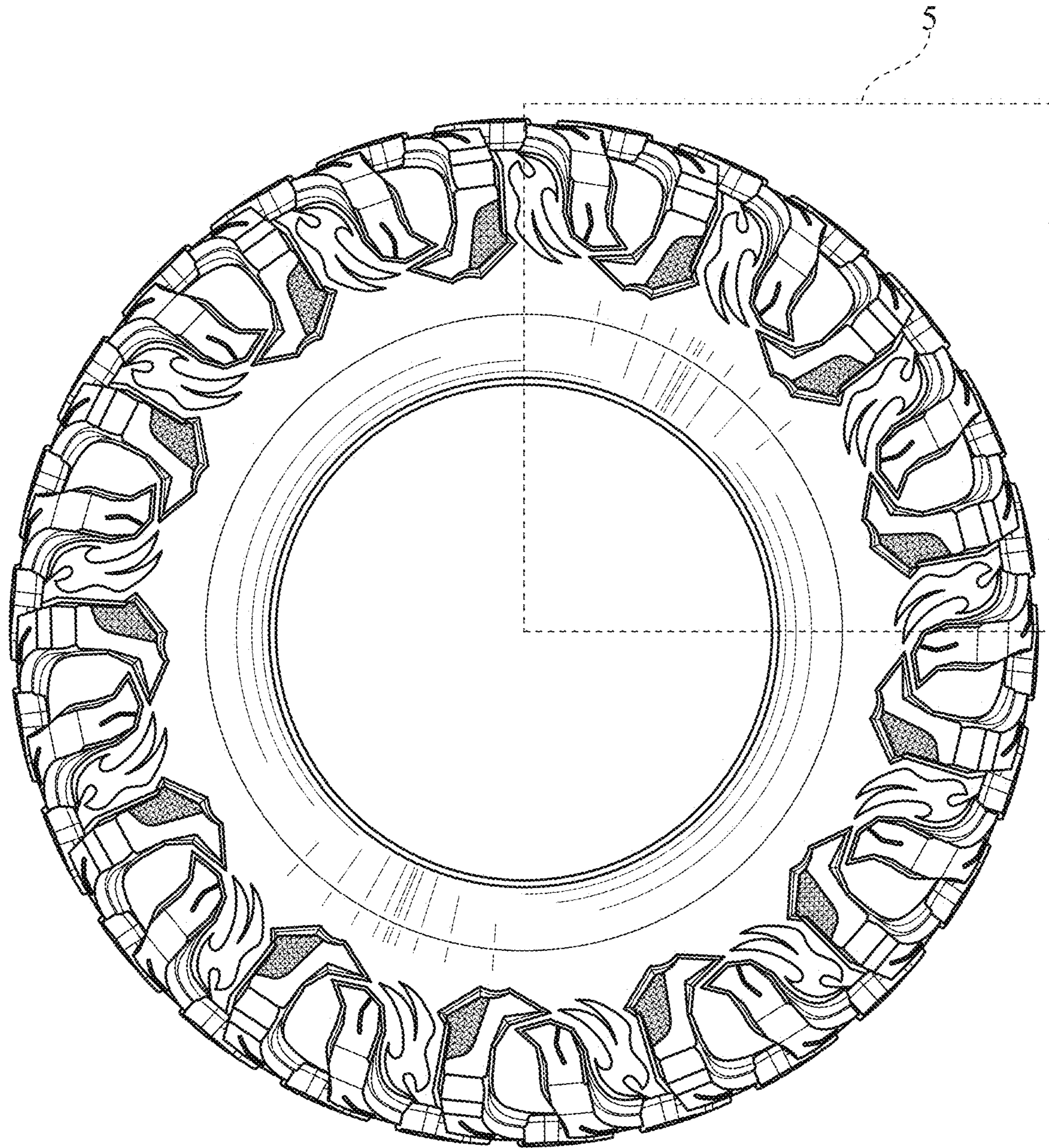

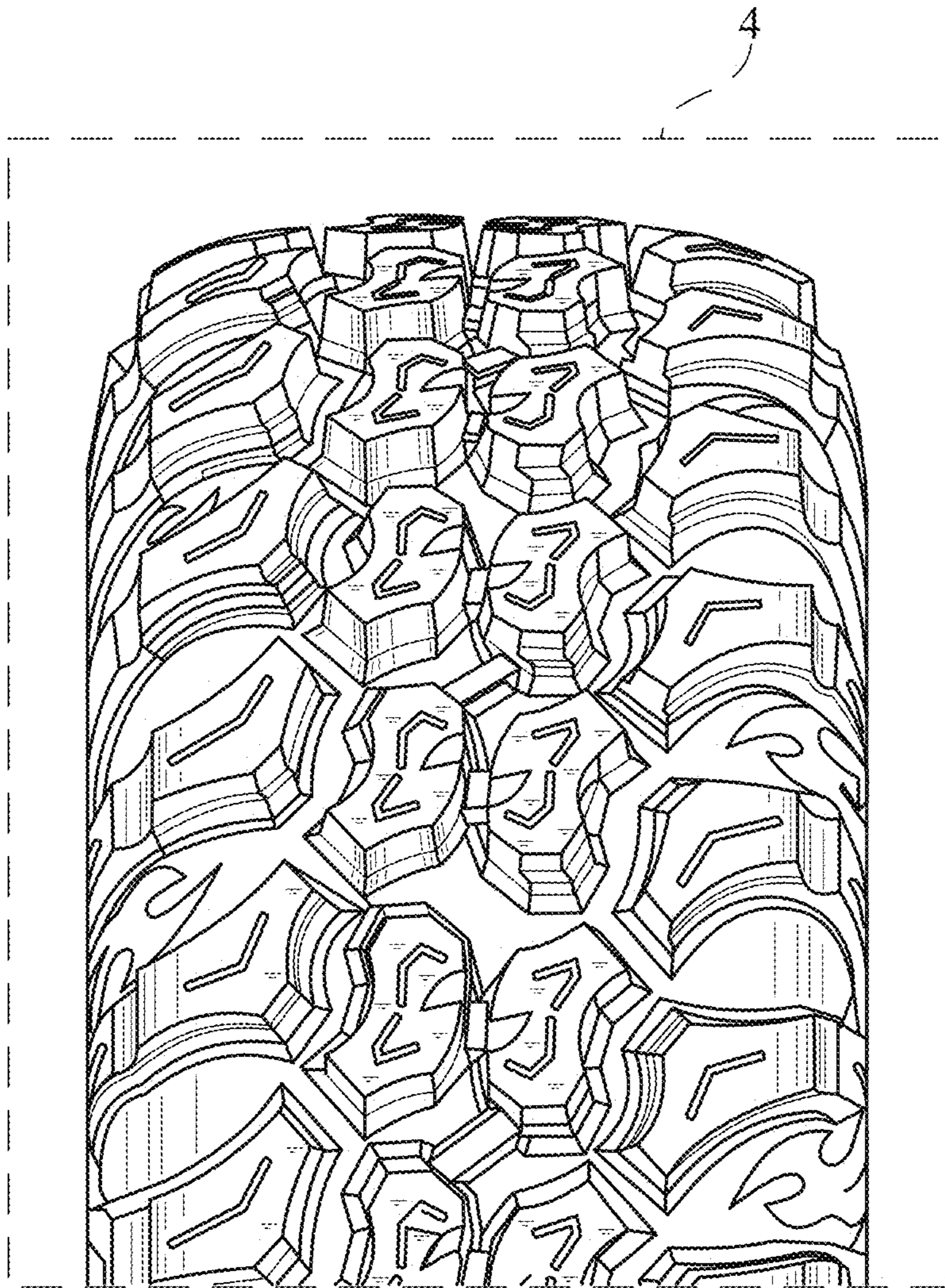

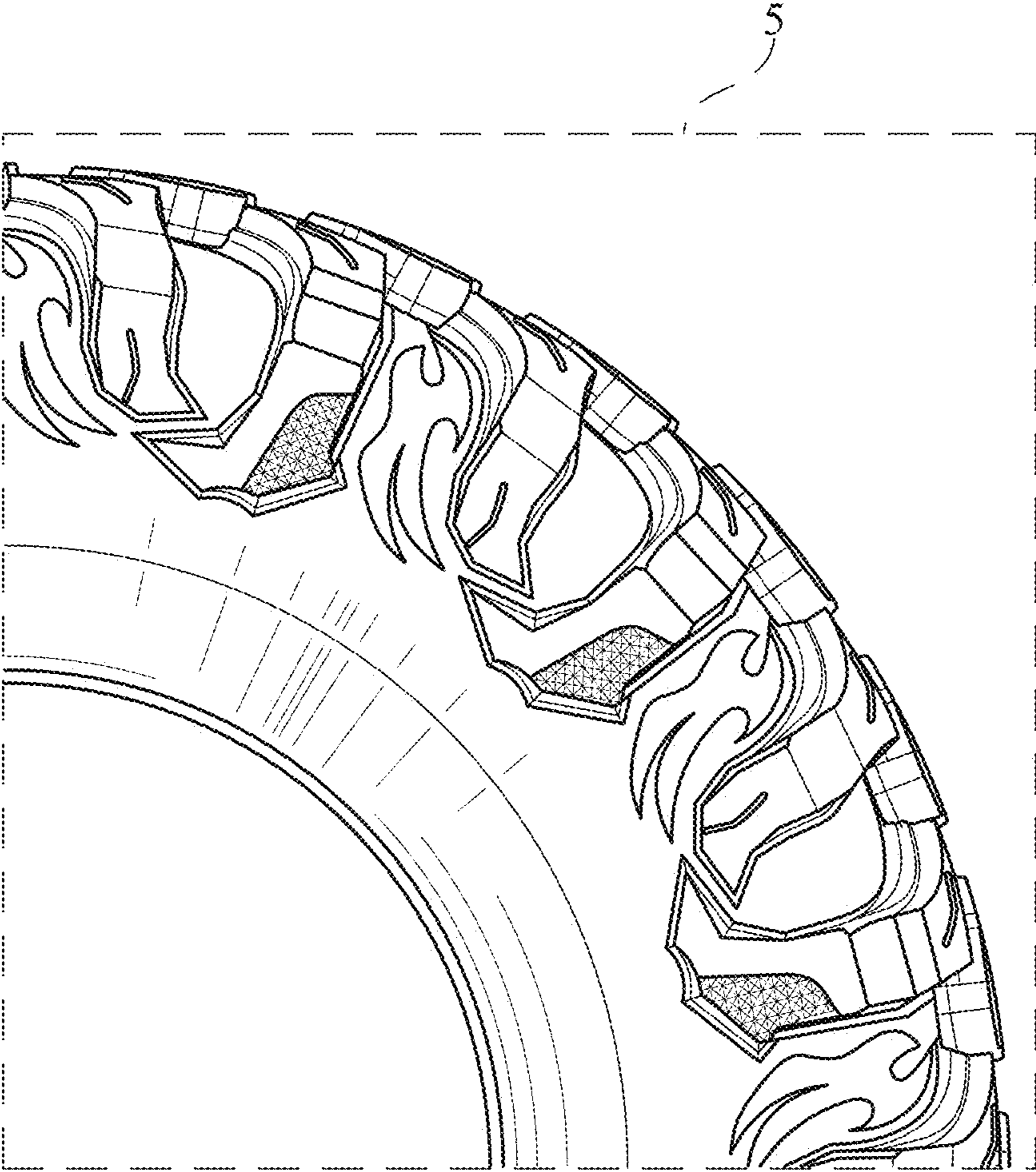

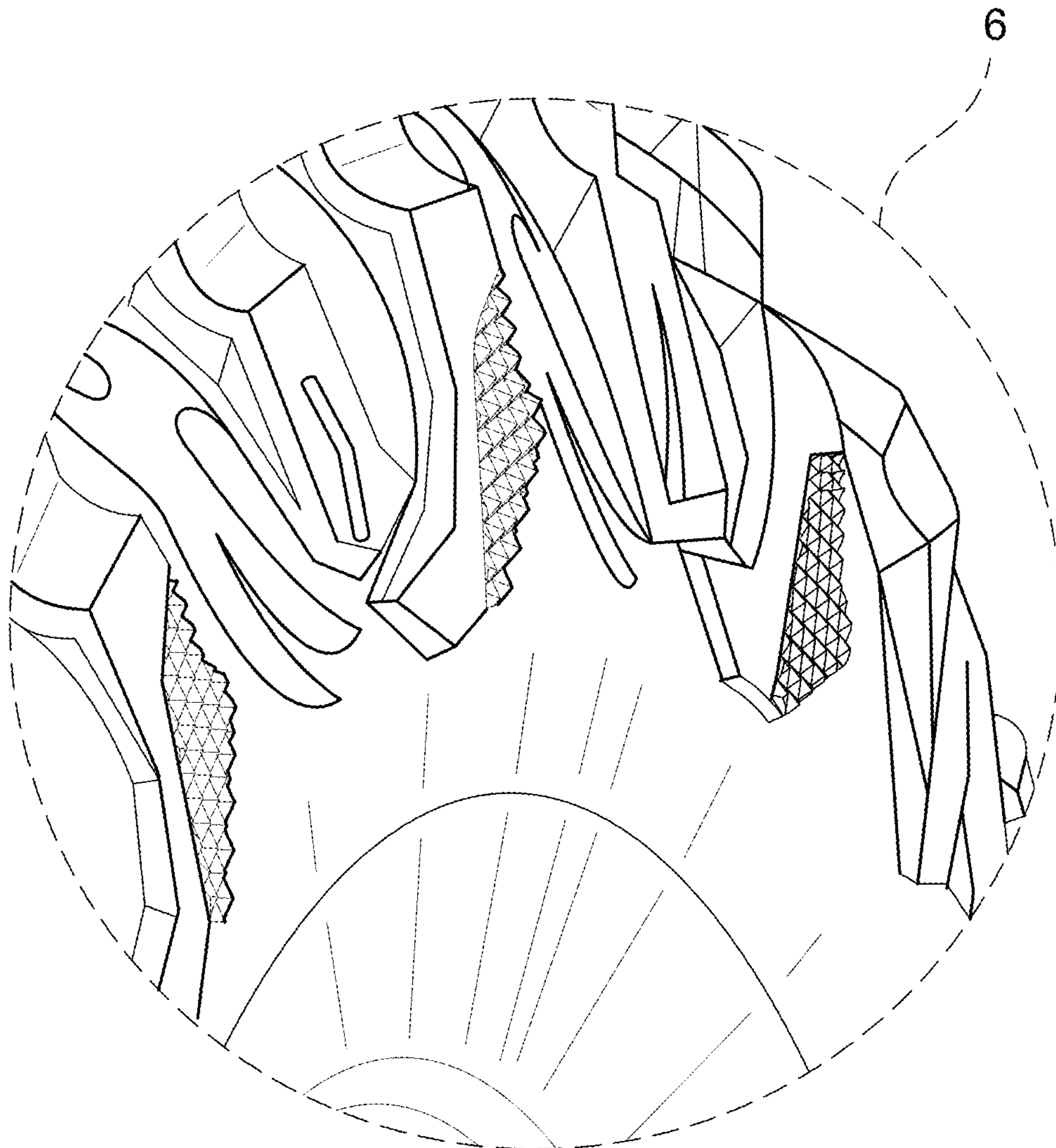

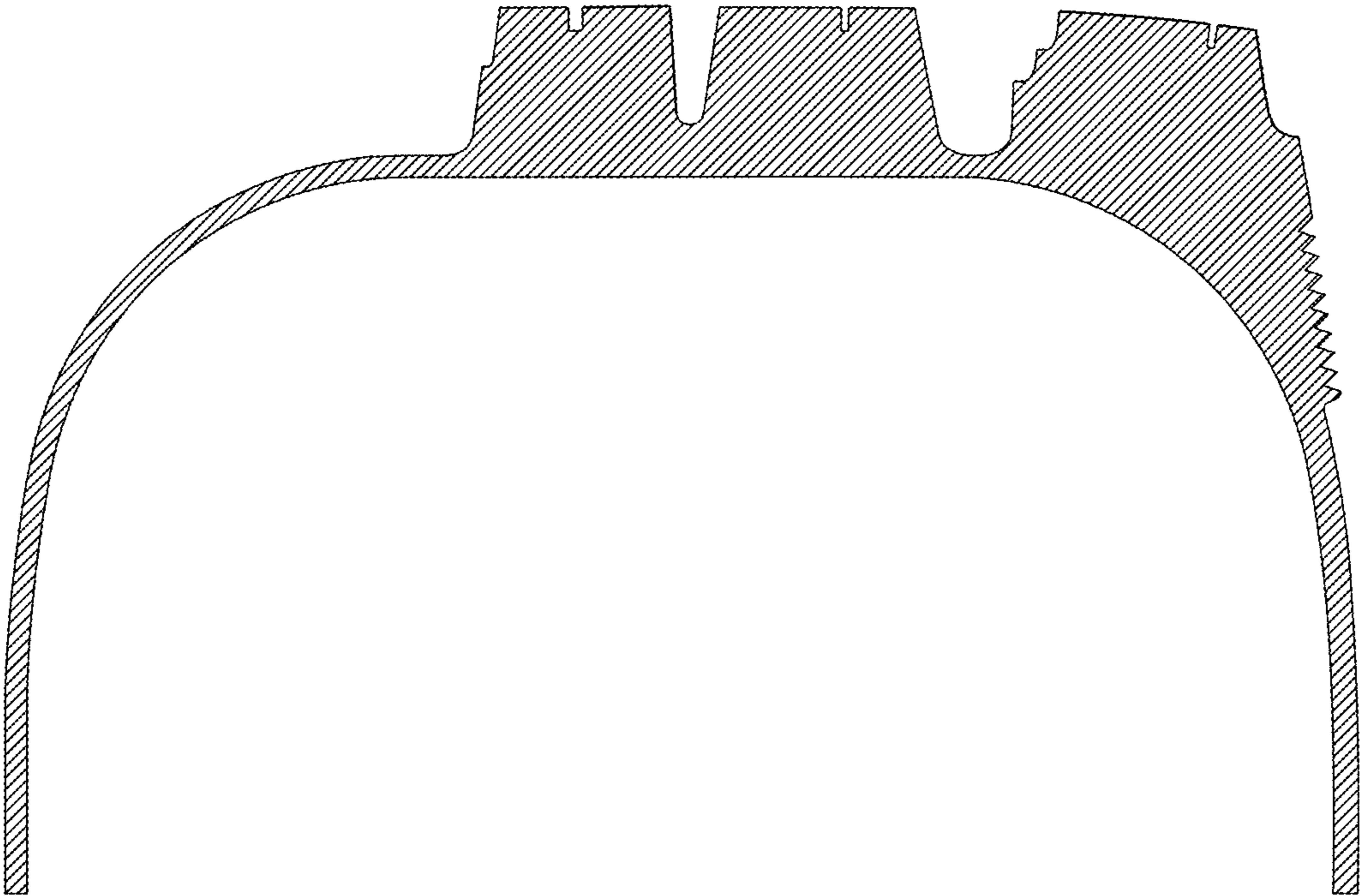
