DESCRIPTION

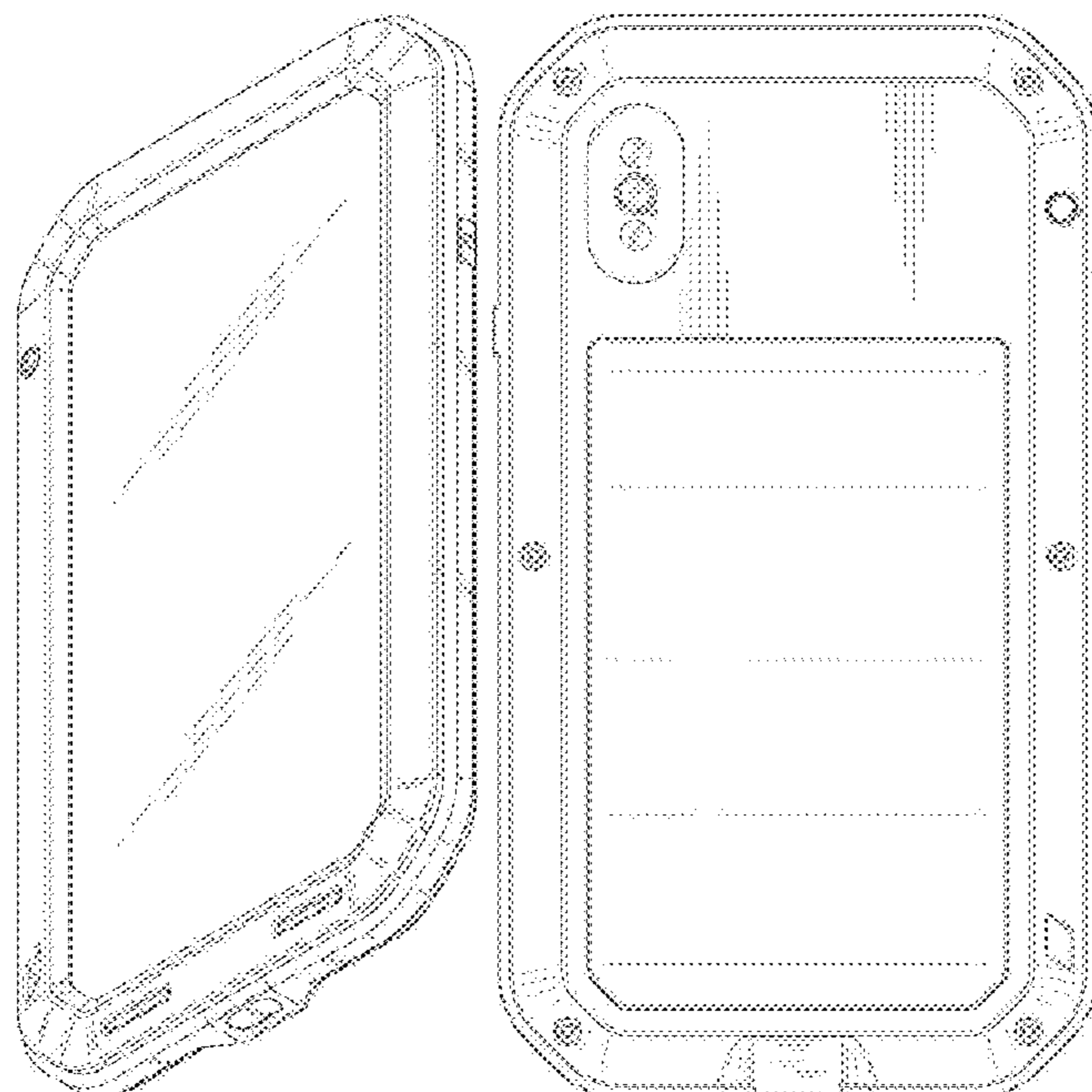
FIG. 1 is a perspective view of a phone case showing my new design;

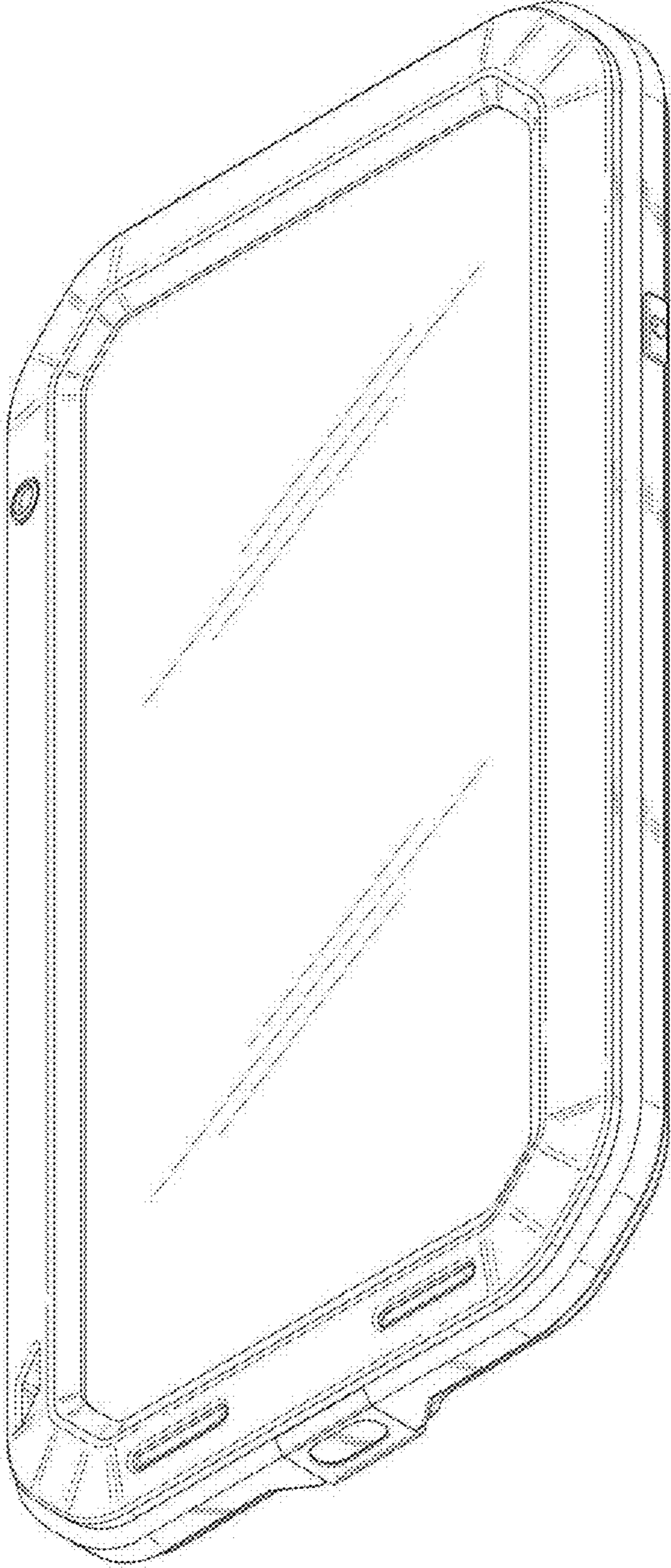

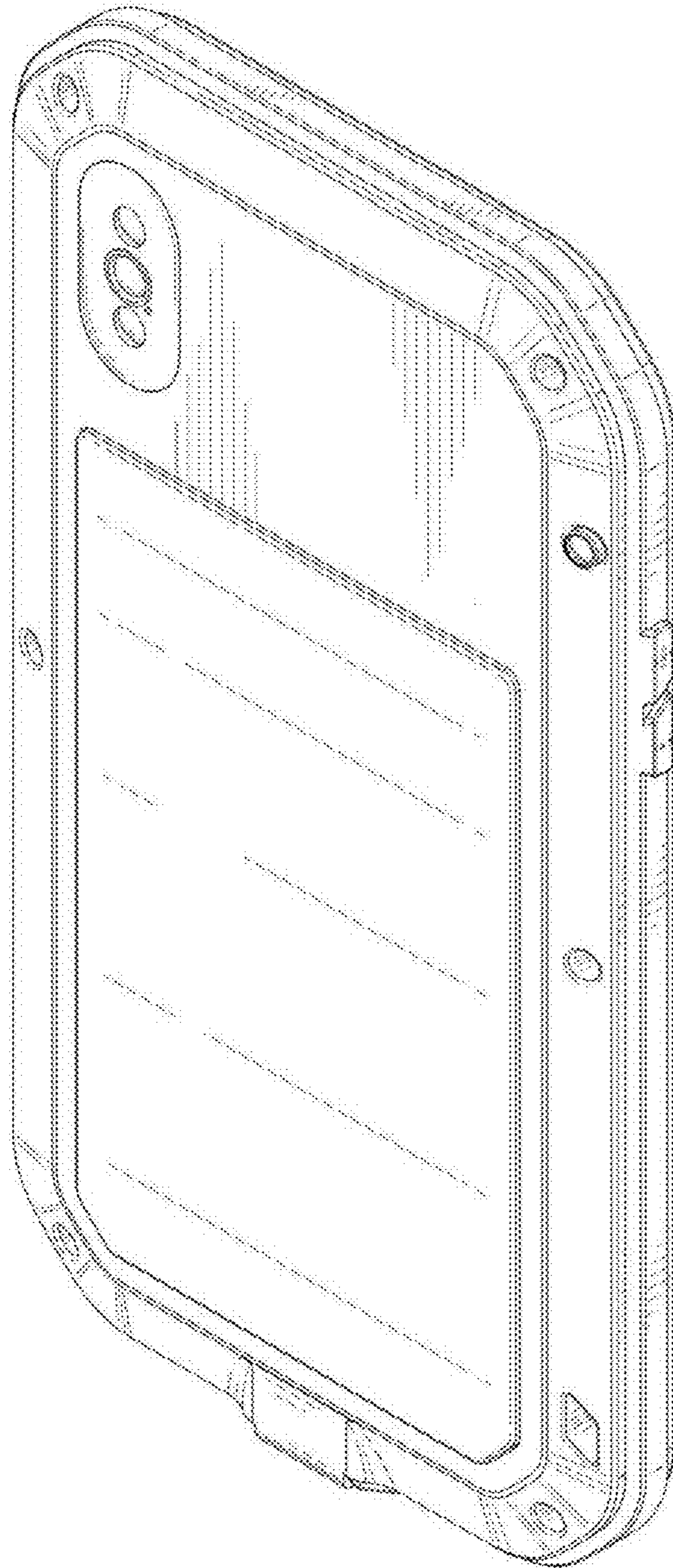

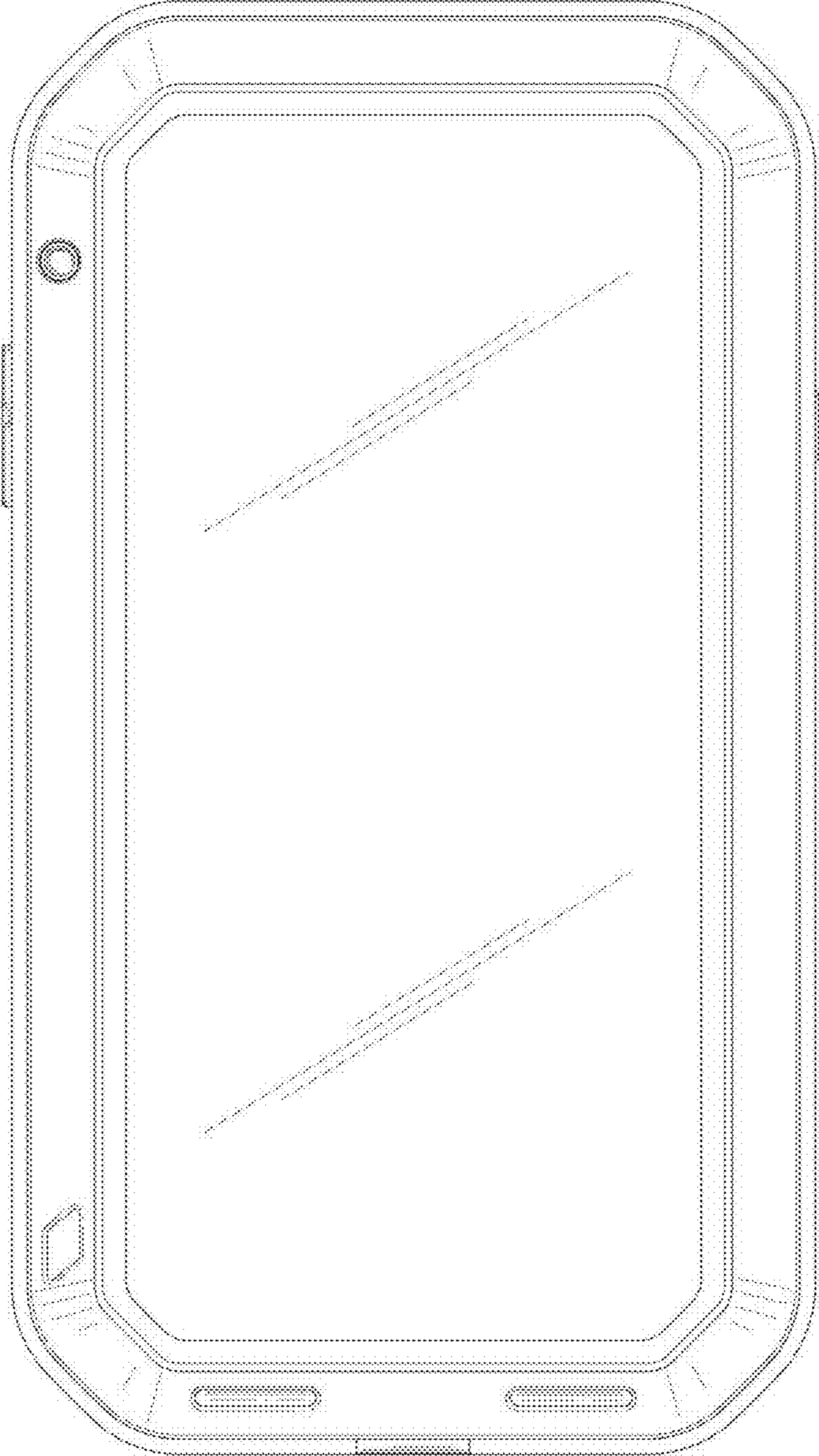

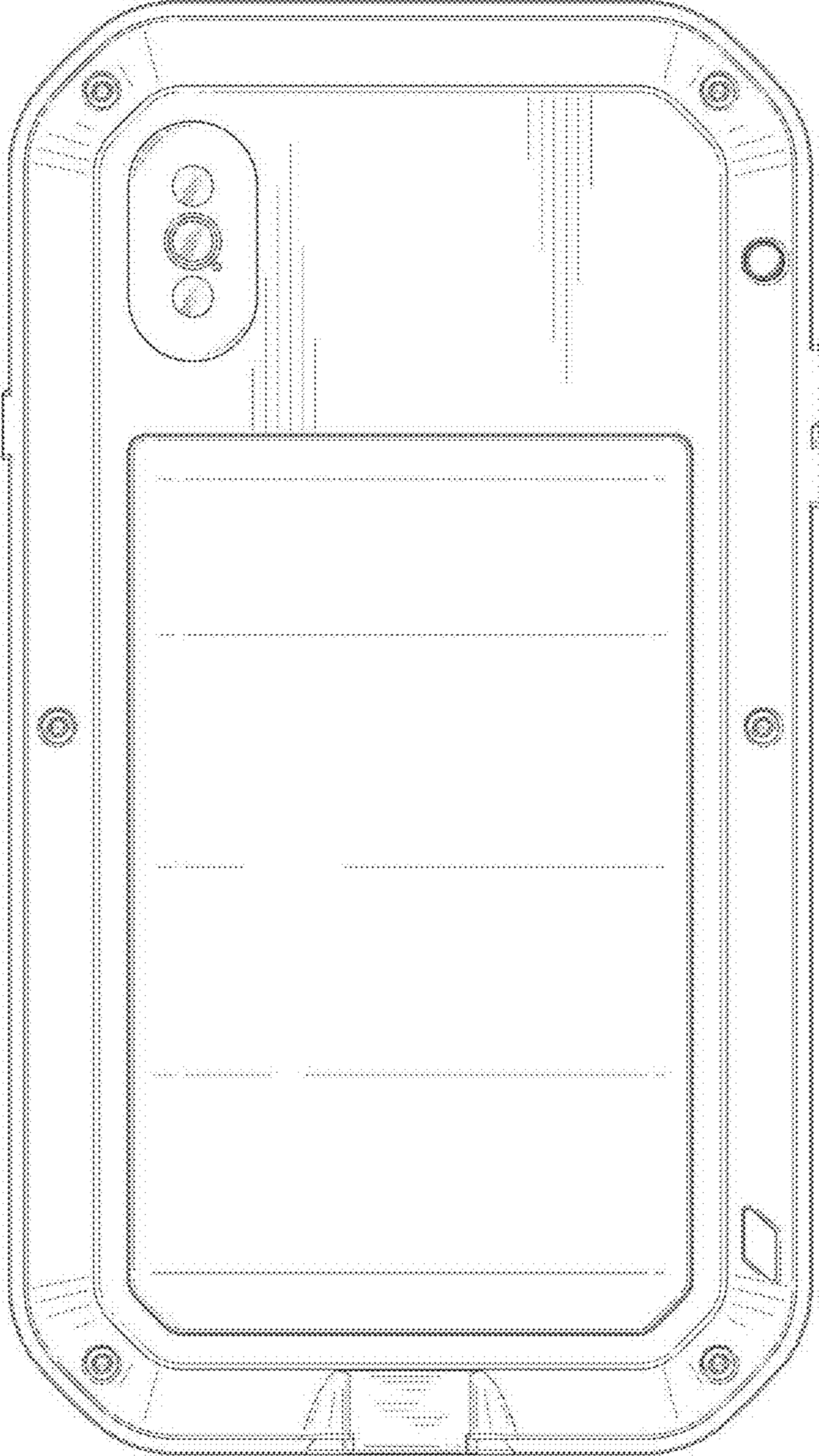

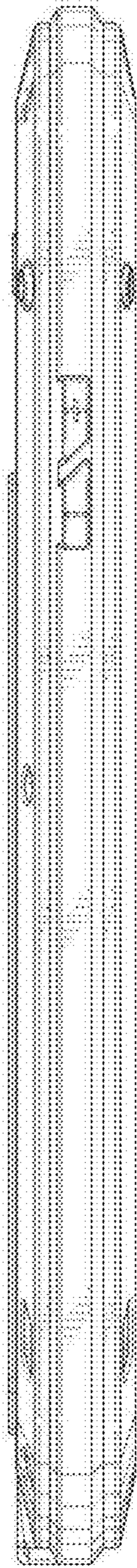

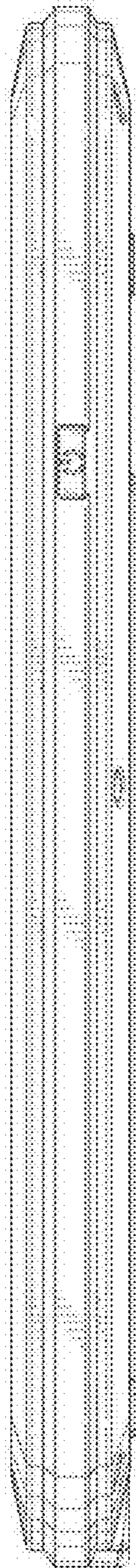

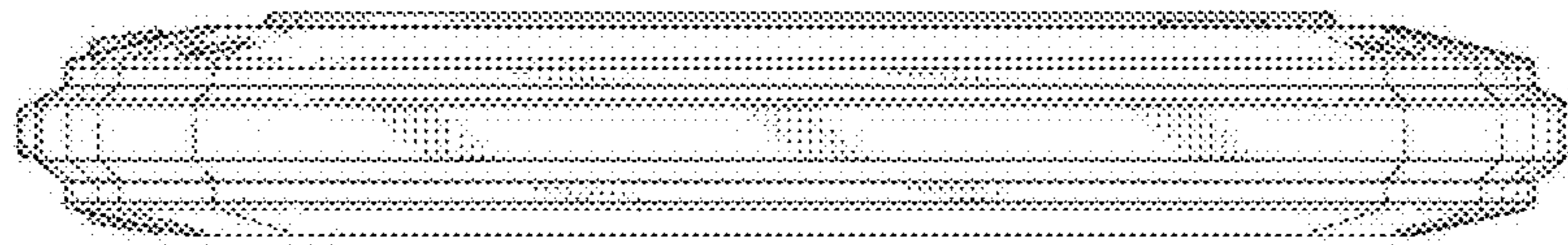

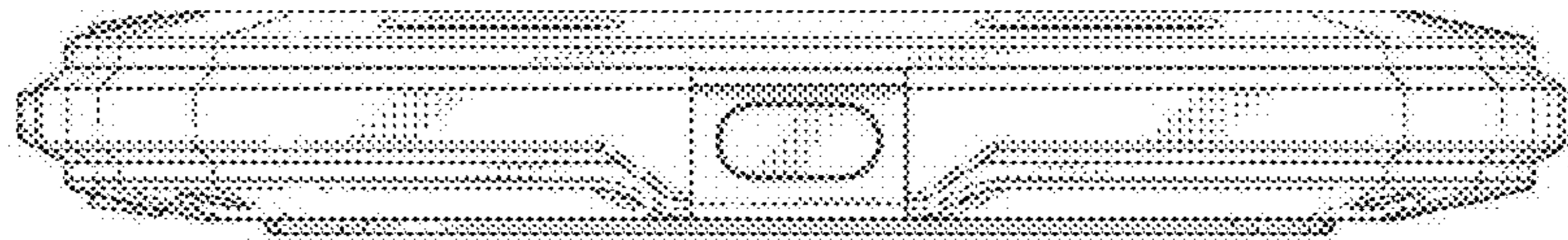
