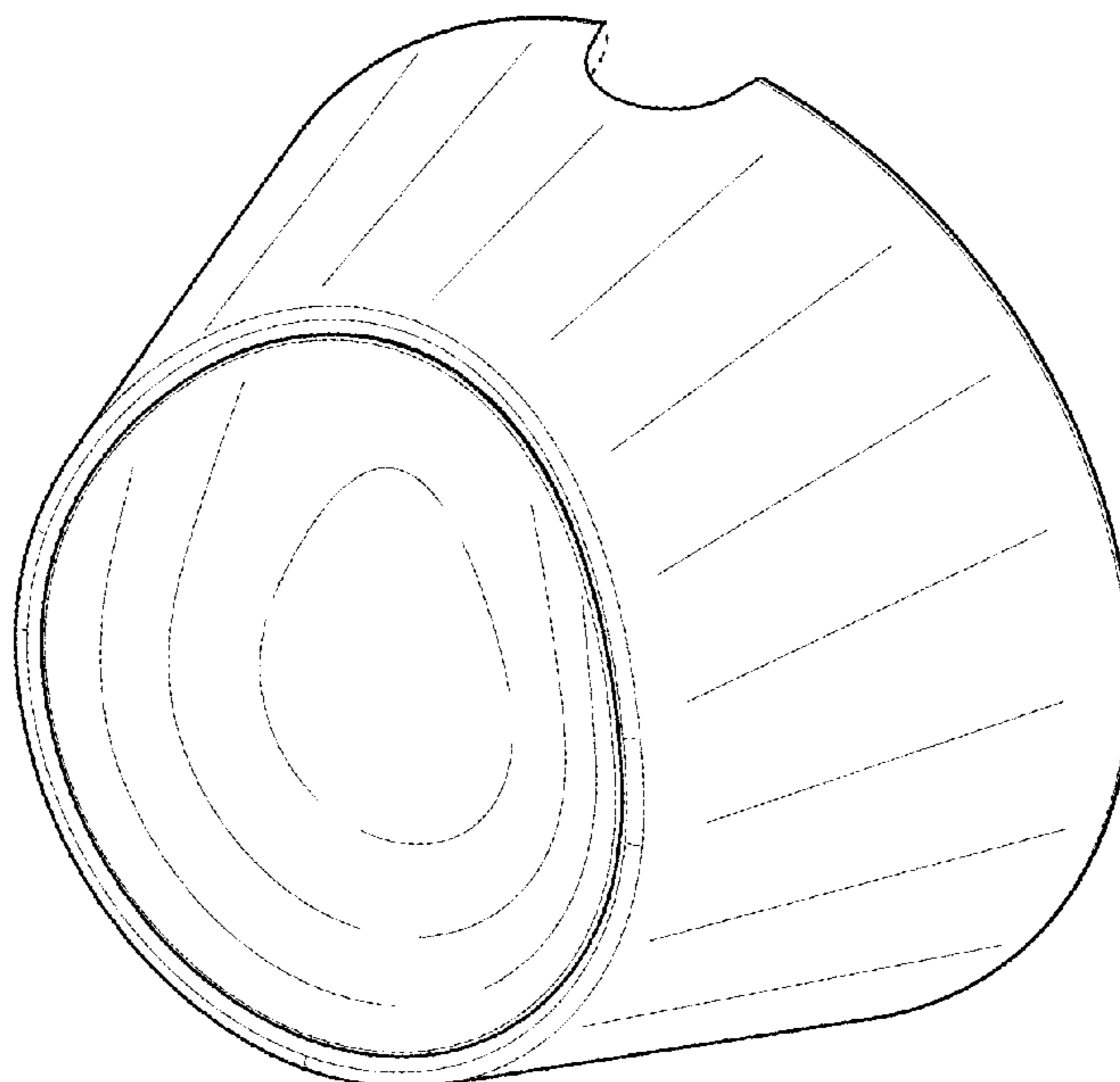

The ornamental design for an electronics device mount, as shown and described.

DESCRIPTION
FIG. 1 is a top, front, right side perspective view of an electronics device mount showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right-side elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

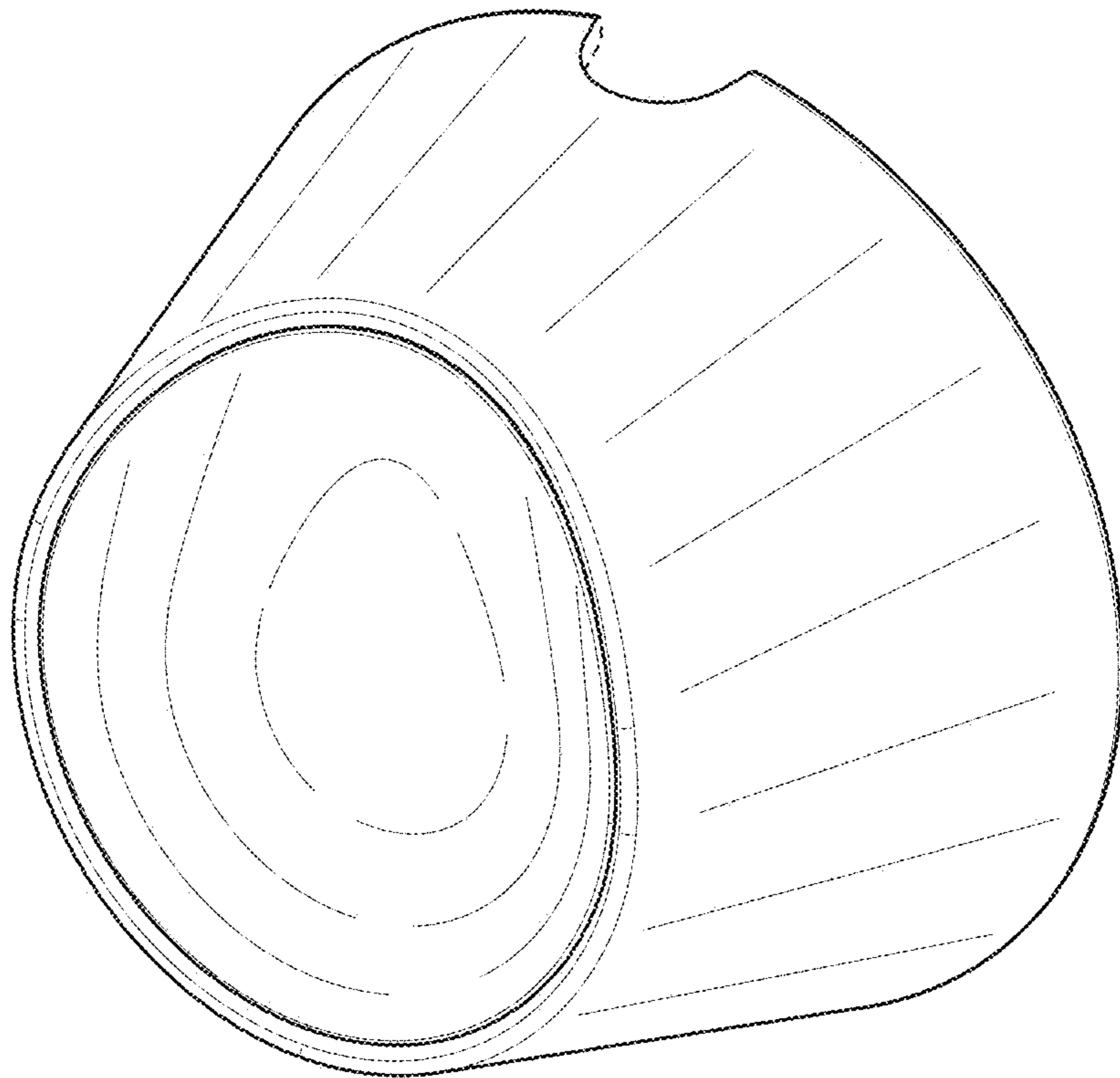

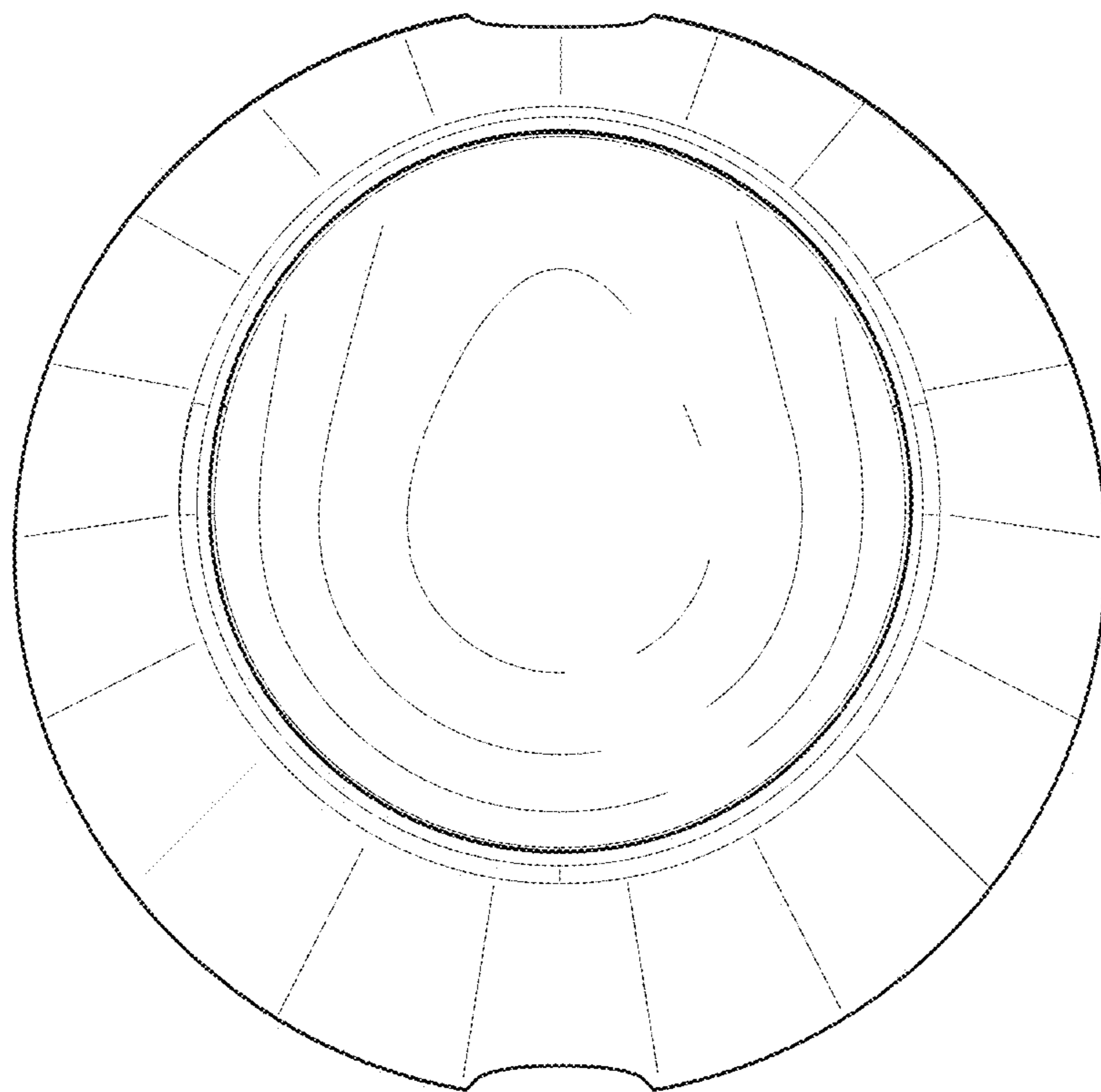

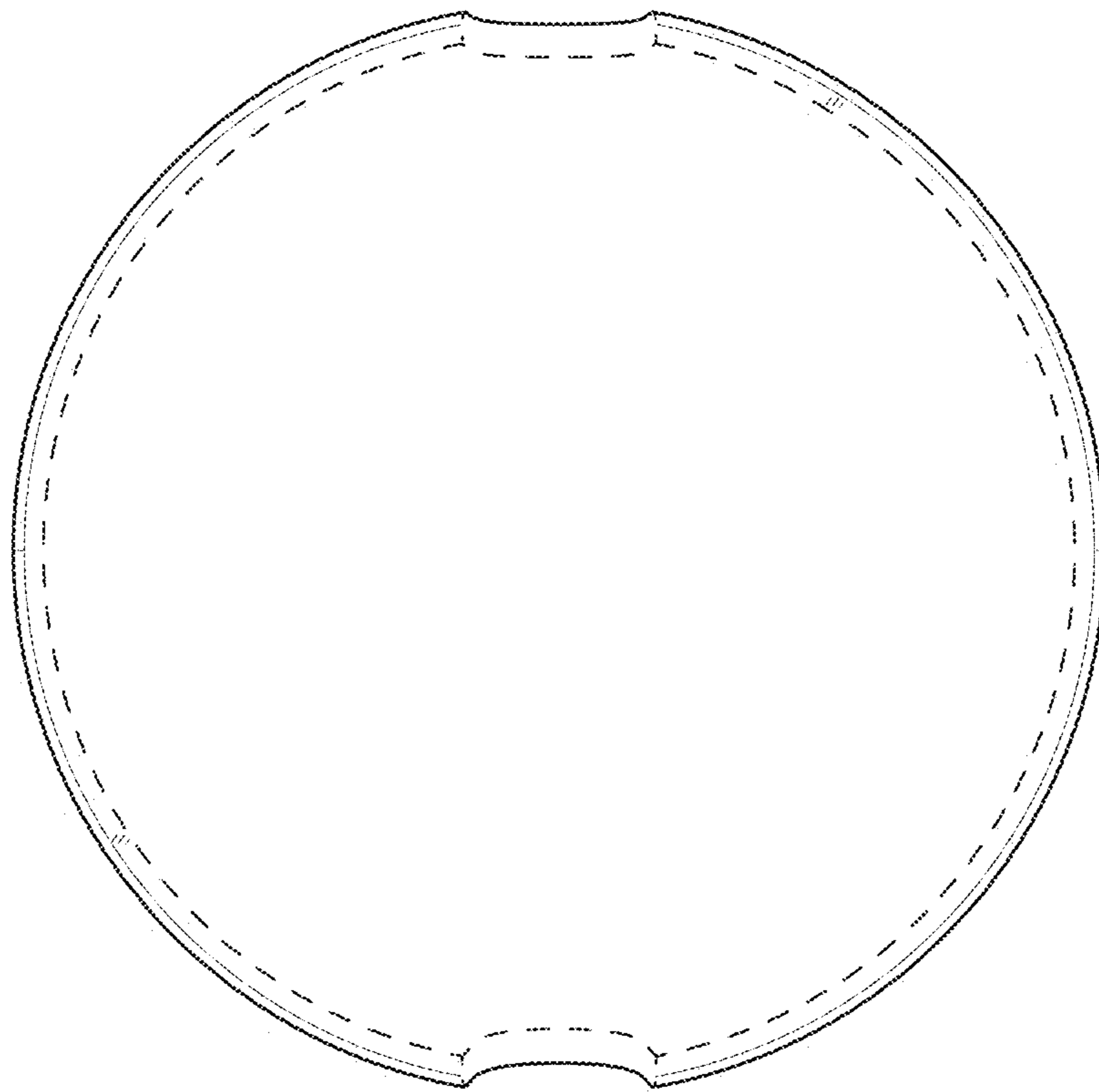

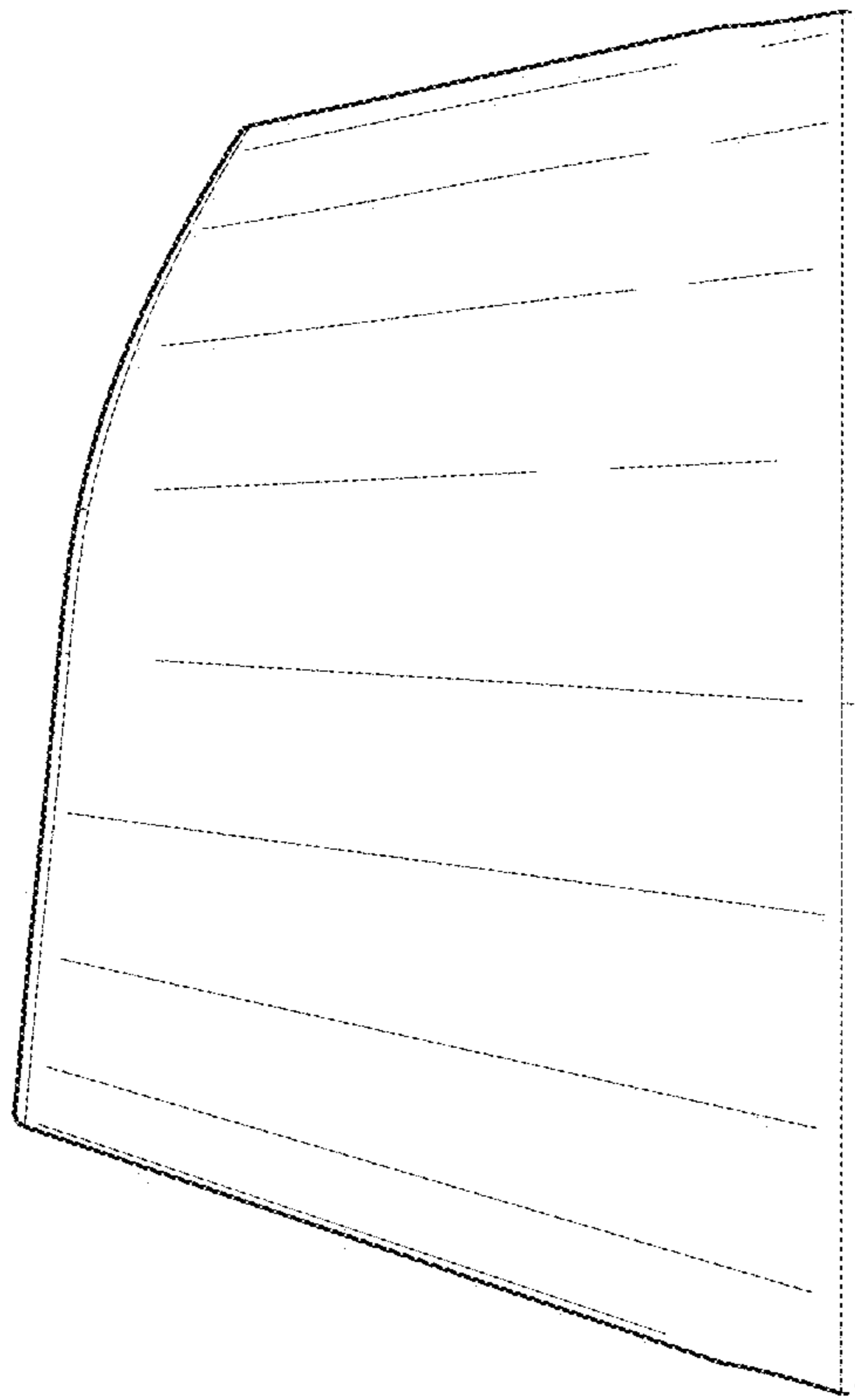

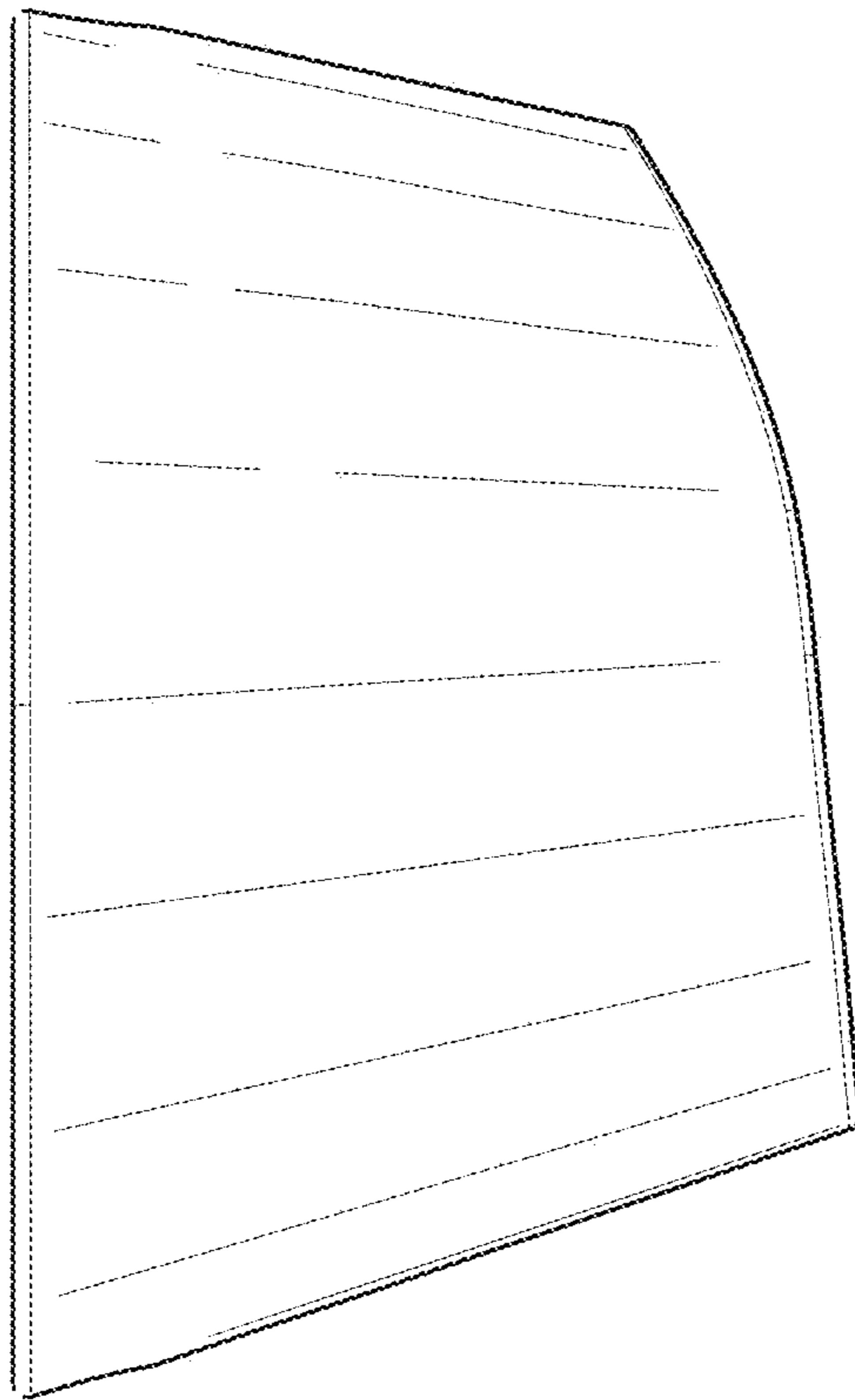

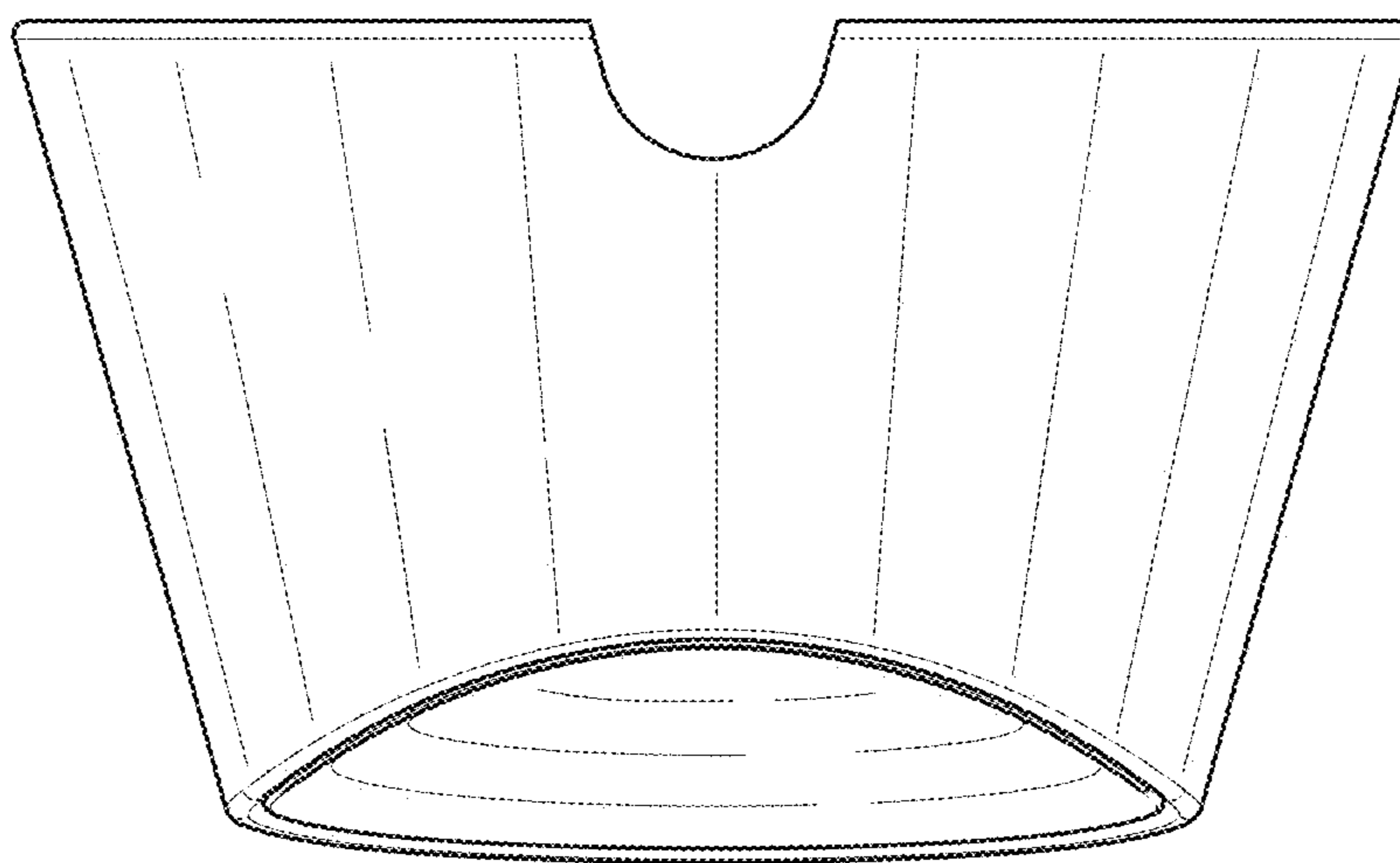

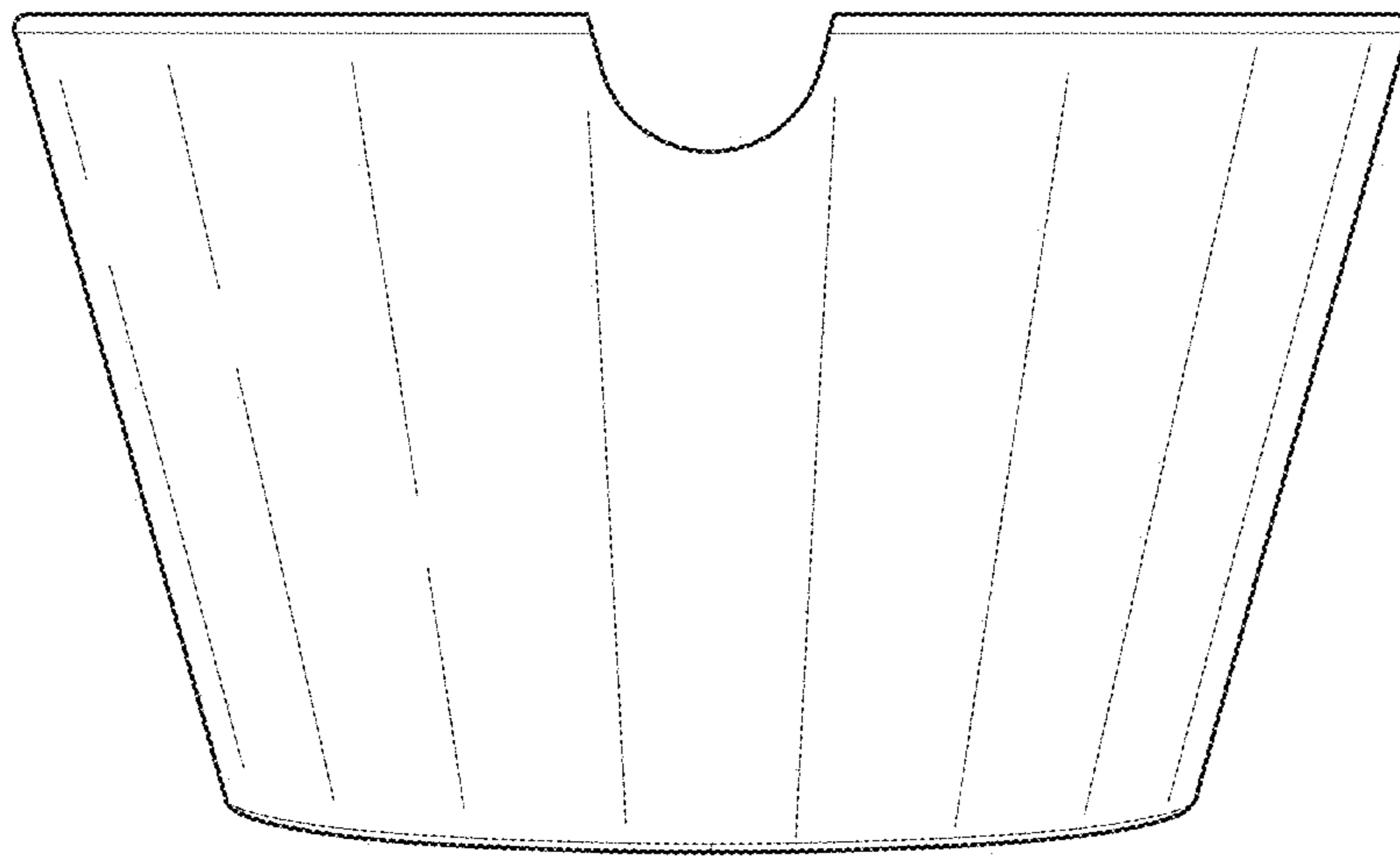
