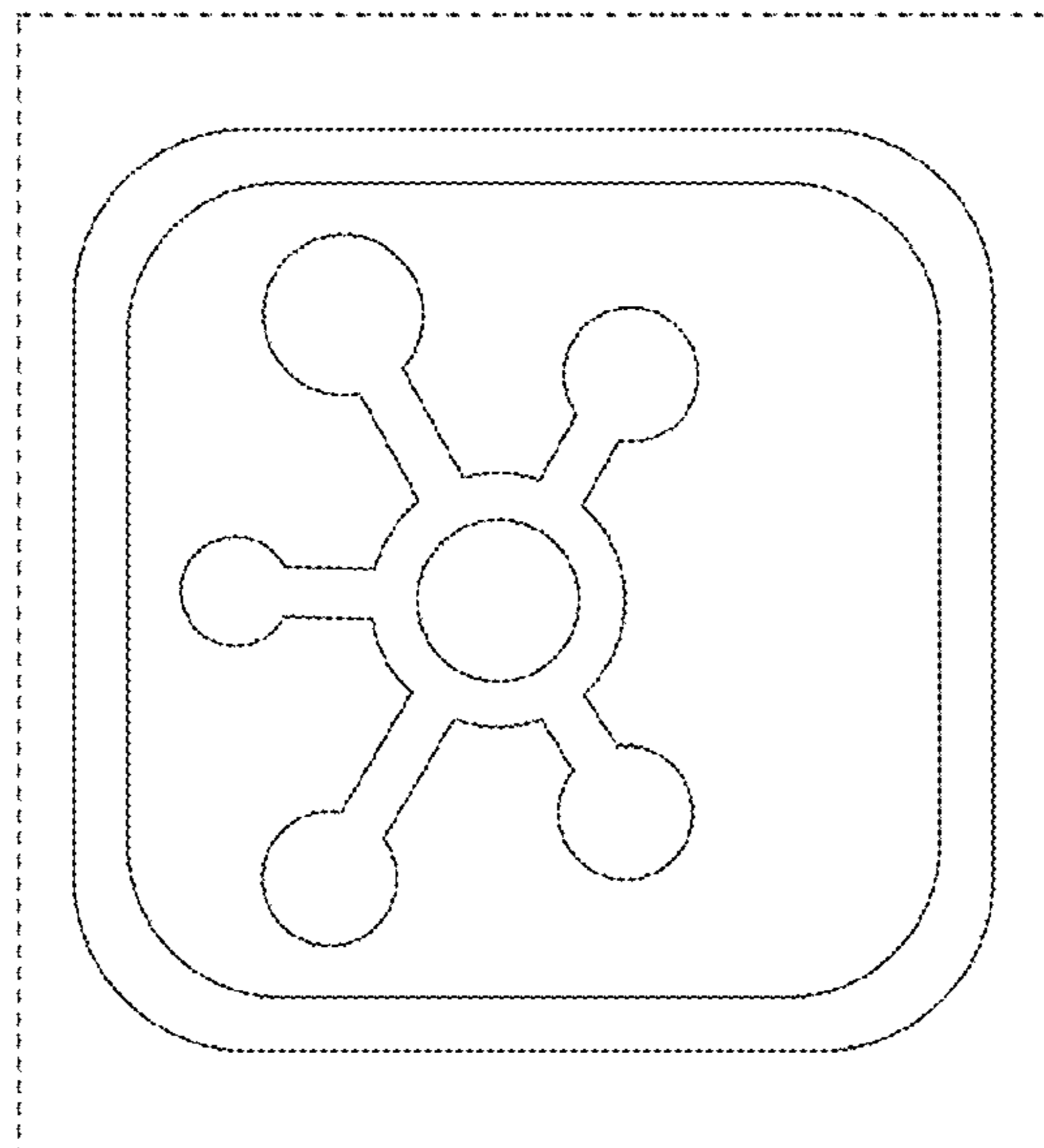
The ornamental design for the display panel portion with a connect app icon, as shown and described.
