The ornamental design for a type font, as shown and described.

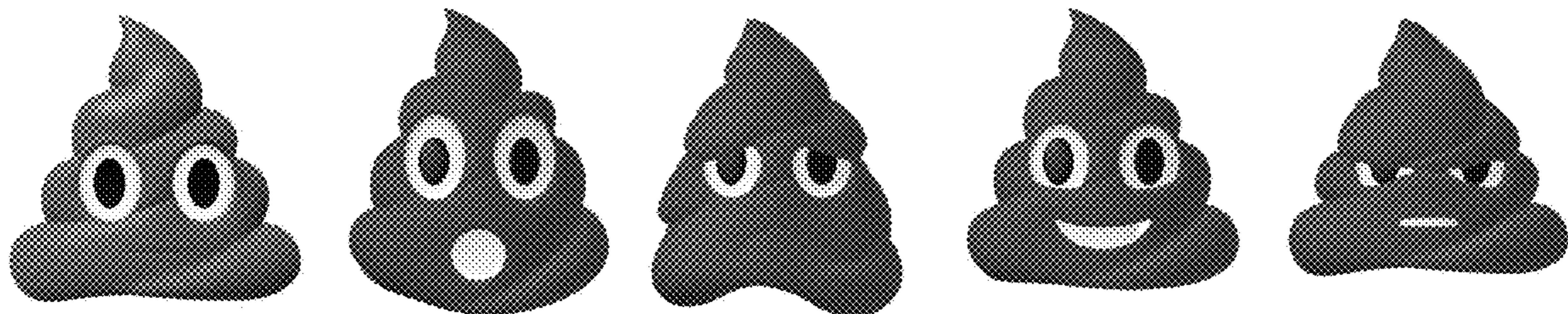
DESCRIPTION

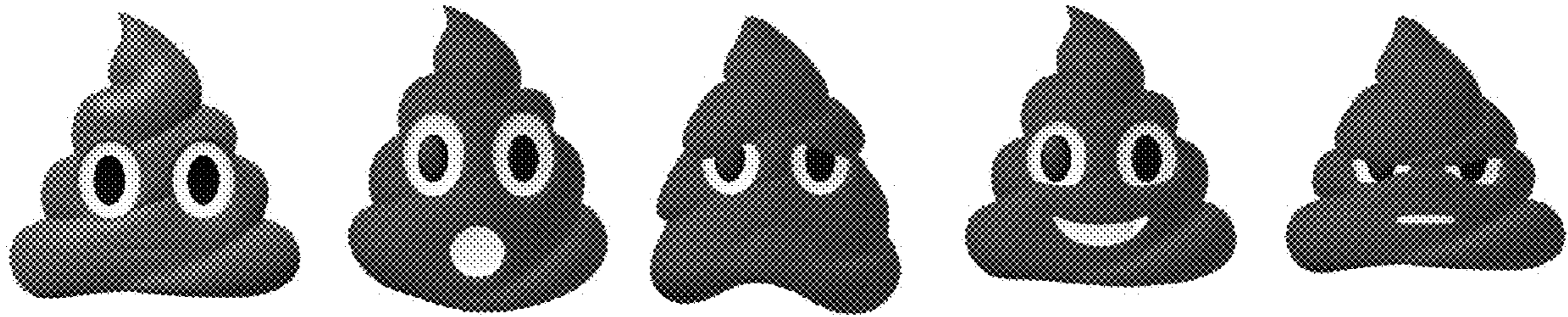

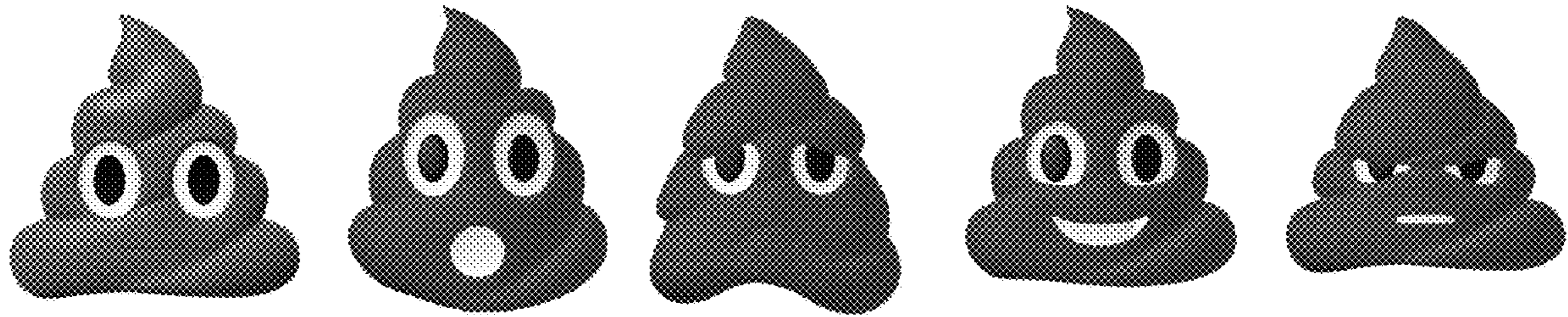
