**DESCRIPTION**

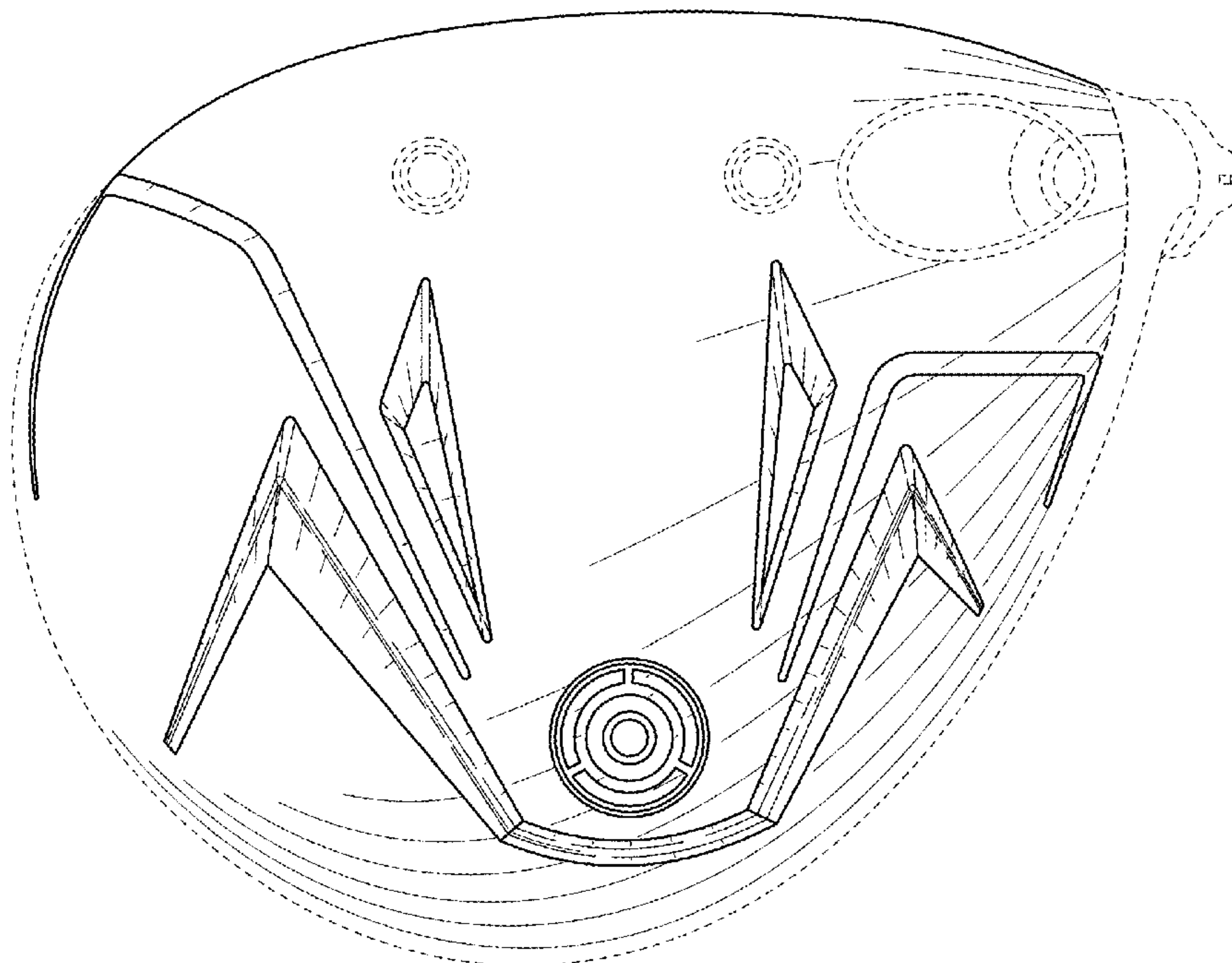
FIG. 1 is a rear perspective view of the golf club head claimed herein;

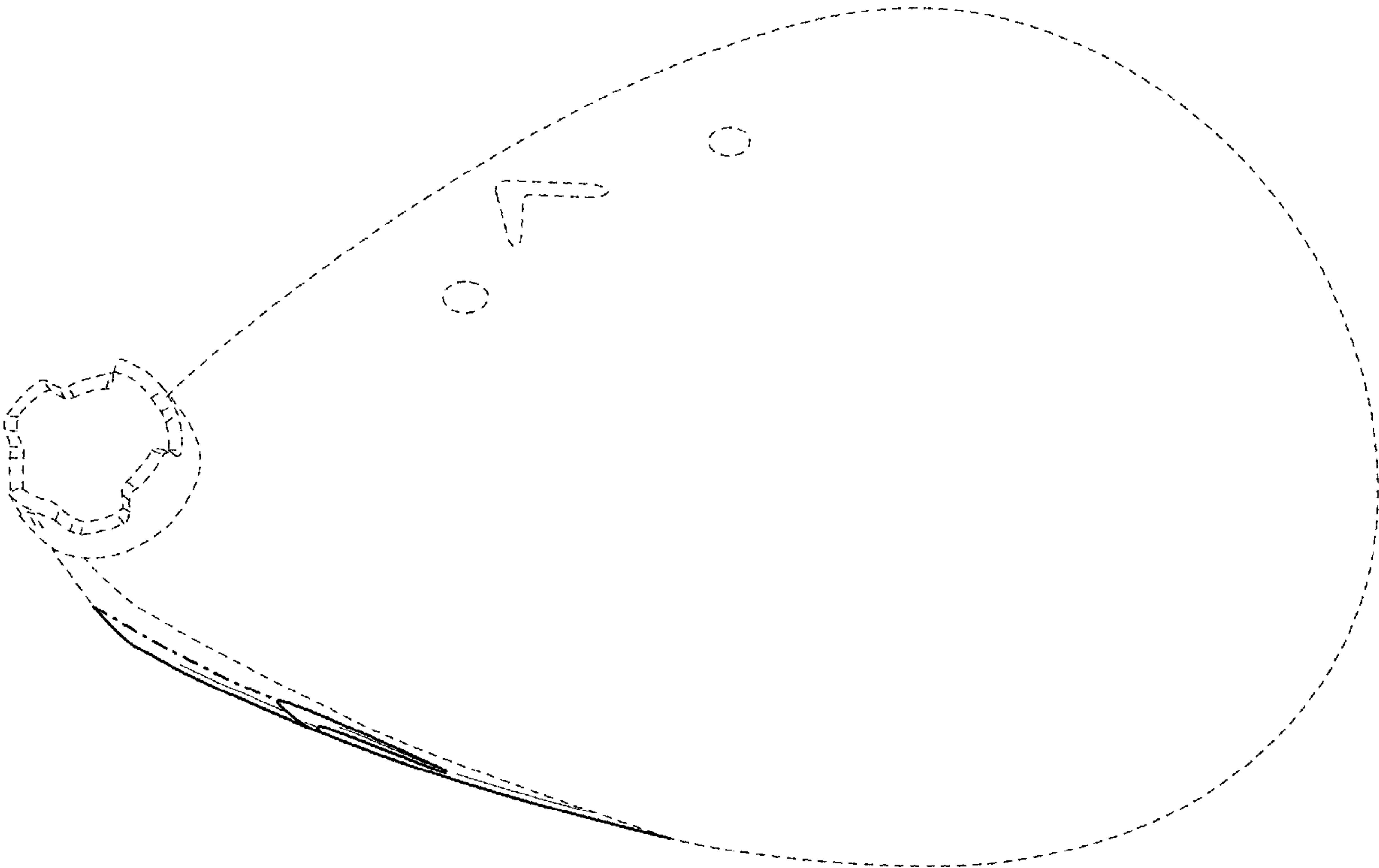

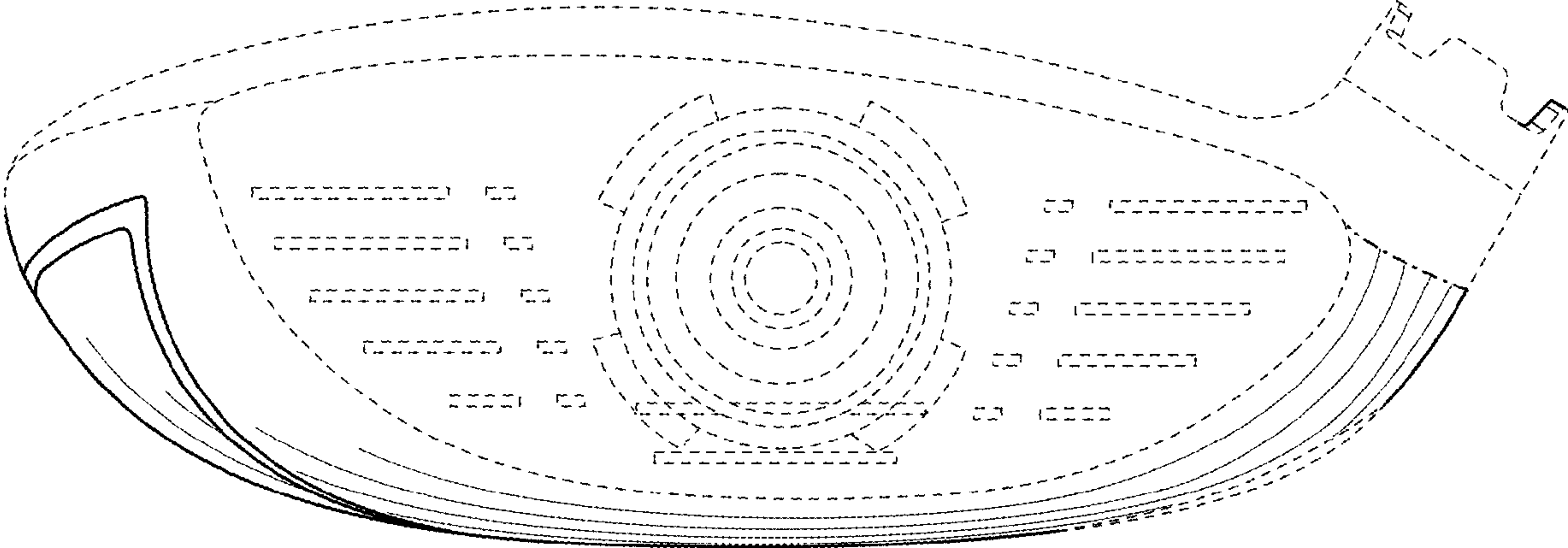

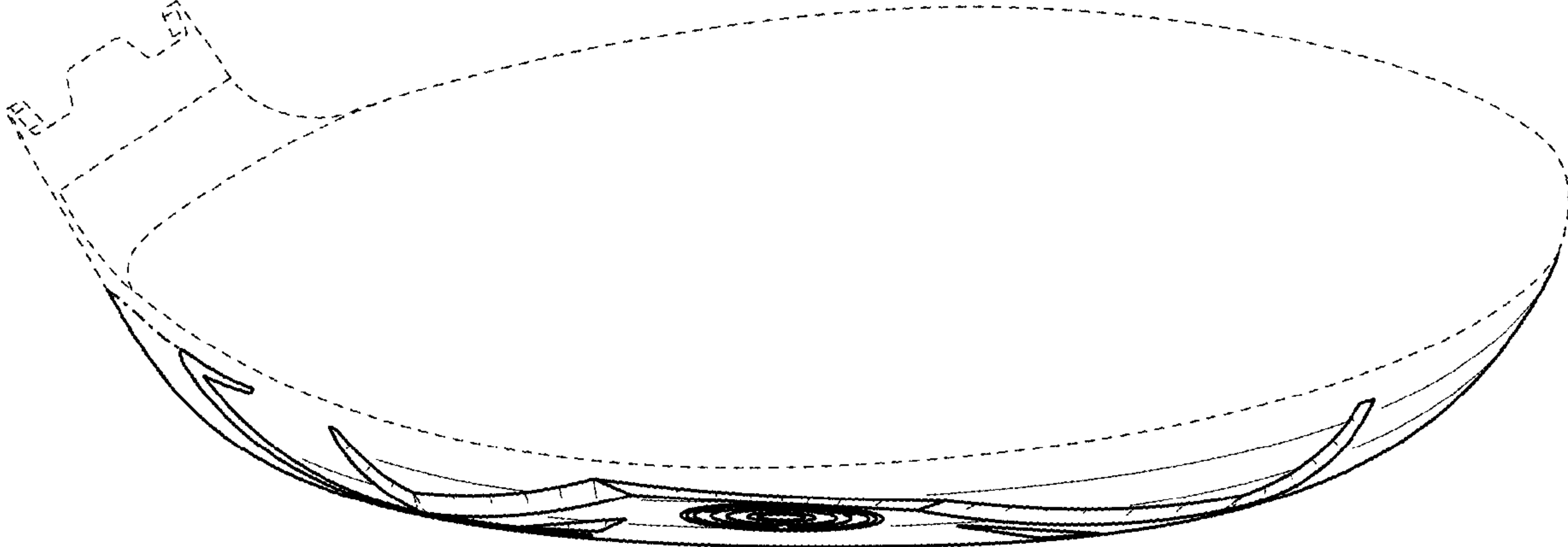

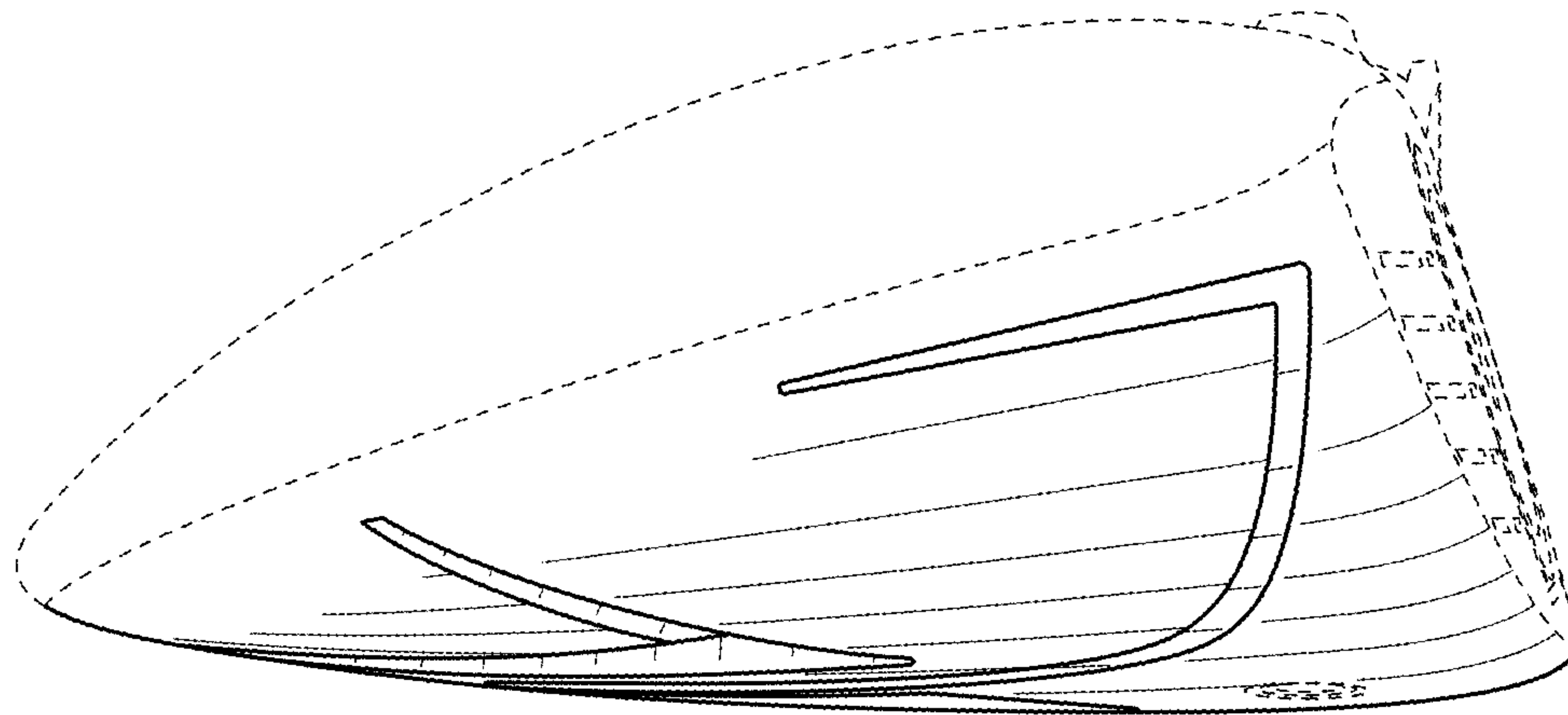

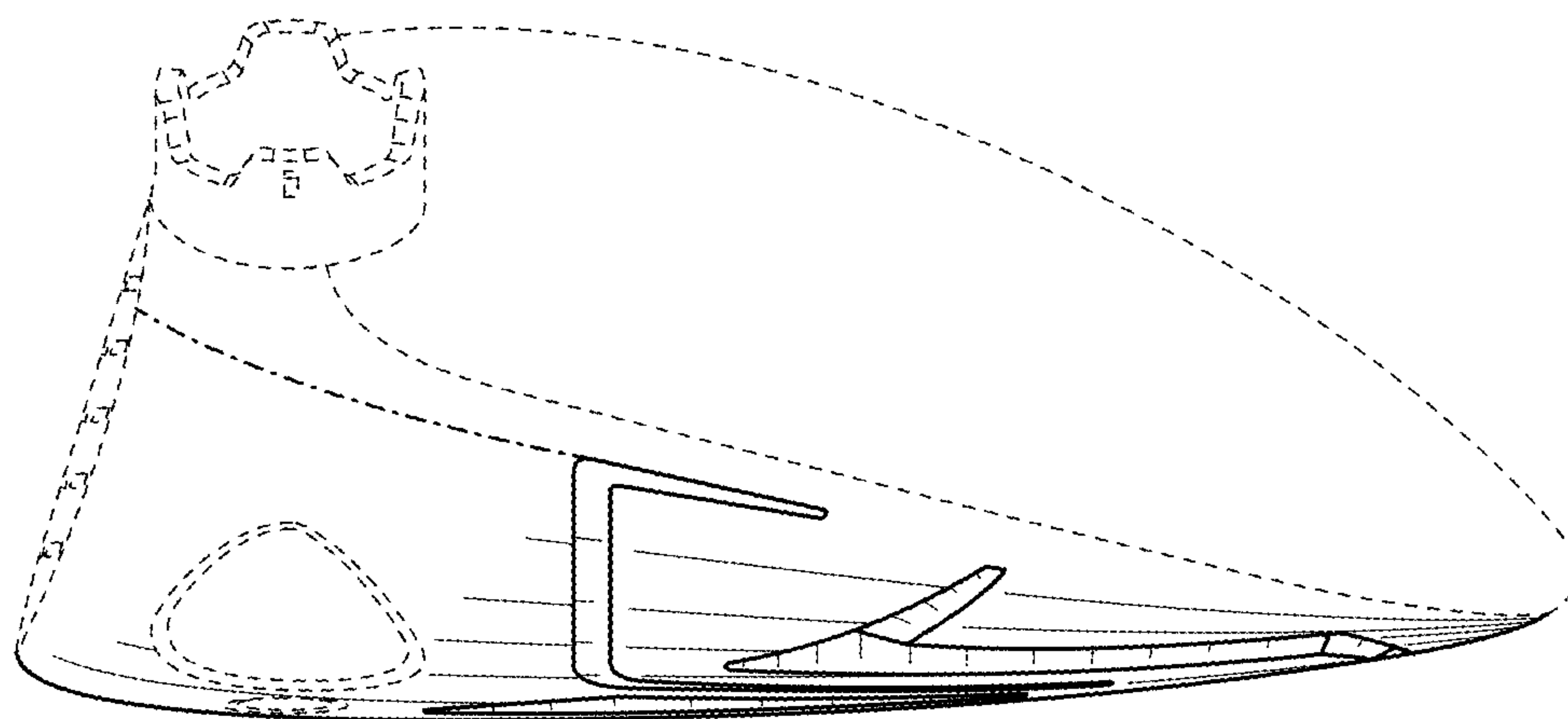

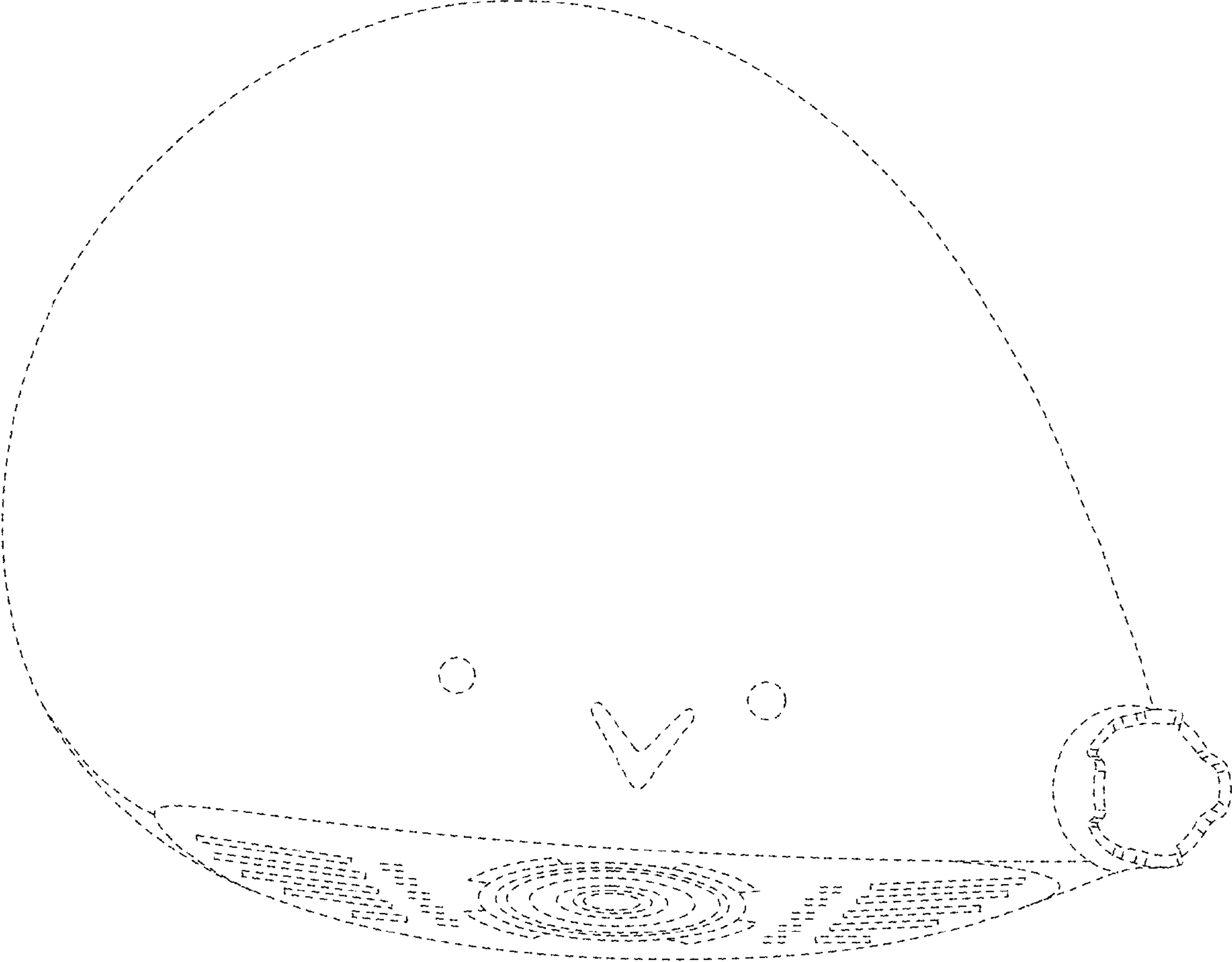

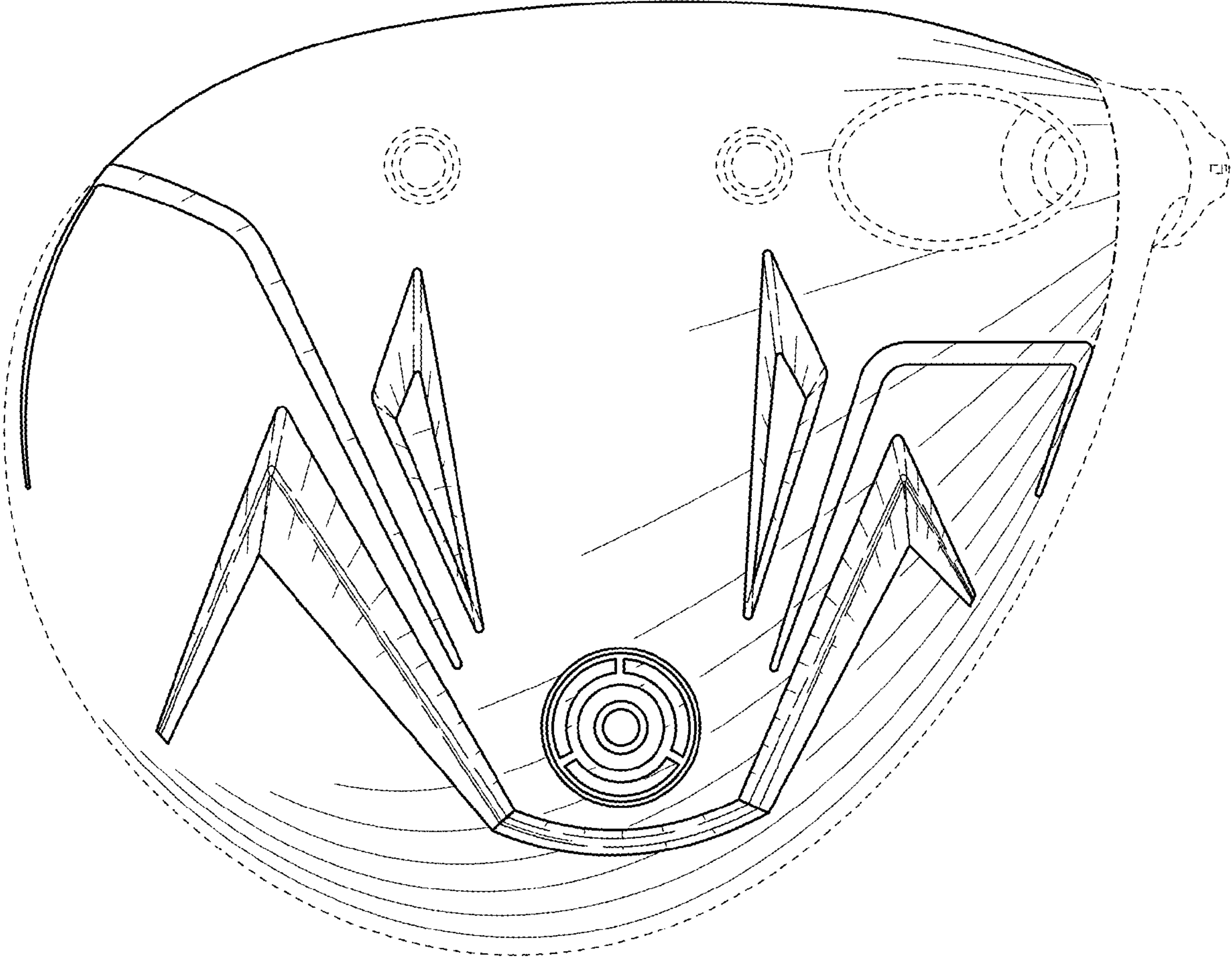
