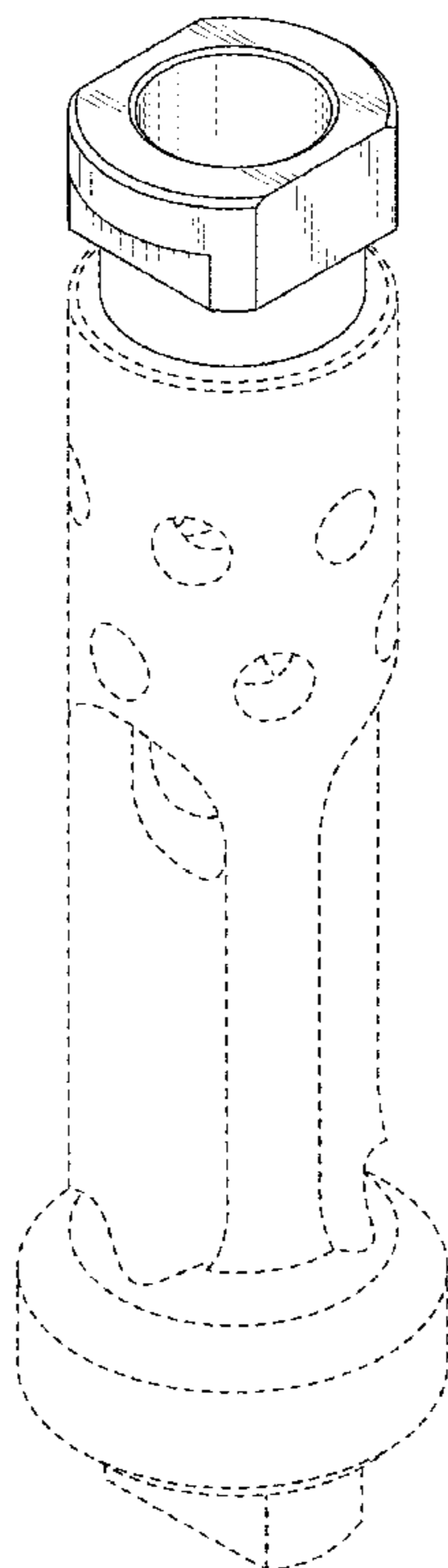
(57) **CLAIM**

The ornamental design for a discharge valve assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a discharge valve assembly showing my new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines shown in the figures are included for the purpose of illustrating environment and form no part of the claimed design.

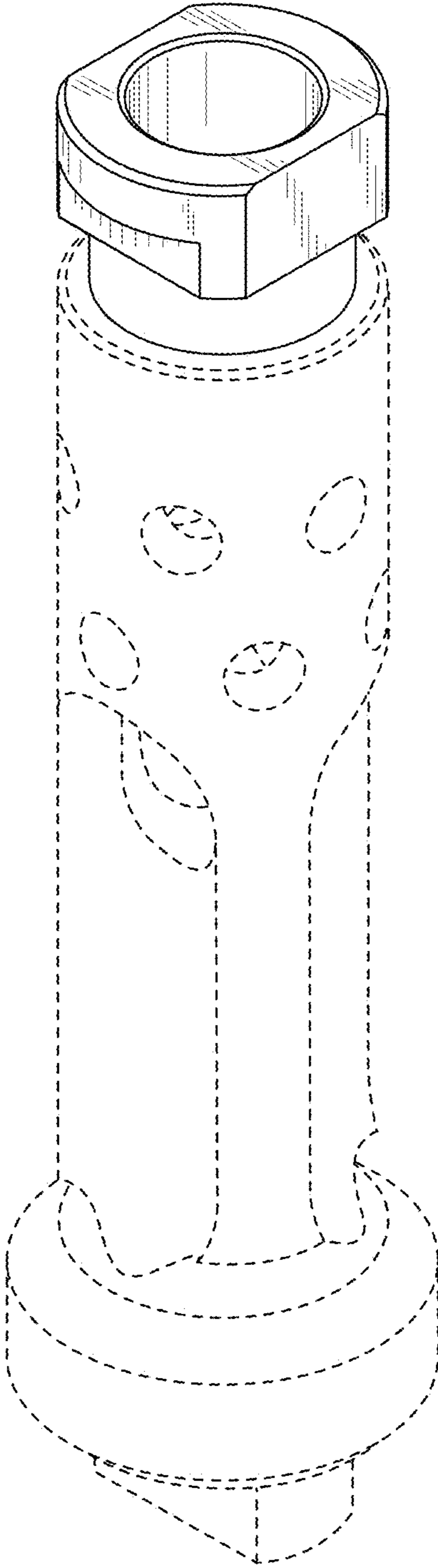

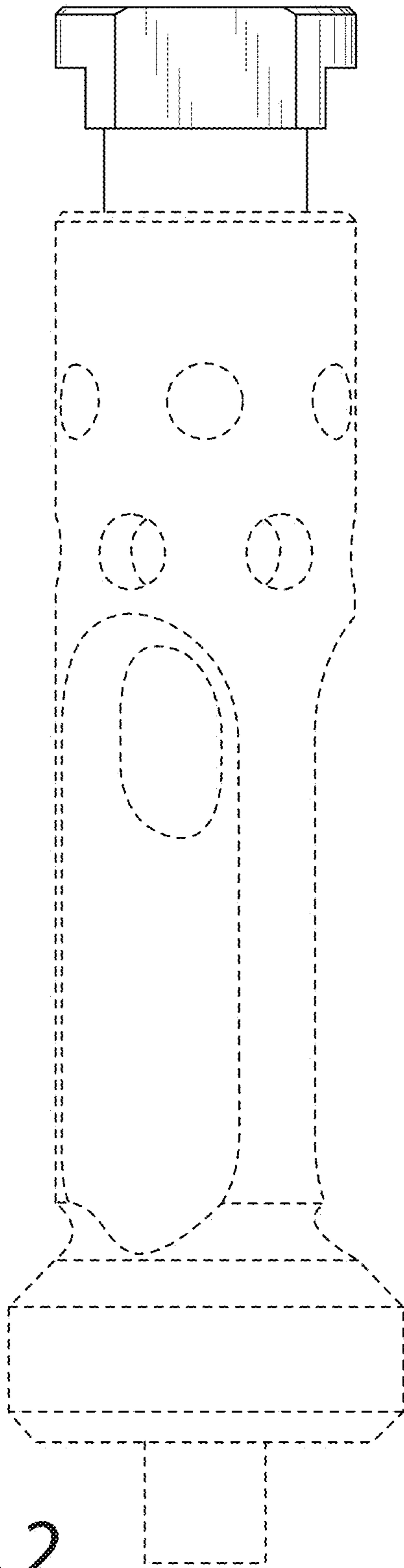

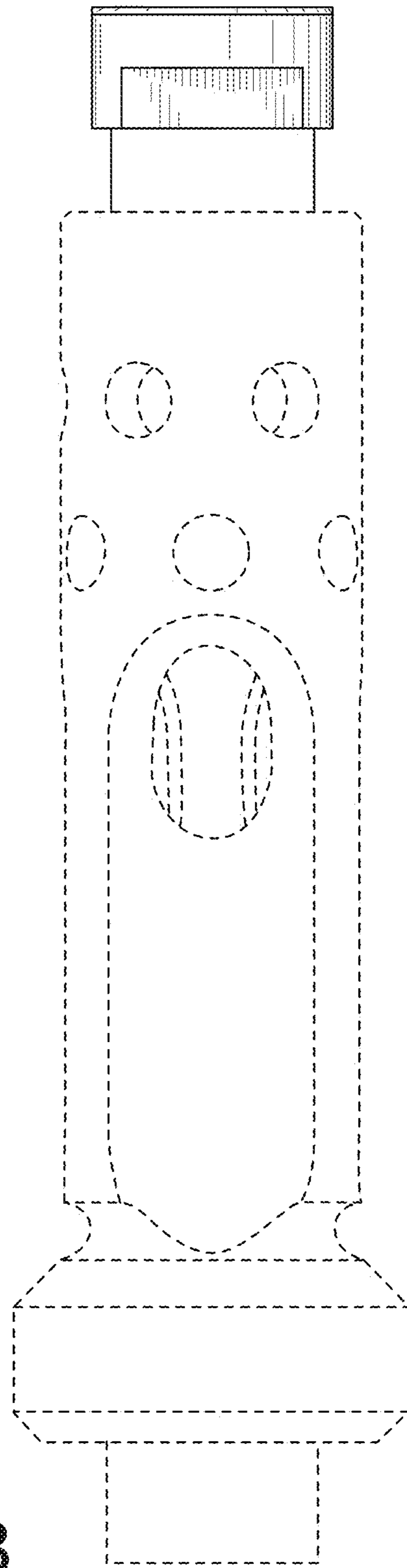

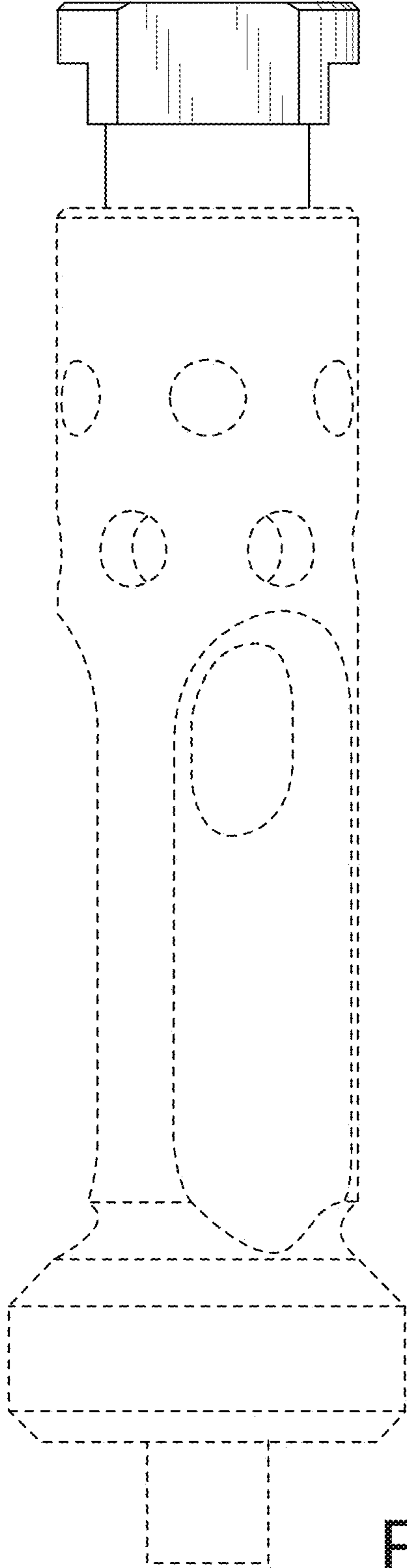

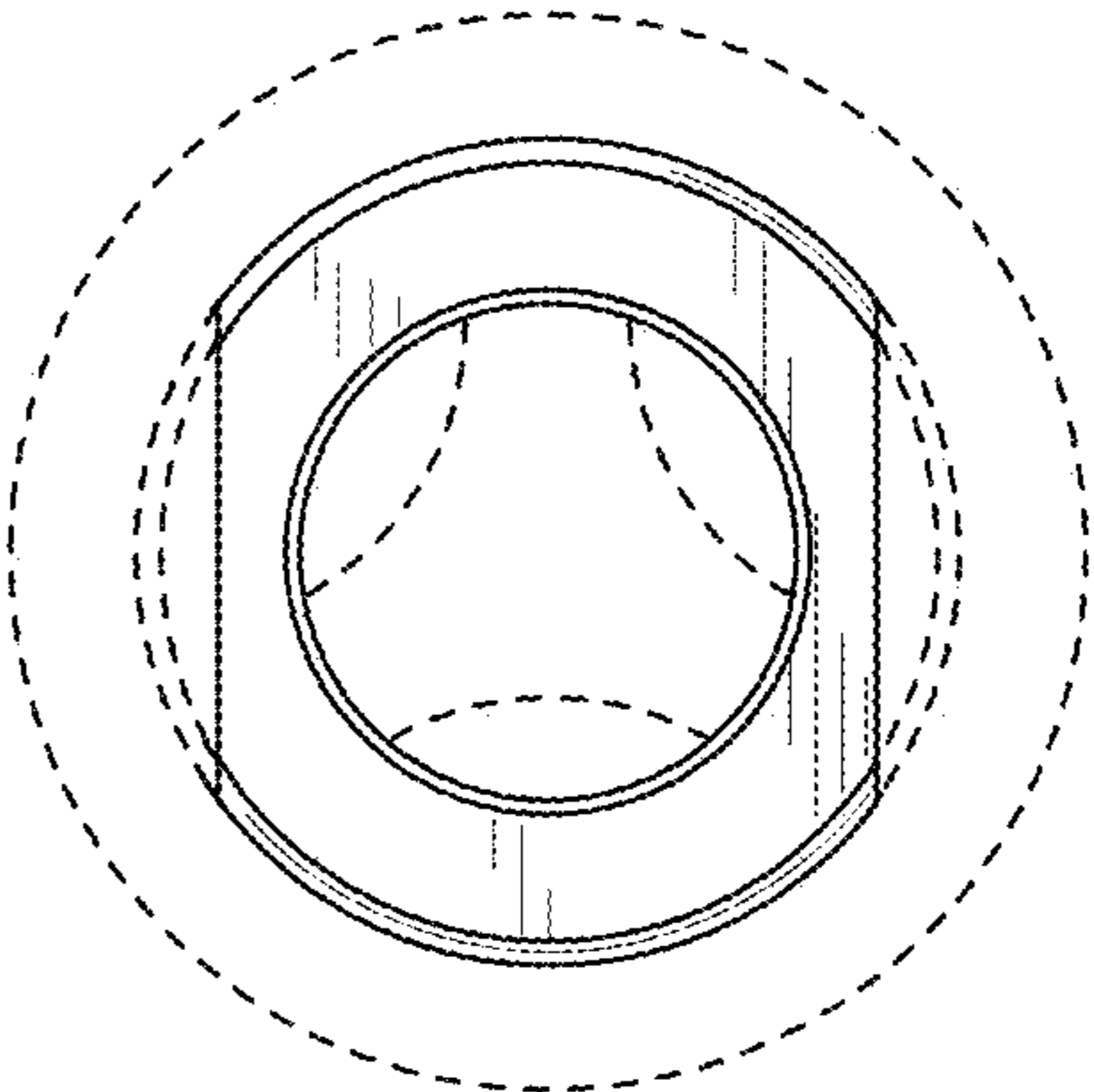

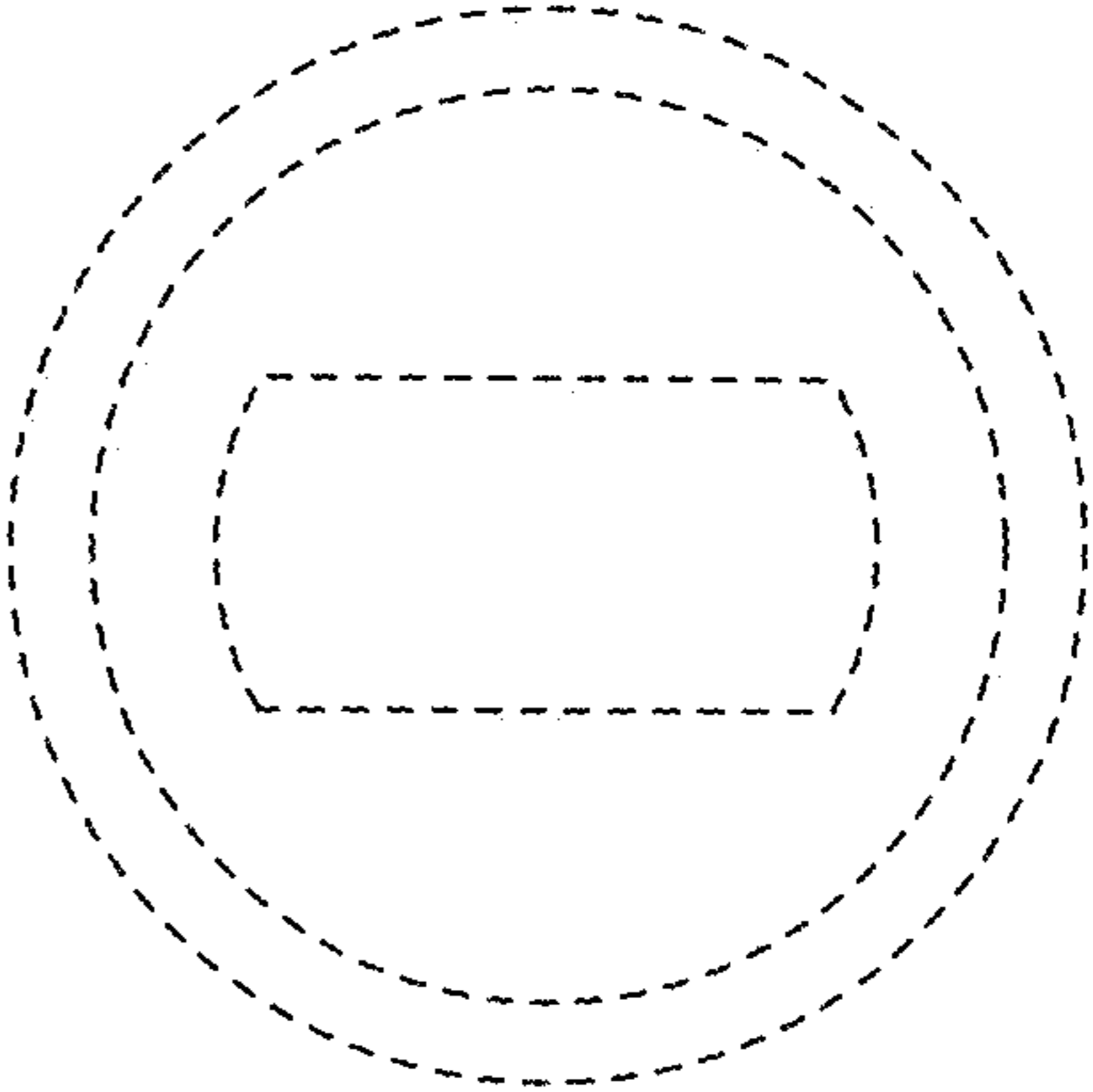
