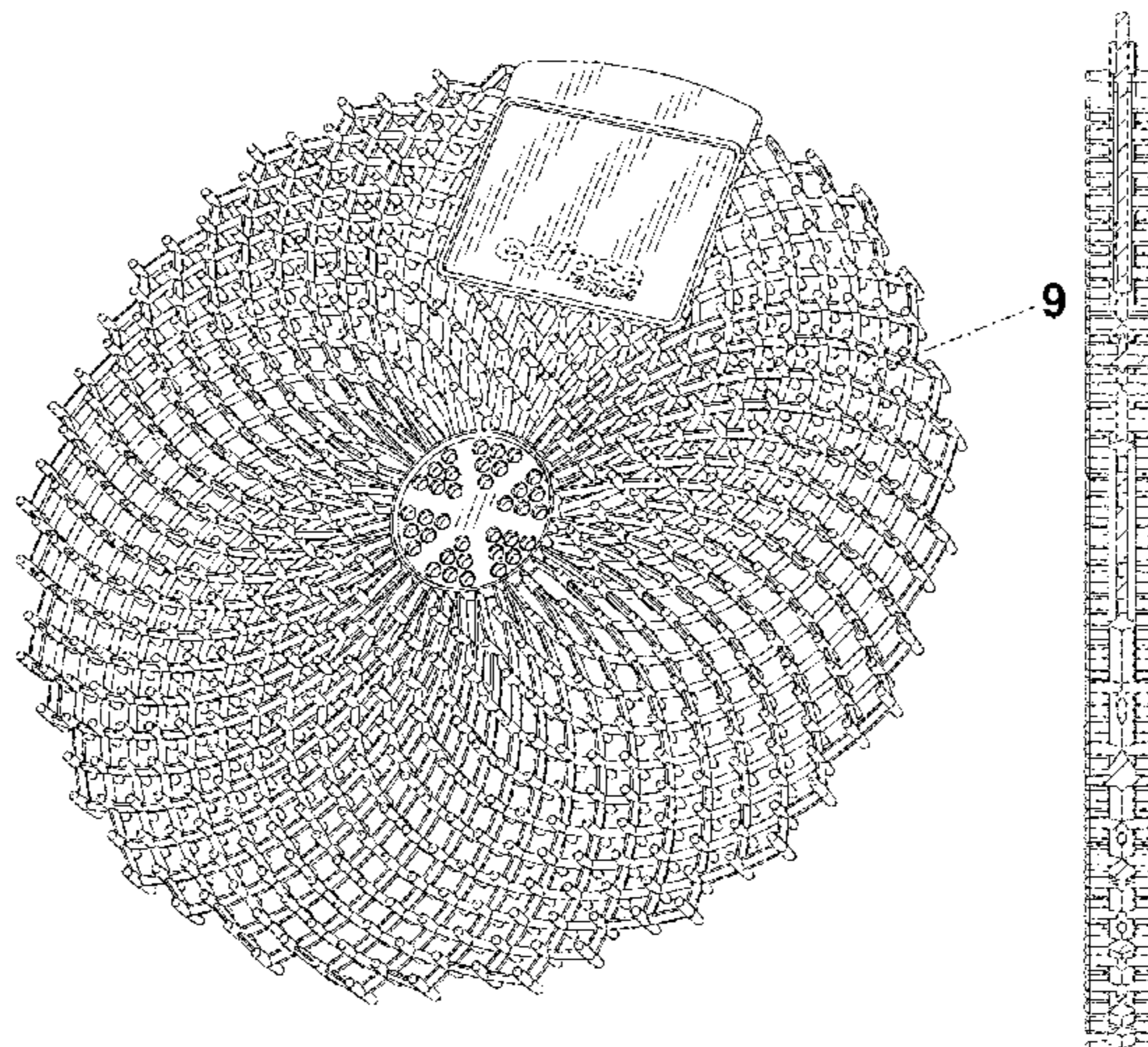
(57) **CLAIM**

The ornamental design for a urinal screen, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a urinal screen showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a side cross-sectional view as taken through section lines 3-3 of FIG. 2;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a left-side elevational view thereof;
FIG. 7 is a rear elevational view thereof;
FIG. 8 is a front elevational view thereof;
FIG. 9 is an enlarged fragmentary top perspective view of a portion of the urinal screen taken in circle 9 of FIG. 1 and illustrating the presence of ribs having both a diamond-shaped cross-section and a circular-shaped cross-section;
FIG. 10 is an enlarged cross-sectional view taken through section lines 10-10 of FIG. 9 illustrating a shape of each of the ribs having the diamond-shaped cross-section; and,
FIG. 11 is an enlarged cross-sectional view taken through section lines 11-11 of FIG. 9 illustrating a shape of each of the ribs having the circular-shaped cross-section.
The broken lines shown in the drawings depict portions of the urinal screen that form no part of the claim.
The dot dash broken lines indicate cutoff boundaries for enlarged detailed portion views and form no part of the claim.

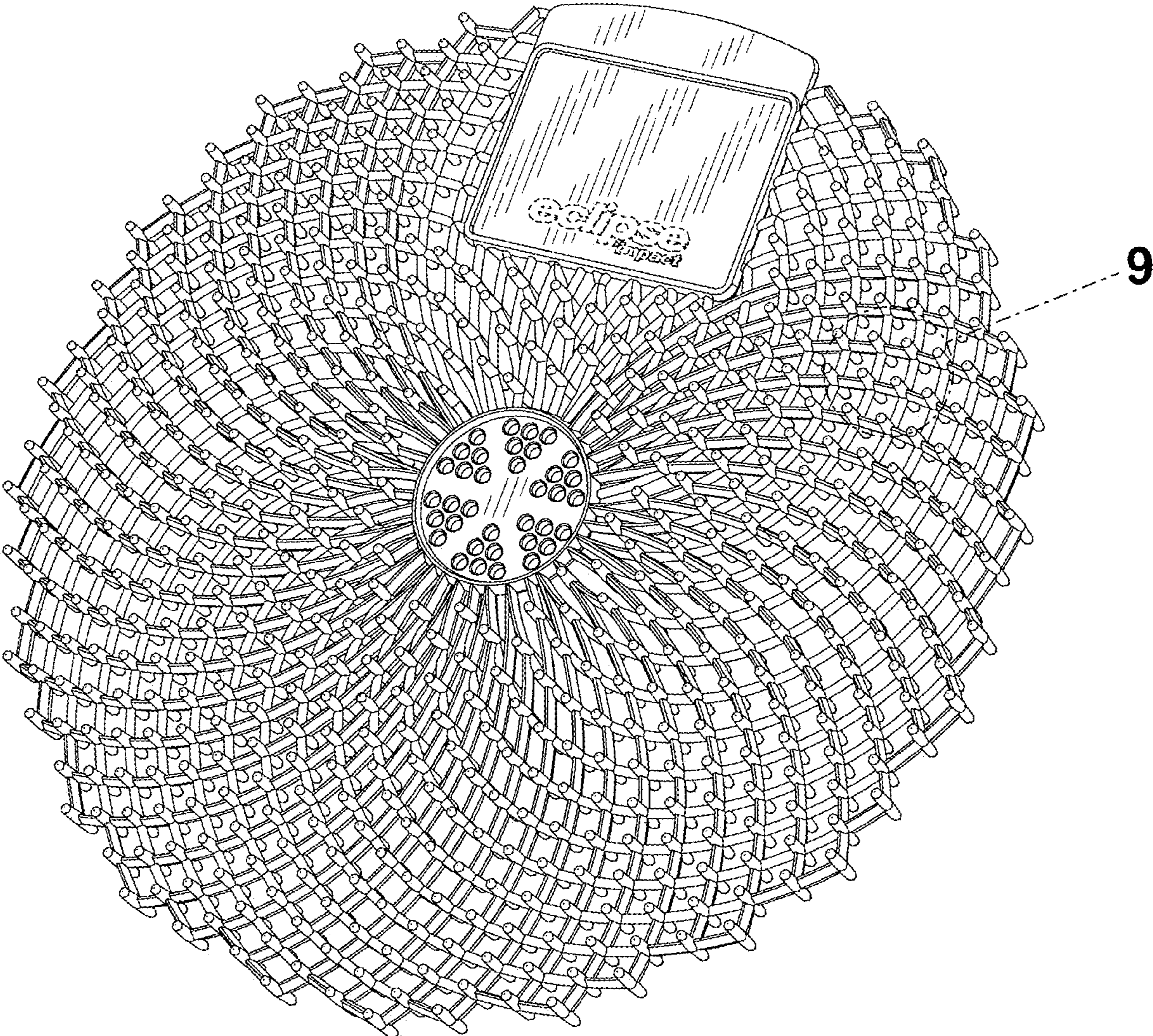

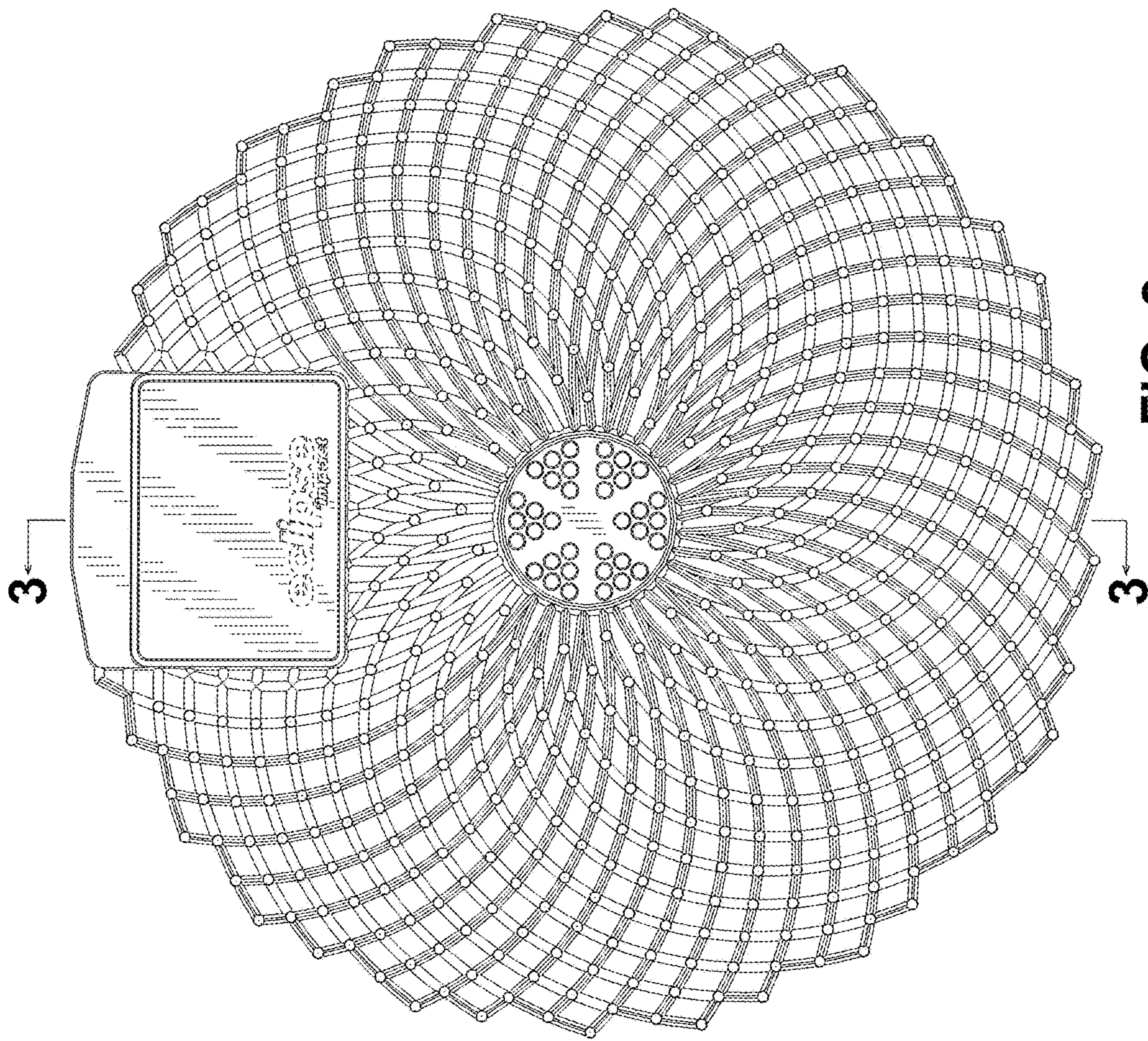

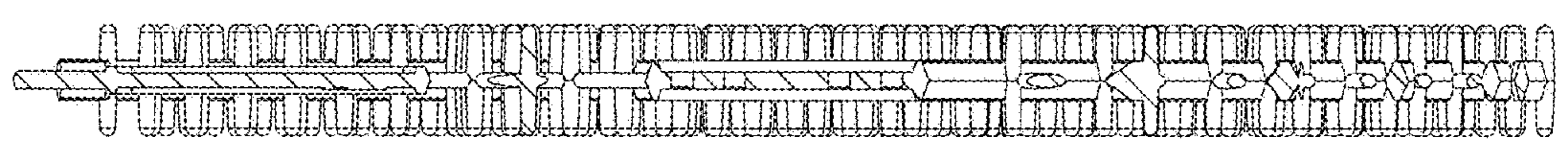

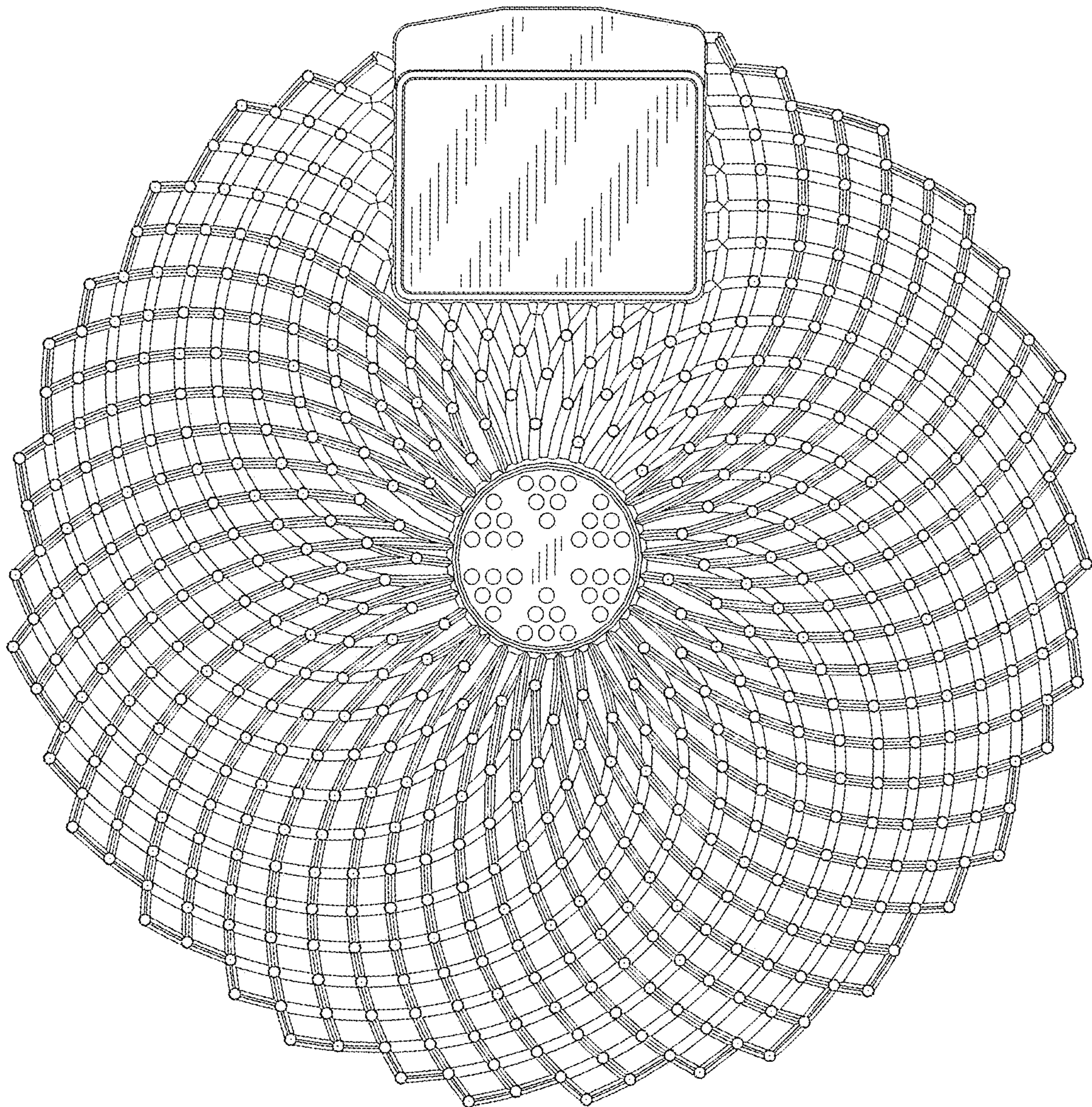

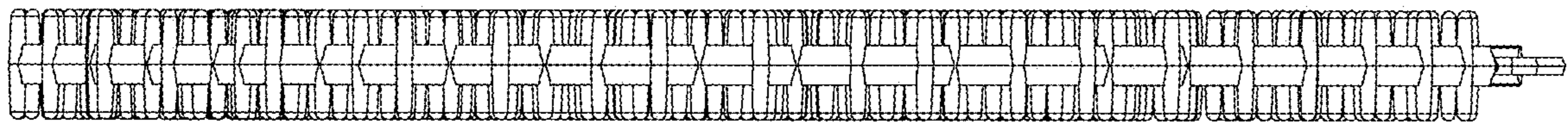

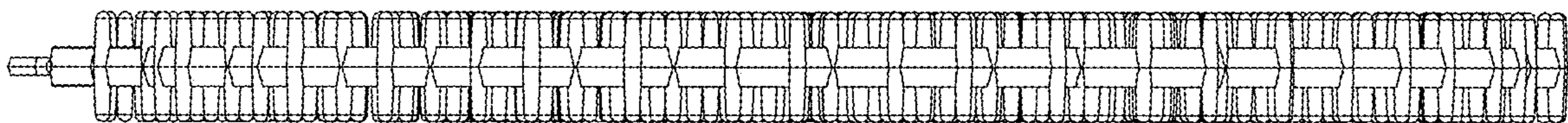

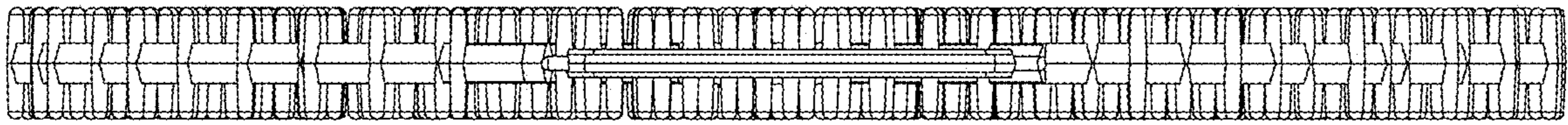

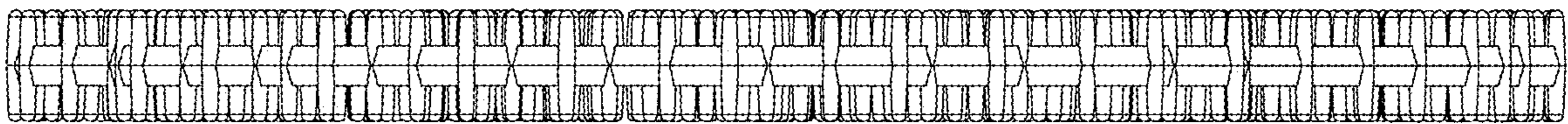

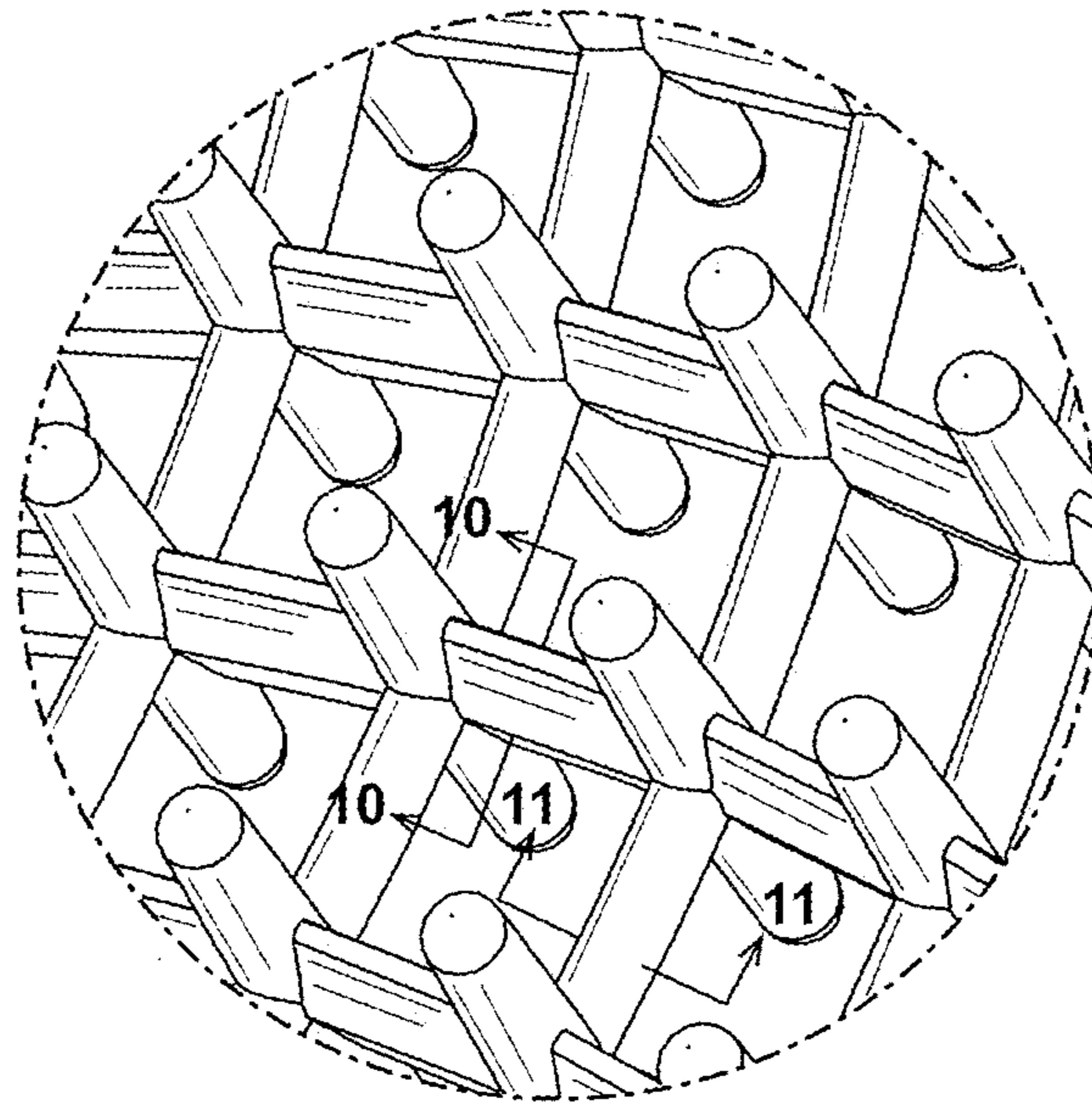

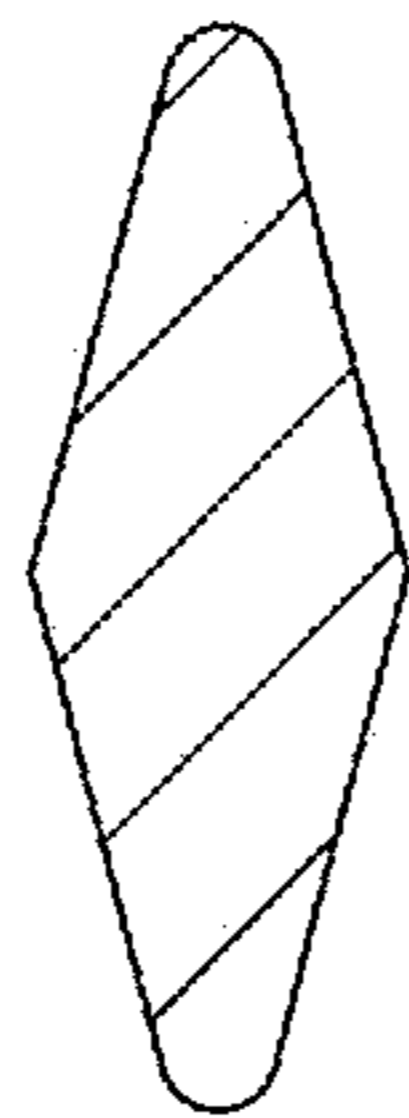

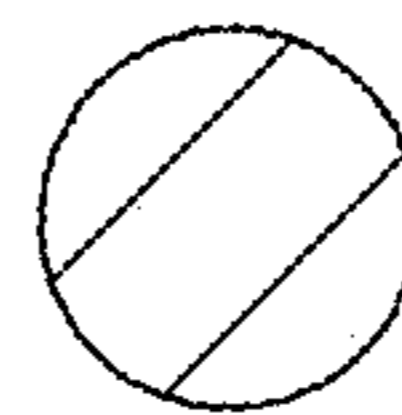
