The ornamental design for a circular bandage, as shown and described.

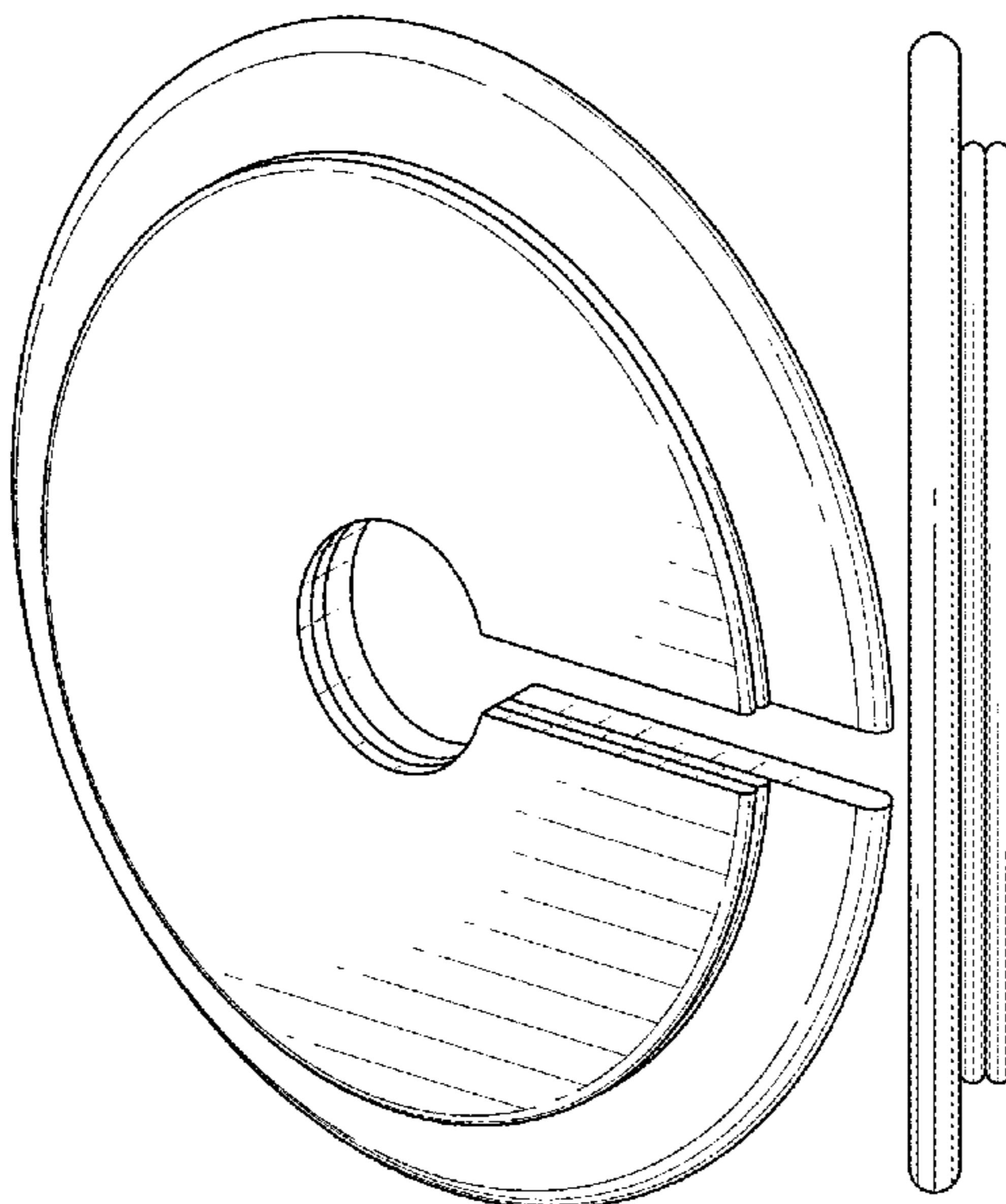

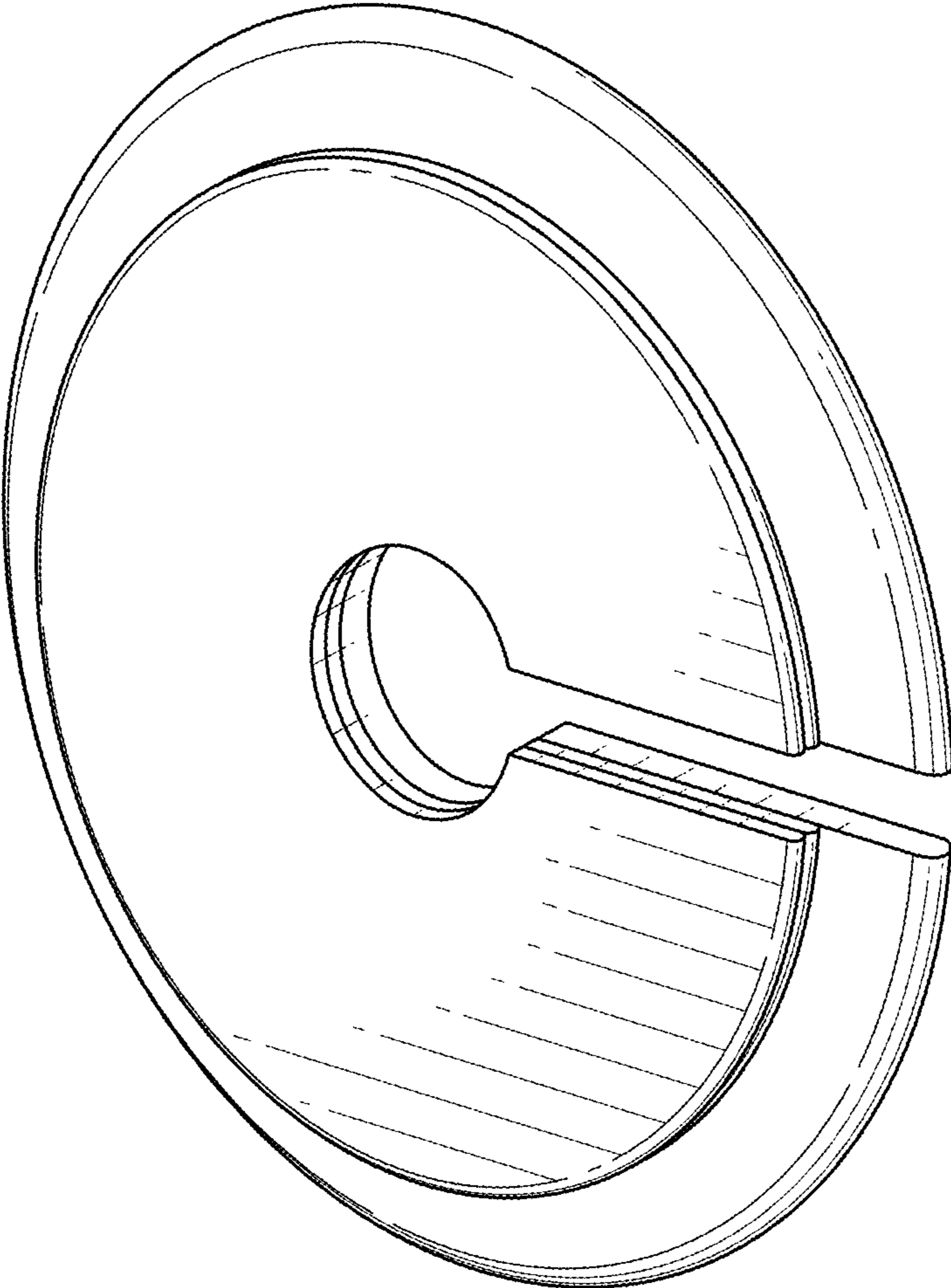

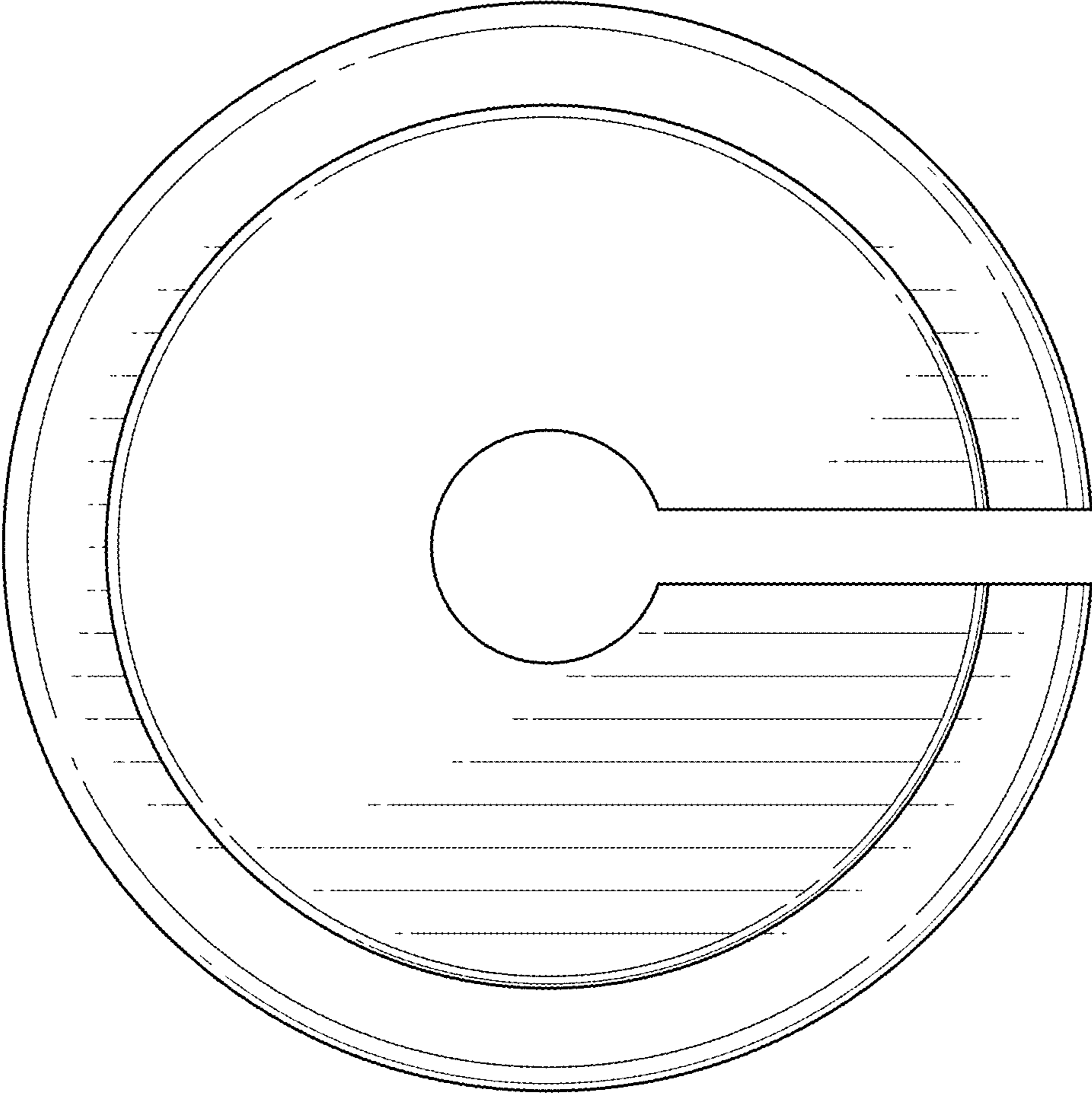

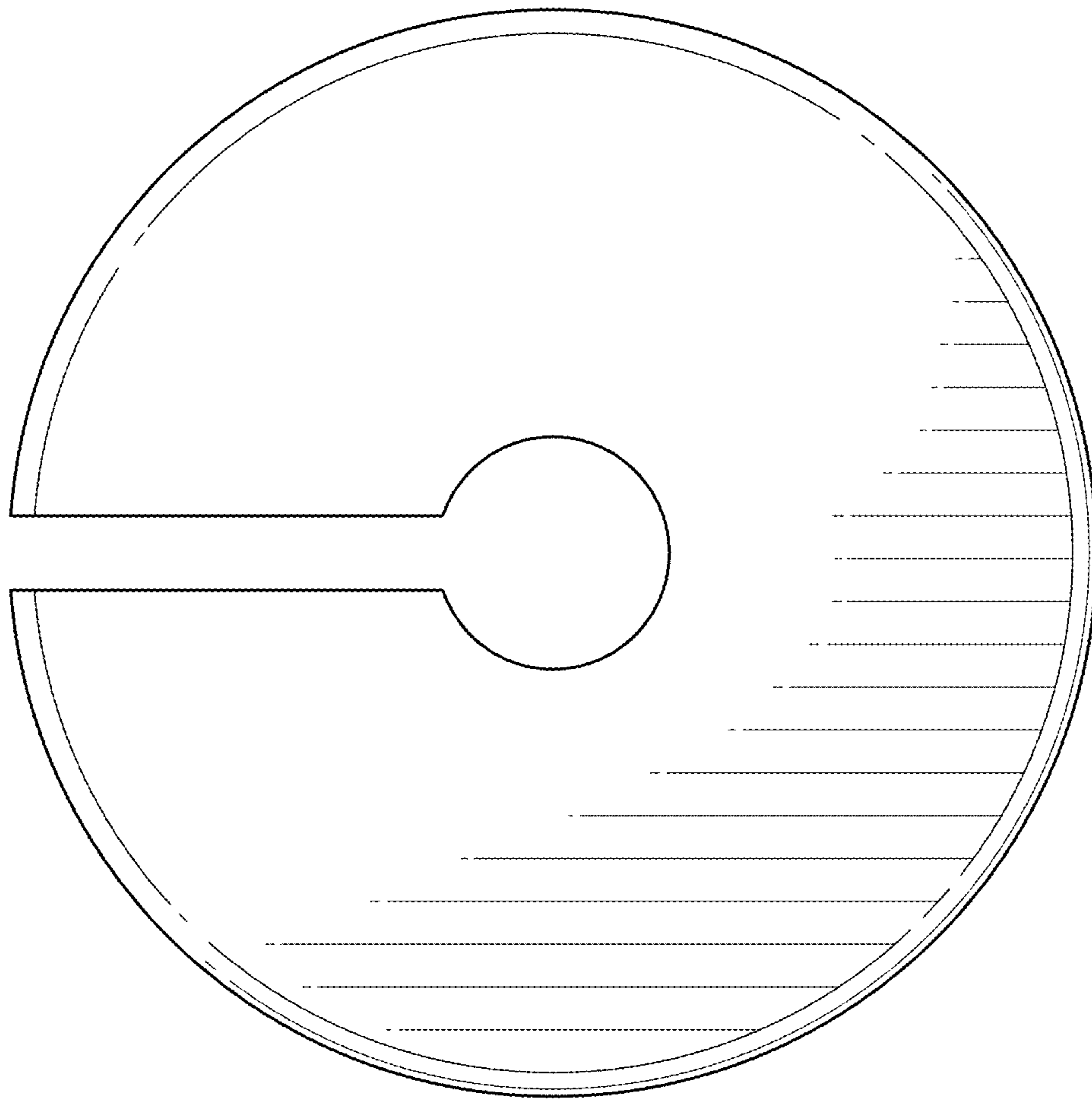

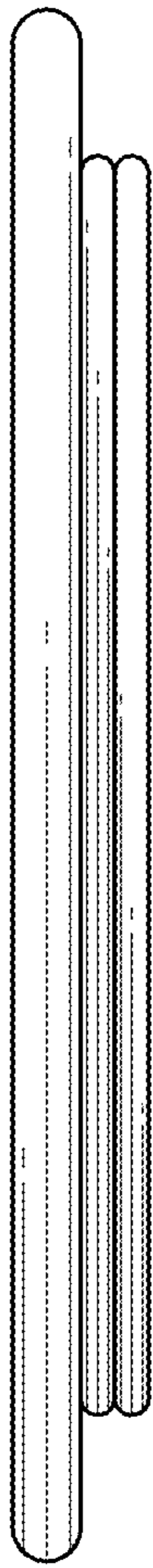

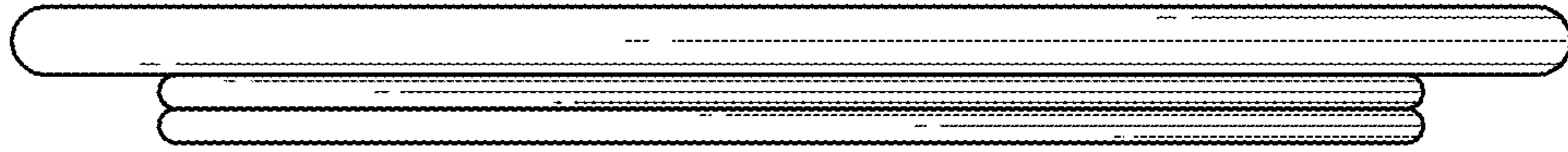

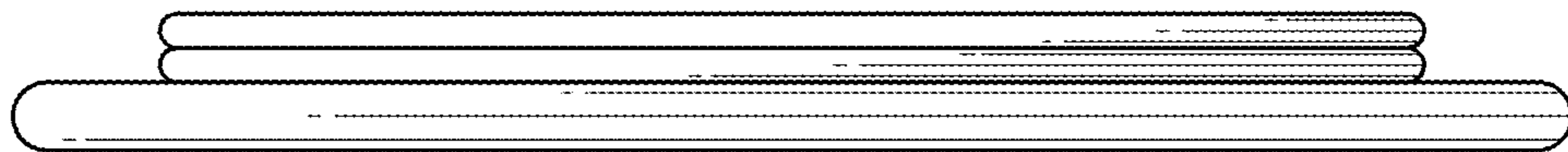
